# M ultistep cascading and fourth-harm onic generation

#### Abstract

W e apply the concept of multistep cascading to the problem of fourth-harm onic generation in a single quadratic crystal. W e analyze a new model of param etric wave mixing and describe its stationary solutions for tw o-and three-color plane w aves and spatial solitons. Som e applications to the optical frequency division as well as the realization of the double-phase-m atching processes in engineered Q PM structures w ith phase reversal sequences are also discussed.


Cascading e ects in optical $m$ aterials $w$ ith quadratic (second-order or ${ }^{(2)}$ ) nonlinear response provide an e cient w ay to low er the critical pow er of all-opticalsw itching devices [1, [1, ]. The concept of $m$ ultistep cascading $[\underline{Z}]$ brings new ideas into this eld, leading to the possibility of an enhanced nonlinearity-induced phase shift and generation of $m$ ulticolor param etric spatial solitons. In particular, m ultistep cascading can be achieved by two nearly phase $m$ atched second-order nonlinear processes, second-harm onic generation (SH G) and sum-frequency m ixing (SFM), involving the third-ham on ic wave $\left[{ }^{[1,4}\right.$ In this Letter, we extend the concept of $m$ ultistep cascading to nonlinear e ects of the fourth order and the fourth-harm onic generation ( FHG ) in a single noncentrosym $m$ etric crystal. In particular, we analyze a new m odelofm ultistep cascading that involves the FH G process, and describe its stationary solutions for norm al m odes | plane waves and spatial solitons. O ur study provides the rst system atic analysis of the problem of FHG via a pure cascade process, observed experim entally $m$ ore than 25 years ago [G] and later studied in a cascading lim it only [ild.

W e consider the FHG via tw o second-order param etric processes: $!+!=2!$ and $2!+2!=4!$, where $!$ is the frequency of the fundam ental wave. In the approxim ation of slow ly varying envelopes $w$ ith the assum ption of zero absorption of all interacting w aves, we obtain

where $A, S$, and $T$ are the envelopes of the fundam ental-frequency (FF), second- (SH) and fourthharm onic (FH) waves respectively, 1;2 are proportional to the elem ents of the second-order susceptibility tensor, and $k_{1}=2 \mathrm{k}_{1} \quad \mathrm{k}_{2}$ and $\mathrm{k}_{2}=$ $2 \mathrm{k}_{2} \quad \mathrm{k}_{4}$ are the corresponding wave-vector m is$m$ atch param eters. W e introduce the nom alized envelopes ( $u, v, w$ ) according to the follow ing relations:

In order to describe a fam ily of nonlinear $m$ odes characterized by the propagation constant, we look for solutions in the form $u(x ; z)$ !

Here $s=\operatorname{sign}()=1, \quad={ }_{1}=\left(\begin{array}{ll}4 & 2\end{array}\right)$ is a relative strength of two param etric processes, and the norm alized m ism atches are de ned as $=4+=$ and $_{1}=$ $1=4+{ }_{1}=$, where $=8 k_{2} z_{d}$ and ${ }_{1}=k_{1} z_{d}$.

First, we analyze the plane-w ave solutions of Eq. [1]) which do not depend on $x$. In this case, the totalintensity $I$ is conserved, and we present it in term s of the unscaled variables as $I=I_{u}+I_{v}+I_{w}$, where $I_{u}=j \mathcal{J}=4, I_{v}=j{ }^{\text {j }}$, and $I_{w}=4 j \mathrm{j}$ f. Solutions $\mathrm{fU}_{0} ; \mathrm{V}_{0} ; \mathrm{W}_{0} \mathrm{~g}$, which do not depend on $z$, are the so-called norm alm odes. The sim plest one-com ponent FH m ode $\mathrm{f} 0 ; 0 ; \mathrm{W} 0 \mathrm{~g}$ exists at $=0$. It has a xed phase velocity $=\quad=4$ and an arbitrary am plitude, being unstable for $I_{w}>\quad{ }^{2}=4$ due to a para$m$ etric decay instability.

Twom ode solution f0; $\overline{2} ; 1 \mathrm{~g}$ describes a param etric coupling betw een $S H$ and FH waves, and it exists for
$>0$, bifurcating at $=0$ from the FH mode. $\mathrm{Cou}-$ pling of this tw ofm ode plane w ave to a FF w ave can lead to its decay instability, provided $j_{1 j}<{ }_{1}^{(c r)}=\frac{P}{2}$. To understand the physical m eaning of this inequality, we note that the fam ily of solutions characterized by the propagation constant corresponds to a straight line in the $(; 1)$ \{param eter space, see $F$ igs. $111(a, b)$. $M$ oreover, all such lines include the point $(4 ; 1=4)$ as the
asym ptotic lim it for $j j!+1$. This special point belongs to the instability region if the relative strength of the FF-SH interaction exceeds a critical value, i.e. for
$>{ }^{(\mathrm{cr})}=1=\left(\begin{array}{ll}8 & 2\end{array}\right), 0: 088$. H ow ever, for $<(\mathrm{cr})$ this decay instability is suppressed for highly intense waves, ow ing to a strong coupling w ith the FH eld.

Finally, a threem ode solution, $\mathrm{V}_{0}=1=, \mathrm{W}_{0}=$ $\mathrm{V}_{0}^{2}=(2), \mathrm{U}_{0}=\mathrm{P} \frac{2 \mathrm{~V}_{0}\left(1 \mathrm{~W} \mathrm{~W}_{0}\right)=}{2}$, exists for (i) $>0$ and $0<1<1_{1}^{\text {(cr) }}$, (ii) $>0$ and $1<{ }_{1}^{(\mathrm{cr})}$, and (iii) < 0 and ${ }_{1}>0$. In the $\lim$ it $j$ ! +1 , such threewave modes are possible only for $>$ (cr). In the region (i), stability properties of the three-w ave solutions are determ ined by a sim ple criterion: the m odes are stable if @I=@j j> 0, and unstable, otherw ise. For the param eter regions (ii) and (iii), oscillatory instabiltities are possible as well. Existence and stability of all types of stationary planew ave solutions of the m odel (11) are sum $m$ arized in $F$ igs. 11

In general, the system $\left[\underline{11}_{11}^{(1)}\right.$ ) is nonintegrable and its dynam ics are irregular. H ow ever, we nd that in som e cases a quasi-periodic energy exchange betw een the ham onics is possible. F igurell (a) show s one such case, w hen the intensities of unstable tw o-w ave and stable three-w ave stationary m odes are close to each other, and an unstable tw O-w ave m ode periodically generates a FF com ponent. Less regular dynam ics are observed for other cases, such as for the generation ofboth SH and FH waves from an
input FF wave $\mathbb{F}$ ig. the possibility ofe ective energy transfer to higher harm onics close to the double phase m atching point.

Equations ( $\binom{1}{1} m$ ay have a di erent physical $m$ eaning provided the norm alized am plitude v stands for them ode of the fundam ental frequency !. Then, Eqs. (III) describe the optical frequency division by two (the eld u) via param etric am pli cation and down-conversion (see, e.g., [ $\left.\overline{1}_{1}\right]$ ), provided both FF (v) and SH (w) elds are launched sim ultaneously at the input. Such a frequency division param etric process is in fact shown in $F$ ig. $\overline{\underline{2}} \mathbf{1}(a)$, $w$ here this tim e the generated $u$ wave corresponds to the frequency $!=2$, and is show $n$ as dotted.

W e now look for spatially localized solutions of E qs. $\left[\frac{1}{1}\right)$, quadratic solitons. $F$ irst, we note that tw o-w ave solitons consisting_of the SH and FH com ponents can be approxim ated as [20 ind

where allparam eters are functions of only. B right solitons either do not exist or are unstable being in resonance w ith linear waves [it
$>0$ and ${ }_{1}>0$, at $s=+1 . W e$ nd that in this region, sim ilar to planew ave $m$ odes, threew ave solitons exist for $0<1<{ }_{1}^{(c r)}$, where the critical (cut-o ) value ${ }_{1}^{(\mathrm{cr})}$ corresponds to a bifurcation from the twowave solution $\overline{(-1)}$ ). In order to nd ${ }_{1}^{(c r)}$, we should solve the rst equation of the system ${ }_{(1)}^{(1)}(1)$ w th the SH pro le from Eq. $\bar{Z}$ ) (see also $\overline{[ }]$ ). H ow ever, such a linear eigenvalue problem has no exact analytical solution for arbitrary $p$, and thuswe introduce an approxim ation $V_{0}(x)^{\prime}$ $V_{0}(x)=V_{m} \operatorname{sech}^{2}(x=q)$, requiring that the functions $\infty 0-$ incide at the am plitude level $V_{m}=2$, and then de ne the scaling param eter as $q=p$ cosh ${ }^{1}\left(2^{1=p}\right)=\cosh ^{1}\left(2^{1=2}\right)$. Such an approxim ation adequately describes an e ective soliton w aveguide, and thus should provide overall good accuracy (except for som e lim titing cases). A fter solving the eigenvalue problem w ith the potential $F_{0}(x)$, we obtain an approxim ate expression for the bifurcation points: ${ }_{1}^{(c r)},\left(P^{1+4 V_{m} q^{2}} 1 \quad 2 n^{\mathcal{Y}}=\left(4 q^{2}\right)\right.$, where $n$ is the
order ofthem ode guided by the tw o-com ponent param etric soliton w aveguide $\left.{ }^{[2}\right]$. For a single-hum pmode $(n=0)$ the behavior of this cut-o is very sim ilar to that of the plane waves. Indeed, in the cascading lim it (1), we have $\mathrm{V}_{\mathrm{m}}, 2^{\mathrm{P}}$, and ${ }_{1}^{(\mathrm{cr})}, 2^{\mathrm{P}}$ - which di ens by ${ }^{\mathrm{P}}{ }_{2}$ from the corresponding result for plane w aves. The critical value of for one-hum p solitons can also be found from the approxim ate solution, (cr) , 0:132. W e perform ed num erical sim ulations and found that the accuracy of our approxim ation is of the order of (and usually better than) 1\% in a w ide range of param eters ( $>10{ }^{2}$ and $>10^{2}$ ), see Fig. ${ }^{\prime}$

Q uite rem arkably, for both positive _ and 1 the stability properties of solitons [see Figs. ${ }_{2}^{1} 1(\mathrm{a}, \mathrm{b})$ ] and plane waves [see Figs. $\left.{ }_{1}^{11}(a, c)\right]$ look sim ilar. Speci cally, stability of two-and three-com ponent solitons is de ned by the Vakhitov-K olokolov criterion @P =@ > 0, where $P={ }_{1}^{\mathrm{R}_{+1}} \mathrm{Idx}$ is the soliton power, except for the region ${ }_{1}<{ }_{1}^{(c r)}$ where tw o-com ponent solutions exhibit para$m$ etric decay instability. A $n$ exam ple of such an instability is presented in Figs. ${ }_{1}^{1} 1(c, d)$, where an unstable tw owave soliton generates a stable threew ave state. Such instability-induced dynam ics are very di erent from that of plane w aves where, instead, quasi-periodic energy exchange is observed [see Fig. ${ }^{\prime 2}$ (a) ]. In the case of localized beam s, di raction leads to an e ective power loss and
convergence to a new (stable) state.
Sim ilar to other $m$ odels of $m$ ultistep cascading $\left.\overline{R_{1}} \cdot \overline{4} \overline{4}\right]$, Eqs. (11) possess various types of exact analytical solutiops, which can be found at $=1=1$ anf $>$ $1=\frac{2}{2} ; 1==4(0 \ll 1)$ and $=1=\left(3^{1} \overline{2}\right)$ or
$=[(3)=(4+2)]^{1=2}$. D etails $w$ ill be presented elsewhere.

In order to observe experim entally the multistep cascading and multi-frequency param etric e ects described above, we should satisfy the double-phasem atching conditions. U sing the conventional quasi-phase$m$ atching ( $Q P M$ ) technique [d] for FHG via a pure cascade process in LiTaO 3 , we nd that there exists only one wavelength ( $2: 45 \mathrm{~m}$ ), for which tw o param etric processes can be phase-m atched sim ultaneously by the different orders $m$ of the QPM structure $w$ th the period $Q=34 \mathrm{~m}$. H ow ever, for the so-called phasereversal QPM structures [1]-] characterized by tw $\circ$ periods, the QPM period $Q$ and the modulation period $\mathrm{ph}(\mathrm{ph}>\mathrm{e})$, double-phase m atching is possible in a broad spectral range, provided the periods are selected to satisfy the conditions: $Q=4 j k_{1}+k_{2} j^{1}$, $\mathrm{ph}=4 \mathrm{mj} \mathrm{k}_{1} \quad \mathrm{k}_{2} j^{1}$, where m is the grating order. $T$ hus, the engineered QPM structures suggested in [1d] are $m$ ore e cient than, e.g., the F ibonaccisuperlattices, and they can be used to achieve double-phase matching and to support di erent types ofm ultistep cascading processes.

In conclusion, we have introduced a new model of multistep cascading that describes the fourth-harm onic generation via param etric wave $m$ ixing. W e have analyzed the existence and stability of the stationary solutions of this m odel for norm alm odes | plane waves and spatial solitons. W e have also discussed the possibility of double-phase-m atching in engineered QPM structures w ith phase-reversal sequences.
