# Spectra of R andom C ontractions and Scattering Theory for D iscrete-T im e System $s$

#### Abstract

$R$ andom contractions (sub-unitary random $m$ atrices) appear naturally when considering quantized chaotic $m$ aps $w$ ithin a general theory of open linear stationary system s with discrete tim e. We analyze statistical properties of com plex eigenvalues of generic $N \quad N$ random $m$ atrices $\hat{A}$ of such a type, corresponding to system $s$ w ith broken tim e-reversal invariance. Deviations from unitarity are characterized by rank $M \quad N$ and a set of eigenvalues $0<T_{i} \quad 1 ; i=1 ;:: ; \%$ M of the $m$ atrix $\hat{\mathrm{T}}=\hat{\mathrm{I}} \quad \hat{A}^{\wedge} \mathrm{A}^{\hat{A}} . W$ e solve the problem com pletely by deriving the joint probability density of N com plex eigenvalues and calculating alln point correlation functions. In the lim it $N \gg M$; $n$ the correlation functions acquire the univensal form found earlier for weakly non $H$ erm itian random $m$ atrices.


The theory of wave scattering can be looked at as an integral part of the general theory of linear dynam ic open system $s$ in term $s$ of the input-output approach. These ideas and relations were developed in system theory and engineering $m$ athem atics $m$ any years ago, see papers and references therein. Unfortunately, that developm ent went alm ost unnotioed by the m a jority
 and references therein. For this reason we feel it could be useful to recall som e basic facts of the input-output approach in such a context.

An O pen Linear System is characterized by three $H$ ilbert spaces: the space $E_{0}$ of intemal states
2 E 0 and two spaces E of incom ing $(-)$ and outgoing ( + ) signals or waves also called input and output spaces, $m$ ade of vectors 2 E . A cting in these three spaces are four operators, or $m$ atrices: a) the so-called fundam ental operator $\hat{A}$ which $m$ aps any vector from intemal space $\mathrm{E}_{0}$ onto som e vector from the sam e space $E_{0}$ b) tw o operators $\hat{W}_{1 ; 2}, ~ w$ ith $\hat{W}_{1} \mathrm{~m}$ apping incom ing states onto an intemalstate and $\hat{W}_{2} \mathrm{~m}$ apping intemal states onto outgoing states and c) an operator $\hat{S_{0}}$ acting from $E$ to $E_{+}$.

W ewillbe interested in describing the dynam ics ( $t$ ) of an intemal state with time provided we know the state at initial instant $t=0$ and the system is sub ject to a given input signal ( $t$ ). In what follow s we consider only the case of the so-called stationary (or tim e-invariant) system s when the operators are assum ed to be tim e-independent. Let us begin with the case of continuoustim e description. The requirem ents of linearity, causality and stationarity lead to a system of two dynam icalequations:

Interpretation of these equations depends on the nature of the state vector as well as of the vectors and is di erent in di erent applications. In the context of quantum $m$ echanics one relates the scalar product $y$ w ith the probability to nd a particle inside the "inner" region at timet, whereas $y$ stays for probability currents ow ing in and out of the region of intemal
states (the num ber of particles com ing or leaving the inner dom ain per unit tim e). The condition of particle conservation then reads as:

It is easy to verify that Eq. (2-1) is com patible w th the dynam ics Eq. ([1]) only provided the operators satisfy the follow ing relations:

which show $S$, in particular, that $\hat{A}$ can be written as $A=\hat{H} \quad \frac{i}{2} \hat{W} \hat{W} y$, with a $H$ em itian $\hat{H}=\hat{H^{y}}$.
The meaning of $\hat{H}$ is transparent: it govems the evolution $i \frac{d}{d t}=\hat{H} \quad(t)$ of an inner state when the coupling $\hat{W}$ betw een the inner space and input/output spaces is absent. A s such, it is just the H am iltonian describing the closed inner region. T he fundam ental operator $\hat{A}$ then has a natural interpretation of the e ective non-selfadjoint $H$ am iltionian describing the decay of the probability from the inner region at zero input signal: $(t)=0$ for any $t \quad 0$. If, how ever, the input signal is given in the Fourier-dom ain by (! ), the output signal is related to it by:

where we assum ed $(t=0)=0$. The unitary $m$ atrix $\hat{S}(!)$ is know $n$ in the $m$ athem atical literature as the characteristic $m$ atrix-fiunction of the non $H$ erm itian operator $\hat{A}$. In the present context it is just the scattering $m$ atrix whose unitarity is guaranteed by the conservation law Eq $(\overline{2})$.

The contact w th the theory of chaotic scattering is now apparent: the expression Eq. $(\overline{3} \overline{1})$ w as frequently used in the physicalliterature [ of the scattering $m$ atrix for a quantum chaotic system $w$ ithin the so-called random $m$ atrix approach. $T$ he $m$ ain idea underlying such an approach is to replace the actual $H$ am iltonian $\hat{H}$ by a large random $m$ atrix and to calculate the ensuing statistics of the scattering $m$ atrix. The physical argum ents in favor of such a replacem ent can be found in the cited literature.

In particular, $m$ ost recently the statistical properties of com plex eigenvalues of the operator $\hat{A}$
 scattering $m$ atrix and have the physicalinterpretation ofresonances - long-lived interm ediate states to which discrete energy levels of the closed system are transform ed due to coupling to continua.

In the theory presented above the time $t w a s$ a continuous param eter. On the other hand, a very useful instrum ent in the analysis of classical H am iltonian system s w ith chaotic dynam ics are the so-called area-preserving chaotic $m$ aps $\left[\begin{array}{l}{[-1} \\ \hline\end{array}\right]$. They appear naturally either as a $m$ apping of the P oincare section onto itself, or as result of a stroboscopic description of H am iltonians which are periodic functions of tim $e$. Their quantum $m$ echanical analogues are unitary operators which act on H ibert spaces of nite large dim ension $N$. They are often referred to as evolution, scattering or F loquet operators, depending on the physical context where they are used. Their eigenvalues consist of N points on the unit circle (eigenphases). N um erical studies of various classically chaotic system s suggest that the eigenphases conform statistically quite accurately the results obtained for unitary random $m$ atrioes of a particular sym $m$ etry (D yson circular ensem bles).

Let us now im agine that a system represented by a chaotic $m$ ap ("inner world") is em bedded in a larger physical system ("outer world") in such a way that it describes particles which can com e inside the region of chaotic $m$ otion and leave it after som etim e. M odels of such type appeared, for exam ple, in [1]-1] w here a kind of scattering theory for "open quantum m aps" w as developed based on a variant of $L$ ipm ann-Schw inger equation.

On the other hand, in the general system theory $[$ [2] dynam ical system $\mathrm{s} w$ ith discrete tim e are considered as frequently as those with continuous time. For linear system sa "stroboscopic" dynam ics is just a linear map ( $(\mathrm{n})$; ( $n$ )) ! ( $+(n)$; $(n+1))$ which can be generally w ritten as:

A gain, we would like to consider a conservative system, and the discrete-tim e analogue of Eq. (ᄌᄌㄱ) is:

A ssum ing further that the $m$ otion outside the inner region is regular, we should be able to describe generic features of open quantized chaotic $m$ aps choosing the $m$ atrix $\hat{u}$ to be a $m$ em ber of a Dyson circular ensemble. In fact, this line of reasoning ism otivated by recent papers [1] [1] 1 the $F$ loquet description of a $B$ loch particle in a constant force and periodic driving. A fter som e approxim ations the evolution of the system is described by a mapping: $c_{n+1}=F c_{n}$, where the

O ne can check that such a dynam ics can be easily brought to the standard Eqs. (4in (15) w the the fundam ental operator being on $N \quad N$ random $m$ atrix of the form $\hat{A}=\hat{1} \hat{1} \wedge$, and all M diagonal elem ents of the $N \quad M m$ atrix are equal to unity. A ctually, the original paper! em ployed a slightly di erent but equivalent construction dealing $w$ ith an "enlarged" intemalspace of the dim ension $N+M$. W e prefer to follow the general schem e because of its conceptual clarity.
$D$ irect inspection im $m$ ediately show $s$ that the non-vanishing eigenvalues of the fiundam ental operator $\hat{A}$ as above coincide w ith those of a (N M) (N M) subblock of the random unitary $m$ atrix $u$. C om plex eigenvalues of such "truncations" of random unitary $m$ atrices were studied in m uch detail by the authors of a recent insightful paper []거]. They managed to study eigenvalue correlations analytically for arbitrary N ; M . In particular, they found that in the lim it N ! 1
 operators of the form $\hat{A}=\hat{H} \quad \frac{i}{2} \hat{W} \hat{W}$ y occuring in the theory ofopen system $s w$ ith continuous-tim e dynam ics.

Such a rem arkable universality, though not com pletely unexpected, deserves to be studied in $m$ ore detail. In fact, truncated unitary m atrices represent only a particular case of random contractions $\hat{A}$. A ctually, som e statistical properties of general subunitary $m$ atrioes were under investigation recently as a $m$ odel of scattering $m$ atrix for system $s w$ ith absonption, see [14 $\left.4^{1}\right]$.

The particular case of rank-one deviations from unitarity is the sim plest one to investigate and w as considered in a recent preprint $\left.\overline{[1]} \overline{5_{1}^{\prime}}\right]$. H ow ever, generalization to arbitrary $M$ along the lines of [ $\left.{ }_{[15}{ }^{-1}\right]$ seem ed to be problem atic. The $m$ ain goal of the present paper is to suggest a regular way of studying the specta of random contractions for a given deviation from unitarity.

 The rem arkable feature of such a distribution is that it allow for calculation of alln point correlation functions for arbitary $\mathrm{N} ; \mathrm{n}$; M w ith help of the m ethod of orthogonal polynom ials. A gain, the particular case $M=1$ [1-3] is quite instructive and can be recom $m$ ended to follow rst for understanding of the general form ulae outlined below.

In principle, all integrations in the equation Eq.(1.i) can be perform ed explicitly and the resulting form ulae provide the desired general solution of the problem. W e present below as an exam ple the low est correlation function $R_{1}(z)$, which is just the $m$ ean eigenvalue density inside the unit circle $\dot{k} j<1$. All the equations above are valid for arbitrary $N \quad M$; $n$. In the theory of quantum chaotic scattering we, how ever, expect a kind of universality in the sem iclassical lim it. Translated to the random $m$ atrix language such a lim it corresponds to $N$ ! 1 at xed $n ; M$. Still, extracting the
