# A nom alous scaling of a passive scalar in the presence of strong an isotropy

F ield theoretic renom alization group and the operator product expansion are applied to a m odel of a passive scalar quantity $(t ; x)$, advected by the Gaussian strongly anisotropic velocity eld $w$ ith the covariance / ( $t t^{0}$ ) $\dot{x} \quad x^{0} j$. Inertial-range anom alous scaling behavior is established, and explicit asym ptotic expressions for the structure functions $S_{n}(r) \quad h[(t ; x+r) \quad(t ; x)]_{i}$ are obtained; they are represented by superpositions of pow er law S w ith nonuniversal (dependent on the an isotropy param eters) anom alous exponents, calculated to the rst order in " in any space dim ension d . In the lim it ofvan ishing an isotropy, the exponents are associated w ith tensor com posite operators built of the scalar gradients, and exhibit a kind of hierarchy related to the degree of anisotropy: the less is the rank, the less is the dim ension and, consequently, the m ore im portant is the contribution to the inertial-range behavior. The leading term s of the even (odd) structure functions are given by the scalar (vector) operators. For the nite anisotropy, the exponents cannot be associated w ith individual operators (w hich are essentially $\backslash \mathrm{m}$ ixed" in renorm alization), but the aforem entioned hierarchy survives for all the cases studied. The second-order structure function $S_{2}$ is studied in $m$ ore detailusing the renom alization group and zerom ode techniques; the corresponding exponents and amplitudes are calculated with in the perturbation theories in ", $1=\mathrm{d}$, and in the anisotropy param eters. If the anisotropy of the velocity is strong enough, the skew ness factor $S_{3}=S_{2}^{3=2}$ increases going dow $n$ tow ards to the depth of the inertial range; the higher-order odd ratios increase even if the an isotropy is weak.

## I. IN TRODUCTION

Recently, much e ort has been invested to understand inertial-range anom alous scaling of a passive scalar. Both the natural and num erical experim ents suggest that the violation of the classical K olm ogorov $\{\mathrm{O}$ bukhov theory [1] is even $m$ ore strongly pronounced for a passively advected scalar eld than for the velocity eld itself; see, e.g., $\left.\left[{ }_{1}^{1} n_{1}^{1}\right]_{1}^{1}\right]$ and literature cited therein. At the sam e tim e, the problem of passive advection appears to be easier tractable theoretically. T he m ost rem arkable progress has been achieved for the so-called K raichnan's rapid-change m odel $\left[\overline{5}_{1}^{1}\right]$ : for the rst time, the anom alous exponents have been calculated on the basis of a m icroscopic $m$ odel and $w$ ithin regular expansions in form al sm all param eters; see, e.g., $[\underline{G}\{1][1]$ and references therein.
$W$ ithin the $\backslash$ zero $m$ ode approach," developed in $\$[1]$, nontrivialanom alous exponents are related to the zero $m$ odes (unforced solutions) of the closed exact equations satis ed by the equal-tim e correlations. W ithin the approach based on the eld theoretic renom alization group ( RG ) and operator product expansion (OPE), the anom alous scaling em erges as a consequence of the existence, in the $m$ odel of com posite operators $w$ ith negative critical dim ensions, which determ ine the anom alous exponents [11 [1] [1]

A nother im portant question recently addressed is the e ects of large-scale anisotropy on inertial-range statistics of passively advected elds O bukhov theory, the anisotropy introduced at large scales by the forcing (boundary conditions, geom etry of an obstacle etc.) dies out when the energy is transferred down to the sm aller scales ow ing to the cascade m echanism
 support to the aforem entioned hypothesis on the restored localisotropy of the inertial-range turbulence for the velocity and passive elds [14,16\{1]. M ore precisely, the exponents describing the inertial-range scaling exhibit universality and hierarchy related to the degree of anisotropy, and the leading contribution to an even fiunction is given by the exponent from the isotropic shell $[1]$, Nevertheless, the anisotropy survives in the inertial range and reveals itself in odd correlation functions, in disagreem ent w ith what w as expected on the basis of the cascade ideas. $T$ he so-called skew ness factor decreases dow $n$ the scales $m$ uch slow er than expected $[1,1]$, while the higher-order odd dim ensionless ratios (hyperskew ness ets) increase, thus signalling of persistent sm all-scale an isotropy [14 "ind.
 rapid-change velocity, and for the scalar advected by the two-dim ensionalN avier-Stokes velocity eld [16].

In the present paper, we study the anom alous scaling behavior of a passive scalar advected by the tim e-decorrelated strongly anisotropic $G$ aussian velocity eld. In contradistinction $w$ ith the studies of $[4$
isotropic and the large-scale anisotropy w as introduced by the im posed linear m ean gradient, the uniaxialanisotropy in our m odel persists for all scales, leading to nonuniversality of the anom alous exponents through their dependence on the anisotropy param eters.

The aim of our paper is tw ofold.
Firstly, we obtain explicit inertial-range expressions for the structure functions and correlation functions of the scalar gradients and calculate the corresponding anom alous exponents to the rst order of the " expansion. W e show that the exponents in ourm odelbecom e nonuniversal through the dependence on the param eters describing the anisotropy of the velocity eld. O w ing to the anisotropy of the velocity statistics, the com posite operators of di erent ranksm ix strongly in renorm alization, and the corresponding anom alous exponents are given by the eigenvalues of the $m$ atrioes which are nether diagonal nor triangular (in contrast w the case of large-scale anisotropy). In the language of the zerom ode technique this $m$ eans that the $S O(d)$ decom positions of the correlation functions (em ployed, e.g., in Refs. [1] ${ }^{-1}$ ]) do not lead to the diagonalization of the di erential operators in the corresponding exact equations.

N evertheless, the hierarchy obeyed by the exponents for the vanishing anisotropy survives when the anisotropy becom es strong. This fact (along w ith the nonuniversality) is the $m$ ain qualitative result of the paper.

A nother scope of the paper is to give the detailed account of the RG approach and to com pare the results obtained w ithin both the RG and zerom ode techniques on the exam ple of the second-order structure fiuction.
$T$ he paper is organized as follow s .
In Sec. "init we give the precise form ulation of the m odeland outline brie y the generalstrategy of the RG approach.
In Sec. III, we give the eld theoretic form ulation of the $m$ odel and derive the exact equations for the response function an̄"d pair correlator.

In Sec. ${ }^{1} \overline{-1}{ }^{\prime}$, we perform the ultraviolet ( UV ) renorm alization of them odeland derive the corresponding $R G$ equations w ith exactly known RG functions ( functions and anom alous dim ensions). These equations possess an infrared ( $\mathbb{R}$ ) stable xed point, which establishes the existence of $\mathbb{R}$ scaling $w$ ith exactly known critical dim ensions of the basic elds and param eters of the $m$ odel.
In Sec. 'V', 'I, we discuss the solution of the RG equations for various correlation functions and determ ine the dependence of the latter on the UV scale.

In Sec. $\overline{\text { N }} \ddagger$, we discuss the renorm alization of various com posite operators. In particular, we derive the one-loop result for the critical dim ensions of the tensor operators, constructed of the scalar gradients.

In Sec. $\bar{V} \bar{I} \bar{I}$, we show that these dim ensions play the part of the anom alous exponents, and present explicit inertialrange expressions for the structure functions and correlations of the scalar gradients.

In Sec. VV III, we give the detailed com parison of the RG and zero-m ode techniques on the exam ple of the secondorder structure function, com pare the representation obtained using RG and OPE w ith the ordinary perturbation theory, and calculate the am plitude factors in the corresponding pow er law s .

The results obtained are review ed in Sec. ITX.'
II. DEFINITION OF THEMODEL.ANOMALOUSSCALINGAND \DANGEROUS"COMPOSITE OPERATORS.

The advection of a passive scalar eld ( x$) \quad(\mathrm{t} ; \mathrm{x})$ in the rapid-change m odel is described by the stochastic equation

Here ' is an integral scale related to the scalar noise and C $(\mathrm{r}=\mathrm{`})$ is a function nite as ' ! 1 . W ith no loss of generality, we take $C(0)=1$ in what follow $s$. The velocity $v(x)$ obeys a $G$ aussian distribution $w$ ith zero $m$ ean and correlator

$T$ he issue of interest is, in particular, the behavior of the equal-tim e structure functions

In principle, they can be calculated with in the ordinary perturbation theory (i.e., as series in $g_{0}$ ), but this is not useful for studying inertial-range behavior: the coe cients are singular in the lim its $r$ ! 1 and/or $m r$ ! 0 , which compensate the smallness of $g_{0}$ (assum ed in ordinary perturbation theory), and in order to nd correct $\mathbb{R}$ behaviorw e have to sum the entire series. $T$ he desired sum $m$ ation can be accom plished using the eld theoretic renorm alization group ( RG ) and operator product expansion (OPE);


The RG analysis consists of tw o $m$ ain stages. On the rst stage, the $m u l t i p$ licative renorm alizability of the $m$ odel is dem onstrated and the di erentialRG equations for its correlation functions are obtained. T he asym ptotic behavior of the functions like ( $\overline{5}^{\prime}$ ') for $r \gg 1$ and any xed $m r$ is given by $\mathbb{R}$ stable xed points of the $R G$ equations and has the form

In general, the sum $m$ ation is im plied over allpossible renorm alized com posite operators $F$ allow ed by the sym $m$ etry ( $m$ ore precisely, see Sec. $i \bar{V} \bar{I}$ ) ; $\mathbb{F}$ ] being their critical dim ensions. W ithout loss of generality, it can be assum ed that the expansion is m ade in irreducible tensors; in the isotropic case only scalar operators have nonvanishing $m$ ean values and contribute to the right hand side of Eq. (q) .
$T$ he peculiarity of the $m$ odels describing turbulence is the existence of the so-called \dangerous" com posite operators w ith negative critical dim ensions $\left[12^{2}\right.$, the scaling functions for $m r!0$, and the leading term is given by the operator $w$ ith $m$ inim al $\mathbb{F}]$. The leading contributions to $S_{2 n}$ are determ ined by scalar gradients $F_{n}=\left(@_{i} @_{i}\right)^{n}$ and have the form

In the theory ofturbulence, the singularm dependence ofcorrelation functions $w$ ith the exponents nonlinear in $n$ is referred to as anom alous scaling, and $n$ them selves are term ed the anom alous exponents; see, e.g., [1] in ill. T he above discussion show s that the anom alous exponents (in the sense of the turbulence theory) are not sim ply related to the anom alous or criticaldim ensions (in the sense of the theory of phase transitions) of the structure functions them selves; they are determ ined by the criticaldim ensions of certain com posite operators entering into the corresponding OPE $\overline{\mathrm{I}}$

In a num ber of papers, e.g. [Al ", is a constant vector that determ ines the distinguished direction and therefore introduces large-scale anisotropy. T he anisotropy gives rise to nonvanishing odd functions $S_{2 n+1}$. The critical dim ensions of all com posite operators rem ain unchanged, but the irreducible tensor operators acquire nonzero $m$ ean values and their contributions appear on the right hand side of Eq. (iq); see [14]. This is easily understood in the language of the zero-m ode approach: the noise $f$ and the term (hv) do not a ect the di erential operators in the equations satis ed by the equal-tim e correlations functions; the zero $m$ odes (hom ogeneous solutions) coincide in the tw o cases, but in the latter case the $m$ odes $w$ ith nontrivial angular dependence should be taken into account.
$T$ he direct_calculation to the order $O$ (") has show $n$ that the leading exponent associated w ith a given rank contribution to Eq. [ $\overline{1} 1)$ decreasesm onotonically w th the rank [14]. H ence, the leading term of the inertial-range behavior of an even structure function is determ ined by the sam e exponent (12), while the exponents related to the tensor operators
 for the magnetic eld advected passively by the rapid-change velocity in the presence of a constant background eld, and in $\left[\overline{1}_{1}^{1}\right]$ w ithin the context of the $N$ avier\{Stokes turbulence.

Below we shall take the velocity statistics to be anisotropic also at sm all scales. W e replace the ordinary transverse pro jector in Eq. ( $\overline{1} \mathbf{1})$ w th the general transverse structure that possesses the uniaxial anisotropy:

$W$ e note that the quantities $(\overline{1} \overline{1} \overline{1}),\left(\overline{1} \overline{4} \overline{4}^{\prime}\right)$ possess the sym $m$ etry $n!n$. The anisotropy $m$ akes it possible to introduce
 the evenness in $n$ and gives rise to nonvanishing odd functions $S_{2 n+1}$. H ow ever, this leads to no serious alterations in the RG analysis; we shall discuss this case in Sec. Nill and for now we assum e hvfi=0.
 equation, including passive advection and $m$ agnetic tunbulence, $w$ ith the expression (14.) entering into the stirring force correlator. The detailed account can be found in $R$ ef. [25], where som e errors of the previous treatm ents are also corrected. H ow ever, these studies have up to now been lim ited to the rst stage, i.e., investigation of the existence and stability of the xed points and calculation of the criticaldim ensions ofbasic quantities. C alculation of the anom alous exponents in those $m$ odels rem ains an open problem.

The feature characteristic of the models like ( ${ }^{(1)} \bar{L}_{1}$ ) is that all the skeleton $m$ ultiloop diagram $s$ entering into the self-energy operators 0,0 o contain e ectively colosed circuits of retarded propagatorsh $0_{i}$ (it is crucial here that the propagator hvvio in Eq. (3/1) is proportional to the function in tim e) and therefore vanish.

## IV.RENORMALIZATION,RGEUNCTIONS,ANDRGEQUATIONS

T he analysis of the UV divergences is based on the analysis of canonicaldim ensions. D ynam icalm odels of the type (115), in contrast to static $m$ odels, have two scales, so that the canonical dim ension of som equantity $F$ (a eld or a param eter in the action functional) is described by two numbers, the $m$ om entum dim ension $d_{F}^{k}$ and the frequency dim ension $d_{F}^{!}$. They are determ ined so that $\left.\mathbb{E}\right][\mathbb{L}] d_{F}^{k}[T] d_{F}^{\prime}$, where $L$ is the length scale and $T$ is the time scale. $T$ he dim ensions are found from the obvious norm alization conditions $d_{k}^{k}=d_{x}^{k}=1, d_{k}^{!}=d_{x}^{!}=0, d_{!}^{k}=d_{t}^{k}=0$, $d_{!}^{!}=d_{t}^{!}=1$, and from the requirem ent that each term of the action functionalbe dim ensionless (w ith respect to the $m$ om entum and frequency dim ensions separately). Then, based on $d_{F}^{k}$ and $d_{F}^{!}$, one can introduce the total canonical dim ension $d_{F}=d_{F}^{k}+2 d_{F}^{!}$(in the free theory, $\varrho_{t} /$ ), which plays in the theory of renom alization of dynam ical $m$ odels the sam e role as the conventional ( m om entum ) dim ension does in static problem s .
$T$ he dim ensions for the $m$ odel (1-5) are given in $T$ able 1, including the param eters $w$ hich $w$ ill be introduced later on. $>$ From $T$ able $i t$ follows that the $m$ odel is logarithm $\bar{i}$ (the coupling constant $g_{0}$ is dim ensionless) at $"=0$, so that the UV divergences have the form of the poles in " in the G reen functions.

A nalysis of the divergences should be based on the follow ing auxiliary considerations:
(i) From the explicit form of the vertex and bare propagators in the model (1-5) it follows that $\mathrm{N} \quad \mathrm{N}=2 \mathrm{~N}_{0}$ for any 1 -irreducible $G$ reen function, where $N_{0} \quad 0$ is the total num ber of bare propagators $h i_{0}$ entering into the function (obviously, no diagram $s$ w ith $\mathrm{N}_{0}<0$ can be constructed). Therefore, the di erence $\mathrm{N} \circ \mathrm{N}$ is an even non-negative integer for any nonvanishing function.
(ii) If for som e reason a num ber of extemal $m$ om enta occurs as an overall factor in all the diagram $s$ of a given $G$ reen function, the real index of divergence $d^{0}$ is sm aller than $d$ by the corresponding num ber (the $G$ reen function requires counterterm sonly if $d^{0}$ is a non-negative integer). In the model $\left.\underline{11}_{1}^{1}\right)_{1}^{\prime}$ ), the derivative @ at the vertex ${ }^{0}$ (v@) can be m oved onto the eld ${ }^{0}$ by virtue of the transversality of the eld $\overline{\mathrm{v}}$. Therefore, in any 1-irreducible diagram it is alv ays possible to $m$ ove the derivative onto any of the extemal \tails" or ${ }^{0}$, which decreases the real index of divergenc: $d^{0}=d \quad N \quad N \quad$. The elds , ${ }^{0}$ enter into the counterterm sonly in the form of derivatives @, @ ${ }^{0}$.

From the dimensions in Table $\ddagger$ we nd $d=d+2 \quad N_{v}+N \quad(d+1) N \circ$ and $d^{0}=(d+2)(1 \quad N \quad 0) \quad N_{v}$. It then follows that for any $d$, super cial divergences can exist only in the 1-irreducible functions $h$ : : : $i_{1}$ ir $w$ ith $\mathrm{N} 0=1$ and arbitrary value of N , for which $\mathrm{d}=2, \mathrm{~d}^{0}=0$. How ever, all the functions w ith $\mathrm{N}>\mathrm{N}$ o vanish (see above) and obviously do not require counterterm s . W e are left w th the only super cially divergent function $\mathrm{h}{ }^{0} \mathrm{i}_{1}$ ir; the corresponding counterterm smust contain two sym bols @ and in the isotropic case reduce to the only structure
0 . In the presence of anisotropy, it is necessary to also introduce new counterterm of the form ${ }^{0}(\mathrm{n} @)^{2}$, which is absent in the unrenorm alized action functional (1-5). Therefore, the $m$ odel (1) in its original form ulation is not m ultiplicatively renom alizable, and in order to use the standard RG techniques it is necessary to extend the m odel by adding the new contribution to the unrenorm alized action:

## VI.RENORMALIZATION AND CRITICALD IMENSIONS OF COM POSITE OPERATORS

A ny local (unless stated to be otherw ise) m onom ial or polynom ial constructed of prim ary elds and their derivatives at a single spacetim e point $x \quad(t ; x)$ is term ed a composite operator. Exam ples are $\left.{ }^{N}(x), \llbracket_{i}(x) @_{i}(x)\right]^{N}$, $@_{i}(x) @_{j}(x),{ }^{0}(x) r_{t}(x)$ and so on.

Since the argum ents of the elds coincide, correlation functions with such operators contain additionalUV divergences, which are rem oved by additional renorm alization procedure; see, e.g., [22, 23']. For the renorm alized correlation functions standard RG equations are obtained, which describe $\mathbb{R}$ scaling of certain $\backslash$ basis" operators $F$ with de nite critical dim ensions $F \mathbb{E}]$. D ue to the renom alization, $\mathbb{E}$ ] does not coincide in generalw ith the naive sum of
critical dim ensions of the elds and derivatives entering into $F$. A s a rule, com posite operators $m$ ix in renorm alization, i.e., an UV nite renom alized operator $F^{R}$ has the form $F^{R}=F+$ counterterm $S$, where the contribution of the counterterm $s$ is a linear com bination of $F$ itself and, possibly, other unrenorm alized operators which \adm ix" to $F$ in renorm alization.

(i) The leading anisotropy correction is of order $O(1 ; 2)$ for $p=$ and $O\left({ }_{1 ; 2}^{2}\right)$ for $p=0$, so that the dim ensions $\mathbb{N}$;0] are anisotropy independent in the linear approxim ation, and
(ii) This leading contribution depends on $1 ; 2$ only through the combination $32_{1}+d_{2}$.

The eigenvalues beyond the sm all 1;2 expansion have been obtained num erically. Som e of them are presented in $F$ igs. $2\left\{5\right.$, nam ely, the dimensions $[n ; p]$ for $n=3 ; 4 ; 5 ; 6$ vs 1 for $2=0$, $\mathrm{vs}{ }_{-1}=2$, and vs 2 for $1=0$. The $m$ ain conclusion that can be drawn from these diagram $s$ is that the hierarchy (811) dem onstrated by the dim ensions for the isotropic case $(1 ; 2=0)$ holds valid for all the values of the anisotropy param eters.

## VII. OPERATOR PRODUCTEXPANSION ANDANOMALOUS SCALING

Representations (4) for any scaling functions ( $m$ r) describes the behavior of the correlation functions for $r \gg 1$ and any xed value of mr ; see Sec. V . T The inertial range corresponds to the additional condition $\mathrm{m} r \ll 1$. The form of the functions ( $\mathrm{m} r$ ) is not determ ined by the RG equations them selves; in analogy w th the theory of critical phenom ena, its behavior form $r$ ! 0 is studied using the well-known $W$ ilson operator product expansion (OPE); see, e.g.,

## IX. CONCLUSION

Let us recallibrie $y$ the $m$ ain points of the paper.
W e have studied the anom alous scaling behavior of a passive scalar advected by the tim e-decorrelated strongly
 involves_in nitely $m$ any param eters; $m$ ost practicalcalculations have been perform ed for the truncated tw o-param etric $m$ odel $\left(\overline{1} \overline{4} \overline{4}^{\prime}\right)$, which seem $s$ to represent nicely the $m$ ain features of the general case (14).
 allow s one to apply the RG and OPE techniques to it. The corresponding RG equations have an $\mathbb{R}$ stā̄le xed point, Eq. (42), which leads to the asym ptotic expressions of the type (49), (52') for various correlation fiunctions in the region $r \gg 1$.

Those expressions involve certain scaling functions of the variable $m r$, whose behavior at $m r \ll 1$ is determ ined by the O P E. It establishes the existence of the inertial-range anom alous scaling behavior. T he structure functions are given by superpositions of pow er law S w th nonuniversal (dependent on the anisotropy param eters $1 ; 2$ ) exponents.

The exponents are determ ined by the critical dim ensions of com posite operators ( 5 ( $8_{1}^{\prime \prime}$ ) built of the scalar gradients. In contrast w ith the isotropic velocity eld, these operators in ourm odelm ix in renorm alization such that the $m$ atrices of their critical dim ensions are neither diagonal nor triangular. T hese $m$ atrioes are calculated explicitly to the order
 in $1 ; 2 \mathbb{E}$ qs. (86), (871)] or num erically $\mathbb{E}$ igs. 1 \{9].

In the lim it of vanishing anisotropy, the exponents can be associated with de nite tensor com posite operators built of the scalar gradients, and exhibit a kind of hierarchy related to the degree of anisotropy: the less is the rank, the less is the dim ension and, consequently, the $m$ ore im portant is the contribution to the inertial-range behavior [see Eqs. ( 8 (11) $)$ ].

T he leading term s of the even (odd) structure functions are given by the scalar (vector) operators. For the nite an isotropy, the exponents cannot be associated with individual operators (w hich are essentially $\backslash \mathrm{m}$ ixed" in renorm alization), but, surprising enough, the aforem entioned hierarchy survives for all the cases studied, as is show $n$ in $F$ igs. 2\{9.

The second-order structure function $S_{2}(r)$ is studied in $m$ ore detail using the $R G$ and zero-m ode techniques; like in the isotropic case 志], its leading term has the form $S_{2} / r^{2}$ ", but the amplitude now depends on 1;2 and the angle between the vectors $r$ and $n$ from Eq. (14í). The rst anisotropic correction has the form ( $\mathrm{m} r$ ) ${ }^{[2 ; 2]} \mathrm{w}$ ith the exponent [2;2]=O(") from Eq. (85). The fiunction $S_{2}$ satis es the exact equation (113); this allow $s$ for an altemative derivation of the perturbation theory in ", and also gives a basis for perturbation theories in $1=d$ or the anisotropy param eters $1 ; 2$; see the discussion in Sec. VVII.

It is well know $n$ that, for the isotropic velocity eld, the anisotropy introduced at large scales by the extemal forcing or im posed $m$ ean gradient, persists in the inertial range and reveals itself in odd correlation functions: the skew ness
factor $S_{3}=S_{2}^{3=2}$ decreases form $r$ ! 0 but slow ly (see Refs. increase (see, e.g., [14 [1] [18]).

In the case at hand, the inertial-range behavior of the skew ness is given by $S_{3}=S_{2}^{3=2} /(m r)^{[3 ; 1]}$. For $1 ; 2$ ! 0 , the exponent $[3 ; 1]$ is given by Eq. (80) $w$ ith $n=3$ and $p=1$; it is positive and coincides $w$ th the result of $R$ ef. $[\underline{p}]$. The levels of the dim ension [3;1] on the ${ }_{1}$ \{ 2 plane are shown in $F i g .10$. O ne can see that, if the anisotropy becom es strong enough, [3;1] becom es negative and the skew ness factor increases going dow $n$ tow ards to the depth of the inertial range; the higher-order odd ratios increase already when the anisotropy is w eak.
