A nom alous scaling of a passive scalar in the presence of strong an isotropy

Field theoretic renorm alization group and the operator product expansion are applied to a model. of a passive scalar quantity (t;x), advected by the Gaussian strongly anisotropic velocity eld with the covariance / (t t^0) is x^0 . Inertial-range anom alous scaling behavior is established, and explicit asymptotic expressions for the structure functions S_n (r) h[(t;x + r) (t;x)¹i are obtained; they are represented by superpositions of power laws with nonuniversal (dependent on the anisotropy parameters) anom alous exponents, calculated to the rst order in " in any space dim ension d. In the lim it of vanishing an isotropy, the exponents are associated with tensor composite operators built of the scalar gradients, and exhibit a kind of hierarchy related to the degree of anisotropy: the less is the rank, the less is the dimension and, consequently, the more important is the contribution to the inertial-range behavior. The leading term s of the even (odd) structure functions are given by the scalar (vector) operators. For the nite anisotropy, the exponents cannot be associated with individual operators (which are essentially \m ixed" in renorm alization), but the aforem entioned hierarchy survives for all the cases studied. The second-order structure function S₂ is studied in m ore detail using the renorm alization group and zero-m ode techniques; the corresponding exponents and amplitudes are calculated within the perturbation theories in ", 1=d, and in the anisotropy parameters. If the anisotropy of the velocity is strong enough, the skewness factor $S_3=S_2^{3=2}$ increases going down towards to the depth of the inertial range; the higher-order odd ratios increase even if the anisotropy is weak.

I. IN TRODUCTION

Recently, much e ort has been invested to understand inertial-range anom alous scaling of a passive scalar. Both the natural and num erical experim ents suggest that the violation of the classical K olm ogorov (O bukhov theory [1,2] is even more strongly pronounced for a passively advected scalar eld than for the velocity eld itself; see, e.g., [3,4] and literature cited therein. At the same time, the problem of passive advection appears to be easier tractable theoretically. The most remarkable progress has been achieved for the so-called K raichnan's rapid-change model [5]: for the rst time, the anom alous exponents have been calculated on the basis of a microscopic model and within regular expansions in form all small parameters; see, e.g., [6{12}] and references therein.

W ithin the \zero-m ode approach," developed in [6(10], nontrivial anom abus exponents are related to the zero m odes (unforced solutions) of the closed exact equations satis ed by the equal-time correlations. W ithin the approach based on the eld theoretic renorm alization group (RG) and operator product expansion (OPE), the anom abus scaling emerges as a consequence of the existence in the m odel of com posite operators with negative critical dimensions, which determ ine the anom abus exponents [11[15].

A nother in portant question recently addressed is the e ects of large-scale anisotropy on inertial-range statistics of passively advected elds [9,10,14{19} and the velocity eld itself [20,21]. A coording to the classical K olm ogorov{ O bukhov theory, the anisotropy introduced at large scales by the forcing (boundary conditions, geometry of an obstacle etc.) dies out when the energy is transferred down to the smaller scales owing to the cascade mechanism [1,2]. A number of recent works con rm s this picture for the even correlation functions, thus giving som e quantitative support to the aforem entioned hypothesis on the restored local isotropy of the inertial-range turbulence for the velocity and passive elds [14,16{21}]. M ore precisely, the exponents describing the inertial-range scaling exhibit universality and hierarchy related to the degree of anisotropy, and the leading contribution to an even function is given by the exponent from the isotropic shell [14,15,17{19,21}]. N evertheless, the anisotropy survives in the inertial range and reveals itself in odd correlation functions, in disagreem ent with what was expected on the basis of the cascade ideas. The so-called skew ness factor decreases down the scales m uch slower than expected [3,4,9,10], while the higher-order odd dim ensionless ratios (hyperskew ness ets) increase, thus signalling of persistent sm all-scale anisotropy [14,16,18]. The e ect seem s rather universal, being observed for the scalar [14] and vector [18] elds, advected by the G aussian rapid-change velocity, and for the scalar advected by the two-dim ensional N avier-Stokes velocity eld [16].

In the present paper, we study the anom alous scaling behavior of a passive scalar advected by the time-decorrelated strongly anisotropic G aussian velocity eld. In contradistinction with the studies of [4,9,10,14], where the velocity was

isotropic and the large-scale anisotropy was introduced by the imposed linear mean gradient, the uniaxial anisotropy in our model persists for all scales, leading to nonuniversality of the anom abus exponents through their dependence on the anisotropy parameters.

The aim of our paper is two fold.

Firstly, we obtain explicit inertial-range expressions for the structure functions and correlation functions of the scalar gradients and calculate the corresponding anom abus exponents to the rst order of the "expansion. We show that the exponents in ourm odelbecome e nonuniversal through the dependence on the parameters describing the anisotropy of the velocity statistics, the composite operators of di erent ranks m ix strongly in renorm alization, and the corresponding anom abus exponents are given by the eigenvalues of the m atrices which are neither diagonal nor triangular (in contrast with the case of large-scale anisotropy). In the language of the zero-m ode technique this means that the SO (d) decompositions of the corresponding exact equations.

Nevertheless, the hierarchy obeyed by the exponents for the vanishing anisotropy survives when the anisotropy becomes strong. This fact (along with the nonuniversality) is the main qualitative result of the paper.

A nother scope of the paper is to give the detailed account of the RG approach and to compare the results obtained within both the RG and zero-m ode techniques on the example of the second-order structure function.

The paper is organized as follows.

In Sec. II, we give the precise form ulation of the model and outline brie y the general strategy of the RG approach. In Sec. III, we give the eld theoretic form ulation of the model and derive the exact equations for the response function and pair correlator.

In Sec. IV, we perform the ultraviolet (UV) renorm alization of the model and derive the corresponding RG equations with exactly known RG functions (functions and anom alous dimensions). These equations possess an infrared (IR) stable xed point, which establishes the existence of IR scaling with exactly known critical dimensions of the basic elds and parameters of the model.

In Sec. V, we discuss the solution of the RG equations for various correlation functions and determ ine the dependence of the latter on the UV scale.

In Sec. V I, we discuss the renorm alization of various composite operators. In particular, we derive the one-bop result for the critical dimensions of the tensor operators, constructed of the scalar gradients.

In Sec. V II, we show that these dimensions play the part of the anom alous exponents, and present explicit inertialrange expressions for the structure functions and correlations of the scalar gradients.

In Sec. V III, we give the detailed comparison of the RG and zero-m ode techniques on the example of the secondorder structure function, compare the representation obtained using RG and OPE with the ordinary perturbation theory, and calculate the amplitude factors in the corresponding power laws.

The results obtained are reviewed in Sec. IX.

II. DEFINITION OF THE MODEL.ANOMALOUS SCALING AND \DANGEROUS" COMPOSITE OPERATORS.

The advection of a passive scalar eld (x) (t;x) in the rapid-change model is described by the stochastic equation

where $@_t @=@t, @_i @=@x_i, _0$ is the molecular di usivity coe cient, is the Laplace operator, v(x) is the transverse (ow ing to the incom pressibility) velocity eld, and f f(x) is a Gaussian scalar noise with zero m ean and correlator

Here ' is an integral scale related to the scalar noise and C (r=') is a function nite as '! 1. With no loss of generality, we take C (0) = 1 in what follows. The velocity v(x) obeys a Gaussian distribution with zero mean and correlator

In the isotropic case, the tensor quantity $T_{ij}(k)$ in (3) is taken to be the ordinary transverse projector, $T_{ij}(k) = P_{ij}(k)$ $i_{j} k_{i}k_{j}=k^{2}$, $k \quad j_{k}j D_{0} > 0$ is an amplitude factor, 1=m is another integral scale, and d is the dimensionality of the x space; 0 < " < 2 is a parameter with the real (K olm opprov) value " = 4=3. de ne the coupling constant g₀ (i.e., the form al expansion parameter in the ordinary perturbation theory) and the characteristic UV momentum scale . In what follows, we shall not distinguish the two IR scales, setting m ' 1='. The issue of interest is, in particular, the behavior of the equal-tim e structure functions

in the inertial range, specied by the inequalities 1 = << r << 1 = m' `. In the isotropic case, the odd functions S_{2n+1} vanish, while for S_{2n} dimensionality considerations give

where R_{2n} are some functions of dimensionless parameters. In principle, they can be calculated within the ordinary perturbation theory (i.e., as series in g_0), but this is not useful for studying inertial-range behavior: the coe cients are singular in the limits r! 1 and/orm r! 0, which compensate the smallness of g_0 (assumed in ordinary perturbation theory), and in order to nd correct IR behavior we have to sum the entire series. The desired sum mation can be accomplished using the eld theoretic renorm alization group (RG) and operator product expansion (OPE); see R efs. [12{14].

The RG analysis consists of two main stages. On the rst stage, the multiplicative renorm alizability of the model is dem onstrated and the di erential RG equations for its correlation functions are obtained. The asymptotic behavior of the functions like (5) for r >> 1 and any xed m r is given by IR stable xed points of the RG equations and has the form

with certain, as yet unknown, \scaling functions" R_{2n} (m r). In the theory of critical phenom ena [22,23], the quantity 2n + n is term ed the \critical dimension," and the exponent n, the difference between the critical [S_{2n}] dimension $[S_{2n}]$ and the \canonical dimension" 2n, is called the \anom alous dimension." In the case at hand, the latter has an extrem ely simple form : n = n". W hatever be the functions R_n (m r), the representation (7) in plies the existence of a scaling (scale invariance) in the IR region (r >> 1, mr xed) with de nite critical dimensions of all Rrelevant" parameters, $[S_{2n}] = 2n + n$ ", r = 1, m = 1 and xed \irrelevant" parameters 0 and . This means that the structure functions (5) scale as S_{2n} ! $[S_{2n}]S_{2n}$ upon the substitution m ! ^m m , r ! r. In general, the exponent [S_{2n}] is replaced by the critical dimension of the corresponding correlation function. This dimension is calculated as a series in ", so that the exponent " plays the part analogous to that played by the parameter " = 4 d in the RG theory of critical phenomena, while ' is an analog of the correlation length ' r_c ; see [22,23].

On the second stage, the small m r behavior of the functions R_{2n} (m r) is studied within the general representation (7) using the OPE. It shows that, in the lim it m r! 0, the functions R_{2n} (m r) have the asymptotic form s

where C_F are coe cients regular in m r. In general, the sum m ation is in plied over all possible renorm alized com posite operators F allowed by the symmetry (more precisely, see Sec. VII); F] being their critical dimensions. W ithout loss of generality, it can be assumed that the expansion is made in irreducible tensors; in the isotropic case only scalar operators have nonvanishing m ean values and contribute to the right hand side of Eq. (8).

The peculiarity of the models describing turbulence is the existence of the so-called \dangerous" composite operators with negative critical dimensions [12{14,24,25]. Their contributions into the OPE give rise to a singular behavior of the scaling functions for mr! 0, and the leading term is given by the operator with minimal F]. The leading contributions to S_{2n} are determ ined by scalar gradients $F_n = (0_1 \ 0_1)^n$ and have the form

where the critical dimensions n of the operators F_n are given by

The expression (9) agrees with the results obtained earlier in [7,8] using the zero-m ode techniques; the O ("²) contribution to n is obtained in [12].

In the theory of turbulence, the singular m dependence of correlation functions with the exponents nonlinear in n is referred to as anom alous scaling, and $_n$ them selves are term ed the anom alous exponents; see, e.g., [1,2]. The above discussion shows that the anom alous exponents (in the sense of the turbulence theory) are not simply related to the anom alous or critical dimensions (in the sense of the theory of phase transitions) of the structure functions them selves; they are determ ined by the critical dimensions of certain composite operators entering into the corresponding OPE.¹

In a num ber of papers, e.g. [4,9,10,14], the arti cial stirring force in Eq. (1) was replaced by the term (hv), where h is a constant vector that determ ines the distinguished direction and therefore introduces large-scale anisotropy. The anisotropy gives rise to nonvanishing odd functions S_{2n+1} . The critical dimensions of all composite operators remain unchanged, but the irreducible tensor operators acquire nonzero mean values and their contributions appear on the right hand side of Eq. (8); see [14]. This is easily understood in the language of the zero-mode approach: the noise f and the term (hv) do not a left the di erential operators in the equations satis ed by the equal-time correlations functions; the zero modes (hom ogeneous solutions) coincide in the two cases, but in the latter case the modes with nontrivial angular dependence should be taken into account.

The direct calculation to the order O (") has shown that the leading exponent associated with a given rank contribution to Eq. (1) decreases monotonically with the rank [14]. Hence, the leading term of the inertial-range behavior of an even structure function is determined by the same exponent (10), while the exponents related to the tensor operators determine only subleading corrections. A similar hierarchy has been established recently in Ref. [17] (see also [18]) for the magnetic eld advected passively by the rapid-change velocity in the presence of a constant background eld, and in [21] within the context of the N avier{Stokes turbulence.

Below we shall take the velocity statistics to be an isotropic also at small scales. We replace the ordinary transverse projector in Eq. (3) with the general transverse structure that possesses the uniaxial an isotropy:

Here the unit vector n determ ines the distinguished direction $(n^2 = 1), n_i(k) = P_{ij}(k)n_j$, and is the angle between the vectors k and n, so that $(nk) = k \cos [note that (nk) = 0]$. The scalar functions can be decomposed the G egenbauer polynom ials (the d-dimensional generalization of the Legendre polynom ials, see Ref. [37]):

(we shall see later that odd polynom ials do not a ect the scaling behavior). The positivity of the correlator (3) leads to the conditions

In practical calculations, we shall mostly con ne ourselves with the special case

Then the inequalities (13) reduce to $_{1,2}$ > 1. We shall see that this case represents nicely all the main features of the generalm odel (11).

We note that the quantities (11), (14) possess the sym m etry n ! n. The anisotropy m akes it possible to introduce mixed correlator hvfi/n (t t⁰) C⁰(r=') with some function C⁰(r=') analogous to C (r=') from Eq. (2). This violates the evenness in n and gives rise to nonvanishing odd functions S_{2n+1} . How ever, this leads to no serious alterations in the RG analysis; we shall discuss this case in Sec. V II, and for now we assume hvfi= 0.

In a number of papers, e.g., $[30{34}]$, the RG techniques were applied to the anisotropically driven N avier{Stokes equation, including passive advection and magnetic turbulence, with the expression (14) entering into the stirring force correlator. The detailed account can be found in Ref. [25], where som e errors of the previous treatments are also corrected. How ever, these studies have up to now been limited to the rst stage, i.e., investigation of the existence and stability of the xed points and calculation of the critical dimensions of basic quantities. C alculation of the anom alous exponents in those models remains an open problem.

¹ The OPE and the concept of dangerous operators in the stochastic hydrodynam ics were introduced and investigated in detail in [26]; see also [24,25]. For the K raichnan m odel, the relationship between the anom alous exponents and dimensions of com posite operators was anticipated in [6{8,11} within certain phenom enological form ulation of the OPE, the so-called \additive fusion rules," typical to the m odels with multifractal behavior [27]. A similar picture has been discussed in [28,29] in connection with the Burgers turbulence and grow th phenom ena.

The stochastic problem (1) { (3) is equivalent to the eld theoretic model of the set of three elds f⁰; ;vg with action functional

The rst four terms in Eq. (15) represent the M artin{Siggia{Rose-type action for the stochastic problem (1), (2) at xed v (see, e.g., [22,23]), and the last term represents the G aussian averaging over v. Here D and D_v are the correlators (2) and (3), respectively, the required integrations over x = (t; x) and sum m ations over the vector indices are in plied.

The form ulation (15) means that statistical averages of random quantities in stochastic problem (1){(3) can be represented as functional averages with the weight exp S(), so that the generating functionals of total [G(A)] and connected [W(A)] G reen functions of the problem are given by the functional integral

The model (15) corresponds to a standard Feynm an diagram matic technique with the triple vertex ${}^{0}(v \circ)$ ${}^{0}V_{j}v_{j}$ with vertex factor (in the momentum -frequency representation)

where k is the momentum owing into the vertex via the eld . The bare propagators in the momentum -frequency representation have the form

The pair correlation functions h i of the multicomponent eld f 0 ; y g satisfy standard D yson equation, which in the component notation reduces to the system of two equations, cf. [1]

where G(!;k) h⁰i and D(!;k) h i are the exact response function and pair correlator, respectively, and •, • • • • • are self-energy operators represented by the corresponding 1-irreducible diagram s; all the other functions

in the model (15) vanish identically.

The feature characteristic of the models like (15) is that all the skeleton multiloop diagram s entering into the self-energy operators \circ , $\circ \circ$ contain e ectively closed circuits of retarded propagators h \circ i (it is crucial here that the propagator hvvi₀ in Eq. (3) is proportional to the function in time) and therefore vanish.

Therefore the self-energy operators in (19) are given by the one-loop approximation exactly and have the form

where $q^0 = k = q$. The solid lines in the diagram s denote the exact propagators $h^{-0}i$ and h = i, the ends with a slash correspond to the eld 0, and the ends without a slash correspond to ; the dashed lines denote the bare propagator (3); the vertices correspond to the factor (17).

The integrations over !⁰ in the right-hand sides of Eqs. (20) give the equal-time response function G (q) = (1=2) d!⁰G (!⁰;q) and the equal-time pair correlator D (q) = (1=2) d!⁰D (!⁰;q); note that both the self-energy operators are in fact independent of !. The only contribution to G (q) comes from the bare propagator h⁰i₀ from Eq. (18), which in the trepresentation is discontinuous at coincident times. Since the correlator (3), which enters into the one-loop diagram for ^o, is symmetric in t and t⁰, the response function must be de ned at t = t⁰ by half the sum of the limits. This is equivalent to the convention G (q) = (1=2) d!^o (i!⁰ + $_0q^2$)¹ = 1=2 and gives

Equation (22) can also be rewritten as a partial di erential equation for the pair correlator in the coordinate representation, D (r) h (t;x) (t;x + r)i [we use the same notation D for the coordinate function and its Fourier transform]. Noting that the integral in Eq. (22) involves convolutions of the functions D (k) and D $_0 T_{ij}$ (q)=(q² + m²)^{d=2+} "=², and replacing the momenta by the corresponding derivatives, ik_i ! For 0 < " < 2, equations (22){ (24) allow for the limit m ! 0: the possible \mathbb{R} divergence of the integrals at q = 0 is suppressed by the vanishing of the expressions in the square brackets. For the isotropic case (i.e., after the substitution T_{ij} ! P_{ij}) Eq. (23) coincides (up to the notation) with the well-known equation for the equal-time pair correlator in the model [5].

Equation (21) will be used in the next section for the exact calculation of the RG functions; solution of Eq. (23) will be discussed in Sec. V III in detail.

IV.RENORMALIZATION, RG FUNCTIONS, AND RG EQUATIONS

The analysis of the UV divergences is based on the analysis of canonical dimensions. Dynamical models of the type (15), in contrast to static models, have two scales, so that the canonical dimension of some quantity F (a eld or a parameter in the action functional) is described by two numbers, the momentum dimension d_F^k and the frequency dimension d_F^k . They are determined so that $[F] [L] d_F^k [T] d_F^l$, where L is the length scale and T is the time scale. The dimensions are found from the obvious normalization conditions $d_K^k = d_K^k = 1$, $d_F^l = d_R^l = 0$, $d_F^k = d_R^k = 0$, $d_F^l = d_R^l = 1$, and from the requirement that each term of the action functional be dimensionless (with respect to the momentum and frequency dimensions separately). Then, based on d_F^k and d_F^l , one can introduce the total canonical dimension $d_F = d_F^k + 2d_F^l$ (in the free theory, $\ell_L / r)$, which plays in the theory of renormalization of dynamical models the same role as the conventional (momentum) dimension does in static problem s.

The dimensions for the model (15) are given in Table I, including the parameters which will be introduced later on. >From Table I it follows that the model is logarithm ic (the coupling constant g_0 is dimensionless) at " = 0, so that the UV divergences have the form of the poles in " in the G reen functions.

The total canonical dimension of an arbitrary 1-irreducible G reen function $= h_{1}$ ir is given by the relation

where $N = fN_{\circ}; N_{v}g$ are the numbers of corresponding elds entering into the function , and the summation over all types of the elds is implied. The total dimension d is the formal index of the UV divergence. Super cial UV divergences, whose removal requires counterterms, can be present only in those functions for which d is a non-negative integer.

A nalysis of the divergences should be based on the following auxiliary considerations:

(i) From the explicit form of the vertex and bare propagators in the model (15) it follows that N \circ N = 2N₀ for any 1-irreducible G reen function, where N₀ 0 is the total number of bare propagators h i₀ entering into the function (obviously, no diagram s with N₀ < 0 can be constructed). Therefore, the di erence N \circ N is an even non-negative integer for any nonvanishing function.

(ii) If for some reason a number of external momenta occurs as an overall factor in all the diagram s of a given G reen function, the real index of divergence d^0 is smaller than d by the corresponding number (the G reen function requires counterterm s only if d^0 is a non-negative integer). In the model (15), the derivative 0 at the vertex ${}^0(v0)$ can be moved onto the eld 0 by virtue of the transversality of the eld v. Therefore, in any 1-irreducible diagram it is always possible to move the derivative onto any of the external \tails" or 0 , which decreases the real index of

divergence: $d^0 = d$ N N \circ . The elds , ⁰ enter into the counterterm s only in the form of derivatives (0, 0). From the dimensions in Table I we nd d = d + 2 N_v + N (d + 1)N \circ and $d^0 = (d + 2)(1$ N $\circ)$ N_v. It then follows that for any d, super cial divergences can exist only in the 1-irreducible functions h 0 ::: i_1 ir with N \circ = 1 and arbitrary value of N , for which d = 2, $d^0 = 0$. However, all the functions with N > N \circ vanish (see above) and obviously do not require counterterm s. We are left with the only super cially divergent function h 0 i_1 ir; the corresponding counterterm s must contain two symbols (0) and in the isotropic case reduce to the only structure 0 . In the presence of anisotropy, it is necessary to also introduce new counterterm of the form $^0(n(0)^2)$, which is absent in the unrenorm alized action functional (15). Therefore, the model (15) in its original form ulation is not multiplicatively renorm alizable, and in order to use the standard RG techniques it is necessary to extend the model by adding the new contribution to the unrenorm alized action:

Here $_0$ is a new dimensionless unrenormalized parameter. The stability of the system implies the positivity of the total viscous contribution $_0k^2 + _{0 0} (nk)^2$, which leads to the inequality $_0 > 1$. Its real (\physical") value is zero, but this fact does not hinder the use of the RG techniques, in which it is rst assumed to be arbitrary, and the equality $_0 = 0$ is imposed as the initial condition in solving the equations for invariant variables (see Sec. V). Below we shall see that the zero value of $_0$ corresponds to certain nonzero value of its renormalized analog, which can be found explicitly.

For the action (26), the nontrivial bare propagators in (18) are replaced with

(39), (40) is a consequence of the UV niteness of the anom alous dimensions $_F$; their independence of " is a property of the MS scheme. Note also that the expressions (38) { (40) are exact, i.e., have no corrections of order g^2 and higher; this is a consequence of the fact that the one-loop approximation (21) for the self-energy operator is exact.

The xed points of the RG equations are determ ined from the requirem ent that all the beta functions of the model vanish. In our model the coordinates g; of the xed points are found from the equations

From the explicit expressions (39), (40) it then follows that the RG equations of the model have the only IR stable xed point with the coordinates

V.SOLUTION OF THE RG EQUATIONS. INVARIANT VARIABLES

The solution of the RG equations is discussed in Refs. [22{26] in detail; below we can ne ourselves to only the information we need.

Consider the solution of the RG equation on the exam ple of the even di erent-time structure functions

² Form ally, $_{1,2}$ can be treated as the additional coupling constants. The corresponding beta functions $_{1,2}$ \mathbb{P} $_{1,2}$ vanish identically owing to the fact that $_{1,2}$ are not renorm alized. Therefore the equations $_{1,2} = 0$ give no additional constraints on the values of the parameters g; at the xed point.

In general, the large r behavior of the invariant variables is governed by the IR stable xed point: $g \mid g \mid$, ! for r ! 1. However, in multicharge problem s one has to take into account that even when the IR point exists, not every phase trajectory (i.e., solution of Eq. (46)) reaches it in the limit r ! 1. It may rst pass outside the natural region of stability [in our case, g > 0, > 1] or go to in nity within this region. Fortunately, in our case the constants Z_F entering into Eq. (46) are known exactly from Eqs. (38), and it is readily checked that the RG ow indeed reaches the xed point (42) for any initial conditions $g_0 > 0$, $_0 > 1$, including the physical case $_0 = 0$. Furtherm ore, the large r behavior of the invariant viscosity is also found explicitly from Eq. (46) and the last relation in (30): $= D_0 r^{"}=g$ (we recall that $D_0 = g_{0-0}$). [35] for the stirred Navier{Stokes equation and is related to the Second K olm ogorov hypothesis; see also the discussion in [25,26].

Now let us turn to the general case. Let F (r;) be some multiplicatively renorm alized quantity (say, a correlation function involving composite operators), i.e., $F = Z_F F_R$ with certain renorm alization constant Z_F . It satis as the RG equation of the form $D_{RG} + _F F_R = 0$ with $_F$ from (33a). Dimensionality considerations give

VI.RENORMALIZATION AND CRITICAL DIMENSIONS OF COMPOSITE OPERATORS

Any local (unless stated to be otherwise) monom ial or polynom ial constructed of primary elds and their derivatives at a single spacetime point x (t;x) is termed a composite operator. Examples are N (x), $[0_{i}$ (x) $(0_{i}$ (x)]^{N}, $(0_{i}$ (x) $(0_{i}$ (x)) $(1, 1)^{N}$, $(0, 1)^{N}$,

Since the arguments of the elds coincide, correlation functions with such operators contain additional UV divergences, which are removed by additional renorm alization procedure; see, e.g., [22,23]. For the renorm alized correlation functions standard RG equations are obtained, which describe IR scaling of certain \basis" operators F with de nite critical dimensions $_{\rm F}$ [F]. Due to the renorm alization, [F] does not coincide in general with the naive sum of

critical dimensions of the elds and derivatives entering into F. As a rule, composite operators mix in renormalization, i.e., an UV nite renormalized operator F^R has the form $F^R = F + \text{counterterm} s$, where the contribution of the counterterm s is a linear combination of F itself and, possibly, other unrenormalized operators which \admix" to F in renormalization.

Let F fF g be a closed set, all of whose monom ials mix only with each other in renorm alization. The renorm alization matrix Z_F fZ g and the matrix of anom alous dimensions $_F$ f g for this set are given by

(56) we obtain d = N + N N_{\rm V} (d+1)N $_{\rm 0}$, and from the analysis of the diagram s it follows that the total number of the elds entering into the function can never exceed the number of the elds in the operator $^{\rm N}$ itself, i.e., N N (cf. item (i) in Sec. IV). Therefore, the divergence can only exist in the functions with N_{\rm V} = N $_{\rm 0}$ = 0, and arbitrary value of N = N , for which the form al index vanishes, d = 0. How ever, at least one of N external \tails" of the desired type with all the external tails attached to the vertex F), at least one derivative (appears as an extra factor in the diagram , and, consequently, the real index of divergence d⁰ is necessarily negative.

This means that the operator ^N requires no counterterms at all, i.e., it is in fact UV nite, ^N = Z [^N]^R with Z = 1. It then follows that the critical dimension of ^N (x) is simply given by the expression (53) with no correction from _F and is therefore reduced to the sum of the critical dimensions of the factors:

It is also clear from the analysis of the diagram s that the counterterm s to these operators can involve the elds , ⁰ only in the form of derivatives, (0, 0, 0), so that the real index of divergence has the form $d^0 = d = N = N_v$ (d + 2)N °. It then follows that super cial divergences can exist only in the G reen functions with $N_v = N = 0$ and any N = N, and that the corresponding operator

It is then obvious that the critical dimensions associated with the operators F[N;p] are completely determined by the eigenvalues of the nite subblocks with $N^0 = N$. In the following, we shall not be interested in the precise form of the basis operators (55), we rather shall be interested in the anom alous dimensions them selves. Therefore, we can neglect all the elements of the matrix (59) other than $Z_{[N,p][N,p^0]}$.

In the isotropic case, as well as in the presence of large-scale anisotropy, the elements $Z_{[N,p][N,p^0]}$ vanish for $p < p^0$, and the block $Z_{[N,p][N,p^0]}$ is triangular along with the corresponding blocks of the matrices U_F and $_F$ from Eqs. (55), (53). In the isotropic case it can be diagonalized by changing to irreducible operators (scalars, vectors, and traceless tensors), but even for nonzero in posed gradient its eigenvalues are the same as in the isotropic case. Therefore, the inclusion of large-scale anisotropy does not a ect critical dimensions of the operators (58); see [14]. In the case of sm all-scale anisotropy, the operators with di erent values of p m is heavily in renorm alization, and the matrix $Z_{[N,p][N,p^0]}$ is neither diagonal nor triangular here.

Now let us turn to the calculation of the renorm alization constants $Z_{[N,p][N,p^0]}$ in the one-loop approximation. Let (x;) be the generating functional of the 1-irreducible G reen functions with one composite operator F [N;p] from Eq. (58) and any number of elds . Here x (t;x) is the argument of the operator and is the functional argument, the \classical counterpart" of the random eld . These expressions illustrate two facts which seem to hold for all N: (i) The leading anisotropy correction is of order O ($_{1,2}$) for $p \in 0$ and O ($_{1,2}^2$) for p = 0, so that the dimensions [N;0] are anisotropy independent in the linear approximation, and

(ii) This leading contribution depends on $_{1,2}$ only through the combination $_3$ 2 $_1$ + d $_2$.

The eigenvalues beyond the small $_{1;2}$ expansion have been obtained numerically. Some of them are presented in Figs. 2{5, namely, the dimensions [n;p] for n = 3;4;5;6 vs $_1$ for $_2 = 0$, vs $_1 = _2$, and vs $_2$ for $_1 = 0$. The main conclusion that can be drawn from these diagrams is that the hierarchy (81) demonstrated by the dimensions for the isotropic case ($_{1;2} = 0$) holds valid for all the values of the anisotropy parameters.

VII.OPERATOR PRODUCT EXPANSION AND ANOMALOUS SCALING

Representations (49) for any scaling functions (m r) describes the behavior of the correlation functions for r >> 1and any xed value of mr; see Sec. V. The inertial range corresponds to the additional condition m r << 1. The form of the functions (m r) is not determ ined by the RG equations them selves; in analogy with the theory of critical phenomena, its behavior for m r ! 0 is studied using the well-known W ilson operator product expansion (OPE); see, e.g., [22[26].

A coording to the OPE, the equal-time product $F_1(x)F_2(x^0)$ of two renormalized operators for x $(x + x^0)=2 = \text{const}$ and r x x^0 ! 0 has the representation

The renorm alized correlator hF₁ (x)F₂ (x⁰) i is obtained by averaging Eq. (88) with the weight exp S_R with the renorm alized action (28); the quantities hF i / m ^F appear on the right hand side.

From the operator product expansion (88) we therefore nd the following expression for the scaling function (m r) in the representation (49) for the correlator $hF_1(x)F_2(x^0)i$:

II); this does not a let the critical dimensions, but gives rise to nonvanishing odd structure functions. In general, the operators entering into the OPE are those which appear in the corresponding Taylor expansions, and also all possible operators that adm ix to them in renorm alization [22,23]. The leading term of the Taylor expansion for the function S_N is obviously given by the operator N is presented by the renormalization [22,23]. The leading term of gives rise to all the operators $F N^{\circ}$; p] with $N^{\circ} = N$ and all possible values of p. The operators with $N^{\circ} > N$ (whose contributions would be more important) do not appear in Eq. (89), because they do not enter into the Taylor expansion for S_N and do not adm ix in renormalization to the terms of the Taylor expansion; see Sec. V I. Therefore, combining the RG representation (47) with the OPE representation (89) gives the desired asymptotic expression for the structure function in the inertial range:

The dots stand for the contributions of the operators other than F [N;p], for example, $0^2 (2^2)$; they give rise to the term s of order (m r)²⁺⁰ (") and higher and will be neglected in what follows. Some remarks are now in order.

(i) If the mixed correlator hvfi is absent, the odd structure functions vanish, while the contributions to even functions are given only by the operators with even values of N⁰. In the isotropic case ($_{1;2} = 0$) only the contributions with p = 0 survive; see [12]. In the presence of the anisotropy, $_{1;2} \notin 0$, the operators with $p \notin 0$ acquire nonzero m can values, and their dimensions N⁰; p] also appear on the right hand side of Eq. (90).

(ii) The leading term of the small mr behavior is obviously given by the contribution with the minimal possible value of \mathbb{N}^{-0} ; p]. Now we recall the hierarchy relations (81a), (81b), which hold for $_{1,2} = 0$ and therefore remain valid at least for $_{1,2} < < 1$. This means that, if the anisotropy is weak enough, the leading term in Eq. (90) is given by the dimension \mathbb{N} ; 0] for any S $_{\mathbb{N}}$. For all the special cases studied in Sec. V I, this hierarchy persists also for nite values of the anisotropy parameters, and the contribution with \mathbb{N} ; 0] remains the leading one for such N and $_{1,2}$. (iii) O f course, it is not in possible that the inequalities (81a), (81b) break down for some values of n, d and $_{1,2}$.

and the leading contribution to Eq. (90) is determ ined by a dimension with N⁰ 6 N and/orp > 0. Furtherm ore, it is not in possible that the matrix (79) for som e $_{1,2}$ had a pair of complex conjugate eigenvalues,

and . Then the smallm r behavior of the scaling function (m r) entering into Eq. (90) would involve oscillating terms of the form

A nother exotic situation emerges if the matrix (79) cannot be diagonalized and is only reduced to the Jordan form. In this case, the corresponding contribution to the scaling function would involve a logarithmic correction to the powerlike behavior, $(m r) = C_1 \ln (m r) + C_2$, where is the eigenvalue related to the Jordan cell. However, these interesting hypothetical possibilities are not actually realized for the special cases studied above in Sec. VI.

(iv) The inclusion of the mixed correlator hvfi / n (t t^0) C⁰(r=') violates the evenness in n and gives rise to nonvanishing odd functions S_{2n+1} and to the contributions with odd N⁰ to the expansion (90) for even functions. If the hierarchy relations (81a), (81b) hold, the leading term for the even functions will still be given by the contribution with N;0]. If the relations (81c) hold, the leading term for the odd function S_{2n+1} will be given by the dimension

[2n;0] for n < (d+2)=4 and by [2n + 1;1] for n > (d+2)=4. Note that for the model with an imposed gradient, the leading terms for S_{2n+1} are given by the dimensions [2n + 1;1] for all n; see [14]. This can be related to the observation of Ref. [39] that the odd structure functions of the velocity eld appear more sensitive to the anisotropy than the even functions.

Representations similar to Eqs. (49), (90) can easily be written down for any equal-time pair correlator, provided its canonical and critical dimensions are known. In particular, for the operators F [N;p] in the IR region (r! 1, mr xed) one obtains

So far, we have discussed the special case of the velocity correlator given by Eqs. (3), (14). Let us conclude this Section with a brief discussion of the general case (11). The RG analysis given above in Secs. III{V II can be extended directly to this case; no serious alterations are required. From the expressions (21), (71) it in mediately follows that only even polynom ials in the expansion (12) can give contributions to the renorm alization constants, and consequently, to the coordinates of the xed point and the anom alous dimensions. For this reason, the odd polynom ials were om itted in Eq. (12) from the very beginning. Moreover, it is clear from Eq. (21) that only the coe cients $a_1 \le 1 = 0;1$ and $b_1 \le 1 = 0;1;2$ contribute to the constants $Z_{1;2}$ in Eq. (28) and therefore to the basic RG functions (33) and to the coordinates of the xed point in Eq. (42). Therefore, the xed point in the generalm odel (11) is parametrized com pletely by these ve coe cients; the higher coe cients enter only via the positivity conditions (13).

Furtherm one, it is clear from Eqs. (71) that for = 0, only coe cients a $_1$ with 1 2 and b₁ with 1 3 can contribute to the integrals H_n and, consequently, to the one-loop critical dimensions (79). Therefore, the calculation of the latter essentially simplies for the special case a₀ = 1, a₁ = 0 and b₁ = 0 for 1 2 in Eq. (11). Then the coordinates of the xed point (42) are the same as in the isotropic m odel, in particular, = 0, and the anom alous exponents will depend on the only two parameters a₂ and b₃. We have performed a few sample calculations for this situation; the results are presented in Figs. 6{9 for [n;p] with n = 3;4;5;6 vs a₂ for b₃ = 0, vs a₂ = b₃, and vs b₃ for a₂ = 0. In all cases studied, the general picture has appeared sim ilar to that outlined above for the case (14). In particular, the hierarchy of the critical dimensions, expressed by the inequalities (81), persists also for this case. We may conclude that the special case (14) case represents nicely all the main features of the generalm odel (11).

VIII.EXACT SOLUTION FOR THE SECOND-ORDER STRUCTURE FUNCTION AND CALCULATION OF THE AM PLITUDES

The form al statem ent of the problem is to sum up the expansion (97) assuming that " is small with the additional condition that " $\ln u = 0$ (1). The desired solution is given by the OPE; it shows that the small u behavior of (u) for the second-order structure function has the form, see Eqs. (89) and (90) in Sec. V II:

C alculation of the term s (" ln u)^p with p > 1 gives additional equations for the same quantities C $_{1;2}^{(0)}$, which must be satis ed autom atically and can therefore be used to verify the representation (98). Below we shall show that the solution (128) coincides with the RG result (112) for m = 0. To this end, we shall show rst that the last term in Eq. (112), proportional to (m r), is an eigenfunction of the operator in the left hand side of Eq. (113) with the eigenvalue of zero. [6] (owing to the z! z symmetry of our model, only even n can contribute). From the RG view points, the exponents in Eq. (134) are related to the n-th rank composite operators built of two elds and n derivatives; in particular, 2 (which gives the leading correction for m r << 1) coincides with the dimension [2;2].

In order to nd the O ($_{1;2}$) correction to $_{2}^{(0)}$, which we denote $_{2}^{(1)}$, we expand the operator L () from Eq. (118) around the point $_{1;2} = 0$ and $= _{2}^{(0)}$ up to the term s linear in $_{1;2}$ and $_{2}^{(1)}$:

IX . C O N C LU S IO N

Let us recall brie y the main points of the paper.

We have studied the anom alous scaling behavior of a passive scalar advected by the tim e-decorrelated strongly anisotropic G aussian velocity eld. The statistics of the latter is given by Eqs. (3) and (11). The general case (11) involves in nitely m any parameters; most practical calculations have been performed for the truncated two-parametric m odel (14), which seems to represent nicely the main features of the general case (14).

The original stochastic problem (1){(3) can be cast as a renormalizable eld theoretic model [Eqs. (15){(18)], which allow some to apply the RG and OPE techniques to it. The corresponding RG equations have an IR stable xed point, Eq. (42), which leads to the asymptotic expressions of the type (49), (52) for various correlation functions in the region r >> 1.

Those expressions involve certain scaling functions of the variable m r, whose behavior at m r << 1 is determined by the OPE. It establishes the existence of the inertial range anom alous scaling behavior. The structure functions are given by superpositions of power laws with nonuniversal (dependent on the anisotropy parameters $_{1;2}$) exponents.

The exponents are determ ined by the critical dimensions of composite operators (58) built of the scalar gradients. In contrast with the isotropic velocity eld, these operators in our modelm ix in renormalization such that the matrices of their critical dimensions are neither diagonal nor triangular. These matrices are calculated explicitly to the order O(") Eqs. (74), (76), (78), (79)], but their eigenvalues (anomalous exponents) can be found explicitly only as series in $_{1,2}$ Eqs. (86), (87)] or numerically Figs. 1{9].

In the lim it of vanishing anisotropy, the exponents can be associated with de nite tensor composite operators built of the scalar gradients, and exhibit a kind of hierarchy related to the degree of anisotropy: the less is the rank, the less is the dimension and, consequently, the more important is the contribution to the inertial-range behavior [see Eqs. (81)].

The leading terms of the even (odd) structure functions are given by the scalar (vector) operators. For the nite anisotropy, the exponents cannot be associated with individual operators (which are essentially m ixed" in renorm alization), but, surprising enough, the aforem entioned hierarchy survives for all the cases studied, as is shown in Figs. 2(9.

The second-order structure function $S_2(r)$ is studied in more detail using the RG and zero-mode techniques; like in the isotropic case [5], its leading term has the form S_2 / r^2 ", but the amplitude now depends on $_{1;2}$ and the angle between the vectors r and n from Eq. (14). The rst anisotropic correction has the form (m r) $^{[2;2]}$ with the exponent [2;2] = 0 (") from Eq. (85). The function S_2 satisfies the exact equation (113); this allows for an alternative derivation of the perturbation theory in ", and also gives a basis for perturbation theories in 1=d or the anisotropy parameters $_{1;2}$; see the discussion in Sec.V III.

It is wellknown that, for the isotropic velocity eld, the anisotropy introduced at large scales by the external forcing or in posed m ean gradient, persists in the inertial range and reveals itself in odd correlation functions: the skewness

factor $S_3=S_2^{3=2}$ decreases for m r ! 0 but slow ly (see R efs. [3,4,9,10]), while the higher-order ratios $S_{2n+1}=S_2^{n+1=2}$ increase (see, e.g., [14,16,18]).

In the case at hand, the inertial-range behavior of the skewness is given by $S_3=S_2^{3=2}$ / (m r) ^[3;1]. For _{1;2} ! 0, the exponent [3;1] is given by Eq. (80) with n = 3 and p = 1; it is positive and coincides with the result of Ref. [9]. The levels of the dimension [3;1] on the ₁{ 2 plane are shown in Fig. 10. One can see that, if the anisotropy becomes strong enough, [3;1] becomes negative and the skewness factor increases going down towards to the depth of the inertial range; the higher-order odd ratios increase already when the anisotropy is weak.
