# A new class of sem iclassical w ave function uniform izations

#### Abstract

W e present a new sem iclassical technique which relies on replacing com plicated classical $m$ anifold structure $w$ ith sim pler $m$ anifolds, which are then evaluated by the usual sem iclassical rules. U nder circum stances where the originalm anifold structure gives poor or useless results sem iclassically the replacem ent $m$ anifolds can yield rem arkable accuracy. W e give several working exam ples to ilhustrate the theory presented here.


## I. IN TRODUCTION

Sem iclassicalm ethods are based on classicalm echanics; the relevant classical $m$ anifolds form the \skeleton" to which the wave function is attached. H ow ever, associating a sem iclassicalw ave function $w$ th a classicalm anifold is problem atic when enclosed loops in phase space have area less than ~. If that happens, typically two or $m$ ore stationary-phase points corresponding to distinct contributions to the sem iclassical wave function are not well separated in phase. C onsequently, the stationaryphase (SP ) m ethod, on which sem iclassical approxim ation is based, breaks down. W orse, in som e im portant situations, such as the universal hom oclinic oscillations associated w ith chaotic regions of phase space, the bad enclosed loops $m$ ay be repeated $m$ any tim es in a sm all region $\left[\begin{array}{ll}11 \\ 1\end{array}\right]$.

A though the sem iclassicalw ave fiunction diverges near caustics lurking near the sm all area loops, the exact quantum wave function is of course well-behaved. This is one $m$ anifestation of quantum sm oothing over classical detail. W e shall quantify below how this sm oothing occurs. W e suggest and test a new way of looking at the sm oothing process in term $s$ of \replacem ent $m$ anifolds", in which new, well behaved classical $m$ anifolds are substituted for the original badly behaved ones. O ne application of this approach is uniform izing a sem iclassical wave function in the vicinity of the ubiquitous hom oclinic oscillations of a chaotic system .

It is w idely understood that very sm all changes in potentials or walls ofbilliards can have little e ect on quantum eigenstates, but can drastically a ect the classical m anifold structure. This im $m$ ediately im plies a $m$ any-to-one relationship betw een the classical $m$ anifolds and quantum wave functions. That is, $m$ any di erent underlying classicalm anifold pattems correspond to the sam e wave function. N ow, whatever the choice of $m$ anifold (am ongst these equivalent form $s$ ) we can suppose an appropriate uniform ization exists which gives the correct
wave function. H ow ever, the non-uniform ized, sim ple sem iclassical lim it for the various choiges of $m$ anifolds can di er drastically in accuracy. It is this fact which we exploit in the present paper.

II. STANDARD UN IFORM IZATION:THEA RY FUNCTION

The paradigm exam ple of uniform ization is the A iry function, i.e. the energy eigenfunction of the linear ram $p$ potential. $W$ e take the potential to be of the form

U pon entering the \bad" region, the originalm om entum integralm ay be substituted for the W K B result, giving a uniform ization. W e have an integral over \initialm om entum," $m$ aking this exam ple a type of \initial value representation" (IVR) as rst dis-
 result of the integral is an A iry function, but in general there $m$ ay be integrals which are not know $n$ analytically or even close to ones that are known.

In this paper we encounter $m$ ore complex situations which are induced by nonlinear interactions, including
chaos, re ection from corrugated surfaces, etc. W e w ill show that intricate $m$ anifolds can som etim es be replaced by m uch sim pler ones, which $m$ ay them selves be evaluated sem iclassically in any basis, using a much sim pli ed uniform ization if required.

## III. REPLACEMENTMAN IFOLDS

We now introduce an exam ple of such a problem atic Lagrangian $m$ anifold, de ned by a position $m$ om entum relation

This m odelwas rst introduced_in Ref. $\left.\overline{A l}_{1}^{-1}\right]$ but was not explored there. The function (11-1) has oscillations of increasing am plitpde and frequency, which how ever have the sam e area $p(x) d x=\sim$ betw een successive zeros (see Fig. ${ }^{2}$ 는, sm all value of corresponds to sm all area of loops). This is also a characteristic property of hom oclinic oscillations near a periodic onbit. T he m om entum $p(x)$ spans an ever larger range as $x$ increases, but we now show that for $<1$ the $m$ anifold's sem iclassical behavior can be understood by replacing it w ith three sm ooth m anifolds. The rules for replacem ent are sim ple to derive.

 $\cos \left(\mathrm{x}^{3}\right)$ is bounded by 1. H ow ever sem íclassically it has the intenpretation of the sum of three sm ooth classical m anifolds, i.e. $p=p_{0}, p=p_{0}+3 \sim x^{2}$ and $p=$ po $3 \sim x^{2}$. They have the weights $A(x), i_{4} e^{i=2} A(x)$, $i_{4} e^{i}=2 A(x)$, respectively. The situation is depicted in Fig.

A m ost every discussion of the relation of classical and quantum $m$ echanics for chaotic system $s$ alludes to quantum sm oothing, but here we have seen explicitly one way this sm oothing com es about. For all reasonable purposes
the three sm ooth classicalm anifolds accurately replace the rapid oscillations of the originalm anifold. $N$ ote too that depending on the param eters the outlying $m$ anifolds $p=p_{0}+3 \sim x^{2}$; and $p=p_{0} 3 \sim x^{2}$ lie far beyond the lim its of the original distributions. W e shall discuss interesting consequences of this in the next section.

So far, we have considered the wave function only in position representation where caustics are absent and the sem iclassical form (13') w as accurate. The situation deteriorates drastically in m om entum space. In order to nd the wave function in $m$ om entum representation, we have to sum over all contributions from intersections of a horizontal line (corresponding to a m om entum eigenstate)
 jacent intersections w ill be separated by a phase $S=\sim$ that is sm aller than 1 for any classically allow ed $m$ om entum, and therefore the standard sem iclassical approxi$m$ ation $w$ illbreak dow $n$ for all classicalm om enta! H ow ever using the replacem entm anifolds (RM s) is a m uch sim pler and m ore intuitive approach which can rescue the situation. To nd

the $m$ om entum $w$ ave function (p) associated $w$ ith the originalm anifold we add (w th appropriate $w$ eights) $w$ ave functions $n(p)$ corresponding to the three RM S. Each of these partial w ave functions is equal to a Fourier transform of a corresponding position wave function $n(x)$,

Except for a small region close to $p_{0}$ (highlighted in Fig. ${ }_{\mathbf{1}}^{\mathbf{1}} \mathbf{1}$ ), this integral can be evaluated by $\mathrm{SP} m$ ethod! In otherw ords, although the sem iclassicalapproxim ation com pletely fails for the originalm anifold, it w orks alm ost everyw here for the replacem ent $m$ anifolds. M oreover, as we show in the follow ing section, the standard A iry uniform ization procedure of Section
correct the inaccuracy in a narrow region nearpo. W ew ill see that the $m$ om entum $w$ ave fiunction found by applying SP approxim ation to RM s is in excellent agreem ent w ith num erical solution. W e em phasize that the RM s do not yield the original, badly behaved sem iclassical result, but rather som ething $m$ uch $m$ ore accurate and $m$ uch sim pler.

IV.UNTFORM IZATION W ITH REPLACEMENT MANIFOLDS IN A GENERALIZED MODEL

In order to capture other properties ofhom oclinic oscillations in our model, we consider a generalized manifold

The presence of the derivative $\frac{d(x)}{d x}$ ensures equal loop areas betw een successive zeros of ( x ). We nd the uniform sem iclassical transform ation ele$m$ ent hp $\dot{p}_{0} i$, and thereby $x$ the amplitude prefactor to be $A(x)=(2 \sim)^{1=2}$; this how ever retains all the problem atic features of the $m$ anifold. W e solve the problem to allorders in by replacing the originalm anifold w ith an in nite series of RMS. First we note that the sem iclassical transform ation elem ent

If evaluated by $S P$ method, the integral $y$ ields a very poor sem iclassical result since there exist $m$ any coalescing $S P$ points. A $n$ accurate uniform answer is obtained by evaluating integral ( $\mathbf{2}_{2}^{\prime} \overline{1}_{1}^{\prime}$ ) exactly. The accuracy is usually further im proved by changing the integration variable from $x$ to $x_{0}$ (in our case both form $s$ are equivalent since $x=x_{0}$ ). This uniform version of hp $p_{0} i$ is in IVR form
 sum over RM S. Thism anifold form ost functions ( $x$ ) of interest contains no caustics, and consequently hp $\dot{p}_{0} \dot{i}_{n}$ allow s evaluation by SP m ethod! A s prom ised, we have expressed the uniform version of hp $\dot{p}_{0} i$ as a weighted sum over sem iclassical replacem ent $m$ anifolds,

If applied to a well-behaved (i.e. decaying fast enough at 1 ) function of $p$, the resulting sum converges for any
. The replacem ent-m anifold $m$ ethod is therefore not restricted to the regim e where loop areas are sm aller than ~. It also works in the strongly chaotic regim e where
> 1 (and where the standard sem iclassical approxim ation holds) if all m anifolds up to inj' are included in the sum. $T$ his follow s since $J_{n}(=2)$ considered as a function of $n$ decays exponentially fast for $\mathfrak{j} j>=2$. In other w ords, we only need to include severalRM s.beyond those intersecting the originalm anifold. Physically, the $m$ anifolds outside of the range of the original one lie in a classically forbidden region in which the w ave function is exponentially suppressed.

In opposite case ( < 1) which interests us the most, considering RMs up to inj=1 will su ce while the \prim itive" sem iclassical approxim ation fails com pletely even for $p=p_{0}$. In this regime can be thought of as a param eter de ning the strength of a perturbation which causes the $m$ anifold to oscillate around a sim ple $m$ anifold that describes the system if perturbation is absent.

To com plete our solution for a speci c function (x), we m ust evaluate hp $\dot{p}_{0} i_{n}$. For $n=0$, we cannot use $S P$ approxim ation (because the action is linear), but integral (24.) is trivial and we obtain in general

Here the replacem ent-m anifold approach should be com pared to the sem iclassical perturbation (SCP) approxim ation of M iller and Sm th $[\overline{9}, 1]$ bative classicaldynam ics to calculate the sem iclassicals $m$ atrix. T hey rst applied this $m$ ethod to the collinear collision of an atom $w$ ith a diatom ic $m$ olecule $[\underline{1}]$. The starting point is the initial value representation of the classical scattering $m$ atrix,

In this regim ewe expect the SCP and RM approxim ations to give the sam e answer. $W$ e shall verify that for the scattering by a corrugated wall in Section iv in. The SCP approxim ation of M iller and Sm th presently appears to be m ore widely applicable since it does not require any special property of the $m$ anifold. On the other hand, advantage of the RM $m$ ethod lies in the fact that it is not sub jected to the sm allness of perturbation. $P$ rovided that the full action falls into one of the classes discussed above, we can apply the RM m ethod w ithout approxim ating classicaldynam ics.

## V.MODELOFHOMOCLINICOSCILLATIONS

Hom oclinic oscillations in chaotic system s have another characteristic property: the am plitude of oscillations (i.e. \height" of loops) increases exponentially as

keep area of loops constant, the width of loops has to decrease accordingly. B ecause system $s$ in nature are usually bounded, the exponentially grow ing loops m ust eventually tw ist in a com plicated way to $t$ into available phase space. For sake of sim plicity, we consider a m odel that satis es the requirem ent of exponential grow th, but is unbounded. Such a m odel can be found am ong generalized $m$ anifolds of previous section. Speci cally, we want to nd a manifold whose hom oclinic points (i.e. intersections w ith line $p=p_{0}$ in our case) form a geom etric series,

## VI. COMPARISON W ITH THE <br> STATIONARY-PHASEMETHOD

    W A LL
```

Let us apply the replacem ent-m anifold method to a physical problem generating loop structure in phase space. Scattering of a plane wave by a corrugated wall has exactly such a property. This system has been used to $m$ odelelastic scattering of atom $s$ by solid surfaces (for review see $\left.\left[\overline{1}_{2}^{1}\right]\right)$. C onsider a tw o-dim ensional coordinate space divided into two parts by a periodically curved boundary consisting of the set ofpoints $w$ ith coordinates related by

T he re ected rays are show $n$ in $F$ ig. 1, . N otice also the clearly visible caus -

tics. The P oincare surface of section in $F$ ig. pendence of $m$ om entum com ponent $p_{2 x}$ of re ected rays on coordinate $x$ at a given distance $y_{2}$ from $x$ axis. $W$ e can see fam iliar loops w ith constant area and predict the failure ofsem iclassicalapproxim ation when this area gets sm aller than ~. Below we uniform ize the sem iclassical solution using RM s and com pare the outcom e w ith the exact and prim itive sem iclassical results.

There exist several approaches to solve this scattering problem exactly. G arcia and C abrera [13] have thoroughly com pared $m$ erits of various $m$ ethods. T he $m$ ain issue is the solution's convergence, which im proves w ith decreasing corrugation param eter. Luckily, this regim e overlaps w ith the small-loop lim it in which we are interested. W e can therefore use the m ost straightforw ard approach based on the so-called $R$ ayleigh hypothesis [14] which has been show $n$ to be valid for $<0: 448$ by M illar [15ㄴ﹎ㄴ․ D etails of the solution are provided in the A ppendix. A probability density plot of the $w$ ave function is show $n$ in $\mathrm{Fig} \cdot{ }^{110} \mathrm{IO}_{1}^{\prime}$.

The whole scattering problem can be form ulated using an analogue to the sm ooth-potential Lippm annSchw inger equation. Invoking the G reen's theorem, it can be shown that the totalw ave function satis es

 Our goal, how ever, is to make a connection $w$ ith a sem iclassical picture in the P oincare surface of section ( F ig. ${ }^{1} \mathrm{~g}_{1}$ ). That gure im plicitly assum es that classically only a single scattering event takes place before a ray leaves the wall perm anently. If corrugation is deep enough (" > "max, where $\mathrm{max}_{\mathrm{m}}$ < 1), multiple scattering will occur for any incident angle 1. T he larger " gets ( $w$ ithin the range $0<"<"_{m}$ ax ), the sm aller the m axim um allowed incident angle 1 . Let us consider a

wallw ith very shallow corrugation ("=0.2) and a sm all
angle of incidence ( $1_{=} 0.2$ ), a situation which classically allow s only a single re ection. W e also choose the incident-w ave length $=\frac{2}{k}$ to be $0: 3$ tim es the period of corrugation. The surprising result we shall obtain below is that although there exist seven realB ragg peaks in the scattered w ave, the sem iclassics break dow $n$ w hile the single-scattering approxim ation using replacem ent $m$ anifolds works w th excellent accuracy.

The sim ple sem iclassicalw ave function $m$ ay be evaluated e.g. by tracing of individual rays and em ploying the $V$ an $V$ leck propagator [1].]. The action $m$ ust be adjusted by correct M aslov indioes, corresponding to re ection from a hard wall and to passage through caustics $\left[1 \bar{l}_{1}^{\prime}\right]$. A probability density plot of the sem iclassicalw ave function is show $n$ in $F$ ig. '111'. N ote the caustics, which clearly separate regions w ith one, three, and ve contributions to the scattered wave. Betw een caustics, solution looks qualitatively the sam e as the exact quantum analogue in Fig.ind. By looking at a surface of section at $y_{2}=4=$ (where there are already at least three contributions for any x) in Fig. 'i, we expect that sem iclassical and quantum wave functions should disagree everyw here. This guess is con m ed in F ig. ${ }^{1} \mathrm{I}_{2}{ }^{\prime}$.

N ow let us nd a uniform expression for the scattered w ave. The Lippm ann-Schw inger equation (51) is an integralequation, and it is not im m ediately obvious how it could be used to nd scat from inc. W e circum vent this problem by proceeding in four steps: rst we canonically transform the incident $w$ ave function to a new coordinate system $r^{0}$ in which the wall becom es straight. W e solve the scattering problem in these coordinates, since there the sem iclassical approach is exact. T hen we transform back to the originalcoordinate system in which we propagate the w ave using the free-space G reen's function to obtain our nal answer. Sem iclassical approach is used for each separate step but their com bination is evaluated exactly.

B efore w e proceed, it should be noted that the outcom e ofthis four-step process, an integralrepresentation of the scattered wave, can be view ed as a continuous supenposition of w aves em anating from sources along the boundary, w ith strength proportional to the nom al derivative of the incident $w$ ave. It can be show $n$, in fact, that this process is equivalent to a generalized $K$ irchho di raction $m$ ethod [1] 은].

These tum out to be very close to the exact quantum coe cients obtained in the A ppendix, but here we have avoided the solution of a linear system ( A (丁).

The uniform expression ( 621 ) for coe cients of expansion (52) is surprisingly accurate. A two-dim ensional density plot in Fig. 11010 does not revealany di erence from the exact quantum solution while an analogoussem iclassical plot clearly show s the caustics (see Fig. '11 I' ) . E ven if we look at the $P$ oincare surface of section in a region w ith m any classical caustics, the quantum and uniform solutions agree while sem iclassical solution fails m iserably (see Fig. ${ }^{\prime} \mathbf{1}_{2}^{\prime}$ ). The uniform solution agrees w ith one found by G aribaldiet al. [1] $]$ and is som ew hat m ore accurate than the sam e result $w$ thout the $k_{1 y}=k_{2 y ; n}$ prefactor obtained by $H$ ubbard and $M$ iller [10 ${ }^{1}$ ] by SCP approxim ation and by G aribaldiet al. [19]. A SG aribaldiet al. (w ho obtain three di erent solutions di ering only by prefactors) point out, these prefactors \should not be taken too seriously." W e agree: for traveling $m$ odes, they do not cause large errors, and since all these solutions neglect $m$ ultiple scattering, we cannot expect high accuracy of the already sm all coe cients of evanescent $m$ odes.

A s prom ised in Section '든', we have obtained alm ost identical result using RM S as H ubbard and M iller w ith SCP approxim ation [101]. They found their answer for a
hard wallas a lim it of the solution for a sm ooth potential due to Lennard-Jones and D evonshire [2d]. A though we were lucky in this case to obtain exactly solvable integrals for RM s, we can quite generally expect that the replace$m$ ent $m$ anifolds $w$ ill be $m$ uch sm oother than the original one, enabling their sim ple evaluation by SP $m$ ethod.

W e discuss the speci c choige of param eters. Selecting " 1, 1 was necessary for the validity of the single-scattering approxim ation. At rst, it appears that the sim ple sem iclassical approxim ation should be accurate for this regim e of very shallow corrugation, since scattering from a at wallhas an exact sem iclassical answ er. The correct criterion, how ever, is based on the area

W e arrive at a surprising result that the validity of sem iclassical approxim ation has nothing to do w th the periodicity of corrugation, but only depends on the product kd of w ave vector and corrugation depth. If this product is $s m$ all, sem iclassical approxim ation breaks dow $n$. In the opposite case ofdeep corrugation, sem iclassicalapproxim ation w orks, although wem ight have to take into account classical tra jectories corresponding to $m$ ultiple scattering.

V III. C O N C LU S IO N

W e have successfully uniform ized several intim idating situations which can arise when repeated sm all areas or loops arise from enclosing classical $m$ anifolds using the replacem ent-m anifold idea. This notion can rejuvenate physical intuition about the quantum wave function and also be a very convenient approach to an accurate result. T w o physically m otivated cases w ere considered (the hom oclinic-like oscillation and the corrugated wall) along w ith several other contrived cases to test the m ethod. The present m ethod should work in m ore com plicated tim e-dependent problem $s$ if used w ith M iller's IV R applied to V an V leck's sem iclassicalpropagator. A fter replacem entm anifolds are identi ed, the perturbative
expansion contributions to the wave function could be found by SP approxim ation applied to these $m$ anifolds.

Future work along these lines includes the attem pt to uniform ize a fullhom oclinic tangle. It rem ains to be seen how convenient and generally applicable the replacem ent m anifold idea is. H ow ever, it seem s clear that we now have a new $m$ ethod which sim pli esm any problem swhile reinstating an intuitive foundation.
