## A new class of sem iclassical wave function uniform izations

W e present a new sem iclassical technique which relies on replacing com plicated classical manifold structure with sim pler manifolds, which are then evaluated by the usual sem iclassical rules. Under circum stances where the original manifold structure gives poor or useless results sem iclassically the replacement manifolds can yield remarkable accuracy. W e give several working examples to illustrate the theory presented here.

#### I. IN TRODUCTION

Sem iclassical m ethods are based on classical m echanics; the relevant classical m anifolds form the \skeleton" to which the wave function is attached. However, associating a sem iclassical wave function w ith a classical m anifold is problem atic when enclosed loops in phase space have area less than ~. If that happens, typically two or m ore stationary-phase points corresponding to distinct contributions to the sem iclassical wave function are not well separated in phase. C onsequently, the stationaryphase (SP) m ethod, on which sem iclassical approxim ation is based, breaks down. W orse, in som e im portant situations, such as the universal hom oclinic oscillations associated with chaotic regions of phase space, the bad enclosed loops m ay be repeated m any tim es in a sm all region [1].

A lthough the sem iclassical wave function diverges near caustics lurking near the sm all area bops, the exact quantum wave function is of course well-behaved. This is one manifestation of quantum sm oothing over classical detail. We shall quantify below how this sm oothing occurs. We suggest and test a new way of boking at the sm oothing process in terms of \replacem ent manifolds", in which new, well behaved classical manifolds are substituted for the original badly behaved ones. One application of this approach is uniform izing a sem iclassical wave function in the vicinity of the ubiquitous hom oclinic oscillations of a chaotic system .

It is widely understood that very small changes in potentials or walls of billiards can have little e ect on quantum eigenstates, but can drastically a ect the classical manifold structure. This immediately implies a manyto-one relationship between the classical manifolds and quantum wave functions. That is, many di erent underlying classical manifold patterns correspond to the sam e wave function. Now, whatever the choice of manifold (am ongst these equivalent form s) we can suppose an appropriate uniform ization exists which gives the correct wave function. However, the non-uniform ized, simple sem iclassical limit for the various choices of manifolds can di er drastically in accuracy. It is this fact which we exploit in the present paper.

# II. STANDARD UN IFORM IZATION : THE A IRY FUNCTION

The paradigm example of uniform ization is the A iry function, i.e. the energy eigenfunction of the linear ram p potential. We take the potential to be of the form

the Schrodinger equation reads

with  $(u) = _0(x)$ . Eq. (5) is exactly solved by going to the momentum representation. We have

This is the standard W KB form for the linear ram p potential. Figure 1 illustrates the situation for the sem i-

classical position wave function, which becomes inaccurate when the area enclosed by the verticalx-line and the energy contour corresponding to the state  $\pm$  i falls below P lanck's constant. Upon entering the \bad" region, the originalm om entum integralm ay be substituted for the W KB result, giving a uniform ization. We have an integral over \initial m om entum," m aking this example a type of \initial value representation" (IVR) as rst discussed by M iller [2,3]. O fcourse in this case we know the result of the integral is an A iny function, but in general there m ay be integrals which are not known analytically or even close to ones that are known.

In this paper we encounter more complex situations which are induced by nonlinear interactions, including chaos, re ection from corrugated surfaces, etc. W e will show that intricate m anifolds can som etim es be replaced by much simpler ones, which m ay them selves be evaluated sem iclassically in any basis, using a much simpli ed uniform ization if required.

### III. REPLACEM ENT MANIFOLDS

W e now introduce an example of such a problem atic Lagrangian manifold, de ned by a position-momentum relation

This model was rst introduced in Ref. [4] but was not explored there. The function (11) has oscillations of increasing amplitude and frequency, which how ever have the same area p(x)dx = -between successive zeros (see Fig. 2, sm all value of corresponds to sm all area of bops). This is also a characteristic property of hom oclinic oscillations near a periodic orbit. The momentum p(x) spans an ever larger range as x increases, but we now show that for < 1 the manifold's sem iclassical behavior can be understood by replacing it with three sm ooth manifolds. The rules for replacement are simple to derive.

The action function S(x) is the integral of p(x):

if < 1. For small this expression is nearly identical with (13) with the original action (12), because  $\cos(x^3)$  is bounded by 1. However sem iclassically it has the interpretation of the sum of three smooth classical manifolds, i.e.  $p = p_0$ ,  $p = p_0 + 3 \sim x^2$  and  $p = p_0 \quad 3 \sim x^2$ . They have the weights A (x),  $i_{\overline{4}}e^{i} = 2$  A (x),  $i_{\overline{4}}e^{i} = 2$  A (x), respectively. The situation is depicted in Fig. 3.

A lm ost every discussion of the relation of classical and quantum m echanics for chaotic systems alludes to quantum sm oothing, but here we have seen explicitly one way this sm oothing com es about. For all reasonable purposes the three sm ooth classical manifolds accurately replace the rapid oscillations of the original manifold. Note too that depending on the param eters the outlying manifolds  $p = p_0 + 3 \sim x^2$ ; and  $p = p_0 - 3 \sim x^2$  lie far beyond the lim its of the original distributions. We shall discuss interesting consequences of this in the next section.

So far, we have considered the wave function only in position representation where caustics are absent and the sem iclassical form (13) was accurate. The situation deteriorates drastically in momentum space. In order to nd the wave function in momentum representation, we have to sum over all contributions from intersections of a horizontal line (corresponding to a momentum eigenstate) with the oscillating manifold (11). When < 1, the adjacent intersections will be separated by a phase  $S = \sim$ that is sm aller than 1 for any classically allow ed m om entum, and therefore the standard sem iclassical approximation will break down for all classical momenta! U sual A iry-type uniform ization m ethods of Section II (also see [5,6]) do not serve under these circum stances, because the manifold is dense with caustics (see the lled-in areas  $S_1$  and  $S_2$  in Fig. 2). Apparently, we have no other choice but to part with sem iclassical method and use a num erical Fourier transform (IVR) over the position wave function to obtain (p). However using the replacem entm anifolds (RM s) is a much sim pler and more intuitive approach which can rescue the situation. To nd

the momentum wave function (p) associated with the original manifold we add (with appropriate weights) wave functions  $_{n}$  (p) corresponding to the three RM s. Each of these partial wave functions is equal to a Fourier transform of a corresponding position wave function  $_{n}$  (x),

Except for a small region close to  $p_0$  (highlighted in Fig. 3), this integral can be evaluated by SP method! In other words, although the sem iclassical approximation completely fails for the original manifold, it works alm ost everywhere for the replacement manifolds. Moreover, as we show in the following section, the standard A iry uniform ization procedure of Section II can be exploited to

correct the inaccuracy in a narrow region nearp<sub>0</sub>. We will see that the momentum wave function found by applying SP approximation to RM s is in excellent agreement with numerical solution. We emphasize that the RM s do not yield the original, badly behaved sem iclassical result, but rather something much more accurate and much simpler.

#### IV.UNIFORM IZATION W ITH REPLACEMENT MANIFOLDS IN A GENERALIZED MODEL

In order to capture other properties of hom oclinic oscillations in our model, we consider a generalized manifold

in which  $x^3$  from (11) is replaced by a generic smooth function (x). The presence of the derivative  $\frac{d_{(x)}}{dx}$  ensures equal bop areas between successive zeros of (x). Example of a manifold with (x) =  $\log \frac{x}{a}$  is displayed in Fig. 5. Manifold (17) can be obtained from a horizontal manifold representing a momentum state  $\dot{p}_0$  i by a canonical transform ation of coordinates [7]

We nd the uniform sem iclassical transform ation element hpjp\_0i, and thereby x the amplitude prefactor to be A (x) =  $(2 \ \sim)^{1=2}$ ; this how ever retains all the problem atic features of the manifold. We solve the problem to allorders in by replacing the original manifold with an in nite series of RM s. First we note that the sem iclassical transform ation element

is fairly accurate since there are no caustics in this representation (to each nalx corresponds a single initial  $x_0$ ).  ${\rm T}\,{\rm he}\,{\rm m}$  om entum -representation element is obtained by a Fourier transform ,

If evaluated by SP method, the integral yields a very poor sem iclassical result since there exist m any coalescing SP points. An accurate uniform answer is obtained by evaluating integral (21) exactly. The accuracy is usually further in proved by changing the integration variable from x to  $x_0$  (in our case both form s are equivalent since  $x = x_0$ ). This uniform version of hpjoi is in IVR form [2,3], but can best be evaluated by writing hxjoi as a sum over RM s. Recognizing that the factor  $e^{i_2 \cos (x)}$  in hxjo $i_{sc} = (2 \ \sim)^{1=2}$  exp ip $_0x = + i_2 \cos (x)$  is a generating function for Bessel functions, we can extend the sum from previous section beyond the rst order in . In fact we obtain an in nite sum convergent for any ,

Thism anifold form ost functions (x) of interest contains no caustics, and consequently  $hpp_0 i_n$  allows evaluation by SP m ethod! A sprom ised, we have expressed the uniform version of  $hpp_0 i$  as a weighted sum over sem iclassical replacem ent m anifolds,

If applied to a well-behaved (i.e. decaying fast enough at

. The replacement-manifold method is therefore not restricted to the regime where loop areas are smaller than ~. It also works in the strongly chaotic regime where > 1 (and where the standard sem iclassical approximation holds) if all manifolds up to jnj' are included in the sum. This follows since  $J_n$  (=2) considered as a function of n decays exponentially fast for jnj> =2. In other words, we only need to include severalRM sbeyond those intersecting the original manifold. Physically, the manifolds outside of the range of the original one lie in a classically forbidden region in which the wave function is exponentially suppressed.

In opposite case ( < 1) which interests us the most, considering RM s up to  $j_1 j = 1$  will su ce while the \prim itive" sem iclassical approximation fails completely even for  $p = p_0$ . In this regime can be thought of as a parameter de ning the strength of a perturbation which causes the manifold to oscillate around a simplemanifold that describes the system if perturbation is absent.

To complete our solution for a speci c function (x), we must evaluate  $hp p_0 i_n$ . For n = 0, we cannot use SP approximation (because the action is linear), but integral (24) is trivial and we obtain in general

For  $n \in 0$ , SP method applied to (24) yields a result in the form of a sum over SP points  $x_{SP}$ ,

RM s still contain one caustic at  $p = p_0$ , which can be easily uniform ized by evaluating integral (24) exactly [8],

Having found  $hp \dot{p}_0 \dot{i}_n$ , we can calculate  $hp \dot{p}_0 \dot{i}_{1,un \, if}$  (23) to all orders in .  $hp \dot{p}_0 \dot{i}_{1,sc}$  and  $hp \dot{p}_0 \dot{i}_{1,un \, if}$  agree very well except for a small region near  $p_0$  (sim ilarly as in Fig. 1). Fig. 4 demonstrates the excellent agreement

of RM m ethod with the direct num erical computation of  $hp \dot{p}_0 i$  using fast Fourier transform (IVR).

Here the replacement-manifold approach should be compared to the semiclassical perturbation (SCP) approximation of Miller and Smith [9,10] who used perturbative classical dynamics to calculate the semiclassical S matrix. They rst applied this method to the collinear collision of an atom with a diatomic molecule [9]. The starting point is the initial value representation of the classical scattering matrix,

where  $\sim = 1$ ,  $n_i$ ,  $n_f$ ,  $q_i$ ,  $q_f$  denote, respectively, the initial and nalvalues of the action and angle variables describing the internal degree of freedom, and is the action integral. For details, see R ef. [2] and [9]. If the classical quantities listed above are calculated using the rst-order perturbation dynam ics, the S m atrix takes the form

where  $_0$  is twice the phase-shift for the unperturbed potential and A  $(q_i; n_i)$  is the time integral of the perturbation potential along the unperturbed trajectory [9]. For various physical system s (such as ion-dipole collisions [9] or atom -surface scattering [10]), A (q\_i;n\_i) has a sinusoidal dependence on qi as long as perturbation rem ains small. In this regime we expect the SCP and RM approxim ations to give the same answer. We shall verify that for the scattering by a corrugated wall in Section V  $\Pi$ . The SCP approximation of M iller and Sm ith presently appears to be more widely applicable since it does not require any special property of the manifold. On the other hand, advantage of the RM m ethod lies in the fact that it is not subjected to the smallness of perturbation. Provided that the full action falls into one of the classes discussed above, we can apply the RM method without approxim ating classical dynam ics.

### V.MODELOF HOMOCLINIC OSCILLATIONS

Hom oclinic oscillations in chaotic systems have another characteristic property: the amplitude of oscillations (i.e. \height" of loops) increases exponentially as we approach an unstable periodic orbit (see Fig. 5). To

keep area of loops constant, the width of loops has to decrease accordingly. Because system s in nature are usually bounded, the exponentially growing loops must eventually twist in a complicated way to t into available phase space. For sake of simplicity, we consider a model that satis es the requirement of exponential growth, but is unbounded. Such a model can be found among generalized manifolds of previous section. Speci cally, we want to nd a manifold whose hom oclinic points (i.e. intersections with line  $p = p_0$  in our case) form a geometric series,

where  $_{+}$  is the Lyapunov exponent. In other words, we are looking for a function (x) such that (x<sub>h</sub>) = 2 n. The logarithm ic function comes to mind rst since  $\log \frac{x_n}{a} = n_{+}$ . With the correct prefactor  $= \frac{2}{+}$ , we nd the desired function

because  $(x_n) = \log \frac{x_n}{a} = \frac{2}{+}n_+ = 2$  n. Substituting (x) from (32) into the general form (17), we obtain a manifold described by

For  $p > p_0$ , only manifolds with n > 0 contribute, and for  $p < p_0$  only n < 0 is allowed. Dening  $j = j_1 j_j$  for  $p \in p_0$  we replace the sum over n by sum over all positive j. In both cases, the j-th m anifold gives a sem iclassical contribution

with j = jnj > 0. In this case caustics are missing because there is a single SP point  $x_{sp}$ . We have a nite integration limit at zero, but it is separated from  $x_{sp}$  by an in nite action (equal to the area delimited by lines  $x = 0, p = p_0$ , and the n-th RM, see Fig. 5). In fact, it can be shown that further terms in asymptotic expansion of hpjp<sub>0</sub>  $i_{j,sc}$  have the same dependence on ~ and p p as (36), and only di er in their dependence on j . Luckily, these claims can be easily veried by evaluating integral (24) analytically. This oscillatory integral is made convergent by displacing momentum p with an imaginary in nitesimal term i, > 0,

In this form, the answer is found by rotating the contour about the origin of complex plane by  $\frac{1}{2}$  sgn (p p). Let

us explicitly solve the case  $p > p_0$ . Fig. 6 shows a contour in complex plane enclosing a region with no singularities, and as a result the sum of integrals along appropriate parts of the contour is zero,  $I_1 + I_R + I_2 + I_r = 0$ . In the lim it  $R \ ! \ 1$ ,  $r \ ! \ 0$ ,  $I_1$  becomes our desired integral (37) and both  $I_R$  and  $I_r$  vanish, in plying  $I_1 = \quad$   $\underbrace{1}_2$ . Contour for integral  $I_2$  is the set of complex points  $z = \quad$  ix =  $e^{i \ =2} \ x, x > 0$ . Consequently,

For  $p < p_0$ , we need to close the contour in the upper halfplane, but otherwise the procedure is analogous. Com – bining the two cases, we obtain a single analytic expression for the uniform transformation element,

where s = sgn(p p). As promised, the uniform and sem iclassical forms have identical dependence on ~ and p p. The only di erence lies in the dependence on n , in particular the sem iclassical form is obtained if we keep only the rst term in the asymptotic expansion of (1 + in) in hppoin,  $i_{n,unif}$ . However, for our conservative choice of 33 the agreement between hppoin, sc and hppoin,  $i_{n,unif}$  is such that they may be used interchangeably for any practical purposes. Finally, in Fig. 7, hppoi is applied to an initial G aussian wave packet centered around X<sub>0</sub>, P<sub>0</sub>, nam ely

The large oscillation near  $p = p_0$  in Fig. 7 corresponds to the zeroth RM contribution <sup>i</sup>(p), the smaller wavelet to the right corresponds to the remaining RM s. The gure con m s the excellent accord between RM m ethod and num erical IVR evaluation by FFT [11]. We have thus succeeded in uniform izing som ething with m any of the properties of hom oclinic oscillations near an unstable periodic orbit using replacem ent-m anifold \technology".

## VI.COM PARISON W ITH THE STATIONARY PHASE METHOD

It is instructive to check explicitly if the expansion in term s of RM s agrees with sem iclassical method applied to the original manifold when areas of loops are larger than ~ ( > 1). Let us choose an analytically solvable example with  $(x) = x \cdot C$  or responding manifold

has another advantage compared to manifolds in Figures 3 and 5. Unlike those, for 1 and small enough p p<sub>0</sub>, manifold (42) has all caustics in a safe distance. The RM s are horizontal lines  $p_n = p_0 + n \sim$ , independent of x and corresponding transform ation elements can be evaluated exactly as  $hp \dot{p}_0 \dot{i}_n = (p \ p \ n \sim)$ . Table I shows that for  $= 10 \text{ sem iclassical and RM values of } a_n \text{ di er by less than 0.02 up to } n = 3$ . In the opposite limit, for < 1, even  $a_0$  evaluated sem iclassically is completely o.

# VII.SCATTERING FROM A CORRUGATED WALL

Let us apply the replacement-manifold method to a physical problem generating bop structure in phase space. Scattering of a plane wave by a corrugated wall has exactly such a property. This system has been used to model elastic scattering of atom s by solid surfaces (for review see [12]). Consider a two-dimensional coordinate space divided into two parts by a periodically curved boundary consisting of the set of points with coordinates related by

where gives the spatial frequency of corrugation and " the maximum slope  $\frac{dy}{dx}$  of the wall. A plane wave with momentum  $\sim k_1$  is incident from the upper half-plane at an angle 1 from the y axis, so the incident wave vector is  $k_1 = k$  (sin 1; cos 1): C lassically, the wave rejects specularly from the curved boundary. The rejected rays are shown in Fig. 8. Notice also the clearly visible caus-

tics. The Poincare surface of section in Fig.9 displays dependence of momentum component  $p_{2x}$  of rejected rays on coordinate x at a given distance  $y_2$  from x axis. We can see familiar loops with constant area and predict the failure of sem iclassical approximation when this area gets smaller than ~. Below we uniform ize the sem iclassical solution using RM s and compare the outcom e with the exact and primitive sem iclassical results.

There exist several approaches to solve this scattering problem exactly. G arcia and C abrera [13] have thoroughly compared merits of various methods. The main issue is the solution's convergence, which improves with decreasing corrugation parameter . Luckily, this regime overlaps with the small-loop limit in which we are interested. We can therefore use the most straightforw and approach based on the so-called Rayleigh hypothesis [14] which has been shown to be valid for < 0.448 by M illar [15]. D etails of the solution are provided in the Appendix. A probability density plot of the wave function is shown in Fig. 10.

The whole scattering problem can be formulated using an analogue to the smooth-potential Lippm ann-Schwinger equation. Invoking the Green's theorem, it can be shown that the total wave function satis es

where  $\hat{G}_0$  is the free-space G reen's operator and  $\hat{n}(x)$  is a norm alunit vector at the boundary pointing into free space. Now we could use periodicity of the wall, expand tot (r) in its Fourier modes,

and recover the linear system (A 6) for coe cients a  $_n$ . Our goal, however, is to make a connection with a sem iclassical picture in the Poincare surface of section (Fig. 9). That gure implicitly assumes that classically only a single scattering event takes place before a ray leaves the wall permanently. If corrugation is deep enough (" > " $_m$  ax, where " $_m$  ax < 1), multiple scattering will occur for any incident angle 1. The larger " gets (within the range 0 < " < " $_m$  ax), the smaller the maximum allowed incident angle 1. Let us consider a

wall with very shallow corrugation (" = 0.2) and a sm all

angle of incidence ( $_1 = 0.2$ ), a situation which classically allows only a single rejection. We also choose the incident-wave length  $=\frac{2}{k}$  to be 0.3 times the period of corrugation. The surprising result we shall obtain below is that although there exist seven realB ragg peaks in the scattered wave, the sem iclassics break down while the single-scattering approximation using replacement manifolds works with excellent accuracy.

The simple sem iclassical wave function may be evaluated e.g. by tracing of individual rays and employing the Van V leck propagator [16]. The action must be adjusted by correct M aslov indices, corresponding to rejection from a hard wall and to passage through caustics [17]. A probability density plot of the sem iclassical wave function is shown in Fig.11. Note the caustics, which clearly separate regions with one, three, and ve contributions to the scattered wave. Between caustics, solution looks qualitatively the same as the exact quantum analogue in Fig.10. By looking at a surface of section at  $y_2 = 4 =$ (where there are already at least three contributions for any x) in Fig.9, we expect that sem iclassical and quantum wave functions should disagree everywhere. This guess is con med in Fig.12.

Now let us nd a uniform expression for the scattered wave. The Lippm ann-Schwinger equation (51) is an integral equation, and it is not immediately obvious how it could be used to nd  $_{\rm scat}$  from  $_{\rm inc}$ . We circum vent this problem by proceeding in four steps: rst we canonically transform the incident wave function to a new coordinate system  $r^0$  in which the wall becomes straight. We solve the scattering problem in these coordinates, since there the sem iclassical approach is exact. Then we transform back to the original coordinate system in which we propagate the wave using the free-space G reen's function to obtain our nal answer. Sem iclassical approach is evaluated for each separate step but their combination is evaluated exactly.

Before we proceed, it should be noted that the outcom e of this four-step process, an integral representation of the scattered wave, can be viewed as a continuous superposition of waves emanating from sources along the boundary, with strength proportional to the norm alderivative of the incident wave. It can be shown, in fact, that this process is equivalent to a generalized K inchho di raction m ethod [18].

Returning to expression (57), we recognize that the exponent in integral over  $x^0$  corresponds to a classical manifold

These turn out to be very close to the exact quantum coe cients obtained in the Appendix, but here we have avoided the solution of a linear system (A 6).

The uniform expression (62) for coe cients of expansion (52) is surprisingly accurate. A two-dimensional density plot in Fig. 10 does not revealany di erence from the exact quantum solution while an analogous sem iclassical plot clearly shows the caustics (see Fig. 11). Even if we look at the Poincare surface of section in a region with many classical caustics, the quantum and uniform solutions agree while sem iclassical solution fails m iserably (see Fig. 12). The uniform solution agrees with one found by Garibaldietal. [19] and is som ew hat more accurate than the same result without the  $k_{1y}=k_{2y;n}$  prefactor obtained by Hubbard and M iller [10] by SCP approxim ation and by Garibaldietal. [19]. AsGaribaldietal. (who obtain three di erent solutions di ering only by prefactors) point out, these prefactors \should not be taken too seriously." We agree: for traveling modes, they do not cause large errors, and since all these solutions neglect multiple scattering, we cannot expect high accuracy of the already sm all coe cients of evanescent m odes.

As promised in Section IV, we have obtained almost identical result using RM s as Hubbard and M iller with SCP approximation [10]. They found their answer for a hard wallas a lim it of the solution for a sm ooth potential due to Lennard-Jones and D evonshire [20]. A lthough we were lucky in this case to obtain exactly solvable integrals for RM s, we can quite generally expect that the replacement manifolds will be much sm oother than the original one, enabling their simple evaluation by SP m ethod.

W e discuss the speci c choice of parameters. Selecting " 1, 1 was necessary for the validity of the single-scattering approximation. At rst, it appears that the simple sem iclassical approximation should be accurate for this regime of very shallow corrugation, since scattering from a atwallhas an exact sem iclassical answer. The correct criterion, how ever, is based on the area of loops in phase space (see Fig. 9). In this case, for sm all " and , the height of loops is equal to the momentum kick in region of maximum slope, approximately p" and the width is half the period of corrugation, -. The loop area is smaller than  $p'' - = kd^{\prime}$  (d is the depth of corrugation) and has to be compared to ~. We arrive at a surprising result that the validity of sem iclassical approximation has nothing to do with the periodicity of corrugation, but only depends on the product kd of wave vector and corrugation depth. If this product is sm all, sem iclassical approximation breaks down. In the opposite case of deep corrugation, sem iclassical approxim ation works, although wem ight have to take into account classical trajectories corresponding to multiple scattering.

#### V III. C O N C LU S IO N

We have successfully uniform ized several intim idating situations which can arise when repeated small areas or loops arise from enclosing classical manifolds using the replacement-manifold idea. This notion can rejuvenate physical intuition about the quantum wave function and also be a very convenient approach to an accurate result. Two physically motivated cases were considered (the hom oclinic-like oscillation and the corrugated wall) along with several other contrived cases to test the method. The present method should work in more com – plicated time-dependent problems if used with Miller's IVR applied to Van V leck's sem iclassical propagator. A fter replacement manifolds are identied, the perturbative expansion contributions to the wave function could be found by SP approximation applied to these manifolds.

Future work along these lines includes the attempt to uniform ize a fullhom oclinic tangle. It remains to be seen how convenient and generally applicable the replacement manifold idea is. However, it seems clear that we now have a new method which simpli esm any problem swhile reinstating an intuitive foundation.
