# DYNAM ICS OF SOLITONS AND OUASISOLITONS OF CUBIC THIRD-ORDER NONLINEAR SCHRODINGER EQUATION

The dynamics of soliton and quasisoliton solutions of cubic third order nonlinear Schrodinger equation is studied. The regular solitons exist due to a balance between the nonlinear term s and (linear) third order dispersion; they are not in portant at small  $_3$  ( $_3$  is the coe cient in the third derivative term ) and vanish at  $_3$  ! 0. The most essential, at small  $_3$ , is a quasisoliton em itting resonant radiation (resonantly radiating soliton). Its relationship with the other (steady) quasisoliton, called embedded soliton, is studied analytically and in num erical experiments. It is dem onstrated that the resonantly radiating solitons emerge in the course of nonlinear evolution, which shows their physical signi cance.

## I. IN TRODUCTION

Equations describing soliton processes are usually obtained by certain approximating procedures a ecting nonlinearity and dispersion. Now, in extensive studies of ultrafast processes, the classical approxim ations often appear to be insu cient and higher order e ects becom e of importance. A typical example is high speed system s like nonlinear transmission lines in fem to second regime for soliton com m unications, etc. For such system s soliton solutions in classical sense do not generally exist. Only for very specic choices of parameters one can nd localized solutions. Instead of regular solitons there may appear nonlocal steady or (and) unsteady soliton like structures (which may be called quasisolitons). These m ay, how ever, have signi cant im portance for the nonlinear dynam ics.

In this paper we consider dynam ics described by the extended third-order cubic nonlinear Schrodinger (NLS) equation

which plays an important role in many nonlinear problem s, in partiqular, in the nonlinear beroptics [1,2]. The third derivative term describes higher order correction to the linear dispersion and the cubic terms with the rst derivative are dispersive nonlinear corrections. Here, we assume that all  $_n$  (1) n 3) are realparam eters.

Eq.(1) has regular soliton solutions [3-5], vanishing at ⅓ j! 0. In particular cases, Eq.(1) m ay have exact N soliton solutions [4] or even be integrable [5]. An important feature of the solutions describing regular solitons is that they are degenerating at  $_3! 0$  (see below), which substantially reduces their physical importance. Their num erical investigation at 1:2 1 where done e.g. in Ref.[6] (see also references therein)

There also exist some solutions to Eq.(1), describing quasisolitons. One of them is a steady solution looking like a soliton type pulse embedded into a small amplitude plane wave (a soliton on plane wave pedestal). We call it embedded soliton (ES), using the word proposed in a di erent context in Ref.[7]. A part from that, Eq. (1) has other type of quasisoliton solutions which describe soliton-like pulses perm anently em itting resonantly generated radiation (see, e.g., Refs. [8-12] for the particular case at  $_1 = _2 = 0$  and [13,14] for the full Eq.(1)). We will call them resonantly radiating solitons (RRS); they are unsteady because of losses caused by the radiation. The lifetime of radiating soliton is su ciently large if 3 is small enough and, naturally, one can speak about the soliton only in this quasisteady case. (However, at long tim es, the losses caused by the radiation becom e essential for applications [2].) At  $_3$  ! 0, the RRS turns into the regular soliton of Eq.(1) without the third derivative.

There is an interesting and important connection between the two types of quasisolitons, ES and RRS, and we dem onstrate it in num erical sim ulations. We will also study the role of solitons and quasisolitons in the nonlinear processes described by Eq.(1). In particular, the regular solitons and RRS compete between them selves in nonlinear processes. As far as the regular solitons disappear at  $_3$  ! 0 and the RRS have short lifetimes at large  $_3$ , it is clear that at large  $_3$  the regular solitons are more important while the RRS may play a decisive role at su ciently small 3. The most interesting case is, of course, sm all  $_3$  , because the third derivative term em erges as the result of an expansion. (The e ect of next, 4th derivative, term can be seen in Refs.[13,14]; at certain relationship between the coe cients before third and fourth derivatives there can be no radiation at all which, naturally, may happen also when other high-order term s are taken into account.)

The paper is organized as follows. In Sec.I we describe important properties of Eq.(1), which are used below. In particular, we discuss regular soliton solutions [3], G alilean transform ations and conservation law s [13,14]. The embedded solitons are studied in Sec.3. As we have already mentioned, the ES consists of a steady soliton-like pulse on the plane wave background. This structure is rater common in di erent nonlinear highly dispersive system s [9-20]. At  $_3$  ! 0 , the plane wave disappears and the pulse turns into a regular soliton of Eq. (1) at  $_3 = 0$ . The plane wave amplitude, increasing with  $_3$ , may become unstable at su ciently large 3 due to the modulational instability. Considering small 3, we show that the pulse part of ES is rather close to the pulse in RRS and the wavenum ber of the plane wave coincides with the wavenum ber of resonantly em itted radiation (by the RRS) . Next, we introduce the cut o operation, cutting o both wave wings from the ES (Sec.IV). Then we see that the remained soliton-like pulse is transformed into the RRS, emitting radiation only in one direction, according to the direction of the group velocity of resonant radiation. The resonant radiation disappears at  $1 = 6_3$ . In this case, considered in Sec.V, we show that Eq.(1) can be transformed, by means of the Galilean transformation, to the complex modied Korteweg-de Vries (MKdV) equation . At particular initial conditions, it is reduced to the realM K dV equation which is integrable and therefore has N - soliton solutions [22]. This does not mean the complete integrability of Eq.(1) at  $_1 = 6_3$  , because the reduction to the real MK dV equation is possible only for particular initial conditions. However, the Painleve analysis [21] of the above m entioned com plex M K dV equation shows that at 6  $_3 = _1 = 2 _2$  it possesses the Painleve property. This is just the case when Eq. (1) is integrable [5]. If  $_2 = 0$ , we arrive at the case considered by H irota [4] who has shown the existence of N - soliton solutions in this case. Our approach, however, is more general and (in fact, as in Ref. [23]) we can see that the N -soliton solutions are possible even for nonvanishing 2 (at <sub>2</sub> €  $3_{3}$ ). Then we present a num erical study of the initial value problem in the H irota case:  $_1 = 6_3$ ,  $_2 = 0$  taking as initial conditions complex pulses and one can see how the robust H irota solitons are em erging from these pulses. In Sec.VI, we describe num erical experiments at  $1 \notin 6$  3. Solving the initial value problem, we show that, at su ciently small 3, the initial disturbances decay into the resonantly radiating solitons (RRS).On the other hand, at sm all 3, the Potasek-Tabor solitons [3] were not detected. This indicates that the RRS are important physical objects playing a signi cant role in nonlinear dynam ics. In Sec. VII, a sum m ary of obtained results is given. In Appendix A, the modulational instability of a plane wave, described by Eq.(1), is considered; it is helpful in the study of the stability of embedded solitons. In Appendix B we investigate analytically, by m eans of conservation laws, the evolution of RRS caused by the radiation. This analysis is in agreement with numerical results described in Secs.IV and VI.

II. IM PORTANT PROPERTIES OF EQ. (1)

## a. Exact soliton solutions

First, we discuss the exact soliton solutions of Eq.(1). They can be written in the form

In fact, these are the soliton solutions found by Potasek and Tabor [3] (with corrected misprints). We will call Eqs. (2a-e) Potasek-Tabor (PT) soliton solutions. At  $_3 = 0$ , PT solitons do not exist; this signi es that their existence is a result of a ballance between the nonlinear terms and the linear third order dispersive term . If  $_2 \in 0$ , from Eq. (2e) it follows that is a xed number, uniquely determined by the coe cients of Eq.(1). However, the solitons (2) exist even at  $_2 = 0$  provided that

In this case can be arbitrary , because Eq. (2e) follows from the equation 12  $_2$   $_3$  =  $_1$  6  $_3$  + 2  $_2$ .

In case (3) and  $_2 = 0$ , Eq. (1) is the so called H irota equation that can be transformed to the complex modi ed K ortew eq-de V ries equation which has N -soliton solutions [4]. For the H irota soliton, from Eq.(2b) it follows

In the other particular case,  $6_3 = 1 = 2_2$ , Eq. (1) is integrable [5]. (See also Sec.V.) Some results for solitons (2) with  $2 \in 0$  were reported in Ref.[6] (see also references therein). In particular, it was shown numerically that they emerge in a solution of initiall value problem. However, this result was obtained at 1 = 3 = 1; at sm all  $_3$ , as it will be shown below, they cannot compete with RRS.

Apart from the solution (2a-e), describing "bright" solitons, which was called in Ref. [3] sech-fam ily, Potasek and Tabor have also found tanh-fam ily which will not be discussed here. (Some generalizations, with both sech and tanh terms, are derived in Ref. [27] by means of rather tedious algebra; the results of this paper are mostly contained in Ref.[3] and the generalizations [27],

which are valid for very specic choices of the parameters, can be obtained by the much simpler approach of Potasek and Tabor.) The results of Ref. $\beta$ ] are repeated also in some other papers (e.g.[23]).

## b. G alilean transform ation

In the following we shall frequently use the Galilean transform ation describing the transition to the reference fram emoving with the velocity V. For Eq. (1) it reads

One can check by means of straightforward calculations that Eq. (1) has the following integral of motion

## III.EM BEDDED SOLITONS

W e start with the solutions to Eq. (1) of the form

where x and t are de ned in (8). Substituting (16) into Eq.(1), we arrive at the ordinary di erential equation

In posing periodic boundary conditions at the ends of a su ciently broad interval and considering V and (0) as given parameters and as the eigenvalue, we arrive at a nonlinear eigenvalue problem which can be num erically solved by a kind of shooting method. An example of such solution at  $_2 = 0$  and

is shown in Fig.1 (a,b). It is a nonlocal steady pulse with j (x)  $j_{m ax} = j (x_0) j$  and sm all symmetric "wings". At large jx  $x_0 j$  we can linearize Eq. (17); then we see that

On the other hand we can determ ine directly from (x) which is found numerically from Eq. (17), together with . From Fig. 1b we see that the numerically found

(x) has indeed asymptotic behavior (19) with 5:3 which is very close to the root of Eq. (20), written in (21). This agreement is an evidence of the correctness of the numerical solution of eigenvalue problem by the shooting method. In a similar way, the solution of eigenvalue problem (17) and Eq. (20) for  $_2 = 0$  and

Eqs. (35)-(38) were obtained in Ref. [14] for a pulse part of RRS.From (35) it follows that the soliton amplitude is

In fact, similar quasisoliton solutions, looking like embedded solitons, were obtained, by dierent approaches, for other highly dispersive systems as well [15-17,9,11,12,17-20].

Substituting here (26), (27) and taking into account (6), (7) and (10), (11) we have Eq.(17) as one should expect.

which is a restriction on the soliton velocity (6).

A small term f(x) in Eq.(32) expresses the e ect of the third order dispersion. At jxj  $(a_2)=$ , or less, it describes a modi cation of the pulse, arising due to the last term in Eq. (28), while at large x

where k is a root of Eq. (30). Note, that this equation was derived in Ref. [14] for the wavenum ber of the resonantly generated radiation by the RRS in the reference fram e where the RRS is at rest. From all that we conclude that (32) coincides with the asym ptotic expression for the RRS and its radiation at large t.

Let us now compare the embedded solitons, obtained above numerically, with the solution (32) at condition (13). From Eq.(38) we have

Then we have for the case (18), (21), which is shown in Fig. 1:  $u_0$  1:37. For the case (22)  $u_0$  1:41, and for (23)  $u_0$  1:42. So, in all three cases we approximately have  $u_0$  1:4 which is rather close to (0) = 1:5, assumed in the nonlinear eigenvalue problem for all three cases. This supports the conclusion that expressions (35) and (36) approximately describe the pulse in the embedded soliton (at sm all  $_3$ ).

Now consider f(x). At small <sub>3</sub>, the roots of Eq. (30) have simple analytical expressions [14]. Neglecting the rst term in (30), we have two smallest roots

It is easy to check that we can arrive at Eq. (55) by substituting in Eq. (52) the rst of conditions (54) and p=1.

From the all foregoing, one can see a connection between the embedded and resonantly radiating solitons. In the next section we present num erical experim ents disclosing this connection from another side.

#### IV.THE CUT OFF OPERATION

Let us de ne the cut o operation transform ing the embedded soliton into an isolated pulse. Turning to the function (x) in (16), we write

where r(x) is a cutting factor which we take in the form

Here  $x_0$  is the center of the pulse and x > 0 is the width of the cutted function <sub>cut</sub> (x). A ccording to (57), r(x) vanishes at jx x\_0 j! 1 and the positive parameter characterizes the "sharpness" of vanishing. A ssum ing that is small enough and x is such that the factor r(x) cuts o only the wings without essential disturbing the pulse in (x) ( and x can be properly chosen in

num erical tests) we then take the pulse  $_{cut}(x)$  as the initial condition to Eq.(1) (see Fig.2a)

In F ig 2b one can see that the cutted pulse em its radiation at t> 0. How ever, on the left hand side of the pulse the radiation spreads out with time; this shows that on the left hand side there is a transient radiation, em itted at smallt due to initial condition (58). On the contrary, on the right hand side we see a wave train with approxim ately constant am plitude, with the front propagating to the right; so, the length of the wavetrain increases with time. Therefore the cutted pulse perm anently em its radiation to the right. The spectrum, shown in Fig.1c, has a peak at approximately equal to the root of Eq. (20) with account of nite velocity of the pulse at t = 138 (it is still rather close to from Eq. (21), i.e. to the wavenum ber of the wing waves in em bedded soliton).

A nalyzing the time behavior of arg, we do not that d(arg) = dt = (t) is a slow function of t, with (0) 0:98 and (130) 0:85. Note that this (0) coincides, with a good accuracy, with (21). Similar results were obtained for cutted pulses in cases (22) and (23).

W e conclude that the cutted pulses are radiating solitons; and the radiation is perm anently emitted only in one direction. As far as is connected with k from Eq. (31), which is the real root of Eq. (30), obtained from the resonant condition, we conclude that the cut o operation transform s ES ino RRS. The front of radiated wavetrain propagates with the group velocity U (k) given by [14]

Therefore at  $_3 < 0$  it should be k < 0 and U (k) > 0. This means that the soliton in Fig. 2a should perm anently emit radiation to the right while the peak in the spectrum of the wavetrain should be at negative k. This is in agreement with the results presented in Figs. 2b and 2c.

To describe analytically the whole system after the cut o , one can use at small  $_3$  the equation  $\left[ 14 \right]$

Eq. (62) expresses that the soliton radiates in the direction of group velocity U and the radiation front propagates with the velocity jJ j. The mentioned above adiabatic approximation means that at su ciently small <sub>3</sub>, the radiation is so small that the soliton parameters in  $u_s(x)$  and s(x) (as well as the wavenumber k) can be considered as constant. However, the soliton boses may be essential at large times.

The variation of soliton parameters, caused by the radiation, can be estimated by means of the integrals of motion (Appendix B). A vast information about the soliton evolution, caused by the radiation, follows from the num erical solution of Eq.(1). For the parameters used in Figs. 2, the results following from this solution are presented in Fig.3. One nds that the mean value of  $j j_{max} = u_0(t)$ , shown in Fig.3a, decreases logarithm ically, sim ilar to what was found for the case  $_1 = _2 = 0$  [25,26]. Analyzing the soliton position (Fig.3b) one can nd that the soliton velocity V (t) increases from V(0) = 0 to V(138)0:29, i.e. the soliton is accelerating and the function V (t) increases (also log-0:98, (138) arithm ically). Now, using (0) 0:85 and Eqs. (47),(44), we have (0)  $p \frac{1:4}{a_2}$  (138) 1:28 Therefore, the soliton width =  $p \frac{1:4}{a_2}$  increases from 1:28. (0) 0:71 to (138) 0:99, i.e. the radiating soliton is widening with time. All that can be considered as a num erical con mation of analytical results obtained in Appenix B from the conservation laws, in particular that

It is completely integrable and, in particular, has exact N - soliton solutions [2] if  $_2 \in 3_3 = (1-2)_1$  [cf. with Eq. (2b)]. As far as Eq. (66) is reduced to Eq. (69) only for particular initial conditions, it may not be , generally, integrable; however, one can assert that it also possess N - soliton solutions at any  $_2 \in (1-2)_1$ , which is a generalization of the H irota solution at  $_2 = 0$ . Therefore is arbitrary and  $V_s$  (), ! () coincide with Eqs. (2c,d) respectively. This means that Eqs. (74) and (75) indeed describe the H irota solitons, mentioned in Sec2a. It is also seen that though the H irota conditions do not ensure the integrability (Painleve tests are negative !), Eq. (1) in H irota case de nitely has exact N -soluton solutions.

We see that (X;T) evolves into two pulses, well separated at T = 168. The spetrum of (X;T) at T = 168(Fig.5) gives an evidence that, in addition to these pulses, no signi cant wavetrains are produced at initial condition (77). The time variation of the amplitude of the pulse with largest amplitude, j<sup>(1)</sup> j is shown in Fig.6. It approaches the constant lim it, approxim ately equal to 15. The velocity of that pulse approaches the lim it approxin ately equal to 0.35 . These results suggest that the leading pulse asym ptotically approaches a regular soliton with  $a^{(1)}$  1:5 and  $V_s^{(1)}$  0:35. The shapes of (X;T), obtained num erically for T > 150, con m this conclusion. Then, using Eqs. (2c,d) and (4), we can calculate the shifted frequency  $!^0 = ! (k) kV_s^{(1)}$ , which is the soliton frequency in the reference fram e where the soliton is at rest. The plot of  $!^{0}$  versus  $V_{s}$ , shown in Fig.7, gives  $!^{0}(0:35)$  1:5. This must be equal to arg (1). On the other hand, the num erical solution perm its to obtain arg <sup>(1)</sup> versus time in the frame where the pulse is at rest. This also gives arg <sup>(1)</sup> 1:5, at su ciently large T . Similar results were obtained for the second pulse. Thus we conclude that the initial com plex pulse (77) decays into two H irota solitons. Qualitatively sim ilar results were obtained for the initial pulse

O ther features of the dynam ics of H irota solitons, in particular their collisions, will be exam ined in another paper.

Here, we report on the num erical solutions of Eq.(1) in general case. First we take, as initial condition, the pulse (77) with A = 1.9, C = 0 and  $X_0 = 100$  and assume that

The behavior of solution at these parameters is shown in Fig.8, where the case  $_3 = 0$  (with  $_1 = 0.5$ ) is also presented for comparison. In the latter case, the initial pulse splits into four solitons of the form (33), (35)-(38), with  $a_2 = 1$  and moving to the left (Fig.8a). On the other hand, in the case (79) the initial pulse splits into three radiating solitons. Two of them propagate to the right and the smallest one - to the left.

The radiating wavetrains propagate to the right with the group velocities larger than the soliton velocities (Figs. 8b and 8c); this is in agreement with Eq. (60). The time dependence of the soliton coordinates is shown in Fig.9. At <sub>3</sub>, the soliton velocities are constant. At <sub>3</sub> = 0.1, the solitons are accelerating in positive direction, which agrees with Eq. (64).

The Fourier spectra for both cases,  $_3 = 0$  and  $_3 = 0.1$ , are shown in Fig. 10. The spectrum at  $_3 = 0$  exhibits no resonant radiation (Fig.10a) while at  $_3 = 0.1$  we see three distinct resonant peaks with negative , which are the wave num bers of the resonant radiation em itted by the solitons in the "laboratory" fram e (Fig.10b). The di erence between the wave num bers follows from Eq. (20) which is valid, as we have seen, both for em bedded and radiating solitons. As far as the solitons have di erent velocities and am plitudes (the latters are determ ined by the soliton parameter ), they have di erent wavenum bers because , being a root of Eq. (20), depends on the soliton velocity and am plitude.

 $_3 > 0, k > 0, U < 0$ ). On the right hand side, there is a radiation composed from the harmonics of continuous spectrum; it satis as the linearized Eq.(1) and has been em itted in the transient period of time. The spectal distribution is shown in Fig.14. One can see two spectral maximums at positive wavenumbers. The narrow one corresponds to the resonant radiation, while the broader peak is composed of the continuous spectrum. Its structure can be understood from the dispersion equation

As far as  $k_0$  is less then the wavenum ber of resonant radiation, approxim ately given by Eq.(50) (note that in our case, according to (45),  $a_2 > 1$ ), one can see why the peak of continuous spectra is less than of resonant radiation. All this show s that the pulse in Fig. 13 is nothing than RRS. The time behavior of its amplitude is shown in Fig. 15; qualitatively, it is similar to Fig. 3a.

It is reasonable to compare these results with the case  $_1 = 0.6$ ,  $_3 = 0$ , at the same initial condition. Then we have two regular solitons, propagating to the right. The soliton positions versus time for both cases are shown in Fig. 16. Note a very sm all acceleration of RRS in the direction of group velocity (which is now negative).

An important di erence between the two cases,  $_3 = 0$ and  $_3 \in 0$ , is seen in Figs. 11 and 12. In the rst case, the average soliton amplitudes have constant limits at t! 1 while in the second case they must slow ly decrease because of the soliton radiation.

In the aforegoing, we studied the case when 1 = 3 = 0. Now let us consider 1 = 3 = 0. We take

and initial condition (77) with  $C = 1=2, X_0 = 850$ . The solution at T = 370 is shown in Fig. 13. We see a pulse with radiation on both its sides. An analysis show s that on the left hand side there is the resonantly generated radiation (in agreement with Eq. (60), where now We have considered soliton and quasisoliton solutions of Eq. (1) and their relationship. Solutions (2), describing regular solitons, degenerate at  $_3$  ! 0; this shows that they exist due a balance between nonlinear terms and linear third order dispersion. On the other hand the quasisolitons (embedded and resonantly radiating)

turn at  $_3$ ! 0 into the regular soliton solutions of Eq. (1) without the third derivative term . A part from that, at  $_2$  = 0, the regular solitons exist only in the special case  $_1$  = 6  $_3$ .

The resonantly radiating solitons (RRS) are nonsteady; the amplitudes of their radiation at sm all  $_3$  are exponentially sm all and so their parameters change logarithm ically slow in this case. Only such quasisteady solitons have su ciently large lifetim es to be of physical signi cance. The embedded solitons (ES), which are steady structures consisting of pulses embedded into plane waves (wings), have close connection with RRS, sim ilar to other system s. The corresponding analytical treatment in Sec.III is suplemented by numerical simulations with the cut o operation (Sec.IV); it is dem onstrated that it leads to the transform ation of ES into RRS that radiates in the direction of the radiation group velocity. Just after the cutt o, the amplitude, velocity and wavenum ber of the radiated wavetrain coincide with those of wings; marching in time, we have seen that the amplitude decreases, the soliton velocity increases and the wavenum ber changes according to Eqs.(30) and (31). This is in agreement with conservation laws (Appendix В).

In Sec. V we have investigated a special case  $_1 = 6_3$ , interesting from a theoretical point of view. Then the quasisolitons, ES and RRS, do not exist and Eq. (1) can be reduced to the complex MKdV equation which has N -soliton solutions (consisting of regular solitons). This generalizes the H irota solutions obtained for  $_1 = 6_3$ ,  $_2 = 0$ . The complex MKdV equation possesses the Painleve property only at  $_2 = 3_3$ , which is the case when Eq.(1) is integrable.

P resum ably, in the nonlinear processes only regular solitons and RRS may be of the physical signi cance. From Eq. (2b) it follows, how ever, that the amplitude of regular soliton vanishes at  $_3$  ! 0, while for the RRS it remains nite. Therefore one should expect that at small  $_3$ , the RRS are more important in the nonlinear evolution. This was con med by solving the initial value problem (Sec. VI), where the RRS and not regular solitons are seen emerging from the initial disturbances. (Sm all  $_3$  is the most interesting case from physical point of view because the third derivative term is in fact the result of an expansion).

Applying the stability criterion to the wings of embedded solitons, where  $1=2_{3}$ , we see that this may satisfy condition (A9b); then one can expect that the wings are stable. Now, consider Eq. (B15). Taking into account (B2), (B10), (B11) and (B19) we see that at

and sm all  $_1$ , Eq. (B15) is approximately equivalent to (B18). Performing calculations similar to those in Ref. [19] and using (B14), we conclude that the soliton width

<sup>1</sup> and velocity V (t) are changing logarithm ically slow. The same holds for the soliton am plitude  $u_{(}9t)$ , determined from (39) and (37), in agreement with numerical solution of Eq.(1) (see Figs.3). The chracteristic time of the variations of soliton parameters has the same order of magnitude as in Ref.[26], which is much less than the right hand side of (B 20).

If  $_1$  is not small, the analysis is rather tedious and will not be considered here.
