#### Abstract

The dynam ics of soliton and quasisoliton solutions of cubic third order nonlinear Schrodinger equation is studied. The regular solitons exist due to a balance between the nonlinear term $s$ and (linear) third order dispersion; they are not im portant at small ${ }_{3}\left({ }_{3}\right.$ is the coe cient in the third derivative term ) and vanish at 3 ! 0. The most essential, at small 3 , is a quasisoliton em itting resonant radiation (resonantly radiating soliton). Its relationship $w$ ith the other (steady) quasisoliton, called em bedded soliton, is studied analytically and in num erical experim ents. It is dem onstrated that the resonantly radiating solitons em erge in the course of nonlinear evolution, which show stheir physical signi cance.

## I. IN TRODUCTION

Equations describing soliton processes are usually obtained by certain approxim ating procedures a ecting nonlinearity and dispersion. N ow, in extensive studies of ultrafast processes, the classical approxim ations often appear to be insu cient and higher order e ects becom e of im portance. A typical exam ple is high speed system $s$ like nonlinear transm ission lines in fem tosecond regim e for soliton com m unications, etc. For such system s soliton solutions in classical sense do not generally exist. O nly for very speci $c$ choiges of param eters one can nd $10-$ calized solutions. Instead of regular solitons there $m$ ay appear nonlocal steady or (and) unsteady soliton like structures (which may be called quasisolitons). These $m$ ay, how ever, have signi cant im portance for the nonlinear dynam ics.

In this paper we consider dynam ics described by the extended third-order cubic nonlinear Schrodinger (NLS) equation

which plays an im portant role in $m$ any nonlinear problem $s$, in partiqular, in the nonlinear ber optics [1,2]. T he third derivative term describes higher order correction to the linear dispersion and the cubic term $s$ w ith the rst derivative are dispensive nonlinear corrections. H ere, we assum e that all n (1 n 3) are real param eters.

Eq.(1) has regular soliton solutions [3-5], vanishing at ※ j! 0. In particular cases, Eq.(1) m ay have exact N soliton solutions [4] or even be integrable [5]. An im portant feature of the solutions describing regular solitons is that they are degenerating at $3!0$ (see below), which substantially reduces their physical im portance. Their num erical investigation at $1 ; 2 \quad 1$ where done e.g. in Ref.[6] (see also references therein)

There also exist som e solutions to Eq.(1), describing quasisolitons. O ne of them is a steady solution looking like a soliton type pulse em bedded into a sm all am plitude plane wave (a soliton on plane wave pedestal). W e call it em bedded soliton ( $E S$ ), using the w ord proposed in a di erent context in Ref.[7]. A part from that, Eq. (1) has other type of quasisoliton solutions which describe soliton-like pulses perm anently em itting resonantly generated radiation (see, e.g., $R$ efs. [8-12] for the particular case at $1=2=0$ and $[13,14]$ for the full Eq.(1)). W e will call them resonantly radiating solitons (RRS); they are unsteady because of losses caused by the radiation. $T$ he lifetim e of radiating soliton is su ciently large if 3 is sm allenough and, naturally, one can speak about the soliton only in this quasisteady case. (H ow ever, at long tim es, the losses caused by the radiation becom e essential for applications [2].) At $3!0$, the RRS tums into the regular soliton of Eq.(1) w ithout the third derivative.
$T$ here is an interesting and im portant connection betw een the two types of quasisolitons, ES and RRS, and we dem onstrate it in num ericalsim ulations. W e w illalso study the role of solitons and quasisolitons in the nonlinear processes described by Eq.(1). In partiqular, the regular solitons and RRS com pete between them selves in nonlinear processes. A s far as the regular solitons disappear at $3!0$ and the RRS have short lifetim es at large 3 , it is clear that at large 3 the regular solitons are $m$ ore im portant while the RRS m ay play a decisive role at su ciently $s m$ all 3. T he m ost interesting case is, of course, sm all 3 , because the third derivative term em erges as the result ofan expansion. (T he e ect ofnext, 4th derivative, term can be seen in Refs .[13,14]; at certain relalionship betw een the coe cients before third and fourth derivatives there can be no radiation at allwhich, naturally, m ay happen also when other high-order tem s are taken into account.)

The paper is organized as follows. In Sec.I we describe im portant properties of Eq.(1), which are used below. In particular, we discuss regular soliton solu-
tions [3], G alilean transform ations and conservation law s [13,14]. The em bedded solitons are studied in Sec.3. A s we have already $m$ entioned, the ES consists of a steady soliton-like pulse on the plane wave background. This structure is rater com $m$ on in di erent nonlinear highly dispersive system s [9-20]. At $3!0$, the plane wave disappears and the pulse tums into a regular soliton of Eq. (1) at $3=0$. The plane wave amplitude, increasing $w$ ith $3, m$ ay becom e unstable at su ciently large 3 due to the $m$ odulational instability. C onsidering sm all 3 , we show that the pulse part of $E S$ is rather close to the pulse in RRS and the wavenum ber of the plane $w$ ave coincides $w$ th the $w$ avenum ber of resonantly em itted radiation (by the RRS). N ext, we introduce the cut o operation, cutting o both wave wings from the ES (Sec.IV).Then we see that the rem ained soliton-like pulse is transform ed into the RRS, em itting radiation only in one direction, according to the direction of the group velocity of resonant radiation. T he resonant radiation disappears at ${ }_{1}=63$. In this case, considered in Sec.V, we show that Eq.(1) can be transform ed, by $m$ eans of the $G$ alilean transform ation, to the com plex m odi ed K ortew eg-de V ries ( $M \mathrm{~K} \mathrm{dV}$ ) equation. At particular initial conditions, it is reduced to the realM $\mathrm{K} d V$ equation which is integrable and therefore has N -soliton solutions [22]. This does not $m$ ean the com plete integrabillity of Eq.(1) at $1=63$, because the reduction to the realM KdV equation is possible only for particular initial conditions. H ow ever, the Painleve analysis [21] of the above $m$ entioned com plex M K dV equation shows that at $6{ }_{3}=1=22$ it possesses the $P$ ainleve property. This is just the case when Eq. (1) is integrable [5]. If $2_{2}=0$, we arrive at the case considered by $H$ irota [4] who has shown the existence of $N$ - soliton solutions in this case. Our approach, however, is m ore general and (in fact, as in Ref. [23]) we can see that the $N$ -soliton solutions are possible even for nonvanishing 2 (at $263_{3}$ ). Then we present a num erical study of the initial value problem in the $H$ irota case: ${ }_{1}=63$,
$2=0$ taking as initial conditions com plex pulses and one can see how the robust H irota solitons are em erging from these pulses. In Sec.V I, we describe num erical experim ents at $1 \notin 6$. Solving the initial value problem, we show that, at su ciently sm all 3, the initial disturbances decay into the resonantly radiating solitons (RRS).On the other hand, at sm all 3, the P otasek-Tabor solitons [3] w ere not detected. $T$ his indicates that the RRS are im portant physicalob jects playing a signi cant role in nonlinear dynam ics. In Sec. VII, a sum $m$ ary of obtained results is given. In A ppendix A, the m odulationalinstability of a plane w ave, described by Eq.(1), is considered; it is helpful in the study of the stability of em bedded solitons. In A ppendix B we investigate analytically, by $m$ eans of conservation law $s$, the evolution of RRS caused by the radiation. This analysis is in agree$m$ ent $w$ th num erical results described in Secs.IV and V I.
II. IM PORTANT PROPERTESOFEQ.(1)

## a. E xact soliton solutions

First, we discuss the exact soliton solutions of Eq.(1). $T$ hey can be w ritten in the form

In fact, these are the soliton solutions found by P otasek and Tabor [3] (w ith corrected m isprints). W e w ill call Eqs. (2a-e) Potasek-Tabor (PT) soliton solutions. At $3=0, \mathrm{PT}$ solitons do not exist; this signi es that their existence is a result of a ballance between the nonlinear term $s$ and the linear third order dispersive term. If $2 \in 0$, from Eq. (2e) it follows that is a xed num ber, uniquely determ ined by the coe cients of Eq.(1). H ow ever, the solitons (2) exist even at $2=0$ provided that

In this case can be anbitrary, because Eq. (2e) follow s from the equation $122_{2}=16_{3}+22$.

In case (3) and $2=0$, Eq. (1) is the so called H irota equation that can be transform ed to the com plex modi ed K ortew eg-de V ries equation which has N -soliton solutions [4]. For the H irota soliton, from Eq.(2b) it follow s

In the other particular case, $6_{3}=1=22$, Eq. (1) is integrable [5]. (See also Sec.V .) Som e results for solitons (2) with $2 \in 0$ were reported in Ref.[6] (see also references therein). In particular, it was show n num erically that they em erge in a solution of initiall value problem. H ow ever, this result was obtained at $1=3=1$; at sm all 3, as it willbe show $n$ below, they cannot com pete w th RRS.

Apart from the solution (2a-e), describing "bright" solitons, w hich w as called in R ef. [3] sech-fam ily, P otasek and T abor have also found tanh-fam ily which w ill not be discussed here. (Som e generalizations, w ith both sech and tanh term $s$, are derived in Ref. [27] by $m$ eans of rather tedious algebra; the results of this paper are m ostly contained in Ref.[3] and the generalizations [27],
which are valid for very speci c choices of the param eters, can be obtained by the $m$ uch sim pler approach of P otasek and Tabor.) The results of Ref.[3] are repeated also in som e other papers (e.g.[23]).

## b. G alilean transform ation

In the follow ing we shall frequently use the $G$ alilean transform ation describing the transition to the reference fram em oving w ith the velocity V .For Eq. (1) it reads

## III. EM BEDDED SOLITONS

W e start w ith the solutions to Eq. (1) of the form

Im posing periodic boundary conditions at the ends of a su ciently broad interval and considering $V$ and ( 0 ) as given param eters and as the eigenvalue, we arrive at a nonlinear eigenvalue problem which can be num erically solved by a kind of shooting $m$ ethod. A $n$ exam ple ofsuch solution at $2=0$ and

. From Fig. 1b we see that the num erically found
(x) has indeed asym ptotic behavior (19) w th $5: 3$ which is very close to the root of Eq. (20), w ritten in (21). This agreem ent is an evidence of the correctness of the num erical solution of eigenvalue problem by the shooting $m$ ethod. In a sim ilar way, the solution of eigenvalue problem (17) and Eq. (20) for $2=0$ and

In fact, sim ilar quasisoliton solutions, looking like embedded solitons, were obtained, by di erent approaches, for other highly dispersive system s as well [15-17,9,11,12,17-20].

N ow consider the embedded solitons, starting from G alilean transform ation (5). W riting it in the form

A sm all term $f(x)$ in Eq.(32) expresses the e ect of the third order dispersion. At $\dot{x} j \quad-\left(a_{2}\right)=$, or less, it describes a m odi cation of the pulse, arising due to the last term in Eq. (28), while at large x

where $k$ is a root of Eq. (30). N ote, that this equation was derived in Ref. [14] for the wavenum ber of the resonantly generated radiation by the RRS in the reference fram e where the RRS is at rest. From all that we conclude that (32) coincides w ith the asym ptotic expression for the RRS and its radiation at large $t$.

Let us now com pare the em bedded solitons, obtained above num erically, w th the solution (32) at condition (13). From Eq.(38) we have

So, in all three cases we approxim ately have $u_{0} \quad 1: 4$ which is rather close to $(0)=1: 5$, as sum ed in the nonlinear eigenvalue problem for all three cases. This supports the conclusion that expressions (35) and (36) approxim ately describe the pulse in the em bedded soliton (at sm all 3).

Now consider $f(x)$. At sm all 3 , the roots of Eq. (30) have sim ple analytical expressions [14]. Neglecting the rst term in (30), we have two sm allest roots

It is easy to check that we can arrive at Eq. (55) by substituting in Eq. (52) the rst of conditions (54) and $\mathrm{p}=1$.

From the all foregoing, one can see a connection between the em bedded and resonantly radiating solitons. In the next section we present num erical experim ents disclosing this connection from another side.

## IV.THECUTOFFOPERATION

Let us de ne the cut o operation transform ing the em bedded soliton into an isolated pulse. Tuming to the function ( $x$ ) in (16), we w rite

characterizes the "sharpness" of vanishing. A ssum ing that is sm all enough and $x$ is such that the factor $r(x)$ cuts $o$ only the $w$ ings $w$ thout essential disturbing the pulse in ( $x$ ) ( and $x$ can be properly chosen in
num erical tests) we then take the pulse cut (x) as the initial condition to Eq.(1) (see F ig 2a)

In F ig 2 b one can see that the cutted pulse em its radiation at $t>0$. H ow ever, on the left hand side of the pulse the radiation spreads out $w$ ith tim $e$; this show s that on the left hand side there is a transient radiation, em ilted at $s m$ all $t$ due to initial condition (58). On the contrary, on the right hand side we see a wave train w ith approxim ately constant am plitude, w ith the front propagating to the right; so, the length of the w avetrain increases w ith time. Therefore the cutted pulse perm anently em its radiation to the right. T he spectrum, show $n$ in $F$ ig. 1 c , has a peak at approxim ately equal to the root of Eq. (20) $w$ ith account of nite velocity of the pulse at $t=138$ (it is still rather close to from Eq. (21), i.e. to the w avenum ber of the w ing waves in em bedded soliton).

A nalyzing the time behavior of arg, we nd that $d(\arg )=d t=(t)$ is a slow function of $t$, $w$ ith ( 0 ) $0: 98$ and (130) 0:85. N ote that this (0) coincides, w ith a good accuracy, w th (21). Sim ilar results were obtained for cutted pulses in cases (22) and (23).

W e conclude that the cutted pulses are radiating solitons; and the radiation is perm anently em itted only in one direction. As far as is connected w th $k$ from Eq. (31), which is the real root of Eq. (30), obtained from the resonant condition, we conclude that the cut o operation transform S ES ino RRS. The front of radiated w avetrain propagates $w$ ith the group velocity $U(k)$ given by [14]

Therefore at $3<0$ it should be $k<0$ and $U(k)>0$. This means that the soliton in Fig. 2a should perm anently em it radiation to the right while the peak in the spectrum of the wavetrain should be at negative $k$. This
is in agreem ent w ith the results presented in Figs. 2b and 2 c .

To describe analytically the whole system after the cut 0 , one can use at sm all 3 the equation [14]

Eq. (62) expresses that the soliton radiates in the direction of group velocity $U$ and the radiation front propagates $w$ ith the velocity $j \mathrm{j} j$. The mentioned above adiabatic approxim ation $m$ eans that at su ciently sm all $3^{3}$, the radiation is so sm all that the soliton param eters in $u_{s}(x)$ and $s(x)$ (as well as the $w$ avenum ber $k$ ) can be considered as constant. H ow ever, the soliton losses may be essential at large tim es.

The variation of solition param eters, caused by the radiation, can be estim ated by $m$ eans of the integrals of $m$ otion (A ppendix B). A vast inform ation about the soliton evolution, caused by the radiation, follow srom the num erical solution of Eq.(1). For the param eters used in Figs. 2, the results follow ing from this solution are presented in $F$ ig.3. O ne nds that the $m$ ean value of $j j_{\mathrm{max}}=u_{0}(t)$, shown in $F$ ig.3a, decreases logarithm ically, sim ilar to what was found for the case $1=2=0[25,26]$. A nalyzing the soliton position ( $F$ ig.3b) one can nd that the soliton velocity $V$ ( $(t)$ increases from $\mathrm{V}(0)=0$ to $\mathrm{V}(138) \quad 0.29$, i.e. the soliton is accelerating and the function $V(t)$ increases (also logarithm ically). N ow, using (0) 0:98, (138) 0:85 and Eqs. (47),(44), we have ${ }^{(0)} \mathrm{p} \frac{1: 4, ~(138)}{} 1: 28$. $T$ herefore, the soliton width $=P \overline{a_{2}}=$ increases from
(0) 0:71 to (138) 0:99, i.e. the radiating soliton is widening with time. All that can be considered as a num erical con $m$ ation of analytical results obtained in A ppenix B from the conservation law s , in particular that

(75) indeed describe the $H$ irota solitons, $m$ entioned in $\operatorname{Sec} 2 \mathrm{a}$. It is also seen that though the H irota conditions do not ensure the integrability ( P ainleve tests are negative !), Eq. (1) in H irota case de nitely has exact $N$ -soluton solutions.

The structures of $(X ; T)$ at $T=0$ and $T=168$ are show $n$ in $F$ igs. $4(a, b)$. $W$ e see that ( $X ; T$ ) evolves into tw o pulses, well separated at $T=168$. $T$ he spetrum of ( $\mathrm{X} ; \mathrm{T}$ ) at $T=168$ ( $F$ ig .5) gives an evidence that, in addition to these pulses, no signi cant w avetrains are produced at in itialcondition (77). The time variation of the am plitude of the pulse $w$ ith largest amplitude, $j^{(1)} j$ is shown in $F$ ig.6. It approaches the constant lim it, approxim ately equal to 1.5 . The velocity of that pulse approaches the lim it approxin ately equal to 0.35 . These results suggest that the leading pulse asym ptotically approaches a regular soliton $w$ th $a^{(1)} \quad 1: 5$ and $V_{s}^{(1)} \quad 0: 35$. The shapes of $(X ; T)$, obtained num erically for $T>150$, con m this conclusion. T hen, using Eqs. ( $2 \mathrm{c}, \mathrm{d}$ ) and (4), we can calculate the shifted frequency $!^{0}=!(\mathrm{k}) \quad \mathrm{kV}_{\mathrm{s}}{ }^{(1)}$, which is the soliton frequency in the reference fram e where the soliton is at rest. The plot of $!^{0}$ versus $V_{s}$, shown in $F$ ig. 7 , gives ! ${ }^{0}(0: 35) \quad 1: 5$. Thism ust be equal to arg ${ }^{(1)}$. O n the other hand, the num erical solution perm its to obtain arg (1) versus time in the frame where the pulse is at rest. This also gives arg ${ }^{(1)} 1: 5$, at su ciently large T . Sim ilar results were obtained for the second pulse. T hus we conclude that the initial com plex pulse (77) decays into two H irota solitons. Q ualitatively sim ilar results were obtained for the in itial pulse

O ther features of the dynam ics of $H$ irota solitons, in particular their collisions, will be exam ined in another paper.
VI.PULSE EVOLUTIONAT 1 G 6

H ere, we report on the num ericalsolutions ofE q. (1) in general case. F irst we take, as in itial condition, the pulse (77) $w$ ith $A=1.9, C=0$ and $X_{0}=100$ and assum $e$ that

The behavior of solution at these param eters is show $n$ in Fig.8, where the case $3=0$ (w th $1=0: 5$ ) is also presented for com parison. In the latter case, the initial pulse splits into four solitons of the form (33), (35)-(38), w th $\mathrm{a}_{2}=1$ and m oving to the left ( F ig.8a). On the other hand, in the case (79) the initial pulse splits into three radiating solitons. Two of them propagate to the right and the sm allest one - to the left.

$T$ he radiating $w$ avetrains propagate to the right $w$ ith the group velocities larger than the soliton velocities ( $F$ igs. 8b and 8c); this is in agreem ent w ith Eq. (60). $T$ he tim e dependence of the soliton coordinates is show $n$ in F ig. 9 . At 3, the soliton velocities are constant. At $3=0: 1$, the solitons are accelerating in positive direction, which agrees w ith Eq. (64).

The Fourier spectra for both cases, $3=0$ and $3=0: 1$, are show $n$ in $F$ ig. 10. The spectrum at $3=0$ exhibits no resonant radiation ( F ig.10a) while at
$3=0: 1 \mathrm{we}$ see three distinct resonant peaks w ith negative, which are the wave num bers of the resonant radiation em itted by the solitons in the "laboratory" fram e ( $F$ ig.10b). T he di erence betw een the w ave num bers follow s from Eq. (20) which is valid, as w e have seen, both for em bedded and radiating solitons. A s far as the solitons have di erent velocities and am plitudes (the latters are determ ined by the soliton param eter ), they have di erent wavenum bers because , being a root of Eq. (20), depends on the soliton velocity and am plitude.

A $n$ im portant di erence betw een the tw 0 cases, $3=0$ and $3 \in 0$, is seen in $F$ igs. 11 and 12. In the rst case, the average soliton am plitudes have constant lim its at $t$ ! 1 while in the second case they $m$ ust slow ly decrease because of the soliton radiation.

In the aforegoing, we studied the case when $1 \begin{array}{llll} & 3 & 0 .\end{array}$ Now let us consider 130 O. W e take

and intial condition (77) w ith $C=1=2, X_{0}=850$. $T$ he solution at $T=370$ is show $n$ in $F$ ig. 13. $W$ e see a pulse w th radiation on both its sides. An analysis show s that on the left hand side there is the resonantly generated radiation (in agreem ent w ith Eq. (60), where now
$\left.{ }_{3}>0, \mathrm{k}>0, \mathrm{U}<0\right)$. On the right hand side, there is a radiation com posed from the harm onics of continuous spectrum ; it satis es the linearized Eq.(1) and has been em itted in the transient period of tim e. T he spectal distribution is shown in Fig.14. O ne can see tw o spectral m axim um s at positive wavenum bers. The narrow one corresponds to the resonant radiation, while the broader peak is com posed of the continuous spectrum. Its structure can be understood from the dispersion equation

As far as $\mathrm{k}_{0}$ is less then the w avenum ber of resonant radiation, approxim ately given by Eq.(50) (note that in our case, according to (45), $a_{2}>1$ ), one can see why the peak ofcontinuous spectra is less than of resonant radiation. All this show s that the pulse in $F$ ig. 13 is nothing than RRS.T he tim e behavior of its am plitude is shown in Fig. 15 ; qualitatively, it is sim ilar to Fig. 3a.

It is reasonable to com pare these results $w$ th the case $1=0: 6,3=0$, at the sam e intial condition. Then we have two regular solitons, propagating to the right. $T$ he soliton positions versustim e forboth cases are show $n$ in $F$ ig. 16. $N$ ote a very sm all acceleration of RRS in the direction of group velocity (which is now negative).

## V II. CONCLUSIONS

W e have considered soliton and quasisoliton solutions of Eq. (1) and their relationship. Solutions (2), describing regular solitons, degenerate at $3!0$; this show s that they exist due a balance betw een nonlinear term $s$ and linear third order dispersion. O $n$ the other hand the quasisolitons (em bedded and resonantly radiating)

tum at 3 ! 0 into the regular soliton solutions of $q$. (1) $w$ thout the third derivative term. A part from that, at $2=0$, the regular solitons exist only in the special case $1_{1}=63$.

The resonantly radiating solitons (RRS) are nonsteady; the am plitudes of their radiation at sm all 3 are exponentially sm all and so their param eters change logarithm ically slow in this case. Only such quasisteady solitons have su ciently large lifetim es to be of physical signi cance. The em bedded solitons (ES), which are steady structures consisting of pulses em bedded into plane waves (w ings), have close connection with RRS, sim ilar to other system s. The corresponding analytical treatm ent in Sec.III is suplem ented by num erical sim ulations w th the cut o operation (Sec.IV) ; it is dem onstrated that it leads to the transform ation of ES into RRS that radiates in the direction of the radiation group velocity. Just after the cutt o , the am plitude, velocity and w avenum ber of the radiated w avetrain coincide $w$ ith those of $w$ ings; $m$ arching in tim $e$, we have seen that the am plitude decreases, the soliton velocity increases and the w avenum ber changes according to Eqs.(30) and (31). This is in agreem ent with conservation laws (Appendix B).

In Sec. V we have investigated a special case $1=6$ 3, interesting from a theoretical point of view. Then the quasisolitons, ES and RRS, do not exist and Eq. (1) can be reduced to the com plex M K dV equation which has N -soliton solutions (consisting of regular solitons). $T$ his generalizes the $H$ irota solutions obtained for $1_{1}=$ $63,2=0$. The com plex M K dV equation possesses the Painleve property only at $2=33$, which is the case when Eq.(1) is integrable.

P resum ably, in the nonlinear processes only regular solitons and RRS m ay be of the physical signi cance. From Eq. (2b) it follow s, how ever, that the am plitude of regular soliton vanishes at 3 ! 0, while for the RRS it rem ains nite. Therefore one should expect that at sm all 3 , the RRS are $m$ ore im portant in the nonlinear evolution. This was con $m$ ed by solving the initial value problem (Sec. V I), where the RRS and not regular solitons are seen em erging from the initial disturbances. (Sm all 3 is the most interesting case from physicalpoint of view because the third derivative term is in fact the result of an expansion).
