#### Abstract

W e derive integrable discrete system $s$ which are contiguity relations of tw o equations in the Painleve-G ambier classi cation depending on som e param eter. These studies extend earlier work where the contiguly relations for the six transcendental Painleve equations were obtained. In the case of the $G$ am bier equation we give the contiguity relations for both the continuous and the discrete system .

## 1. Introduction

$T$ he relation of discrete $P$ ainleve equations to their, better know $n$, continuous analogues has by now been m ly established. A s a $m$ atter of fact one of the very rst $m$ ethods proposed to the derivation of discrete $P$ ainleve equations ( $d-P$ ) has been the one based on the auto$B$ acklund/Schlesinger transform ations of continuous $P$ ainleve equations [1]. ( $T$ his link goes even further back in time since one of the rst discrete $P$ ainleve equation obtained, even before the notion of a $d P$ was explicited, was the one derived by Jim bo and M in a [2] as a contiguity relation of the solutions of $P_{\text {II }}$ ). The general $m$ ethod for this derivation has been am ply explained in previous publications [3]. O ne uses the auto-B acklund/Schlesinger transform ations in order to derive relations for the solutions of a continuous P ainleve equations for contiguous values of the one of its param eters and one gets precisely a $d P$. The discrete equation related to $P_{\text {II }}$ has been rst obtained, as explained above, by Jim bo and $M$ iva [2] and rediscovered in [1]. The $d P^{\prime}$ 's related to $P_{\text {III }}$ were rst given in [1] and have been recently reexam ined in detail in [4]. The discrete equation related to $P_{\text {Iv }}$ was rst obtained in [1] and was again studied in [5]. Som e $d P^{\prime}$ 's related to $P_{v}$ were rst given in [1] but the relation of $P_{v}$ to asym $m$ etric $d P_{\text {II }}$ is under preparation [6]. Finally the discrete system s obtained from the auto-B acklund of $\mathrm{P}_{\mathrm{VI}}$ were presented in full detail in [7]. Thus the discrete, di erence, $P$ ainleve equations can be interpreted as the contiguity relations of the continuous ones. ( T his would tend to cast a doubt on the fiundam ental character of the $d P^{\prime} s . W$ hile this is justi ed as far as the di erence $d P$ 's are concemed there exists a second type of $d P$ 's which have no relation to continuous $P$ ainleve equations whatsoever. T hese are the $m$ ultiplicative equations, $q P^{\prime}$ s [8] which are purely discrete ob jects and thus of the $m$ ost fiundam ental nature). O ne of the consequences of this relation between continuous and discrete $P$ ainleve equations is that one can obtain the Lax pairs of the latter from the $m$ ere existence of the Lax pairs and Schlesinger transform ations of the form er. The only com plication com es from the fact that given a $d P$ one has to identify the procedure for its derivation based on the Schlesinger transform ation of som e continuous Painleve equation. $T$ his can be done in the fram e of the geom etric description of $P$ ain leve equations which was introduced in [9] and dubbed the \G rand Schem e". T his description based, on the geom etry of the a ne $W$ eyl group weight spaces, has tumed out to be a m ost valuable tool for the classi cation of the $d P^{\prime}$ 's, which $m$ inim ised their uncontrollable proliferation.

In the approach we have described above the em phasis was on the discrete analogues of the six transcendentalequations ofP ainleve. A s a m atter of fact the rem aining integrable OD E's of the P ainleve-G am bier classi cation have received little attention. O ur current know ledge is essentially lim ited to the discrete analogues of the 24 basic equations of G am bier [10]. In particular no results exist on the contiguity relations other than for the six equations
of Painleve. In this paper we intend to focus on just this question and present a rst, exploratory, study of som e discrete equations related to continuous system $s$ which are not one of the six $P$ ainleve equations. In particular we shall obtain the $m$ appings related to the equations 35 and 27 of the Painleve-G am bier classi cation. Equation 27 is also known as the $G$ am bier equation and has been studied in detail in [11], where its discrete equivalent has been obtained. Since, as was show $n$ in [12], both the continuous and discrete $G$ am bier equations possess Schlesinger transform ations, one can obtain the contiguity relations not only of the continuous but also of the discrete system. T his result is presented in the last part of the present paper.

## 2. D iscrete systems related to $\mathrm{P}_{35}$

The rst system we are going to exam ine is the equation \# 35 in the $P$ ainleve-G am bier classi cation [13]:

$w$ here $z$ is the independent variable and is a constant. The way to integrate this equation is based on the follow ing M iura transform ation. W e start with the general solution of $P_{\text {II }} V$, and we construct the quantity

which solves (2.1). M oreover, starting from the general solution of (2.1) w , the quantity

solves $\mathrm{P}_{\text {II }}$. Equations (2.3) and (2.4) de ne a M iura transform ation relating $\mathrm{P}_{\text {II }}$ and $\mathrm{P}_{35}$. A nother such $M$ iura relation betw een $P_{\text {II }}$ and som e other equation of the $P$ ainleve-G am bier list is already know $n$, that relating $P_{\text {II }}$ and $P_{34}$. It has been studied in detail in [14] in both the continuous and the discrete case.

Equation $P_{35}$ has a param eter, ,through its relation to $P_{\text {II }}$. Let usw ritew for the solution of (2.1) corresponding to the param eter and $v$ and $q$ for the solutions of $P_{\text {II }}$ entering in (2.1), (2.3) and (2.4). N ext we consider the auto-B acklund transform ations of $P_{\text {II }}$ [15]:

corresponding to solutions where the param eter varies by integer quantities. Thus, follow ing the general theory presented in [1] one can introduce a discrete system associated to these transform ations as a m apping which is the contiguity relation for the solutions of $\mathrm{P}_{\text {II }}$. This equation was in fact rst obtained in [2] and is now know $n$ (at least to the present authors) under the nam e of altemate $d P_{I}$. It has the form

$T$ his is the equation satis ed by all solutions of $P_{\text {II }}$, and in particular by $q$, when we vary the param eter of $P_{\text {II }}$ using (2.5).

U sing the M iura (2.3) we can obtain the solutions of $\mathrm{P}_{35}, \mathrm{w}+1$ and $\mathrm{w} \quad 1$, corresponding to the param eter values 1:

U sing (2 2), (2.3), (2.5) and (2.7), one can write an equation relating $w+1, w$ and $w \quad 1$ alone where neither v nor its derivatives appear. Interpreting as a discrete independent variable, we obtain thus a second-order discrete equation for w . This mapping is how ever quadratic in w +1 and w 1 and thus (as was also argued in [16]) cannot be integrable. O ur argum ent is based on the fact that the evolution of such a mapping leads in general to an exponential num ber of im ages, and preim ages, of the intitial point. The non-integrability of this non-singlevalued system is not in contradiction to the fact that we can obtain one solution of this $m$ apping, nam ely the one fumished by the evolution of the system before elim ination. This solution is the only one that we know how to describe, while a system w ith exponentially increasing num ber of branches eludes a full description.

In order to proceed, instead of working w ith a second-order $m$ apping, we choose to derive a system of two coupled equations. W e rst $m$ ake use of the discrete sym $m$ etry of the solutions of $P_{\text {II }}$ : if $v$ is a solution of $P_{\text {II }} w$ th param eter, then $v$ is a solution of $P_{\text {II }}$ w th param eter.$W$ e then introduce the quantity

$v$ and $q!q . T$ he quantity $u$ is thus the solution of a slightly $m$ odi ed $P_{35}$ equation (w ith $q$ instead of $q$ ) that we shall denote $P_{35}$. N ote that, from (2.3) and (2.8) we have:

W e start by writing an equation between $w{ }_{1}$, w and $u$ only, using (2.2), (2.3), (2.5), (2.7) and (2.9). Sim ilarly we also obtain an equation relating $u+1, u$ and $w . W$ e thus nd the second-order discrete system :

where $q$ is a particular solution of (2.6).
$T$ his system introduces the contiguity relations for equation $\mathrm{P}_{35}$ (2.1) and $\mathrm{P}_{35}$. It can be integrated $w$ ith the help of altemate $d P_{I}$, equation (2.6). We rst write $v^{0}$ in term $s$ of $v+1$ and $v$ and $q^{0}$ in term $s$ of $q+1$ and $q$ using the Schlesinger transform ation (2.5). U sing these expressions in the de nition (2.3), we obtain the follow ing:

The quantity $u$ is obtained in term sof $v$ and $w$ using (2.9). Thus, once $v$ is know $n$, we can construct $w$ and $u$ in a straigthforw ard way.

At this point we can rem ark that while (2.10) is integrable by construction, the condition for integrability, nam ely that $q$ is a speci c function, $m$ ay appear som ew hat contrived. In what follow s we shall show that the fact that $q$ satis es altemate $d \mathrm{P}_{\text {I }}$ can be obtained precisely through the singularity con nem ent criterion. We start by writing (2.10) and (2.6) in a $m$ ore convenient way in order to im plem ent the singularity analysis.:

There are three possible sources of singularities for (2.12): $u=0, w=0$ and the case when the denom inator in the rhs of equation (2.12a) happens to be 0 for som e value of
. $W$ e rst exam ine the singularity $u=0$. Let the initial condition $w i$ be free and introduce the sm all param eter $: \mathrm{u}=$. At the lowest order in $w e n d, w=1=+::$, $u_{+1}=1=+:::, w_{+1}=O()$. Then $u+2 m u s t$ take the inde nite form $0=0$ in order to contain the inform ation on $w \quad 1$ when ! 0. Im plem enting this condition, we nd that $q$ m ust indeed satisfy

for som e constant and $z \mathrm{~m}$ ust be linear in . (T he tw o other singularities are autom atically con ned for all functions $q$ and $z$.) T hus the singularity con nem ent criterion gives for $q$ and $z$ precisely the constraints expected from the construction of (2.12) from $\mathrm{P}_{35}$ •
3. A mapping related to the continuous $G$ ambier equation

T he second discrete system we are going to derive is the contiguity relation of the solutions of the $G$ am bier equation. T he continuous $G$ am bier system can be w ritten as a cascade of tw o R iccati equations:

$w$ here $a, c$ and are free functions of the independent variable $z$ and $n$ is an integer. By a change of variable, the function can be scaled to 0 or 1 but, for the purpose of constructing Schlesinger transform ations, it is m ore convenient to keep it as a free function. M oreover, if we require that equation (3.1) possess the P ainleve property, the functions will be subject to one $m$ ore constraint. $T$ his constraint depends on the value of the integer param eter $n$.

Let us w rite $x_{n}, a_{n}$ and $n$, the quantities appearing in (3.1) corresponding to the coupling param eter $n$ in (3.1b). Then, we can introduce the follow ing Schlesinger transform ation $[12,17]$. It relates the solutions of (3.1) to that of an equation of the sam e form but w ith a coupling param eter $\mathrm{A}=\mathrm{n}+2$. T his transform ation is given by:

W e can obtain a second-order m apping for $x$ elim inating $y$ betw een equations (3 2a) and (3.3a) .

$T$ here is another way to present equation (3.4) if wew rite it as a system, involving explicitly $y$ and using the fact that it does not depend on $n$. The two equations (3.2b) and (32c) are equivalent to the upshifts (by 2 units of $n$ ) of (3.3b) and (3.3c). Equation (3.2b) is the com patibility condition between (3.2a) and the upshiff of (3.3a).

W e obtain thus

The evolution of and $a$ is obtained through equations (3.2b)-(3.2c). System (3.5) is just a particular case of the $G$ am bier $m$ apping introduced in [18]. It is rem arkable that the contiguity relation of the solutions of the $G$ am bier equations $w$ ith respect to the one integer param eter, nam ely $n$, is again a (discrete) $G$ am bier equation. H ow ever the latter does not have the full freedom of the $G$ am bier $m$ apping (in perfect parallel to the relation betw een continous $P$ ainleve equations and $d P$ 's.)

## 4. A mapping related to the discrete $G$ ambier equation

In this section we shall concentrate on the generic discrete version of the G am bier equation. A swas shown in [12] it can be w ritten as a system of two discrete $R$ iccati's in cascade:

(O ther choices for the $G$ am bier $m$ apping do exist but equation (4.1) is the $m$ ost convenient for the derivation of the Schlesinger transform ation.) The m apping was analysed in [17] using the singularity con nem ent $m$ ethod. The only singularity that plays a role is that induced by a special value of $y$, which, given the form of (4.1), is $y=0$. The way for this singularity to be con ned is to require that the value of $x$ go through an indeterm inate value $0=0$ after a certain num ber of steps, say $N$. This $m$ eans in particular that $x ~ m ~ u s t ~ b e ~ z e r o, ~$ while $s$ appearing in (4.1b) m ust be equal to the quantity $\mathrm{N}_{\mathrm{N}}$ (introduced in [12]) which is the N th iterate of $\mathrm{y}=0$ under (4.1a), N tim es downshifted i.e. $0 ; \mathrm{n}=0,1 ; \mathrm{n}=\mathrm{C}_{\mathrm{n}}$, , $2_{2 ; n}=\frac{c_{n} 2+c_{n} 1}{c_{n} 2+1}$, etc. A s was show $n$ in [12], at the continuous lim it, the number $N$ of steps, necessary for con nem ent, goes over to the param eter $n$ appearing in the continuous G am bier equation (3.1).
$T$ he discrete version of the Schlesinger transform ation (3.2) is a transform ation which relates the solution of a $m$ apping con ning in $N$ steps to that of a $m$ apping con ning in $N+2$ steps.

T he com plete analysis for the derivation of the discrete Schlesinger can be found in [12]. H ere we shall just state the result:
where x is the solution requiring $\mathrm{N}+2$ steps for con nem ent and x stands for the solution necessitating just $N$ steps. T he quantity is given by
$W$ ith this proper choige of $w e$ nd that $x$ satis es an equation:

$W$ e can now obtain the contiguity relation of the solutions of the $G$ am bier maping by elim inating y betw een (4 2) and (4.5).

On the other hand, just as in the case of the continuous $G$ am bier system there exists a sim pler w ay to w rite this m apping. T he value ofy appearing in (42) or (4.5) is independent of $N$. Thus a far sim pler way to present the $m$ apping is for instance as

A gain we rem ark that (4.7) is a m apping of am bier type although of a very particular one.

## 5. Conclusion

In this paper we have studied the contiguly relations of the solutions oftw o equations in the Painleve-G am bier classi cation which contain som e param eter. This kind of investigation was previously lim ited to the six transcendental equations of $P$ ainleve. The $m$ ain result of those studies was to show that the discrete Painleve equations are just the contiguity relations of the continuous $P$ ainleve equations. Here we have extended this approach to equations which, while not being one of the six P ainleve equations are integrable and, in fact, belong to the sam e classi cation. In the case of the G am bier equation we have used the Schlesinger transform ation which is associated to the integer param eter $n$ appearing in the equation. O ur result in the case of the continuous $G$ am bier equation is that the contiguity relation of the solutions satis es a $m$ apping which assum es the form of a discrete analogue of the G am bier system, in a nice analogy to the situation for the continuous and discrete $P$ ainleve equations. In parallel to our approach for $d P$ 's the discrete $G$ am bier system has also been analysed. W e have show $n$ that using the Schlesinger transform ation that also exist in this case one can derive the contigulty relation of the solutions which tums out to be in the form of (a specialcase of) a G am bierm apping. W e expect our approach to be applicable to other equations of the $P$ ainleve-G am bier classi cation which contain param eters and for which M iura/Schlesinger transform ations exist. N ow that the question of classi cation of discrete $P$ ainleve equations is in the process ofbeing settled [19,20] it is interesting to analyse the rem aining equations in the classi cation and work out their im plications in the discrete case.
