# PERTURBATION THEORY FOR LYAPUNOV EXPONENTSOFATORALMAP: EXTENSION OFARESULT OF SHUBANDW IKKINSON. by D avid Ruelle*. 

A bstract. Starting from a hyperbolic toral autom onphism, we obtain, for a sm allvolum e preserving perturbation, an exact and rigorous second order perturbation expansion of the Lyapunov exponents.

K eyw ords: Lyapunov exponent, toral autom orphism , hyperbolicity.

[^0]W e consider volum e preserving perturbations F of a di eom orphism $\mathrm{F}_{0}=(; \mathrm{J})$ of $T^{m+1}=T^{m} \quad T$, where is a hyperbolic autom onphism of $T^{m}$, and $J$ is a translation of $T$. $W$ riting $\mathrm{F}=\mathrm{F}_{0}+\mathrm{aF}^{0}$, we shall show that the Lyapunov exponents for ( F ; volum e) can be expanded to second order in a (T heorem 1). In particular, the central Lyapunov exponent
${ }^{c}$ of ( $F$; volum e), to second order in a, is generally 0 (C orolary 11). For a special fam ily of perturbations one obtains particularly sim ple form ulae, rst noted by Shub and W ilkinson [10]. W e recover their result in $T$ heorem 12. W e deviate from [10] m ostly in that we don't have di erentiability of ${ }^{c}$, only a second order expansion around $a=0$. $T$ he ideas used here are largely those in Shub and $W$ ilkinson [10], and can be appreciated in the background provided by H irsh, P ugh and Shub [6], Bums and W ilkinson [3], R uelle and $W$ ilkinson [9]. For recent work related to Lyapunov exponents, see also Bonatti, G om ez-M ont and V iana [2], A vila and B ochi [1].

A fter completing the writing of this paper, the author received a preprint by $D$. D olgopyat [4], which develops sim ilar ideas in a m ore general setting, but without the speci c form ulas we obtain here.

## 1. Theorem .

Let be a hyperbolic autom onphism of $\mathrm{T}^{\mathrm{m}}$, and $\mathrm{J}: \mathrm{y} \mathrm{T} y+(\mathrm{mod} 1)$ a translation of $T$. De ne $F_{0}=(; J)$, and let $F=F_{0}+a F^{0}$ be a $C^{2}$ perturbation of $F_{0}$, volume preserving to rst order in a. (We take $F^{0}: T^{m+1} \eta R^{m+1}$ and $F_{0}+a F^{0}()$ has to be understood ( $m$ od 1 ) in each com ponent). Let ${ }_{1}<{ }_{2}<:::$ be the Lyapunov exponents of ( $\mathrm{F}_{0}$; volum e) and $\mathrm{m}_{1} ; \mathrm{m}_{2}$;::: theirm ultiplicities (the exponent $=0$ occurs w th m ultiplicity 1). A lso let $a_{a}^{(1)} \quad a_{a}^{(2)} \quad::$ :be the Lyapunov exponents of ( $F$; volum e) repeated according to m ultiplicity. T hen we have the second order expansion

(this applies in particular to ${ }^{c}=a_{a}^{(\prime)}$ for $0_{0}^{(")}=0$ ).
An explicit expression for $L_{r}$ can be obtained (see P roposition 9). W e do not assum e ergodicity of ( $\mathrm{F} ;$ volum $e$ ), and therefore we use integrated Lyapunov exponents (averaged over the volum e), see how ever Rem ark 15 (a).

If one likes one $m$ ay to $F_{0}+a F^{0}$ add tem s of higher order in a so that the sum $F$ is exactly volum e preserving. T hese higher order term $s$ will not change our results, and are om itted in what follow $s$.
2. N orm al hyperbolicity.

A $s$ in [10], we invoque the theory of norm al hyperbolicity of [6]. $W$ e start from the fact that $F_{0}$ is nom ally hyperbolic to the sm ooth bration of $T^{m+1}$ by circles fxg $T$.

Taking som ek 2 we apply [6] Theorem s (7.1), (7.2). Thus we obtain a $\mathrm{C}^{1}$ neighborhood U of $\mathrm{F}_{0}$ in the $\mathrm{C}^{\mathrm{k}}$ di eom onphism sof $\mathrm{T}^{\mathrm{m}+1}$ such that, for F 2 U , there is an equivariant bration $: T^{m+1}!T^{m}$ with

The bers ${ }^{1}$ fxg are $C^{k}$ circles form ing a continuous bration of $T^{m+1}$ (this bration is in general not $s m$ ooth). Furtherm ore there is a TF -invariant continuous splitting of T T ${ }^{m+1}$ into three subbundles:

such that $\mathrm{E}^{\mathrm{C}}$ is 1 -dim ensional tangent to the circles ${ }^{1} \mathrm{fxg}, \mathrm{E}^{\mathrm{s}}$ is $\mathrm{m}^{\mathrm{s}}$-dim ensional contracting and $E{ }^{u}$ is $\mathrm{m}^{\mathrm{u}}$-dim ensional expanding for TF.

If ${ }_{r}<0$ (and $F$ is in a suitable $C^{1}-s m$ all neighborhood $U$ of $F_{0}$ ), we can introduce a continuous vector subbundle $\mathrm{E}^{\mathrm{r}}$ of TT ${ }^{\mathrm{m}+1}$ which consists of vectors contracting under $T F^{n}$ faster than $\left({ }_{r}+\right)^{n}$ where $>0$ and $r_{r}+r_{r+1}$. In fact $E^{r}$ is a hyperbolic (attracting) xed point for the action induced by TF ${ }^{1}$ on the bundle of $m_{1}+:::+m_{r}$ dim ensional linear subspaces of $T T^{m+1}$ (over $\mathrm{F}^{1}$ acting on $\mathrm{T}^{\mathrm{m}+1}$ ).

If ${ }_{r}>0$, replacem ent of $F$ by $F^{1}$ sim ilarly yields a continuous subbundle $E^{r}$ of $m_{r}+::: d i m$ ensional subspaces.
3. Proposition .

A ssum e that $F$ is of class $C^{k}, k \quad 2$, and that $F$ is $C^{k}$ close to $F_{0}$. The bundles $E^{r}$, $\mathrm{E}^{\mathrm{r}}$, when restricted to a circle ${ }^{1}$ fxg are of class $\mathrm{C}^{k}{ }^{1}$, continuously in x .

IfG denotes the ( $G$ rassm annian) $m$ anifold ofm ${ }_{1}+:::+m_{r}$ dim ensionallinear subspaces of $R^{m+1}$, we $m$ ay identify the bundle of $m_{1}+:::+m_{r}$ dinensional linear subspaces of $T T^{m+1}$ with $T^{m+1}$ G. W e denote by E 2 G the spectral subspace of the $m$ atrix de ning corresponding to the sm allest $m_{1}+:::+m_{r}$ eigenvalues (in absolute value, and repeated according to $\mathrm{multiplicity)}$.

If $F_{0}$ is the action de ned by $\mathrm{TF}_{0}$ on $\mathrm{TT}^{\mathrm{m}+1} \quad \mathrm{G}$, the circles fxg $\mathrm{T} \quad \mathrm{fEg}$ form an $\mathrm{F}_{0}$ invariant bration of $\mathrm{T}^{\mathrm{m}+1}$ fEg, to which $\mathrm{F}_{0}$ is norm ally hyperbolic. If F is $\mathrm{C}^{\mathrm{k}}$ close to $F_{0}$, the corresponding $C^{k}{ }^{1}$ action $F$ is nom ally hyberbolic to a pertubed bration where fxg $T$ fEg is replaced by $E^{r} j^{1}$ fxg. A ccording to [6] Theorem 7.4, C orollary (8.3) and the follow ing Rem ark 2, we nd that the C ${ }^{k}{ }^{1}$ circle $E^{r}{ }^{\mathrm{j}}{ }^{1}$ fxg $\mathrm{T}^{\mathrm{m}+1} \quad \mathrm{G}$ depends continuously on $\times 2 \mathrm{~T}^{\mathrm{m}+1}$. Sim ilarly for E. $\square$
$N$ ote that in [10], the $C^{r}$ section theorem is used in a sim ilar situation, giving estim ates uniform in x . H ow ever, continuity in x (not just uniform ity) w illbe essential for us in what follow s.

They rem ark that their result extends to the situation where is a hyperbolic autom orphism of $T{ }^{m}$ w ith onedim ensional expanding eigenspace. M ore generally, if is any hyperbolic autom onphism of $\mathrm{T}^{\mathrm{m}}$, T heorem 12 gives close to (; rotation of T ) in $\mathrm{C}^{2}\left(\mathrm{~T}^{\mathrm{m}+1}\right)$ a di eom onphism F w ith
${ }^{c}>0$. Since ${ }^{c}$ is given by an integral over the volum e of a local \central" stretching exponent, we have ${ }^{c}>0$ in a $C^{1}$ neighborhood of $F$. But by a result of $D$ olgopyat and W ilkinson 5] (C orollary 0.5), stable ergodicity is here $C^{1}$ open and dense in the $C^{2}$ volum e preserving di eom orphism s: we have center bunching and stable dynam ical coherence because we consider perturbations of ( ; rotation of $T$ ) for which the center foliation is $C^{1}$, see [6], [7]. In conclusion, close to (hyperbolic autom onphism of $\mathrm{T}^{\mathrm{m}}$ ) (rotation on T) there is a $C^{1}$ open set $V$ of ergodic volum e preserving $C^{2}$ di eom onphism $s$ of $T^{m+1} w$ th
central Lyapunov exponent ${ }^{c}>0$ (or also with ${ }^{c}<0$ ). In particular, if F 2 V , the conditionalm easures of the volum e on the circles ${ }^{1}$ fxg are atom ic, as discussed in [9].
