# New contiguity relation of the sixth Painleve equation from a truncation

### A bstract

For the master Painleve equation P6(u), we do not a consistent method, adapted from the Weiss truncation for partial dierential equations, which allows us to obtain the rst degree birational transformation of 0 kam oto. Two new features are implemented to achieve this result. The rst one is the hom ography between the derivative of the solution u and a Riccati pseudopotential. The second one is an improvement of a conjecture by Fokas and Ablow itz on the structure of this birational transformation. We then build the contiguity relation of P6, which yields one new second order nonautonomous discrete equation.

K eywords: Painleve equations, birational transform ation, contiguity relation, Schlesinger transform ation, singular manifold method, truncation.

#### 1 Introduction

Second order rst degree algebraic ordinary di erential equations (ODEs) de ne six and only six functions [1], which satisfy neither a rst order ODE nor a linear ODE. Since the sixth of these Painleve equations Pn can generate the ve others by a con uence process [2], we will mainly concentrate on it

It depends on four arbitrary complex constants ;;;.

The purpose of this article is twofold: (i) we rst present a new, direct method, only based on the singularity structure of this ODE, in order to derive a rst degree birational transform ation for P 6; (ii) we then establish for P 6 the contiguity relation, interpreted as a discrete P ain leve equation.

A birational transform ation is de ned by

with r and R rational functions, and it maps an equation

with some homography (usually the identity) between x and X . The parameters (; A) must obey as many algebraic relations as elements in . The degree of a birational transform ation is by de nition the highest degree in U  $^{0}$  or u $^{0}$  of the num erator and the denom inator of (1).

There are at least three uses of a birational transform ation. The rst one is an equivalence relation: two solutions exchanged by the transform ation are considered as identical. The second use is to generate from a known solution a countable number of new solutions which may be of physical interest [3]. The third point of view, which we develop here, is the construction of a contiguity relation in order to de ne a nonautonom ous discrete Painleve equation.

The interest of being able to handle P6 is to avoid the tedious consideration of the other daughter Painleve equations.

Indeed, all the similar results for these equations can be easily obtained by action of the con uence, among them all the rst degree birational transform ations of all Pn equations [5].

There currently exist two birational transform ations of P 6. Gamier [6, 7] was the rst to nd a birational transform ation of P6, to establish a theorem of Schwarz on the problem of Plateau. This transform ation, which has second degree, was later rediscovered by several authors [8, 9, 10]. There also exists a rst degree birational transform ation, found by 0 kam oto [9] while studying the Weyl group which preserves the Hamiltonian of P6, and rediscovered recently [11] in a dierent context. This transform ation reads

The transform ation is clearly birational since the lhs. is hom ographic in both u and U. In the above, the m onodrom y exponents = (1; 0; 1; x) are de ned as

and sim ilarly for their uppercase counterparts, while the odd-parity constant N takes the equivalent expressions

The transform ation of Gamier is an integer power [12] of this rst degree transform ation.

To achieve our goal (rely only on the singularity structure to nd a birational transform ation), we need to improve the singular manifold method so that it succeeds to obtain a birational transform ation for P6. Originally introduced for partial di erential equations (PDEs) by Weiss, Tabor and Camevale [13], the singular manifold method is a powerful tool for deriving Backlund transform ations, by considering only the singularity structure of the solutions. Its current achievem ents are detailed in sum mer school proceedings, see Refs. [14, 15]. An extension to ODEs has been proposed [16, 17, 18] to derive a birational transform ation for the Pain leve equations, but its application to the master equation P 6 is still an open problem. We solve it here by implementing an essential piece of information, which has up to now been overlooked.

The paper is organized as follows. In Section 2, we exploit the information that there always exists a hom ography between the derivative of the solution of the considered Painleve equation Pn and the Riccati pseudopotential Zintroduced in the \truncation" assum ption. This reduces the problem to nding two functions of two variables instead of two functions of three variables.

In Section 3, we implement this homography in the denition of a truncation, which allow sus to overcom e the major di culty, coming, in the case of P6, from a residual coe cient which remains undeterm ined (technically coming from the value 1 of the Fuchs index). This diculty is the main reason why P6 has never been handled before by methods based on the singularity structure. We also in prove a previous conjecture [19] on the necessary form of the birational transform ation. The truncation then becomes easy to solve and admits, up to the four homographies on (U;x) which conserve x, a unique solution, which is the transform ation T 6 of 0 kam oto.

In Section 4, we give the various representations of this transform ation.

In Section 5, we solve the recurrence relation between the monodromy exponents of P6, and we build the contiguity relation, which de nes a unique nonautonom ous second order di erence equation.

Finally, in Section 6, we propose a weaker de nition of a Schlesinger transform ation so as to identify this notion with that of birational transform ation.

## 2 The fundam entalhom ography

From the result of Richard Fuchs [20], the P6 equation is obtained from the complete integrability of a linear dierential system of order two. Therefore the pseudopotential of the singular manifold method has only one component Z [21], which can be chosen so as to satisfy some RiccatiODE.

Each Pn equation which adm its a birational transform ation has one or several (four for P6) couples of families of movable simple poles with opposite residues  $u_0$ , therefore both the one-family truncation and the two-family truncation [22, 14, 15] are applicable. In the present paper, we consider only the one-family truncation, whose assumption is

in which u and U satisfy (2) and (3), ( $Z;z_1;z_2$ ) are rational functions of ( $x;U;U^0$ ) to be determined. A fler this is done, the relation (12) represents half of the birational transform ation.

B esides the equation (13), there exists a second R iccati equation in the present problem, this is the Painleve equation (3) itself. Indeed, any N -th order, rst degree ODE with the Painleve property is necessarily [23, pp. 396 [409] a R iccati equation for U  $^{(N-1)}$ , with coe cients depending on x and the lower derivatives of U, in our case

Since the group of invariance of a R iccati equation is the hom ographic group, the variables U $^0$  and Z are linked by a hom ography, the three coe cients  $g_j$  of which are rational in (U;x). Let us de ne it as

This allows us to obtain the two coe cients  $z_j$  of the Riccati pseudopotential equation (13) as explicit expressions of  $(g_j; \theta_u g_j; \theta_x g_j; A_2; A_1; A_0; U^0)$ . Indeed, eliminating  $U^0$  between (14) and (15) de nes a rst order ODE for Z, whose identication with (13) modulo (15) provides three relations.

For the one-family truncation, these are

Therefore, the natural unknowns in the present problem are the two coe cients  $g_1;g_2$  of the homography, which are functions of the two variables (U;x), and not the two functions  $(z_1;z_2)$  of the three variables  $(U^0;U;x)$ .

Remark. One must also consider the case when the relation between Z  $^{1}$  and U  $^{0}$  is a ne, excluded in (15). Assuming

which for P 6 adm its no solution  $G_1$  rational in U .

## 3 The truncation

Just like the eld u is represented, see Eq. (12), by a Laurent series in Z which term inates (\truncated series"), the lhs. E (u) of the Pn equation (supposed written as a polynomial, i.e. without denominators involving u) can also be written as a truncated series in Z. This is achieved by the elimination of  $u;Z^0;U^0;U^0$  between (2), (3), (12), (13) and (15), followed by the elimination of  $(g_0;z_1;z_2)$  from (16){ (18) (q denotes the singularity order of Pn written as a dierential polynomial in u, it is 6 for P6),

The nonlinear determ ining equations  $E_j = 0$  are independent of  $U^0$ , and this is the main difference with previous work. In particular, in all cases successfully processed to date [17, 18], both  $g_1$  and  $2A_2 = 0$ . Log  $g_0$  vanish, which cancels the coefcient of  $U^0$  in  $z_1$  and  $z_2$ . In the case of P6, we are going to see that the truncation possesses a solution if and only if  $(z_1; z_2)$  depends on  $U^0$ .

A nother di erence is the greater number ( q+3 instead of q+1) of equations E  $_j=0$ , which is due to the additional elim ination of U  $^0$  w ith (15).

The q+3 determ ining equations (22) in the three unknown functions  $u_0(x)$ ,  $g_1(U;x)$ ,  $g_2(U;x)$  (and the unknown scalars ; ; in terms of A;B;;) must be solved, as usual, by increasing values of their index j.

This truncation for P 6 possesses a very nice invariance, which drastically helps the practical resolution. For any solution  $g_j$  (U;x), there exist three other solutions, generated by the action on  $g_j$  (U;x) of the four hom ographies of U which conserve x and P 6, namely the identity and

Let us now state a conjecture which will strongly restrict the coe-cient  $g_2$ . From the expression of the direct half of the birational transform ation,

the values of U which correspond to u=1 are de ned (apart from the poles of  $g_1$  and  $g_0$ ) by the ODE

The point u = 1 has the peculiarity to be a singular point of all the Pn equations and, for all known birational transform ations of Pn (see the book [24] for P2 to P5, Ref. [7, formula (2.8)] and

Ref. [9, p. 356] for P6), it happens that the ODE analogous to (28) is a RiccatiODE (or a product of RiccatiODEs in [7, 10]), i.e. the unique rst order rst degree ODE which has the Painleve property. In at least one other exam ple of higher order [25], the birational transform ation between two dierent ODEs having the Painleve property has a denominator which de ness a P1 equation. Let us conjecture the generality of this property.

C on jecture. Given a birational transform ation between two ODEs having the Painleve property, for any singular point u of the ODE, the ODE for U de ned by the direct half of the birational transform ation has the Painleve property.

This is an improvement of a previous conjecture by Fokas and Ablow itz [19, form ula (2.6)] in two respects: both elds u and U are required to satisfy the same ODE, and no specic U-dependence is assumed for  $g_0$  and  $g_1$ ; their conjecture (whatever be u, Eq. (27) is a Riccati equation for U) happens to be true for P2{P5 but not for P6.

In the case of P 6, our conjecture implies that the four expressions

are second degree polynomials of U with coe cients depending on x. One notices im mediately, from the last three fractions, that there could exist a particular solution  $g_1 = 0$ ;  $g_0 = g(x)U(U-1)(U-x)$ . We are going to see that this is indeed the case.

The practical resolution of the truncation for P 6 is performed in Appendix 8, and the coecients of the fundamental homography are found to be

Let us present this birational transform ation in more detail.

# 4 The elem entary birational transform ation of P6

The eight signs  $(s_1; s_0; s_1; s_x)$  and  $(S_1; S_0; S_1; S_x)$ , with  $s_j^2 = S_j^2 = 1$ , of them one odrom y exponents remain arbitrary and independent.

## 4.1 The a ne representation

In the space of the m onodrom y exponents, the direct birational transform ation and its inverse have an a ne representation

in which M  $_{\rm 1}$  and M  $_{\rm 0}$  are m atrices of rational num bers. These are

and, depending on the signs, one has M  $_{1}^{n}$  = 1, with n = 2;3;4 or 6. The convention adopted for the signs is aim ed at making (6) equal to its inverse when all signs are +1.

#### 4.2 The birational representation

equivalent to the a ne representation (6). Two sets of expressions are appropriate to represent the birational transform ation, depending on its later use.

The rst set involves only the squares of the monodrom y exponents,

is adapted to the construction of the contiguity relation, which is done in Section 5.

Both sets allow one to directly apply the well known degeneracy (Ref. [2] in the space , Ref. [26] in the space ) to generate birational transform ations of the other Pn equations. This is done in a forthcom ing paper [5].

## Contiguity relation

From each birational transform ation, one easily deduces a contiguity relation, which generalizes, as noted by Gamier [7], that of the hypergeom etric equation of Gauss. Its system atic computation is as follows [4].

1. Consider the birational transform ation, i.e. the direct birational transform ation and its inverse

in which is taken at the center point  $z = z_0 + nh$ . This very simple expression is clearly invariant under any permutation of the four singular points of P6.

This contiguity relation (53) can be interpreted as a second order discrete equation [4]. The two-point recurrence relation (6) adm its ve classes of solutions. Each class, characterized by a signature, leads to a di erent contiguity relation (53), i.e. to a di erent second order discrete equation. Four of them are autonomous (signatures  $(s_jS_j) = (+), (++), (+++), (+++)$ ), they cannot adm it a continuum lim it to a Painleve equation. The only nonautonomous one (signature ( )) is

In the continuum  $\lim it$ , among the six  $\sin ple$  poles of v in the sum (including 1), the  $\inf v$  will create a second order derivative and the four others v ill de ne at v ost four singular points. Since none of the last four poles depends on v, it is in possible that the continuum  $\lim iv$  be P6.

The transform of this discrete equation under

has already been obtained [27, Eq. (1.5)] as a reduction of a lattice K dV equation, together with a discrete Lax pair and a continuum limit to the full P5. This is in agreement with the continuum limit of the hypergeometric contiguity relation, which is not the hypergeometric equation but a confuence on uent one. Nevertheless, we do not know of a general proof of this feature.

# 6 On Schlesinger transform ations

Up to this point we have carefully avoided using the expression Schlesinger transform ation, and this is because of som e discrepancy which we would want stly, to point out, secondly, to try to correct.

The relevant item s are

- 1. a birational transform ation of some nonlinear ODE, whose de nition presents no ambiguity,
- 2. the monodrom y data, also unambiguously de ned by the isomonodrom ic deformation of some linear ODE,
- 3. a Schlesinger transform ation, whose present de nition, recalled below, is in our opinion unsatisfactory.

A Schlesinger transform ation (ST) was originally de ned [28] as a discrete transform ation preserving the monodrom y of a given linear ODE, and Schlesinger explicitly prescribed [29, p. 136] [28, p. 134] that monodrom y exponents should be shifted by integer values, which is a succient condition to preserve the monodrom y data. All subsequent authors, in particular Gamier [7] and Jim bo and Miwa [30] (who created the expression Schlesinger transform ation) complied with this prescription because all had in mind the isomonodrom is deform ations.

The discrepancy is the following. It would be nice to have a one-to-one correspondence, hence an equivalence, between the notion of birational transform ation and that of Schlesinger transform ation. With the present de nition, this is not the case for the birational transform ation (42), whose associated a ne transform ation (6) { (7) does not obey the prescription of Schlesinger of shifts by integers and therefore does not preserve the monodromy data. A rst step in this direction was recently made in Refs. [31, 32, 33], who relaxed the prescription to shifts by half-integers, so as to globally change the monodromy matrix to its opposite rather than to conserve it.

W hat happens here is one step beyond: the monodrom y matrix is changed to its opposite, but the shifts by half-integers occur not in the space of monodrom y exponents, but in the space adapted to the a ne Weyl group D 4 of P6. Indeed, in the basis of 0 kam oto (58),

the a ne representation (6) becomes (when all signs are chosen equal to + 1 to sim plify)

In the monodrom y matrix, the set of four trigonometric lines in Eq. (3.19) of Ref. [10] just undergoes a global sign change.

To conclude this discussion, in order to identify Schlesinger transform ation and birational transform ation, at least for P6 (we leave the full generality to mathematicians), we propose that a Schlesinger transformation be dened as any discrete transformation which either conserves or changes to its opposite the monodromy matrix, without any additional prescription on the monodromy exponents.

As a consequence of this weaker de nition, the matrices M  $_1$  and M  $_0$  in (35) will have half-integer elements. Another consequence of practical importance is the identication, at least for the Pn equations, of the two notions Schlesinger transform ation, birational transform ation, since they will now have a one-to-one correspondence.

## 7 Conclusion

The fundamental homography between the derivative of the solution of the Painleve equation and the Riccati pseudopotential has allowed us to de neal consistent truncation. The result thus obtained for P6 is a rst degree birational transformation, and its contiguity relation de nesa single nonautonomous secondorder dierence equation. Its degeneracies under the confuence of the Pn equations could provide new secondorder discrete equations.

As an application, one can iterate this birational transform ation, starting from the two-parameter solution which Picard established for  $_{j}^{(0)} = 0; j = 1; 0; 1; x;$  to carry it to any such that 2  $_{j}$  and  $_{p}^{(0)}$  be arbitrary integers. Any iterate will be some a lighteratic transform of the solution of Picard.

Two important open problems remain in the domain of truncations, namely to de ne truncations able to provide, rstly a Lax pair of P6, secondly a Lax pair for the discrete equations built from the Schlesinger transformation.

A ll fam ilies of movable singularities are equivalent under homographies. The data for this unique representative family are

Equation j=0 only depends on  $u_0$  and its solution is (60). Equation j=1 is identically satisfied, as a consequence of the value 1 of the Fuchs index. There remain seven equations (22) j=2;:::;8, in the two unknowns  $g_k(U;x);k=1;2$ . The next two ones are
