# On Relations of Hyperelliptic Weierstrass al Functions

#### Abstract

We study relations of the Weierstrass's hyperelliptic al-functions over a non-degenerated hyperelliptic curve $y^{2}=f(x)$ of arbitrary genus $g$ as solutions of sine-Gordon equation using Weierstrass's local parameters, which are characterized by two ramified points. Though the hyperelliptic solutions of the sine-Gordon equation had already obtained, our derivations of them is simple; they need only residual computations over the curve and primitive matrix computations.

## §1. Introduction

The sine-Gordon equation is a famous nonlinear integrable differential equations. For a hyperelliptic curve $C_{g}\left(y^{2}=f(x)=\left(x-b_{1}\right) \cdots\left(x-b_{2 g+1}\right)\right)$ of genus $g$, the hyperelliptic solutions of the sine-Gordon equation were formulated in [ Mu 3.241 ] in terms of Riemann theta functions. In $[\mathrm{Mu}],(U, V, W)$ representation of symmetric product space of the $g$ curves $S y m m^{g} C_{g}$ is defined; especially, $U$ is defined by $U(z):=\left(x_{1}-z\right) \cdots\left(x_{g}-z\right)$ a for a point $\left(\left(x_{1}, y_{1}\right), \cdots,\left(x_{g}, y_{g}\right)\right)$ in $S_{y m m}{ }^{g} C_{g}$. (In this article, we will denote $U$ by $F(z)$ on later following the conventions in [Ba1, 2, 3, Ma].) Using the relation between $U$ and the Riemann theta functions in [ Mu 3.113], the solutions [ Mu 3.241 ] can be rewritten as,

where P and Q are ramified points of $C_{g}, A$ is a constant number, $[D]$ is a meromorphic function over $\operatorname{Sym}^{g}\left(C_{g}\right)$ with a divisor $D$ for each $C_{g}$ and $t_{\mathrm{P}^{\prime}}$ is a coordinate in the Jacobi
variety such that it is identified with a local parameter at a branch point $\mathrm{P}^{\prime}$ up to constant. In other words, for a finite branch point $\left(b_{i}, 0\right) U\left(b_{i}\right)$ is identified with $\left[2\left(b_{i}, 0\right)-2 \infty\right]$ up to constant factor.

In the formulations in $[\mathrm{Mu}]$, local parameters $t_{\mathrm{P}^{\prime}}$ were not concretely treated. In this article, we will give more explicit representations of (1-3) using concrete local parameters in $[\mathrm{Ba} 2, \mathrm{~W} 2,3]$ and present simpler derivations of (1-3) without using any $\theta$-function. This article is an application of a scheme developed in [Ma] to the sine-Gordon equation, which is based upon [Ba3].

In [W1, W2], Weierstrass defined al function by al ${ }_{r}=\gamma_{r} \sqrt{U\left(b_{r}\right)}$ using a constant factor $\gamma_{r}$. In Theorem 3.1, we will give

in terms of a coordinate system $u^{(r)}$ 's defined in (2-5). $\mathrm{al}_{r}(u)$ has the single order zero at $\left(b_{r}, 0\right)$ and a singularity of the single order at $\infty$ as a function of $x_{i} \in C_{g}$.

Further we give another representation in Theorem 4.1 in terms of $v$ 's defined in (2-6) $\left(a_{1}:=b_{r}, a_{2}:=b_{s}\right)[\mathrm{W} 2,3]$,

The function $\operatorname{al}_{s}(v) / \mathrm{al}_{r}(v)$ vanishes with order one when $x_{i}$ is at $\left(b_{s}, 0\right)$ whereas it diverges with order one if $x_{i}$ approaches to $\left(b_{r}, 0\right)$. As they were discovered by Weierstrass [W2, 3] and they play the essential roles in the investigation in $[\mathrm{W} 2,3]$ and in $\S 4$. Thus we have called them Weierstrass parameters.

In these proofs, we will use only residual computations using the data of curve itself without any $\theta$ functions as the derivation of hypereilliptic solutions of the modified Korteweg-de Vries equations in [Ma]. The curve is sometimes given by an affine equation with special coefficients. Then it might be important to study the relation between the properties of line-bundle over the curve and these coefficients. As (1-4) and (1-5) can be explicitly expressed by data of curve $C_{g}$, the author believes that they have some advantage as relations of special functions.

## §2. Differentials of a Hyperelliptic Curve

In this section, we will give the conventions and notations of the hyperelliptic functions in this article. We denote the set of complex numbers by $\mathbb{C}$ and the set of integers by $\mathbb{Z}$.
2.1 Hyperelliptic Curve. We deal with a hyperelliptic curve $C_{g}$ of genus $g(g>0)$ given by the affine equation,

where $\lambda_{2 g+1} \equiv 1$ and $\lambda_{j}$ 's are complex numbers. We use the expressions,

where $b_{j}$ 's $\left(b_{i}=a_{i}, b_{g+i}=c_{i}\right)$ are complex numbers.
It is noted that the permutation group acts on these $\left\{b_{r}\right\}$ and $\left\{a_{r}\right\}$.
2.2 Definition [Ba1, Ba2, W2, 3].
(1) For a point $\left(x_{i}, y_{i}\right) \in C_{g}$, the unnormalized differentials of the first kind are defined by,

(2) Let us define the Abel maps for $g$-th symmetric product of the curve $C_{g}$,

These coordinates are universal covering of the related Jacobian $\mathcal{J}$. The definition (2-6) [Ba2 p.382] is due to Weierstrass [W2, 3] and we call (2-6) Weierstrass parameter, though we choose different constant factor from the original one [W2, 3]. This parameterization is a key of the second solutions mentioned in $\S 4$.

### 2.3 Definition.

(1) Hyperelliptic al function is defined by [Ba2 p.340, W2, 3],

where $\gamma_{r}:=\sqrt{-1 / P^{\prime}\left(b_{r}\right)}$ and

On the choice of $\gamma_{r}$, we will employ the convention of Baker [Ba2] instead of original one [W2, 3]. We note that $\mathrm{al}_{r}$ 's have mutually algebraic relations.

For later convenience, a polynomial associated with $F(x)$ is introduced by

Then we have $\chi_{i, g-1}^{(r)} \equiv 1$ and $\chi_{i, 0}^{(r)}=F\left(b_{r}\right) /\left(x_{i}-b_{r}\right)$. Further we introduce $g \times g$-matrices,

where $F^{\prime}(x):=d F(x) / d x$.
2.3 Lemma. For these matrices, following relations hold:
(1) The inverse matrix of $\mathcal{W}^{(r)}$ is given by $\mathcal{W}^{(r)-1}=\mathcal{F}^{(r) \prime^{-1}} \mathcal{V}^{(r)}$, where $\mathcal{V}^{(r)}$ is Vandermond matrix,

Proof. (1) is obtained by direct computations. (2) is a well-known result [T]. Since the zero and singularity in the left hand side give the right hand side as

for a certain constant $C$. In order to determine $C$, we multiply $\prod_{k, l}\left(x_{k}-a_{l}\right)$ both sides and let $x_{1}=a_{1}, x_{2}=a_{2}, \cdots$, and $x_{g}=a_{g}$. Then $C$ is determined as above. (3) is obtained by the Laplace formula using the minor determinant for the inverse matrix.I

Then we have following corollary.
2.5 Corollary. Let $\partial_{u_{i}}^{(r)}:=\partial / \partial u_{i}^{(r)}, \partial_{v_{i}}:=\partial / \partial v_{i}$, and $\partial_{x_{i}}:=\partial / \partial x_{i}$.

## §3. Relations between Hyperelliptic al Functions ( $b_{r}, \infty$ )-type

In this section, we will give the first relation of hyperelliptic al function using the parameters $u_{1}^{(r)}$ and $u_{g}^{(r)}$ in (2-5).

### 3.1 Theorem.

Here we will give a comment on Theorem 3.1. Let us fix the parameters $x_{2}, \cdots, x_{g}$ and regard $\mathrm{al}_{r}$ as a function of a parameter related to $x_{1}$ over $C_{g}$. Then its divisor is $\left(\mathrm{al}_{r}\right)=\left(b_{r}, 0\right)-\infty$. Further by letting $t^{2}=\left(x_{i}-b_{r}\right)$ around $\left(b_{r}, 0\right)$, the definition (2-3) shows,

while for $s^{2}=1 / x$ around $\infty$,

Hence (3-1) can be regarded as an explicit representation of (1-3).
Proof. Instead of (3-1), we will prove following formula (3-2) in remainder in this section.

The strategy is essentially the same as [Ba3, Ma]. First we translate the words of the Jacobian into those of the curves; we rewrite the differentials $u^{(r)}$ 's in terms of the differentials over curves as in (3-3). We count the residue of an integration and use a combinatorial trick. Then we will obtain (3-2).

From (2-10), we will express $u^{(r)}$ 's by the affine coordinates $x_{i}$ 's,

Here we will note the derivative of $F(x)$, which is shown by direct computations.

The proof of Theorem 3.1 finishes due to the following lemma.

### 3.2 Lemma. Following relations hold:

Proof. : (3-5) will be proved by the following residual computations: Let $\partial C_{g}^{o}$ be the boundary of a polygon representation $C_{g}^{o}$ of $C_{g}$,

\oint_{\partial C_{g}^{o}} \frac{f(x)}{\left(x-b_{r}\right)^{2} F(x)^{2}} d x=0 . \tag{3-7}
\end{equation*}
$$

The divisor of the integrand of (3-7) is given by,

$$
\left(\frac{f(x)}{\left(x-b_{r}\right)^{2} F(x)^{2}} d x\right)=3 \sum_{i=1, b_{i} \neq b_{r}}^{2 g+1}\left(b_{i}, 0\right)-\left(b_{r}, 0\right)-2 \sum_{i=1}^{g}\left(x_{i}, y_{i}\right)-2 \sum_{i=1}^{g}\left(x_{i},-y_{i}\right)-\infty .
$$

We check these poles: First we consider the contribution around $\infty$ point. Noting that the local parameter $t$ at $\infty$ is $x=1 / t^{2}$,

$$
\operatorname{res}_{\infty} \frac{f(x)}{\left(x-b_{r}\right)^{2} F(x)^{2}} d x=-2
$$

Since the local parameter $t$ at $\left(x_{k}, \pm y_{k}\right)$ is $t=x-x_{k}$, we have

$$
\operatorname{res}_{\left(x_{k}, \pm y_{k}\right)} \frac{f(x)}{\left(x-b_{r}\right)^{2} F(x)^{2}} d x=\frac{1}{F^{\prime}\left(x_{k}\right)}\left[\frac{\partial}{\partial x}\left(\frac{f(x)}{\left(x-b_{r}\right)^{2} F^{\prime}(x)}\right)\right]_{x=x_{k}} .
$$

For each branch point $\left(b_{r}, 0\right)$, the local parameter $t$ is $t^{2}=x-b_{r}$ and thus

$$
\operatorname{res}_{\left(b_{r}, 0\right)} \frac{f(x)}{\left(x-b_{r}\right)^{2} F(x)^{2}} d x=2 \frac{f^{\prime}\left(b_{r}\right)}{F\left(b_{r}\right)^{2}} .
$$

By arranging them, we obtain (3-5).
On the other hand, (3-6) can be proved by using a trick: for $i \neq j$,

$$
\frac{1}{\left(b_{r}-x_{k}\right)\left(b_{r}-x_{l}\right)\left(x_{k}-x_{l}\right)}=\frac{1}{\left(x_{k}-x_{l}\right)^{2}}\left(\frac{1}{\left(b_{r}-x_{k}\right)}-\frac{1}{\left(b_{r}-x_{l}\right)}\right) .
$$

## §4. Relations between Hyperelliptic al Functions: $\left(a_{1}, a_{2}\right)$-type

In the previous section, we have a solution with a duality between a finite ramified point and $\infty$-point. In this section, we will give a relation between hyperelliptic al functions using the Weierstrass parameter (2-6). The relation has a duality between finite ramified points $\left(a_{r}, 0\right)$ and $\left(a_{s}, 0\right)$.

### 4.1 Theorem. For $r \neq s$, we obtain

$$
\begin{equation*}
\frac{\partial}{\partial v_{r}} \frac{\partial}{\partial v_{s}} \log \frac{\mathrm{al}_{r}}{\mathrm{al}_{s}}=\frac{1}{2\left(a_{r}-a_{s}\right)}\left(f^{\prime}\left(a_{r}\right) \frac{\gamma_{r}^{2} \mathrm{al}_{s}^{2}}{\gamma_{s}^{2} \mathrm{al}_{r}^{2}}+f^{\prime}\left(a_{s}\right) \frac{\gamma_{s}^{2} \mathrm{al}_{r}^{2}}{\gamma_{r}^{2} \mathrm{al}_{s}^{2}}\right) \tag{4-1}
\end{equation*}
$$

Before we prove it, we will give some comments: Let us fix the parameter $x_{2}, \cdots, x_{g}$ and regard $\mathrm{al}_{r} / \mathrm{al}_{s}\left(\propto \sqrt{F\left(a_{r}\right) / F\left(a_{s}\right)}\right)$ as a function of $x_{1}$ over $C_{g}$. Then its divisor is $\left(\mathrm{al}_{r} / \mathrm{al}_{s}\right)=\left(a_{r}, 0\right)-\left(a_{s}, 0\right)$. By letting $t_{r}^{2}=\left(x_{i}-a_{r}\right)$ around $\left(a_{r}, 0\right)$, infinitesimal value of Weierstrass parameter (2-4) is given,

$$
\left.d v_{r}^{(i)}\right|_{\left(a_{r}, 0\right)}=\frac{1}{\sqrt{f^{\prime}\left(a_{r}\right)}} d t_{r} .
$$

Thus (4-1) is also a concrete expression of (1-3).

Proof. Similar to the proof of Theorem 3.1, let us prove the theorem. Without loss of generality, we will prove the following relation instead of (4-1):

$$
\begin{equation*}
\frac{\partial}{\partial v_{1}} \frac{\partial}{\partial v_{2}} \log \frac{F\left(a_{1}\right)}{F\left(a_{2}\right)}=\frac{F\left(a_{1}\right) F\left(a_{2}\right)}{\left(a_{1}-a_{2}\right)}\left(\frac{f^{\prime}\left(a_{1}\right)}{F\left(a_{1}\right)^{2}}+\frac{f^{\prime}\left(a_{2}\right)}{F\left(a_{2}\right)^{2}}\right) . \tag{4-2}
\end{equation*}
$$

From (2-9) and (2-10), the derivative $v$ 's are expressed by the affine coordinate $x_{i}$ 's,

$$
\frac{\partial}{\partial v_{r}}=F\left(a_{r}\right) \sum_{j=1}^{g} \frac{2 y_{j}}{F^{\prime}\left(x_{j}\right)\left(x_{j}-a_{r}\right)} \frac{\partial}{\partial x_{j}}
$$

The right hand side of (4-2) becomes,

$$
\begin{equation*}
\frac{\partial^{2}}{\partial v_{1} \partial v_{2}} \log \frac{F\left(a_{1}\right)}{F\left(a_{2}\right)}=F\left(a_{1}\right) \sum_{j=1 i=1}^{g} \frac{2 y_{j}}{\left(x_{i}-a_{1}\right) F^{\prime}\left(x_{j}\right)} \frac{\partial}{\partial x_{j}} \frac{2 y_{i} F\left(a_{2}\right)}{F^{\prime}\left(x_{i}\right)\left(x_{i}-a_{2}\right)} \frac{\left(a_{1}-a_{2}\right)}{\left(x_{i}-a_{1}\right)\left(x_{i}-a_{2}\right)} . \tag{4-3}
\end{equation*}
$$

The right hand side of (4-3) is

$$
\begin{gathered}
F\left(a_{1}\right) F\left(a_{2}\right) \sum_{i=1}^{g} \frac{1}{F^{\prime}\left(x_{i}\right)}\left[\frac{\partial}{\partial x}\left(\frac{f(x)\left(a_{2}-a_{1}\right)}{\left(x-a_{1}\right)^{2}\left(x-a_{2}\right)^{2} F^{\prime}(x)}\right)\right]_{x=x_{i}} \\
-F\left(a_{1}\right) F\left(a_{2}\right) \sum_{k, l, k \neq l} \frac{2 y_{k} y_{l}\left(a_{2}-a_{1}\right)}{F^{\prime}\left(x_{k}\right) F^{\prime}\left(x_{l}\right)\left(x_{l}-a_{1}\right)\left(x_{k}-a_{2}\right)\left(x_{k}-a_{1}\right)\left(x_{l}-a_{2}\right)\left(x_{l}-x_{k}\right)} .
\end{gathered}
$$

Then the proof of Theorem 4.1 is completely done due to the following lemma.
4.2 Lemma. Following relations hold:

$$
\begin{gather*}
\sum_{i=1}^{g} \frac{1}{F^{\prime}\left(x_{i}\right)}\left[\frac{\partial}{\partial x}\left(\frac{f(x)}{\left(x-a_{1}\right)^{2}\left(x-a_{2}\right)^{2} F^{\prime}(x)}\right)\right]_{x=x_{i}}=\frac{1}{\left(a_{1}-a_{2}\right)^{2}}\left(\frac{f^{\prime}\left(a_{1}\right)}{F\left(a_{1}\right)^{2}}-\frac{f^{\prime}\left(a_{1}\right)}{F\left(a_{1}\right)^{2}}\right) . \\
\sum_{k, l, k \neq l} \frac{2 y_{k} y_{l}\left(a_{2}-a_{1}\right)}{F^{\prime}\left(x_{k}\right) F^{\prime}\left(x_{l}\right)\left(x_{l}-a_{1}\right)\left(x_{k}-a_{2}\right)\left(x_{k}-a_{1}\right)\left(x_{l}-a_{2}\right)\left(x_{l}-x_{k}\right)}=0 \tag{4-4}
\end{gather*}
$$

Proof. : Similar to Lemma 3-2, we consider an integral,

$$
\begin{equation*}
\oint_{\partial C_{g}^{o}} \frac{f(x)}{\left(x-a_{1}\right)^{2}\left(x-a_{2}\right)^{2} F(x)^{2}} d x=0 . \tag{4-6}
\end{equation*}
$$

As the divisor of the integrand of (4-6) is

$$
\begin{align*}
& \left(\frac{f(x)}{\left(x-a_{1}\right)^{2}\left(x-a_{2}\right)^{2} F(x)^{2}} d x\right) \\
& \quad=3 \sum_{i=1, b_{i} \neq a_{1}, a_{2}}^{2 g+1}\left(b_{i}, 0\right)-\left(a_{1}, 0\right)-\left(a_{2}, 0\right)-2 \sum_{i=1}^{g}\left(x_{i}, y_{i}\right)-2 \sum_{i=1}^{g}\left(x_{i},-y_{i}\right)+3 \infty \tag{4-9}
\end{align*}
$$

we count residual contributions from each terms as in the proof of Lemma 3-2 and obtain (4-4). Considering the symmetry, (4-5) is easily obtained.
