Electrom igration-Induced Propagation of Nonlinear Surface
Waves

Abstract

Due to the e ects of surface electrom igration, waves can propagate over the free surface of a current-carrying m etallic or sem iconducting lm of thickness h_0 . In this paper, waves of nite am-p plitude, and slow modulations of these waves, are studied. Periodic wave trains of nite am-p plitude are found, as well as their dispersion relation. If the lm material is isotropic, a wave train with wavelength is unstable if $=h_0 < 3.9027:::$, and is otherwise marginally stable. The equation of motion for slow modulations of a nite am-p plitude, periodic wave train is shown to be the nonlinear Schrodinger equation. As a result, envelope solitons can travel over the lm's surface.

I. Introduction

W aves propagating over the free surface of a layer of water subject to gravity have been studied extensively for well over a century. In his ground breaking paper of 1847, Stokes showed that steady periodic wave trains of nite amplitude are possible, and that their dispersion relation depends upon their amplitude [1]. In these wave trains, the e ects of dispersion and nonlinearity balance, yielding a steady wave form.

In the 1960's, it was discovered that if the water is of nite depth h_0 and the wavelength = 2 =k is su ciently short, the wave train is unstable. Benjam in and Feir [2] showed that the Stokes wave train is unstable to small modulational or side band perturbations if $kh_0 > 1:363:::$, and this been con rmed experimentally [3, 4, 5, 6].

Benjam in and Feir's analysis holds only at early times, just after the instability has begun to develop. Zakharov [7] and later Hasim oto and Ono [8] derived an equation of motion for the envelope of a packet of nite-amplitude gravity waves which remains valid long after the onset of the instability. Their equation | the nonlinear Schrodinger equation | admits envelope soliton solutions that are intimately related to the ultimate state of the uid surface.

Although it is not yet widely appreciated, there are nontrivial electrical free boundary problems. When an electrical current passes through a piece of solid metalor semiconductor, collisions between the conduction electrons and the atoms at the surface lead to drift of these atoms. This phenomenon, which is known as surface electromigration (SEM), can cause the surface of a solid to move and deform [9, 10, 11, 12, 13, 14, 15, 16, 17, 18, 19, 20, 21]. The free surface of a conducting lim moves in response to the electrical current owing through the bulk of the lim, in much the same way that ow in the bulk of a uid a exts the motion of its surface. However, the analogy is not perfect | the boundary conditions are very different in the two problems. In addition, metals and semiconductors are anisotropic materials, and this distinguishes them from uids as well.

Waves can propagate over the free surface of a current-carrying Imadeposited on an insulating substrate, at least in the limit of smallam plitude. These waves, whose propagation is induced by surface electrom igration, are somewhat analogous to gravity waves, and will be called \SEM waves." The linear dispersion relation for these waves has been known for some time [15], and will be discussed brie y in Sec. III.

It is natural to ask to what extent the nonlinear behavior of gravity waves is paralleled by

that of SEM waves. To address this question, in this paper I will study SEM waves of nite am plitude, and slow modulations of these waves. Periodic wave trains of nite am plitude (the analog of the Stokes wave) are found, as well as their dispersion relation. If the lm material is isotropic, the wave trains are unstable for $kh_0 > 1:609927:::$ and are otherwise marginally stable. It is worth mentioning that SEM is not just of academic interest: In modern integrated circuits, the current-carrying metallines or \interconnects" carry very high current densities, and electrical failure can occur due to the electric of SEM. In particular, SEM can cause a small perturbation at the edge of a metal strip to become a slit-shaped void which propagates across the line until its tip contacts the opposite side of the strip; electrical failure is then complete [20, 21, 22, 23].

II. Equations of M otion

Consider a single-crystalm etallic or sem iconducting lm of uniform thickness h_0 deposited on the plane surface of an insulating substrate. We take the z axis to be normal to the lm-vacuum interface and locate the origin 0 in this plane. (We will occasionally and it convenient to use another set of Cartesian coordinates $(x^0; z^0)$ with $x^0 = x$, $z^0 = z + h_0$ and origin 0^0 at the substrate surface.) The lm's surface z = 0 will be assumed to be a low index crystal plane. A constant electrical current ows through the lm in the x direction, and the electric lm within the lm is lm0 = lm2.

Now suppose that the upper surface of the lm is perturbed. Let the outward-pointing unit normal to this surface be \hat{n} . 


FIG. 1: The current-carrying metalthin lm. The height of the free surface above the substrate, lm, depends only on lm and lm. The outward-pointing unit normal to the free surface is lm, and the electric lm are from the perturbation is lm0.

The goal of this paper is to go beyond the linear approximation and study wave trains of nite amplitude. To begin, we will not the analog of the Stokes wave propagating over deep water: we will consider the limit h_0 ! 1 and restrict our attention to periodic wave trains with constant amplitude a. These simplifying assumptions will be relaxed in the next section.

is a decreasing function of a when a is small. In contrast, the phase velocity of small amplitude gravity waves on deep water increases with amplitude. For a given amplitude 2a, the phase velocity is smallest for = 3=4, or, equivalently, for c = 1=8.

To third order in a, the wave is symmetric about the crests, even though the applied electric eld breaks the right-left symmetry.

IV . Slow M odulation of Finite Amplitude Periodic W ave Trains

To nd a steady, periodic wave train (the analog of the Stokes wave), we would take the amplitudes $_{nj}$ to be constants and the $_{nj}$'s to depend on z alone. We will go further, and allow the $_{nj}$'s to vary slow by in space and time as viewed from the frame of reference moving with the group velocity. As a result, we will be able to nd the steady, periodic wave train and investigate its stability as well. (Our analysis closely parallels D avey and Stewartson's treatment of modulated gravity waves [24].) To be explicit, we set

Eq. (45) describes a periodic wave train of nite amplitude propagating over a metal or sem iconducting layer of nite thickness. Eq. (46) is the nonlinear dispersion relation.

Eqs. (51) – (53) give a good approxim ate solution to the original equations of motion in the lim it that $a=h_0$ and h_0k tend to zero with $a=h_0^3k^2$ remaining nite as the lim it is taken. If the amplitude of the choidal wave is small enough that ka $(kh_0)^3$ 1, Eqs. (51) and (52) reduce to Eqs. (48) and (49). Thus, in the thin lm lim it, the nonlinear wave (45) is a choidal wave of small amplitude.

The periodic wave train (44) is marginally stable if 0 but is unstable if > 0 [8]. This means that for a given value of , the periodic wave train is unstable if kh_0 exceeds a critical value we shall denote by $_c = _c($), and is marginally stable for kh_0 $_c$. The




FIG. 2: A plot of 1 = c as a function of 1 = c is zero for 2 and 1 = 2.

critical value $_{\rm c}$ = 1:609927::: for the isotropic case (= 1) and is in nite for 2 and 1=2. Fig. 2 is a plot of 1= $_{\rm c}$ () as a function of . It is intereresting to note that the smallest value of $_{\rm c}$ is obtained for a value of diering just slightly from unity (= 0:972:::).

For kh_0 1, the product is negative, regardless of the value of . The periodic wave train is therefore m arginally stable in this lim it. This is in accord with the fact that choidal waves are marginally stable [26].

IV . C onclusions

In this paper, the electrom igration-induced dynam ics of small-amplitude disturbances on a low index crystal surface were studied. Periodic wave trains of nite amplitude were found, as well as their dispersion relation. These wave trains are unstable for $kh_0 > c()$, and are otherwise marginally stable. The equation of motion for slow modulations of the nite amplitude, periodic wave train was shown to be the nonlinear Schrodinger equation. As is well known, this equation is exactly solvable for initial conditions that vanish with suicient speed as jkj! 1 [27]. This exact solution has an number of consequences for electrom ignation—induced propagation of surface waves. If $kh_0 > c$ (), a localized initial wave packet of arbitrary shape will

eventually disintegrate into a number of envelope solitons and a small oscillatory tail. These solitons survive collisions with each other with no permanent change except a shift in phase and position.

What are the prospects of an experimental test of the theory developed in this paper? Quite recently, the SEM—induced dynamics of metal surfaces of large area have received some attention, but unfortunately these experiments were carried out on polycrystalline lms, and so they do not perm it a test of the theory [28, 29].

The experim ental situation is more promising in the case of semiconductors. A number of beautiful experimental studies of the SEM -induced dynamics of single crystal silicon. In shave been carried out, but on initially planar, vicinal surfaces [9, 30]. These studies revealed that a vicinal surface is unstable against step-bunching for one current direction, and that it is stable for the opposite current direction. Experimental studies of the dynamics of perturbed, low-index silicon surfaces that are subject to high electric elds have not yet been carried out.

To test the theory, a singly-periodic periodic wave structure could be etched into a low-index silicon surface. A fler perturbing the surface in this way, a high electrical current would be applied parallel to the ripple wavevector. The subsequent surface dynam ics could be imaged by scanning tunneling microscopy, as has already been done for vicinal surfaces.

The analog of the Stokes wave would be obtained by etching many parallel ripples into the wafer surface before the application of current. In this way, the amplitude dependence of the phase velocity could be determined and compared with the theoretical prediction. To observe the development of an envelope soliton (or solitons), on the other hand, a few tens or hundreds of ripples would be etched into the lminitially. This would produce a \wave packet" that would ultimately disintegrate into one or more envelope solitons and a small oscillatory tail under the action of an applied current.
