Symbolic D ynamics of H om oclinic O rbits in a Symmetric M ap

Abstract

Sym bolic dynam ics for hom oclinic orbits in the two-dimensional symmetric map, $x_{n+1} + cx_n + x_{n-1} = 3x_n^3$, is discussed. Above a critical c, the system exhibits a fully-developed horse-shoe so that its global behavior is described by a complete ternary symbolic dynam ics. The relative location of hom oclinic orbits is determ ined by their sequences according to a simple rule, which can be used to numerically locate orbits in phase space. W ith the decrease of c, more and more pairs of hom oclinic orbits collide and disappear. Forbidden zone in the symbolic space induced by the collision is discussed.

1 Introduction

This paper concerns locating hom oclinic orbits (HOs) for maps. The topic received some recent interests because it is closely related to nding spatially localized oscillatory solutions in one-dimensional lattices (see [1] and references therein). Numerical methods usually involve a shooting strategy or an assumption of the initial topology of HOs [2, 3, 4, 5]. In both cases, a deep understanding of the qualitative behavior of maps is important. As a coarse-grained description of dynamics, symbolic dynamics(SD) has been productively applied to one- and two-dimensional maps[8]. The electiveness of SD relies on the hyperbolic nature of the underlying dynamics. Therefore, SD should be a powerful tool to describe the qualitative behavior of HOs when the system is dominated by unstable motion. In this paper, we shall discuss this through a speci c map.

The system we consider is the map with its orbits $fx_n g$ obeying the relation

which has been studied in [6, 7]. The coe cient 3 can be re-scaled to an arbitrary positive number, so only c is the parameter of dynamical signi cance. Let $(a_h; b_h) = (x_n; x_{n-1}), \text{Eq.}(1)$ can be rewritten as a two-dimensional conservative map,

The system contains a xed point 0 = (0;0), which is unstable when jcj > 2. As in Ref. [7], we consider the orbits that are hom oclinic to point 0 at c > 2. The paper is organized as follows. Section 2 gives a prelim inary discussion of the map. Section 3 contains a general description of its SD. In Sec. 4, sym metric HOs are discussed in detail. This is followed by a brief sum mary.

2 Prelim inary

2.1 Sym m etries

M ap (12) is invariant under the spatial reversion (a;b) ! (a; b). M oreover, it has two inverse sym m etries, $I_1 : (a;b)$! (b;a) and $I_2 : (a;b)$! (b; a). I_1 and I_2 satisfy $I_1F I_1 = I_2F I_2 = F^{-1}$ and $I_1^2 = I_2^2 = I$. The inverse sym m etries determ ine four fundam ental sym m etry lines,

For points on these lines, their forward and backward trajectories are related by simple rules. Speci cally, F^k (X) coincides with I₁F^{1 k} (X), I₁F^k (X), I₂F^{1 k} (X) or I₂F^k (X) if X belongs to sl₁, sl₂, sl₃ or sl₄, respectively. Therefore, if X further belongs to the unstable manifold of a xed point, it must be a hom oclinic or herteroclinic point. This property was used to locate HOs with symmetry [7].

2.2 Norm al form for stable and unstable manifolds

Numerical investigation of HOs relies essentially on a precise computation of the stable and unstable manifolds. For canonic systems, the invariant manifold of a unstable xed point $X_0 = (a_0; b_0)$ can be determined by the Birkho normal form [9]. The manifold is given by the parameterized curve X (t) = (a(t); b(t)) with

Here is one of the eigenvalues of F at X_0 , speci cally, j j > 1 for the unstable manifold and j j < 1 for the stable one. Take $X_0 = 0$ as an example. Its unstable manifold can be written as

for k > 1. When k ! 1, g_k drops very fast if c is not too small (e.g. c > 3). In our numerical study, O_u (t) at t 1 is computed by the series expansion with a reasonable cuto . Applying F on a precisely determined piece of O_u (t) (2.4), we may obtain O_u (t) at large t with high precision.

3 Symbolic dynam ics: general description

3.1 Fully-developed horse-shoe and complete symbolic dynam ics

The global dynam ics of (1.2) at large c is most conveniently accounted for based on the relation between the stable and unstable manifolds of the xed points $A = (x_{d}; x_{d})$ and $B = (x_{d}; x_{d})$, where $x_{d} = \frac{P}{(c+2)=3}$. Figure 1a shows these invariant manifolds at c = 5:7, denoted by $A_{s};A_{u};B_{s}$ and B_{u} , respectively. The rst part of A_{s} , \overline{ACE} , is approximately a horizontal line. F^{-1} maps \overline{AC} to \overline{ACE} and two additional nearly horizontal segments, \overline{EG} and \overline{GJ} , form ing a s-turn. The rst three parts of A_{u} , B_{s} and B_{u} can be generated from A_{s} by taking advantage of the symmetry.

Under the action of F¹, the area conned by the rst segments of A, A_u, B_s and B_u (the diam ond-shaped ACBD in Fig. 1a) is transformed to the s-shaped region ACEGJBDFHK, indicating that the global dynamics exhibits a well-developed horse-shoe. This is schematically shown in Fig.1b. A fler taking into consideration of the symmetry, we can see that this geometric structure is guaranteed by the intersection between \overline{EGJ} consisting of the second and third segments of A_s and \overline{AD} , the rst part of A_u. The points of intersection correspond to two orbits that are hom oclinic to point A. In fact, the two points lie on sl₁ and hence correspond to HOs with relation symmetry. W ith the decrease of c, the two points move toward each other and collide at c = c 5:453254835, leading a tangency of A_s, A_u and sl₁.

As a prototype of chaotic dynam ics, the global behavior of horse-shoe is well-known. In our case, it is conveniently described by a complete ternary SD.

Symbolic representation of points All stable (or unstable) manifolds, that generally refer to invariant vector eld and shrink under the action of F (or F¹)[8], can be naturally divided into three groups and coded with +, 0 and , respectively (see Fig. 1). Correspondingly, a point X in phase space is represented by a bilateral symbolic sequence

where $s_k \ 2 \ f+;0; \ g$ is the code for the stable (or unstable) manifold on which $F^k(X)$ (or $F^{k+1}(X)$) is located. The completeness of SD means that each sequence is realized by at least one phase space

point. By de nition we have

where F is the right shift of \backslash "with respect to the sequence. Therefore, a bilateral symbolic sequence without \backslash " can be used to represent an orbit without its initial point speci ed. For example, the symbolic sequences of the xed points A, B and O are $+^1$, 1 and 0^1 , respectively.

O rder of sym bolic sequences A point is indicated by its forward sequence S_+ (hence stable manifold) and backward sequence S (unstable manifold). The location of stable manifolds in the phase space induce a nature order to forward sym bolic sequences, $s_1s_1s_2 \dots > s_0s_1^0s_2^0 \dots$ if the stable manifold of $s_1s_1s_2 \dots$ is above that of $s_1^0s_2^0 \dots$. The assignment of letters in plies

i.e., any sequence beginning with $\setminus + "$ is larger than any sequence beginning with $\setminus 0"$, which is in turn larger than any sequence beginning with $\setminus "$. The comparison of two arbitrary sequences relies on the fact that + and preserve the order while 0 reverses it. (Note that the eigenvalues of xed points A and B are positive while those of point 0 are negative.) A sum e that $S = s_1 s_2 ::: s_n s_{n+1} ::: and S^0 = s_1 s_2 ::: s_n s_{n+1}^0 ::: and s_{n+1} > s_{n+1}^0$, then $S > \hat{S}$ (or $S < \hat{S}$) if the number of $\setminus 0"$ in $s_1 s_2 ::: s_n$ is even (or odd). For example, the rst three segments of A_s correspond to $+^1$, $0+^1$ and $+^1$, respectively. It can be easily veried that the rst am ong the three is the largest forward sequence, and that there is no sequence which is sm aller than the second and at the same time larger than the third. Sim ilarly, backward sequences can be ordered in accordance with the location of their unstable manifolds in the phase space. We have

We shall indicate a point, an orbit or a piece of invariant manifold with the same symbolic sequence if there is no danger of causing confusion.

3.2 Under-developed horse-shoe and truncated symbolic dynam ics

W hen c < c, the second and third segments of A_s do not cross the segment of A_u . In this case, there are some \forbidden" sequences, e.g. $+^1 0+^1$ and $+^1 +^1$, which cannot be realized by any real orbits. Consider a sequence $S = S S_+ \cdot W$ hen c > c, it corresponds to a real orbit on which there is a point being the intersection of stable manifold S_t and unstable manifold S. W hen we reduce c, the two segmens of manifold will vary continuously with c and they must be tangent at a critical value of $c = q_b$ before S is forbidden. The tangency can

be viewed as a collision of two orbits. Since the two colliding orbits are in nitely close when $c! q_0$, generally their corresponding sequences di er by only one symbol, say, one is $S_1 OS_2$ and the other is $S_1 S_2$. (A logically more meaningful statement is that, to maintain the simple order of invariant manifolds, the partition line that separates $S_1 0$ and S_1 should pass the tangent point[8]). The tangency of stable manifold S_2 with unstable manifolds $S_1 0$ and S_1 implies a forbidden zone in the space of sequences or symbolic space[8]. Speci cally speaking, sequence $S^0 = S_1^0 - S_2^0$ with

corresponds to no point in the phase space (Fig.2a). Similarly, if the two colliding orbits are $S_1 0S_2$ and $S_1 + S_2$, the forbidden zone is given by

Of course, any sequence S^0 with certain F^k (S^0) satis es (3.5) is also forbidden.

Due to symmetry, it is not exceptional in our case that the sequences of the two colliding orbits di er by two symbols. The forbidden zone due to such collision will be also discussed.

4 Symmetric homoclinic orbits

We now focus on the orbits that are hom oclinic to the xed point O. The unstable manifold of O is given by (2.4). From the symmetry, the stable manifold can be written as $O_s(t) = (G(t);G(t))$. By de nition, HOs correspond to the solutions of equations G(t) = G(t) and G(t) = G(t^0). However, the equations have little practical use because G(t) changes violently at large t. The more useful know ledge is the global location of the stable and unstable manifolds. When c > c, each sequence $0^1 S 0^1$ corresponds to a HO. To locate the orbit in the phase space, we can scan initial point X on 0^1 , the rst segment of Q, searching for the target S₊(X) = S 0¹. For a symmetry line. In all cases, the order of forward sequences can be used for an e ective searching strategy. Having a HO at large c, we can trace it to small c until it collides with another HO and disappears. We shall not go into details about the locating of HOs. We shall focus on the com patibility between HOs at c < c.

In the following discussion, the stable and unstable manifolds are always referred to as O_s and O_u . We st give another description of the forbidden zone induced from the tangency of

stable and unstable manifolds, or the collision of two HOs. Let X and X⁰ be two hom oclinic points which collide each other when c ! q_0 . For c > c, the stable and unstable manifolds connecting X and X⁰ form a closed curve O (X;X⁰) (see Fig. 2), which shrinks to a single point when c = q_0 . Note that both O_s and O_u are continuous and self-avoiding curves. Consider a hom oclinic point enclosed by O (X;X⁰) or lying on O (X;X⁰). Being the intersection of stable and unstable manifolds, the point cannot cross O (X;X⁰) when c is continuously varied. The area enclosed by O (X;X⁰) at c > c vanish before c = q_0 . Therefore, O (X;X⁰) de nes the forbidden zone corresponds to the collision of X and X⁰.

It can be seen that the forbidden zone de ned by O (X; X^0) coincides with that de ned by (3.5) if S (X) and S (X⁰) dier by only one symbol (see Fig 2b). To study the evolution of symmetric HOs, we need also consider the the case that S (X) and S (X 0) di er by two symbols. For this purpose, the structure of stable and unstable manifolds should be studied in detail. Consider the 3^k segments of stable manifold of the form S d , where S exhausts all the ternary strings with length [5] = k. The relative locations of these segments of manifold in the phase space are determined by the order of S.W eask that how the 3 segm ents are connected to form a continuous curve. All these segments are generated from d by F^k, i.e., F^k (S d) = Sd. We may cut the segment $\dot{\theta}$, according to backward sequences, into 3^k pieces, each of which are coded with S . The way to joint these 3° pieces into the whole segment θ is determined by the order of the 3^k strings S . A fler expanding under F k , the segment θ becomes the 3^k seem ents of S d , so they should be connected also according to S . In the simplest case of k = 1, three segments of O_s from top to bottom are $+\theta$, θ and 0. Form ing an s-tum, + θ and $\hat{\mathbf{d}}$ joint with $\hat{\mathbf{d}}$ at its left and right ends, respectively. For k = 2, the nine segments of O_s are ordered from top to bottom as

as shown in Fig.3 schem atically by horizontal lines. In the gure S is also taken as the abbreviation for $S \overset{1}{\circ}$. These segments are connected end to end according to the following order of backward S :

++; 0+; +; 0; 00; +0; +; 0 and

The arrangement is shown in Fig.3. We see that pair (00; +0) joint at their left ends, (+0; +) joint at their right ends, (+; 0) joint at their left ends, and so on. In general, the sequence pair of connected segments of stable manifold take one of the following form s,

(i) $S = {}^{m} OS_{0}$ and $S^{0} = {}^{m} + S_{0}$; (ii) $S = + {}^{m} OS_{0}$ and $S^{0} = + {}^{m} S_{0}$; where m 0. Segment pair of type (i) are connected at their left ends while pair of type (ii) are connected at their right ends. By taking advantage of the symmetry, a parallel description can be given to the unstable manifold.

Now we study the forbidden zone in plied by the collision of two symmetric HOs. Let us not consider two examples. In the nst case, $S(X) = \hat{d} + + + \hat{d}$ and $S(X^0) = 0^1 + + + \hat{d}$. From the above discussion, 0^1 and \hat{d} are connected at their upper ends while $+ + + \hat{d}$ and $+ + + \hat{d}$ are connected at their right ends. The forbidden zone enclosed by $O(X; X^0)$ is shown in Fig. 2c. We see that it is the union of two forbidden zones, one is de ned by $O(X; X^0)$ and the other by $O(X^0; X^0)$, where $S(X^0) = 0^1 + + + \hat{d}$ (or $0^1 + + + \hat{d}$).

The next example is $S(X) = 0^1 \quad 0 \quad 00 \quad d \quad and \quad S(X) = 0^1 \quad + \quad 0 + \quad 1 \quad Now \quad 0^1 \quad 0$ and $0^1 \quad + \quad are connected at the bottom . On the other hand, \quad 00 \quad b \quad and \quad 0 + \quad d \quad are not$ $joint neighboring segments on <math>O_s$. They are connected by $0 \quad d \quad and \quad + \quad d \quad The area$ $enclosed by <math>O(X; X^0)$ is shown in Fig. 2d, which again turns out to be the union of two regions enclosed by $O(X; X^0)$ and $O(X^0; X^0)$ with $S(X^0) = 0^1 \quad 0 \quad 0 + \quad d \quad (or \quad 0^1 \quad + \quad 00 \quad d \quad).$

In general, suppose $S(X) = 0^1 S_1 0$ $S_2 0 S_3 0^1$ and $S(X^0) = 0^1 S_{1-1}$ $S_{2-2} S_3 0^1$, where $_{1,2} 2$ f+; g. This covers all the colliding symmetric HOs with two dimensional tetters. As seen in the two examples, it can be shown that the forbidden zone enclosed by $O(X;X^0)$ is the union of that demed by $O(X;X^0)$ and $O(X^0;X^0)$, where $S(X^0) = 0^1 S_1 0$ $S_{2-2} S_3 0^1$ (or $0^1 S_{1-1} - S_2 0 S_3 0^1$). In other words, when forming the forbidden zone, the collision of X and X 0 can be regarded as the triple collision involving X, X 0 and X 0 . Since either the pair of S (X 0) and S (X 0) dimensional X 0 construct the forbidden zone for the above general case.

We have numerically calculated all symmetric HOsO¹ SO¹ with 3j 7 and traced them from c = 6 to collision parameters q_b . Am ong the 160 orbits, only O¹ O¹ and O¹ O¹ persist till c = 2. We obtained 94 collisions, each of them corresponds to a tangency of O_s and a symmetry line (see Fig.4 for some examples). Due to symmetry, only half of the collisions are independent. They are ordered with descending q_b and listed in Tab.1. We further examine the compatibility between symmetric HOs. Collision of a pair of symmetric HOs may implies the elimination of some others. For example, it can be veried that the forbidden zone of the colliding HO pair (S;S⁰) = (+ + ;+00) includes the HO sequence pair (+ ; 0). Therefore, the collision of HO pair (+ ; 0) should occurs at a larger c than that for (+ + ;+00). In fact, the form er appears as the 9-th collision in Tab.1 while the latter is the 16-th. We motion that all such

restrictions in the 47 pairs of sequences in Tab.1 are in accordance with the order of c_b (Fig.5).

5 Summary

In the above we have discussed the symbolic dynam ics of system (1.2) with a focus on the orbits that are hom oclinic to point 0 = (0;0). When c > c, the global dynam ics is described by a complete ternary symbolic dynam ics, so that each sequence $0^1 \le 0^1$ corresponds a hom oclinic orbit. The location of these orbits are qualitatively determ ined by their corresponding sequences according to simple rules. With the decrease of c, more and more symmetric hom oclinic orbits collide in pair and disappear. Based on the geometrical constraint that any hom oclinic point cannot cross a region enclosed by the stable and unstable manifolds, the compatibility between hom oclinic orbits is discussed.
