# Linear and nonlinear $m$ arginal stability for fronts of hyperbolic reaction di usion equations

#### Abstract

$W$ e study travelling fronts of equations of the form $u_{t t}+(u) u_{x}=u_{x x}+f(u)$. A criterion for the transition from linear to nonlinear $m$ arginal stability is established for positive functions (u) and for any reaction term $f(u)$ for which the usualparabolic reaction di usion equation $u_{t}=u_{x x}+f(u)$ adm its a front. A s an application, we treat reaction di usion system $s w$ ith transport $m$ em ory.

## I. IN TRODUCTION

Reaction di usion equations are used to $m$ odel transport phenom ena in a variety of contexts such as population dynam ics, transm ission lines, am e propagation am ong others. The prototype of such equations, for
 ties has been achieved is the parabolic reaction di usion equation

where subscripts denote derivatives. For positive reaction term $s$, su ciently localized initial conditions evolve into a m onotonic decaying travelling front joining the stable $u=1$ to the unstable $u=0$ equilibrium points. For bistable reaction terk R , which satisfy $\mathrm{f}<0$ in $(0 ; a)$ and $f>0$ in $(a ; 1)$, with $R_{1} f>0$, it is possible to nd initial conditions for which the system will evolve into a m onotonic decaying front joining the tw o stable equilibrium points $u=1$ to $u=0$. In the rst case there is a continuum of speeds for which there exist $m$ onotonic fronts, the system evolves into the front of $m$ inim al speed. In the second case there is a unique speed.

The use ofE q. ([II) to m odela physicalprocess involves assum ptions on the stochastic process that describes the $m$ otion of the individuals. $M$ ore speci cally, B row nian m otion is assum ed $\left[\mathrm{B}_{1}^{\prime}\right]$. If instead a m ore realistic process is considered [4] [ di erential equation that describes the motion is a hyperbolic reaction di usion equation of the form

It has been shown that, as in the usual reaction di $u-$ sion equation, for positive (u), the hyperbolic equation adm its $m$ onotonic decaying fronts of speed $C_{1}<1$ and that the speed of the front is determ ined from a related parabolic equation [క్ర] $]$.

Equations of this form have been studied for particular cases of (u) obtained assum ing speci c functions for m em ory e ects in the di usion tem work has dealt $w$ ith the stability of the traveling front
[101]. For constant (u) and positive, concave, f the traveling fronts are stable to local perturbations. The asym ptotic behavior of the front of $m$ in im al speed has also been found [ [10 ${ }^{\prime}$ ]. N um erical solutions for positive but non concave $f$ indicate that the transition from linear to nonlinear $m$ arginal stability occurs at the sam e param -
 D etailed analysis for a piecew ise linear reaction tem has given insight into the nature of possible travelling waves [IT]. In system $s w$ ith exponential transport $m$ em ory (u) is of the form

For this case a variational principle for the front ofm inim al speed was constructed for positive reaction term $s$ $f(u)$; it was proved that for concave reaction term $s$, as in the parabolic equation, linear m arginal stability holds [6].

In this work we construct a variational principle for any positive function (u) and general reaction term $s$ for which the parabolic equation adm its a front. From this principle upper and low er bounds are constructed which perm it the a priori determ ination of the transition from linear to nonlinearm arginalstability [1] all known results as particular exam ples, and construct others that show di erent types ofbehavior depending on the explicit functions $f(u)$ and ( $u$ ). O urm ain result is the follow ing, consider Eq. (2), w ith (u) $>0$, and $f(u)$ a reaction term forw hich fronts of the parabolic equation exist, as described above. The m inim al (or unique, for the bistable case) speed of the fronts joining the stable to the unstable points $u=1$ to $u=0$ is given by

T he suprem um is taken over all positive decaying functions $g(u)$ for which the integrals exist. From this result it follow $s$ that, for positive reaction term $s$ which satisfy $\mathrm{f}^{0}(0)>0$, the follow ing bound holds,

which enables one to characterize functions for which m arginal stability holds. T he low er bound, the marginal stability value, is that im posed by linear considerations alone. Im proved low erbounds valid for all reaction term $s$ are obtained by direct use of the variational principle.

## II. SPEED OF FRONTS

C onsider the hyperbolic reaction di usion equation

where $f(u)$ and (u) $2 C^{1}[0 ; 1]$. We shall assum e that $f$ belongs to the class for which $m$ onotonic fronts joining the equilibrium points $u=1$ to $u=0$ exist. $T$ he precise conditions have been spelled above in the introduction,

$W$ ew ish to nd them inim alor unique speed forwhich there is a m onotonic decaying travelling wave solution $u=u\left(\begin{array}{lll}x & c & t\end{array}\right)$ ofEq. (G). The speed satis es $\left(\begin{array}{ll}1 & Z\end{array}\right) u_{z z}+$ $c(u) u_{z}+f(u)=0, \lim u_{z!} 1=1, \lim u_{z!1}=0$, $u_{z}<0$, where $z=x$ ct. It is known that when $f>$ 0 there is a continuum of fronts for a range of speeds $c<c<1$, where $c$ is the $m$ inim al speed of a related parabolic equation $\left[\begin{array}{l}{[1]} \\ \hline\end{array}\right]$. There is a unique speed in the bistable case. Wemay, as usual, consider the tra jectory in phase space by de ning $p=u_{z}(u)$. Themonotonic decaying front obeys

Before going any further we recall the constraints posed by linearization around the xed points. Linearizing around $u=0$ we nd that $p$ approaches zero as mu , $w$ here $m$ is the positive root of

$W$ hen $f^{0}(0)>0$, since it is know $n$ that $m$ onotonic fronts exist w th $c^{2}<1, m$ is realif the term in square brackets is positive, that is,

where we have called $c_{L}$ the $m$ inim al speed derived from linear theory or, as it is know $n$, linear $m$ arginal stability value.
$W$ hen $f^{0}(0) \quad 0$, linear theory im poses no constraint on the speed. A nalysis near the equilibrium point $u=1$ im poses no constarint on the speed as we assum e that $f$ is positive or of the bistable type.
$T$ he sim plest, but not unique, $m$ ethod to obtain a variational characterization of the speed is to introduce a stretching of coordinates which reduces the equation to the standard parabolic reaction di usion equation $[$ [ $[\mathbf{W}]$. Since (u) > 0, we may introduce a new independent coordinate de ned by the follow ing transform ation,

So that if $f$ is of the bistable type, forw hich fronts exist, the sam e holds for $F$ if $1 c^{2}>0$ which we know to hold. M oreover

W e m ay then apply directly the variational principle for fronts of the parabolic reaction di usion equation $[[1-3]$, that is,

A $s$ in the usual parabolic case the $m$ axim um is attained except at the linear $m$ arginal stability value. H ere too one can show that the linear marginal stability value is obtained by taking the suprem um instead of the $m$ aximum . In term softhe originalfunctions f and , Eq.(12) reads,

> III. CRITERION FOR LINEAR AND NONLINEAR MARGINALSTABILITY

For the parabolic reaction di usion equation $E q_{1}^{1}(\underset{1}{-1})$, for $\mathrm{f}>0$, we know that the m inimal speed, $\mathrm{CpF}_{\mathrm{F}}$ of the propagating front is bounded below and above. W hen these two bounds coincide, then one can determ ine the speed unam biguosly. A rst estim ate com es from the bound [11, $\overline{1}, \overline{2}$

W hen these tw o bounds coincide linearm arginalstability holds. It $m$ ay still hold if these tw o bounds do not coincide. $T$ h is can be decided $m$ aking use of the integral variational principle which im proves the low er bound [1] [1], and of a minim ax variational principle which im proves the upper bound $\left.{ }^{1} \overline{1} \overline{4}_{1}^{-}\right]$. C om bined use of the two perm its the exact determ ination of the speed. For the bistable case, we can obtain the speed $m$ aking use of the integral variational principle. In this section the analogue of the above results is obtained for the hypenbolic fronts.

## A. U pper bound

W e present here a simple derivation of the upper bound, valid both for positive and bistable reaction term s . T he follow ing evident inequality holds,

O bserve that this upper bound coincides w th the linear value when the suprem um occurs at $u=0$.
B. Low er B ounds

The lower bounds have already been obtained, one is the linear bound Eq. $(\underline{1})$, and im proved low er bounds can be obtained by choosing particular trial functions $g$. Equality, in the expression below, holds for a certain $g$.

IV. APPLICATIONS
A. C onstant (u)

As a rst exam ple consider the case (u) = 0, a constant. A s explained in the introduction the stability of the traveling front for this equation has been proven recently [10']. N um erical investigations have shown that the transition from linear to nonlinearm arginal stability occur at the sam e param eter values as for the parabolic equation $w$ th the sam e reaction term [d]. $T$ his last fact follow s directly from the bounds above. For a constant
(u), we obtain $=1=0$ and $y=u$. Then, the bounds read

The upper and lower bounds are identical to those for the speed of fronts of the parabolic equation parabolic equation; the speed is given by

The speed of the front is determ ined in term $s$ of the speed of the parabolic front w th the sam e reaction term, therefore the transition from linear to nonlinearm arginal stability occurs at the sam e param eter values as for the parabolic case. T he speed itself, how ever, is low er than the speed of the front of the parabolic equation,

## B . Suppresion of non linear $m$ arginal stability

A s a second exam ple, which show s that substantially di erent behavior $m$ ay occur, take the reaction function $f(u)=u(1 \quad u)(1+a u)$. The front of $m$ in $m$ al speed for the parabolic equation is given by

If we now consider the hyperbolic equation with (u)= $1+$ au, the upper and lower bounds coincide and the speed

Them inim alspeed is the linearm arginal stability value, no transition from linear to nonlinear $m$ arginal stability occurs. A signi cant slow dow $n$ of the speed takes place.
C. T im e delayed di usion

In system sw th tim e delayed di usion the function (u) adopts the form

form which arises $w$ hen considering di usion $w$ ith exponential tim e delay. H ere $s$ is a param eter. For this function $=1=s$ and $K(u)=u \quad f(u)=s$. The speed of the front $w$ as studied for positive reaction term $s$, and it $w$ as show $n$ that for concave reaction term $s m$ arginal stability holds [6]. This can be proved easily from the present approach. A s E q. (1- ${ }^{-1}$ ) show s, linearm arginalstability holds for all positive reaction term swith $\mathrm{f}^{0}(0)>0$ provided that the suprem um of

occurs on $u=0$, since $B(0)=4 f^{0}(0)={ }^{2}(0)$, is equal to the lower bound. To prove then that linear marginal stability holds it su ces to show that $B^{0}(u)<0$ for u $2(0 ; 1]$. Taking the derivative we obtain, after some algebra,

$w$ here $h(u)=u f^{0} \quad f$. It follow $s$ im mediately that for concave reaction term $s \mathrm{~B}^{0}(u)<0$. For concave term $s$ $\mathrm{f}^{\infty}<0$, so the rst term in the square brackets is negative. A nd $h(u)$ is negative for concave functions as well, $h(0)=0$, and $h^{0}=u f^{\infty}<0$. So we have recovered the result that for concave functions w ith $f^{0}(0)>0$, linear m arginal stability holds. A s it occurs for the parabolic case. itm ay hold fornoncave functions asw ell, fact which can be determ ined by use of the variational principle.

C onsider again the reation term $f(u)=u\left(\begin{array}{ll}1 & u\end{array}\right)(1+a u)$ as in subsection B. In the parabolic equation transition from linear to nonlinear $m$ arginal stability occurs at $\mathrm{a}=2$. Chogse here $\mathrm{s}=2$ which guarantees $>0$ for $0<a<(5+\overline{21})=2 \quad 4: 79$. We show in $F$ ig. 1 that the transition from linear to nonlinearm arginal stability occurs at a lower value of a than that for the parabolic case. $W$ e chose as a trial function $g(u)=\left(\begin{array}{ll}1 & u\end{array}\right)^{7}=u^{1: 8}$. $T$ he dot-dash line show s the low erbound im posed by the linear $m$ arginal stability value, the solid line the lower bound from the variational principle. The transition occurs at at a as low as 1.6 at least. T he precise transition value can be found by using a better trial function. T he dashed line shows the upper bound, which guarantees that linear m arginal stability holds for $0<a<1$, values forwhich $f$ is concave.

> D . A bistable reaction term

The variational principle and the bounds obtained above hold for positive and bistable reaction system $s$, no assum ption on the sign of $f$ is $m$ ade in the derivations. W e m ay therefore apply them to a bistable reaction term. $W$ e take as an exam ple a case for the speed of the parabolic front can be determ ined exactly,

If $(u)=0$ a constant, the speed of the front is given by Eq $\left(\overline{1}_{1}^{-1} \bar{g}_{1}\right)$, and the exact speed is know $n$ w ith Cp F given above.

For this bistable reaction term, w ith $(u)=1 \quad f^{0}(u)$, which is positive for $0<a<1=2$, w ith a simple trial function $g(u)=1 . u$, all integrals are elem entary, we obtain, using Eq. (14 í í),

$N$ um erical determ ination of the speed can be $m$ ade $w$ ith any desired accuracy by use of im proved trial functions.

We wish to point that, in recent work, a variational principle valid only for positive reaction term $s$ has been applied to a bistable example [i/l]. B istable reaction term $s$, by de nition, are not positive throughout the whole interval, so the hypothesis of their derivation is violated. W e attribute the nearly perfect agreem ent between the speed of the front obtained from their (nonapplicable) variational principle to that obtained from direct num erical integration to a coincidence for the speci ctrial function chosen. It is not di cult to nd an acceptable trial function, sharply peaked at the origin, for which the integrand of their variational expression, and so the speed, becom es com plex.

## V. CONCLUSION

W e have studied the speed of travelling fronts of hyperbolic reaction di usion equations ! ${ }^{(1)}$ ) for reaction term $s$ for which the parabolic reaction di usion equation ! (1) adm its fronts. A variational principle for the speed of the fronts has been obtained for a w ide class of system $s$. Explicit upper and low erbounds, obtained from the variational expression allow one to characterize sytem $s$ for
which marginal stability holds. W e have seen that depending on the nonlinearities of the equation the range of validity of linear $m$ arginal stability, can be increased or decreased, com pared to the com parable range for a parabolic equation $w$ th the same reaction term. The stability of the fronts has been proved for a lim ited class of such equations $[1] 1]$, num erical solutions have been explored for system s w th m em ory e ect. T hese results w ill be $m$ ore relevant if the stability of fronts ofm ore general system $s$ is proved. At present num erical results indicate that the front ofm inim alor unique speed can be selected. $T$ he general in itial value problem for hyperbolic reaction di usion equations is an open problem.

## APPENDIX A

Let $g(y)$ be a positive decaying function, which satis es $g(1)=0$, and callh $(y)=g^{0}(y)$, so that $h>0$. Then
where we used Schw arz's inequality. The second integral on the right side is, integrating by parts,
