In form ation transfer and nontrivial collective behavior in chaotic coupled map networks

The emergence of nontrivial collective behavior in networks of coupled chaotic maps is investigated by means of a nonlinear mutual prediction method. The resulting prediction error is used to measure the amount of information that a local unit possesses about the collective dynamics. Applications to locally and globally coupled map systems are considered. The prediction error exhibits phase transitions at critical values of the coupling for the onset of ordered collective behavior in these networks. This information measure may be used as an order parameter for the characterization of complex behavior in extended chaotic systems.

Much interest has recently been directed to understanding the phenom enon of em ergence of nontrivial collective behavior in systems of interacting chaotic elements [1]. Nontrivial collective behavior (NTCB) is characterized by a well-de ned evolution of macroscopic quantities em erging out of local chaos. Models based on coupled map networks have been widely used in the investigation of cooperative phenomena that appear in m any extended chaotic dynam ical system s [2]. In particular, NTCB has been studied in coupled maps on regular Euclidean lattices [1, 3], in one-dim ensional lattices [4], fractal geom etries [5], and globally coupled m ap system s [6, 7, 8, 9]. In this article, we investigate the information transfer between the local and global levels of coupled m ap network models as a condition for self-organization in spatiotem poral system s. One may ask the question: how much information does a local unit possess about the collective dynamics of a system ?; or, how does the information ow depend on parameters of the system?.

To analyze how global order in spatiotem poral systems can arise out of local chaos, we consider a system of N interacting elements, where the state of element i (i = 1;2;:::;N) at discrete time t is denoted by x_{+}^{i} . The evolution of each element is assumed to depend on its own local map dynamics and on its interaction with other elements in the network, where the strength of the interactions is given by a coupling param eter. The collective dynamics of the system at time t may be described by some statistical variable ht, such as the mean eld. The information transfer between local (x_t^i) and macroscopic (h+) variables is analyzed by comparing their corresponding time evolutions. We adopt a simple computational technique based on a mutual nonlinear modeling [10, 11]. This method makes use of the temporal evolution of a driven variable (which is receiving inform ation)

to infer characteristics of the driver variable. In our case, for di erent values of the coupling parameter we record time series containing the simultaneous evolution of the macroscopic quantity $h_{\rm t}$ and of a chosen local variable $x_{\rm t}^{\rm i}$.




FIG. 1: (a) B ifurcation diagram h_t vs. for hom ogeneous globally coupled maps, with b=0. Four dierent phases are observed as is varied: turbulent (T), periodic (P), chaotic bands (C), and synchronized (S). (b) E $_3$ (h jk) vs for this system. (c) B ifurcation diagram of a local mapx $_t^i$ vs. , exposing the underlying chaotic dynam ics.

The trajectory of the series x_t^i is reconstructed in an embedding space of dimension d as a collection of vectors $(x_t^i; x_t^i; x_t^i; \dots; x_{t-d+1}^i)$. Then, for each of these vectors, we system attically look for its nearest neighbor $(x_p^i; x_p^i; \dots; x_p^i)$ in the Euclidean distance, as shown in Fig. 1. The root-mean-square error over h_t at the embedding dimension d is computed as

where h_p is the value of the macroscopic variable that bears the time index of x_p^i , and is the standard deviation of h_t .

The prediction error given by Eq. (1) can be interpreted as a measure of the information that the series x_t^i possesses about the macroscopic variable h_t . In this context, small values of Eq. (h ix) in ply that the dynamics of the global quantity h_t is embedded in the local evolution. Larger mutual prediction errors indicate that the two time series become more independent of each other. In particular, for two totally independent random series the error Eq. (1) has a value of $\frac{1}{2}$.

As applications, we have calculated the error E $_{\rm d}$ (h jx) as a function of the coupling strength in coupled map system s exhibiting NTCB. This quantity was computed for several embedding dimensions dand the curve giving minimal errors was selected in each case.

The rst example is a system of maps subjected to

global coupling de ned as

$$\mathbf{x}_{\mathsf{t+1}}^{\mathsf{i}} = (1 \quad) \, \mathbf{f}_{\mathsf{i}} \, (\mathbf{x}_{\mathsf{t}}^{\mathsf{i}}) + \frac{\mathbf{x}^{\mathsf{N}}}{\mathsf{N}} \, \mathbf{f}_{\mathsf{j}} \, (\mathbf{x}_{\mathsf{t}}^{\mathsf{j}});$$

where the function $f_i\left(x_t^i\right)$ describes the local dynam ics of element i, and is the coupling parameter. The usual homogeneous globally coupled map system [6] corresponds to having the same local function for all the elements, i.e., $f_i\left(x_t^i\right) = f\left(x_t^i\right)$. As local dynamics, we employ the logarithm ic map $f\left(x\right) = b + \ln jxj$ [12], where b is a real parameter. This map does not belong to the standard classes of universality of unimedal or bounded maps. Robust chaos occurs in the parameter interval b 2 [1;1], with no periodic windows and no separated chaotic bands on this interval [12]. In a second example, heterogeneity in the local maps in Eq. (2) is introduced by taking $f_i\left(x_t^i\right) = b_i + \ln jx_t^i$ with the values of the parameters b_i distributed in [1;1].

The last example is a one-dimensional, homogeneous, diusively coupled logarithm icm ap lattice given by

where periodic boundary conditions are assumed in Eq. (3).

As the macroscopic variable for these systems we consider the instantaneous mean eld, de ned as

$$h_t = \frac{1}{N} \sum_{j=1}^{N} f_j(x_t^j)$$




FIG. 2: (a) B ifurcation diagram h_t vs. for hom ogeneous globally coupled maps, with b = 0. Four dierent phases are observed as is varied: turbulent (T), periodic (P), chaotic bands (C), and synchronized (S). (b) E₃ (hjk) vs for this system. (c) B ifurcation diagram of a local map x_t^i vs. , exposing the underlying chaotic dynam ics.

Each of the above examples presents nontrivial collective behavior in som e range of their param eters. Figure 2 (a) shows the bifurcation diagram of the mean eld ht of the hom ogeneous globally coupled m ap system, Eq. (2), as a function of the coupling strength [9]. The local param eter is xed at b = 0 for all maps and the system size is $N = 10^4$. For each value of , the mean eld was calculated at each time step during a run starting from random initial conditions on the local maps, uniformly distributed on the interval [8;4], after discarding the transients. W hen the local param eterb is in the range [1;1], the elements x_t^i are chaotic and desynchronized (see Fig. 2(c)). However, the mean eld in Fig. 2(a) reveals the existence of global periodic attractors for som e intervals of the coupling. Di erent collective states em erge as a function of the coupling: a turbulent phase, where he manifests itself as a xed point, following the standard statistical behavior of uncorrelated disordered variables; collective periodic states; collective chaotic bands; and chaotic synchronization [9]. In this representation, collective periodic states at a given value of the coupling appear as sets of vertical segments which correspond to intrinsic uctuations of the periodic orbits of the mean eld. Increasing the system size N does not decrease the amplitude of the collective periodic orbits. Moreover, when N is increased the width of the segments that make a periodic orbit in the bifurcation diagrams such as in Fig. 2(a) shrink, indicating that the global periodic attractors become better de ned in the large system lim it. Figure 2 (b) shows E3 (hjk) vs. . An abrupt change in the value of the quantity E3 (hjx) can clearly be seen at a critical value of the coupling c' 021, a behavior characteristic of a rst order phase transition. At this critical value of the coupling the collective behavior changes from a turbulent phase to a periodic collective state, as observed in Fig. 2(a). The error for < c is large, indicating that there is no appreciable information sharing between the local and macroscopic levels when the system is in the turbulent phase. For > c the error drops discontinuously to very small values. The local unit suddenly becomes \aware" of the collective dynam ics; the time series of a single map is good enough to provide assertive predictions of the mean eld evolution. Thus, there is a large amount of information transfer from the collective dynamics to each of the elements in the network, even before synchronization is achieved. Increasing the coupling beyond the synchronization region leads again to a turbulent state of the system and to a large value of the error E_3 (h jx).




FIG. 3: (a) B ifurcation diagram h_t vs. for heterogeneous globally coupled maps; system size is N = 10^4 . (b) E $_3$ (h jx) vs for this network.

Figure 3(a) shows the bifurcation diagram of h_t vs. for the globally coupled heterogeneous map lattice. In this case the local param eters bi are set at random with a uniform distribution in the chaotic interval, ie., b_i 2 [1;1]. Again the local dynam ics are chaotic, yet collective periodic behavior arise in som e w indows of the coupling param eter. Figure 3 (b) shows the error E $_3$ (h jk) for the heterogeneous globally coupled system. In this case the prediction error stays large up to a critical value of the coupling $_{\rm c}$ ' 0:04 and then decreases continuously for > c. The decrease in the prediction error resembles a second order phase transition. The emergence of collective periodic behavior is manifested in the low values of the error for > c. The disorder introduced in the globally coupled network by the local heterogeneity can be detected by the quantity E 3 (h jk) as a change in the character of the transition to collective behavior when compared to a similar transition in a homogeneous globally coupled system, Fig. 2(a).

The emergence of nontrivial collective behavior can

also be observed in the one-dimensional coupled map lattice, Eq. (3), as shown in Fig. 4(a). In this case the system presents only a turbulent (statistical xed point) phase and a period-two collective state [4]. Figure 4(b) shows E $_2$ (hjx) as a function of the coupling in the one-dimensional coupled map lattice. There is again a decrease in the error at the critical value of the coupling strength for which the transition from turbulence to periodic collective states occurs. We have observed similar transitions from large to small values in the quantity E $_{\rm d}$ (hjx) at the onset of NTCB in networks having other connecting topologies, as well as when employing unimodal chaotic maps as local dynamics.




FIG. 4: (a) B iffurcation diagram h_t vs. for one-dimensional coupled map lattice; $N=10^4$ and b=0. (b) E $_2$ (h jx) vs for this lattice.

The logarithm ic map has been employed as local dynam ics in the above examples because the emergence of ordered collective behavior in those coupled system s cannot be attributed to the existence of windows of periodicity nor to chaotic band splitting in the local dynam ics. These systems can be chaotic at a local level and simultaneously periodic at a macroscopic level. Thus, there should exist som e global inform ation sharing am ong the elem ents of the networks that leads to a collective organization besides the trivial synchronization. The inform ation transfer required for the onset of nontrivial collective behavior takes place at some specic values of the param eters of the system s. The observed decreasing of the errors at the transition to nontrivial collective behavior can be interpreted as a manifestation of the emergence of organization in these systems. It should be noticed that in all cases the dynam ics of the elements do not experience notable change before and after the transition to nontrivial collective behavior, since local dynam ics is always chaotic.

In conclusion, we have shown that the error $E_d\left(h_{jk}\right)$ is a useful quantity to characterize the transition to ordered collective behavior in chaotic spatiotem poral system s. C onnectivity and coupling strengths are the mechanisms.

anism for information ow in networks of dynamical units. However, our results suggest that transference of the information that is relevant for the emergence of collective organization in systems of interacting chaotic elements is associated to low values of E $_{\rm d}$ (h $_{\rm jx}$). Finally, the exploration of a possible relationship between E $_{\rm d}$ (h $_{\rm jx}$) and other quantities used to study coupled chaotic map systems, such as the collective Lyapunov exponent [8] or transferentropy [13], is an interesting problem for future research.
