# FractalD i usion in Sm ooth D ynam ical System s w ith V irtual Invariant C urves

## A bstract

Prelim inary results of extensive num erical experim ents $w$ ith a fam ily of sim ple m odels speci ed by the sm ooth canonical strongly chaotic $2 \mathrm{D}-\mathrm{m}$ ap w ith global virtualinvariant curves (V IC s) are presented. W e focus on the statistics of the di usion rate $D$ of individual trajectories for various xed values of the $m$ odel perturbation param eters K and d . O ur previous con jecture on the fractal statistics determ ined by the critical structure of both the phase space and the $m$ otion is con m ed and studied in som e detail. Particularly, we have found additional characteristics of what we term ed earlier the V IC di usion suppression which is related to a new very speci ctype of the critical structure. A surprising exam ple of ergodic $m$ otion $w$ ith a "hidden" critical structure strongly a ecting the di usion rate was also encountered. At a weak perturbation ( $K \quad 1$ ) we discovered a very peculiar di usion regim e w ith the di usion rate $D=K^{2}=3$ as in the opposite lim it ofstrong ( $K \quad 1$ ) uncorrelated perturbation but, to the contrary, w ith strong correlations and for a very short tim e only. A s yet, we have no de nite explanation of such a controversial behavior.

1. Introduction: virtual invariant curves

In a 2 D m ap (2.1) we are going to study here the di usion crucially depends on the global invariant curves (G IC s) which cut the 2D phase space (a cylinder, see next Section) of the motion. Even a single such curve is su cient to com pletely block the global di usion (GD) in the action variable along the cylinder. As is well known by now the existence of the G IC s does depend not only on the perturbation strength but also on its sm oothness. It is convenient to characterized the latter by the tem poral Fourier spectrum of the perturbation. For analytical perturbation the Fourier am plitudes decay exponentially fast. In this case GD sets up if the perturbation > cr exceeds som e critical value. O therw ise, the chaos rem ains localized with in relatively narrow chaotic layers of nonlinear resonances. A s a result, the GD is either com pletely blocked by G IC s or the rate of the di usion as well as the $m$ easure of its dom ain decay exponentially in param eter $1=$ as ! 0 (the so-called A mold di usion, for a general review see, e.g., [1], 'Rír '

By de nition, the H am iltonian of a sm ooth system has the power\{ law Fourier spectrum with a certain exponent +1 (see, e.g., $\left[\begin{array}{ll}-1 /]\end{array}\right.$ and references therein). In this case the GD is alw ays blocked for some su ciently sm all perturbation strength < or () provided the sm oothness param eter $>$ or exceeds the critical value. This is sim ilar

[^0]to the analytical H am iltonian except that the critical perturbation depends now on the Ham iltonian sm oothness（ cr（）！ 0 as ！cr）．

To the best of our know ledge，the m ost strong rigorous result reads：cr＜ 4 for a
 to even sm aller value $\mathrm{cr}=3$ which is still to be con m ed som ehow，theoretically or num erically．In any event，the sm oothness of our m odel here $=2$ is even less．

U ntil recently，the behavior of dynam ical system $S$ in the opposite case $<\quad$ or of a poorsm oothness rem ained rather vague．Even though the most num ericaldata seem ed to

 certain restricted part of the phase space for a fairly long computation tim e．N o clear explanation of these strange events has been given as yet．
$M$ eanw hile，about 20 years ago（！）a num ber of $m$ athem atical studies revealed var－ ious possibilities for the existence of G IC s in sm ooth system swith＜cr（see，e．g．，
 ［⿹勹龴⿵⺆⿻二丨冂刂 w wo rigorously proved a strange survival of in nitely many G IC s am id a strong local chaos．Surprisingly，all these interesting results rem ain essentially unknown，at least to physicists．A pparently，this is because the abovem entioned $m$ athem atical papers were re－ stricted（perforce ！）to what could be done rigorously that is to the invariant curves only w thout any attem pt to analyse the very interesting and im portant transport processes such as di usion．This is still in reach to the physical analysis and num erical（or labora－ tory）experim ents only．A s a result，only after recent accidental rediscovery of G IC s in chaos by O vsyannikov［1］in］］（which are still unpublished（！），see［1］ of O vsyannikov＇s theorem ）the intensive physical studies of this interesting phenom enon have begun
 strange locked－in tra jectory w as observed stillm uch earlier $\uparrow \hat{1}, 1.1$ ．A pparently，th is is because such a model（a particular case of our $m$ odel $w$ th param eter $d=1=2$ ，see next Section） is the sim plest one possessing those curious G IC s（for discussion see［1］ 1 ］）．Perhaps the $m$ ain sunprise $w$ as in that the G IC $s$ include the separatrices of nonlinear resonances w hidh were always considered before as ones destroyed rst by alm ost any perturbation．The principal di erence is that now the invariant curves，separatrioes including，do exist for the special values of the system param eters only（say $K=K_{m}$ ）．

Even though there are in nitely $m$ any such special values of the param eter，and the in nitely $m$ any G IC s for each ofthe value of which just a single G IC does com pletely block the GD the probability of the latter that is the $m$ easure of such $K$－values is apparently zero．So，a principal question to be answered is：what would be the behavior of that system for an arbitrary value of $K$ ？In［īq］we con jectured that even though the set of
 so that one $m$ ay expect som e change（presum ably suppression）of the di usion for every $K$ value as com pared to the＂usual＂（fam iliar）dynam ical system．In other words，we guessed that the structure of the phase space and of the $m$ otion therein $m$ ay be changed by the form ation of G IC at a close $K$ value even if at alm ost any $K$ there is actually no

G IC. This is why we call now such a neighbourK invariant curve the virtual one (V IC) w th respect to any K 畒 $\overline{\mathrm{G}}]$.
$P$ relim inary num erical experim ents presented in [ī $[\overline{1}]$ did con $m$ our con jecture. This w as done by the prom pt com putation of the average di usion rate $D(K)$ as a function of param eter $K$ in the dom ain $w$ ith $G I C s$, real or virtual ones. The experim ents revealed a very strong suppression of the di usion, up to $m$ any orders ofm agnitude, restricted only by the com putation tim e. But what tumed out to be even $m$ ore interesting $w$ as a very com plicated (apparently fractal) structure of the dependence $D$ ( $K$ ). This seem $s$ to be a result of a very com plicated structure of the m odel phase space itself. P relim inary, the latter looks like a so-called critical structure (see, e.g., [岁]) but a rather speci c one due to a forest of V IC s.

In the present paper we begin studying this seem ingly new type of such a structure. Speci cally, we start w ith investigation of the statistical properties of the di uson as one of the characteristic processes in the chaotic m otion.
2. M odel: the sam e again

For reader's convenience we repeat below the discription of the model which is the sam e as in $\left[\overline{1} \overline{5},{ }^{\prime} 1 \overline{1} \overline{6}\right]$. T he m odel is speci ed by a m ap in canonical variables action (m om entum ) p-phase x:

where $K=">0$ is pertunbation strength (not necessarily weak), and "force" $f(x)$ has a form of antisymm etric (f $(y)=f(y) ; y=x \quad 1=2)$ piecew ise linear "saw " of period 1. The phase space of the $m$ odel is a cylinder: $0<\mathrm{x}<1$; $1<\mathrm{p}<+1$.

where $y=x \quad 1=2$, and the second param eter $d(0 \quad d \quad 1)$ is the distance betw een the two "teeth" of the saw ff $(x) j=1$ at points $y=y=d=2$. Them ost studied particular case of the fam ily corresponds to $d=1=2 w$ hen the two-teeth saw $f(x)$ is sym m etric. In the lim it $d=0$ the two teeth $m$ erge in one, and all the invariant curves are destroyed. This was observed and explained in [15] for $\mathrm{K}>0$. In the opposite case $\mathrm{K}<0$ (which is equivalent to $\mathrm{K}>0 ; \mathrm{d}=1$ ) the dynam ics of the m odel is com pletely di erent, and we w ill not consider it in this paper (for a brief discussion see [1] $\left.{ }^{-1}\right]$ ). In our 2D m ap (2.1) the G IC supports rotation of phase $x$ around cylinder which bars any $m$ otion in $p$ over G IC s. Unlike this the local invariant curve (LIC), surrounding, for exam ple, a dom ain of
 which allow s other tra jectories to bypass that obstacle.

The G IC s, separatrioes including, do exist in the whole interval $0<d<1$ but for

The calculation of the di usion rate and other quantities are done using the standard analysis of the nonlinear resonances and their interaction（overlap）（see，e．g．，［ī，＇ $T$ he calculation is especially simple if one can neglect the variation of coe cients $\mathrm{jf}_{\mathrm{n}} j$ const in（2．4）．This sim pli cation is exact ford $=0$（2．6），and rem ains reasonably accurate ［ī̄］for

N otioe that the dependence $D(K) / K^{5=2}$ is di erent from the usual，or better to say， the sim plest one $D(K) / K^{2}$ ．This is explained by the dynam ical correlation of m otion which is determ ined by the frequency of the phase oscillation on nonlinear resonances

H ere ${ }_{n}$ stands for the Lyapunov exponent charaterizing the local exponential instability of the $m$ otion which is the $m$ ain criterion for dynam ical chaos．$N$ otice that for $=1$
both $n$ and $n$ do not depend on the Fourier harm onic num ber $n$. T he exact value of the Lyapunov exponent in the $\lim$ it $d=0$ is given by

The latter expression is the approxim ation for sm all K (cf. Eq.(2.9)) which is fairly well within the region of application of Eq. (2.8) ( $K<0: 1$ ) w ith accuracy $1 \%$. A s the time in ourm odel is discrete (the num ber ofm ap's terations) both correlation characteristics, (2.9) and (2.10), m ust be sm all, hence the above restriction on param eter $K$ too.

In the opposite lim it $\mathrm{K} \quad 1$ the correlation betw een successive x values are negligible, and one arrives at the "usual" relation for the di usion rate:

independent of the param eter d. In interm ediate region (K 1) the correlation causes the decaying oscillation (see [g]) which is beyond the soope of the present paper.
3. D i usion w ithout any invariant curves: averages and $m$ om ents

A sw as already $m$ entioned above there are no invariant curves for $d=0 . M$ oreover, the $m$ otion is ergodic that is of the sim plest structure of the phase space (cf. Section 4 below ). $T$ herefore, this particular case is not of the $m$ ain interest to us by itself. $N$ evertheless, it is a good introduction to our central problem considered in Section 6 below. A sim ilar approach was taken in our previous paper tī
$F$ irst, we consider the tim e dependence of the di usion rate $D(K ; t)$. The sem icolon here instead of usual com m a is intended to em phasize that this tim e dependence is not a real physical contribution to the di usion but rather a combination of two di erent processes: the proper di usion via accumulation of random perturbation e ects and a stationary regular oscillation of the di using variable ( $p$ in our case) which is a sort of badkground for the di usion. Such a phenom enon can be roughly represented by a sim ple relation:

where $B(\mathbb{K})$ is som e function of the perturbation (see, e.g., [1] $\overline{1}]$ and Eq.(3.5) below ). In other words, in $m$ any cases, the present studies including, the nondi using stationary part can be separated from the di using part which much simpli es the analysis of this com plicated process. A ll this can be describe, of course, via the standard $m$ ethod of the correlation ofperturbation. H ow ever, this would lead to a m uch m ore intricate theoretical


A $n$ exam ple of the di usion kinetics is presented in $F$ ig.1. The com putation was done as follow s. A num ber oftra jectoriesM 1 w th random intialconditions hom ogeneously distributed w thin the unit area of the phase cylinder ( $0 \quad x_{0}<1 ; 0 \quad p<1$ ) were run for a su ciently long tim e w ith successive outputs at certain interm ediate $m$ om ents of tim e tas show $n$ in $F$ ig.1. Rem em ber that $t$ is $m$ easured in the num ber ofm ap's iterations.

Each output includes the di usion rate < D > averaged over all M trajectories, and the dim ensionless variance of that

For $G$ aussian distribution of action $p$ this variance would be unity. $T$ his is indeed the case for a su ciently long $m$ otion tim ew hen the $m$ easured di usion rate reaches its asym ptotic value $D_{1}$ (3.1). A quite di erent dependence $V_{M}(t)$ for previous sm aller tim $e$ is of no surprise (nor is it very interesting) as over there $D(t)$ depends on a com pletely di erent physical process one needs to pass over.

A real surprise was the very beginning of the di usion, the plateau in Fig.1. This looks as a real di usion unlike the follow ing part of a stationary oscillation. M oreover, the di usion rate on the plateau $D_{0}=K^{2}=3$ is them axim alone (2.11) as for large $K \quad 1$. A nother interesting observation is the duration of this strange di usion

which is close to the inversed Lyapunov exponent, the rise tim e of the local exponential instabillty of the underlaying chaotic $m$ otion. The last but not least curious property is the fast increase of variance (32):

as shown in Fig.1. This is qualitatively di erent from the behavior of the sam e di usion rate for large $\mathrm{K} \quad 1$ when the variance $\mathrm{V}_{\mathrm{M}} \quad 1$ is usual. The dynam icalm echanism of this strange transitional di usion is not com pletely clear and requires further studies. A pparently, it is related som ehow to the $m$ ain correlation (2.9) on the dynam ical scale (3.3). Even though the initial "di usion" is relatively fast it goes on a short tim $\mathrm{m}_{\mathrm{q}}$ e only so that the relative change of the initial distribution of trajectories j pjjpjo $\mathrm{D}_{\mathrm{o}}=$
$K^{3=4} \quad 1$ is negligible for sm all $K \quad 1$ unless the initial distribution $j \mathrm{pj}_{0}<\mathrm{K}^{3=4}$ is very narrow. H ow ever, in the latter case the dependence $D(t)$ is very sensitive to the form of the intial distribution in $p$ as a few our prelim inary num erical experim ents reveal. The variance of $D(t)$ is especially strong for $s m$ all $t \quad t$ in the region of that $m$ ysterious plateau but eventually decays as $t$ ! 1 when the di usion approaches its lim it value $D_{1}$. A pparently, this is related to a com plicated ne structure of the phase space and/or of the m otion correlations. T his interesting question certainly deserves further studies but in the present paper we consider the sim plest, hom ogeneous, distribution of the tra jectory intial conditions on the phase cylinder.

In this particular case, a very sim ple and suprisingly accurate em pirical relation for the di usion tim e dependence has been found starting from a qualitative picture (3.1). It has the form :

Here is the dim ensionless tim ew ith an em pirical tting param eter c 1 which is very close to one. The second em pirical param eter 4 is less de nite but it a ects the tum of the dependence $D(t)$ at 1 only. This relaxation of the di usion rate has two tim e scales: (i) theplateau ${ }_{p l}=1$ or $t_{p 1}=1=C \quad 1=\overline{2 \mathrm{~K}} \quad 1$, and (ii) the relaxation $\mathrm{R}=\mathrm{D}_{0}=\mathrm{D}_{1} \quad 1=\overline{\mathrm{K}} \quad 1$ or $\mathrm{t}_{\mathrm{R}} \quad 1=\mathrm{K}$ which is still much longer. Interestingly, the usual di usion spreading of a very narrow intial p-distribution on the relaxation time scale

is exactly equal to the spreading on the plateau. H ence, the full relaxation spreading is tw ioe as large which is also directly seen from the em pirical relation (3.5):

and which is stillm uch less than the unit p-period.
In Fig. 1 the em pirical relation (3.5) is presented and com pared to the num erical data in the dim ensionless variables and $D=D=D_{1}$ where $D_{1}$ is the asym ptotic ("true") di usion rate (2.8). In these variables the curves $w$ th various $K$ values are sim ilar, and converge in the lim it ! 1 .

A nother interesting scaling can be done as follow s. Let us calculate the di usion rate $D_{1}(D())=D_{\text {th }}$ from Eq. (3.5), and plot the ratio of that to the true rate (2.8):

Then, w thin the accuracy of scaling (3.5) and of uctuations, this ratio m ust be alw ays close to unity. This is indeed the case except the plateau ( $t<t_{0}$ ) where the rate D ( ) is alm ost independent of (see Fig.1).

The next im portant statistical property are the uctuations of the di usion rate. O ne characteristic of those is the dispersion of tracjectories which is characterized by the variance (32). If all the trajectories would be statistically independent the dispersion of the $m$ ean di usion rate were

By construction, the trajectories are independent indeed w ith respect to their intial conditions but not necessarily to the corresponding di usion rate. To chedk this we repeated the com putation of di usion N tim es w th new and independent initial conditions, and then calculated the second (new) dim ensionless variance for the average di usion rate:

A gain, ifEq.(3.7) holds true the variance $\mathrm{V}_{\mathrm{N}}$ should be close to one.

The tim e dependence ofboth variances, $\mathrm{V}_{\mathrm{M}}(\mathrm{t})$ and $\mathrm{V}_{\mathrm{N}}(\mathrm{t})$, is show n in F ig.1. Rem ark$a b l y$, their behavior is qualtatively di erent. The rst variance $\mathrm{V}_{\mathrm{M}}(\mathrm{t})$ depends on the distribution function of $p$ in the ensem ble of tra jectories while the second variance $V_{N}$ ( $t$ ) is a ected by the statistical dependence (or independence) am ong trajectories whatever their distribution function. The results of our num erical experim ents presented in F ig. 1 clearly dem onstrate that the distribution in p quidkly deviates from the Gaussian one during the di usion on plateau, and come back only in the lim itt! 1 when the diffusion rate $D!D_{1}$ approaches the asym ptotic value w thout any nondi using part. Unlike this, the trajectories rem ain statistically independent during the whole process of the di usion relaxation. W e will com e back to discussion of this interesting point in the conclusion to this paper (Section 7).

N ow we tum to them ost inform ative statisticalcharacteristic, the distribution function $\mathrm{f}(\mathrm{D})$ of the di usion rate.
4. D i usion w ithout any invariant curves: the distribution function

In the $m$ ain part of our paper (Section 6) we shall be prim arily interested in the distribution taild ! 0 of very low di usion rate. The shape of this tail is known to be an im portant characteristic of the critical structure of the $m$ otion (see, e.g., 㥠]). First indications of such a structure in the presence of the virtual invariant curves have been observed in $[1 \overline{1}-1]$. H ere we continue these studies.

Since the statistics of the far tail is alw ays rather poor we m ake use, as in [ī-1], of a special version of the integral distribution

the so-called "rank-ordering statistics of extrem e events" (see, e.g., tī follow ing simple ordering of the $D(j)$ values (events) of the di usion rate is su cient: D $(j+1)>D(j) ; j=1 ; 2 ;:: ;$ J. Then the integral probability is approxim ately given by the ratio $j=J$ as shown in Eq.(4.1).

In com putation we typically ran $M$ trajectories by $N$ tim es (see Section 3), so that the m axim al num ber of events reached $\mathrm{J}=\mathrm{M} \quad \mathrm{N}=10^{\ddagger} \quad 10=1{ }^{\delta}$. To obtain the low est possible $D$ values and $m$ inim ize, at the sam e tim e, a rather big output we ordered all the com puted events but printed out $m$ uch less of those $J_{0} \quad J$ in such a way to get som e all $J_{1}<J_{0}$ rst (the sm allest) $D_{j}$ while the rest were printed out in a logarithm ic scale. An example of such distribution is presented in F ig 2 for $\mathrm{K}=0: 001$ in variables $\mathrm{D}=$ $\mathrm{D}=<\mathrm{D}>$ and $\mathrm{F}(\mathrm{D})=\mathrm{j}=\mathrm{J}$ where $<\mathrm{D}>$ is some average di usion rate (see below). $T$ he upper distribution corresponds to a rather long motion tim et $=10^{4} \quad 1=\mathrm{K}$ when the $m$ ean di usion rate is already very close to the lim it $\mathrm{D}_{1}$. For the lower distribution $t=10$ is very short and corresponds to the plateau.

At least in the form er case when the $p$ distribution is $G$ aussian (see Section 3) the distribution

where the latter expression gives the asym ptotics $D$ ! 0 we need. T his asym ptotics is in a very good agreem ent w ith em pirical data in Fig 2 even at D $0: 1$ (!). For very sm all D the accuracy of the agreem ent is lim ited by the uctuations due to a few rem aining points. The sm allest $D=8: 3 \quad 10^{11}$ corresponds to the estim ate $D_{m}$ in $\quad 1=\mathcal{J}^{2}=10^{10}$.

Since the distribution $f(D)$ in (4.6) is also $G$ aussian of $\bar{D}$ the integral $F(D)$ adm its a very sim ple approxim ation found in [1] [1]:

The relative accuracy $\mathrm{j} F=\mathrm{F} \mathrm{j}<0: 05$ of that approxim ation is better than 5\% in the whole range off. A ctually, the accuracy is even $m$ uch better except a narrow interval at D $\quad 1=2$.

Thus, the upper distribution in Fig 2, which describes the realdi usion at su ciently long $m$ otion tim $e$, is well in agreem ent $w$ ith the available theory. T his is no longer the case for the low er distribution on the plateau. In itself, this is not a surprise as in the latter case, unlike the form er one, the $m$ easured di usion rate is $m$ ainly determ ined by nondi usive processes. H ow ever, a very interesting feature of this nondi usive distribution is in that the exponent of the power-law tail rem ains exactly the sam e as if the p-distribution were again a G aussian one. The sim plest explanation, quite plausible to us, is in that the far tail still represents such a distribution which is a part of the whole distribution according to our original picture expressed by estim ate (3.1). O ne im m ediate inference would be
decrease of the tail probability if we still use the same variable $D=D=D_{1}$. This is indeed the case according to the data in F ig 2 !

A more di cult problem is the quantitative estim ate of the distribution shift for the motion timet<1=K when the ratio $\left\langle\mathrm{D}>=\langle\mathrm{D}(\mathrm{t})\rangle=\mathrm{D}_{1}>1\right.$. This shift can be characterized either via the probability decrease by $R_{F}$ tim es for a xed $D$ or via the increase of $D$ itself by $R_{D}$ times for a xed probability. N otioe that on the tail $R_{D}=R_{F}^{2}$ due to the square-root dependence (4.6). Characteristic $R_{D}$ seem $s$ to us $m$ ore preferable since it describes the shift not only of the tail but also (qualitatively) of the whole distribution F (D).

A fter som e playing w ith the data we have found the follow ing em pirical relation for the tail shift:

The philosophy behind this relation is follow ing. $W$ e start $w$ th our original picture of a com bined di usive/nondi usive process (3.1) which is alm ost our nal choice (4.8). H ow ever, at the beginning we seem ed to im prove the original relation by inclusion of our surprising discovery, the plateau. Speci cally, we tried to m ake use ofE q.(3.5) which is in a good agreem ent w th the em pirical data for the dependence D ( $t$ ) (see Fig.1). A lso, we have found that it partly described the distribution F (D) too, except on that m ysterious plateau! Then, our nal, so far, step was the change from (3.5) back to a version of (3.1) in the form (4.8).

H ow strange itm ay seem this did work w ith a reasonable accuracy as the insert in F ig 2 dem onstrates. The rem aining question "why?" is still to be answered in farther studies. A ctually, this is a general serious problem of the dynam icalm echanism underlaying the plateau form ation and statistics.

O ur em pirical relation (4.7) can be represented in a di erent way. $N$ am ely, instead describing the actual distribution tail shifted w ith respect to the lim iting asym ptotics (4.6) we $m$ ay introduce the scaled di usion rate

The result is shown in $F$ ig 2 as a beam of 10 scaled distributions which are scattered now around asym ptotics (4.6).
5. D i usion am id virtual invariant curves: the Lyapunov exponents

A bove we considered a very particular and $m$ ost sim ple lim iting case ofourm odel (2 2) $w$ ith param eter $d=0$. In this case the $m$ otion is ergodic $\left[\begin{array}{l}-1 / 1\end{array}\right]$ wich greatly simpli es the
problem under consideration. N evertheless, we obtained a num ber of new results which form the $m$ foundations for further studies.

Them ost im portant new feature of the $m$ otion ford $>0$ is the so \{called divided phase space of the system that is a $m$ ixture ofboth chaotic as well as regular com ponents of the m otion. This is a typical structure of a few \{freedom dynam ical system (see, e.g., [il]).

First of all, we need to exclude the regular trajectories from further analysis of the di usion statistics. The standard well known $m$ ethod to do this is sim ultaneous com putation for each trajectory of the so\{called Lyapunov exponent that is the rate of the
 a 2 D canonical (ham iltonian) map like our model (2.2) there are two Lyapunov exponents whose sum is always zero: $1+2=0$. For a chaotic trajectory one exponent, say, ${ }_{1}=+>0$ is positive while another one ${ }_{2}=<0$ is negative. A s a result, according to the standard de nition of the Lyapunov exponent in the lim it $t$ ! , any tangent vector ( dx ; dp) of the linearized $m$ otion approaches the eigenvector corresponding to $+>0$.

A sim plew ellknow n procedure for com puting + , wem ade use in the present w ork too, is the follow ing. For each of $M$ trajectories $w$ ith random intialconditions $x_{0} ; p_{0}$ we chose the tangent vector ( dx ; dp ) of random direction and unit m odulus: $\mathrm{d}^{2}=\mathrm{dx}^{2}+\mathrm{dp}^{2}=1$. $T$ hen both m aps, the m ain one and the second one linearized w ith respect to the m ain reference trajectory $x\left(t ; x_{0} ; p_{0}\right) ; p\left(t ; x_{0} ; p_{0}\right)$ were run sim ultaneously during som e timet. Finally, the current ( $(\mathrm{t})$ was calculated from the standard relation:

where the brackets denoted the averaging over $M$ tra jectories. Unlike the form alm athem atical de nition of in the lim it $t$ ! 1 , in num erical experim ents the Lyapunov exponent ( t ) is alw ays tim e dependent, perforce.

In Fig. 3 a few typical exam ples of the distribution are depicted for the number of events in (4.1) $\mathrm{J}=\mathrm{M}$ equal to that of trajectories while the num ber of printed $\{$ out points $J_{0}=M^{0} \quad M$ is less except the case $d=0$. The sim plest one is for ergodic $m$ otion ( $d=0$ ). It has a form ofalm ost vertical step which derivative $d F=d \quad 10^{4}$ is very narrow -function. N otioe that regular chain of points along F axis has no special physical meaning but sim ply re ects a particular accepted type of the distribution $F(j)=j=J$ (4.1) w th integer j. The mean depends only on $K$ (see Eq.(2.10)) but not on the initial conditions. This exam ple in $F$ ig. 3 show s the em pirical/theoretical ratio which is very close to unity as expected.

Two other exam ples correspond to the same $K=0: 45$ and $M=10^{4}$ but di erent motion time $t=10^{4}$ and $10^{5}$ iterations. Both distributions have the sam e step at the largest which corresponds to di usive com ponents (not necessarily a single one) of the $m$ otion sim ilar to the ergodic case. H ow ever, the $m$ ost interesting part of the form er is the rest of the distribution which represents a rich motion structure contrary to $a$ dull one in the ergodic motion.

The largest (but again not the $m$ ost interesting) part of this structure is related to the distribution steep cut-o at sm all. . Com parison of the two distributions for dif-
ferent $m$ otion time $t=10^{4}$ and $10^{5}$ shows that the values of the trajectories in this region decrease with increasing tim $e$, approxim ately as $1=t$. $T$ his would $m$ ean that all these trajectories are regular (see Eq.(5.1)) because the tangent vector does not grow. The relative num ber of such trajectories gives the total area of regular m otion on system 's phase cylinder. In a particular exam ple under consideration it am ounts to $A_{\text {reg }}=3177=10000 \quad 0: 318\left(t=1 \delta^{5}\right)$. Generally, that value depends on a particular cut $\{0$ border from above chosen (see arrow in F ig.3). This delicate experim ental problem is considerably m itigated by a lucky feature of distribution in ourm odel, nam ely, a relatively w ide plateau ofF ( ) im m ediately above the cut\{o with only a few trajectories on it. H ow ever, the statistical accuracy

is typically much worse, and can be im proved by increasing the num ber of tra jectories (and the com putation tim e) only.

A nother interesting feature of distribution in our model is a characteristic "fork" shape of the cut $\{0$. This is a result of negative form any regular trajectories. Such a peculiar representation is obtained by ordering (t) valuesw ith their signsbut plotting out them odulij ( $t$ ) jonly. Thus, the low er prong of the fork corresponds to negative ( $t$ ) < 0 while on the upper one ( $($ ) $>0$ are positive. This is due to the complex\{conjugate Lyapunov exponents which results in a strictly bounded oscillation of the tangent vector ( dx ; dp) in this case. H ow ever, the area (5.4) A $0: 20<\mathrm{A}_{\text {reg }} \quad 0: 318$ is noticeably less than the total regular dom ains $A_{\text {reg }}$. The rest is lled w th the tra jectories which are also regular but linearly unstable. This $m$ eans the linear in tim e grow th of the tangent vector
( t ) $\quad \mathrm{t}$ so that ( t )! 0 rem ains positive but is vanishing in the lim it t ! 1 . This is the so \{called $m$ arginal local instability $w$ th both $\quad 0$ equal zero (for discussion see [1]9]1). A curious point is that this seem ingly exceptional case becom es the typical one in a nonlinear oscillator system due to the dependence of oscillation frequencies on the trajectory initial conditions. In fact, the bounded oscillation producing negative $(t)$ is the exceptional case instead. The origin of this peculiarity is in a piecew ise linear force in our $m$ odel (2 2). A s a result, the $m$ otion in the $m$ ain (and the biggest for large $K$ ) regular dom ain around xed point $x=1=2 ; p=0$ is plainly a harm onic oscillation $w$ ith the frequency ( $\mathrm{K}<\mathrm{d}$ )

Here $y=x \quad 0: 5=\quad \mathrm{d}=2$ is the position of two singularities of the force (see Eq. (2 2) and below ) which restrict the size of the regular dom ain surrounded by the lim iting ellipse to which both lines of singularity y $=d=2=0.25$ are tangent. This ellipse is determ ined

A ll the num erical values above correspond to $K=0: 45$ and $d=1=2$. W ithin the ellipse the $m$ otion of tangent vector obeys the sam e equation as the $m$ ain $m$ otion, the only di erence being an arbitrary length of the tangent vector (for details see ${ }_{\underline{W}}^{\mathbf{N}} \overline{\mathrm{l}}$ and references therein).

C om ing back to Fig. 3 notice the decrease of the $m$ easured area A with increasing $m$ otion time. This is explained by penetration of trajectories into a very com plicated criticalstructure at the chaos border surrounding each regular dom ain (for details see, e.g., [行]). For the sam e reason, the direct $m$ easurem ent of the whole regular region $A_{\text {reg }} \quad 0: 40$ by a single chaotic trajectory as long as $10^{9}$ iterations gives a notioeably larger value as com pared to $A_{\text {reg }} \quad 0: 318$ from $10^{6}$ trajectories for $10^{5}$ iterations each.

In all the curiosity of the ( $t$ ) distribution in regular com ponents of the $m$ otion our m ain interest in the present study is the interm ediate region between the regular cut\{ 0 at $m$ ost $s m$ all ( $t$ )! 0 and the chaotic step at maxim al independent of $t$. The distribution in this region also does not depend on $m$ otion time and characterizes the proper critical structure of the chaotic m otion. In an exam ple in Fig.3 this structure is presented by a relatively sm all probability step F 0:06 at 0:03. In the next Section a few other exam ples w ill be given too.
6. D i usion am id virtual invariant curves: the C ritical statistics

In Fig. 4 we present three characteristic exam ples of the e ect of the critical structure on the di usion statistics. The dashed curve show s the "unperturbed" distribution F (D) (4.1) of the nom alized di usion rate $D=D=D$ norm where the nom alizing rate $D$ norm to be chosen in each partioular case (see below). The term unperturbed $m$ eans here the ergodic case $\mathrm{d}=0 \mathrm{w}$ ithout any invariant curves and critical structure (Section 4, the problem of critical structure in this case is not as simple as it m ay sem, see below and Section 7). In this case the norm alizing rate $D_{\text {norm }}=D_{1}$ is the true asym ptotic di usion rate (4.5).

N ow we are interested in the e ect of the critical structure which typically arises in a nonergodic $m$ otion $w$ ith its barriers for the chaos, or chaos borders. The latter are particular, and very im portant, case of an invariant curve which is transform ed into itself under system 's dynam ics. A s was discussed already above (Section 1) there are several di erent types of invariant curves (IC s).

O ne is well studied and rather fam iliar chaos border surrounding any dom ain w ith regular $m$ otion. In this paper we call it the local invariant curve (LIC) which does not block the global di usion (GD) around such a dom ain. An im portant property of LIC is the robustness which $m$ eans that a $s m$ all change of the system, say, of a param eter $K$ or d cannot distroy the LIC but $m$ ay only deform it slightly. This im plies that LIC s are alw ays present in any divided phase space.

H ere we arem ainly interested in a di erent IC type, the globalinvariant curves (G IC s) . Each G IC cuts the whole phase\{space cylinder ( x m od 1) of our model, and thus com pletely prevents GD in p. Such IC s are less known, especially the most surprising of
them，the separatrix of a nonlinear resonance．H ow ever，those G IC ss are not robust in the $m$ odel under consideration（see $\left.\underline{Q}_{\underline{1}} \mathbf{1}\right]$ ），being destroyed by alm ost any arbitrarily sm all perturbation of the system，particularly by a change of even a single its param eter．In other words，such G IC s do exist for the special values，say，$K=K_{m}$ only．Even though there are typically in nitely $m$ any such special values the probability to nd a G IC in a random ly chosen system is zero．This is why we are interested in a m ore generic situation when our m odel has no G IC s at all．Yet，the e ect of those still persists in a certain dom ain around each $K_{m}$ ！For this reason we call such $G$ IC $s$ the virtual invariant curves （V IC s）in analogy w ith other virtual quantities in physics like，for exam ple，virtual en－ ergy levels in qantum m echanics．N otice that unlike a G IC the V IC is robust and，hence， generic．

B oth LIC s and G IC s produce the so \｛called critical structure of the m otion（see，e．g．， ［⿶凵⿱乛⿰㇒乛小一灬丶 ］）which is typically characterized by a power\｛ law distribution of principal quantities． The corresponding exponents $C_{4}$ are called the critical exponents．T heir values are show $n$ in $F$ ig． 4 at the related distributions．N otioe that the opposite is generally not true that is a particular power law does not necessarily indicates any critical structure．In our $m$ odel this is just the case for the ergodic $m$ otion where the di usion rate distribution is also characterized by an asym ptotic（D）！0）power law w ith exponent $c_{0}=0: 5$（see above and Section 7）．H ow ever，an im portant di erence betw een ergodic and nonergodic dynam ics is in that all criticalexponents in the latter case $\mathrm{c}_{\mathrm{h}}<\mathrm{c}_{0}$ are less than（generally noncritical）ergodic exponent $c_{0}$ ．This is the $m$ ain physical result of our prelim inary num erical experim ents we can present and discuss already right now（see Fig．4）．

Let us start w th the distribution for $K=0: 45$（upper solid line）which is far in the region w thout V IC s（the border of this region is at $K_{B}(d=1=2)=1=3$ ，see Eq．（2．3） above and $[1-1-1])$ ．H ow ever，the regular tra jectories（ $\left.A_{\text {reg }} 0: 318\right)$ together w ith LIC s and the related critical structure are present．A s a result the distribution（ $w$ ith $D_{\text {norm }}=D_{1}$ ） is well deviates from the unperturbed one for ergodic $m$ otion $w$ ith $d=0$ ．This type of the critical structure in a relatively narrow layer around a LIC is well studied by now（see， e．g．，［－$\left[\begin{array}{l}{[1]}\end{array}\right)$ including som e deviation of a typical distribution from a pure power law．The latter would $m$ ean the exact scale invariance of the underlaying critical structure in both the system phase space as well as its $m$ otion tim $e$ ．

The critical structure is described by the so \｛called renom alization group，or renorm－ group forbrevity．On the other hand，them otion equations for any dynam ical system also form a certain（dynam ical）group．Such a fundam ental sim ilarity allow s one to intenpret the critical structure as a certain dynam ics which was called the renorm dynam ics $\underline{\underline{2}} \underline{\underline{a}}, \underline{\prime}, \underline{4}]$ ． In this picture the exact scale invariance w ith a pure power\｛ law distribution corresponds to the sim plest，periodic，renom dynam ics even though the originaldynam ics $m$ ay be the m ost com plicated chaotic m otion．The resolution of this apparent paradox is in that the latter com plexity of the originaldynam ics is＂transferred＂to the dynam ical in nitely di－ $m$ ensional space of the renom dynam ics leaving behind the $m$ ost sim ple renorm dynam ics itself（som etim es ！）．

The latter lim it is m ost studied simply because it is the simplest one．H owever，


Particularly, this im plies a certain chaotic oscillation of the characteristic distribution around som e average power law. This is just the case for the upper distribution in $F$ ig. 4 under discussion. It is characterized by the average critical exponent $c_{1}=0: 3 \mathrm{w}$ ith uctuations ( $q \quad q$ ) $=0: 1$. Such an intenpretation of the critical structure in question is know $n$ to be typicalbut not necessarily unique (see below ). The really unique property of this critical structure is the in nite power law, w ith or w ithout the uctuations. The term "in nite" corresponds here to the range of a renorm dynam ical variable ln D ! 1 w ith unrestricted variation even though the di usion rate itselfD $>0$ is strictly bounded from below.
$T$ his is no longer the case for a new type ofcritical structure w hich we have encountered in our problem and which is produced by V IC s (= robust G IC s) rather than by the robust LIC s. A swas already explained above the principal di erence between the two is in that theV IC is not an invariant curve at all. In term sofrenorm dynam ics itm eansthat V IC can m im ic a G IC for relatively large in D only. This is clearly seen in Fig .4 in the upper part of the distribution w ith local critical exponent $C_{2}=0: 09$ and param eter $K=0: 335$ (points). H ere we have taken $\mathrm{D}_{\text {norm }}=10^{6}<\mathrm{D}_{1} \quad 2 \quad 10^{5} \mathrm{~m}$ uch sm aller than the true di usion rate $D_{1}$. This shifts the whole distribution to the right to avoid the overlapping $w$ ith other distributions. $T$ his value is slightly above the border $K_{B}(1=2)=1=3$ (see Eq.(2.3)) where there is a lot of V IC s w ithout any G IC. As a result the range of characteristic critical exponent $c_{2}$ is very short: $\ln D \quad 5$ as com pared w th the totalavailable range
25. The rest of the distribution rem ains fairly close to the unperturbed one. This would $m$ ean the absence of the critical structute over there or, at least, its sharp change at $\ln D<2$. In case of the form er intenpretation the renorm $m$ otion stops in the latter region.
In tum, this would im ply a "dissipative" rather than "H am iltonian" renorm dynam ics. N otice that the m ain part of the distribution is close but not identical to the unperturbed one inchuding a slight di erence in the characteristic exponent. D oes it m eans a certain very slow renorm $m$ otion rem ains a very interesting open question yet to be studied. Interestingly, the larger critical exponent $c_{2}^{0}=0: 45$ is also close to the local critical exponent $c_{1}^{0}=0: 4$ in the region $w$ thout V IC s or G IC s and was intenpreted above as a random uctuation in the renom chaos. Is it really true still rem ains unclear.

Finally, the third distribution in Fig. 4 (lower solid line) is actually coincides with the unperturbed distribution ( $\mathrm{D}_{\text {norm }} \quad \mathrm{D}_{1}$ ) even though it corresponds to the region w ith $m$ any V IC s and strong suppression of the di usion ( $K=0: 3294$, see $F$ ig 3 in (1-1). A deviation for very sm all D is due to a poor statistics at this end. N otioe that the coincidence of both distributions is not only asym potic ( $F$ ! 0) but com plete, including the opposite lim it $F$ ! 1. A nd this is in spite of a rather large regular region $A_{\text {reg }} \quad 0: 581$. $T$ he origin of this peculiarity for a particular $K$ value rem ains unclear. O ne possibility is that, for som e reasons, the area of the critical structure at the chaos border around this regular dom ain is unusually sm all. Exam ples of such a peculiarity in di erent m odels are known (see $[\underline{2} 2 \bar{i}])$. A ctually, in the latter work the critical structure was found to be unusually large but hidden. In other words, the $m$ otion was ergodic but $w$ th strong correlations (cf. the unusual di usion rate (2.8) for $K \quad 1$ in ergodic system at $d=0$ ).

C om ing back to this case in F ig. 4 we can conclude that our "unperturbed" power\{ law distribution $w$ th exponent $c_{0}=1=2$ (dashed line) $m$ ay well represent a peculiar critical structure related to the strong hidden tem poralcorrelations rather than to a purely spatial geom etry of the phase space. If this is true, indeed, the correlation decay $m$ ay wellbe not a power\{law one at all as is the case in $m$ odel [2̄2̄in] where such a hidden decay is purely exponential (se Fig. 6 over there).

At last, let usmention another peculiarity of the critical structure in question: all the critical exponents found so far are less, if only a little, than "unperturbed" or "hidden" one $c_{0}=1=2$. The physical $m$ eaning of this universal inequality is in that the critical structure under consideration does alw ays increase the probability of very low di usion rate $D!0$. The generalmechanism of this is known (see, e.g., tī] ), and is explained by the "sticking" of a tra jectory w ithin a com plicated critical structure which slow s down the di usion. Interestingly, that the sign of the stidking e ect $m$ ay be opposite when the sticking accelerates the di usion up to the absolute maxim um $D(t) / t$ of hom ogeneous


To sum $m$ arize, we see that our "sim ple" $m$ odel in the present paper really reveals a great variety of critical structure still to be farther studied and understood.
7. C onclusion: A hidden critical structure ?

In this paper we present som e prelm inary results of the num erical experim ents $w$ ith a fam ily of simple m odels speci ed by the $s m$ ooth canonical 2D map (2.1) w th global virtual invariant curves (V IC s). As in our previous paper tī] we make use here of the sam e strongly chaoticm odel, and focus again on the statistics of the di usion rateD which proves to be of a very com plicated (apparently fractal) type determ ined by the so \{called critical structure ofboth the phase space and them otion (see, e.g., [4] ] . In previous paper [ of trajectories $w$ th random initial conditions. O urm ain result there was observation of very big and irregular uctuations of the dependence $<\mathrm{D}(\mathrm{K})\rangle$, and a long and very slow ly decaying tail of $<\mathrm{D}>$ distribution for $<\mathrm{D}>$ ! 0 . W e term ed the latter e ect the V IC di usion suppression.

In the present paper we continue studying this interesting phenom enon in $m$ ore details. To this end we tum from the statistics of averages < $D(K)>$ as a function of $m$ odel param eter $K$ to that of individual trajectories for a given K. In principle, such an approach provides the $m$ ost deep insight into a statistical problem. As the $m$ ain statistical characteristic we have chosen the integral distribution F (D) in the form (4.1) for a poor statistics at $D!0$. Prelm inary results of our extensive num erical experim ents presented in Fig. 4 con m , indeed, our earlier con jecture on a critical structure underlaying the fractal dependence $<\mathrm{D}(\mathbb{K})>$ in $[1-1 \overline{1} 1 \mathrm{l}$, the true sign of such a structure being various pow er\{ law distributions found. M oreover, besides the fam iliar well known critical structure exem pli ed in $F$ ig. 4 by the case w ith param eter $K=0: 45$ we did observe $m$ any cases of a rather di erent structure as one $w$ ith $K=0: 335$. The principal di erence of the latter is its nite size in the structure variable $\ln D<5$. The natural explanation of this di erence is the follow ing. First of all, the V IC is not a true invariant curve like G IC .

T he latter com pletely blocks the G D while the form er can, at m ost, inhibit the di usion only. Them echanism of inhibition is known to be the sticking of a tra jectory inside a very com plicated critical structure. In tum, the sticking is the stronger (longer) the sm aller is the spatial and/or the longer is the tem poral scale of the critical structure. But for the V IC structure both are strictly restricted. On the other hand, such a restriction is the weaker the higher is the V IC density. In the system under consideration the latter is rather large, and hence the restriction leaves enough freedom for a strong suppression of GD for alm ost any K. M oreover, since the critical exponent of the V IC structure is typically very sm all (for exam ple $\mathrm{c}_{2}=0: 09$ in F ig.4) the probability of large suppression is high even for a short critical structure (cf. 㛚] for a di erent characteristic of this phenom enon). This slow decaying suppression probability is well ascertained in our num erics but we have not, as yet, any theoretical explanation of such a behavior.

Now we com e, perhaps, to the most interesting result of our current studies. H ow strange it m ay seem, this brings us to the apparently sim plest case of our $m$ odel $w$ ith $\mathrm{d}=0$ when the m otion is ergodic. C an it still reveal any structure on the grounds that the distribution $F(D)$ is also a power law (Fig.4)? That is the question! Certainly, it is not the case if, in addition, param eter K 1 is big, and the di usion rate has the standard form (2.11): D / K ${ }^{2}$. But what if $\mathrm{K} \quad 1$ is sm all? At least, the di usion rate becom es qualitatively di erent: D / K ${ }^{5=2}$. W hat does it m ean? G enerally, nothing! But in a particular case under consideration such dependence $D(K)$ can be, and actually was, derived [ī $\overline{1}-1$ from the resonance structure of the $m$ otion. If the system were not ergodic (w ith divided phase space) this structure would be clearly seen in the phase space. T he question is what happens for ergodic $m$ otion $w$ th the sam e dependence $D(K)$ ? In [ī $\overline{1}]$ we conjectured that som e structure would still persist in the form of the correlations which determ ine the di usion rate that is in some "hidden" form unseen directly in the picture of the $m$ otion in phase space. An exam ple of such hidden critical structure
 function was exponential rather than a power\{ law one (?). Hence, the question is if this qualitative di erence could depend on a particular characteristic of the critical structure? Still another question arises from a very strange tem poral behavior of the di usion rate in the sam e "sim ple" case of ergodic $m$ otion for $d=0$. W e m ean a "m ysterious" plateau at the very beginning of di usion under a weak perturbation ( $K$ 1, see Fig.1). In this case the dependence $D(K)=K^{2}=3$ is the same as in the opposite lim it of strong ( $K$ 1) uncorrelated perturbation (?) but for a very short tim e only, the shorter the stronger is the perturbation (?!). M oreover, the correlations on the plateau are not only very large as in the weak \{perturbation lim it K ! 0 but even increasing during the whole plateau regim e ( $e \mathrm{~F}$ ig.1, dashed lines for variances $\mathrm{V}_{\mathrm{M}}$ () (32)). As yet, we have no de nite explanation for such a controversial behavior. A discreet current conjecture is the follow ing. The duration of plateau is pl 1 , or $\xi_{1} \quad 1=1=$ (see Eq.(2.9)). But the latter expression gives the period of phase oscillation on the critical nonlinear resonance which determ ines the di usion rate does characterize not only the correlation decay, as usual, but also the correlation uprise. Still, the invariable di usion rate over the whole plateau region is to be explained yet.

In any event, we are very curious to continue these $m$ ost interesting studies!
