# Lax pair form ulation of the $N=4$ Toda chain ( $\mathrm{K} d V$ ) hierarchy in $N=4$ superspace

#### Abstract

Lax pair and H am iltonian form ulations of the $\mathrm{N}=4$ supersym metric Toda chain ( K dV) hierarchy in $N=4$ superspace are proposed. The general form ulae for the in nite tow er of its bosonic ows in term sof the Lax operator in $\mathrm{N}=4$ superspace are derived. A new $\mathrm{N}=4$ super eld basis in which the ow s are local is constructed and its embedding in the $\mathrm{N}=4$ O (4) superconform al supercurrent is established. A proof that the ows possess ve com plex conjugations and an in nite-dim ensional group of discrete sym $m$ etries in $N=4$ superspace is presented. A relation between the two descriptions of the hierarchy in $N=4$ superspace used in the literature is established. All know $\mathrm{N}=2$ super eld representations of the $\mathrm{N}=4 \mathrm{~K} d V$ hierarchy are show $n$ to derive from our $N=4$ superspace Lax representation.

## 1 Introduction

Recently, the Lax pair representation of the $N=4$ supersym $m$ etric Toda chain hierarchy in $\mathrm{N}=2$ superspace has been constructed in 17]. The explicit relationship betw een the $\mathrm{N}=4$ supersym $m$ etric Toda chain and KdV [2, [3] hierarchies has been established in [4], and due to this reason we call both these hierarchies the $N=4$ Toda chain ( $K$ dV) hierarchy. A s a byproduct, the relationship, established in $[3]$, induces a new Lax pair representation of the $\mathrm{N}=4 \mathrm{KdV}$ herarchy in $\mathrm{N}=2$ superspace. So together w ith the form er Lax pair in $\mathrm{N}=2$ superspace derived in [5], []], two Lax pair representations of the $N=4$ Toda ( $K$ dV ) hierarchy in $N=2$ superspace are now known. H ow ever, although the rst few ow sof the hierardhy are known both in harm onic [ ${ }^{3}$ ] and ordinary $\mathrm{N}=4$ superspace $[$, [4], a Lax pair form ulation in $\mathrm{N}=4$ superspace is still unknow n . M oreover, even a relation (if any) between the two di erent descriptions of the ow $\sin \mathrm{N}=4$ superspace used in 3] and [7] is not established yet.

The present paper addresses both above-stated problem s. Thus, we propose a Lax pair and a H am ittonian form ulation of the $\mathrm{N}=4 \mathrm{Toda}(\mathrm{K} \mathrm{dV}$ ) hierarchy in $\mathrm{N}=4$ superspace and establish a simple relation between the two above-m entioned descriptions of the hierarchy in $\mathrm{N}=4$ superspace. W e derive general form ulae for its bosonic $\mathrm{N}=4$ ow s in term s of the Lax operator in $N=4$ superspace and construct an $N=4$ super eld basis in which they are local. M oreover, we show how to embed this super eld basis into the $N=40$ (4) superconform al supercurrent. $W$ e also present a proof that all these ow s possess both an in nite-dim ensional group of discrete D arboux transform ations [1, [, [, 4] and ve com plex conjugations in $N=4$ superspace.

## 2 Lax pair form ulation of the $\mathrm{N}=4$ Toda ( $\mathrm{K} d V$ ) hierarchy in $N=4$ superspace

O ur starting point is a $m$ anifestly $N=2$ supersym $m$ etric Lax pair representation of even ow $s$ of the $\mathrm{N}=4$ Toda chain (K dV) hierarchy [1]

W e would like to write the ows in $N=4$ superspace. We introduce two additional odd coordinates and the $\mathrm{N}=4$ odd covariant derivatives

O ur claim is that if one replaces the $N=2$ super elds $J$ and $\bar{J}$ in this basis by one chiral

then the Lax pair representation (2) with the new $N=4$ Lax operator $L_{1}$,

gives consistent $\left.H^{3}\right] \mathrm{N}=4$ supersym metric ows $\frac{@}{@ t_{1}}$. In order to prove this claim it is enough to show that the ow equations (3), being rew rilten in the basis (5), are consistent w ith the chirality constraints (8). W e present the proof in a few steps in what follows.

First, let us simplify the Lax operator $L_{1}$ ( 9 ) by applying a gauge transform ation and requiring that the gauge transform ed Lax operator

but the square of the operator $N$ does not equal zero as $M$ does, see equation 23). Perhaps one can m odify the operator $N$ to satisfy this property, but we did not succeed in that.

Third, on the basis of the properties of the Lax operator $\mathcal{E}_{1}^{T}$ discussed in the previous paragraph, we are ready to prove the follow ing three identities:

A s concems the rem aining relation (34), it can easily be derived from the relation (33) if the substitution (25) is applied to it and then the identity (29) is used. A ltematively, it can be obtained starting from the identities

Second, the operator $\mathrm{E}_{1}^{\mathrm{T}}$ comm utes w th $\overline{\mathrm{D}}^{+}$. This presentation $w$ ill be useful when we w ill study an altemative Lax pair construction in section 6 .

The rst term in the right-hand side of equation 65) is local because of locality of the Lax operator $L_{1}^{T}$ (64) w ith respect to the super elds and . So, nonlocality could only com e from the second term, due to nonlocality of (64). H ow ever, this term is actually a polynom ial in derivatives of , which are local due to the chirality properties (63) of the super elds and - T herefore, all potential nonlocalities in fact disappear. T he sam e argum ent is valid w ith respect to each basis from the set 61 (63).

As an exam ple, we would like to explicitly present a few rst nontrivialm anifestly $N=4$ supersym $m$ etric ow s resulting from equations 35) and (61),

N ow, we would like to discuss the H am iltonian structure of the $\mathrm{N}=4$ Toda ( K dV) hierarchy in $N=4$ superspace. Let us present rst the general form ulae for the conserved quantities (H am iltonians) $\mathrm{H}_{1}^{\mathrm{t}}$ of the $\mathrm{N}=4$ ows (35) and 60(63) in $\mathrm{N}=4$ superspace,

Each of them satis es the constraints (87) and, as a consequence, possesses only 8 independent super eld components. The degenerate $m$ apping to (97) gives the precise relationship between the Poisson structures (93) and 95). The central charge of the $N=4$ SU (2) SC subalgebra of the $N=4 O$ (4) SCA is $c=c_{1}+c_{2}$. The super eld relationship 97) between the $\mathrm{N}=4$ superconform alSU (2) and O (4) algebras could give a bridge tow ards the resolution of the longstanding problem of constructing an $N=40$ (4) $\mathrm{K} d V$ hierarchy (if any), but this problem is out of the scope of the present paper and willbe considered elsew ere.

## $4 \quad R$ eal form $s$ and discrete sym $m$ etries of the $N=4$ Toda (K dV ) hierarchy in $\mathrm{N}=4$ superspace

It is well known that di erent real form s derived from the sam e com plex integrable hierarchy are nonequivalent in general. $K$ eeping this in $m$ ind it seem $s$ im portant to nd as $m$ any di erent real form s of the $N=4$ Toda ( K dV ) hierarchy as possible. $T$ his task was already analysed in [6, 4] at the level of the second and third ow s of the hierarchy in the realn $=2$ superspace,

[^3]and three nonequivalent com plex conjugations were constructed for these ow s. N onequivalent here $m$ eans that it is not possible to relate any two of them via obvious sym m etries. N ow, based on the results of the previous sections we are able to extend these com plex conjugations to $N=4$ superspace and prove that all the ows $\frac{\mathrm{C}}{\mathrm{Ct}}$ of the hierarchy in $\mathrm{N}=4$ superspace are invariant under any of these com plex con jugations.

W e w ill use the standard convention regarding com plex conjugation of products involving odd operators and functions (see, e.g., the books [12, 13]). In particular, if O is som e even di erentialoperator acting on a super eld $F$, we de ne the com plex conjugate ofo by ( OF ) = O F .

Therefore, we are led to the conclusion that the second ow equations (66) unify the three particular "SU (2) fram es" ofthe $\mathrm{N}=4 \mathrm{~K} d V$ hierarchy in $\mathrm{N}=2$ superspace (com pare equations (112) and (118) w ith equations (4.5) and (4.3a,b,c) from [1]). The sam e property is certainly valid for any other ow of the $\mathrm{N}=4 \mathrm{Toda}(\mathrm{KdV})$ hierarchy in the $\mathrm{N}=4$ superspace.

It is interesting to rem ark that if one introduces an auxiliary $N=4$ super eld $V^{12}$ as

## 6 A lternative Lax pair construction in $N=4$ superspace

The results of the previous sections can be used as inputs for an altemative, heuristic construction of a Lax pair representation of the $N=4$ Toda ( $\mathrm{K} d V$ ) hierarchy in $N=4$ superspace. Indeed, let us rem ember that there exist another Lax pair form ulation of the $\mathrm{N}=4 \mathrm{KdV}$ hierarchy in the $N=2$ super eld basis (a) $f \forall\left(z ;^{+}{ }^{+}{ }^{+}\right) ; F\left(z ;{ }^{+} ;{ }^{+}\right) ; \bar{F}\left(z ;{ }^{+} ;^{+}\right) g$ with the second ow equations [112) 5, [6]. Therefore, we conclude that the $\mathrm{N}=4$ super eld equations (66) and 133) are the second ow equations of the sam e $N=4$ supersym $m$ etric Toda ( $K$ dV) hierarchy written in two di erent $\mathrm{N}=4$ super eld bases, $\mathrm{fJ} ; \overline{\mathrm{J}} ; \mathrm{D} ; \overline{\mathrm{D}} \mathrm{g}$ and $\mathrm{fV} ; \overline{\mathrm{V}} ; \mathrm{D} ; \overline{\mathrm{D}} \mathrm{g}$, respectively. ## 7 C onclusion

In this paper, we have developed a consistent Lax pair form ulation of the $\mathrm{N}=4$ supersym m etric Toda chain (K dV ) hierarchy in $N=4$ superspace. The explicit general form ulae (35) for its bosonic ows in term sof the Lax operator in $\mathrm{N}=4$ superspace have been derived. Then, a change ofbasis in $\mathrm{N}=4$ superspace has allow ed us to elim inate allnonlocalities in the ow s60 $\{$ 63). W e have also explicitly presented the general form ula for the corresponding H am iltonians (79), the rst two Ham iltonian structures (78(79) as well as the recursion operator (82-84) in $\mathrm{N}=4$ superspace. Then, we have simpli ed these form ulae by rew riting them in term s of the single real linear $N=4$ super eld 92,94) whose ows are local. Furthem ore, we have established its relationship (97) to the $N=40$ (4) superconform al supercurrent which hopefiully could shed light on the longstanding problem of constructing the $\mathrm{N}=4 \mathrm{O}$ (4) K dV hierarchy. Then, we have shown that all these ow s possess ve com plex conjugations (98) (100) and 107 (109) as well as an in nite-dim ensional group of discrete D arboux sym m etries (104). Finally, the explicit form ulae $121 ;(122)$ and $138\{139)$ relating the two di erent descriptions of the ow s in $\mathrm{N}=4$ superspace used in [3] and [] have established. It is obvious that there rem ain a lot of work to do in order to im prove our understanding of the hierarchy in $\mathrm{N}=4$ superspace, but the construction of the $N=4$ Lax pair form ulation presented in this paper is a crucial, necessary step tow ards a com plete description.
