Lax pair form ulation of the N=4 Toda chain (K dV) hierarchy in N=4 superspace

A bstract

Lax pair and Ham iltonian formulations of the N = 4 supersymmetric Toda chain (KdV) hierarchy in N = 4 superspace are proposed. The general formulae for the in nite tower of its bosonic ows in terms of the Lax operator in N = 4 superspace are derived. A new N = 4 super eld basis in which the ows are local is constructed and its embedding in the N = 4 0 (4) superconformal supercurrent is established. A proof that the ows possess we complex conjugations and an in nite-dimensional group of discrete symmetries in N = 4 superspace is presented. A relation between the two descriptions of the hierarchy in N = 4 superspace used in the literature is established. All known N = 2 super eld representations of the N = 4 KdV hierarchy are shown to derive from our N = 4 superspace Lax representation.

1 Introduction

Recently, the Lax pair representation of the N=4 supersymmetric Toda chain hierarchy in N=2 superspace has been constructed in [1]. The explicit relationship between the N=4 supersymmetric Toda chain and K dV [2, 3] hierarchies has been established in [4], and due to this reason we call both these hierarchies the N=4 Toda chain (K dV) hierarchy. As a byproduct, the relationship, established in [4], induces a new Lax pair representation of the N=4 K dV hierarchy in N=2 superspace. So together with the former Lax pair in N=2 superspace derived in [5, 6], two Lax pair representations of the N=4 Toda (K dV) hierarchy in N=2 superspace are now known. However, although the rst few ows of the hierarchy are known both in harmonic [2] and ordinary N=4 superspace [3, 4], a Lax pair formulation in N=4 superspace is still unknown. Moreover, even a relation (if any) between the two dierent descriptions of the ows in N=4 superspace used in [3] and [4] is not established yet.

The present paper addresses both above-stated problem s. Thus, we propose a Lax pair and a Ham iltonian formulation of the N = 4 Toda (K dV) hierarchy in N = 4 superspace and establish a simple relation between the two above-mentioned descriptions of the hierarchy in N = 4 superspace. We derive general formulae for its bosonic N = 4 ows in terms of the Lax operator in N = 4 superspace and construct an N = 4 super eld basis in which they are local. Moreover, we show how to embed this super eld basis into the N = 4 O (4) superconformal supercurrent. We also present a proof that all these owspossess both an in nite-dimensional group of discrete D arboux transformations [7, 8, 1, 4] and vecomplex conjugations in N = 4 superspace.

2 Lax pair form ulation of the N=4 Toda (K dV) hierarchy in N=4 superspace

Our starting point is a manifestly N = 2 supersymmetric Lax pair representation of even ows of the N = 4 Toda chain (K dV) hierarchy [1]

where the subscript 0 denotes the di erential part of the operator and L^T is the operator conjugated Lax operator. The functions v $v(z; ^+;)$ and u $u(z; ^+;)$ are N = 2 super elds, and D are ferm ionic covariant derivatives?

It is instructive to rewrite the Lax operator (1) in another super eld basis [4]

where J J(z; $^+$;) and \overline{J} \overline{J} (z; $^+$;) are unconstrained even N = 2 super elds. It becomes

We would like to write the ows in N=4 superspace. We introduce two additional odd coordinates and the N=4 odd covariant derivatives

Our claim is that if one replaces the N=2 super elds J and \overline{J} in this basis by one chiral J (z; +; ; +;) and one antichiral \overline{J} (z; +; ; +;) even N=4 super eld,

then the Lax pair representation (2) with the new N = 4 Lax operator L_1 ,

gives consistent³ N = 4 supersymmetric ows $\frac{e}{et_1}$. In order to prove this claim it is enough to show that the ow equations (3), being rewritten in the basis (5), are consistent with the chirality constraints (8). We present the proof in a few steps in what follows.

First, let us $\sin p$ lify the Lax operator L_1 (9) by applying a gauge transform ation and requiring that the gauge transform ed Lax operator

respectively, where the subscripts 1 and 0 denote the differential part of the operator without the nonderivative term and the nonderivative term, respectively. A first substituting $\frac{\theta}{\theta t_1}$ from equations (15) into (14), the Lax equations become

The transposed Lax operator \hat{E}_1^T (19) entering into the Lax pair representation (18) possesses the following important properties:

which can be derived by rewriting the corresponding formulae of [1] into the super eld basis (5).

Second, let us discuss som e properties of the Lax operator $\mathbb{A}_1^{\mathbb{T}}$ (19) which will be useful in what follows. It can be represented as a sum of two operators M and \overline{M} ,

but the square of the operator N does not equal zero as M does, see equation (23). Perhaps one can M does, the operator M to satisfy this property, but we did not succeed in that.

Third, on the basis of the properties of the Lax operator \mathbb{A}_1^T discussed in the previous paragraph, we are ready to prove the following three identities:

respectively, where the subscript 1 denotes the coe cient of the inverse derivative D $_{+}^{1}$ of a pseudodi erential operator. Now, the quantity $(E_{1}^{T})^{21}$ being substituted from equation (37) into equations (38{39}) just leads to the relations (32{33}). As concerns the remaining relation (34), it can easily be derived from the relation (33) if the substitution (25) is applied to it and then the identity (29) is used. A Itematively, it can be obtained starting from the identities

Then we substitute the quantity $(D_+ + \overline{D}^+)^{-1} \hat{E}_1 (D_+ + \overline{D}^+)^{-21}$ from (42) into (43),

One important remark is in order. The general resolution of the identities (33{34}) and (29) leads to the following general representation for the quantity $(\hat{E}_1^T)^{21}$:

where X $_1$ and Y $_1$ are N = 4 unconstrained nonlocal functionals of the basic super elds. A ctually, the functionals X $_1$ and Y $_1$ are ambiguously de ned because both of them are acted upon by the projectors D $_1$ D and $\overline{D}^+\overline{D}^-$, which can be expressed via the operator D $\overline{D}^ \overline{D}^+$ D $_1$ as

As a next remark, let us show that one can give two dierent presentations of the ows (18) in N=4 superspace which are reminiscent of the formalisms used in [3] and in [17, 18] in the N=2 supersymmetric case. First, multiplying the Lax pair representation (18) on both sides by the projector \overline{D}^+D_+ @ 1, it becomes

and the subscript + denotes the part of the operator L^{21} which can be represented in the form \overline{D}^+ O D $_+$, where O is a di erential operator [5]. In order to show that the lows (48) coincide with those in (18), one has to make use of two properties of the operator \widehat{E}_1^T . First, its even powers are pseudo-di erential operators containing powers of the derivative $D_+ = \overline{D}^+ + D_+$ only. Second, the operator \widehat{E}_1^T commutes with \overline{D}^+ . This presentation will be useful when we will study an alternative Lax pair construction in section 6.

As a second, distinct presentation of the ows (18), let us introduce the operator

Then, in the spirit of references [17, 18], we consider the ow equations

which do not have the Lax form. However, it is a matter of simple calculations to show that, as a consequence of (56), the operator L_1 satisfies the Lax equations (18). Let us note that, by considering a differential operator L of higher order, one may hope to generalize the N=4 hierarchy considered in this article.

The N = 4 Toda (KdV) hierarchy ows (35) in the N = 4 super eld basis fJ; \overline{J} g are nonlocal because of the nonlocal dependence of the Lax operator \widehat{E}_1^T (19) on the super elds J and \overline{J} . Nevertheless, it is possible to obtain local ows by introducing a new super eld basis f; \overline{g} de ned by the following invertible transform ations:

where and are new constrained odd N = 4 super elds

The rst term in the right-hand side of equation (65) is local because of locality of the Lax operator L_1^T (64) with respect to the super elds and . Each of them satis es the constraints (87) and, as a consequence, possesses only 8 independent super eld components. The degenerate mapping to (97) gives the precise relationship between the Poisson structures (93) and (95). The central charge of the N = 4 SU (2) SC subalgebra of the N = 4 O (4) SCA is $c = c_1 + c_2$. The super eld relationship (97) between the N = 4 superconform al SU (2) and O (4) algebras could give a bridge towards the resolution of the longstanding problem of constructing an N = 4 O (4) K dV hierarchy (if any), but this problem is out of the scope of the present paper and will be considered elsewere.

4 Real form s and discrete sym m etries of the N=4 Toda (K dV) hierarchy in N=4 superspace

It is well known that dierent real forms derived from the same complex integrable hierarchy are nonequivalent in general. Keeping this in m ind it seems important to nd as many dierent real forms of the N = 4 Toda (KdV) hierarchy as possible. This task was already analysed in [6, 4] at the level of the second and third ows of the hierarchy in the real N = 2 superspace,

and three nonequivalent complex conjugations were constructed for these ows. Nonequivalent here means that it is not possible to relate any two of them via obvious symmetries. Now, based on the results of the previous sections we are able to extend these complex conjugations to N = 4 superspace and prove that all the ows $\frac{\theta}{\theta t_1}$ of the hierarchy in N = 4 superspace are invariant under any of these complex conjugations.

We will use the standard convention regarding complex conjugation of products involving odd operators and functions (see, e.g., the books [12, 13]). In particular, if 0 is some even dierential operator acting on a supereld F, we dene the complex conjugate of 0 by (0 F) = 0 F.

Therefore, we are led to the conclusion that the second ow equations (66) unify the three particular "SU (2) fram es" of the N = 4 K dV hierarchy in N = 2 superspace (com pare equations (112) and (118) with equations (4.5) and (4.3a,b,c) from [3]). The same property is certainly valid for any other ow of the N = 4 Toda (K dV) hierarchy in the N = 4 superspace.

It is interesting to rem ark that if one introduces an auxiliary N = 4 super eld V 12 as

where the indices i; j; k are raised and lowered by the antisymmetric tensors ij and $_{ij}$, respectively, ($^{ij}_{jk} = ^{i}_{k}$, $_{12} = ^{12} = 1$) and (ijk) means symmetrization. The SU (2) spin 1 N = 4 supercurrent V $^{ij} = V$ ji was initially introduced in [2, 3] for the description of the N = 4 K dV equation. Thus, formulae (121{122}) establish the precise correspondence with [2, 3]. Using this correspondence, one can calculate, e.g. the matrices a^{ij} from [3],

which correspond to (112) and (118), respectively, as well as establish the one{to{one correspondence of the second Ham iltonian structure J_2 (79) with the N = 4 superspace form of the N = 4 SU (2) superconform alalgebra used in [3].

6 A lternative Lax pair construction in N = 4 superspace

The results of the previous sections can be used as inputs for an alternative, heuristic construction of a Lax pair representation of the N = 4 Toda (K dV) hierarchy in N = 4 superspace. Indeed, let us remember that there exist another Lax pair formulation of the N = 4 K dV hierarchy in the N = 2 super eld basis (a) $f\nabla(z; +; +)$; F(z; +; +); F(z; +; +) g with the second ow equations (112) [5, 6]. The corresponding Lax operator L is

Let us analyze these equations in the sam e way as it has been done in the previous section. We introduce the N = 2 super eld basis f (z; +;); (z; +;); (z; +;)g

Therefore, we conclude that the N=4 super eld equations (66) and (133) are the second ow equations of the same N=4 supersymmetric Toda (K dV) hierarchy written in two dierent N=4 super eld bases, fJ; \overline{J} ; \overline{D} g and fV; \overline{V} ; \overline{D} g, respectively. The explicit relation between these two bases is the following:

Actually, the Lax pair representation (130{131) is a direct consequence of the Lax pair representation (48{49}). In order to show this, one can set express the Lax operator L_1 (131) in terms of the super elds J and \overline{J} using equations (136), then verify that it is the square of the Lax operator L (49),

7 Conclusion

In this paper, we have developed a consistent Lax pair form ulation of the N = 4 supersym m etric Toda chain (K dV) hierarchy in N = 4 superspace. The explicit general formulae (35) for its bosonic ows in terms of the Lax operator in N = 4 superspace have been derived. Then, a change of basis in N = 4 superspace has allowed us to elim in at eall non localities in the ows (60) 63). We have also explicitly presented the general formula for the corresponding Hamiltonians (70), the rst two Ham iltonian structures (78{79}) as well as the recursion operator (82-84) in N = 4 superspace. Then, we have simplied these formulae by rewriting them in terms of the single real linear N = 4 super eld (92{94) whose ows are local. Furthermore, we have established its relationship (97) to the N = 40 (4) superconform all supercurrent which hopefully could shed light on the longstanding problem of constructing the N = 4 O (4) K dVhierarchy. Then, we have shown that all these owspossess ve complex conjugations (98{100) and (107{108) as well as an in nite-dimensional group of discrete Darboux symmetries (104). Finally, the explicit formulae (121{122}) and (138{139}) relating the two dierent descriptions of the ows in N = 4 superspace used in [3] and [4] have established. It is obvious that there remain a lot of work to do in order to improve our understanding of the hierarchy in N = 4superspace, but the construction of the N = 4 Lax pair formulation presented in this paper is a crucial, necessary step towards a complete description.
