A theory of clustering of inertial particles advected by a turbulent velocity eld caused by an instability of their spatial distribution is suggested. The reason for the clustering instability is a com bined e ect of the particles inertia and a nite correlation time of the velocity eld. The crucial param eter for the clustering instability is a size of the particles. The critical size is estimated for a strong clustering (with a nite fraction of particles in clusters) associated with the growth of the mean absolute value of the particles number density and for a weak clustering associated with the growth of the second and higher moments. A new concept of compressibility of the turbulent di usion tensor caused by a nite correlation time of an incompressible velocity eld is introduced. In this model of the velocity eld, the eld of Lagrangian trajectories is not divergence-free. A m echanism of saturation of the clustering instability associated with the particles collisions in the clusters is suggested. A pplications of the analyzed e ects to the dynamics of droplets in the turbulent atm osphere are discussed. An estimated nonlinear level of the saturation of the droplets number density in clouds exceeds by the orders of magnitude their mean number density. The critical size of cloud droplets required for clusters form ation is more than 20 m.

I. INTRODUCTION

Form ation and evolution of aerosols and droplets inhom ogeneities (clusters) are of fundam ental signi cance in many areas of environmental sciences, physics of the atm osphere and meteorology (e.g., sm og and fog formation, rain formation), transport and mixing in industrial turbulent ows (like spray drying, pulverizedcoal-red furnaces, cyclone dust separation, abrasive water-jet cutting) and in turbulent combustion (see, e.g., [1, 2, 3, 4, 5, 6, 7, 8]). The reason is that the direct, hydrodynam ic, di usional and them al interactions of particles in dense clusters strongly a ect the character of the involved phenomena. Thus, e.g., enhanced binary collisions between cloud droplets in dense clusters can cause fast broadening of droplet size spectrum and rain formation (see, e.g., [8]). A nother example is combustion of pulverized coalor sprays whereby reaction rate of a single particle or a droplet di ers considerably from a reaction rate of a coal particle or a drop let in a cluster (see, e.g., [9, 10]).

A nalysis of experim ental data shows that spatial distributions of droplets in clouds are strongly inhom ogeneous

(see, e.g., [11, 12, 13, 14]). Small-scale inhomogeneities in particles distribution were observed also in laboratory turbulent ows [15, 16, 17, 18].

It is well-known that turbulence results in a relaxation of inhom ogeneities of concentration due to turbulent diffusion, whereas the opposite process, e.g., a preferential concentration (clustering) of droplets and particles in turbulent uid ow still remains poorly understood.

In this paper we suggest a theory of clustering of particles and drop lets in turbulent ows. The clusters of particles are formed due to an instability of their spatial distribution suggested in Ref. [19] and caused by a combined e ect of a particle inertia and a nite velocity correlation time. Particles inside turbulent eddies are carried out to the boundary regions between them by inertial forces. This mechanism of the preferential concentration acts in all scales of turbulence, increasing toward small scales. An opposite process, a relaxation of clusters is caused by a scale-dependent turbulent di usion. The turbulent diffusion decreases towards to smaller scales. Therefore, the clustering instability dom inates in the Kolmogorov inner scale, which separates inertial and viscous scales. Exponential growth of the number of particles in the clusters is saturated by their collisions.

In our previous study [19] we suggested and analyzed qualitatively an idea that inertia of particles may lead to their clustering. Later this idea was questioned by our quantitative analysis [20, 21] of the K raichnan model of turbulent advection of particles by the delta-correlated in time random velocity eld. It was proved that the clustering of inertial particles does not occur in the K raichnan model. The latter result may be considered as counterexam ple.

The main quantitative result of the theory of clustering instability of inertial particles, suggested in this paper, is the existence of this instability under some conditions that we determ ined. We showed that the inertia of the particles is only one of the necessary conditions for particles clustering in turbulent ow. In the present study we found a second necessary condition for the clustering instability: a nite correlation time of the uid velocity eld which in the suggested theory results in a nonzero divergence of the eld of Lagrangian trajectories. This time is equal zero in the above mentioned K raichnan model (see [22]) which was the reason for the disappearance of the instability in this particular model.

In this study we used a model of the turbulent velocity eld with a nite correlation time which drastically changes the dynam ics of inertial particles. In the framework of this model of the velocity eld we rigorously derived the su cient conditions for the clustering instability. We demonstrated the existence of the new phenomena of strong and weak clustering of inertial particles in a turbulent ow. These two types of the clustering instabilities have dierent physical meaning and dierent physical consequences in various phenomena. We computed also the instability thresholds which are dierent for the strong and weak clustering instabilities.

II. QUALITATIVE ANALYSIS OF STRONG AND WEAK CLUSTERING

A. Basic equations in the continuous media approximation

In this study we used the equation for the number density n(t;r) of particles advected by a turbulent velocity eld u(t;r):

where D = kT=6 a is the coe cient of molecular (Brownian) di usion, is the uid kinematic viscosity, and T are the uid density and temperature, respectively, a is the radius of a particle and k is the Boltzmann constant. Due to inertia of particles their velocity $v(t;r) \in u(t;r)$; e.g., the eld v(t;r) is not divergence-free even for div u=0 (see [19]). Equation (2.1) in plies conservation of the total number of particles in a closed volume. Consider

Here we assumed that the mean particles velocity is zero. We also neglected the term / ndiv v describing an e ect of an external source of uctuations. This term does not a ect the growth rate of the instability. In the present study we investigate only the e ect of self-excitation of the clustering instability, and we do not consider an effect of the source term on the dynamics of uctuations. The source term / n div v causes another type of uctuations of particle number density which are not related with an instability and are localized in the maximum scale of turbulent motions. A mechanism of these uctuations is related with perturbations of the mean number density of particles by a random divergent velocity eld. The magnitude of these uctuations is much lower than that of uctuations which are caused by the clustering instability.

In our qualitative analysis of the problem we use Eq. (2.3) written in a co-m oving with a cluster reference frame. Formally, this may be done using the Belinicher-L'vov (BL) representation (for details, see [2.3, 24]). Let $_{\rm L}$ $(t_0;r;t)$ will be Lagrangian trajectory of the reference point [in the particle velocity eld v(t;r)] located at r at time t_0 and $_{\rm L}$ $(t_0;r;t)$ be an increment of the trajectory:

Actually the BL representation is very sim ilar to the Lagrangian description of the velocity eld. The di erence between the two representations is that in the Lagrangian representation one follows the trajectory of every uid particle $r + t_0(r;t_0;t)$ (located at r at time $t = t_0$), whereas in the BL-representation there is a special initial point r_0 (in our case the initial position of the center of the cluster) whose trajectory determines the new coordinate system (see [23, 24]). With time the BL-eld v(r₀t;r) becomes very dierent from the Lagrangian velocity eld. It must be noted that the simultaneous correlators of both, the Lagrangian and the BL-velocity elds, are identical to the simultaneous correlators of the Eulerian velocity v (r;t). The reason is that for stationary statistics the simultaneous correlators do not depend on t_{i} and in particular one can assum $e t = t_{0}$.

Sim ilar to Eq. (2.5) let us introduce BL representation for (t;r):

The dierence between Eqs. (2.3) and (2.8) is that Eq. (2.8) involves only velocity dierence (2.6) in which the velocity $(r_0; r_0)$ of the cluster center is subtracted.

B. Rigid-cluster Approximation

Consider qualitatively a time evolution of dierent statistical moments

assum ing that at the initial time, t=0, the spatial distribution of particles is almost homogeneous, all moments M $_{\rm q}(0)$ are small, where h $_{\rm v}$ idenotes the ensemble averaging over random velocity eld v. In order to eliminate the kinematice ect of sweeping of the cluster as a whole we consider Eq. (2.3) in the BL-representation, Eq. (2.8). Since the simultaneous moments of any eld variables in the Eulerian and in the BL-representations coincide, the moments M $_{\rm q}$ (t) can be written as

Our conjecture is that on a qualitative level we can consider the role of each term in the Eq. (2.8) separately, assuming some reasonable, time independent, frozen shape (x) of a distribution (r_0) ; inside a cluster:

Here A (t) is time-dependent amplitude of a cluster, 'cl is the characteristic width of the cluster. Shape function (x) may be chosen with a maximum equal one at x=0 and unit width. Real shapes of various clusters in the turbulent ensemble are determined by a competition of dierent terms in the evolution equation (2.8). However, we believe that particular shapes a ect only numerical factors in the expression for the growth rate of clusters and do not e ect their functional dependence on the parameters of the problem which is considered in this subsection.

1. E ect of turbulent di usion

The advective term in the LHS of Eq. (2.8) results in turbulent di usion inside the cluster. This e ect may be modelled by renormalization of the molecular di usion coe cient D in the right hand side (RHS) of Eq. (2.8)

where $_{\rm dif}(q)$ denotes a contribution to the damping rate of M $_{\rm g}$ (t) caused by turbulent di usion.

2. E ect of particles inertia

In this subsection we show that the term <code>~divW</code> in the RHS of Eq. (2.8) can result in an exponential grow th of M $_{\rm q}$ (t) / exp[$_{\rm in}$ (q)t]; i.e., in the instability. We denoted here the contribution to the grow th rate of M $_{\rm q}$ (t), caused by the inertia of particles, by $_{\rm in}$ (q). In order to evaluate $_{\rm in}$ (q) we neglect now in Eq. (2.8) both, the convective term in the LHS of this equation (i.e. the the turbulent velocity dierence inside the cluster) and the molecular di usion term . The resulting equation reads:

The main contribution to the BL-velocity di erence W $(r_0\, t;r)$ in the RHS of this equation is due to the eddies with size $`_{cl}$, the characteristic size of the cluster. Denote by v_{cl} the characteristic velocity of these eddies and by $_{V}$ $`_{cl}=v_{cl}$ the corresponding correlation time. In our qualitative analysis we neglect the r dependence of div W $(r_0\, t;r)$ inside the cluster and consider the divergence in Eq. (2.17) as a random process b(t) with a correlation time $_{V}$:

3. Qualitative picture of the clustering instability

In previous subsections we evaluated the contributions to the growth rate of M $_{\rm q}$ (t) due to the turbulent di usion $_{\rm dif}$ (q), Eq. (2.16), and due to the particles inertia $_{\rm in}$ (q), Eq. (2.21). The total growth rate m ay be evaluated as a sum of these contributions:

C learly, the instability is caused by a nonzero value of h_v (div W)² i; i.e., by a compressibility of the particle velocity eld v (t;r).

Compressibility of uid velocity itselfu (t;r) (including atmospheric turbulence) is often negligible, i.e., divu

0. However, due to the e ect of particles inertia their velocity v(t;r) does not coincide with u(t;r) (see, e.g., [25, 26, 27, 28]), and a degree of compressibility, v, of the eld v(t;r), may be of the order of unity [19, 20, 29].

Note that parameter $_{\rm v}$ is independent of the scale of the turbulent velocity eld. It characterizes a compressible part of the velocity eld as a whole. The main contribution to this parameter comes from the scales which are of the order of the K olmogorov scale .

C learly, the moments with $q > q_{cr}$ are unstable. Equations (2.25) and (2.27) in ply that it happens when $a > a_{q;cr}$ where $a_{q;cr} = a_{1;cr} = q^{1-4}$ is the value of a at which $q_{cr} = q$. The largest value of $a_{q;cr}$ corresponds to the instability of the rst moment, hj ji: $a_{1;cr} = 0.84$ a, $a_{2;cr} = 0.84$ a, $a_{3;cr} = 0.76$ a, $a_{4;cr}$, $a_{4;cr}$, etc.

Note that if hj ji grows in time then almost all particles can be accumulated inside the clusters (if we neglect a nonlinear saturation of such growth). We dene this case as a strong clustering. On the other hand, if $q_{\rm cr}>1$ the rst moment hj ji does not grow, and the clusters

contain a small fraction of the total number of particles. This does not mean that the instability of higher m om ents is not im portant. Thus, e.g., the rate of binary particles collisions is proportional to the square of their number density $hn^2i = (n)^2 + hj j^2i$. Therefore, the growth of the 2nd moment, hj j2i, (which we dene as a weak clustering) results in that binary collisions occur mainly between particles inside the cluster. The latter can be important in coaquilation of droplets in atm ospheric clouds whereby the collisions between droplets play a crucial role in a rain formation. The growth of the q-th m om ent, hj jqi, results in that q-particles collisions occur mainly between particles inside the cluster. The growth of the negative m om ents of particles num ber density (possibly associated with form ation of voids and cellular structures) was discussed in [30] (see also [31, 32]).

In the above qualitative analysis whereby we considered only one-point correlation functions of the number density of particles, we missed an important elect of an elective drift velocity which decreases a growth rate of the clustering instability. For the one-point correlation functions of the number density of particles the elective drift velocity is zero for homogeneous and isotropic turbulence. However, in the equations for two-point and multi-point correlation functions of the number density of particles the elective drift velocity is not zero and as we will see in the next section it increases a threshold for the clustering instability.

III. THE CLUSTERING INSTABILITY OF THE 2ND MOMENT

A. Basic equations

In the previous section we estimated the growth rates of all moments hj j^qi . Here we present the results of a rigorous analysis of the evolution of the two-point 2nd moment

In this analysis we used stochastic calculus [e.g., W isner path integral representation of the solution of the C auchy problem for Eq. (2.1), Feynman-K ac formula and C am eron-M artin-G insanov theorem]. The comprehensive description of this approach can be found in [21, 33, 34, 35].

We showed that a nite correlation time of a turbulent velocity plays a crucial role for the clustering instability. Notably, an equation for the second moment (t;R) of the number density of inertial particles comprises spatial derivatives of high orders due to a non-local nature of turbulent transport of inertial particles in a random velocity eld with a nite correlation time (see Appendix A and [20]). However, we found that equation for (t;R) is a second-order partial dierential equation at least for two models of a random velocity eld:

but with dierent expressions for its coe cients. The meaning of the coe cients B (R), U (R) and \hat{D} (R) is as follows:

- { Function B (R) is determined only by a compressibility of the velocity eld and it causes generation of uctuations of the number density of inertial particles.
- { The vector U (R) determ ines a scale-dependent drift velocity which describes a transfer of uctuations of the number density of inertial particles over the spectrum . Note that U (R = 0) = 0 whereas B (R = 0) \in 0: For incompressible velocity eld U (R) = 0; B (R) = 0.
- { The scale-dependent tensor of turbulent di usion \hat{D} (R) is also a exted by the compressibility.

In very small scales this tensor is equal to the tensor of the molecular (Brownian) di usion, while in the vicinity of the maximum scale of turbulent motions this tensor coincides with the usual tensor of turbulent di usion. Tensor \hat{D} (R) may be written as




FIG.1: The range of param eters ($_{\rm V}$; $_{\rm T}$) for $_{\rm B}$ = $_{\rm U}$ = $_{\rm V}$ in the case of Sc = 10^3 (curve c), Sc = 10^5 (curve b) and Sc! 1 (curve a). The dashed line $_{\rm V}$ = $_{\rm T}$ corresponds to the -correlated in time random compressible velocity eld.

that even a very small deviations from the -correlated in time random compressible velocity eld results in the instability of the second moment of the number density of inertial particles. 


FIG.2: The range of parameters (Sc; $_{\rm V}$) for Sc = 10^3 (curve c), Sc = 10^5 (curve b) and Sc! 1 (curve a). The line Sc = 0 corresponds to the -correlated in time random compressible velocity eld.

Figure 2 shows the range of parameters (Sc; $_{\rm v}$) for Sc = 10^3 (curve c), Sc = 10^5 (curve b) and Sc! 1 (curve a).

It is seen from FIG.2 that for $_{\rm V}>0.2$ the second-order correlation function of the number density of inertial particles can grow in time exponentially (i.e., $_{\rm 2}>0$) even for very small Strouhal numbers. For example, in the vicinity of $_{\rm V}=3$; the growth rate $_{\rm 2}$ of the clustering instability of the second-order correlation function is given by

The su cient condition for the exponential growth of the second m oment of a number density of inertial particles is $Sc > Sc^{(cr)}$; where the critical Schm idt number $Sc^{(cr)}$ is given by $Sc^{(cr)} = Sc(_2 = 0)$: The clustering instability occurs when the degree of compressibility of particles velocity $_{\rm V} > 0.2$; i.e., for particles and droplets with the radius a > 25.4 m. IV. NONLINEAR EFFECTS

The compressibility of the turbulent velocity eld with a nite correlation time can cause the exponential growth of the moments of particles number density. This small-scale instability results in formation of strong inhomogeneities (clusters) in particles spatial distributions. The linear analysis does not allow to determine a mechanism of saturation of the clustering instability. As can be seen from Eq. (3.12) molecular di usion only depletes the growth rates of the clustering instability at the linear stage (contrary to the instability discussed in Ref.

 $\[30]\]$). The clustering instability is saturated by nonlinear e ects.

Now let us discuss a mechanism of the nonlinear saturation of the clustering instability using on the example of atmospheric turbulence with characteristic parameters:

This values may be considered as a lower estimate for the \two-way coupling" when the e ect of uid on particles has to be considered together with the feed-back e ect of the particles on the carrier uid. However, it was found in [38] that turbulence modication by particles is governed by the ratio of the particle energy and the total energy of the suspension (rather then the energy of the carrier uid) and thus by parameter (1+) (rather then by itself). Thus we expect that the two-way coupling can only mitigate but not stop the clustering instability.

An actual mechanism of the nonlinear saturation of the clustering instability is \four way coupling" when the particle particle interaction is also important. In this situation the particles collisions result in e ective particle pressure which prevents further grows of concentration. Particles collisions play essential role when during the life-time of a cluster the total number of collisions is of the order of number of particles in the cluster. The rate of collisions J n_{cl} = can be estimated as $4 \ \text{ann}_{cl}^2 \text{jy}_{rel} \text{j}$. The relative velocity v_{rel} of colliding particles with di erent but com parable sizes can be _p j(u r)uj $pu^2 = .$ Thus the estim ated as j_{vrel}j collisions in clusters may be essential for

where 's is a mean separation of particles in the cluster. For the above parameters (a = 30 m) $n_{\rm cl}$ 3 $10\,{\rm cm}^3$, 's 5a 150 m and $N_{\rm cl}$ 300. Note that the mean number density of droplets in clouds n is about 10^2 $10^3 {\rm cm}^3$. Therefore the clustering instability of droplets in the clouds increases their concentrations in the clusters by the orders of magnitude.

In all our analysis we have neglected the e ect of sedim entation of particles in gravity eld which is essential for particles of the radius a > 100 m . Taking ${\bf `}_{\rm cl}$ ' we assumed implicitly that $_{\rm p}$ < . This is valid (for the atm ospheric conditions) if a $\,$ 60 m . O therw ise the cluster size can be estimated as ${\bf `}_{\rm cl}$ ' $(_{\rm p}=$ $)^{3-2}$.

Our estimates support the conjecture that the clustering instability serves as a preliminary stage for a co-

agulation of water droplets in clouds leading to a rain form ation.

V. DISCUSSION

In this study we investigated the clustering instability of the spatial distribution of inertial particles advected by a turbulent velocity eld. The instability results in form ation of clusters, i.e., small-scale inhom ogeneities of aerosols and droplets. The clustering instability is caused by a combined elect of the particle inertia and nite correlation time of the velocity eld. The nite correlation time of the turbulent velocity eld causes the compressibility of the eld of Lagrangian trajectories. The latter implies that the number of particles owing into a small control volume in a Lagrangian frame does not equal to the number of particles owing out from this control volume during a correlation time. This can result in the depletion of turbulent di usion.

The role of the compressibility of the velocity eld is as follows. Divergence of the velocity eld of the inertial particles div v = p P = T he inertia of particles results in that particles inside the turbulent eddies are carried out to the boundary regions between the eddies by inertial forces (i.e., regions with low vorticity and high strain rate). For a small molecular di usivity divv / $_{p}$ P = : Thus [see Eq. (2.1)]. Therefore, dn=dt / there is accumulation of inertial particles (i.e., dn=dt > 0) in regions with P < 0: Similarly, there is an outow of inertial particles from the regions with P > 0: This mechanism acts in a wide range of scales of a turbulent uid ow. Turbulent di usion results in relaxation of uctuations of particles concentration in large scales. However, in small scales where turbulent diusion is small, the relaxation of uctuations of particle concentration is very weak. Therefore the uctuations of particle concentration are localized in the small scales.

This phenom enon is considered for the case when density of uid is much less than the material density $_p$ of particles ($_p$): When $_p$ the results coincide with those obtained for the case $_p$ except for the transformation $_p$! $_p$; where

For p the value dn=dt / p P = : Thus there is accumulation of inertial particles (i.e., dn=dt > 0) in regions with the minimum pressure of a turbulent uid since < 0: In the case p we used the equation of motion of particles in uid ow which takes into account contributions due to the pressure gradient in the uid surrounding the particle (caused by acceleration of the uid) and the virtual ("added") mass of the particles relative to the ambient uid [39].

The exponential growth of the second moment of a number density of inertial particles due to the small-

scale instability can be saturated by the nonlinear effects (see Section IV). The excitation of the second mom ent of a num ber density of particles requires two kinds of com pressibilities: com pressibility of the velocity eld and compressibility of the eld of Lagrangian trajectories, which is caused by a nite correlation time of a random velocity eld. Remarkably, the compressibility of the eld of Lagrangian trajectories determines the coecient of turbulent di usion (i.e. the coe cient D the second-order spatial derivative of the second m om ent of a number density of inertial particles in Eq. (32). The compressibility of the eld of Lagrangian trajectories causes depletion of turbulent di usion in small scales even for v = 0.0 n the other hand, the compressibility of the velocity eld determ in es a coe cient B (r) near the second m om ent of a num ber density of inertial particles in Eq. (32). This term is responsible for the exponential growth of the second moment of a number density of particles.

Sum m ary:

We showed that the physical reason for the clustering instability in spatial distribution of particles in turbulent ows is a combined e ect of the inertia of particles leading to a compressibility of the particle velocity eld v(t;r) and a nite velocity correlation time.

The clustering instability can result in a strong clustering whereby a nite fraction of particles is accumulated in the clusters and a weak clustering when a nite fraction of particle collisions occurs in the clusters.

The crucial parameter for the clustering instability is a radius of the particles a. The instability criterion is a > $a_{\rm cr}$ a for which $h({\rm div}\,v)^2i=h{\rm prot}\,v^2i$. For the droplets in the atm osphere a ' 30 m. The growth rate of the clustering instability $_{\rm cl}$ 1 (a=a) 4, where is the turnover time in the viscous scales of turbulence.

We introduced a new concept of compressibility of the turbulent di usion tensor caused by a nite correlation time of an incompressible velocity eld. For this model of the velocity eld, the eld of Lagrangian trajectories is not divergence-free.

We suggested a mechanism of saturation of the clustering instability -particle collisions in the clusters. An evaluated nonlinear level of the saturation of the droplets number density in clouds exceeds by the orders of magnitude their mean number density.
