# Singular sector of the B urgers $H$ opf hierarchy and deform ations of hyperelliptic curves

#### Abstract

W e discuss the structure of shock singularities of the B urgers $H$ opf hierarchy. It is show $n$ that the set of singular solutions de nes a strati cation of the a ne space of the ow param eters in the hierarchy. The strati cation is associated w ith the B irkho decom position of the $G$ rassm annian given by the set of linear spaces spanned by the hierarchy. W e then construct integrable hierarchy on each stratum and dem onstrate that it describes a deform ation of a hyperelliptic curve param etrizing the stratum . T he hierarchy is called the hidden Burgers $H$ opfhierarchy, and we found the $R$ iem ann invarint form and the hodograph solution.


## 1. Introduction: S ingu lar solutions of the B H hierarchy

The Burgers $H$ opf ( BH ) hierarchy de ned by

plays an im portant role in the study of a w ide range of phenom_ena in physics
 clear that the BH hierarchy can be obtained by the dispersionless lim it of the K dV hierarchy as well as the dissipationless lim it of the B urgers hierarchy. H ow ever the present study does not require any inform ation of the original hierarchy.
$U$ sing the $m$ ethod of characteristic, the solution of the hierarchy can be expressed by the hodograph form $w$ th to $x$,

where $f(u) m$ ay be determ ined by the in itial data, e.g. $u(x ; 0 ; 0 ; \quad)={ }^{1} f(x)$ for a $m$ onotone data. $T$ hen the BH hierarchy gives a deform ation of the data $x=f(u)$ in each $t_{j}$-direction, and this de nes an in nite dim ensional surface given by (11).

H ere we are interested in the class of solutions of the BH hierarchy w ith singularity of shock wave type. The singularity of this type corresponds to a point on the surface where the derivative $@ u=@ x$ blows up at this point, that is, the equation (1. 1.1 ) is not invertible for $u$. This condition is equivalent to ${ }^{0}:=@=@ u=0$ at the point, which im plies that the solution $u$ can be expressed as a function of

[^0]( $t_{1} ; t_{2}$; ). Thus the conditions $=0$ and $^{0}=0$ de ne a singular sector of codim ension 1 in $C^{1}$. The a ne space $C^{1}$ is then strati ed w ith those singular sectors as follow s: Let us rst de ned the solution sets,

$w$ here $j_{j} j$ is the num ber of solutions in $U_{j}$. For exam ples, $Z_{0}$ consists of the points where (u) = 0 has only sim ple roots, and the points in $Z_{1}$ correspond to the case where $(u)=0$ and ${ }^{0}(u)=0$ has just only one com $m$ on root and no roots for
${ }^{(j)}(u)=0$; $j 2$. The closure of the set of those singular sectors then form s a decom position of the a ne space $C^{1}$, i.e.

In order to show som e explicit structure of the set $Z_{m}$, let us consider the case where $f(u)$ is given by a $(\mathbb{N}+1)$ th degree of polynom ial in $u$. Then on a $(\mathbb{N}+1)$ dim ensional subspace of $C^{1}$ w th $t_{n}=0$ for $n \quad N+1$, the equation $(1,1)$ can be w ritten by

Since all the coe cients $b_{j}$ 's on the right hand side can be absorbed by shifting the tim es, ( $x \quad b_{0} ; t_{1} \quad\left(b_{1}=c_{1}\right) ; t_{2} \quad\left(b_{2}=c_{2}\right)$; $)$ we just set $\left.a_{j}\right] \neq 0$. Then we consider the singular sectors, denoted as $\mathrm{Z}_{\mathrm{m}}^{\mathrm{N}+1}$, on the subspace $\mathrm{C}^{\mathrm{N}+1}$. T he equation (1.3) is well known as a universalunfolding of a singularity of $A_{N}$ type [|़-1]. The singularity of this type includes cusp, swallow tail and butter y for $\mathrm{N}=2 ; 3$ and 4. As an exam ple we just consider the case with $N=2$.

Example 1.1. T he hodograph solution $\left(11_{2}^{-3}\right)$ w ith $\mathrm{N}=2$ is given by

The sets $Z_{1}^{3}$ obviously intersects on the double points of $u^{+}=u$, and form $s a$ cusp singularity. The intersection provides the higher singular sector $\mathrm{Z}_{2}^{3}$ which is given by a tw isted cubic curve,

The real sections of those sectors $w$ illbe an interesting ob ject to study.

Remark 12. A strati cation of certain (com pact) $m$ anifold is an interesting problem ofalgebraic geom etry, and has severalintim ate connectionsw ith the study of integrable system s . For exam ples, the isospectralm anifolds of the periodic Toda lattioes are given by Jacobian varieties which have the strati cation based on the
 isospectralm anifolds are com pacti ed in the ag manifolds, and are decom posed
 also $\left[\overline{2}_{2}^{2}\right]$ for several exam ples of the strati cations of Jacobian varieties related to nite dim ensionalham iltonian system s.) The present study w illprovide an exam ple of the strati cation related to integrable system s of hydrodynam ic type.

In this paper, we construct an integrable hierarchy de ned on each singular sector $\mathrm{Z}_{\mathrm{m}}$. Those hierarchies can be also obtained by the dispersionless lim its of the hidden hierarchies of the K dV equation considered in $[191]$. W e call those the hidden BH hierarchies, and we construct those as a regularization of the shock singularity of the $B H$ hierarchy. E ach hierarchy on $Z_{m}$ is called the $B H_{m}$ hierarchy. In Section 2, we discuss the G rassm annian structure of the singular sectors and show the connection to hyperelliptic curves. Then in Section 3, we de ne the $\mathrm{BH}_{\mathrm{m}}$ hierarchy on $Z_{m}$ as a deform ation of hyperelliptic curve of genusm. W e also show that the hierarchy can be put into the $R$ iem ann invariant form, and then construct the hodograph solution. The R iem ann invariant form has been also obtained in a di erent approach in ${ }_{-1-1}^{-1}$. In Section 4, we give a brief discussion on several extensions of the present construction of the hidden dispersionless hierarchies. W e also $m$ ention som e related topics such as a topological eld theory strati cation of the Frobeniusm anifold as obtained by those hidden hierarch ies [1] [1].

## 2. G rassm annian structure of the BH hierarchy

In this section we discuss the $G$ rassm annian structure of the solutions of the BH hierarchy. Let us rst recall (see for exam ple [1] ${ }_{1}^{-1}$ ]) that the BH hierarchy can be form ulated as

The hierarchy $(\overline{2}-\overline{1})$ can be considered as a deform ation of the curve $(2 \overline{2})$ which corresponds to the $R$ iem ann surface of genus 0 (sphere) w ith the com pacti cation. Later we w ill use $k=2$, and then we assign the degrees as

O ne introduces a function $S\left(x ; t_{1} ; t_{2} ; \quad\right.$ which plays an im portant role in the theory of dispersionless hierarchy. The $S$ function is de ned by rew riting (2.11) in the form,

To characterize the solution space of the BH hierarchy, we now de ne a linear space spanned by the ow s $\left.(2,3)^{2}\right)$ in a $m$ anner sim ilar to the case of the $K P$ hierarchy [3눈,

Since $Q_{i}$ is a polynom ialin $p$ and $p^{2}=k+u$, one can also consider $Q_{i}$ be an elem ent in $C \mathbb{k}] \quad p$. This observation willbe crucial for de ning an integrable hierarchy on the singular sector. T hus we have

O ne should however note that the linear space $W$ o cannot be de ned on the singular sectors where the ows (2.1) blow up and the commutativity am ong the $S$ ow s is not de ned. Recall that the conditions on the hodograph solution $=0$ provide a constraint on the coordinates. For exam ple, the rst condition ${ }^{0}=0$ gives

which de nes a hyperelliptic curve of genus $m$ and is a sm ooth a ne variety for the generic values of $u_{i}{ }^{\prime} s$, the deform ation param eters. Then the ring $\left.W_{m}=C \mathbb{k}\right] \mathbb{R}$ can be considered as a part of the quotient ring $C k ; p]=C_{m} w$ th the curve $C_{m}$. O ne should also note that there is a natural reduction of the curve,

which corresponds to the conditions on the param eters, $u_{2 m}=u_{2 m} \quad=0$. This can be considered as a dispersionless analog of the regularization of the singularity in the KP hierarchy by the Backlund transform ation [3्1] $]$. Thus the stratum $m$ is param etrized by the curve $C_{m}$, and the boundary of the stratum corresponds to a singular curve of degenerate genus $m$. The higher order stratum is obtained by the desingularization of the curve by increasing the genus. The curve $C_{m}$ can be_obtained by the dispersionless lim it of the hidden $K$ dV hierarchy considered in [19'1] and also by a quasi-classical @ dressing $m$ ethod introduced in [18"]. In the next section we will consider a deform ation of the curve by de ning a system of equations for the param eters $u_{i}$ in $C_{m}$ where the deform ation is param etrized by the timest for $j m$.

## 3. The hidden BH hierarch ies

We now construct an integrable deform ation of the curve $C_{m}$ in $(\overline{2} . \bar{q})$, which is de ned on the singular sector $Z_{m} . F$ irst recall the quotient ring of $C\left[k ; p_{m}\right]$ over an ideal $C_{m}$ which has a split,

H ere we have relabeled the tim es as $t_{m+i}!t_{i}$, but we do not think it will cause any confusion. A s we will show below, all the ows in (3.1) are com patible for appropriate form of $Q_{j}^{m}$, that is, $Q Q_{i}^{m}=@ t_{j}=@ Q_{j}^{m}=@ t_{i}$, and in particular we have for the case $i=0$,

The sim plest exam ple of the $\mathrm{BH}_{\mathrm{m}}$ equations in term s of $u_{i}$ 's is given by the $t_{1}$ - ow of the $\mathrm{BH}_{1}$ equation (see $R$ em ark 32

A s a consequence of the Lax form ( $\underline{3}_{-1}^{-1}$ ), we have

We here note that the $R$ iem ann invariant form has an obvious reduction with $j=0$ for som e j's. This corresponds to the reduction of the genus as $m$ entioned in the end of the previous section. There is also another reduction $w$ ith all $0=\quad \bar{z} m$ $w$ hich is associated to a degenerate case of $C_{m}$ equivalent to $p_{m}^{2}=k^{2 m+1}$ of genus 0 .

W ith the form (3.5), we can construct the hodograph solution of the hierarchy as shown in $[1]=$ en rst rem ark that the functions $j(k)$ in (3) form a nite ring of dim ension $2 \mathrm{~m}+1$,

Remark 32. The general form of the $\mathrm{BH}_{\mathrm{m}}$ hierarchy can be written in the follow ing form $w$ th the polynom ial ${ }^{i}(k)$ for $k$ being replaced by a $m$ atrix $K$,

## 4. Further extensions and discussion

The present construction of the hidden hierarchies can be extended to the case w ith the hyperelliptic curve associated with an even degree polynom ial,

Here the degree of $k$ is assigned as $D e g(k)=1$ so that $D e g(p)=m+1$. The hierarchy of deform ations of the curve $C_{m}$ can be also obtained as the dispersion less lim it of the integrable hierarchy associated w ith the energy-dependent Schrodinger potentials considered in $[2001]$, which coincides $w$ th the hidden hierarchy for the
 associated w th the curve $\overline{\mathrm{C}}_{\mathrm{m}}^{-1}$ the dJM $m$ hierarchy. M ost of the results obtained in Sections 2 and 3 rem ains the sam efor this case. In particular, the singular sectors $Z_{m}$ for the dJM $o$ hierarchy are given by the higher order intersections of tw o curves given by the hodograph solution for $\mathrm{v}_{1}$ and $\mathrm{v}_{2}$, which are de ned as follow s : Let the curve $\mathrm{C}_{0}$ be given by

The singular structure of the dispersionless JM hiearchy is then sim ilar to the case of the BH hierarchy. W e will report a detailed discussion on the strati cation determ ined by the dJM $m$ hierarchies elsew here.

O ne should also note that the integrable deform ation of the algebraic curve de ned by either $\mathrm{BH}_{\mathrm{m}}$ or $\mathrm{dJM}_{\mathrm{m}}$ hierarchy is rather a general property of the dispersion less integrable hierarchy. For exam ple, the dispersionless lim it of the rst hidden K P hierarchy discussed in [1] [1] leads to the standard form of the elliptic curve,

T$ his con tains the $\mathrm{BH}_{1}$ hierarchy as the reduction w ith $\mathrm{q}=\mathrm{k}=$ constant and $\mathrm{v}_{0}=\mathrm{v}_{1}=0$, and the hidden dispersioless B oussinesq hierarchy w ith the reduction $p=k=$ constant and $u_{0}=0$. The singular structures determ ined by the hidden dispersionless K P
hierarchy and its reductions (such as the Gelfand-D ikii type) will be discussed elsew here. W e also rem ark that the integrable deform ation of hyperelliptic curve discussed in the present paper is di erent from that given by the $W$ hitham hierarchy (see for exam ple (10]). The W hitham hierarchy describes a slow m odulation over a quasi-periodic solution of the original dispersive equation, and is obtained as a dispersive regularization of the dispersion less hierarchy. H ow ever our deform ation describes each stratum (singular sector) of the B irkho decom position, which is param etrized by the hyperelliptic curve, and it has no direct connection w ith the original dispersive equation.

A s a nal rem ark, we would like to point out that the $\mathrm{BH}_{\mathrm{m}}$ hierarchy may not have a single free energy (or prepotential) which plays a centralrole of a topological eld theory. In the dispersionless K P hierarchy, the free energy can be obtained by integrating tw ice the function $\mathrm{G}_{\mathrm{ij}}$ (referred as the Gel fand-D ikii potential in [-4 ${ }_{-1}{ }^{-1}$ ) de ned as the ux density of the conservation law s,

H ow ever one can show that $G_{i j}$ is not a sym $m$ etric function $w$ ith respect to the indices $i ; j$ exœpt the case $w$ ith $m=0$. H ence there is no further integration to express the $\mathrm{G}_{\mathrm{ij}}$ as a tw o point function as in the case ofdispersionless

where i's are the prim ary elds or graviationaldecendants and $F$ represents the free energy of the topological eld theory. Thus the $\mathrm{BH}_{\mathrm{m}}$ hierarchy is som ew hat di erent from $m$ ost of the known dispersionless hierarchies which have a direct connection to topological eld theory a topological eld theory based on the $\mathrm{BH}_{\mathrm{m}}$ hierarchies, and if there exists such a theory, then the associated Frobenius $m$ anifold $m$ ay have a strati ed structure characterized by a nite ring related to $F_{m}$ in (3.6).
