# Singular sector of the Burgers-Hopfhierarchy and deform ations of hyperelliptic curves

A bstract. We discuss the structure of shock singularities of the Burgers-Hopf hierarchy. It is shown that the set of singular solutions denes a stratication of the ane space of the owparameters in the hierarchy. The stratication is associated with the Birkho decomposition of the Grassmannian given by the set of linear spaces spanned by the hierarchy. We then construct integrable hierarchy on each stratum and demonstrate that it describes a deformation of a hyperelliptic curve parametrizing the stratum. The hierarchy is called the hidden Burgers-Hopf hierarchy, and we found the Riemann invarint form and the hodograph solution.

1. Introduction: Singular solutions of the BH hierarchy

The Burgers-Hopf (BH) hierarchy de ned by

plays an important role in the study of a wide range of phenomena in physics from hydrodynamics to topological eld theory (for examples, see [23, 7, 8]). It is clear that the BH hierarchy can be obtained by the dispersionless limit of the KdV hierarchy as well as the dissipationless limit of the Burgers hierarchy. However the present study does not require any information of the original hierarchy.

U sing the method of characteristic, the solution of the hierarchy can be expressed by the hodograph form with  $t_0$  x,

where f (u) m ay be determined by the initial data, e.g. u (x;0;0; ) =  ${}^{1}$ f(x) for a monotone data. Then the BH hierarchy gives a deformation of the data x = f (u) in each  $t_1$ -direction, and this de nes an in nite dimensional surface given by (1.1).

Here we are interested in the class of solutions of the BH hierarchy with singularity of shock wave type. The singularity of this type corresponds to a point on the surface where the derivative @u=@x blows up at this point, that is, the equation (1.1) is not invertible for u. This condition is equivalent to w=0 = w=0 at the point, which implies that the solution u can be expressed as a function of

where  $y_j$  is the number of solutions in  $y_j$ . In order to show some explicit structure of the set  $Z_{\,\mathrm{m}}$  , let us consider the case where f(u) is given by a (N + 1)th degree of polynom ial in u. Then on a (N + 1)dim ensional subspace of  $C^1$  with  $t_n = 0$  for N + 1, the equation (1.1) can be written by

Since all the coe cients  $b_{j}$ 's on the right hand side can be absorbed by shifting the tim es,  $(x b_0; t_1 (b_1=c_1); t_2 (b_2=c_2);$  ), we just set  $a_1 \ge 0$ . Then we consider the singular sectors, denoted as Z  $_{\rm m}^{\rm N+1}$ , on the subspace C  $^{\rm N+1}$  . The equation (1.3) is wellknown as a universal unfolding of a singularity of A<sub>N</sub> -type [5]. The singularity of this type includes cusp, swallow tail and butter y for N = 2;3 and 4. As an example we just consider the case with N = 2.

The sets  $Z_1^3$  obviously intersects on the double points of  $u^+ = u^-$ , and form s a cusp singularity. The intersection provides the higher singular sector  $Z_2^3$  which is given by a twisted cubic curve,

The real sections of those sectors will be an interesting object to study.

Remark 12. A strati cation of certain (compact) manifold is an interesting problem of algebraic geometry, and has several intimate connections with the study of integrable systems. For examples, the isospectral manifolds of the periodic Toda lattices are given by Jacobian varieties which have the stratication based on the theta divisor [2, 1, 15]. Also in the case of nite nonperiodic Toda lattices, the isospectral manifolds are compactified in the agmanifolds, and are decomposed into the Bruhat cells which correspond to the sets of singular solutions [11, 6]. (See also [22] for several examples of the stratications of Jacobian varieties related to nite dimensional hamiltonian systems.) The present study will provide an example of the stratication related to integrable systems of hydrodynamic type.

In this paper, we construct an integrable hierarchy de ned on each singular sector  $Z_m$ . Those hierarchies can be also obtained by the dispersionless limits of the hidden hierarchies of the K dV equation considered in [19]. We call those the hidden BH hierarchies, and we construct those as a regularization of the shock singularity of the BH hierarchy. Each hierarchy on  $Z_m$  is called the BH $_m$  hierarchy. In Section 2, we discuss the G rassmannian structure of the singular sectors and show the connection to hyperelliptic curves. Then in Section 3, we de ne the BH $_m$  hierarchy on  $Z_m$  as a deformation of a hyperelliptic curve of genus m. We also show that the hierarchy can be put into the Riemann invariant form, and then construct the hodograph solution. The Riemann invariant form has been also obtained in a dierent approach in [9]. In Section 4, we give a brief discussion on several extensions of the present construction of the hidden dispersionless hierarchies. We also mention some related topics such as a topological eld theory [4] and a possible stratic cation of the Frobenius m an invariance by those hidden hierarchies [14].

#### 2. G rassm annian structure of the BH hierarchy

In this section we discuss the G rassm annian structure of the solutions of the BH hierarchy. Let us strecall (see for example [13]) that the BH hierarchy can be formulated as

The hierarchy (2.1) can be considered as a deform ation of the curve (2.2) which corresponds to the R iem ann surface of genus 0 (sphere) with the compactication. Later we will use k=2, and then we assign the degrees as

One introduces a function  $S(x;t_1;t_2;$  ) which plays an important role in the theory of dispersionless hierarchy. The S function is dened by rewriting (2.1) in the form,

To characterize the solution space of the BH hierarchy, we now de ne a linear space spanned by the  $\cos s$  (2.3) in a manner  $\sin s$  ilar to the case of the KP hierarchy  $\beta$ ],

Since  $Q_i$  is a polynomial in p and  $p^2 = k + u$ , one can also consider  $Q_i$  be an element in C[k] p. This observation will be crucial for dening an integrable hierarchy on the singular sector. Thus we have

which is the condition for the KdV reduction in terms of the KP hierarchy [21].

O ne should however note that the linear space W  $_0$  cannot be de ned on the singular sectors where the ows (2.1) blow up and the commutativity among the S ows is not de ned. Recall that the conditions on the hodograph solution =0 provide a constraint on the coordinates. For example, the rst condition  $^0=0$  gives

The Grassmannian Gr is a set of all linear spaces  $W_m$ ; m = 0, and it has the Birkho decomposition [21],

where the Birkho stratum  $_{m}$  is the set of all linear spaces of W  $_{m}$ . The structure of the G rassmannian is then the same as the K dV hierarchy by making the identication with  $k=\ ^{2}$ ,

Since the degrees of k and  $p_m$  are assigned as

which de ness a hyperelliptic curve of genus m and is a smooth a nevariety for the generic values of  $u_i$ 's, the deformation parameters. Then the ring  $W_m = C \ k$  p can be considered as a part of the quotient ring  $C \ k$ ;  $p \models C_m$  with the curve  $C_m$ . One should also note that there is a natural reduction of the curve,

which corresponds to the conditions on the parameters,  $u_{2m}=u_{2m-1}=0$ . This can be considered as a dispersionless analog of the regularization of the singularity in the KP hierarchy by the Backlund transform ation [3]. Thus the stratum  $_{m}$  is parametrized by the curve  $C_{m}$ , and the boundary of the stratum corresponds to a singular curve of degenerate genus m. The higher order stratum is obtained by the desingularization of the curve by increasing the genus. The curve  $C_{m}$  can be obtained by the dispersionless lim it of the hidden K dV hierarchy considered in [19] and also by a quasi-classical @ dressing method introduced in [18]. In the next section we will consider a deform ation of the curve by dening a system of equations for the parameters  $u_{i}$  in  $C_{m}$  where the deformation is parametrized by the times  $t_{i}$  for j m.

## 3. The hidden BH hierarchies

We now construct an integrable deform ation of the curve  $C_m$  in (2.6), which is de ned on the singular sector  $Z_m$ . First recall the quotient ring of C [k; $p_m$ ] over an ideal  $C_m$  which has a split,

Then a deform ation of the curve  $C_m$  with an in nite number of deform ation param eters is de ned in the same form as  $(2\,3)$ ,

where  $S^m$  is given by (2.4), and  $D \exp(Q_j^m) = 2 (m+j) + 1 \text{ with } Q_0^m = p_m$ . With this denition, the functions  $a_i$ 's in  $S^m$  can be explicitely written in terms of  $u_i$ 's in the curve  $C_m$ . Here we have relabeled the times as  $t_{m+i}$ !  $t_i$ , but we do not think it will cause any confusion. As we will show below, all the lows in (3.1) are compatible for appropriate form of  $Q_j^m$ , that is,  $Q_j^m = Q_j^m = Q_j^m = Q_j^m$ , and in particular we have for the case i=0,

This corresponds to the reduction of the genus as mentioned in the end of the previous section. There is also another reduction with all  $_0=\frac{1}{2m}$  which is associated to a degenerate case of  $C_m$  equivalent to  $p_m^2=k^{2m+1}$  of genus 0

W ith the form (3.5), we can construct the hodograph solution of the hierarchy as shown in [1.3]. We rst remark that the functions  $^{j}(k)$  in (3.5) form a nite ring of dimension 2m+1,

where  $t_i^0$  is the initial position of the characteristic at  $t_{2m+j}=0$ ; j 1: As a simplest example with m=1, we have an explicit solution from (3.7) by setting  $t_{2m+j}=(3=2)_{j1}$  and  $t_i^0=0$ ,

A lso taking the sum  $\stackrel{P}{\underset{i=0}{\sum}} \overset{1}{\underset{i=0}{\sum}} t_i^0$  of (3.7), we obtain

Theorem 3.1. The hodograph solution of the  $BH_m$  hierarchy is given by

where the times  $(x;t_1;t_2;$  ) can be shifted arbitrary.

This form ulawillbe useful to study the singular structure of the BH  $_{\rm m}$  hierarchy as in the case of the BH hierarchy. We will report a detailed analysis elsewhere.

Remark 32. The general form of the BH  $_{m}$  hierarchy can be written in the following form with the polynomial  $^{i}$  (k) for k being replaced by a matrix K ,

$$\frac{\partial \mathbf{U}}{\partial t_1} = {}^{\mathrm{i}}(\mathbf{K}) \frac{\partial \mathbf{U}}{\partial \mathbf{x}}; \quad \mathbf{w} \pm \mathbf{h} \quad \mathbf{U} = (\mathbf{u}_0; \mathbf{u}_1; \quad \mathbf{u}_1; \quad \mathbf{u}_2; \mathbf{u}_1)^{\mathrm{T}};$$

where K is the (companion) matrix given by

$$K = \begin{bmatrix} 0 & & & & & & 1 & & & 0 \\ B & u_1 & 0 & & & & C & 0 \\ B & \vdots & \vdots & \ddots & \ddots & \vdots & \vdots \\ 0 & u_{2m-1} & 0 & & & A & 1 \\ & u_{2m} & 0 & & & 0 \end{bmatrix}$$

For example,  $^{1}$  (K) = K  $(1=2)u_{0}I$  with I = (2m + 1) (2m + 1) identity matrix.

## 4. Further extensions and discussion

The present construction of the hidden hierarchies can be extended to the case with the hyperelliptic curve associated with an even degree polynomial,

( 
$$C_m := (k;p) 2 C^2 p^2 = k^{2m+2} + v_i k^{2m+2} :$$

Here the degree of k is assigned as  $D \in G(k) = 1$  so that  $D \in G(p) = m + 1$ . The hierarchy of deform ations of the curve  $C_m$  can be also obtained as the dispersionless lim it of the integrable hierarchy associated with the energy-dependent Schrodinger potentials considered in [20], which coincides with the hidden hierarchy for the Jaulent-M iodek hierarchy [12] (see also [17]). We here call the integrable hierarchy associated with the curve  $C_m$  the dJM hierarchy. Most of the results obtained in Sections 2 and 3 remains the same for this case. In particular, the singular sectors  $C_m$  for the dJM hierarchy are given by the higher order intersections of two curves given by the hodograph solution for  $v_1$  and  $v_2$ , which are defined as follows: Let the curve  $C_0$  be given by

$$p^2 = k^2 + v_1 k + v_2 = (k_1)(k_2)$$

The hodograph solution has the same form as (1.1),

Here the function  $``_{(i)}$  (  $_1$ ;  $_2$ ) may be given by  $``_{(i)}$  = D  $j_{\frac{1}{2}=\frac{1}{1}}$  with,

$$D := \begin{pmatrix} \begin{pmatrix} 1 \\ 1 \end{pmatrix}^{1} & \begin{pmatrix} 2 \\ 1 \end{pmatrix}^{1} \\ 2 \\ \begin{pmatrix} 4 \end{pmatrix}^{2} \end{pmatrix}; \quad \dot{j} = \frac{0}{0} \\ \frac{1}{0} & 2 \end{pmatrix} ! \begin{pmatrix} 1 \\ 2 \end{pmatrix} \frac{0}{0} \quad \dot{j};$$

where  $\frac{i}{j}=$  0  $\frac{i}{=}$ 0 j. Note that  $^{\sim}_{(1)}$  is just the Jacobian determinant. The singular structure of the dispersionless JM hierarchy is then similar to the case of the BH hierarchy. We will report a detailed discussion on the stratication determined by the dJM  $_{m}$  hierarchies elsewhere.

One should also note that the integrable deformation of the algebraic curve dened by either BH $_{\rm m}$  or dJM $_{\rm m}$  hierarchy is rather a general property of the dispersionless integrable hierarchy. For example, the dispersionless limit of the rst hidden KP hierarchy discussed in [16] leads to the standard form of the elliptic curve,

where D eg ( $Q_n$ ) = n + 2 w ith D eg (p) = 3; D eg (q) = 2 and  $t_0$  = x;  $t_1$  = y. This contains the B H<sub>1</sub> hierarchy as the reduction w ith q = k = constant and  $v_0$  =  $v_1$  = 0, and the hidden dispersioless B oussinesq hierarchy w ith the reduction p = k = constant and  $u_0$  = 0. The singular structures determ ined by the hidden dispersionless KP

hierarchy and its reductions (such as the Gel'fand-Dikii type) will be discussed elsewhere. We also remark that the integrable deformation of hyperelliptic curve discussed in the present paper is dierent from that given by the Whitham hierarchy (see for example [10]). The Whitham hierarchy describes a slow modulation over a quasi-periodic solution of the original dispersive equation, and is obtained as a dispersive regularization of the dispersionless hierarchy. However our deformation describes each stratum (singular sector) of the Birkho decomposition, which is parametrized by the hyperelliptic curve, and it has no direct connection with the original dispersive equation.

As a nalremark, we would like to point out that the BH  $_{\rm m}$  hierarchy may not have a single free energy (or prepotential) which plays a central role of a topological eld theory. In the dispersionless KP hierarchy, the free energy can be obtained by integrating twice the function  $G_{\rm ij}$  (referred as the Gel'fand-Dikii potential in [4]) de ned as the ux density of the conservation laws,

$$\frac{\varrho g_{j}}{\varrho t_{i}} = \frac{\varrho}{\varrho x} G_{ij}:$$

Here  $g_j = G_{0j}$  and  $G_{ij}$  are the coe cients of the expansions of  $p_m$  and  $Q_i^m$  in (3.2). In the case of the BH<sub>m</sub>, they are given by the residue formulae,

$$G_{ij} = \underset{k=1}{\text{Res}} Q_i^m k^j \stackrel{m}{=} \frac{dk}{p}$$
:

Because of the conservation law (4.1),  $G_{ij}$  can be integrated once to get the form with some function  $F_{ij}$ ,

$$G_{ij} = \frac{\theta}{\theta t_i} F_j$$
:

(Note that  $F_j$  are related with the functions  $a_i$ 's in (2.4) as  $F_j = a_{m-1-j}$  for 0 j m 1.) However one can show that  $G_{ij}$  is not a symmetric function with respect to the indices i; j except the case with m=0. Hence there is no further integration to express the  $G_{ij}$  as a two point function as in the case of dispersionless KP theory (see for example [4, 14]), such as,

$$G_{ij} = h^{i}^{j}i = \frac{e^{2}}{et_{i}et_{j}}F;$$

where  $_{\rm i}{'}{\rm s}$  are the primary  $\,$  elds or graviational decendants and F  $\,$  represents the free energy of the topological  $\,$  eld theory. Thus the B H  $_{\rm m}$   $\,$  hierarchy is som ewhat dierent from most of the known dispersionless hierarchies which have a direct connection to topological  $\,$  eld theory [7, 4]. It is then quite interesting to construct a topological  $\,$  eld theory based on the B H  $_{\rm m}$   $\,$  hierarchies, and if there exists such a theory, then the associated Frobenius manifold may have a strati ed structure characterized by a  $\,$  nite ring related to F  $_{\rm m}$  in (3.6).
