#### Abstract

W e present a review of the norm al form theory for weakly dispersive nonlinear w ave equations where the leading order phenom ena can be described by the $K d V$ equation. $T h$ is is an in $n$ ite dim ensional extension of the well-known P oincare-D ulac norm al form theory for ordinary di erential equations. W e also provide a detailed analysis of the interaction problem of solitary $w$ aves as an im portant application of the norm al form theory. Several explicit exam ples are discussed based on the norm al form theory, and the results are com pared w ith their num erical sim ulations. Those exam ples include the ion acoustic wave equation, the B oussinesq equation as a m odel of the shallow w ater waves, the regularized long wave equation and the $H$ irota bilinear equation having a 7th order linear dispersion.

## 1. Introduction

In this chapter, we review the nom al form theory developed in 14, 15] for weakly nonlinear and weakly dispersive wave equations where the leading order equation is given by the $K d V$ equation in an asym ptotic perturbation sense. The chapter is based on the report 16] and the $m$ aster thesis of the rst author at O saka U niversity.

A series of lectures was carried out by the second author in the Euro Sum mer School2001 held at the Isaac $N$ ew ton Institute, $C$ am bridge for A ugust 12-25, 2002. $T$ he lecture started $w$ ith a brief sum $m$ ary of the $P$ oincare- $D$ ulac norm alform theory for a system of ordinary di erential equations 3 ]. The $m$ ain point in the lecture is to present the norm al form theory for near integrable system where the leading order system is given by a nolinear wave equation. This $m$ ay be considered as an in nite dim ensional extension of the $P$ oincare-D ulac norm al form theory. The basic technique of the norm al form theory based on the Lie transform ation can be form ally extended to the in nite dim ensional case. U nfortunately the convergence theorem of the norm al form series has no extension to the present theory. H ow ever one should em phasize that the leading order in the present theory is given by a nonlinear equation, and it is not clear how one de ne a resonant surface for the leading order equation. This $m$ ay provide a good problem for a future project.

Let us brie $y$ sum $m$ arize a background of the norm al form theory for near integrable system $s$ of nonlinear dispersive equations. It is well-known that for a w ide class of nonlinear dispersive w ave equations, the leading order nonlinear equation in an asym ptotic expansion tums out to be given by an integrable system, such as the $K$ ortew eg-de $V$ ries ( $K$ dV ) equation in weak dispersion lim it and the nonlinear Schrodinger equation in strong dispersion lim it (see for exam ple 28]). This im plies that $m$ ost of the nonlinear dispersive $w$ ave equations are integrable at the nontrivial leading orders in an asym ptotic sense. Then a naturalquestion is to ask how the higher order corrections a ect to the integrability of the leading order equations. In [19], the e ect of the higher order corrections on one-soliton solution of the K dV equation was studied, and it was shown that the velocity of soliton is shifted by the secular term $s$ in the higher order term $s$. Those secular term $s$ or resonant term $s$ are given by the sym $m$ etries of the $K d V$ equation. T he nonsecular term $s$ then contribute to $m$ odify the shape of soliton. H ow ever the $m$ ulti-soliton interactions w ere not studied in that paper. In [14], the norm al form for $w$ eakly dispersive equations was rst introduced up to the second oreder corrections, and it was found that the integrable approxim ation can be extended beyond the $\mathrm{K} d V$ approxim ation but not to the second order. This obstacle to the asym ptotic integrability plays no rule for one-soliton solution, but provides a cruciale ect for tw o soliton interactions. This was found in 15, 16]. The obstacles are de ned as the nonexistence of the integrals of perturbed equation in the form of the power series in a sm all param eter. This w as also recognized as the nonexistence of approxim ate sym $m$ etries of the perturbed equation 21]. (T he norm al form for strongly dispersive $w$ ave equations has been also studied in [11, 18].) T hen in [15], the e ect of the obstacle on the interaction of tw o soliary w aves w as studied for the regularized long w ave equation (although the $m$ ethod can apply to other equations of weakly dispersive system ). A n inelasticity due to the obstacle w as found, and it leads to the shifts of the soliton param eters and a generation of a new soliton as well as radiations through the interaction.

In this lecture, we present a com prehensive study of the norm al form theory for weakly dispersive wave equations: We start in Section 2 to de ne the perturbed $K d V$ equation as an asym ptotic expansion of a weakly dispersive wave equation whose leading order equation is given by the $K$ dV equation. W e give a recursion form ula to generate the higher order corrections which $m$ ay be obtained by an asym ptotic perturbation $m$ ethod (see for exam ple 28]). The set of those higher order term sform san extended space ofdi erentialpolynom ialsw hich includes som e nonlocal term s. The space is denoted by $円_{\text {odd }}$, where \odd"im plies the weight of the polynom ial.

In Section 3, the conserved quantities or integrals of the $\mathrm{K} d V$ equation are review ed, and we discussed approxim ate integrals of the perturbed $\mathrm{K} d V$ equation. W e then obtain the conditions for the existence of approxim ate integrals in each order (P roposition 3.1). W e also discuss a connection of the conserved quantities and the N -soliton solutions of the $\mathrm{K} d V$ equation.

In Section 4, we review the sym $m$ etries of the $K d V$ equation, and discuss the approxim ate sym $m$ etries for the perturbed $K d V$ equation. H ere we also de ne the space of $ط_{\text {even }}$, which together w ith $ط_{\text {odd }}$ provides the appropriate spaces for the norm al form transform de ned in the next section.

In Section 5, we describe the nom al form theory. The norm al form transform ation is then obtained by a linear equation of an adjoint $m$ ap de ned as

where $K^{(0)}$ is the $K d V$ vector eld. The explicit form of the norm al form is given for the perturbed $K d V$ equation which contains the rst three low est weight approxim ate conserved quantities (P roposition 5.1). The norm al form then adm its one-soliton solution of the K dV equation, which con m s the result in 19]. W e also discuss the $G$ ardner $M$ iura transform ation which is an invertible version of the $M$ iura transform ation, and show that the inverse $G$ ardner $M$ iura transform ation is nothing but the norm al form transform ation after rem oving the sym $m$ etries of the $K d V$ equation (Proposition 52).

In Section 6, we consider the interaction problem of two solitary waves, and provides the explicit form ulae for the shifts of the soliton param eters (P roposition 6.1). we also give the form ulae of the radiation energy and additional phase shifts which are used to com pare w th the num erical sim ulations for som e exam ples in the next section.

F inally in Section 7, we present explicit exam ples including ion acoustic wave equation, the B oussinesq equation as a m odel of shallow water $w$ aves and the regularized long w ave equation. W e show the good agreem ents w ith the results obtained by the norm al form theory. W e also consider a 7th order H irota bilinear equation which adm its an exact two soliton solution but is know $n$ to be nonintegrable. W e look for an obstacle to the asym ptotic integrability, and nd that the obstacles appear at the fourth order. This im plies that the forth order obstacles play no rule for two soliton solution, just like all obstacles has no rule for one-soliton solution for the system $w$ th the rst three approxim ate integrals.

## 2. Perturbed K dV equation

U nder the assum ption of weak nonlinearity and weak dispersion, the w ave propagation in a one-dim ensional medium can be described by the $\mathrm{K} d V$ equation in
the leading order of an asym ptotic expansion. U sing an appropriate asym ptotic perturbation $m$ ethod (e.g. see [28]) one can show that the higher order correction to the $K d V$ equation has the follow ing expansion form $w$ ith a sm all param eter w th $0<1$,

## 3. C onserved quantities and $N$ soliton solutions

$T$ he integrability of the $K d V$ equation im plies the existence of an in nite num ber of conserved quantities or integrals. H ere we brie y sum m arize those quantities, and discuss the approxim ate integrals for the perturbed equation 2.1). The approxim ate integralsw illplay a fundam entalrole for the nom alform theory discussed in Section 5, and provide an analyical tool to study the nonitegrable e ect on the solution of the perturbed $\mathrm{K} d V$ equation.

O ne should note here that $m$ any physicalexam ples have severalconserved quantities, such as a totalm ass, $m$ om entum and energy, which $m$ ay be assigned as the rst three quantities $I_{1}[u ;] w$ ith $l=0 ; 1$ and 2 . $T$ hen the existence of the higher conservated quantity $I_{3}[u ;]$ is a key for the integrability of the perturbed equation. The item i) in P roposition 3.1 suggests the (asym ptotic) integrability of the perturbed equation 2.1) up to order. In fact, in Section $\$$, we transform the perturbed equation to an integrable system up to order, and discuss the e ect of the nonexistence of $I_{3}^{(2)}$, i.e. ${ }_{1}^{(2)} 0$, on the interaction behavior of tw o solitons.

## 5. Normal form theory

The norm al form theory has been well developed in the study of nite dim ensionaldynam icalsystem $s$ (cf. [3]). Them ain punpose ofthe norm alform is to classify the vector elds near critical points in tem s of the sym $m$ etries of the leading order equation. T his concept has been applied for the perturbed K dV equation as well as the nonlinear Schrodinger equation in $14,15,11,18]$.

In this section we review the norm alform theory for the perturbed $K d V$ equation [15, 16], and discuss the e ect of the obstacles on two-soliton interactions. W e also discuss the G ardner-M iura transform ation (which is an invertible version of the M iura transform ation) in term $s$ of the norm al form theory, and show that the $G$ ardner $M$ iura transform ation is just a norm al form transform ation.
5.1. N orm al form . The basic idea of the norm al form for the perturbed $\mathrm{K} d V$ equation is to rem ove all the nonresonant (nonsecular) term $s$ in the higher order corrections using a near identity transform ation given by the Lie transform ation.

Since the sym $m$ etries $K{ }_{0}^{(n)}(u)$ of the $K d V$ equation give the obvious resonant term $s$, we w rite each higher order term $K^{(n)}(u)$ in the form,

However as we have show n in P ropostion 3.1, there are conditions for the existence of approxim ate conserved quantities. T hus we expect to see obstacles in rem oving all the nonlinear term $s F^{(n)}(u)$ from the higher order corrections. In fact we have

## 6. Interactions of solitary waves

A s an im portant application of the norm al form theory, we consider the interaction problem of solitary waves, and show how the theory enables us to understand the interaction properties under the in uence of the higher orders in the perturbed $K d V$ equation 2.1). We assum $e$ that the perturbed equation possesses the rst three conserved quantities, i.e. $=f 0 ; 1 ; 2 g$. $T$ hen the rst obstacle appears in the order ${ }^{2}$ as ${ }_{1}^{(2)} 0$, that is, we consider the norm al form ,

Several physical exam ples of this type will be discussed in Section 7. We use the $m$ ethod of perturbed inverse scattering transform 12, 13] to analyze the norm al form. W e start $w$ th a brief description of the $m$ ethod.

In order to see the e ect ofobstacles, we now consider the interaction oftw o solitary waves, and show the inelasticity in the interaction which can be considered as a nonintegrable e ect of the obstacle.

Those results except for a new solitary wave production are consistent $w$ th the num erical observation in 国]. It $m$ ay be di cult to observe the new solitary wave from the num erical calculation, since this solitary $w$ ave has long $w$ idth and sm all am plitude $(3)^{2}$ which is of order ${ }^{8}$ (see below).

## 7. Examples

In this section, the norm al form theory is applied to som e explicit models including the ion acoustic wave equation, the B ousinesq equation as a m odel of the shallow water waves, and the regularized long wave equation (som etim es called BBM equation). We also carry out the num erical sim ulation for those exam ples and com pare the results $w$ th the predictions obtained from the norm alform theory such as the phase shift 6.5) and the radiation energy 6.4).

W e also consider the 7th order H irota K dV equation which is known to be nonintegrable even though it adm its an exact tw o solitary w ave solution. Them ain issue is to determ ine the order of the obstacle of the corresponding norm al form, which indicates an nonintegrability of the equation in the asym ptotic sense. It tums out that the obstacles appear at order ${ }^{4}$.
7.1. Ion acoustic waves. An asym ptotic property of the ion acoustic waves has been discussed in several papers (see for exam ple 2q]). These studies show that the $K d V$ equation is derived as the rst approxim ation of the ion acoustic wave equation under the weakly dispersive lim it. The higher order corrections to the K dV soliton solution have been also discussed in 19]. Recently, Li and Sattinger in 20] studied num erically the interaction problem of solitary waves and show ed that the am plitude of the radiation after tw o solttary w ave interaction can be observed as sm all as $10{ }^{5}$ order, and they concluded that the $\mathrm{K} d V$ equation gives an excellent approxim ation. H ere we explain those observations based on the norm al form theory developed in the previous sections.

Follow ing the $m$ ethod in 28], we rst derive the $K d V$ equation $w$ ith the higher order corrections. The ion acoustic wave equation is expressed by the system of three partial di erentialequations in the dim esionless form,

Since $f$ has an expansion of the power series of and each coe cient $f^{(n)}$ is an elem ent in $\prod_{\text {even }}^{(n)}$, the expressions of $n$; $v$ have the sam eform as of the norm al form transform ation. In the asym ptotic sense, all the physical variables are expressed by one function $u$ as $U=u R_{+}$. Then the choice of the higher order term $s f$ has a freedom. Then the $m$ ain purpose of the norm al form is to use this freedom to classify near integrable system $s$ in the asym ptotic sense.

W e now com pare the results in Section 6 w th num erical results. W e used the spectralm ethod 30] for the num ericalcom putation. For a conven ience, we consider 7.1) in a $m$ oving fram $e w$ th a speed $c$,

The core part is given by 7.1. for $=0.2$. $T$ hese gures show that the generation of the radiation can be suppressed by adding the higher order dressing term $s$ into the core.

N ow let us discuss the interaction of the two solitary waves. In Figure 2, we show the result of the phase shift of the solitary wave with the param eter $1_{1}\left(>2^{2}\right)$ for various values of $1 \quad 2$. Here we $x \quad 1+2=0: 5$ and $=\left(\begin{array}{l}2 \\ 1\end{array}{ }_{2}^{2}\right)=2^{\prime}$ $0: 07$. The solid line is calculated from the form ula 6.5), and the broken line is obtained by the num erical sim ulation. The phase shift of the $K d V$ soliton is also show $n$ as the dotted line. A s we can see that the phase shift form ula gives a good agreem ent to the num erical results. The energy of the radiation em itted after the interaction is caluculated from 6.4) and is shown in Figure 3. This show s that the radiation energy is of order $10{ }^{5}$ which also agrees w the result in 20]. Thus the norm al form theory provides an accurate description of the deviation from the $K d V$ equation.

Since this equation is truncated at the rst order from the shallow $w$ ater $w$ ave equation, the nom al form $m$ ay not provide a structure of the asym $p-$ totic integrability at the second order. H ow ever the B oussinesq equation itself has an interesting $m$ athem atical structure, such as the regularization at the higher dispersion regim $e$, and it $m$ ay be interesting to study its ow $n$ asym ptotic integrability. The norm al form for the shallow water wave equation has been studied in [17].

$N$ ow let us consider the phase shift during the tw o solitary wave interactions in the sam eway as the ion acoustic w ave equation. T he result is shown in Figure 4.
A gain, the num erical data of the phase shift can be well explained by the phase shift form ula. The tim e evolution of $\quad 1(t)$ is shown in Figure 5. This gure show $s$ that the energy of the radiation after the interaction is about the sam e as that for the ion acoustic wave equation.

The num erical sim ulations by B ona et al. [5] showed that the interaction of the solitary waves is inelastic and generates radiations. Their study also found the shifts of the am plitudes of tw o solitary waves after the collision. The norm al form theory has been applied to this equation in 15]. H ere we review the work 15] and add the phase shift results. W e also com pare the BBM equation $w$ th the ion acoustic wave equation and the B oussinesq equation.

The com parison of the phase shift between the num erical results and those by the form ula 6.5) is show $n$ in Figure 6. Because of the large value of ${ }_{1}^{(2)}$, the agreem ent betw een the num erical results and the results from 6.5) is poor. In the com putation, the value of ${ }^{2}{ }_{1}^{(2)}$ is about of order one, and thus one needs to consider m uch higher corrections to get a
