#### Abstract

W e connect quantum graphs w ith in nite leads, and tum them to scattering system s. W e show that they display all the features which characterize quantum scattering system $s$ w ith an underlying classical chaotic dynam ics: typical poles, delay time and conductance distributions, E ricson uctuations, and when considered statistically, the ensem ble of scattering $m$ atrices reproduce quite well the predictions of appropriately de ned $R$ andom $M$ atrix ensem bles. The underlying classical dynam ics can be de ned, and it provides im portant param eters which are needed for the quantum theory. In particular, w e derive exact expressions for the scattering $m$ atrix, and an exact trace form ula for the density of resonances, in term sofclassicalorbits, analogous to the sem iclassical theory of chaotic scattering. W e use this in order to investigate the origin of the connection between $R$ andom $M$ atrix $T$ heory and the underlying classical chaotic dynam ics. Being an exact theory, and due to its relative sim plicity, it o ers new insights into this problem which is at the fore-front of the research in chaotic scattering and related elds.

## 1. Introduction

Q uantum graphs of one-dim ensional w ires connected at nodes were introduced already m ore than half a century ago to m odel physical system s . D epending on the envisaged application the precise form ulation of the $m$ odels can be quite diverse and ranges from
 Lately, quantum graphs attracted also the interest of the quantum chaos community because they can be view ed as typical and yet relatively sim ple exam ples for the large class of system s in which classically chaotic dynam ics im plies univensal correlations in the sem iclassical lim it [13, 14, 15, 11, 17, 18, 19, 20, 21]. U p to now we have only a lim ited understanding of the reasons for this universality, and quantum graph models provide a valuable opportunity form athem atically rigorous investigations of the phenom enon. In particular, for quantum graphs an exact trace form ula exists [12, 13, 14] which is based on the periodic onbits of a m ixing classical dynam ical system. M oreover, it is possible to express two-point spectral correlation functions in term $s$ of purely combinatorial problem s 16, 17, 18, 19].

By attaching in nite leads at the vertioes, we get non-com pact graphs, for which a scattering theory can be constructed 22, 23, 24]. They display $m$ any of the feature that characterize scattering system $s$ with an underlying chaotic classical dynam ics [25, 26, 27, 28, 29], and they are the sub ject of the present paper. The quantum scattering $m$ atrix for such problem s can be written explicitly, together $w$ ith a trace form ula for the density of its resonances. These expressions are the analogues of the corresponding sem iclassical approxim ations available in the theory of chaotic scattering 25, 26, 27], albeit here they are exact. W ith these tools we analyze the distribution of resonances, partial delay times, and the statistics of the uctuating scattering am plitudes and cross sections. M oreover, we address issues like the statistical properties of the ensemble of the scattering $m$ atrioes, and conductance distribution. Finally we analyze the e ect of non-uniform connectivity on the statistical properties of the scattering $m$ atrix. A $m$ ain part of our analysis $w$ illibe focused on the com parison of the statistical properties of the above quantities w ith the Random M atrix Theory (RMT) predictions 39, 31, 32, 33, 32, 33, 36, 37, 38, 39, 40].

T he paper is structured in the follow ing way. In section (2), them athem aticalm odel is introduced and the $m$ ain de nitions are given. Section (3) is devoted to the derivation of the scattering $m$ atrix for graphs. The trace form ula for the density of resonances of quantum graphs is presented in section (4) which includes also the analysis of the underlying classical system. The next section, is dedicated to the analysis of various statistical properties of the $S \mathrm{~m}$ atrix. O ur num erical data are com pared both $w$ th the predictions of RM $T$ and w ith the sem iclassical expectations. Finally, in section (6), we analyze the class of star-graphs for which several results can be analytically derived. O ur conclusions are sum $m$ arized in section (7).

## 2. Q uantum G raphs: De nitions

W e start by considering a com pact graph G . It consists of V vertices connected by B bonds. The num ber of bonds which em anate from each vertex i de nes the valency $v_{i}$ of the corresponding vertex (for simplicity we will allow only a single bond between any two vertices). The graph is called $v$ regu lar if all the vertioes have the sam e valency $v$. The total num ber ofbonds is $B=\frac{1}{2} P_{i=1}^{V} V_{i}$. A ssociated to every graph is its connectivity $m$ atrix $C$. It is a square $m$ atrix of size $V$ whose $m$ atrix elem ents $C_{i ; j}$ take the values 1 if the vertioes $i ; j$ are connected with a bond, or 0 otherw ise. The bond connecting the vertioes $i$ and $j$ is denoted by b $(i ; j)$, and we use the convention that $i<j$. It will be som etim es convenient to use the \tim e reversed" notation, where the rst index is the larger, and $\hat{\mathrm{b}} \quad$ (j;i) with $j>$ i. W e shall also use the directed bonds representation, in which b and $\hat{\mathrm{b}}$ are distinguished as two directed bonds con jugated by tim e-reversal. W e associate the naturalm etric to the bonds, so that $\mathrm{x}_{\mathrm{i} ; \mathrm{j}}\left(\mathrm{x}_{\mathrm{j} ; \mathrm{i}}\right) \mathrm{m}$ easures the distance from the vertex i(j) along the bond. The length of the bonds are denoted by $L_{b}$ and we shall henceforth assum $e$ that they are rationally independent. The $m$ ean length is de ned by hLi $\quad(1=B)^{P}{ }_{b}^{B}=1 L_{b}$ and in allnum erical calculations bellow it $w$ ill be taken to be 1. In the directed-bond notation $L_{b}=L_{\hat{6}}$.

The scattering graph $G$ is obtained by adding leads which extend from M (V) vertices to in nity. For simplicity we connect at most one lead to any vertex. The valency of these vertices increases to $v_{i}=v_{i}+1$. The $M$ leads are denoted by the index i of the vertex to which they are attached while $x_{i}$ now $m$ easures the distance from the vertex along the lead i.

The Schrodinger operator (w ith $\sim=2 \mathrm{~m}=1$ ) is de ned on the graph $G$ in the follow ing way: On the bonds b , the components b of the totalwave fiunction are solutions of the one - dim ensional equation

where $A_{b}$ (w ith $<e\left(A_{b}\right) \quad 0$ and $A_{b}=A_{b}$ ) is a $\backslash m$ agnetic vector potential" which breaks the tim e reversal sym $m$ etry. In $m$ ost applications we shall assum $e$ that all the $A_{b}$ 's are equal and the bond index will be dropped. The com ponents of the wave functions on the leads, $i(x)$, are solutions of

At the vertioes, the wavefunction satis es boundary conditions which ensure current conservation. To im plem ent the boundary conditions, the com ponents of the wave function on each of the bonds b and the leads i are expressed in term s of counter propagating waves w ith a wave-vector $k$ :

The amplitudes $a_{b} ;$ on the bonds and $I_{i} ; O_{i}$ on the lead are related by 1


T hese equalities im pose the boundary conditions at the vertioes. T he vertex scattering $m$ atriaes ${ }_{j ; j}{ }_{j}^{(i)}$, are $v_{i} \quad V_{1}$ unitary sym $m$ etric $m$ atrices, and $j_{i} j^{0} g o$ over all the $v_{i}$ bonds and the lead which em anate from i. The unitarity of ${ }^{\text {(i) }}$ guarantees current conservation at each vertex.

On the right hand side of (4), the vertex scattering matrix (i) was w ritten explicitly in term $s$ of the vertex re ection amplitude ${ }^{\text {(i) }}$, the leadłoond transm ission am plitudes $f{ }_{j}{ }^{(i)} g$, and the $v_{i} \quad V_{1}$ bond bond transition $m$ atrix $\underset{j j^{0}}{(i)}$, which is sub unitary (jdet~(i) ${ }^{\text {j }}<1$ ), due to the coupling to the leads.
$G$ raphs for which there are no further requirem ents on the ${ }^{(i)}$ shall be referred to as generic. It is often convenient to com pute the vertex scattering $m$ atrix from a requirem ent that the wave function is continuous and satis es N eum ann boundary conditions at that vertex. T hese graphs shall be referred to as N eum ann graphs, and the resulting ${ }^{\sim}$ (i) m atrices read:

Vertioes which are not coupled to leads have ${ }^{i}=1 ; j_{j}^{(i)}=0$, while the bond $\quad$ bond transition $m$ atrix $\sim_{j: j^{0}}^{(i)}=\frac{2}{v} \quad j ; j^{0}$ is unitary.

## 3. The $S-m$ atrix for $Q$ uantum $G$ raphs

It is convenient to discuiss rst graphs w ith leads connected to all the vertioes $\mathrm{M}=$ $V$. The generalization to an arbitrarily number $M \quad V$ of leads (channels) is straightforw ard and w ill be presented at the end of this section.

To derive the scattering $m$ atrix, we rst w rite the bond wave functions using the tw o representations which are con jugated by \tim e reversal":

In other words, but for a phase factor, the outgoing wave from the vertex i in the direction $j$ is identical to the incom ing wave at $j$ com ing from $i$.

where 1 is the 2B 2B unit $m$ atrix. Here, the $\backslash$ bond scattering $m$ atrix" $S_{b}$ is a subunitary $m$ atrix in the 2 B dim ensional space of directed bonds which propagates the wavefiunctions. It is de ned as $S_{B}(k ; A)=D(k ; A) R^{r}$, w ith

$D(k ; A)$ is a diagonal unitary $m$ atrix which depends only on the $m$ etric properties of the graph, and provides a phase which is due to free propagation on the bonds. The sub-unitary matrix $R$ depends on the connectivity and on the bond-bond transition $m$ atrioes ~ . It assigns a scattering am plitude for transitions betw een connected directed bonds. $R$ is sub-untary, since

C om bining (11) for all leads $i=1 ;::: ; \mathrm{V}$, we obtain the unitary $\mathrm{V} \quad \mathrm{V}$ scattering $m$ atrix $S^{(N)}$,

From Eq. (12), we see that the scattering $m$ atrix $m$ ay be decom posed into two parts $S^{(N)}(k)=S^{D}+S^{f l}(k)$ which are associated w th tw o well separated tim e scales of the scattering process. $S^{D}\left(=i_{i} j^{i}\right)$ is the prom pt re ection at the entrance vertex and induces a \direct" com ponent. In general, it varies very slowly with energy, and is system dependent. On the other hand the \chaotic" com ponent of the $S$ matrix, $\mathrm{S}^{\mathrm{fl}}(\mathrm{k})$, starts by a transm ission from the incom ing lead $i$ to the bonds ( $i ; r$ ) w ith transm ission am plitudes ${ }_{r}^{(i)}$. The wave gains a phase $e^{i\left(k+A_{b}\right) I_{b}}$ for each bond it traverses and $a$ scattering am plitude $\sim_{r ; s}^{(i)}$ at each vertex. This multiple scattering inside the interaction region becom es apparent when the expansion

is substituted in (12). Eventually the wave is transm itted from the bond $(s ; j)$ to the lead $j w$ ith an am plitude ${ }_{s}^{(j)} \cdot \underset{X}{\text { Explicitly, }}$

where $T_{i!} j$ is the set of the trajectories on $G$ which lead from $i$ to $j$. $B_{\bar{p}}$ is the am plitude corresponding to a path $t w h o s e ~ l e n g t h ~ a n d ~ d i r e c t e d ~ l e n g t h ~ a r e ~ l_{t}={ }_{\mathrm{b} 2 \mathrm{t}} \mathrm{L}_{\mathrm{b}}$ and $t={ }^{P}{ }_{b 2 t} L_{b} A_{b}$ respectively. Thus the scattering amplitude $S_{i ; j}^{(V)}$ is a sum of a large num ber of partialam plitudes, whose com plex interference brings about the typical irregular uctuations of $j_{i ; j}^{(N)} \rho$ as a function ofk.

O ne of the basic concepts in the quantum theory of scattering are the resonances. T hey represent long-lived interm ediate states to which bound states of a closed system are converted due to coupling to continua. On a form al level, resonances show up as poles of the scattering $m$ atrix $S^{(M)}$ occurring at com plex wave-num bers ${ }_{n}=k_{n} \quad \frac{i}{2} \quad n$, where $k_{n}$ and ${ }_{n}$ are the position and the $w$ idth of the resonances, respectively. From (12) it follow $s$ that the resonances are the com plex zeros of

The eigenvalues of $S_{B}$ are in the unit circle, and therefore the resonances appear in the lower half of the complex plane. M oreover from Eq. (15) it is clear that their form ation is closely related to the intemal dynam ics inside the scattering region which is govemed by $S_{\mathrm{B}}$.

There exists an intim ate link between the scattering $m$ atrix and the spectrum of the corresponding closed graph. It $m$ anifests the exterior -interior duality 41] for graphs. The spectrum of the closed graph is the set of wave-num bers for which $S^{(V)}$ has +1 as an eigenvalue. This corresponds to a solution where no currents ow in the leads so that the conservation of current is satis ed on the intemalbonds. 1 is in the spectrum of $S^{(V)}$ if

In contrast to $R, R$ is a unitary $m$ atrix in the space of directed bonds, and therefore the spectrum is real. (18) is the secular equation for the spectrum of the com pact part of the graph, and it was derived in a di erent way in 133.

The di erence $R=R \quad R$ gets sm aller as larger graphs are considered (for graphs w ith $N$ eum ann boundary conditions it is easy to see that the di erence is of order $\frac{1}{v}$ ). That is, the leads are weekly coupled to the com pact part of the graph, and one can use

perturbation theory for the com putation of the resonance param eters. To low est order, ( $R=0$ ), the resonances coincide w th the spectrum of the com pact graph. Let $k_{n}$ be in the spectrum. H ence, there exists a vector jni which satis es the equation

To rst order in $R$, the resonances acquire a width

To check the usefulness of this result, we searched num erically for the true poles for a few scattering graphs and com pared them with the approxim ation (2d). In gure 1 we show the com parison for fully connected $N$ eum ann graphs with $V=5 ; 15$ and $A=0$. As expected the agreem ent between the exact poles and the perturbative results im proves as $v$ increases.

W e nally comment that the form alism above can be easily $m$ odi ed for graphs where not all the vertices are attached to leads. If the vertex $l$ is not attached, one has to set ${ }^{(1)}=1 ;{ }_{j}^{(1)}=0$ in the de nition of ${ }^{(1)}$. The dim ension of the scattering $m$ atrix is then changed accordingly.

For the sake of com pleteness we quote here an altemative expression for the $S$ $m$ atrix which applies for $N$ eum ann graphs, exchusively [14]. For this punpose we de ne the V V matrix

Here $W_{i_{1} ; j}=i_{i_{i} ; j}$ is the $M \quad V$ leads-vertioes coupling $m$ atrix, ( $W=1$ when $M=V$ ). $T$ his form of the $S$ matrix is rem iniscent of the expression which was introduced by $W$ eidenm uller to generalize the B reit- W igner theory for $m$ any channels and intemal states. H ow ever, (23) is an exact expression which involves no truncations.

It follows from (23) that in the present case, one can identify the poles of the $S$ $m$ atrix $w$ th the zeros of

Its $m$ ain advantage over (15) is that it involves a determ inant of a $m$ atrix ofm uch lower dim ension.
4. The trace form ula for resonances and classical scattering on graphs

In the spectral theory ofbounded ham iltonian system $s$, the $m$ ost fundam ental ob ject of study is the spectraldensity which consists ofa sum of functions at the spectralpoints. For open system s , it is replaced by the resonance density, which is de ned on the realk line and consists of an in nite sum of Lorentzians which are centered at $k_{n}=<e_{n}$ and have width ${ }_{n}=2=m_{n}$, where ${ }_{n}$ are the com plex poles of the scattering $m$ atrix. In the present section we shall express the resonance density for scattering graphs in term $s$ of periodic orbits of their com pact part. This is the analogue of the trace form ula for bounded graphs.

### 4.1. The T race Form ula

The resonance density $d_{R}(k)$ can be deduced from the total phase (k) = $\frac{1}{i} \ln \operatorname{det} S^{(M)}(k)$ of the scattering $m$ atrix 43]:

It is a $s m$ ooth function for real $k$, and can be intenpreted as the $m$ ean length of the delay associated $w$ th the scattering at wave-num ber $k$ 26].

U sing Eq. (12) and perform ing standard $m$ anipulations [42], we obtain the follow ing expression for the phase (k)

where $L=2^{P}{ }_{b=1}^{B} L_{b}$ is tw ice the total length of the bonds of $G$.

### 4.2. C lassical D ynam ics

W e conclude this section with the discussion of the classical dynam ics on the graph $G$. A classical particle $m$ oves freely as long as it is on a bond. The vertices are singular points, and it is not possible to write dow $n$ the analogue of the $N$ ew ton equations there. In [13, 14] it was show $n$ that it is possible to de ne a classical evolution on the graph: A P oincare section on the graph consists of the discrete set of directed bonds. The phase-space density at a (topological) tim en is the set ofoccupation probabilities $b(n)$ of the directed bonds, and the classical evolution is govemed by a $M$ arkovian $m$ aster equation. A pplied to the com pact part of a scattering graph it reads,

In jecting a particle from the leads to the scattering dom ain, its probability to be on any bond random izes, because at each vertex a $M$ arkovian choice of one out of $v$ directions is $m$ ade. The longer a particle rem ains $w$ thin the interaction regim $e$, the $m$ ore scattering events it experiences. The set of trapped trajectories whose occupancy decays exponentially in time is the analogue of the strange repeller in generic H am iltonian system s displaying \chaotic scattering".

## 5. Statistical A nalysis of the $S$ matrix

So far we developed the scattering theory of graphs, pointing out their sim ilarity w ith scattering system swhich display chaotic scattering in the classical lim it. D ue to the interference of a large num ber of am plitudes, the $S$ matrix uctuates as a function of $k$, and its further analysis calls for a statistical approach which w ill be the sub ject of the present section. We shall show that quantum graphs possess typical poles, delay time and conductance distributions, E ricson uctuations of the scattering am plitudes, and when considered statistically, the ensemble of scattering $m$ atrices are very well reproduced by the predictions of RM T. At the sam etim e deviations from the universal RM T results, which are related to the system - speci c properties of som e graphs, will be pointed out. The study of these deviations is especially convenient for graphs because of the transparent and sim ple scattering theory developed in term s of scattering tra jectories.

An im portant param eter which is associated w ith the statistical properties of the $S$-m atrix is the E ricson param eter de ned through the scaled $m$ ean resonance width as:

where $h{ }_{k}$ idenotes spectral averaging and is the $m$ ean spacing between resonances. The E ricson param eter determ ines whether the resonances overlap ( $h i_{k}>1$ ) or are isolated ( $h i_{k}<1$ ). Typical example for the two extreme situations are show $n$ in gure 2.

The degree of resonanœ overlap determ ines the statistical properties of the S$m$ atrix. W e shall show in the sequel that the $m$ ean $w$ idth can be approxim ated by the classical decay rate $h i_{k}={ }_{c l}$. For the $v$ regular graphs discussed above, we have

### 5.1. T he resonance w idth distribution

Since the bond lengths are rationally independent, we nd that $G$ depends on a nite num ber ofincom $m$ ensurate frequencies. H ence, the integral can be replaced by a phase space average,

An im portant feature of the distribution of the resonances in the com plex plane can be deduced by studying the secular function $G_{G}() \cdot$. $\operatorname{Consider~} G_{G}(=0)$. If one of the eigenvalues of the $m$ atrix $R$ ( 9 ) takes the value $1, G(k=0)=0$ and because of the quasi-periodicity of $G$, its zeros reach any vicinity of the realaxis in nitely many tim es. $T$ he largest eigenvalue of the $R \mathrm{~m}$ atrix for $v$-regular $N$ eum ann graphs is 1 , and therefore the distribution of resonance $w$ idths is nite in the vicin ity of $=0$. For generic graphs, the spectrum of $R$ is inside a circle of radius $m$ ax $<1$. This implies that the poles are exchuded from a strip just under the real axis, whose w idth can be estim ated by

$T$ he distribution of the com plex poles for a generic fully connected graph with $\mathrm{V}=5$ is shown in gure 3a. The vertical line which $m$ arks the region from which resonances are excluded was com puted using (42).
$R$ andom $m$ atrix theory can provide an expression for the distribution of resonances. In the case ofnon-overlapping resonances, perturbation theory show s that the resonance w idths are distributed according to the so-called ${ }^{2}$ distribution

It show s that in the lim it of large num ber of channels there exist a strip in the com plex
plane which is free of resonances. This is in agreem ent with previous ndings 27, 39, 44]. In the case of $m$ axim al coupling ie. $g=1$, the pow er law 46) extends to in nity, leading to divergencies of the various $m$ om ents of 's. U sing (43) we recover the well known M oldauer-Sim onius relation 30] for the $m$ ean resonance width 37]

The resonance width distribution for a $V=5$ regular and generic graph is shown in gure 3b together w th the RM T prediction, which reproduces the num erical distribution quite well. Figure 4 show s a sim ilar com parison for a $N$ eum ann graph. T he relatively high abundance of resonances in the vicinity of the real axis conform $s$ w ith the expectations.

### 5.2. The Form Factor

To investigate further the dynam ical origin of the resonanœe uctuations, we study the resonance two-point form factor $K$ ( $t$ ). Them ain advantage of $K$ ( $t$ ) is that it allow s us to study the resonance ${ }_{Z}$ uctuations in term s of classical orbits. It is de ned as

This is reasonable since an open system cannot be distinguished from a closed one during short tim es. This simple approxim ation is checked in the inset of gure 5 (see dashed line) and it is show $n$ to
reproduce the num erical data rather well in the dom ain $t \quad 5$. The asym ptotic decay is dom inated by the resonances which are nearest to the gap, and it cannot be captured by the crude argum ent presented above. For generic graph, $K_{R}$ decays exponentially but w ith a rate given by as $=$ gap (the best $t$, indicated in gure 5 by the dashed line, give as which agrees with gap within 30\%). For the graph with Neum ann boundary conditions, gap $=0$ and one expects an asym ptotic pow er-law decay. The corresponding best $t$ (sed dashed line in gure 5) showst ${ }^{2}$.

In $H$ am iltonian system $s$ in $m$ ore than one dim ension, the size of the spectral interval k where the spectral average is perform ed is lim ited by the requirem ent that the sm ooth part of the spectral density is approxim ately constant. H ere instead we can take arbitrarily large spectral intervals since the sm ooth spectral density is constant [13, 14]. This way, one can reach the dom ain where the function $K_{R}(t)$ is com posed of arbitrarily shanp spikes which resolve com pletely the length spectrum for lengths which are both sm aller and larger than $l_{1}$. In the inset of gure 5 we show the num erical $K$ ( $t$ ) calculated w ith high enough resolution. In the same inset we $m$ ark with arrow s the location of the lengths of short periodic onbits. W e notice that as long as tL is shorter than the length of the shortest periodic orbit, $K(t)=0$. W ith increasing $t$, the periodic orbits becom e exponentially dense and therefore the peaks start to overlap, giving rise to a quasi continuum described approxim ately by Eq. (51).

### 5.3. E ricson uctuations

A s w as m entioned above, the scattering cross sections are dom inated by either isolated resonances, or by overlapping resonances whose uctuations follow a typical pattem. These pattems were rst discussed by E ricson 45] in the fram e of nuclear physics and were show $n$ to be one of the $m$ ain attributes of chaotic scattering 26]. The transition betw een the tw o regim es is controlled by the E ricson param eter (37). Typical uctuating cross sections are shown in gure 2.

A convenient $m$ easure for Ericson uctuations is the autocorrelation function

The contribution of longer orbits are approxim ated by using the diagonal approxim ation, which results in a Lorentzian w th a width Er . Including explicitly up to $\mathrm{n}=3$ scattering events we get,

where $G$ is determ ined by the condition $C(=0 ;)=1$. The intenplay between the contributions of long and short periodic onbits is shown in gure 6. For overlapping resonances, the autocorrelation function is well reproduced by a Lorentzian while for the case of isolated resonances one can clearly see the contributions of short paths.

In gure 7 we report the $m$ ean resonance width $h i_{k}$ calculated num erically for various graphs, the param eter er extracted from the best $t$ of the num erical C ( ) with Eq. (53), togetherw ith the RM T prediction Eq. (47), and the classicalexpectation given by Eq. (38). The results justify the use of the classical estim ate especially in the $\lim$ it $V$ ! 1 for $x e d V=V$ (which is the analogue of the sem iclassical lim it). In this lim it, the RM T and the classical estim ate coincide.

### 5.4. S m atrix statistics

O ne can check further the applicability of RM $T$ by studying the entire $S^{(M)}$ matrix distribution function. The probability density ofM $\quad M$ unitary $S^{(M)}$ m atrioes is de ned in a $M+M(M \quad 1)=2$ param eter space and was found rst in [3]] to be given by the Poisson K emel

where C is a norm alization constant which depend on the sym m etry class. All system speci c relevant inform ations are included in the ensemble average $S^{(M)}$ matrix, de ned as $S_{i ; j}=h S^{D} i_{k}$. For regular graphs, $S$ is proportional to the unit $m$ atrix ie. $S_{i ; j}=\frac{1 \mathrm{~V}}{1+\mathrm{v}} \mathrm{i}_{\mathrm{i} j}$, while the eigenvectors are distributed uniform ly and independent from the eigenphases. The invariant $m$ easure $d \quad(S)$ is given as
where $d$ is the solid angle on the $M$ dim ensional unit hyper-sphere.
For large M values, a num ericalcheck of this probability distribution is prohibitive. However, for M = 2 one can nd easily the exact form of (54) and compare with the num erical results. The resulting distribution of the eigenphases 1 ; 2 of the 2 scattering $m$ atrioes of regular graphs is given by

we get the corresponding distribution functions $\mathrm{P}_{\mathrm{S}}(!)$ and $\mathrm{P}_{\mathrm{S}}(\mathrm{)}$. O ur num erical results for an ensam ple of $S$ m atrices calculated for di erent realizations of the lengths of the graphs are reported in gure 8 together w th the RMT predictions (56) for a regular graph w th two channels. A $n$ overall good agreem ent is seen both for $A=0$ and $A \notin 0$.

### 5.5. P artial delay tim es statistics

$T$ he $W$ igner delay tim e captures the tim e-dependent aspects of quantum scattering. It can be intenpreted as the typical tim e an alm ost $m$ onochrom atic wave packet rem ains in the interaction region. It is de ned as

where $i$ are the eigen-phases of the $S^{(M)}$ m atrix. The partial derivatives $\frac{@_{i}(k)}{@ k}$ are the partial delay tim es and their statistical properties were studied extensively within the RMT 35, 37, 39]. For the one-channel case it was found 37, 39] that the probability distribution of the scaled (w th the $m$ ean level spacing ) partial delay tim es $\mathrm{T}_{\mathrm{i}}=\frac{-}{2} \frac{\varrho_{\mathrm{i}}(\mathrm{k})}{@ k}$ is

where $I_{0}(x)$ stands for the $m$ odi ed Bessel function.
To investigate the statistical properties of the partial delay tim es for our system we had calculated P (T) for various graphs. The resulting distributions are shown in gure 9 together w th the RM T predictions (58,59). An overall agreem ent is evident.

D eviations appear at the short tim e regin e (i.e. short orbits), during which the \chaotic" com ponent due to m ultiple scattering is not yet fully developed 28].

### 5.6. C onductance D istribution

D ue to the recent experim ental investigation ofelectronic transport through m esoscopic devices [4]], the study of the statistical properties of the conductance gained som e im portance. For a device connected to reservoirs by leads, the Landauer- Buttiker form ula relates its conductance $G$ to the transm ission coe cient $T_{G}$ by the expression $\mathrm{G}=\left(2 \mathrm{e}^{2}=\sim\right) \mathrm{T}_{\mathrm{G}} . \mathrm{W}$ hen each lead supports one channel, the transm ission coe cient can be written in term $s$ of the $S^{(M)} m$ atrix as
$w$ here $j$ is the input channel.
In the absence of direct processes, the distribution of conductance $P\left(T_{G}\right)$ for arbitrarily num ber of channels was worked out within RM $T$, and the results describe in a satisfactory way both the num erical calculations and the experim ental data (for a review see 4d] and references therein). However in cases where direct processes appear signi cantly, one m ust use the P oisson's kemel (54) in its fullgenerality. This is exactly the case w ith $N$ eum ann graphs since $S \in 0$. The probability distribution of the transm ission $T_{G}$ is then

 equivalent channels $S_{11}=S_{22}=S$, Eq. 61) can be w orked out analytically 34] in the lim it of strong re ection and $T_{G} \quad 1$. The resulting expression is:

O ur num erical results for a regular graph w ith two leads are plotted in gure 10 together w th the RM T results 61,62,63). N otioe that, the sm all conductances are em phasized, because of the presence of direct re ection and no direct transm ission. At the sam e tim e, the most pronounced di erences betw een the tw o sym $m$ etry classes are for $\mathrm{T}_{\mathrm{G}} \quad 1$, where for $=1$ the conductance distribution diverges while it take a nite value for $=2$.

## 6. Scattering from star-graphs.

So far, we have studied scattering from well connected graphs, and we have shown that $m$ any statistical properties of the scattering $m$ atrix are described by RMT.We shall dedicate this section to dem onstrate the statisticalproperties of the $S \mathrm{~m}$ atrix for graphs which have non-uniform connectivity.

A representative example of this category are the \star" (or \Hydra") graphs 14, 16]. They consist of $v_{0}$ bonds, all of which em anate from a single com $m$ on vertex labeled w th the index $i=0$. The vertex at $i=0, w$ ill be referred to in the sequel as the head. The total num ber of vertioes for such a graph is $V=v_{0}+1$, and the vertioes at the end of the bonds will be labeled by $i=1 \quad 0$. The star is a bipartite graph, $a$ property which im plies e.g., that there exists no periodic orbits of odd period [14]. To tum a star graph into a scattering system we add a lead to its head.

It is a simple $m$ atter to derive the scattering $m$ atrix $S=S^{(M=1)}$ for a $N$ eum ann star. It reduces to a phase factor,

which can be used as a starting point for the exact evaluation of the poles. For the latter one has to perform a self consistent search for the com plex zeros of the secular equation (66). This is a time consum ing process and the correct choice of the initial conditions is very im portant.

In gure 11 we present our num erical results for the distribution of rescaled resonance $w$ idths $P()$ for a star $w$ ith $v_{0}=20$. The data are in excellent agreem ent with the RM T expectation given in Eq. (44). W e point that in this case the coupling to the continuum is weak since $g^{\prime} 10 \quad 1$ and therefore the ${ }^{2}$-distribution w th $\mathrm{M}=1$ is applicable.

U sing Eq. (64) we get the follow ing relation for the scaled delay tim es

which can be used to generate $P$ ( $T$ ). The latter is reported in gure 12 together with the RM T prediction (59). We notioe that although the tail of the distribution agrees reasonably wellw th the RM T prediction, there are considerable deviations at the origin .

A peculiarity of the star graph is that the $m$ ean tim e delay is tw ioe larger than the expected one from sem iclassical considerations. To be $m$ ore speci $c$, for a generic chaotic system coupled to $M$ channels, one has 41]

(69) that $\mathrm{hT} \mathrm{i}_{\mathrm{k}}{ }^{\prime} 2 \mathrm{cl}$. H ow ever, due to the fact that all the periodic orbits on the star graph are self tracing we get an additional factor of 2 and thus

Substituting Eq. (74) we get eventually that $h T i_{k}=\frac{1+v_{0}}{v_{0}} \mathrm{v}_{0}!1!1$ which indicate that the $m$ ean time a particle spend inside the interaction regim e is proportional to the H eisenberg time. O ur num erical calculations reported in the lower inset of Fig. 12 agrees nicely $w$ th the sem iclassical prediction 70).
$F$ inally, we analyze the distribution of $S$ when generated over di erent realizations of the lengths of the bond. For the one channel case this is equivalent with the distribution $P()$ of the phase of the $S-m$ atrix. To derive the latter, it is convenient to rew rite the $S$ m atrix in the follow ing form

Equation (77) reproduces the Poisson's kemel for a one-channel scattering matrix, derived in the fram ew ork ofRM T 37]. T he conditions under which this result is derived in 37] are ful lled exactly in the present case. O ur num erical results are reported in gure 13 and are in excellent agreem ent with the theoretical prediction Eq. 77).

## 7. C onclusions

In this paper, we tumed quantum graphs into scattering system s. W e show that they com bine the desirable features ofboth behaving \typically" and being $m$ athem atically sim ple. Thus, we propose them as a convenient tool to study generic behavior of chaotic scattering system s.

The classical dynam ics on an open graph was de ned, and the classical staying probability was shown to decay in an exponential way. The resulting classical escape rate was calculated and used to describe the properties of the corresponding quantum system. The scattering $m$ atrix was written in term $s$ of classical orbits and an exact trace form ula for the resonance density was found. A gap for the resonance widths has been obtained for \generic" graphs and its absence was explained for $N$ eum ann graphs. An analysis of the cross section autocorrelation function was perform ed and its non-universal characteristics were explained in term s of the short classical scattering tra jectories. F inally, due to the relative ease by which a large num ber of num ericaldata can be com puted for the graph $m$ odels, we had perform ed a detail statistical analysis of delay tim es, resonance widths and distribution of the $S$ m atrix. O ur results com pares well w ith the predictions of RM T indicating that our model can be used in order to understand the origin of the connection between RM T and the underlying classical chaotic dynam ics.

The results reported here, com plete our previous investigations on graphs. W e conclude that quantum graphs may serve as a convenient paradigm in the area of quantum chaos, both for spectral and scattering studies.
