Forced Burgers Equation in an Unbounded Domain

The inviscid Burgers equation with random and spatially smooth forcing is considered in the limit when the size of the system tends to in nity. For the one-dimensional problem, it is shown both theoretically and numerically that many of the features of the space-periodic case carry over to in nite domains as intermediate time asymptotics. In particular, for large time T we introduce the concept of T-global shocks replacing the notion of main shock which was considered earlier in the periodic case (1997, E et al., Phys. Rev. Lett. 78, 1904). In the case of spatially extended system s these objects are no anymore global. They can be de ned only for a given time scale and their spatial density behaves as (T) T²⁼³ for large T. The probability density function p(A) of the age A of shocks behaves asymptotically as A⁵⁼³. We also suggest a simple statistical model for the dynam ics and interaction of shocks and discuss an analogy with the problem of distribution of instability islands for a simple rst-order stochastic di erential equation.

K ey words: Burgers turbulence, stochastic forcing, shock discontinuities

I. IN TRODUCTION

The d-dim ensional forced Burgers equation

$$\theta_t u + (u r) u = r r (r (x;t); u = r (1.1))$$

which describes the dynam ics of a stirred, pressure less and vorticity-free uid, has found interesting applications in a wide range of non-equilibrium statistical physics problem s. It arises, for instance, in cosm ology where it is known as the adhesion model [1], in vehicular tra c [2] or in the study of directed polymers in random media [3]. The associated H am ilton {Jacobi equation, satis ed by the velocity potential ,

has been frequently studied as a nonlinear model for the motion of an interface under deposition : when the forcing potential F is random, delta-correlated in both space and time, Eq. (1.2) is the well-known Kardar{Parisi{ Zhang (KPZ) equation [4]. The case with large-scale forcing was considered in Refs. [5, 6] as a natural way to pump energy in order to maintain a statistical steady state. Burgers equation is then a simple model for studying the in uence of well-understood structures (shocks, preshocks, etc) on the statistical properties of the ow. As it is well known, Eq. (1.1) in the lim it of vanishing viscosity (! 0) displays after a nite time dissipative singularities, namely shocks, corresponding to discontinuities in the velocity eld. In the presence of large-scale forcing, it was recently stressed for the one-dimensional case [7, 8] and also for higher dimensions [9, 10], that the global topological structure of such singularities is strongly related to the boundary conditions associated to the equation. More precisely, when, for instance, space periodicity is assumed, a generic topological shock structure can be outlined. It plays an essential role in understanding the qualitative features of the statistically stationary regime.

So far, the singular structure of the forced Burgers equation was mostly investigated in the case of nite-size system swith periodic boundary conditions. It is how ever frequently of physical interest to investigate instances where the size of the domain is much larger than the scale, so as to exam ine, for exam ple, the role of G alilean invariance [11]. The main goal of the present paper is to describe the singular structure of Burgers equation (1.1) in unbounded dom ains. To achieve this goal we consider the case of spatially periodic forcing with a forcing scale L_{f} much smaller than the system size L. More precisely, we assume that the force is random and white in time, hom ogeneous, isotropic, sm ooth and L-periodic in space and investigate the lim it $L = L_f$ 1, while keeping a constant in jection rate of energy. Hence, for a xed size of a system L we consider a stationary regime corresponding to the lim it t! 1 and then study the lim it L! 1 with the L² norm of the forcing growing like L. As we will see, most of the concepts associated to in nite time asymptotics introduced for the periodic case can be generalized in this lim it as interm ediate tim e asym ptotics.

It is important to mention that the problem we are discussing has also another interpretation which has no direct relation to Burgers equation. In fact, we are studying the structure of singularities for variational problem s associated to generic time-dependent Lagrangians in unbounded domains. From this point of view the random forcing is just a natural way to characterize generic timedependence.

The paper is organized as follows. In Sec. II we give a brief exposition of the theory in the case of periodic forcing. In particular, we introduce the variational approach to Burgers turbulence and present results on the existence and the uniqueness of the main shock and the globalm in in izer. In Sec. III we introduce the notion of T-global shocks and describe their behavior in the time asymptotics L_f=u_{ms} Т $L=u_{m s}$, where $u_{m s}$ is the root-m ean-square velocity. W e also discuss theoretical and num erical results for the density of T-global shocks and the probability density function (PDF) of the age of shocks. In Sec. IV, we discuss an analogy with stability theory for one-dimensional stochastic ordinary differential equation (ODE) and present a simple statistical model for the interaction of shocks. Section V contains concluding remarks and, in particular, an interpretation of the results in term s of an inverse cascade. M ost of the results of this paper are focusing on the one-dimensional case. We nish with a brief discussion of possible extensions to the multi-dim ensional case.

II. PERIODIC FORCING

In the case of sm ooth spatially periodic forcing potential F (x;t), it was shown in the one-dimensional case [8] and for higher dimensions [9] that a statistical steady state is reached at large times by the solution to the Burgers equation. Taking the initial time at 1, the velocity eld is periodic in space and uniquely determ ined by the realization of the forcing. At an arbitrary time t, this unique solution can be expressed in term softhe following variational principle [12, 13, 14] involving the Lagrangian action A:

The minimum in (2.1) is taken over all absolutely continuous curves () of \mathbb{R}^d with 2 (1;t] such that

(t) = x.A curve m inim izing the action in (2.1) is called a one-sided m inim izer. It corresponds to a uid particle trajectory which is not absorbed by shocks till time t. For all times < t, such a m inim izer is a trajectory of the dynam ical system corresponding to the Lagrangian ow and thus satis as the Newton equation

Since the force is potential and spatially periodic, the mean velocity

is the rst integral of (1.1). When the initial time is taken at 1, so that the statistically stationary regime is reached, the mean velocity b is the only information remaining from the initial condition. For simplicity, we consider in the sequel the case of a vanishing mean velocity (b = 0), but all the results remain true for arbitrary b.




FIG. 1: Sketch of the unwrapped picture in space-time for d = 1; each m in in izer converges backward in time to one of the periodic in age of the global m in in izer. The main shock is de ned as the location from which emanate two m in in izers approaching di erent in ages of the global m in in izer.

It is easy to show that for Lebesgue alm ost all x there exists a unique one-sided m in im izer. The locations where there are more than one minim izer correspond to shock positions. Those are exactly the positions where the velocity potential (x;t), which is a Lipschitz function, is not di erentiable, so that the piecew ise continuous velocity eld u(x;t) = r(x;t) has jump discontinuities. 1, all the one-sided m in im izers which origi-Ast! nated at time t converge backward-in-time to the trajectory of the unique uid particle which is never absorbed by a shock. This trajectory, denoted $_{\rm cm}$ (), is called the global m in im izer because it is an action-m in im izing trajectory at any time. The statem ent about uniqueness of the globalm in in izer holds under som e natural conditions on the forcing potential (see, e.g., Refs. [8, 9]). Shocks are generically born at some nite time and then grow and merge. There exist a particular shock structure, called the main shock (d = 1) or the topological shock (d > 1)which has always existed in the past. This shock can be constructed by unw rapping the picture to the whole space \mathbb{R}^d (see Fig. 1 for the case d = 1). We then obtain a lattice of periodic boxes, each of them containing a periodic in age of the global m in in izer and the topological shock corresponds to the set of x-positions giving rise to severalm in in izers that approach di erent global m in im izers belonging to di erent im ages of the periodic box.

We focus now on the one-dimensional case with a space-periodic forcing potential of period L. In this case, the global m in im izer is a hyperbolic trajectory of (2.3) and is thus associated to a smooth unstable manifold which is a smooth curve in the position-velocity phasespace (x;u). The main shock is de ned as the unique position giving rise to the left-m ost and the right-m ost onesided m in im izers approaching the global one backwardin-time. By de nition, the trajectory of the globalm inim izer $_{\rm om}$ (t) and the main shock trajectory X $_{\rm ms}$ (t) never intersect, so that they have to satisfy $X_{ms}(t) < qm(t) <$ $X_{ms}(t) + L$. Hence, the large-scale displacement of the two-sided m in imizer is the same as for the main shock. The Lagrangian ow (2.3) is a second-order stochastic ODE. Assuming the vanishing of the mean velocity b, one may be tempted to think that the displacement of a typical trajectory (t) scales like the integral of the Brownian motion:

However this scaling does not apply to the minimizers because the particularity of such trajectories cannot be ignored. Indeed, when investigating the typical displacement of the global minimizer, we might hat

This result was obtained by num erical study of the behavior at large times of the position of the main shock. This gives the large-time typical displacement of the position of the main shock which, as we have seen above, coincides up to a constant with the displacement of the global minimizer. For the num erical investigation, we




FIG.2: A verage over 500 realizations of the position X (t) of the main shock as a function of time for b = 0 and a space-periodic forcing with period $L = L_f$.

chose a forcing which is the sum of independent random impulses acting at discrete \kicking" times [15]. Between successive kicks, the solution to the Burgers equation decays. This method is particularly e cient for obtaining the solution in the lim it of vanishing viscosity, as one can use between kicks the fast Legendre transform method [16] which is directly connected with the variational principle (2.1) and the Lagrangian picture of the ow. The position of the main shock is obtained by a Lagrangian method which is based on the analysis of the right-most and the left-most positions from which the two-sided minimizer is approached. Figure 2 shows the di usive-like behavior of the main shock trajectory for a G aussian forcing con ned to the rst three Fourierm odes in the case when the mean velocity b vanishes.

The di usive behavior of the global minim izer has also a simple theoretical explanation. Indeed, the mean square displacement of the global minim izer can be expressed through its velocity as

where the velocity of the globalm in in izer $_gm$ (s) is a stationary random process. The hyperbolicity of the global m in in izer in plies that the time correlations for this process decay exponentially. Hence, there are just two possibilities: the m ean-square displacem ent (2.7) either grows linearly with time, which gives (2.6), or it stays bounded in a lim it t! 1 . The latter behavior can be easily ruled out since the trajectory of the globalm in im izer does uctuate.

III. STAT IST ICS OF T-SCALES IN LARGE-SIZE SYSTEM SAND PDF FOR THE AGE OF SHOCKS.

As we have discussed above, the existence of the main shock in the spatially periodic situation follows from a simple topological argument. The main shock is unique when the system is considered on the torus corresponding to its period (circle for d = 1). However, if the system is considered on the whole realline (universal cover), then there exists, at each m om ent of time, an L-periodic one-dimensional lattice of main shocks. Each of these shocks is associated to two minimizers (left-most and right-most) which also form a periodic structure. In the case of the main shocks the distance between these two m in im izers tends to L as t ! 1 . For all other shocks the corresponding distance tends to 0. In this sense, the main shocks are the only global shocks present in the system. There is also another way to characterize the main shock. Namely, the main shock is the only shock which existed forever in the past, that is, the main shock is in nitely old, contrary to all other (local) shocks, all of them being created at a nite time and hence having a nite age. In other words, local shocks can be traced backward in time only for a certain nite interval of time. The length of this time interval is what we call the age A of the shock.

W hen we drop the periodicity condition and consider large-size systems, the main shock disappears. But one can still introduce the notion of T-global shocks, that is shocks which behave like the main shock when observed during a tim e scale of the order of T. As in the case of periodic boundary conditions, there are now also two equivalent ways to characterize T-global shock. Geometrically, one can again consider left-most and right-most minim izers associated to a given shock. A fter tracing them backward in time for time intervals longer than a certain \correlation time", these two m in im izers are getting close and start converging to each other exponentially fast. T-global shocks are de ned as shocks for which this \correlation time" is larger than T. This means that for backward tim es t T, one has d(t) & L_f, where d(t) is the distance between m in im izers. Equivalently, one can say that T-global shocks have a nite age larger than T. Below, we study the statistics of the T-global shocks.

W e start with a numerical investigation of the forced Burgers equation in a domain of a size L, much larger than the forcing length-scale L_f . The force is taken to be G aussian, statistically hom ogeneous, white-noise in time and characterized by its covariance

where B is a smooth, L-periodic function. L_f is the correlation length, chosen such that B (') is concentrated at scales '< L_f L. The injection rate of energy per unit length is kept constant (i.e. we choose the space correlation such that B (0) / L). Such a hypothesis is essential because we found that it prevents any L dependency u² (x;t) ¹⁼² of the root-mean-square velocity ums W e will now study the behavior of the statistically stationary solution for the interm ediate time asymptotics t L=u_{m s}. For very large but nite L, the L_f=u_{rm s} problem is well-de ned and we can suppose that the initial condition is taken at 1, so that a statistical steady state is achieved for the solution of the Burgers equation.

In order to obtain a sketch of the behavior of the solution, the limit of in nite aspect ratios $L=L_f$ is investigated num erically using a kicked forcing and the fast Legendre transform method (see Sec. II). Moreover, we consider here the case of a forcing whose spectrum is concentrated in the wavenum ber intervals jkj2 [L_f=L; 3 L_f=L]. Aswew ill see in Sec.V, the functional form of the forcing space correlation B (') at large scale L_f plays an important role. Num erical observations suggest that, at any time in the statistical steady state (obtained after su ciently long integration), the shape of the velocity pro le is locally sim ilar to the order-unity aspect ratio problem, duplicated over independent intervals of size L_f (see Fig. 3(a)). M ore particularly, when tracking the trajectories of uid particles backward in time, one can see that the convergence of the minimizers to each other is far from uniform . Figure 3 (b) shows that the m inim izers are form ing di erent branches which are converging to each other backward in time, de ning in space time a tree-like structure. Eventually, the number






FIG.3: (a) Upper: snapshot of the velocity eld for L = $256L_f$. Lower: zoom of the eld in an interval of length $10L_f$, represented by dashed lines in the upper gure. (b) M inim izing trajectories in space time for the solution to the random ly forced B urgers equation periodic in space with period L = $256L_f$ and over a time interval of length T = 100. The various trajectories are chosen su ciently separated at time t = 0 in order to lighten the picture. The minimizers converge to each other in a rather nonuniform manner, giving rise to a tree-like structure in space-time.

ofbranches decreases and a unique trunk em erges around the globalm inim izer. Note that the same type of behavior is also observed for shocks (see Fig. 4 (a)) by running forward in time. The interm ediate time asymptotics correspond to the time scale for which there is still a large number of such branches.

The velocity eld at a given time, taken for convenience to be t = 0, consists of smooth pieces separated by shocks. Let us denote by f $_{j}$ g the set of intervals

in [0;L), on which the solution u(;0) is smooth. The boundaries of the j's are the shock positions. Each of these shocks is associated to a root-like structure form ed by the trajectories of the various shocks which have merged at times t < 0 to form the shock under consideration (see Fig. 4 (a)). This root-like structure contains the whole history of the shock and in particular its age. Indeed, if the root has a nite depth, the shock under consideration has only existed for a nite time. A Tglobal shock is de ned as a shock whose associated root is deeper than T. One can give the dual de nition for T-globalm in im izers. All the sm oothness intervals i dened above, except that which contains the globalm inim izer, will be entirely absorbed by shocks after a nite time (see Fig. 4 (b)). For each of these pieces, one can dene a life-tim e T_j as the tim e when the last uid particle contained in this piece at time t = 0 enters a shock. It corresponds to the rst time for which the shock located on the left of this smooth interval at time t = 0 m erges with the shock located on the right. W hen the life-time of such an interval exceeds T, the trajectory of this latter uid particle is called a T-globalm in in izer.




FIG.5: Density of T-global shocks as a function of T for three di erent system sizes $L=L_f=64$, 128 and 256; average over 100 realizations.

Hence, for any age T, one can de ne a set of T -scale objects in the spatial domain [0;L) at a given time t. We de ne their spatial density as the number of such objects divided by the size of the domain L. The density (T) of T -global shocks is investigated numerically in the kicked case by using a two-step method. Firstly, the simulation is run up to some large time t for which the statistically stationary regime is reached; secondly, each shock present at time t is tracked backward in time down to the instant of its creation, giving an easy way to determ ine the density (T). We also average numerical results with respect to the forcing realizations. It can be seen from Fig. 5, on which the density for three di erent aspect ratios L = =L_f is presented, that the behavior of (T) is independent of L, and that it displays a power-law (T) / T²⁼³ in the interm ediate asymptotic range L_f=u_{m s} T L=u_{m s}.

We now present a simple phenom enological argument to explain the scaling exponent 2=3. Consider the solution at a given time (t = 0, for instance). Denote by '(T) the typical spatial separation scale for two nearest T-global shocks. Obviously, '(T) 1= (T). The mean velocity of a spatial segment of length 'is given by

 $1^{1=2}$ for the mean velocity uctuations. which gives b Consider now the rightmost minimizer corresponding to the left T-global shock and the leftm ost m in im izer related to the right one. Since there are no T-global shocks in between, it follows that the two minim izers we selected approach each other backward in time for times of the order of T. Thism eans that the backward-in-time displacement of a spatial segment of length 0 (') is itself 0 (') for time intervals of the order of T. The corresponding displacement is given as the sum of two competing e ects: the rst, a kind of drift induced by the localm ean velocity b, is connected with the mean velocity uctuations and gives a displacem ent / b.T; the second e ect is a standard di usive contribution / T¹⁼² related to the di usive behavior of the minim izing trajectories. Taking both into account, we get

where C_1 and C_2 are numerical constants. It is easy to see that the dom inant contribution comes from the rst term. Indeed, if the second term dom inates, i.e. '/ $T^{1=2}$, the rst term then gives a contribution of the order of $v^{3=2}$ which contradicts to (3.4). Hence, one should have $C_1 T v^{1=2}$, leading to the scaling behavior

A swe have already discussed above, T-global shocks are shocks older than T. Denote by p(A) the PDF for the age of shocks. M ore precisely, p(A) is a density in the stationary regime of a probability distribution of the age A (t) of a shock, say the nearest to the origin. It follows from (3.5) that the probability of shocks whose age is larger than A decays like A $2^{=3}$, which im plies the following asymptotics for the PDF p(A):

IV. TW O RELATED STATISTICAL MODELS

W e next discuss a very close analogy between the problem just considered and the dynam ical behavior of a simple rst-order stochastic ODE.Consider the following onedim ensional stochastic Ito equation:

where $0 < C_1$ f(x) G < 1, x 2 R. We are interested in the stochastic ow generated by (4.1). In other words, the aim is to understand the dynamical properties in the large-time asymptotics of the trajectories corresponding to the solutions of (4.1) for di erent initial values. Let X_1 (t) and X_2 (t) with t 0 be the two solutions associated to the initial values X_1 (0) = x_1 and X_2 (0) = x_2 . It is well-known that the di erence $[X_1$ (t) X_2 (t)] is a martingale which does not change its sign; this im plies that the lim it


exists and is nite.




FIG.6: Behavior of the solutions to the stochastic ODE (4.1) for the periodic function $f(x) = 2 + \sin x$. (a) Unwrapped trajectories of the solutions converging to one of the periodic im age. (b) T im e behavior, for a given realization, of the separation between two trajectories x_1 (t) and x_2 (t) associated to two di erent initial conditions. The two trajectories approach each other exponentially fast with a non-random rate .

Consider isst the case when f(x) is periodic. It is easy to see that $c(x_1;x_2)$ has to be equal to a period of the function f(x) (see, e.g., Fig. 6(a)). Let, for simplicity, the smallest period of f(x) be equal to 1. Then, $c(x_1;x_2)$ can take only two values: either 0 or 1. In fact, it is possible to show (see [17, 18, 19, 20]) that the following picture holds. There exists a random periodic sequence of points $x(k) = x(!) + k, k \ge 2, x \ge [0;1)$ such that $c(x_1;x_2) = 0$ for all $x_1;x_2 \ge (x(!) + k; x(!) + k + 1)$ and $c(x_1;x_2) = 1$ for $x_1 \ge (x(!) + k + 1; x(!) + k)$ and $x_2 \ge (x(!) + k; x(!) + k + 1)$. Moreover, in both cases, the convergence is exponential:

where > 0 is a non-random Lyapunov exponent (see Fig.6(b)). The random variable x (!) which determ ines the positions of the separation points x (k) depends on the realization ! of the white noise dW (t). If we consider the stochastic ow on the unit circle, then all the trajectories are stable except the one originating from x (!). The stability is governed by the non-random positive Lyapunov exponent . In contrast, the trajectory which starts at x (!) is unstable and pushes nearby trajectories away. Hence, x (!) plays a role sim ilar to that of the global m in im izer for the Burgers equation with a spatially periodic force. An exponentially sm all neighborhood of it getsm apped into the whole unit circle apart from another exponentially small interval which is the in age of the rest of the circle. This instability island around x (!) is similar to the interval of uid particles which are not absorbed by shocks until time t.

All the results above in the case of periodic f (x) have been well-known for about 20 years and were presented here just to emphasize an analogy with the main shocks and minimizers for Burgers equation in a periodic situation. At the same time, the dynamical behavior in

the non-periodic case is more complicated and much less studied. As we explain below, this behavior is also very similar to the dynamical picture governed by the repelling T-global shocks in the case of non-periodic Burgers equation. Since f(x) is non-periodic $c(x_1;x_2) = 0$ and all trajectories are asymptotic to each other as t! 1. How ever, as in the case of non-periodic Burgers equation,

this convergence is very non-uniform . A lthough there are no globally unstable positions like x(k) = x(!) + k, for a given tim e scale T 1, one still has exponentially sm all T-instability islands which separate di erent intervals of stability from each other. For a given time T, the image under the stochastic ow of the T-instability islands covers alm ost all the real line apart from exponentially sm all pieces which are in ages of the stability intervals. Those exponentially sm all pieces, which we call T-stability intervals play a role sim ilar to that of the T-global shocks in Burgers turbulence. For a larger time scale T_1 Та m a prity of T -instability island will become stable, while some of them will still be unstable. Those islands are in fact T_1 -unstable. One can ask the same question as studied above about the asymptotics of the density of T-instability islands in the limit as T ! 1. Our prelim inary num erical results indicate that the density of T-instability islands scales as T $^{1=2}$. Notice that this scaling is dierent from the scaling T $^{2=3}$ in the case of Burgers equation. We believe that in the case of a stochastic ow the T-instability islands and the density of them can be de ned and studied rigorously. The sim pli cation is connected with the absence of a slow drift which one has for Burgers equation due to uctuations of the average velocity. In the case of the stochastic ow the whole asymptotic dynamical picture is formed by just two factors: di usion and hyperbolic contraction. As a result, the rigorous analysis of the model seems to be a realistic task.

We nally suggest a simple statisticalm odelwhich captures the essential characteristics of the dynam ics and the interactions of T-global shocks and T-stability intervals. W e believe that this model is also quite interesting on its own. Consider an in nite system of particles on a one-dimensional integer lattice Z. Two di erent particles cannot occupy the same site, and some sites are in general not occupied. Each particle is associated to an integer age A 0. Them odel consists in describing a discrete time evolution of particles. To get a con guration of particles at the next step, we proceed as follows. First of all, with a probability 0 , we generate independently new particles in every non-occupied site and we set the age A = 0 for all new ly born particles. Then, each particle independently jumps, with a probability 1=2, either to the right or to the left by a distance 1=2 and we add 1 to the age of all particles. Notice that, after one tim e step, the particles are located on the sites of the dual lattice. If there are two particles which jum ped into the same point of the dual lattice, we then assume that the older one absorbs the younger, that is we ascribe to this site a particle whose age is the maximum of the two ages of the merging particles. It is easy to see that this dynam ics reaches a statistical steady state and one can de ne an integer-valued random variable A which is the age of the particle closest to the origin, say from the right. The probability distribution of this random variable, namely the asymptotics as A ! 1 of the probability p(A), is closely connected with the statistics of T-instability intervals for the non-periodic stochastic ow which we discussed above. A numerical study of the model suggests that p(A) scales like $A^{3=2}$ which corresponds to the scaling T¹⁼² for the density of T-instability islands. We postpone the detailed numerical and theoretical analysis of the non-periodic stochastic ow and the statistical model of interacting particles until a future publication.

V. CONCLUDING REMARKS

We have studied the inviscid random ly forced Burgers equation with non-periodic forcing on the whole real line 1.0 ur results indicate the existence of started at t =stationary regime which corresponds to the velocities of one-sided m in in izers and suggest the follow ing picture. At any given time t (say t = 0) and any given x 2 R, there exists at least one one-sided m in im izer. How ever, due to uctuations of the positions of one-sided minim izers, there are no globalm inim izers. This means that any uid particle gets absorbed by a shock after a certain time. Any two one-sided m in imizers are asymptotic to each other backwards-in-time, that is the distance between them tends to zero as t tends to 1. However, this convergence is very nonuniform. For xed x; y 2 R one-sided m in in izers which originated at t = 0 in x and y will approach each other exponentially fast beyond a certain correlation time T(x;y). This correlation time is of the order of the maximum T for which a T-global shock exists between x and y. O ne can say that T-global shocks form a hierarchical structure separating di erent stability dom ains from each other. By stability dom ains we understand intervals for which one-sided m in im izers converge exponentially fast with a correlation time of the order of the turnover time $L_f = u_m s$. The separation by T-global shocks form separation \walls" between these di erent stability intervals for tim es of the order of T. For larger backward times, one-sided m in imizers from the neighboring stability intervals are exponentially asymptotic to each other. Another interpretation of T-global shocks is connected with their time of creation. Every shock can be traced backward only for a nite time interval. For T-global shocks, this time interval which determ ines the age of the shock is larger than T. Since all shocks have a nite age, it follows that there are no true main shocks in the non-periodic situation. Our results suggest that the large-T asym ptotics of the density of T-global shocks follows the power-law (T) / T $^{2=3}$. This gives a power-law behavior with exponent 5=3 for the PDF of the age of shocks: $p(A) / A^{5=3}$. Another related exponent is connected with the absorption times, de ned in the following way. The absorption time T (') is the time after which all uid particles in the spatial interval ['=2; '=2] are absorbed by shocks. Using the duality between the forward-in-time behavior of uid particles (m in im izers) and the backward-in-time behavior of shocks, we nd that the absorption times T (') / $^{3=2}$ at large '.




FIG. 7: Spectrum h² (k)i of the velocity potential in the stationary regime for the aspect ratio L=L_f = 128. This spectrum contains two power-law ranges: at wavenumbers k L=L_f, the traditional / k⁴ inertial range connected to the presence of shocks in the solution and, for k L=L_f, an \inverse cascade" / k² associated to the large-scale uctuations of

Notice that the power-law behavior of the density (T) of T-global shocks can be interpreted in term of a kind of inverse cascade in the spectrum of the solution (although there is no conserved energy-like quantity). Indeed, the uctuations (3.3) of the m ean velocity suggest that, for large-enough separations ', the velocity potential increment scales like

$$j (x + '; t) (x; t) j / *^{-2}$$

This behavior is responsible for the presence of an intermediate power-law range with exponent 2 in the spectrum of the velocity potential at wavenumbers smaller than the forcing scale (see Fig. 7). This power-law range corresponds for the velocity spectrum to an equipartition of kinetic energy, meaning that the large-domain asymptotics may be considered in the same universality class as the KPZ problem for interface dynamics. It is also im - portant to notice that, in order to obtain this 2 range at small wavenumbers, the spectrum of the forcing potential must go to zero faster than k² as k! 0.0 therw ise, the leading behavior is non-universal and depends on the functional form of the forcing correlation.

The random ly forced Burgers equation in an unbounded dom ain with a di erent type of forcing was also considered in Ref. [21], where it was assumed that the forcing potential has at any time its global maximum and its global minimum in a prescribed compact part of the space. Such a forcing leads to a completely di erent behavior. In particular, in this case there exists a global minimizer located in a nite spatial interval for all times and all otherm inimizers are asymptotic to it in the limit t! 1.

We nally stress that, in this paper, we have mostly discussed the one-dimensional case. It is of particular interest to analyze the e ects of non-compactness of the dom ain and the intermediate time asymptotics in higher dimensions. The notion of main shock is then replaced by that of topological shock [9, 10], which are no more isolated points, but spatially extended objects. The natural problem in this setting is to study geometrical and statistical properties of the T-global shocks and to nd the asymptotic behavior of their age distribution.
