# DEFORM AT IONS OF PLANE ALGEBRA IC CURVES AND INTEGRABLE SYSTEM S OF HYDRODYNAM IC TYPE

W e describe our recent work on deform ations of hyperelliptic curves by m eans of integrable hierarchy of hydrodynam ic type, and discuss a further extension to the cases of non-hyperelliptic curves.

1. Deform ation of plane algebraic curves

Let C be a plane algebraic curve on  $C^2 = f(k;p)g$ :

C: 
$$p^{N} = \sum_{j=1}^{X^{N}} u_{j}(k)p^{N-j}; u(k) 2 C[k]:$$
 (1)

Then consider a deformation of the curve C as the following equation of conservation law;

$$\frac{\partial p}{\partial t} = \frac{\partial}{\partial x}Q; \quad \text{with} \quad Q \ 2 \ \frac{C \ [k;p]}{C} = \prod_{k=1}^{M^{q}} C \ [k] \quad [k] \quad [k] \quad [k] \quad k;$$

where x;t are the deform ation parameters. The equation (2) describes a (quasi-linear) system of equations of hydrodynamic type for  $u_j = u_j(x;t;k)$  in the curve C. Then from a direct computation we nd:

Lem m a 1.1. Let Q be given by

$$Q = \sum_{j=1}^{X^{N}} (k) p^{N-j}; \quad j(k) \ 2 \ C[k]:$$

Then the functions u<sub>i</sub> in the curve C satisfy

$$\frac{@u_1}{@t} = \frac{X^N}{p_{\pm 1}} N \frac{(j)}{p_{\pm 1}} \frac{@j}{@x} + \frac{X^N}{p_{\pm 1}} N \frac{(j)}{p_{\pm 1}} (N - j) \frac{(j+j)}{p_{\pm 1}} \frac{(j+j)}{p_{\pm 1}} \frac{(j+j)}{(j+j)} \frac{(j+j)}{p_{\pm 1}} \frac{(j+j)}{p_{\pm 1}} \frac{(j+j)}{p_{\pm 1}} + \frac{(j+j)}{p_{\pm 1}} \frac{(j+j)}{p_{\pm 1}$$

where  $\int_{1}^{(j)}$  are de ned by

$$p^{2N j 1} = {X^N \atop 1} p^{N k}; 1 j 2N 1:$$

The last equation leads to the recursion relation for  $\begin{pmatrix} i \\ l \end{pmatrix}$  for l = 1; ;N with  $\begin{pmatrix} i \\ N+1 \end{pmatrix} = 0$ ,

$$\begin{array}{c} {}^{(i \ 1)}_{1} = \begin{array}{c} {}^{(i)}_{1} + {}^{(i)}_{l+1}; & \text{for } 1 \ i \ N \ 1 \\ {}^{(i \ N \ + 1)}; & \text{for } N \ i \ 2N \ 1 \end{array}$$

which can be used to nd the explicit form of  $\frac{(i)}{1}$ 's in terms of  $u_j$ 's.

A hierarchy associated with the system (2) m ay be obtained by choosing proper  $u_j(k)$ ; j(k) 2 C[k] for j = 1; ;N, so that the system s for n = 1;2;,

$$\frac{\partial p}{\partial t_n} = \frac{\partial}{\partial x} Q^{(n)}; \quad \text{with} \quad Q^{(n)} = \sum_{\substack{j=1\\j=1}}^{X^N} f^{(n)}(x) p^{N-j};$$

are compatible, i.e.  $@^2p=@t_n @t_m = @^2p=@t_m @t_n$ . (In this paper we choose  $Q^{(0)} = p$ , that is,  $@p=@t_0 = @Q^{(0)}=@x$ , and identify  $t_0 = x$ .) A general scheme to construct such  $Q^{(n)}$  has not been found. It is how ever quite interesting to classify the curves which allow integrable deform ations of this type. In this report, we give several examples of the hierarchy associated with the deform ations of the curve C in (1).

R em ark 1.1. The curve (1) contains several known examples of the hierarchy, which are obtained by the reductions of the dispersionless KP (and mKP) hierarchy (see also R em ark 3.1). The examples contain a model of the Landau-G inzburg theory with rational potentials<sup>1</sup>. This is simply obtained by the following choices of polynomials for  $u_i$ 's in (1): Fix an index of  $u_i$ 's, say n, and set

$$u_n = k^n \quad v_n;$$
 and  $u_i = v_i;$  for  $i \in n;$  (3)

where  $v_i$ 's do not depend on k. Then we have

$$k^{n} = p^{n} + v_{1}p^{n-1} + \frac{v_{n+1}}{p} + \frac{v_{N}}{p^{N-n}}$$
: (4)

which gives a rationalLandau-G inzburg potential<sup>1</sup>. An interesting question is how one can extend the ring C [k;p]=C to a rational ring. A lso one should include a log-term to de ne a complete set of primary elds.

There is another interesting example, which is obtained by the dipersionless lim it of the vector nonlinear Schrödinger equation<sup>6</sup> (Zhakharov reduction<sup>2</sup>),

$$k = p + \frac{{}^{N}X^{1}}{{}_{j=1}} \frac{j}{p v_{j}}$$
:

The hierarchy associated to this curve provides a model of the topological eld theory with N 1 punctures.

R em ark 1.2. The system (2) has an in nite number of conserved densities which are explicitly obtained by expressing p in the Laurent series of k.

## 2. D eform ations of hyperelliptic curves (N = 2)

The curve C with N = 2 corresponds to hyperelliptic curve of genus determined by the degrees of polynom ials  $u_j(k)$ ; j = 1;2;

The deform ation equation (2) then gives

$$\overset{\circ}{\underbrace{\&}} \quad \frac{@u_1}{@t} = \frac{@}{@x} (u_1 \ _1 + 2 \ _2)$$

$$\overset{\circ}{\underbrace{\&}} \quad \frac{@u_2}{@x} = 2u_2 \frac{@}{@x} + \ _1 \frac{@u_2}{@t} \quad u_1 \frac{@}{@x}:$$
(5)

As a particular case with  $u_1 = k$   $v_1$ ;  $u_2 = v_2$  (see Remark 1.1), we have

$$k = p + v_0 + \frac{v_1}{p};$$

which corresponds to the curve of the dispersioness Toda equation discussed in <sup>3</sup>. This curve is also related to the dispersionless AKNS system for the variable  $p^0 = p + v_0$ .

We also note that the variable  $u_1$  (k) can be elim inated by the (gauge) transform ation, p ! p +  $u_1=2$ , and then from (5) one can take Q in the form,

$$Q = _1 (k)p;$$
 (i.e.  $_2 = 0):$ 

Thus we have the following two examples for the case N = 2, where the polynom ial  $u_2$  (k) is either odd or even.

## 2.1. The BH $_m$ hierarchy

The  $BH_m$  hierarchy<sup>4</sup> is dened on the singular sectors of the Burgers-H opf (BH) hierarchy, where the solution of the hierarchy has a shock type singularity. Here the number m is the genus of the curve C given by

$$y^{2} = u_{2}(k) = k^{2m+1} + \int_{j=0}^{km} v_{j}k^{2m-j}$$
: (6)

In particular, the case with m = 0 gives the BH hierarchy (or the dispersionless K dV hierarchy), i.e. with  $u_2 = k + v_0$ ,

$$p^{2} = k + v;$$
 and  $Q^{(n)} = {\binom{n}{1}} (k)p = [k^{n+\frac{1}{2}}]_{+p};$ 

where  $[k^a]_{+p}$  represents the polynom ial part of  $k^a$  in p. The BH hierarchy in term s of the variable v is given by

$$\frac{\partial v}{\partial t_n} = c_n v^n \frac{\partial v}{\partial x}; \quad \text{with} \quad c_n = (1)^n \frac{(2n+1)!!}{2^n n!}; \quad n = 0;1;2; \qquad :$$

In the case with  $m \in 0$ , we have<sup>4</sup>:

P roposition 2.1. The following system associated with the curve (6) form s an integrable hierarchy of a deform ation of the curve;

$$\frac{\partial p}{\partial t_n} = \frac{\partial}{\partial x} Q^{(n)}; \quad \text{with} \quad Q^{(n)} = -\frac{m}{1} p = -\frac{k^{m+n+\frac{1}{2}}}{p} p;$$

where [+] is the polynom ial part of k.

The form  $Q^{(n)}$  can be obtained as follows: First assume  $\begin{pmatrix} n \\ 1 \end{pmatrix}$  (k) be a monic polynom ial of degree n in k. Then from (2) we have

$${}^{(n)}_{1}(k)p = k^{n+m+\frac{1}{2}} + 0 \quad k^{m} \quad \frac{1}{2} ;$$

from which we have

$${}_{1}^{(n)} = \frac{{}^{m} \frac{k^{n+m+\frac{1}{2}}}{p}}{p} +$$

The compatibility between the ows in the hierarchy can be shown directly<sup>4</sup>. The explicit form of the BH<sub>m</sub> hierarchy is given by the following form with the polynomial  $\binom{(n)}{1}$  (k) for k being replaced by a matrix K,

$$\frac{\partial U}{\partial t_n} = \frac{(n)}{1} \langle K \rangle \frac{\partial U}{\partial x}; \quad \text{with} \quad U = \langle u_0; u_1; \quad 2n; u^T;$$

where K is the (companion) matrix given by

$$K = \begin{bmatrix} 0 & u_0 & 1 & 1 & 0 \\ B & u_1 & 0 & C & 0 \\ B & \vdots & \vdots & \ddots & \ddots & \vdots \\ u_{2m} & 1 & 0 & A & 1 \\ u_{2m} & 0 & 0 & 0 \end{bmatrix}$$

For example,  ${}^{(1)}_1$  (K) = K (1=2) $u_0$  I with I = (2m + 1) (2m + 1) identity matrix.

It is also interesting to note that the systems in the hierarchy can be written in the R iem ann invariant form ,

$$\frac{\underline{\theta}_{i}}{\underline{\theta}_{t_{n}}} = \frac{(n)}{1} \frac{\underline{\theta}_{i}}{\underline{\theta}_{x}}; \quad \text{for } i = 0;1;2; \qquad ;2m;$$

where the R iem ann invariants  $_{\rm i}{}^\prime{\rm s}$  are the roots of the polynom ialassociated with the curve C, i.e.

$$p^{2} = \begin{cases} Y^{N} \\ k \\ j = 1 \end{cases}$$

The  $u_{\,j}{\,}'s$  are then given by the elementary symmetric polynomials of  ${\,}_{\,j}{\,}'s$  , i.e.

$$u_{j} = (1)^{j+1} X_{i_{1} i_{j}}; \text{ for } j = 0; ; 2m:$$

The  $_{\rm j}$  are also the eigenvalues of the matrix K . Then the solution can be obtained by the generalized hodograph form  $^4$  ,

$$\int_{j} (v_{1}; v_{1}; x_{j}; t_{1}; x_{j}; t_{1}; x_{j}; t_{1}; x_{n}; t_{n}; t_{n};$$

The regularity of the solution is obtained by the smoothness of the curve, which corresponds to the distinction of the roots  $_j$ . The singular structure of the solution can be described by their intersections of the functions  $_j$  in the hodograph solution<sup>4</sup>.

# 2.2. The dispersionless JM $_{\rm m}$ hierarchy.

The dispersionless  $JM_m$  (dJM<sub>m</sub>) hierarchy is given by a dispersionless (classical) limit of the hidden integrable hierarchy of the Jaulent-M iodic equation<sup>5</sup>. The dJM<sub>m</sub> hierarchy is given by the similar form as the BH<sub>m</sub> hierarchy<sup>4</sup>:

Proposition 2.2. For the hyperelliptic curve of genus m given by

$$p^{2} = k^{2m+2} + \int_{j=1}^{2m+2} v_{j}k^{2m+2} j;$$

we have an integrable hierarchy of deform ation of the curve,

$$\frac{e}{e}p_{n} = \frac{e}{e}Q^{(n)}; \quad \text{with} \quad Q^{(n)} = \frac{e}{1}p_{n} = \frac{e}{p}p_{n} + p:$$

For example in the case with m = 0; n = 1, we have

$$\overset{\circ}{\underbrace{\otimes}} \quad \frac{\underline{\theta} v_1}{\underline{\theta} t_2} = \frac{\underline{\theta}}{\underline{\theta} x} \quad v_2 \quad \frac{3}{4} v_1^2$$
$$\overset{\circ}{\underbrace{\otimes}} \quad \frac{\underline{\theta} v_2}{\underline{\theta} t_2} = \frac{1}{2} \frac{\underline{\theta}}{\underline{\theta} x} \quad (v_1 v_2)$$

which describes classical shallow water waves. Then the dJM  $_{\rm m}$  hierarchy can be considered as an integrable system dened on the singular sector of the codimension m in the solution of the dJM  $_0$  hierarchy. As in the case of the BH hierarchy, the singular sectors are given by the intersection structure of the hodograph solution  $_j$ ; j = 1;2 on  $C^1 = f(x;t_1; ;)g$ .

#### 3. Exam ples of non-hyperelliptic case

A natural extension of the hyperelliptic case (N = 2) m ay be given by the case with the curve,

$$p^{N} = u_{N} (k) = k^{M} + \sum_{j=1}^{M} v_{j} k^{M} j;$$
 (7)

where N; M are positive integers with N 3. The genus of the (irreducible projective) curve C  $CP^2$  for N > M is given by M ax Noether's genus form ula

$$g = \frac{1}{2}$$
 (N 1) (N 2) (N 1) (N M 1) gcd: (N; N M) + 1;

where g.c.d.(A;B) implies the greatest common divisor of A and B. If M > N, the genus is given by the same form ula with the exchange N \$ M. A lso if M = N, the curve is smooth, and the genus is

$$g = \frac{(N 1)(N 2)}{2}$$
:

For the curve (7), we have a similar result as in the case of hyperelliptic curve:

P roposition 3.1. The following integrable hierarchy of hydrodynamic type provides a deformation of the curve (7);

$$\frac{\varrho_p}{\varrho_{t_n}} = \frac{\varrho}{\varrho_x} Q^{(n)}; \quad \text{with} \quad Q^{(n)} = k^{\frac{M}{N}+n}_{p};$$

The compatibility can be shown in the same way as the hyperelliptic case and it can be found in our paper<sup>4</sup>.

R em ark 3.1. O ne should note that the hierarchy in P roposition 3.1 is not the same as a dispersionless Lax reduction<sup>2</sup>, i.e.

$$k^{N} = [k^{N}]_{+p} = polynom is lof degree N in p:$$

However the Lax reduction is a special case of the curve (1) where all of the  $u_1(k)$ 's do not depend on k except  $u_N(k) = k^N$ .
