# DEFORMATIONSOFPLANEALGEBRAICCURVESAND IN TEGRABLE SYSTEMSOFHYDRODYNAM ICTYPE

W e describe our recent work on deform ations of hyperelliptic curves by $m$ eans of integrable hierarchy of hydrodynam ic type, and discuss a further extension to the cases of non-hyperelliptic curves.

1. D eform ation of plane algebraic curves

Let $C$ be a plane algebraic curve on $C^{2}=f(k ; p) g$ :

$T$ hen consider a deform ation of the curve $C$ as the follow ing equation of conservation law ;

$w$ here $x$; $t$ are the deform ation param eters. The equation (2) describes a (quasi-linear) system ofequations of hydrodynam ic type for $u_{j}=u_{j}(x ; t ; k)$ in the curve C. Then from a direct com putation we nd:

$T$ he last equation leads to the recursion relation for ${ }_{1}^{(i)}$ for $l=1$; ;N w th ${ }_{\mathrm{N}+1}^{\text {(i) }}=0$,

which can be used to nd the explicit form of ${ }_{1}^{(i)}$ 's in tem $s$ of $u_{j}$ 's.
A hierarchy associated $w$ th the system (2) $m$ ay be obtained by choosing proper $u_{j}(k) ; j(k) 2 C[k]$ for $j=1 ; \quad ; N$, so that the system $s$ for $n=$ 1;2;

are com patible, i.e. $@^{2} p=@ t_{n} @ t_{n}=@^{2} p=@ t_{m} @ t_{n}$. (In this paper we choose $Q^{(0)}=p$, that is, $@ p=@ t_{0}=@ Q^{(0)}=@ x$, and identify $t_{0}=x$.) A general schem e to construct such $Q^{(n)}$ has not been found. It is however quite interesting to classify the curves which allow integrable deform ations of this type. In this report, we give several exam ples of the hierarchy associated $w$ ith the deform ations of the curve $C$ in (1).

Rem ark 1.1. The curve (1) contains several known exam ples of the hierarchy, which are obtained by the reductions of the dispersionless K P (and m K P ) hierarchy (see also Rem ark 3.1). The exam ples contain a m odel of the Landau-G inzburg theory w ith rationalpotentials ${ }^{1}$. This is sim ply obtained by the follow ing choices of polynom ials for $u_{i}$ 's in (1): $F$ ix an index of $u_{i}$ 's, say $n$, and set

where $v_{i}$ 's do not depend on $k$. Then we have

which gives a rationallandau-G inzburg potential ${ }^{1}$. An interesting question is how one can extend the ring $C[k ; p]=C$ to a rationalring. A lso one should include a log-term to de ne a com plete set of prim ary elds.
$T$ here is another interesting exam ple, which is obtained by the dipersionless lim it of the vector nonlinear Schrodinger equation ${ }^{6}$ (Zhakharov reduction ${ }^{2}$ ),

The hierarchy associated to this curve provides a m odel of the topological eld theory w ith N 1 punctures.

Rem ark 1.2. The system (2) has an in nite num ber ofconserved densities $w$ hich are explicitely obtained by expressing $p$ in the Laurent series of $k$.

## 2. Deform ations of hyperelliptic curves ( $\mathrm{N}=2$ )

The curve C w ith $\mathrm{N}=2$ corresponds to hyperelliptic curve of genus deter$m$ ined by the degrees of polynom ials $u_{j}(k) ; j=1 ; 2$;

$T$ he deform ation equation (2) then gives

A sa particular case $w$ ith $u_{1}=k \quad v_{1} ; u_{2}=v_{2}$ (see Rem ark 1.1), we have

which corresponds to the curve of the dispersioness T oda equation discussed in ${ }^{3}$. This curve is also related to the dispersionless AKNS system for the variable $p^{0}=p+v_{0}$.
$W$ e also note that the variable $u_{1}(k)$ can be elim inated by the (gauge) transform ation, $p!p+u_{1}=2$, and then from (5) one can take $Q$ in the form,

$T$ hus we have the follow ing tw o exam ples for the case $N=2$, where the polynom ial $u_{2}(k)$ is either odd or even.

### 2.1. The BHm hierarchy

The BHm hierarchy ${ }^{4}$ is de ned on the singular sectors of the Burgers $H$ opf (BH) hiearchy, where the solution of the hiearachy has a shock type singularity. H ere the num ber $m$ is the genus of the curve $C$ given by

In particular, the case $w$ th $m=0$ gives the BH hierarchy (or the dispersionless $K$ dV hierarchy), i.e. w th $u_{2}=k+v_{0}$,

where $\left.k^{a}\right]_{+p}$ represents the polynom ial part of $k^{a}$ in $p$. The BH hierarchy in term $s$ of the variable $v$ is given by

In the case w th $m \in 0$, we have ${ }^{4}$ :
P roposition 2.1. T he follow ing system associated w ith the curve (6) form $s$ an integrable hierachy of a deform ation of the curve;

where [ +] is the polynom ial part of $k$.
T he form $Q^{(n)}$ can be obtained as follow s: F irst assum $e{ }_{1}^{(n)}(k)$ be a m onic polynom ial of degree $n$ in $k$. Then from (2) we have

The compatibility between the ows in the hierarchy can be shown directly ${ }^{4}$. The explicit form of the $\mathrm{BH}_{\mathrm{m}}$ hierarchy is given by the follow ing form w th the polynom ial ${ }_{1}^{(n)}(k)$ for $k$ being replaced by a $m$ atrix $K$,

For example, ${ }_{1}^{(1)}(\mathrm{K})=\mathrm{K} \quad(1=2) \mathrm{u}_{0} \mathrm{I}$ w ith $\mathrm{I}=(2 \mathrm{~m}+1) \quad(2 \mathrm{~m}+1)$ identity $m$ atrix.

It is also interesting to note that the system $s$ in the hierarchy can be w ritten in the R iem ann invariant form,

where the $R$ iem ann invariants i's are the roots of the polynom ialassociated w ith the curve C, ie.

The $u_{j}$ 's are then given by the elem entary sym $m$ etric polynom ials of $j$ 's, ie.

$T$ he $j$ are also the eigenvalues of the $m$ atrix $K$. T hen the solution can be obatined by the generalized hodograph form ${ }^{4}$,

The regularity of the solution is obtained by the sm oothness of the curve, which corresponds to the distinction of the roots $j$. The singular structure of the solution can be described by their intersections of the functions $j$ in the hodograph solution ${ }^{4}$.
2.2. The dispersionless $\mathrm{JM}_{\mathrm{m}}$ hierarchy.

The dispersionless $J M_{m}$ ( $\mathrm{d}_{\mathrm{m}}^{\mathrm{m}}$ ) hierarchy is given by a dispersionless (classical) lim it of the hidden integrable hierachy of the Jaulent -M iodic equation ${ }^{5}$. The dJM $m$ hierarchy is given by the sim ilar form as the $\mathrm{BH}_{\mathrm{m}}$ hierarchy ${ }^{4}$ :

Proposition 2.2. For the hyperelliptic curve of genus $m$ given by

we have an integrable hierarchy of deform ation of the curve,

For exam ple in the case $w$ th $m=0 ; n=1$, we have

which describes classical shallow water waves. Then the dJM $m$ hierarchy can be considered as an integrable system de ned on the singular sector of the codim ension $m$ in the solution of the dJM 0 hierarchy. A $s$ in the case of the BH hierarchy, the singular sectors are given by the intersection structure of the hodograph solution $j ; j=1 ; 2$ on $C^{1}=f\left(x ; t_{1} ; \quad ;\right) g$.

## 3. Exam ples of non-hyperelliptic case

A naturalextension of the hyperelliptic case ( $\mathbb{N}=2$ ) m ay be given by the case w th the curve,

where $N$; $M$ are positive integens $w$ ith $N$ 3. The genus of the (irreducible projective) curve $C \quad C P^{2}$ for $N>M$ is given by $M$ ax $N$ oether's genus form ula

where g.c.d. ( $\mathrm{A} ; \mathrm{B}$ ) im plies the greatest com $m$ on divisor of $A$ and $B$. If $M>N$, the genus is given by the sam e form ula w ith the exchange $N \$ M$. A lso if $M=N$, the curve is sm ooth, and the genus is

For the curve (7), we have a sim ilar result as in the case of hyperelliptic curve:

Proposition 3.1. The follow ing integrable hierarchy of hydrodynam ic type provides a deform ation of the curve (7);

The com patibility can be shown in the sam e way as the hyperelliptic case and it can be found in our paper ${ }^{4}$.
$R$ em ark 3.1. O ne should note that the hierarchy in $P$ roposition 3.1 is not the sam e as a dispersionless Lax reduction ${ }^{2}$, i.e.

H ow ever the Lax reduction is a special case of the curve (1) where all of the $u_{j}(k)$ 's do not depend on $k$ except $u_{N}(k)=k^{N}$.
