# P icture of the low -dim ensional structure in chaotic dripping faucets

#### Abstract

C haotic dynam ics of the dripping faucet was investigated both experin entally and theoretically. W em easured continuous change in drop position and velocity using a high-speed cam era. C ontinuous tra jectories of a low -dim ensional chaotic attractor were reconstructed from these data, which was not previously obtained but predicted in our uid dynam ic sim ulation. From the sim ulation, we further obtained an approxim ate potential function $w$ th only two variables, the drop $m$ ass and its position of the center of $m$ ass. T he potential landscape helps one to understand intuitively how the dripping dynam ics can exhibit low-dim ensional chaos.


It is well known that the beat of a dripping water faucet is not always regular and exhibits com plex behaviour including chaos [ill]. Chaotic dripping was originally suggested by R ossler [ $[\underline{Z}]$ and experim entally con $m$ ed by Shaw and his collaborators [3] 1 . Since then, $m$ any experim entaland theoreticalstudies have established the dripping faucet as a sort of paradigm for chaotic system $s$
 have involved $m$ easuring the tim e interval $T_{n}$ betw een successive drips, because the dripping tim e is easily m easured using a drop-counter apparatus $\overline{3}, \overline{1}, \overline{4}, \overline{1}, \overline{1}, \overline{1}, 1$,
 give a retum $m$ ap. B ecause the retum $m$ apstypically appear low dim ensional ( one-dim ensional), the behavior is often described by a sim ple dynam icalm odel
 spring $m$ odel, a $m$ ass point, whose $m$ ass increases linearly $w$ ith tim $e$ at a given ow rate $Q$, oscillates $w$ th a xed value of the spring constant $k$; and a part $m$ of the totalm ass $m$ is rem oved when the spring extension exceeds a threshold, which describes the breakup of a drop. A though the m odel exhibits chaotic retum $m$ aps sim ilar to those obtained experim entally, itsem piricalnature $m$ eans that it does not provide a uni ed explanation for the com plex behavior of the realdripping faucets, typically seen in bifurcation diagram $s$ (plotting of $T_{n}$ vs. the control param eter Q). Thus, the connection betw een the low-dim ensional dynam icalsystem and a presum ably in nite-dim ensional uid dynam icalsystem rem ains elusive.

Recently, we carried out uid dynam ic com putations (FDC) based on a new algorithm involving Lagrangian description and succeeded in reproducing not only the tim e-dependent shapes of the drops, but also various characteristics of
nonlinear dynam ical system s , such as period-doubling, interm ittency, hysteresis, observed in experim ents of dripping faucets [1]]. A detailed analysis of our FD C m ade it possible to im prove the $m$ ass-spring $m$ odelby using $m$ ore realistic approxim ations including taking into account the $m$ ass dependence of the spring constant, and the necking process [1] Tl]. This im proved $m$ ass-spring $m$ odel, described only by three variables: $m$ ass $m$, its position $z_{G}$ and the velocity $\mathrm{z}_{\mathrm{G}}$, closely described the dynam icalbehavior exhibited by the FD C. In particular, qualitatively good agreem ent am ong bifurcation diagram s (especially the repeating structure which re ects the oscillation frequency of each drop), obtained by (i) the experim ent $[1]$ ], (ii) the FDC $[1]]$ and (iii) the im proved $m$ ass-spring m odel $[1]$ lin over a w ide range of the control param eter Q provided a theoretical $m$ odel of the basic low-dim ensional structure inherent in the system, which is presented here.

A $n$ experim ental chaotic attractor is show $n$ in $F$ ig. 111 . In addition to the discrete-tim e variable $T_{n}$, the $m$ ass $m$ ( $t$ ) of the liquid suspended by the nozzle, the position of the center of $m$ ass $z_{G}(t)$ and velocity $z_{G}$ were also m easured. A s seen in $F$ ig. ${ }_{1}^{11}(b), z_{G}(t)$ oscillates because the surface tension works as a restoring force. Sim ilar oscillation w as observed in both our FD C and im proved m ass-spring m odel $\left[\bar{T}_{1} \bar{T}_{1}\right.$. N ote that the frequency of the oscillation during each tim e interval $T_{n}$ is determ ined by the ow rate. At $Q=0.24 \mathrm{~g} / \mathrm{s}, \mathrm{z}_{\mathrm{G}}$ oscillates $61=2$ tim es before the breaking up and the phase of the oscillation in the plane ( $z_{G} ; Z_{G}$ ) uctuates chaotically at breakup. A retum $m$ ap of $f z_{p e a k ; n} 9$ for every fourth peak of $z_{G}(t)$ is presented in $F$ ig. ${ }^{111}(\mathrm{I})$. $T$ he retum $m$ ap of $T_{n}$ ( $F$ ig. '1'(a)) looks like an entangled string and thus the $m$ ap function $T_{n+1}=G\left(T_{n}\right)$ cannot be single-valued. In contrast, the $m$ ap function $z_{p e a k ; n+1}=F\left(z_{p e a k ; n}\right)$ is approxim ately single-vahued, although broadened by 'noise'. Low-dim ensional $\mathrm{m} u l t i-v a h e d m$ ap functions of $\mathrm{T}_{\mathrm{n}}$ have often been obtained in both experim ents
 $m$ odel $\left.[1]_{1}\right]$, the $m$ ap function $m_{r ; n+1}=H^{-}\left(m_{r ; n}\right)$ ( $m_{r ; n}$ being the rem nant $m$ ass just after the $n$-th breakup), as well as the $m$ ap function $F\left(z_{p e a k ; n}\right)$ is singlevalued, while $G\left(T_{n}\right)$ is generally multi-valued. This is because the mapping of the tim e interval $T_{n}$ is not topologically conjugate to that of the dynam ical variable $m_{r ; n}$. The FDC results also showed that $H\left(m_{r ; n}\right)$ is approxim ately single-valued even when $G\left(T_{n}\right)$ is multi-valued. Thus, $T_{n}$ does not directly specify the state of the system despite its easy $m$ easurem ent.
$M$ easurem ent of the continuous-tim e variables $f_{z_{G}}(t) ; z_{G}(t) ; m(t) g m$ ade it possible to visualize the tra jectory of the chaotic attractor in a continuous state space for the rst time. The projection of the attractor in the plane $\left(z_{G} ; z_{G}\right)$ corresponding to the chaotic motion in Fig. '111 is shown in Fig. $\overline{1}$ (top). On average, $z_{G}(t)$ oscillated six tim es during each time interval $T_{n}$ (see $F$ igs. ${ }_{1}^{11}(\mathrm{l}$ )
 dim ensional and explicitly show sthat the drop form ation is well characterized by a few state variables. Figure (b) is a blow -up of the region $S$ in which trajectories starting w th slightly di erent rem nant $m$ asses separate rapidly from each other. The transition from the oscillating process to the 'necking' process (i.e., stretching of the attractor) occurs in this region S [1] In Fig. the FDC results are presented including pro les of the evolving drops ( $F$ ig. 21(d)), which show qualitatively good agreem ent w ith the experim ental observations. The cross section of the theoretical attractor ( $F$ ig. $\overline{\text { han }}$ (c) ) also exhibits the low-dim ensionality. An attractor in the space ( $\left.\mathrm{z}_{\mathrm{G}} ; \mathrm{z}_{\mathrm{G}} ; \mathrm{m}\right)$ w ith a sim ilar spiral
structure has already been obtained using the im proved $m$ ass-spring $m$ odel [1] $\left.\overline{7}_{1}\right]$. $T$ hese results strongly support the use of the three state variables: $z_{G}, z_{G}$ and $m$ to describe the drop $m$ otion.

The m otion of the drop is sub jected to gravitational force and surface tension. Since the surface energy depends on the shape of the drop, the total potential energy U (i.e., gravitationalplus surface) should be a function of the $m$ any degrees of freedom of the liquid. O ur FDC show, how ever, that approxi$m$ ating $U$ as a function of tw o variables, $m$ and $z_{G}$, yields a conceptually clear picture for the basic low-dim ensional structure of the system. C ross sections of $U=m$, the potential energy per unit $m$ ass, at several xed values of $m$ for the chaotic attractor shown in F ig. (bottom) are presented in Fig.
 though the cross sections in Fig. as single-valued functions, then a sheet of the potential surface $U\left(m ; z_{G}\right)=m$ is
 valley and a ridge which converge as m increases and have totally m erged when $m=m$ crit, the $m$ axim um $m$ ass of the static stable shape. $W$ e have also carried out a num erical experim ent based on FDC w th $Q=0$ by xing the value of m. Various arti cial shapes of the drops were used as initial conditions, and it w as found that the point $\left(m ; z_{G}\right)$ rapidly converged onto a w ell-de ned potential surface $U\left(m ; z_{G}\right)=m$ sim ilar to that shown in $F$ ig. ${ }^{1} 1$
$T$ he potentialsurface for the closed system (i.e., the pendant drop for $Q=0$ ) is useful for understanding the dynam ics of the open system $(Q>0)$. The $m$ in im um and a maxim um of $U\left(m ; z_{G}\right)=m$ for the $Q=0$ system correspond to a stable xed point (static equilibrium shape) and a saddle point (unstable equilibrium shape, see $F$ ig. in the top tw o panels off ig. ${ }^{3} 1(\mathrm{~b})$. W hen $\mathrm{m}=\mathrm{m}_{\text {crit }}(=0: 144 \mathrm{~g})$, the stable xed point disappears, and the necking process begins leading to the pinching $\circ$ of the drop. W hen $m<m_{\text {crit }}$, the trajectories of the drops oscillate in the valley of $\mathrm{U}\left(\mathrm{m} ; \mathrm{z}_{\mathrm{G}}\right)=\mathrm{m}$, which corresponds to the spiral structure of the attractor in F ig. 2. The ow of the $Q=0$ system as depicted in $F$ ig. $\bar{N}_{1}^{\prime}(\mathrm{b})$, also suggests that the state point of the drop causes the spiral orbits in the phase space ( $\left.z_{G} ; z_{G} ; m\right)$. The chaotic dynam ics, especially the stretching and folding of the attractor, can be interpreted as follows. The stable xed point approaches the saddle point asm increases. The state point thus visits the vicinity of the saddle point after the spiralm otion, which causes the instability of the orbit, or equivalently, the stretching of the attractor (as in Fig. $\overline{1}(\mathrm{~b})$ ). The P oincare section of the chaotic attractor ( $F$ ig. . increasing $m$, is gradually crushed and asym ptotes to a single line through the necking process.

The above analysis leads to the $m$ otion ofthe dripping faucet being described in term $s$ of the approxim ate potential function $U$ as

where is the dam ping constant. This equation describes the motion of a particle $w$ ith unit $m$ ass in 2 -dim ensional space ( $m ; z_{G}$ ), where the particle is forced to have a constant velocity $\underline{m}=Q$ in the direction of the $m$-axis. O ur im proved $m$ ass-spring $m$ odelcorresponds to a localquadratic approxim ation for the potential near the bottom $z_{G}=z_{0}$ of the valley in which the $m$-dependence
of the spring constant $k(m) \quad @^{2} U\left(m ; z_{0}\right)=@ z_{0}^{2}$ has been included $\left[1 \bar{T}_{1}\right]$. The present description is thus a natural extension of the im proved $m$ ass-spring m odel. A s we have seen, how ever, the picture of the global landscape of the potential is $m$ uch clearer than the im proved $m$ ass-spring $m$ odel for intuitively understanding the dynam ics of the system. If the ow rate $Q$ is sm allenough so that the initialoscillation after the breakup is dam ped, the particle (equivalently the state point of the drop) goes along the bottom of the valley as m increases. At $m=m_{\text {crit }}$, where the valley $m$ erges into the ridge, the particle's $m$ otion loses its stability (start of the necking process) and rapidly approaches the breakup point (on the broken red line in Fig. ${ }^{1} 1(\mathrm{c})$ ). Since the instability alw ays begins at the sam e point $m=m$ crit in this case, the size of each drop is uniform. If, on the other hand, the oscillation of the drop a ects the start of necking, the dripping $m$ otion exhibits a variety of ow rate-dependent periodic and chaotic pattems. N ote that the particle generally gets over the ridge before $m$ reaches $\mathrm{m}_{\text {crit }} \mathrm{when}$ it is oscillating. At a ow rate resulting in a chaotic m otion, two tra jectories starting $w$ th slightly di erent $m$ values (di erent rem nant $m$ asses) are initially close to each other. A s m increases, how ever, one tra jectory may get over the ridge at a certain $m$ value, while the other rem ains in the valley ow ing to $a$ sm all di erence in $\underline{z}_{G}$ (tw 0 red lines in $F$ ig.

Sim ilar potential landscapes are expected for other sub jects involving drop
 describing the $m$ otion in the attractorw as con $m$ ed by FD C to have essentially the sam e topology even for high viscosity liquids and for $m$ icro uidic system $s$ (drop size pl ). Hence, the present picture of a particle $m$ oving along a low dim ensionalpotential surface is relevant to $m$ odeling drop form ation in general.

[21] Besides the up and down-oscillation of the center of $m$ ass of the liquid, there are other oscillation $m$ odes which induce drop deform ation. These extra $m$ odes result in the ne structures of the attractor. For exam ple, the $m$ ap function in $F$ ig. 1 (c) show $s$ tw o or three peaks apart from the $m$ ain one. C lose observation of the experim ental and FD C results revealed that these ne structures correspond to the deform ation $m$ odes of the liquid. A deform ation $m$ ode can be seen in $F$ ig. 2 as a sharp bend of the tra jectory (red arrow s). This extra m ode, which has not been previously observed, w as found to be a collision of the pendant drop w th the nozzle, triggered by the shock of breakup. T he mode is unstable and rapidly decays and thus only a ects the initialoscillation just after the break. Because of the excitation of the extra $m$ ode, the state point $\left(m ; z_{G}\right)$ separates from the well-de ned surface $U\left(m ; z_{G}\right)$ at the initial stage, and rapidly retums ( m s ) to the surface. T his process stretches and folds the chaotic orbit, which $m$ akes the potential surface tw o-folded as in $F$ ig. 3 (a).
