Derivative m om ents in turbulent shear ow s

We propose a generalized perspective on the behavior of high-order derivative moments in turbulent shear ows by taking account of the roles of small-scale intermittency and mean shear, in addition to the Reynolds number. Two asymptotic regimes are discussed with respect to shear effects. By these means, some existing disagreements on the Reynolds number dependence of derivative moments can be explained. That odd-order moments of transverse velocity derivatives tend not vanish as expected from elementary scaling considerations does not necessarily imply that small-scale an isotropy persists at all Reynolds numbers.

I. IN TRODUCTION

The postulate of local isotropy [1] in plies an invariance with respect to spatial rotations of the statistical properties of sm all scales of turbulence. Even though the large scales are anisotropic in all practical ows, it is thought that the sm all scales at high Reynolds numbers are shielded from anisotropy because of their separation by a wide range of interm ediate scales. At any nite Reynolds number, some residual e ects of sm all-scale anisotropy m ay linger, but all properm easures of anisotropy are expected to decrease rapidly with Reynolds number. An understanding of the rate at which sm all scales tend towards isotropy is a basic building block in turbulence theory.

A particularly appealing manner of generating largescale anisotropy is by a hom ogeneous shear characterized by a constant shear rate S dU = dy, where U (y) is the mean velocity in the stream wise direction x, and y is the direction of the shear. During the last few years, nearly hom ogeneous shear ow s, both experim ental [2{4] and num erical, $[5{7}]$ have exam ined the rate at which local isotropy is recovered with respect to the Taylorm icroscale R eynolds num ber, R . The notation is standard: $u^{0} =$, u is the velocity uctuation in the longitu-R dinal direction x, u^0 $hu^2 i$, $^2 = hu^2 i = h(0 u = 0 x)^2 i$, is the kinematic viscosity and h i denotes a suitably dened average. The discussion has often been focused on the behavior of norm alized odd m om ents of transverse velocity derivatives de ned as

where n is a positive integer. The velocity derivatives are small-scale quantities, and symmetry considerations of local isotropy dem and that the odd m om ents of transverse velocity derivatives be zero. In practice, they should decrease with R relatively rapidly. Though the postulate of local isotropy does not by itself stipulate this rate, simple estimates can be made by retaining the spirit of local isotropy and making further assumptions. Let us assume that the non-dimensional moments M $_{2n+1}$ depend on some power p of the shear, which is the ultimate source of anisotropy in hom ogeneous shear ows, and non-dimensionalize the shear dependence by a time scale formed by the energy dissipation rate and uid viscosity; this non-dimensionalization accords with K olmogorov's rst hypothesis that small-scale properties dependence by on and .We may then write

where it is further assumed that $S = O(u^0=L)$ and L is the large scale of turbulence. Lum ley [8] considered a linear dependence on the shear (i.e., p = 1). This yields an inverse power of R for the decay of all odd moments. The choice p = 1 accounts for the dependence of the sign of the odd moments on the sign of S in a simple manner.

The existing experim ental and num erical data on the skewness of the transverse velocity derivative are collected in Fig. 1. Data from any given source seem to t a power-law of the form

with m di ering from one set of data to another. Though the power-law is not a particularly good t for the totality of the data, the average roll-o seem s to be less steep than the inverse power discussed above. A tm ospheric data at m uch higher R eynolds num bers [9,10] are consistent with this slower rate of decay.

The situation with respect to the hyperksewness, M $_5$, is as follows. Two independent laboratory experiments in nearly hom ogeneous shear ows [3,4] draw dierent conclusions on the R behavior of M $_5$. On the one hand,

Shen and W arhaft [4] nd no dependence on R in the range betw een 10^2 and 10^3 . On the other hand, Ferchichi and T avoularis [3] regard their data to be essentially consistent with expectations of local isotropy. (For one perspective on this di erence, see W arhaft and Shen [11]). A collection of all known data is given in Fig. 2. The overall impression from the gure is that, while there is probably a weak decreasing trend for R > 300, the hyperskew ness does not diminish perceptibly even when R is as high as 1000. Shen and W arhaft [4] m easured the seventh normalized m om ent of the velocity derivative and found that it increased with R instead of decreasing.

Such ndings have been interpreted (e.g., Refs. 4 and 5) to mean that, in the presence of large-scale shear, sm all-scale anisotropy persists to very high Reynolds numbers. The intent of this paper is to clarify, at least partially, the simultaneous role played by shear, interm ittency and the Reynolds number | all of which have an im pact on trends displayed by odd derivative moments.

W e now consider in Sec. II the issue of interm ittency versus anisotropy. In Sec. III, we highlight the e ects of shear by discussing the limiting cases of large shear and local isotropy, and argue that R determ ines the state of the ow only partially. In Sec. IV the derivative skew-ness data are plotted in the plane spanned by the non-dimensional shear parameter S and R, where we use the de nition

This broader perspective may help resolve some seem ingly contradictory claims on the recovery of isotropy of small scales.

II. IN TERM ITTENCY VERSUS AN ISOTROPY

A large num ber of measurem ents have shown convincingly that high-order even m om ents of sm all-scale features of turbulence increase with R . Consider the longitudinal velocity derivative @u=@x. The product of its second moment and uid viscosity is essentially the energy dissipation, which is known to remain independent of R when R exceeds som e m oderately high value (see Refs. 14,15). On the other hand, all high-order m om ents of longitudinal velocity gradients grow with R (see, for example, the compilation in Ref. 16 of the data on the atness factor of Qu=Qx). Sixth and higher order mom ents increase at increasingly faster rates with R . These growths are attributed to the intermittency of smallscale turbulence. At the present level of our understanding, interm ittency is independent of an isotropy e ects. Therefore, just as the grow th of high-order even m om ents with increasing R is unrelated to an isotropy, it is legitim ate to ask if, at least in part, the slower-than-expected

decay | or even m odest growth | of odd m om ents, m ay be related to interm ittency.

To separate intermittency e ects from those of anisotropy, at least in som e approxim ate way, it is useful to plot the ratio M_{2n+1} (@u=@y)= M_{2n+1} (@u=@x). It is plausible to assume that the R -growth due to interm ittency e ects is the same for the moments of @u=@x and for the moments of Qu=Qy, the intermittency e ects of odd moments of Qu=Qy are cancelled in these ratios by those of @u=@x. Though this not a rigorous statem ent, it is useful to see the outcom e. Figure 3 shows the results. It is clear, despite large scatter, that all the moments show a tendency to dim inish with Reynolds number. The odd-m om ents in Fig. 3 are norm alized by powers of their respective variances. It would have been desirable to plot ratios of unnorm alized, or \bare", m om ents of the two derivatives, but Ref. 4 does not include those data. In any case, this should not make much di erence because $h(@u=@x)^2 i=h(@u=@y)^2 i$ is essentially a constant at high Reynolds num bers.

This same issue can be rephrased and reexam ined in a som ew hat di erent light. W hen we consider the mom ents such as skewness and hyperskewness, we usually norm alize them by the appropriate power of the variance of the variable. This is perfectly reasonable for G aussian or near-Gaussian variables, but not so for intermittent quantities with highly stretched tails. Perhaps a more reasonable alternative is to consider how an odd m om ent of a certain order varies with respect to the even m om ent just below or just above, or the geom etric m ean of those just below and just above. We illustrate the results of this consideration for the third, fith and seventh order moments of @u=@y (= x) in Fig. 4. The lack of data on the eight m om ent of @u=@y m akes the analysis of the seventh m om ent incom plete. N evertheless, it is clear that all these alternative ways of norm alization show substantial decay. It is hard to be precise about the rates of decay, partly because of the large scatter and partly because the incomplete manner in which the seventh moments have been analyzed, but it is conceivable that increasingly high-order m om ents, within a given norm alizing scheme, decay m ore slow ly. At the least, a careful discussion of the restoration of an isotropy requires the proper inclusion of intermittency e ects. This is our rst point.

III.SHEAR EFFECTS IN TW O LIM ITING CASES

It is reasonable to suppose that, to a rst approxim ation, the mean shear S and the viscosity determ ine the gross state of the ow. Expressing time units in terms of S¹, length units in terms of the integral length scale L, and the mean pro le as $U = Sye_x$, we get

where v = (u;v;w) and e_x is unit vector in the stream – wise direction x. The volume forcing is denoted by f. The two parameters m ay be expected to set the steady state uctuation level and energy dissipation rate. It also follows that the derived parameters R and S adjust them selves dynamically, in ways that are understood on ly partially, to the imposed values of and S.W e then expect

where g_1 and g_2 are unknown functions of their arguments.

A llthe hom ogeneous shear experiments to be discussed below have been done in air. This xes the viscosity to be approximately constant, so we can test the dependence of S and R on the shear rate S. The relevant plots (Figs. 5 (a) and (b)) show no obvious trend but only large scatter. This scatter may be related in part to the fact that P = 6 1 in some of the experiments, leading to nonstationarity. Here P is the production of turbulent kinetic energy, de ned as P = huviS for hom ogeneous shear. In part, it demonstrates that the ow might depend additionally on initial conditions, $hv^2 i_{t=0}$, or the type of driving of small-scale uctuations characterized globally by an input energy. From Eq. (5), the latter is given by

W e then get m ore com plex relations such as

If we add to F igs. 5 the atm ospheric data from Refs. 9 and 10, the situation becom es even m ore com plex. H ow ever, it is likely that, in such inhom ogeneous ow s, one has to take into account secondary factors such as convective e ects (though conditions in which they are m odest can always be chosen carefully). In laboratory experiments, secondary e ects m ight arise from the use of speci c passive or active grids for the generation of turbulence. Further di erences can arise when m easuring at a xed point instead of following the downstream evolution. This discussion m erely underlines the inadequacy of R as the sole indicator of the state of the ow. At the least, we have to possess som e know ledge of the other param eters in uencing the state of the ow before drawing m conclusions on the recovery of isotropy.

To keep m atters simple, we will focus below on hom ogeneously sheared ows. Because the initial conditions
 (@) re not known in all quanti able details, we shall tentatively stipulate a simple generalization of Eq. (1) in the form

and regard other e ects as superimposed $\noise"$ [25]. If so, we should investigate the behavior of the derivative moments by keeping one of the two parameters xed while varying the other, for example by xing S and varying R. This is the topic of the next section. However, it is useful to preface this consideration by examining two limiting behaviors in which some inequalities between R and S can be established.

A . Large shear case

Consider the case of large shear rate for which the coupling of the mean shear to the small-scale ow dom in a tes. In the rapid distortion limit, namely S ! 1, Eq. (5) become s linear because the viscous term as well as the (v r)v term can be dropped, so that any shear rate dependence can be eliminated by the rescaling of the variables, eg.t! St.

0 ur dim ensional estim ates are related to large but nite shear rates. For this case, the term representing the coupling of the turbulent velocity component to the mean shear is important and large in comparison to the nonlinear advective transport. Our situation corresponds to the case in which

For the hom ogeneous shear ow, we get for the left-hand-side of this equation

In the last step above, we have used the fact that the root-m ean-square velocity in the stream wise direction is larger than that in the shear direction, as has been found in all num erical and physical experiments. The term on the right hand side can be estimated roughly as $hu^2 i=$ where the scale ` is characteristic of turbulent velocity gradients, and can therefore be assumed to be of the order of the Taylorm icroscale, .We then require

W ith $= c u^{CB} = L$ and $L = = R e_L^{1=2} = 10$, and the constant c O(1) for su ciently large R , we get

In reality, c depends weakly on S .For example, Sreenivasan [23] has exam ined the data and concluded that c $g \exp(S)$, where 0.03, is a good empirical t. Since this dependence is quite weak, we have taken c to be a constant for simplicity. P resum ably, if Eq. (14) holds, the e ects of shear will always be felt no matter how high the Reynolds number.

B.Local isotropy lim it

At the other extrem e is the case in which local isotropy can be expected, a priori, to prevail A suitable criterion (see Corrsin [24]) is that a su ciently large separation should exist between the shear time scale, S¹, and the K olm ogorov time scale, $= (=)^{1=2}$. This can be written as

W ith c O (1) and R = $(20Re_L=3)^{1=2}$ we obtain

The implication is that local isotropy prevails for all S = R substantially smaller than 0.35. For all other conditions, one should expect that the magnitude of S will play some role in determining how high an R is required for local isotropy to prevail. This explicit dependence on shear has been noted for passive scalars by Sreenivasan and Tavoularis; [26] see their gures 2 and 3.

IV.THE R -S PHASE DIAGRAM

W e now plot in Fig. 6 all available data on the skewness of the transverse derivative, @u=@y, on a phase plane consisting of S and R. The conventional norm alization factors in the de nition of S are the total turbulent energy and its dissipation rate. This can be done quite readily for the num erical data, but experim ents usually provide inform ation only on the stream w ise com ponent of the turbulent energy and on the energy dissipation estim ate from the localisotropy form ula, = 15 h(@u=@x)^2i. The error m ade in this estim ate for the energy dissipation depends [23] on the m agnitudes of shear and R, but it appears to be a reasonable approximation for the present conditions. We have recalculated for all numerical data the energy dissipation rate as in experiments. It is clear from the gure that there is no simple correlation between the two parameters S and R .

W e have replotted the sam e data in Fig. 7. Dierent symbols correspond now to dierent magnitudes of the skew ness, as indicated in the legend, and not to di erent experim ents. Superim posed are islands in shades of grey to obtain a rough idea of the surface plot of f (R; S). We used an interpolation routine with local thin plate splines that can reconstruct a surface from scattered data. [28] The data are sparse in most of the regions of the plane so any surface-tting routine will introduce som e peculiarities. For reasons explained above, we can expect that the derivative skewness will become small in the local isotropy limit (lower right corner) and that the values will grow above 0.8 in the large shear case (upper left comer). A though the latter fact is not re ected by the surface t because the data points are absent there and alm ost all data points are in the interm ediate region, we think that the surface plot is not unreasonable.




FIG.1. The dependence of the skewness of the transverse velocity derivative on the Taylorm icroscale R eynolds num ber. The solid line indicates the R scaling expected to hold on the basis of Lum ley's dimensional considerations (see text). Notation in the legend stands for: PU, Pum ir [5]; YE, Yeung, for details of whose shear ow simulations, see [12]; RM, R ogers et al. [13]; SE, Schum acher and Eckhardt [6,7]; GW, G arg and W arhaft [2]; SW, Shen and W arhaft [4]; FT, Ferchichi and Tavoularis [3].

This plot o ers additional perspectives. For instance, Fig. 1 is just a projection of the data on to the R axis and masks the fundamental e ect of the applied shear (am ong other e ects). We have marked in this gure the trends of the data sets of W arhaft and co-workers (parabolic solid line labelled by GW /SW) and of Ferchichi and Tavoularis (straight line labelled by FT), respectively. They show that the two experiments follow di erent paths: while the Ferchichi-Tavoularis data run directly down the mountain range', the Shen-W arhaft data seem to run in a kind of spiral around the hountain', presum ably resulting in a slower decay of the skew ness when projected on to the R axis. Finally, the two lim iting regimes of Sec. III are also plotted. The local isotropy lim it is not reached for any of the data. The large shear case is reached for very large S . A threshold S_c grows when R increases; alternatively, local isotropy requires larger R if the shear param eter is larger.

V.CONCLUDING REMARKS

Considerable attention has been paid recently to the fact that in shear ows the moments of transverse velocity derivatives do not vanish with Reynolds number as fast as was expected. We have introduced two considerations for interpreting these observations, invoking sm all-scale interm ittency and the magnitude of the shear parameter. These two e ects work in combination with the Reynolds numbers in determ ining the magnitudes of odd moments of velocity derivatives. The fact that the odd moments, when norm alized by an appropriate power of the variance (a procedure steeped in studies of G aussian processes), decay m ore slow ly than expected should not be considered a priori as incontrovertible evidence against local isotropy. We believe that the broader perspective of this paper m ay explain som e seem ing contradictions that exist in the literature.

The conclusions we draw in this paper would be more de nitive if the data spanned much higher Reynolds num – ber range. This can be done with adequate resolution only in atmospheric ows at present. The existing measurements are in conformity with the discussion here, but it is di cult to be de nitive because of the usual problems that offen exist in atmospheric measurements. On the other hand, it seems quite feasible in numerical simulations to x the Reynolds num ber and vary the shearparam eter, even though the Reynolds num ber rangem ay be limited. Such a study will tell us more about the restoration (or otherwise) of small-scale isotropy.

In the recent past, various e orts have been m ade to understand the e ects of anisotropy through an SO (3) decom position of structure functions and other tensorial objects (see Ref. 29 for the basic theoretical idea and Refs. 30-32 for implementations of the idea and further references). The m ethod o ers a transparent way of determ ining the degree of anisotropy in turbulent statistics. The relation between that e ort and the present global picture needs to be explored.




FIG.2. The dependence of the hyperskewness of the transverse velocity derivative on the Taylorm icroscale R eynolds num ber. The notation in the legend is the same as in Fig.1.




FIG.3. The ratio of the norm alized moments M_{2n+1} (@u=@y) and M_{2n+1} (@u=@x) for n = 1, 2 and 3 versus the Taylor microscale Reynolds number. Quantities M_{2n+1} are dened in Eq. (1). The notation in the legend is the same as in Fig.1. Here and elsewhere, data from [4] have been read from published graphs.




FIG.4. Third, fth, and seventh order transverse derivative m om ents with di erent norm alizations, plotted against R . Squares are norm alized by the m om ent of preceding even order, circles by the succeeding even order. Triangles are norm alized by the geometric m ean of both orders. Variable x in the legend stands for @u=@y. The data are from Yeung [12], Schum acher/Eckhardt [6,7] and Shen/W arhaft [4]. Solid lines with attached numbers indicate ts to possible algebraic power laws. Each sym bol corresponds to a di erent norm alization, and includes all the data just cited.




FIG.5. (a) The dependence of the shear parameter S on the shear rate S for xed kinematic viscosity, = air. (b) Dependence of the Taylorm icroscale Reynolds number R on S for xed . Un led symbols are the same as in Fig.1. Additional shear ow experiments have been included, though they did not focus on derivative moments explicitly (led symbols). The additions are: RO, Rose [17]; ML, Mulhearm and Luxton [18]; HC, Harris, Graham, and Corrsin [19]; TC, Tavoularis and Corrsin [20]; TK, Tavoularis and K armik [21]; SV, Saddoughi and Veeravalli [22].






FIG.7. Derivative skew ness and its dependence of R and S. The solid straight line is for the large shear lim it S = R = 1, the dashed lines are for local isotropy lim it S = R = 0.003 and 0.001 (left to right). Underlying grey scales result from a surface t. Trends of the data from Ferchichi and Tavoularis (FT) and W arhaft and co-workers (GW /SW) are indicated by solid lines. D i erent sym bols indicate di erent ranges of the skew ness, and m ay represent data from the same source. The data point below S = 3 is taken from the num erical experiments of R ogers et al. [13]
