This short review is an introduction to a great variety of methods, the collection of which is called the Painlevé analysis, intended at producing all kinds of exact (as opposed to perturbative) results on nonlinear equations, whether ordinary, partial, or discrete.

## 1 The classical program of the Painlevé school and its achievements

It is impossible to understand anything to the Painlevé property without keeping in mind the original problem as stated by L. Fuchs, Poincaré and Painlevé: to define new functions from ordinary differential equations (ODEs). This simply formulated problem implies to select those ODEs whose general solution can be made singlevalued by some uniformization procedure (cuts, Riemann surface), so as to fit the definition of a function. This property (the possibility to uniformize the general solution of an ODE), nowadays called the Painlevé property ( PP ), is equivalent to the more practical definition.

Definition 1 The Painlevé property of an ODE is the absence of movable critical singularities in its general solution.

Let us recall that a singularity is said movable (as opposed to fixed) if its location depends on the initial conditions, and critical if multivaluedness takes place around it. Other definitions of the PP, excluding for instance the essential singularities, or replacing "movable critical singularities" by "movable singularities other than poles", or "its general solution" by "all its solutions", are incorrect. Two examples taken from Chazy [1] explain why this is so. The first example is the celebrated Chazy's equation of class III

whose general solution is only defined inside or outside a circle characterized by the three initial conditions (two for the center, one for the radius); this solution is holomorphic in its domain of definition and cannot be analytically continued beyond it. This equation therefore has the PP, and the only singularity is a movable analytic essential singular line which is a natural boundary.

The second example [11, p. 360] is the third order second degree ODE

whose general solution is singlevalued,

$$
\begin{equation*}
u=e^{c_{1} x+c_{2}} / c_{1}+\frac{c_{1}^{2}-4}{4 c_{1}} x+c_{3} \tag{3}
\end{equation*}
$$

but which also admits a singular solution (envelope solution) with a movable critical singularity,

$$
\begin{equation*}
u=C_{2}-\log \cos \left(x-C_{1}\right) \tag{4}
\end{equation*}
$$

For more details, see the arguments of Painlevé [17, §2.6] and Chazy 17, §5.1].
The PP is invariant under an arbitrary homography on the dependent variable and an arbitrary change of the independent variable (homographic group)

$$
\begin{align*}
& (u, x) \mapsto(U, X), u(x)=\frac{\alpha(x) U(X)+\beta(x)}{\gamma(x) U(X)+\delta(x)}, X=\xi(x) \\
& (\alpha, \beta, \gamma, \delta, \xi) \text { functions, } \alpha \delta-\beta \gamma \neq 0 \tag{5}
\end{align*}
$$

Every linear ODE possesses the PP since its general solution depends linearly on the movable constants, so, in order to define new functions, one must turn to nonlinear ODEs in a systematic way: first order algebraic equations, then second order, ... The current achievements are the following.

First order algebraic ODEs (polynomial in $u, u^{\prime}$, analytic in $x$ ) define only one function, the Weierstrass elliptic function $\wp$, new in the sense that its ODE

is not reducible to a linear ODE. Its only singularities are movable double poles.

Second order algebraic ODEs (polynomial in $u, u^{\prime}, u^{\prime \prime}$, analytic in $x$ ) define six functions, the Painlevé functions $\operatorname{Pn}, n=1, \cdots, 6$, new because they are not reducible to either a linear ODE or a first order ODE. This question of irreducibility, the subject of a long dispute between Painlevé and Joseph Liouville, has been rigorously settled only recently (91]. The canonical representatives of P1-P6 in their equivalence class under the group (5) are

\mathrm{P} 5: u^{\prime \prime}= & {\left[\frac{1}{2 u}+\frac{1}{u-1}\right] u^{\prime 2}-\frac{u^{\prime}}{x}+\frac{(u-1)^{2}}{x^{2}}\left[\alpha u+\frac{\beta}{u}\right]+\gamma \frac{u}{x}+\delta \frac{u(u+1)}{u-1}, } \\
\mathrm{P} 6: u^{\prime \prime}= & \frac{1}{2}\left[\frac{1}{u}+\frac{1}{u-1}+\frac{1}{u-x}\right] u^{\prime 2}-\left[\frac{1}{x}+\frac{1}{x-1}+\frac{1}{u-x}\right] u^{\prime} \\
& +\frac{u(u-1)(u-x)}{x^{2}(x-1)^{2}}\left[\alpha+\beta \frac{x}{u^{2}}+\gamma \frac{x-1}{(u-1)^{2}}+\delta \frac{x(x-1)}{(u-x)^{2}}\right],
\end{aligned}
$$

in which $\alpha, \beta, \gamma, \delta$ are arbitrary complex parameters. Their only singularities are movable poles (in the $e^{x}$ complex plane for P3 and P 5 , in the $x$ plane for the others), with in addition three fixed critical singularities for P6, located at $x=\infty, 0,1$.

Third and higher order ODEs [11, 7, 35, 36] have not yet defined new functions. Although there are some good candidates (the Garnier system

47], several fourth order ODEs 56, 35], which all have a transcendental dependence on the constants of integration), the question of their irreducibility (to a linear, Weierstrass, or Painlevé equation) is very difficult and still open. To understand the difficulty, it is sufficient to consider the fourth order ODE for $u(x)$ defined by

u=u_{1}+u_{2}, u_{1}^{\prime \prime}=6 u_{1}^{2}+x, u_{2}^{\prime \prime}=6 u_{2}^{2}+x \tag{7}
\end{equation*}
$$

This ODE (easy to write by elimination of $u_{1}, u_{2}$ ) has a general solution which depends transcendentally on the four constants of integration, and it is reducible.

The master equation P6 was first written by Picard in 1889 in a particular case, in a very elegant way. Let $\varphi$ be the elliptic function defined by

and let $\omega_{1}(x), \omega_{2}(x)$ be its two half-periods. Then the function

$$
\begin{equation*}
u: x \mapsto u(x)=\varphi\left(2 c_{1} \omega_{1}(x)+2 c_{2} \omega_{2}(x), x\right) \tag{9}
\end{equation*}
$$

with ( $c_{1}, c_{2}$ ) arbitrary constants, has no movable critical singularities, and it satisfies a second order ODE which is P6 in the particular case $\alpha=\beta=\gamma=$ $\delta-1 / 2=0$. The generic P6 was found simultaneously from two different approaches, the nonlinear one of the Painlevé school as said above 81], and the linear one of R. Fuchs 44 as an isomonodromy condition. In the latter, one considers a second order linear ODE for $\psi(t)$ with four Fuchsian singularities of crossratio $x$ (located for instance at $t=\infty, 0,1, x$ ), with in addition, as prescribed by Poincaré for the isomonodromy problem, one apparent singularity $t=u$,

\begin{align*}
-\frac{2}{\psi} \frac{\mathrm{~d}^{2} \psi}{\mathrm{~d} t^{2}}= & \frac{A}{t^{2}}+\frac{B}{(t-1)^{2}}+\frac{C}{(t-x)^{2}}+\frac{D}{t(t-1)}+\frac{3}{4(t-u)^{2}} \\
& +\frac{a}{t(t-1)(t-x)}+\frac{b}{t(t-1)(t-u)} \tag{10}
\end{align*}
$$

$(A, B, C, D)$ denoting constants and $(a, b)$ parameters. The requirement that the monodromy matrix (which transforms two independent solutions $\psi_{1}, \psi_{2}$ when $t$ goes around a singularity) be independent of the nonapparent singularity $x$ results in the condition that $u$, as a function of $x$, satisfies P6.

A useful by-product of this search for new functions is the construction of several exhaustive lists (classifications) of second [45, 8, 30, 31, 32], third [11, 7, 36], fourth [7, 35], or higher order (42] ODEs, whose general solution is explicitly given because they have the PP. Accordingly, if one has an ODE in such an already studied class (e.g. second order second degree binomialtype ODEs 31 $u^{\prime \prime 2}=F\left(u^{\prime}, u, x\right)$ with $F$ rational in $u^{\prime}$ and $u$, analytic in $\left.x\right)$, and which is suspected to have the PP (for instance because one has been unable to detect any movable critical singularity, see Section 3), then two cases are possible: either there exists a transformation (5) mapping it to a listed equation, in which case the ODE has the PP and is explicitly integrated, or such a transformation does not exist, and the ODE has not the PP.

## 2 Integrability and Painlevé property for partial differential equations

Defining the PP for PDEs is not easy, but this must be done for future use in sections 3 (the Painlevé test) and (proving the PP). Such a definition must involve a global, constructive property, which excludes the concept of general solution. Indeed, this is only in nongeneric cases like the Liouville equation that the general solution of a PDE can be built explicitly. This is where the Bäcklund transformation comes in. Let us first recall the definition of this powerful tool (for simplicity, but this is not a restriction, we give the basic definitions for a PDE defined as a single scalar equation for one dependent variable $u$ and two independent variables $(x, t))$.

Definition 2 (Refs. [38, vol. III chap. XII], 605) A Bäcklund transformation (BT) between two given PDEs

\begin{equation*}
E_{1}(u, x, t)=0, E_{2}(U, X, T)=0 \tag{11}
\end{equation*}
$$

is a pair of relations

$$
\begin{equation*}
F_{j}(u, x, t, U, X, T)=0, j=1,2 \tag{12}
\end{equation*}
$$

with some transformation between $(x, t)$ and $(X, T)$, in which $F_{j}$ depends on the derivatives of $u(x, t)$ and $U(X, T)$, such that the elimination of $u$ (resp. $U$ ) between $\left(F_{1}, F_{2}\right)$ implies $E_{2}(U, X, T)=0$ (resp. $\left.E_{1}(u, x, t)=0\right)$. In case the two PDEs are the same, the BT is also called the auto-BT.

Under a reduction $\mathrm{PDE} \rightarrow \mathrm{ODE}$, the BT reduces to a birational transformation (also initials BT!), which is not involved in the definition of the PP for ODEs. Therefore one needs an intermediate (and quite important) definition before defining the PP.

Definition 3 A PDE in $N$ independent variables is integrable if at least one of the following properties holds.

1. Its general solution can be obtained, and it is an explicit closed form expression, possibly presenting movable critical singularities.
2. It is linearizable.
3. For $N>1$, it possesses an auto-BT which, if $N=2$, depends on an arbitrary complex constant, the Bäcklund parameter.
4. It possesses a $B T$ to another integrable $P D E$.

Examples of these various situations are, respectively: the PDE $u_{x} u_{t}+$ $u u_{x t}=0$ with general solution $u=\sqrt{f(x)+g(t)}$, which presents movable critical singularities and can be transformed into the d'Alembert equation; the Burgers PDE $u_{t}+u_{x x}+2 u u_{x}=0$, linearizable into the heat equation $\psi_{t}+\psi_{x x}=0$; the KdV PDE $u_{t}+u_{x x x}-6 u u_{x}=0$, which is integrable by
the inverse spectral transform (IST); the Liouville PDE $u_{x t}+e^{u}=0$, which possesses a BT to the d'Alembert equation $\psi_{x t}=0$.

We now have enough elements to give a definition of the Painlevé property for PDEs which is indeed an extrapolation of the one for ODEs.

Definition 4 The Painlevé property (PP) of a PDE is its integrability (definition (3) and the absence of movable critical singularities near any noncharacteristic manifold.

One will retain that the Painlevé property is a more demanding property than the mere integrability.

The PP for PDEs is invariant under the natural extension of the homographic group (5), and classifications similar to those of ODEs have also been performed for PDEs, in particular second order first degree PDEs [33, 34, isolating only the already known PDEs (Burgers, Liouville, sine-Gordon, Tzitzéica, etc). Classifications based on other criteria, such as the existence of an infinite number of conservation laws [66], isolate more PDEs, which are likely all integrable in the sense of definition 3; it would be interesting to check that, under the group of transformations generated by Bäcklund transformations and hodograph transformations, each of them is equivalent to a PDE with the PP.

If one performs a hodograph transformation (typically an exchange of the dependent and independent variables $u$ and $x$ ) on a PDE having the PP, the transformed PDE possesses a weaker form of the PP in which, for instance, all leading powers and Fuchs indices become rational numbers instead of integers. Details can be found e.g. in Ref. 14. For instance, the Harry-Dym, CamassaHolm 10] and DHH equations 39 can all be mapped to a PDE with the PP by some hodograph transformation.

If the above definition of the PP for PDEs is really an extrapolation of the one for ODEs, then, given a PDE with the PP, every reduction to an ODE which preserves the differential order (i.e. a noncharacteristic reduction) yields an ODE which necessarily has the PP. This proves the conjecture of Ablowitz, Ramani and Segur [3], provided the definition 1 really extrapolates that for ODEs, and this is the difficult part of this question.

There are plenty of such examples of reductions, for instance the self-dual Yang-Mills equations admit reductions to all six Pn equations 64].

Given a PDE, the process to prove its integrability is twofold. One must first check whether it may be integrable, for instance by applying the Painlevé test, as will now be explained in section 3. Then, in case of a nonnegative answer, one must build explicitly the elements which are required to establish integrability, for instance by using methods described in section 1 .

Although partially integrable and nonintegrable equations, i.e. the majority of physical equations, admit no BT, they retain part of the properties of (fully) integrable PDEs, and this is why the methods presented below apply to both cases as well. One such example is included below for information, section 4.5.

## 3 The Painlevé test for ODEs and PDEs

The test is an algorithm providing a set of necessary conditions for the equation to possess the PP. Its full, detailed version can be found in Ref. 17, $\S 6]$, and below is only given a short presentation of its main subset, known as the method of pole-like expansions, due to Kowalevski and Gambier 45]. The generated necessary conditions are a priori not sufficient, this was proven by Picard (1894), who exhibited the example of the ODE with the general solution $u=\wp\left(\lambda \log \left(x-c_{1}\right)+c_{2}, g_{2}, g_{3}\right)$, namely

$$
\begin{equation*}
u^{\prime \prime}-\frac{u^{\prime 2}}{4 u^{3}-g_{2} u-g_{3}}\left(6 u^{2}-\frac{g_{2}}{2}\right)-\frac{u^{\prime 2}}{\lambda \sqrt{4 u^{3}-g_{2} u-g_{3}}}=0 \tag{13}
\end{equation*}
$$

which has the PP iff $2 \pi i \lambda$ is a period of the elliptic function $\wp$, a transcendental condition on ( $\lambda, g_{2}, g_{3}$ ) impossible to obtain in a finite number of algebraic steps such as the Painlevé test. Therefore it is wrong to issue statements like "The equation passes the test, therefore it has the PP". The only way to prove the PP is,

- for an ODE, either to explicitly integrate with the known functions (solutions of linear, elliptic, hyperelliptic (a generalization of elliptic) or Painlevé equations), or, if one believes to have found a new function, to prove both the absence of movable critical singularities and the irreducibility [91] to the known functions,
- for a PDE, to explicitly build the integrability elements of the definition 4.

Let us return to the test itself. It is sufficient to present the method of pole-like expansions for one $N$ th order equation

in one dependent variable $u$ and two independent variables $x, t$. Movable singularities lay on a codimension one manifold

$$
\begin{equation*}
\varphi(x, t)-\varphi_{0}=0 \tag{15}
\end{equation*}
$$

in which the singular manifold variable $\varphi$ is an arbitrary function of the independent variables and $\varphi_{0}$ an arbitrary movable constant. Basically [94], the test of Weiss, Tabor and Carnevale consists in checking the existence of all possible local representations, near $\varphi(x, t)-\varphi_{0}=0$, of the general solution (whatever be its definition, difficult for PDEs) as a locally single valued expression, e.g. the Laurent series

$$
\begin{equation*}
u=\sum_{j=0}^{+\infty} u_{j} \chi^{j+p},-p \in \mathcal{N}, E=\sum_{j=0}^{+\infty} E_{j} \chi^{j+q},-q \in \mathcal{N} \tag{16}
\end{equation*}
$$

with coefficients $u_{j}, E_{j}$ independent of the expansion variable $\chi$. The natural choice $\chi=\varphi-\varphi_{0}$ [94] generates lengthy expressions $u_{j}, E_{j}$. Fortunately,
there is much freedom in choosing $\chi$, only required to vanish as $\varphi-\varphi_{0}$ and to have a homographic dependence on $\varphi-\varphi_{0}$ so as not to alter the structure of movable singularities, hence the result of the test. The unique choice which minimizes the expressions and puts no constraint on $\varphi$ is 16

$$
\begin{equation*}
\chi=\frac{\varphi-\varphi_{0}}{\varphi_{x}-\frac{\varphi_{x x}}{2 \varphi_{x}}\left(\varphi-\varphi_{0}\right)}=\left[\frac{\varphi_{x}}{\varphi-\varphi_{0}}-\frac{\varphi_{x x}}{2 \varphi_{x}}\right]^{-1}, \varphi_{x} \neq 0 \tag{17}
\end{equation*}
$$

in which $x$ denotes an independent variable whose component of $\operatorname{grad} \varphi$ does not vanish. The expansion coefficients $u_{j}, E_{j}$ are then invariant under the six-parameter group of homographic transformations

$$
\begin{equation*}
\varphi \mapsto \frac{a^{\prime} \varphi+b^{\prime}}{c^{\prime} \varphi+d^{\prime}}, a^{\prime} d^{\prime}-b^{\prime} c^{\prime} \neq 0 \tag{18}
\end{equation*}
$$

in which $a^{\prime}, b^{\prime}, c^{\prime}, d^{\prime}$ are arbitrary complex constants, and these coefficients only depend on the following elementary differential invariants and their derivatives: the Schwarzian

$$
\begin{equation*}
S=\{\varphi ; x\}=\frac{\varphi_{x x x}}{\varphi_{x}}-\frac{3}{2}\left(\frac{\varphi_{x x}}{\varphi_{x}}\right)^{2} \tag{19}
\end{equation*}
$$

and one other invariant per independent variable $t, y, \ldots$

\begin{equation*}
C=-\varphi_{t} / \varphi_{x}, K=-\varphi_{y} / \varphi_{x}, \ldots \tag{20}
\end{equation*}
$$

The two invariants $S, C$ are linked by the cross-derivative condition

$$
\begin{equation*}
X \equiv\left(\left(\varphi_{x x x}\right)_{t}-\left(\varphi_{t}\right)_{x x x}\right) / \varphi_{x}=S_{t}+C_{x x x}+2 C_{x} S+C S_{x}=0 \tag{21}
\end{equation*}
$$

identically satisfied in terms of $\varphi$.
For the practical computation of $\left(u_{j}, E_{j}\right)$ as functions of $(S, C)$ only, i.e. what is called the invariant Painlevé analysis, the variable $\varphi$ disappears, and the only information required is the gradient of the expansion variable $\chi$,

$$
\begin{equation*}
\chi_{x}=1+\frac{S}{2} \chi^{2}, \chi_{t}=-C+C_{x} \chi-\frac{1}{2}\left(C S+C_{x x}\right) \chi^{2} \tag{22}
\end{equation*}
$$

with the constraint (21) between $S$ and $C$.
Consider for instance the Kolmogorov-Petrovskii-Piskunov (KPP) equation 55, 74]

\begin{equation*}
E(u) \equiv b u_{t}-u_{x x}+\gamma u u_{x}+2 d^{-2}\left(u-e_{1}\right)\left(u-e_{2}\right)\left(u-e_{3}\right)=0 \tag{23}
\end{equation*}
$$

with $\left(b, \gamma, d^{2}\right)$ real and $e_{j}$ real and distinct, encountered in reaction-diffusion systems (the convection term $u u_{x}$ 87] is quite important in physical applications to prey-predator models).

The first step, to search for the families of movable singularities $u \sim$ $u_{0} \chi^{p}, E \sim E_{0} \chi^{q}, u_{0} \neq 0$, results in the selection of the dominant terms $\hat{E}(u)$

\begin{equation*}
\hat{E}(u) \equiv-u_{x x}+\gamma u u_{x}+2 d^{-2} u^{3} \tag{24}
\end{equation*}
$$

which provide two solutions $\left(p, u_{0}\right)$

$$
\begin{equation*}
p=-1, q=-3,-2-\gamma u_{0}+2 d^{-2} u_{0}^{2}=0 \tag{25}
\end{equation*}
$$

The necessary condition that all values of $p$ be integer is satisfied.
The second step is, for every selected family, to compute the linearized equation,

$$
\begin{align*}
\left(\hat{E}^{\prime}(u)\right) w & \equiv \lim _{\varepsilon \rightarrow 0} \frac{\hat{E}(u+\varepsilon w)-\hat{E}(u)}{\varepsilon} \\
& =\left(-\partial_{x}^{2}+\gamma u \partial_{x}+\gamma u_{x}+6 d^{-2} u^{2}\right) w=0 \tag{26}
\end{align*}
$$

then its Fuchs indices $i$ near $\chi=0$ as the roots of the indicial equation

$$
\begin{align*}
P(i) & =\lim _{\chi \rightarrow 0} \chi^{-i-q}\left(-\partial_{x}^{2}+\gamma u_{0} \chi^{p} \partial_{x}+\gamma p u_{0} \chi^{p-1}+6 d^{-2} u_{0}^{2} \chi^{2 p}\right) \chi^{i+p}  \tag{27}\\
& =-(i-1)(i-2)+\gamma u_{0}(i-2)+6 d^{-2} u_{0}^{2}  \tag{28}\\
& =-(i+1)\left(i-4-\gamma u_{0}\right)=0 \tag{29}
\end{align*}
$$

and finally to enforce the necessary condition that, for each family, these two indices be distinct integers [43, 19]. Considering each family separately would produce a countable number of solutions, which is incorrect. Considering the two families simultaneously, the diophantine condition that the two values $i_{1}, i_{2}$ of the Fuchs index $4+\gamma u_{0}$ be integer has a finite number of solutions, namely [6, App. I]

$$
\begin{align*}
& \gamma^{2} d^{2}=0,\left(i_{1}, i_{2}\right)=(4,4), u_{0}=(-d, d)  \tag{30}\\
& \gamma^{2} d^{2}=2, \quad\left(i_{1}, i_{2}\right)=(3,6), \gamma u_{0}=(-1,2)  \tag{31}\\
& \gamma^{2} d^{2}=-18,\left(i_{1}, i_{2}\right)=(-2,1), \gamma u_{0}=(-6,-3) \tag{32}
\end{align*}
$$

It would be wrong at this stage to discard negative integer indices. Indeed, in linear ODEs such as (26), the single valuedness required by the Painlevé test restricts the Fuchs indices to integers, whatever be their sign. Let us proceed with the first case only, $\gamma=0$ (the usual KPP equation).

The recurrence relation for the next coefficients $u_{j}$,

$$
\begin{equation*}
\forall j \geq 1: E_{j} \equiv P(j) u_{j}+Q_{j}\left(\left\{u_{l} \mid l<j\right\}\right)=0 \tag{33}
\end{equation*}
$$

depends linearly on $u_{j}$ and nonlinearly on the previous coefficients $u_{l}$.
The third and last step is then to require, for any admissible family and any Fuchs index $i$, that the no-logarithm condition

\forall i \in \mathcal{Z}, P(i)=0: Q_{i}=0 \tag{34}
\end{equation*}
$$

holds true. At index $i=4$, the two conditions, one for each sign of $d$ 15,

$$
\begin{gather*}
Q_{4} \equiv C\left[\left(b d C+s_{1}-3 e_{1}\right)\left(b d C+s_{1}-3 e_{2}\right)\left(b d C+s_{1}-3 e_{3}\right)\right. \\
\left.-3 b^{2} d^{3}\left(C_{t}+C C_{x}\right)\right]=0, s_{1}=e_{1}+e_{2}+e_{3} \tag{35}
\end{gather*}
$$

are not identically satisfied, so the PDE fails the test. This ends the test.

If instead of the PDE (23) one considers its reduction $u(x, t)=U(\xi), \xi=$ $x-c t$ to an ODE, then $C=$ constant $=c$, and the two conditions $Q_{4}=0$ select the seven values $c=0$ and $c^{2}=\left(s_{1}-3 e_{k}\right)^{2}(b d)^{-2}, k=1,2,3$. For all these values, the necessary conditions are then sufficient since the general solution $U(\xi)$ is singlevalued (equation numbered 8 in the list of Gambier 45 reproduced in 54]).

It frequently happens that the Laurent series (16) only represents a particular solution, for instance because some Fuchs indices are negative integers, e.g. the fourth order ODE [7, p. 79]

which admits the family

\end{equation*}

The series (16) depends on two, not four, arbitrary constants, so two are missing and may contain multivaluedness. In such cases, one must perform a perturbation in order to represent the general solution and to test the missing part of the solution for multivaluedness.

This perturbation [19] is close to the identity (for brevity, we skip the $t$ variable)

x \text { unchanged, } u=\sum_{n=0}^{+\infty} \varepsilon^{n} u^{(n)}: E=\sum_{n=0}^{+\infty} \varepsilon^{n} E^{(n)}=0 \tag{38}

where, like for the $\alpha$-method of Painlevé, the small parameter $\varepsilon$ is not in the original equation.

Then, the single equation (14) is equivalent to the infinite sequence

\begin{align*}
& n=0 E^{(0)}  \tag{39}\\
& \equiv E\left(x, u^{(0)}\right)=0  \tag{40}\\
& \forall n \geq 1 E^{(n)} \equiv E^{\prime}\left(x, u^{(0)}\right) u^{(n)}+R^{(n)}\left(x, u^{(0)}, \ldots, u^{(n-1)}\right)=0
\end{align*}
$$

with $R^{(1)}$ identically zero. From a basic theorem of Poincaré 17, Theorem II, §5.3], necessary conditions for the PP are

- the general solution $u^{(0)}$ of (39) has no movable critical points,
- the general solution $u^{(1)}$ of (40) has no movable critical points,
- for every $n \geq 2$ there exists a particular solution of 40 without movable critical points.

Order zero is just the original equation (14) for the unknown $u^{(0)}$, so one takes for $u^{(0)}$ the already computed (particular) Laurent series (16).

Order $n=1$ is identical to the linearized equation

$$
\begin{equation*}
E^{(1)} \equiv E^{\prime}\left(x, u^{(0)}\right) u^{(1)}=0 \tag{41}
\end{equation*}
$$

and one must check the existence of $N$ independent solutions $u^{(1)}$ locally singlevalued near $\chi=0$, where $N$ is the order of (14).

The two main implementations of this perturbation are the Fuchsian perturbative method 19] and the nonFuchsian perturbative method 71. In the above example (36), both methods indeed detect multivaluedness, at perturbation order $n=7$ for the first one, and $n=1$ for the second one (details below).

### 3.1 The Fuchsian perturbative method

Adapted to the presence of negative integer indices in addition to the ever present value -1 , this method [43, 19] generates additional no-log conditions (34). Denoting $\rho$ the lowest integer Fuchs index, $\rho \leq-1$, the Laurent series for $u^{(1)}$

u^{(1)}=\sum_{j=\rho}^{+\infty} u_{j}^{(1)} \chi^{j+p} \tag{42}
\end{equation*}
$$

represents a particular solution containing a number of arbitrary coefficients equal to the number of Fuchs indices, counting their multiplicity. If this number equals $N$, it represents the general solution of (41). Two examples will illustrate the method [17, §5.7.3].

The equation

$$
\begin{equation*}
u^{\prime \prime}+4 u u^{\prime}+2 u^{3}=0 \tag{43}
\end{equation*}
$$

possesses the single family

$$
\begin{equation*}
p=-1, E_{0}^{(0)}=u_{0}^{(0)}\left(u_{0}^{(0)}-1\right)^{2}=0, \text { indices }(-1,0) \tag{44}
\end{equation*}
$$

with the puzzling fact that $u_{0}^{(0)}$ should be at the same time equal to 1 according to the equation $E_{0}^{(0)}=0$, and arbitrary according to the index 0 . The necessity to perform a perturbation arises from the multiple root of the equation for $u_{0}^{(0)}$, responsible for the insufficient number of arbitrary parameters in the zeroth order series $u^{(0)}$. The application of the method provides

E^{\prime}\left(x, u^{(0)}\right) & =\partial_{x}^{2}+4 \chi^{-1} \partial_{x}+2 \chi^{-2},  \tag{46}\\
u^{(1)} & =u_{0}^{(1)} \chi^{-1}, u_{0}^{(1)} \text { arbitrary }  \tag{47}\\
E^{(2)} & =E^{\prime}\left(x, u^{(0)}\right) u^{(2)}+6 u^{(0)} u^{(1)^{2}}+4 u^{(1)} u^{(1)^{\prime}} \\
& =\chi^{-2}\left(\chi^{2} u^{(2)}\right)^{\prime \prime}+2 u_{0}^{(1)^{2}} \chi^{-3}=0,  \tag{48}\\
u^{(2)} & =-2 u_{0}^{(1)^{2}} \chi^{-1}(\log \chi-1) \tag{49}
\end{align*}
$$

The movable logarithmic branch point is therefore detected in a systematic way at order $n=2$ and index $i=0$. This result was of course found long ago by the $\alpha$-method 80, $\S 13$, p 221].

The equation (36) possesses the two families

$$

& p=-2, u_{0}^{(0)}=-60, \text { ind. }(-3,-2,-1,20), \hat{E}=u^{\prime \prime \prime \prime}+3 u u^{\prime \prime}-4 u^{\prime 2}  \tag{50}\\
& p=-3, u_{0}^{(0)} \text { arbitrary, indices }(-1,0), \hat{E}=3 u u^{\prime \prime}-4 u^{\prime 2} \tag{51}
\end{align*}
$$

The second family has a Laurent series $(p:+\infty)$ which happens to terminate 19

$$
\begin{equation*}
u^{(0)}=c\left(x-x_{0}\right)^{-3}-60\left(x-x_{0}\right)^{-2},\left(c, x_{0}\right) \text { arbitrary. } \tag{52}
\end{equation*}
$$

For this family, the Fuchsian perturbative method is then useless, because the two arbitrary coefficients corresponding to the two Fuchs indices are already present at zeroth order.

The first family provides, at zeroth order, only a two-parameter expansion and, when one checks the existence of the perturbed solution

one finds that coefficients $u_{20}^{(0)}, u_{-3}^{(1)}, u_{-2}^{(1)}, u_{-1}^{(1)}$ can be chosen arbitrarily, and, at order $n=7$, one finds two violations 19

$$

Q_{-1}^{(7)} \equiv u_{20}^{(0)} u_{-3}^{(1)^{7}}=0, Q_{20}^{(7)} \equiv u_{20}^{(0)^{2}} u_{-3}^{(1)^{6}} u_{-2}^{(1)}=0 \tag{54}
\end{equation*}

implying the existence of a movable logarithmic branch point.

### 3.2 The nonFuchsian perturbative method

Whenever the number of indices is less than the differential order of the equation, the Fuchsian perturbative method fails to build a representation of the general solution, thus possibly missing some no-log conditions. The missing solutions of the linearized equation (41) are then solutions of the nonFuchsian type near $\chi=0$.

In section 3.1, the fourth order equation (36) has been shown to fail the test after a computation practically untractable without a computer. Let us prove the same result without computation at all $\sqrt[71]{ }$. The linearized equation

$$
\begin{equation*}
E^{(1)}=E^{\prime}\left(x, u^{(0)}\right) u^{(1)} \equiv\left[\partial_{x}^{4}+3 u^{(0)} \partial_{x}^{2}-8 u_{x}^{(0)} \partial_{x}+3 u_{x x}^{(0)}\right] u^{(1)}=0 \tag{55}
\end{equation*}
$$

is known globally for the second family because the two-parameter solution (52) is closed form, therefore one can test all the singular points $\chi$ of (55). These are $\chi=0$ (nonFuchsian) and $\chi=\infty$ (Fuchsian), and the key to the method is the information obtainable from $\chi=\infty$. Let us first lower by two units the order of the linearized equation (55), by "subtracting" the two global single valued solutions $u^{(1)}=\partial_{x_{0}} u^{(0)}$ and $\partial_{c} u^{(0)}$, i.e. $u^{(1)}=\chi^{-4}, \chi^{-3}$,

\begin{equation*}
u^{(1)}=\chi^{-4} v:\left[\partial_{x}^{2}-16 \chi^{-1} \partial_{x}+3 c \chi^{-3}-60 \chi^{-2}\right] v^{\prime \prime}=0 \tag{56}
\end{equation*}

Then the local study of $\chi=\infty$ is unnecessary, since one recognizes the Bessel equation. The two other solutions in global form are

c \neq 0: v_{1}^{\prime \prime} & =\chi^{-3}{ }_{0} F_{1}(24 ;-3 c / \chi)=\chi^{17 / 2} J_{23}(\sqrt{12 c / \chi})  \tag{57}\\
v_{2}^{\prime \prime} & =\chi^{17 / 2} N_{23}(\sqrt{12 c / \chi}) \tag{58}
\end{align*}
$$

where the hypergeometric function ${ }_{0} F_{1}(24 ;-3 c / \chi)$ is single valued and possesses an isolated essential singularity at $\chi=0$, while the fonction $N_{23}$ of Neumann is multivalued because of a $\log \chi$ term.

## 4 Singularity-based methods towards integrability

In this section, we review a variety of singularity-based methods able to provide some global elements of integrability. The singular manifold method of Weiss et al. 94] is the most important of them, but it is not the only one.

A prerequisite notion is the singular part operator $\mathcal{D}$,

$$
\begin{equation*}
\log \varphi \mapsto \mathcal{D} \log \varphi=u_{T}(0)-u_{T}(\infty) \tag{59}
\end{equation*}

in which the notation $u_{T}\left(\varphi_{0}\right)$, which emphasizes the dependence on $\varphi_{0}$, stands for the principal part of the Laurent series (16),

u_{T}\left(\varphi_{0}\right)=\sum_{j=0}^{-p} u_{j} \chi^{j+p} \tag{60}
\end{equation*}
$$

In our KPP example (25) with $\gamma=0$, this operator is $\mathcal{D}=d \partial_{x}$.

### 4.1 Linearizable equations

When a nonlinear equation can be linearized, the singular part operator defined in (59) directly defines the linearizing transformation.

For instance, the Kundu-Eckhaus PDE for the complex field $U(x, t)$ [59, 9]

i U_{t}+\alpha U_{x x}+\left(\frac{\beta^{2}}{\alpha}|U|^{4}+2 b e^{i \gamma}\left(|U|^{2}\right)_{x}\right) U=0, \quad(\alpha, \beta, b, \gamma) \in \mathcal{R} \tag{61}
\end{equation*}
$$

with $\alpha \beta b \cos \gamma \neq 0$, passes the test iff 13, 21 $b^{2}=\beta^{2}$. Under the parametric representation

U=\sqrt{u_{x}} e^{i \theta} \tag{62}
\end{equation*}
$$

the equivalent fourth order PDE for $u$ (21]

$$
\begin{align*}
& \frac{\alpha}{2}\left(u_{x x x x} u_{x}^{2}+u_{x x}^{3}-2 u_{x} u_{x x} u_{x x x}\right)+2 \frac{\beta^{2}-(b \sin \gamma)^{2}}{\alpha} u_{x}^{4} u_{x x} \\
& +2(b \cos \gamma) u_{x}^{3} u_{x x x}+\frac{1}{2 \alpha}\left(u_{t t} u_{x}^{2}+u_{x x} u_{t}^{2}-2 u_{t} u_{x} u_{x t}\right)=0 \tag{63}
\end{align*}
$$

admits two families, namely in the case $b^{2}=\beta^{2}$,

$$
\begin{align*}
u & \sim \frac{1}{2 \beta \cos \gamma} \log \psi, \text { indices }-1,0,1,2  \tag{64}\\
u & \sim \frac{3}{2 \beta \cos \gamma} \log \psi, \text { indices }-3,-1,0,2 \tag{65}
\end{align*}
$$

in which $(\log \psi)_{x}$ is the $\chi$ of the invariant Painlevé analysis. When the test is satisfied $\left(b^{2}=\beta^{2}\right)$, the linearizing transformation 59 is provided by 21] the singular part operator of the first family, which maps the nonlinear PDE
(61) to the linear Schrödinger equation for $V$ obtained by setting $b=\beta=0$ in (61),

\begin{align*}
& \text { Kundu-Eckhaus }(U) \Longleftrightarrow \operatorname{Schrödinger}(V), i V_{t}+\alpha V_{x x}=0  \tag{66}\\
& U=\sqrt{u_{x}} e^{i \theta}, V=\sqrt{\varphi_{x}} e^{i \theta}, u=\frac{\log \varphi}{2 \beta \cos \gamma} \tag{67}
\end{align*}
$$

### 4.2 Auto-Bäcklund transformation of a PDE: the singular manifold method

Widely known as the singular manifold method or truncation method because it selects the beginning of a Laurent series and discards ("truncates") the remaining infinite part, this method was introduced by Weiss et al. 94] and later improved in many directions [69, 41, 46] [70, 22, 82, 72]. Its most recent version can be found in the lecture notes of a CIME school 18, 68, to which we refer for further details.

The goal is to find the Bäcklund transformation or, if a BT does not exist, to generate some exact solutions. Since the BT is itself the result of an elimination 12] between the Lax pair and the Darboux involution, the task splits into the two simpler tasks of deriving these two elements. Let us take one example.

The modified Korteweg-de Vries equation (mKdV)

$$
\begin{equation*}
\operatorname{mKdV}(w) \equiv b w_{t}+\left(w_{x x}-2 w^{3} / \alpha^{2}\right)_{x}=0 \tag{68}
\end{equation*}
$$

is equivalently written in its potential form

$$
\begin{equation*}
\mathrm{p}-\mathrm{mKdV}(r) \equiv b r_{t}+r_{x x x}-2 r_{x}^{3} / \alpha^{2}+F(t)=0, w=r_{x} \tag{69}
\end{equation*}
$$

a feature which will shorten the expressions to come. This last PDE admits the two opposite families ( $\alpha$ is any square root of $\alpha^{2}$ )

$$
\begin{equation*}
p=0^{-}, q=-3, r \sim \alpha \log \psi, \text { indices }(-1,0,4), \mathcal{D}=\alpha \tag{70}
\end{equation*}
$$

and the results to be found are:

- the Darboux involution

$$
\begin{equation*}
r=\mathcal{D} \log Y+R \tag{71}
\end{equation*}
$$

a relation expressing the difference of two solutions $r$ and $R$ of p-mKdV as the logarithmic derivative $\mathcal{D} \log Y$, in which $\mathcal{D}=\alpha$ is the singular part operator of either family, and $Y$ is a Riccati pseudopotential equivalent to the Lax pair (see next item),

- the Lax pair, here written in its equivalent Riccati representation,

$$
\begin{align*}
& \frac{y_{x}}{y}=\lambda\left(\frac{1}{y}-y\right)-2 \frac{W}{\alpha}  \tag{72}\\
& b \frac{y_{t}}{y}=\frac{1}{y}\left(-4 \lambda \frac{W}{\alpha}+\left(2 \frac{W^{2}}{\alpha^{2}}+2 \frac{W_{x}}{\alpha}-4 \lambda^{2}\right) y\right)_{x} \tag{73}
\end{align*}
$$

in which $W$ satisfies the mKdV equation (68) and $\lambda$ is the spectral parameter,

- the BT, by some elimination between the above two items.

This program is achieved by defining the truncation 82,

r=\alpha \log Y+R \tag{74}
\end{equation*}
$$

in which $r$ satisfies p-mKdV, $R$ is a yet unconstrained field, $Y$ is the most general homographic transform of $\chi$ which vanishes as $\chi$ vanishes,

Y^{-1}=B\left(\chi^{-1}+A\right) \tag{75}
\end{equation*}
$$

$A$ and $B$ are two adjustable fields, and the gradient of $\chi$ is (22). The l.h.s. of the PDE is then

\mathrm{p}-\mathrm{mKdV}(r) \equiv \sum_{j=0}^{6} E_{j}(S, C, A, B, R) Y^{j-3} \tag{76}
\end{equation*}

and the system of determining equations to be solved is

\end{equation*}

This choice of $Y(75)$ is necessary to implement the two opposite families feature of mKdV . The general solution of the determining equations introduces an arbitrary complex constant $\lambda$ and a new field $W$ 82

W & =(R-\alpha \log B)_{x}, A=W / \alpha \\
b C & =2 W_{x} / \alpha-2 W^{2} / \alpha^{2}+4 \lambda^{2} \\
S & =2 W_{x} / \alpha-2 W^{2} / \alpha^{2}-2 \lambda^{2} \tag{78}
\end{align*}
$$

and the equivalence of the cross-derivative condition $\left(Y_{x}\right)_{t}=\left(Y_{t}\right)_{x}$ to the mKdV equation (68) for $W$ proves that one has obtained a Darboux involution and a Lax pair, with the correspondence $y=B Y$.

The auto-BT of mKdV is obtained by the elimination of $Y$, i.e. by the substitution

in the two equations (72)-(73) for the gradient of $y=B Y$.
The singular manifold equation, defined (94] as the constraint put on $\varphi$ for the truncation to exist, is obtained by the elimination of $W$ between $S$ and $C$,

b C-S-6 \lambda^{2}=0 \tag{80}
\end{equation*}
$$

and it is identical to that of the KdV equation.
Remark. The fact that, in the Laurent series (60), $u_{T}(0)$ (the "l.h.s. ") and $u_{T}(\infty)$ (the "constant level coefficient") are both solutions of the same PDE is not sufficient to define a BT, since any nonintegrable PDE also enjoys this feature. It is necessary to exhibit both the Darboux involution and a good Lax pair.

Most $1+1$-dimensional PDEs with the PP have been successfully processed by the singular manifold method, including the not so easy KaupKupershmidt 72 and Tzitzéica (28) equations.

The extension to $2+1$-dimensional PDEs with the PP has also been investigated (Ref. 40] and references therein).

### 4.3 Singlevalued solutions of the Bianchi IX cosmological model

Sometimes, the no-log conditions generated by the test provide some global information, which can then be used to integrate.

The Bianchi IX cosmological model is a 6-dim system of three second order ODEs

(\log A)^{\prime \prime}=A^{2}-(B-C)^{2} \text { and cyclically, }{ }^{\prime}=\mathrm{d} / \mathrm{d} \tau \tag{81}
\end{equation*}
$$

or equivalently

\left(\log \omega_{1}\right)^{\prime \prime}=\omega_{2}^{2}+\omega_{3}^{2}-\omega_{2}^{2} \omega_{3}^{2} / \omega_{1}^{2}, A=\omega_{2} \omega_{3} / \omega_{1}, \omega_{1}^{2}=B C \text { and cyclically. } \tag{82}
\end{equation*}
$$

One of the families 29, 61]

$$
\begin{align*}
& A=\chi^{-1}+a_{2} \chi+O\left(\chi^{3}\right), \chi=\tau-\tau_{2} \\
& B=\chi^{-1}+b_{2} \chi+O\left(\chi^{3}\right)  \tag{83}\\
& C=\chi^{-1}+c_{2} \chi+O\left(\chi^{3}\right)
\end{align*}
$$

has the Fuchs indices $-1,-1,-1,2,2,2$, and the Gambier test detects no logarithms at the triple index 2. The Fuchsian perturbative method

$$
\begin{equation*}
A=\chi^{-1} \sum_{n=0}^{N} \varepsilon^{n} \sum_{j=-n}^{2+N-n} a_{j}^{(n)} \chi^{j}, \chi=\tau-\tau_{2}, \quad \text { and cyclically } \tag{84}
\end{equation*}
$$

then detects movable logarithms at $(n, j)=(3,-1)$ and $(5,-1)$ 61, and the enforcement of these no-log conditions generates the three solutions :

$$
\begin{align*}
& \left(b_{2}^{(0)}=c_{2}^{(0)} \text { and } b_{-1}^{(1)}=c_{-1}^{(1)}\right) \text { or cyclically, }  \tag{85}\\
& a_{2}^{(0)}=b_{2}^{(0)}=c_{2}^{(0)}=0,  \tag{86}\\
& a_{-1}^{(1)}=b_{-1}^{(1)}=c_{-1}^{(1)} . \tag{87}
\end{align*}
$$

These are constraints which reduce the number of arbitrary coefficients to, respectively, four, three and four, thus defining particular solutions which may have no movable critical points.

The first constraint (85) implies the equality of two of the components $(A, B, C)$, and thus defines the 4 -dim subsystem $B=C$ [90], whose general solution is single valued,

\end{equation*}
$$

The second constraint (86) amounts to suppress the triple Fuchs index 2, thus defining a 3 -dim subsystem with a triple Fuchs index -1 . One can indeed check that the perturbed Laurent series (84) is identical to that of the Darboux-Halphen system 37, 52]

$$
\begin{equation*}
\omega_{1}^{\prime}=\omega_{2} \omega_{3}-\omega_{1} \omega_{2}-\omega_{1} \omega_{3}, \quad \text { and cyclically }, \tag{89}
\end{equation*}
$$

whose general solution is single valued.
The third and last constraint 87) amounts to suppress two of the three Fuchs indices -1 , thus defining a 4 -dim subsystem whose explicit writing is yet unknown. With the additional constraint

$$
\begin{equation*}
a_{2}^{(0)}+b_{2}^{(0)}+c_{2}^{(0)}=0 \tag{90}
\end{equation*}
$$

the Laurent series (83) is identical to that of the 3-dim Euler system (1750) [4], describing the motion of a rigid body around its center of mass

$$
\begin{equation*}
\omega_{1}^{\prime}=\omega_{2} \omega_{3}, \text { and cyclically } \tag{91}
\end{equation*}
$$

whose general solution is elliptic (4]

$$
\begin{align*}
& \omega_{j}=\left(\log \left(\wp\left(\tau-\tau_{0}, g_{2}, g_{3}\right)-e_{j}\right)\right)^{\prime}, j=1,2,3,\left(\tau_{0}, g_{2}, g_{3}\right) \text { arbitrary },  \tag{92}\\
& \wp^{\prime 2}=4\left(\wp-e_{1}\right)\left(\wp-e_{2}\right)\left(\wp-e_{3}\right)=4 \wp^{3}-g_{2} \wp-g_{3} . \tag{93}
\end{align*}
$$

The 4-dim subsystem (the one without (90)) defines an extrapolation to four parameters of this elliptic solution, quite probably single valued, whose closed form is still unknown.

One thus retrieves by the analysis all the results of the geometric assumption of self-duality 48, even slightly more.

### 4.4 Polynomial first integrals of a dynamical system

A first integral of an ODE is by definition a function of $x, u(x), u^{\prime}(x), \ldots$ which takes a constant value at any $x$, including the movable singularities of $u$. Consider for instance the Lorenz model

$$
\begin{equation*}
\frac{\mathrm{d} x}{\mathrm{~d} t}=\sigma(y-x), \frac{\mathrm{d} y}{\mathrm{~d} t}=r x-y-x z, \frac{\mathrm{~d} z}{\mathrm{~d} t}=x y-b z(x-y) \tag{94}
\end{equation*}
$$

First integrals in the class $P(x, y, z) e^{\lambda t}$, with $P$ polynomial and $\lambda$ constant, should not be searched for with the assumption $P$ the most general polynomial in three variables. Indeed, $P$ must have no movable singularities. The movable singularities of $(x, y, z)$ are

$$
\begin{equation*}
x \sim 2 i \chi^{-1}, y \sim-2 i \sigma^{-1} \chi^{-2}, z \sim-2 \sigma \chi^{-2}, \text { indices }(-1,2,4) \tag{95}
\end{equation*}
$$

therefore the generating function of admissible polynomials $P$ is built from the singularity degrees of $(x, y, z)$ (62]

$$
\begin{align*}
\frac{1}{(1-\alpha x)\left(1-\alpha^{2} y\right)\left(1-\alpha^{2} z\right)} & =1+\alpha x+\alpha^{2}\left(x^{2}+y+z\right)+\alpha^{3}\left(x^{3}+x y+x z\right) \\
& +\alpha^{4}\left(x^{4}+x^{2} y+x^{2} z+y z+z^{2}+y^{2}\right)+\ldots \tag{96}
\end{align*}
$$

defining the basis, ordered by singularity degrees,

$$
\begin{equation*}
(1),(x),\left(x^{2}, y, z\right),\left(x^{3}, x y, x z\right),\left(x^{4}, x^{2} y, x^{2} z, y z, z^{2}, y^{2}\right), \ldots \tag{97}
\end{equation*}
$$

The candidate of lowest degree is a linear combination of $\left(x^{2}, y, z\right)$, which indeed provides a first integral 88

$$
\begin{equation*}
K_{1}=\left(x^{2}-2 \sigma z\right) e^{2 \sigma t}, b=2 \sigma \tag{98}
\end{equation*}
$$

Six polynomial first integrals are known [60 with a singularity degree at most equal to four, and these are the only ones 63].

### 4.5 Solitary waves from truncations

If the PDE is nonintegrable or if one only wants to find particular solutions, the singular manifold method of Section 4.2 still applies, it simply produces less results. For autonomous partially integrable PDEs, the typical output is a set of constant values for the unknowns $S, C, A, B, R$ in the determining equations (77). In such a case, quite generic for nonintegrable equations, the integration of the Riccati system (22) yields the value

$$
\begin{equation*}
\chi^{-1}=\frac{k}{2} \tanh \frac{k}{2}\left(\xi-\xi_{0}\right), \xi=x-c t, k^{2}=-2 S, c=C \tag{99}
\end{equation*}
$$

the singular part operator $\mathcal{D}$ has constant coefficients, therefore the solutions $r$ in (71) are solitary waves $r=f(\xi)$, in which $f$ is a polynomial in sech $k \xi$ and $\tanh k \xi$. This follows immediately from the two elementary identities 20

$$
\begin{equation*}
\tanh z-\frac{1}{\tanh z}=-2 i \operatorname{sech}\left[2 z+i \frac{\pi}{2}\right], \tanh z+\frac{1}{\tanh z}=2 \tanh \left[2 z+i \frac{\pi}{2}\right] \tag{100}
\end{equation*}
$$

In the simpler case of a one-family PDE, the (degenerate) Darboux involution is

$$
\begin{equation*}
u=\mathcal{D} \log \psi+U, \partial_{x} \log \psi=\chi^{-1} \tag{101}
\end{equation*}
$$

and the above class of solitary waves $r=f(\xi)$ reduces to the class of polynomials in $\tanh (k / 2) \xi$. In the example of the chaotic Kuramoto-Sivashinsky (KS) equation

$$
\begin{equation*}
u_{t}+u u_{x}+\mu u_{x x}+b u_{x x x}+\nu u_{x x x x}=0, \nu \neq 0 \tag{102}
\end{equation*}
$$

one finds 57

$$
\begin{align*}
\mathcal{D} & =60 \nu \partial_{x}^{3}+15 b \partial_{x}^{2}+\frac{15\left(16 \mu \nu-b^{2}\right)}{76 \nu} \partial_{x}  \tag{103}\\
u & =\mathcal{D} \log \cosh \frac{k}{2}\left(\xi-\xi_{0}\right)+c,\left(c, \xi_{0}\right) \text { arbitrary } \tag{104}
\end{align*}
$$

in which $b^{2} /(\mu \nu)$ only takes the values $0,144 / 47,256 / 73,16$, and $k$ is not arbitrary. In the quite simple writing (104), much more elegant than a third
degree polynomial in tanh, the only nonlinear item is the logarithm, $\mathcal{D}$ being linear and cosh solution of a linear system. This displays the enormous advantage to take into account the singularity structure when searching for such solitary waves.

See e.g. Ref. 25] for a recent application to coupled Ginzburg-Landau equations.

### 4.6 First degree birational transformations of Painlevé equations

At first glance, it seems that the truncation procedure described in section 4.2 should be even easier when the PDE reduces to an ODE. This is not the case, because, in addition to the Riccati variable $\chi$ or $Y$ of the truncation, there exists a second natural Riccati variable and therefore a homographic dependence between the two Riccati variables, which must be taken into account under penalty of failure of the truncation.

Indeed, any $N$ th order, first degree ODE with the Painlevé property is necessarily 79, pp. 396-409] a Riccati equation for $U^{(N-1)}$, with coefficients depending on $x$ and the lower derivatives of $U$, e.g. in the case of P6,

$$
\begin{equation*}
U^{\prime \prime}=A_{2}(U, x) U^{\prime 2}+A_{1}(U, x) U^{\prime}+A_{0}(U, x, A, B, \Gamma, \Delta) \tag{105}
\end{equation*}
$$

Then the Riccati variable of the truncation (denote it $Z$ ) is linked to $U^{\prime}$ by some homography,

$$
\begin{equation*}
\left(U^{\prime}+g_{2}\right)\left(Z^{-1}-g_{1}\right)-g_{0}=0, g_{0} \neq 0 \tag{106}
\end{equation*}
$$

in which $g_{0}, g_{1}, g_{2}$ are functions of $(U, x)$ to be found. Implementing this dependence in the truncation 27] provides a unique solution for P6, which is the unique first degree birational transformation, first found by Okamoto 77,

$$
\begin{align*}
\frac{N}{u-U} & =\frac{x(x-1) U^{\prime}}{U(U-1)(U-x)}+\frac{\Theta_{0}}{U}+\frac{\Theta_{1}}{U-1}+\frac{\Theta_{x}-1}{U-x}  \tag{107}\\
& =\frac{x(x-1) u^{\prime}}{u(u-1)(u-x)}+\frac{\theta_{0}}{u}+\frac{\theta_{1}}{u-1}+\frac{\theta_{x}-1}{u-x}  \tag{108}\\
\forall j=\infty, 0,1, x & :\left(\theta_{j}^{2}+\Theta_{j}^{2}-(N / 2)^{2}\right)^{2}-\left(2 \theta_{j} \Theta_{j}\right)^{2}=0  \tag{109}\\
N & =\sum\left(\theta_{k}^{2}-\Theta_{k}^{2}\right) \tag{110}
\end{align*}
$$

with the classical definition for the monodromy exponents,

$$
\begin{align*}
& \theta_{\infty}^{2}=2 \alpha, \theta_{0}^{2}=-2 \beta, \theta_{1}^{2}=2 \gamma, \theta_{x}^{2}=1-2 \delta  \tag{111}\\
& \Theta_{\infty}^{2}=2 A, \Theta_{0}^{2}=-2 B, \Theta_{1}^{2}=2 \Gamma, \Theta_{x}^{2}=1-2 \Delta \tag{112}
\end{align*}
$$

The equivalent affine representation of (109)-(110) is

$$
\begin{align*}
\theta_{j} & =\Theta_{j}-\frac{1}{2}\left(\sum \Theta_{k}\right)+\frac{1}{2}, \Theta_{j}=\theta_{j}-\frac{1}{2}\left(\sum \theta_{k}\right)+\frac{1}{2}  \tag{113}\\
N & =1-\sum \Theta_{k}=-1+\sum \theta_{k}=2\left(\theta_{j}-\Theta_{j}\right), j=\infty, 0,1, x \tag{114}
\end{align*}
$$

in which $j, k=\infty, 0,1, x$.
The well known confluence from P 6 down to P 2 then allows us to recover [26] all the first degree birational transformations of the five Painlevé equations ( P 1 admits no such transformation because it depends on no parameter), thus providing a unified picture of these transformations.

## 5 Liouville integrability and Painlevé integrability

A Hamiltonian system with $N$ degrees of freedom is said Liouville-integrable if it possesses $N$ functionally independent invariants in involution. In general, there is no correlation between Liouville-integrability and the Painlevé property, as seen on the two examples with $N=1$

$$
\begin{align*}
& H(q, p, t)=\frac{p^{2}}{2}-2 q^{3}-t q  \tag{115}\\
& H(q, p, t)=\frac{p^{2}}{2}+q^{5} \tag{116}
\end{align*}
$$

in which the first system is Painlevé-integrable and not Liouville-integrable, and vice versa for the second system. However, given a Liouville-integrable Hamiltonian system, which in addition passes the Painlevé test, one must try to prove its Painlevé integrability by explicitly integrating.

Such an example is the cubic Hénon-Heiles system

$$
\begin{align*}
H \equiv & \frac{1}{2}\left(p_{1}^{2}+p_{2}^{2}+c_{1} q_{1}^{2}+c_{2} q_{2}^{2}\right)+\alpha q_{1} q_{2}^{2}-\frac{1}{3} \beta q_{1}^{3}+\frac{1}{2} c_{3} q_{2}^{-2}, \alpha \neq 0  \tag{117}\\
& q_{1}^{\prime \prime}+c_{1} q_{1}-\beta q_{1}^{2}+\alpha q_{2}^{2}=0  \tag{118}\\
& q_{2}^{\prime \prime}+c_{2} q_{2}+2 \alpha q_{1} q_{2}-c_{3} q_{2}^{-3}=0 \tag{119}
\end{align*}
$$

which passes the Painlevé test in three cases only,

$$
\begin{align*}
(\mathrm{SK}): & \beta / \alpha=-1, c_{1}=c_{2}  \tag{120}\\
(\mathrm{~K} 5): & \beta / \alpha=-6  \tag{121}\\
(\mathrm{KK}): & \beta / \alpha=-16, c_{1}=16 c_{2} . \tag{122}
\end{align*}
$$

In these three cases, the general solution $q_{1}$ (hence $q_{2}^{2}$ ) is indeed singlevalued and expressed with genus two hyperelliptic functions. This was proven by Drach in 1919 for the second case, associated to $\mathrm{KdV}_{5}$, and only recently 93] in the two other cases. This proof completes the result of Ref. [84], who found the separating variables (a global object) by just considering the Laurent series (a local object), following a powerful method due to van Moerbeke and Vanhaecke 92].

## 6 Discretization and discrete Painlevé equations

This quite important subject (the integrability of difference equations) is reviewed elsewhere in this volume [89, so we will just write a few lines about it, for completeness.

Let us consider the difference equations or $q$-difference equations (we skip for shortness the elliptic stepsize 86),

$$
\begin{align*}
& \forall x \forall h: E\left(x, h,\left\{u(x+k h), k-k_{0}=0, \ldots, N\right\}\right)=0,  \tag{123}\\
& \forall x \forall q: E\left(x, q,\left\{u\left(x q^{k}\right), k-k_{0}=0, \ldots, N\right\}\right)=0, \tag{124}
\end{align*}
$$

algebraic in the values of the field variable, with coefficients analytic in $x$ and the stepsize $h$ or $q$. As compared to the continuous case, the main missing item is an undisputed definition for the discrete Painlevé property. The currently proposed definitions are

1. 23] There exists a neighborhood of $h=0$ (resp. $q=1$ ) at every point of which the general solution $x \rightarrow u(x, h)$ (resp. $x \rightarrow u(x, q)$ ) has no movable critical singularities.
2. [1] The Nevanlinna order of growth of the solutions at infinity is finite.
but none is satisfactory. Indeed, the first one says nothing about discrete equations without continuum limit, and the second one excludes the continuous P6 equation.

Despite the lack of consensus on this definition, a discrete Painlevé test has been developed to generate necessary conditions for the above properties. Of exceptional importance at this point is the singularity confinement method [51], which tests with great efficiency a property not yet rigorously defined, but which for sure will be an important part of the good definition of the discrete Painlevé property. The approach developed by Ruijsenaars [85 for linear discrete equations, namely to require as much analyticity as possible, should be interesting to transpose to nonlinear discrete equations.

Just for consistency, an interesting development would be to display a discrete version of (13) escaping all the methods of the discrete test.

Let us say a word on the discrete analogue of the Painlevé and Gambier classification. These second order first degree continuous equations all have a precise form $\left(u^{\prime \prime}\right.$ is a second degree polynomial in $u^{\prime}$, the coefficient of $u^{\prime 2}$ is the sum of at most four simple poles in $u$, etc), directly inherited from the property of the elliptic equations isolated by Briot and Bouquet. In the discrete counterpart, the main feature is the existence of an addition formula for the elliptic function $\wp$ of Weierstrass. As remarked earlier by Baxter and Potts (see references in [24]), this formula defines an exact discretization of (6). Then, all the autonomous discrete second order first degree equations with the (undefined!) discrete PP have a precise form resulting from the most general discrete differentiation of the addition formula, and the nonautonomous ones simply inherit variable coefficients as in the continuous case. Of course, the
second order higher degree (mostly multi-component) equations are much richer, see details in the review 50].

Another open question concerns the continuum limit of the contiguity relation of the ODEs which admit such a relation. The contiguity relation of the (linear) hypergeometric equation has a continuum limit which is not the hypergeometric equation, but a confluent one. On the contrary, the contiguity relation of the (linearizable) Ermakov equation has a continuum limit which is again an Ermakov equation 53]. One could argue that the latter depends on a function, and the former only on a finite number of constants. Nevertheless, this could leave the hope to upgrade from P5 to P6 the highest continuum limit for the contiguity relation of $\mathrm{P} 6[78,75,26]$.

## 7 Conclusion

The allowed space forced us to skip quite interesting developments, such as the relation with differential geometry [5], or the way to obtain the nonlinear superposition formula from singularities [73], or the weak Painlevé property 79, Leçons 5-10,13,19] 83, 49.

For applications to nonintegrable equations, not covered in this Special issue, the reader can refer to tutorial presentations such that 18,67 .
