# THE CKP HIERARCHY AND THE WDVV PREPOTENTIAL

## 1. The WDVV prepotential

In terms of the so-called flat coordinates $x^{1}, x^{2}, \ldots, x^{n}$ a solution to the Witten-Dijkgraaf-Verlinde-Verlinde (WDVV) equations [13], [6] is given by a prepotential $F\left(x^{1}, x^{2}, \ldots, x^{n}\right)$ which satisfies the associativity relations:

$$
\begin{equation*}
\sum_{\delta, \gamma=1}^{n} \frac{\partial^{3} F(x)}{\partial x^{\alpha} \partial x^{\beta} \partial x^{\gamma}} \eta^{\delta \gamma} \frac{\partial^{3} F(x)}{\partial x^{\gamma} \partial x^{\omega} \partial x^{\rho}}=\sum_{\delta, \gamma=1}^{n} \frac{\partial^{3} F(x)}{\partial x^{\alpha} \partial x^{\omega} \partial x^{\delta}} \eta^{\delta \gamma} \frac{\partial^{3} F(x)}{\partial x^{\gamma} \partial x^{\beta} \partial x^{\rho}} \tag{1}
\end{equation*}
$$

together with a quasi-homogeneity condition :

$$
\begin{equation*}
\sum_{\alpha=1}^{n}\left(1+\mu_{1}-\mu_{\alpha}\right) x^{\alpha} \frac{\partial F}{\partial x^{\alpha}}=(3-d) F+\text { quadratic terms } . \tag{2}
\end{equation*}
$$

where $\mu_{i}, i=1, \ldots, n$ and $d$ are constants .
Furthermore, expression

$$
\begin{equation*}
\frac{\partial^{3} F(x)}{\partial x^{\alpha} \partial x^{\beta} \partial x^{1}}=\eta_{\alpha \beta} \tag{3}
\end{equation*}
$$

defines a constant non-degenerate metric: $g=\sum_{\alpha, \beta=1}^{n} \eta_{\alpha \beta} d x^{\alpha} d x^{\beta}$.
As shown by Dubrovin (e.g. in reference [8]) there is an alternative description of the metric in terms of a special class of orthogonal curvilinear coordinates $u_{1}, \ldots, u_{n}$

$$
\begin{equation*}
g=\sum_{\alpha \beta=1}^{n} \eta_{\alpha \beta} d x^{\alpha} d x^{\beta}=\sum_{i=1}^{n} h_{i}^{2}(u)\left(d u_{i}\right)^{2} \tag{4}
\end{equation*}
$$

called canonical coordinates. These coordinates allow to reformulate the problem in terms of the Darboux-Egoroff metric systems and corresponding Darboux-Egoroff equations and their solutions. In the Darboux-Egoroff metric the Lamé coefficients $h_{i}^{2}(u)$ are gradients of some potential and this ensures that the so-called "rotation coefficients"

$$
\begin{equation*}
\beta_{i j}=\frac{1}{h_{j}} \frac{\partial h_{i}}{\partial u_{j}}, \quad i \neq j, \quad 1 \leq i, j \leq n, \tag{5}
\end{equation*}
$$

are symmetric $\beta_{i j}=\beta_{j i}$. The Darboux-Egoroff equations for the rotation coefficients are:

$$
\begin{gather*}
\frac{\partial}{\partial u_{k}} \beta_{i j}=\beta_{i k} \beta_{k j}, \quad \text { distinct } i, j, k  \tag{6}\\
\sum_{k=1}^{n} \frac{\partial}{\partial u_{k}} \beta_{i j}=0, \quad i \neq j \tag{7}
\end{gather*}
$$

In addition to these equations one also assumes the conformal condition :

$$
\begin{equation*}
\sum_{k=1}^{n} u_{k} \frac{\partial}{\partial u_{k}} \beta_{i j}=-\beta_{i j} \tag{8}
\end{equation*}
$$

The Darboux-Egoroff equations (6)-(7) appear as compatibility equations of a linear system :

$$
\begin{align*}
\frac{\partial \Phi_{i j}(u, z)}{\partial u_{k}} & =\beta_{i k}(u) \Phi_{k j}(u, z) \quad i \neq k  \tag{9}\\
\sum_{k=1}^{n} \frac{\partial \Phi_{i j}(u, z)}{\partial u_{k}} & =z \Phi_{i j}(u, z) \tag{10}
\end{align*}
$$

Define the $n \times n$ matrices $\Phi=\left(\Phi_{i j}\right)_{1 \leq i, j \leq n}, B=\left(\beta_{i j}\right)_{1 \leq i, j \leq n}$ and $V_{i}=$ $\left[B, E_{i i}\right]$, where $\left(E_{i j}\right)_{k \ell}=\delta_{i k} \delta_{j \ell}$. Then the linear system (9)-(10) acquires the following form :

$$
\begin{align*}
\frac{\partial \Phi(u, z)}{\partial u_{i}} & =\left(z E_{i i}+V_{i}(u)\right) \Phi(u, z), \quad i=1, \ldots, n  \tag{11}\\
\sum_{k=1}^{n} \frac{\partial \Phi(u, z)}{\partial u_{k}} & =z \Phi(u, z) \tag{12}
\end{align*}
$$

Let, furthemore $\Phi(u, z)$ have a power series expansion

$$
\begin{equation*}
\Phi(u, z)=\sum_{j=0}^{\infty} z^{j} \Phi^{(j)}(u)=\Phi^{(0)}(u)+z \Phi^{(1)}(u)+z^{2} \Phi^{(2)}(u)+\cdots \tag{13}
\end{equation*}
$$

and satisfy the "twisting" condition ;

$$
\begin{equation*}
\Phi(u, z) \eta^{-1} \Phi^{T}(u,-z)=I \tag{14}
\end{equation*}
$$

Equation (11) implies $\sum_{k=1}^{n} u_{k} \partial \Phi(u, z) / \partial u_{k}=(z U+[B, U]) \Phi(u, z)$, with $U=\sum_{k=1}^{n} u_{k} E_{k k}$. For a matrix $[B, U]$ which is diagonalizable the conformal condition (8) leads to

$$
\begin{equation*}
\sum_{k=1}^{n} u_{k} \frac{\partial \Phi(u, z)}{\partial u_{k}}=z \frac{\partial \Phi(u, z)}{\partial z}+\Phi(u, z) \mu, \quad \mu=\operatorname{diag}\left(\mu_{1}, \ldots, \mu_{n}\right) \tag{15}
\end{equation*}
$$

where $\mu$ is a constant diagonal matrix obtained by a similarity transformation from the matrix $[B, U]$. The constant diagonal elements $\mu_{i}$ entered the quasi-homogeneity condition (2).

Define
$\phi_{\alpha}(u, z) \equiv \sum_{\beta=1}^{n} \Phi_{\beta 1}^{(0)}(u) \Phi_{\beta \alpha}(u, z)=\phi_{\alpha}^{(0)}(u)+z \phi_{\alpha}^{(1)}(u)+z^{2} \phi_{\alpha}^{(2)}(u)+z^{3} \phi_{\alpha}^{(3)}(u)+\ldots$
then, in terms of the flat coordinates $x^{1}, \ldots, x^{n}$

$$
\begin{equation*}
\phi_{\alpha}^{(1)}(u)=\sum_{\beta=1}^{n} \eta_{\alpha \beta} x^{\beta}(u) \tag{17}
\end{equation*}
$$

and the prepotential is given by a closed expression (see e.g. [1] or [2]):

$$
\begin{equation*}
F=-\frac{1}{2} \phi_{1}^{(3)}(u)+\frac{1}{2} \sum_{\delta=1}^{n} x^{\delta}(u) \phi_{\delta}^{(2)}(u) \tag{18}
\end{equation*}
$$

## 2. The CKP hierarchy

The CKP hierarchy [5] can be obtained as a reduction of the KP hierarchy,

$$
\begin{equation*}
\frac{\partial}{\partial t_{n}} L=\left[\left(L^{n}\right)_{+}, L\right], \quad \text { for } L=L(t, \partial)=\partial_{x}+\ell^{(-1)} \partial_{x}^{-1}+\ell^{(-2)} \partial_{x}^{-2}+\cdots, \tag{19}
\end{equation*}
$$

where $x=t_{1}$, by assuming the extra condition

$$
\begin{equation*}
L^{*}=-L \tag{20}
\end{equation*}
$$

By taking the adjoint, i.e., * of (19), one sees that $\frac{\partial L}{\partial t_{n}}=0$ for $n$ even. Date, Jimbo, Kashiwara and Miwa [5], [9] construct such L's from certain special KP wave functions $\psi(t, z)=P(t, z) e^{\sum_{i} t_{i} z^{i}}($ recall $L(t, \partial)=$ $\left.P(t, \partial) \partial P(t, \partial)^{-1}\right)$, where one then puts all even times $t_{n}$ equal to 0 . Recall that a KP wave function satisfies

$$
\begin{equation*}
L \psi(t, z)=z \psi(t, z), \quad \frac{\partial \psi(t, z)}{\partial t_{n}}=\left(L^{n}\right)_{+} \psi(t, z) \tag{21}
\end{equation*}
$$

and

$$
\begin{equation*}
\operatorname{Res} \psi(t, z) \psi^{*}(s, z)=0 \tag{22}
\end{equation*}
$$

The special wave functions which lead to an $L$ that satisfies (20) satisfy

$$
\begin{equation*}
\psi^{*}(t, z)=\psi(\tilde{t},-z), \quad \text { where } \quad \tilde{t}_{i}=(-)^{i+1} t_{i} . \tag{23}
\end{equation*}
$$

We call such a $\psi$ a CKP wave function. Note that this implies that $L(t, \partial)^{*}=$ $-L(\tilde{t}, \partial)$ and that

$$
\operatorname{Res} \psi(t, z) \psi(\tilde{s},-z)=0
$$

One can put all even times equal to 0 , but we will not do that here.
The CKP wave functions correspond to very special points in the Sato Grassmannian, which consists of all linear spaces

$$
W \subset H_{+} \oplus H_{-}=\mathbb{C}[z] \oplus z^{-1} \mathbb{C}\left[\left[z^{-1}\right]\right],
$$

such that the projection on $H_{+}$has finite index. Namely, $W$ corresponds to a CKP wave function if for any $f(z), g(z) \in W$ one has Res $f(z) g(-z)=0$. The corresponding CKP tau functions satisfy $\tau(\tilde{t})=\tau(t)$.

We will now generalize this to the multi-component case and show that a CKP reduction of the multi-component KP hierarchy gives the DarbouxEgoroff system. The $n$ component KP hierarchy [4], [10] consists of the equations in $t_{j}^{(i)}, 1 \leq i \leq n, j=1,2, \ldots$

$$
\begin{equation*}
\frac{\partial}{\partial t_{j}^{(i)}} L=\left[\left(L^{j} C_{i}\right)_{+}, L\right], \quad \frac{\partial}{\partial t_{j}^{(i)}} C_{k}=\left[\left(L^{j} C_{i}\right)_{+}, C_{k}\right] \tag{24}
\end{equation*}
$$

for the $n \times n$-matrix pseudo-differential operators
$L=\partial_{x}+L^{(-1)} \partial_{x}{ }^{-1}+L^{(-2)} \partial_{x}{ }^{-2}+\cdots, \quad C_{i}=E_{i i}+C_{i}^{(-1)} \partial_{x}{ }^{-1}+C_{i}^{(-2)} \partial_{x}{ }^{-2}+\cdots$,
$1 \leq i \leq n$, where $x=t_{1}^{(1)}+t_{1}^{(2)}+\cdots+t_{1}^{(n)}$. The corresponding wave function has the form
$\Psi(t, z)=P(t, z) \exp \left(\sum_{i=1}^{n} \sum_{j=1}^{\infty} t_{j}^{(i)} z^{j} E_{i i}\right), \quad$ where $P(t, z)=I+P^{(-1)}(t) z^{-1}+\cdots$,
and satisfies
$L \Psi(t, z)=z \Psi(t, z), \quad C_{i} \Psi(t, z)=\Psi(t, z) E_{i i}, \quad \frac{\partial \Psi(t, z)}{\partial t_{j}^{(i)}}=\left(L^{j} C_{i}\right)_{+} \Psi(t, z)$
and

$$
\begin{equation*}
\operatorname{Res} \Psi(t, z) \Psi^{*}(s, z)^{T}=0 . \tag{26}
\end{equation*}
$$

From this we deduce that $L=P\left(t, \partial_{x}\right) \partial_{x} P\left(t, \partial_{x}\right)^{-1}$ and $C_{i}=P\left(t, \partial_{x}\right) E_{i i} P\left(t, \partial_{x}\right)^{-1}$. Using this, the simplest equations in (26) are

$$
\begin{equation*}
\frac{\partial \Psi(t, z)}{\partial t_{1}^{(i)}}=\left(z E_{i i}+V_{i}(t)\right) \Psi(t, z), \tag{27}
\end{equation*}
$$

where $V_{i}(t)=\left[B(t), E_{i i}\right]$ with $B(t)=P^{(-1)}(t)$. In terms of the matrix coefficients $\beta_{i j}$ of $B$ we obtain (6) for $u_{i}=t_{1}^{(i)}$.

The Sato Grassmannian becomes vector valued, i.e.,

$$
H_{+} \oplus H_{-}=(\mathbb{C}[z])^{n} \oplus z^{-1}\left(\mathbb{C}\left[\left[z^{-1}\right]\right]\right)^{n}
$$

The same restriction as in the 1-component case (23), viz.,

$$
\Psi(t, z)=\Psi^{*}(\tilde{t},-z), \quad \text { where } \quad \tilde{t}_{n}^{(i)}=(-)^{n+1} t_{n}^{(i)} .
$$

leads to $L^{*}(\tilde{t})=-L(t), C_{i}^{*}(\tilde{t})=C_{i}(t)$ and

$$
\begin{equation*}
\operatorname{Res} \Psi(t, z) \Psi(\tilde{s},-z)^{T}=0, \tag{28}
\end{equation*}
$$

which we call the multi-component CKP hierarchy. But more importantly, it also gives the restriction

$$
\begin{equation*}
\beta_{i j}(t)=\beta_{j i}(\tilde{t}) . \tag{29}
\end{equation*}
$$

Such CKP wave functions correspond to points $W$ in the Grassmannian for which

$$
\operatorname{Res} f(z)^{T} g(-z)=\operatorname{Res} \sum_{i=1}^{n} f_{i}(z) g_{i}(-z)=0
$$

for any $f(z)=\left(f_{1}(z), f_{2}(z), \ldots, f_{n}(z)\right)^{T}, g(z)=\left(g_{1}(z), g_{2}(z), \ldots, g_{n}(z)\right)^{T} \in$ $W$.

If we finally assume that $L=\partial_{x}$, then $\Psi, W$ also satisfy

$$
\begin{equation*}
\frac{\partial \Psi(t, z)}{\partial x}=\sum_{i=1}^{n} \frac{\partial \Psi(t, z)}{\partial t_{1}^{(i)}}=z \Psi(t, z), \quad z W \subset W \tag{30}
\end{equation*}
$$

and thus $\beta_{i j}$ satisfies (7) for $u_{i}=t_{1}^{(i)}$. Now differentiating (28) $n$ times to $x$ for $n=0,1,2, \ldots$ and applying (30) leads to

$$
\Psi(t, z) \Psi(\tilde{t},-z)^{T}=I
$$

These special points in the Grassmannian can all be constructed as follows [11]. Let $G(z)$ be an element in $G L_{n}\left(\mathbb{C}\left[z, z^{-1}\right]\right)$ that satisfies

$$
\begin{equation*}
G(z) G(-z)^{T}=1 \tag{31}
\end{equation*}
$$

then $W=G(z) H_{+}$. Clearly, any two $f(z), g(z) \in W$ can be written as $f(z)=G(z) a(z), g(z)=G(z) b(z)$ with $a(z), b(z) \in H_{+}$, then $z f(z)=$ $z G(z) a(z)=G(z) z a(z) \in W$, since $z a(z) \in H_{+}$. Moreover,

$$
\operatorname{Res} f(z)^{T} g(-z)=\operatorname{Res} a(z)^{T} G(z)^{T} G(-z) b(-z)=\operatorname{Res} a(z)^{T} b(-z)=0 .
$$

If we define $M(t, z)=\Psi(t, z) G(z)$, then one can prove [3], [11] that

$$
M(t, z)=M^{(0)}(t)+M^{(1)}(t) z+M^{(2)}(t) z^{2}+\cdots
$$

We want to change $M(t, z)$ a bit more. However, we only want to do that for very special elements in this twisted loop group, i.e., to certain points of the Grassmannian that have a basis of homogeneous elements in $z$. Let $n=2 m$ or $n=2 m+1$, choose non-negative integers $\mu_{i}$ for $1 \leq i \leq m$ and define $\mu_{n+1-j}=-\mu_{j}$ and let $\mu_{m+1}=0$ if $n$ is odd. Then take $G(z)$ of the form

$$
G(z)=N(z) S^{-1}=N z^{-\mu} S^{-1}, \quad \text { where } \quad \mu=\operatorname{diag}\left(\mu_{1}, \mu_{2}, \ldots, \mu_{n}\right)
$$

and $N=\left(n_{i j}\right)_{1 \leq i, j \leq n}$ a constant matrix that satisfies

$$
\begin{equation*}
N^{T} N=\sum_{j=1}^{n}(-1)^{\mu_{j}} E_{j, n+1-j} \tag{32}
\end{equation*}
$$

and
$S=\delta_{n, 2 m+1} E_{m+1, m+1}+\sum_{j=1}^{m} \frac{1}{\sqrt{2}}\left(E_{j j}+i E_{n+1-j, j}+E_{j, n+1-j}-i E_{n+1-j, n+1-j}\right)$.

Then [3]

$$
\sum_{i=1}^{n} \sum_{j=1}^{\infty} j t_{j}^{(i)} \frac{\partial \Psi(t, z)}{\partial t_{j}^{(i)}}=z \frac{\partial \Psi(t, z)}{\partial z}
$$

from which one deduces that

$$
\begin{equation*}
\sum_{i=1}^{n} \sum_{j=1}^{\infty} j t_{j}^{(i)} \frac{\partial \beta_{i j}}{\partial t_{j}^{(i)}}=-\beta_{i j} . \tag{33}
\end{equation*}
$$

Define $\eta=\left(\eta_{i j}\right)_{1 \leq i, j \leq n}=S^{T} S=\sum_{i=1}^{n} E_{i, n+1-i}$ and denote by $\Phi(t, z)=$ $M(t, z) S=\Psi(t, z) G(z) \bar{S}=\Psi(t, z) N(z)$, then $\Phi(t, z)$ satisfies the following relations:

$$
\begin{aligned}
\Phi(t, z) & =\Phi^{(0)}(t)+\Phi^{(1)}(t) z+\Phi^{(2)}(t) z^{2}+\cdots \\
\Phi(t, z) \eta^{-1} \Phi(t,-z)^{T} & =I \\
\frac{\partial \Phi(t, z)}{\partial t_{1}^{(i)}} & =\left(z E_{i i}+V_{i}(t)\right) \Phi(t, z) \\
\sum_{i=1}^{n} \frac{\partial \Phi(t, z)}{\partial t_{1}^{(i)}} & =z \Phi(t, z), \\
\sum_{i=1}^{n} \sum_{j=1}^{\infty} j t_{j}^{(i)} \frac{\partial \Phi(t, z)}{\partial t_{j}^{(i)}} & =z \frac{\partial \Phi(t, z)}{\partial z}+\Phi(t, z) \mu .
\end{aligned}
$$

We next put $t_{j}^{(i)}=0$ for all $i$ and all $j>1$ and $u_{i}=t_{1}^{(i)}$, then we obtain the situation of Section 1. Define $\phi_{\alpha}(u, z)$ as in (16), then $\phi_{\alpha}^{(1)}(u)=$ $\sum_{\gamma=1}^{n} \eta_{\alpha \gamma} x^{\gamma}(u)$ and the function $F(u)$ given by (18) satisfies the WDVV equations.

## 3. An example

We will now give an example of this construction, viz., the case that $n=3$ (for simplicity) and $\mu_{1}=-\mu_{3}=2$ and $\mu_{2}=0$. Hence, the point of the Grassmannian is given by

$$
N(z) H_{+}=N\left(\begin{array}{ccc}
z^{-2} & 0 & 0 \\
0 & 1 & 0 \\
0 & 0 & z^{2}
\end{array}\right) H_{+} .
$$

More precise, let $n_{i}=\left(n_{1 i}, n_{2 i}, n_{3 i}\right)^{T}$ and $e_{1}=(1,0,0)^{T}, e_{2}=(0,1,0)^{T}$ and $e_{3}=(0,0,1)^{T}$, then this point of the Grassmannian has as basis

$$
n_{1} z^{-2}, n_{1} z^{-1}, n_{1}, n_{2}, n_{1} z, n_{2} z, e_{1} z^{2}, e_{2} z^{2}, e_{3} z^{2}, e_{1} z^{3}, e_{2} z^{3}, \cdots
$$

Using this one can calculate in a similar way as in [12] (using the bosonfermion correspondence or vertex operator constructions) the wave function:

$$
\begin{aligned}
\Psi(t, z) & =P(t, z) \exp \left(\sum_{i=1}^{n} \sum_{j=1}^{\infty} t_{j}^{(i)} z^{j} E_{i i}\right), \quad \text { where } \\
P_{j j}(t, z) & =\frac{\hat{\tau}\left(t_{\ell}^{(k)}-\delta_{k j}\left(\ell z^{\ell}\right)^{-1}\right)}{\hat{\tau}(t)}, \\
P_{i j}(t, z) & =z^{-1} \frac{\hat{\tau}_{i j}\left(t_{\ell}^{(k)}-\delta_{k j}\left(\ell z^{\ell}\right)^{-1}\right)}{\hat{\tau}(t)}
\end{aligned}
$$

and where

$$
\hat{\tau}(t)=\operatorname{det}\left(\begin{array}{cccccc}
n_{11} S_{2}\left(t^{(1)}\right) & n_{11} S_{1}\left(t^{(1)}\right) & n_{11} & 0 & n_{12} & 0 \\
n_{21} S_{2}\left(t^{(2)}\right) & n_{21} S_{1}\left(t^{(2)}\right) & n_{21} & 0 & n_{22} & 0 \\
n_{31} S_{2}\left(t^{(3)}\right) & n_{31} S_{1}\left(t^{(3)}\right) & n_{31} & 0 & n_{32} & 0 \\
n_{11} S_{3}\left(t^{(1)}\right) & n_{11} S_{2}\left(t^{(1)}\right) & n_{11} S_{1}\left(t^{(1)}\right) & n_{11} & n_{12} S_{1}\left(t^{(1)}\right) & n_{12} \\
n_{21} S_{3}\left(t^{(2)}\right) & n_{21} S_{2}\left(t^{(2)}\right) & n_{21} S_{1}\left(t^{(2)}\right) & n_{21} & n_{22} S_{1}\left(t^{(2)}\right) & n_{22} \\
n_{31} S_{3}\left(t^{(3)}\right) & n_{31} S_{2}\left(t^{(3)}\right) & n_{31} S_{1}\left(t^{(3)}\right) & n_{31} & n_{32} S_{1}\left(t^{(3)}\right) & n_{32}
\end{array}\right) .
$$

The functions $S_{i}(x)$ are the elementary Schur polynomials:

$$
S_{1}(x)=x_{1}, \quad S_{2}(x)=\frac{x_{1}^{2}}{2}+x_{2}, \quad S_{3}(x)=\frac{x_{1}^{3}}{6}+x_{2} x_{1}+x_{3} .
$$

The tau function $\hat{\tau}_{i j}(t)$ is up to the $\operatorname{sign} \operatorname{sign}(i-j)$ equal to the above determinant where we replace the $j$-th row by

$$
\left(n_{i 1} S_{1}\left(t^{(i)}\right) \quad n_{i 1} \quad 0 \quad 0 \quad 0 \quad 0 \quad 0\right)
$$

Next we put all higher times $t_{j}^{(i)}$ for $j>1$ equal to 0 and write $u_{i}$ for $t_{1}^{(i)}$. Then using the orthogonality-like condition (32) of the matrix $N$ to reduce long expressions, the wave function becomes:

$$
\begin{aligned}
\Psi(u, z)= & \left(I+\frac{1}{\tau(u)} \sum_{i, j=1}^{3}\left[\left(-w_{1}^{(3)}+w_{1}^{(2)}\left(u_{i}+u_{j}\right)-w_{1}^{(1)} u_{i} u_{j}\right) z^{-1}\right.\right. \\
& \left.\left.+\left(w_{1}^{(1)} u_{i}-w_{1}^{(2)}\right) z^{-2}\right] n_{i 1} n_{j 1} E_{i j}\right) e^{z U}
\end{aligned}
$$

where, for convenience of notation, we have introduced some new "variables"

$$
w_{i}^{(k)}=\frac{1}{k} \sum_{\ell=1}^{3} u_{\ell}^{k} n_{\ell i} n_{\ell 1}
$$

and where

$$
\tau(u)=w_{1}^{(3)} w_{1}^{(1)}-w_{1}^{(2)} w_{1}^{(2)}
$$

Note that in this way we also have determined the rotation coefficients

$$
\beta_{i j}=\frac{1}{\tau(u)}\left(-w_{1}^{(3)}+w_{1}^{(2)}\left(u_{i}+u_{j}\right)-w_{1}^{(1)} u_{i} u_{j}\right) n_{i 1} n_{j 1}
$$

which is a new solution of order 3 of the the Darboux-Egoroff equations.
Recall that $\eta=\sum_{i=1}^{3} E_{i, 4-i}$. It is now straightforward but tedious to determine the flat coordinates $x^{\alpha}$ and the $\phi_{\alpha}^{(j)}$ for $j>1$. One finds that for $\ell>0$ and $p=1,2,3$ :

$$
\begin{equation*}
\phi_{p}^{\left(\ell-\mu_{p}\right)}=\frac{\tau w_{p}^{(\ell+2)}+\tau_{1} w_{p}^{(\ell+1)}+\tau_{2} w_{p}^{(\ell)}}{2(\ell-1)!\tau} \tag{34}
\end{equation*}
$$

and

$$
\begin{equation*}
\phi_{p}^{\left(-2-\mu_{p}\right)}=\delta_{p 3}, \quad \phi_{p}^{\left(-1-\mu_{p}\right)}=-\delta_{p 3} \frac{\tau_{1}}{2 \tau}, \quad \phi_{p}^{\left(-\mu_{p}\right)}=\delta_{p 3} \frac{\tau_{2}}{2 \tau} \tag{35}
\end{equation*}
$$

where

$$
\begin{aligned}
& \tau_{1}=w_{1}^{(2)} w_{1}^{(3)}-w_{1}^{(1)} w_{1}^{(4)} \\
& \tau_{2}=w_{1}^{(2)} w_{1}^{(4)}-\left(w_{1}^{(3)}\right)^{2}
\end{aligned}
$$

Note that (34) also holds for $p=1$ and $\ell=1,2$, it is easy to verify that $\phi_{1}^{(-1)}=\phi_{1}^{(0)}=0$. Using (17), one has the following flat coordinates:

$$
\begin{align*}
& x^{1}=-\frac{\tau_{1}}{2 \tau} \\
& x^{2}=\frac{1}{2 \tau}\left(\tau w_{2}^{(3)}+\tau_{1} w_{2}^{(2)}+\tau_{2} w_{2}^{(1)}\right)  \tag{36}\\
& x^{3}=\frac{1}{4 \tau}\left(\tau w_{1}^{(5)}+\tau_{1} w_{1}^{(4)}+\tau_{2} w_{1}^{(3)}\right)
\end{align*}
$$

From all this it is straightforward to determine $F(u)$, given by (18):

$$
\begin{aligned}
F & =\frac{\tau_{2}}{16 \tau^{2}}\left(\tau w_{1}^{(5)}+\tau_{1} w_{1}^{(4)}+\tau_{2} w_{1}^{(3)}\right) \\
& -\frac{\tau_{1}}{48 \tau^{2}}\left(\tau w_{1}^{(6)}+\tau_{1} w_{1}^{(5)}+\tau_{2} w_{1}^{(4)}\right) \\
& -\frac{\tau}{96 \tau^{2}}\left(\tau w_{1}^{(7)}+\tau_{1} w_{1}^{(6)}+\tau_{2} w_{1}^{(5)}\right) \\
& +\frac{1}{8 \tau^{2}}\left(\tau w_{2}^{(3)}+\tau_{1} w_{2}^{(2)}+\tau_{2} w_{2}^{(1)}\right)\left(\tau w_{2}^{(4)}+\tau_{1} w_{2}^{(3)}+\tau_{2} w_{2}^{(2)}\right)
\end{aligned}
$$

We shall not determine the explicit form of this prepotential in terms of the canonical coordinates here, because it is quite long. However, there is a problem even in this "simple" example. We do not know how to express the cannonical coordinates $u_{i}$ in terms of the flat ones, the $x^{\alpha}$ s and thus cannot express $F$ in terms of the flat coordinates. Hence we cannot determine the desired form of $F$. This can be solved in the simplest example, see [12], viz. the case that $\mu_{1}=-\mu_{n}=1$ and all other $\mu_{i}=0$. This gives a rational prepotential $F$ (in terms of the flat coordinates).
