# The m odi ed tetrahedron equation and its solutions

A bstract
A large class of 3-dim ensional integrable lattice spin $m$ odels is constructed. The starting point is an invertible canonicalm apping operator $R_{1 ; 2 ; 3}$ in the space of a triple $W$ eylalgebra. $\mathrm{R}_{1 ; 2 ; 3}$ is derived postulating a current branching principle together w ith a $B$ axter $Z$-invariance. The tetrahedron equation for $\mathrm{R}_{1 ; 2 ; 3}$ follow S w thout further calculation. If the $W$ eyl param eter is taken to be a root of unity, $R_{1 ; 2 ; 3}$ decom poses into a m atrix conjugation operator $R_{1 ; 2 ; 3}$ and a $c$-num ber functionalm apping $R_{1 ; 2 ; 3}^{(f)}$. The operator $R_{1 ; 2 ; 3}$ satis es a modi ed tetrahedron equation ( $M T E$ ) in which the "rapidities" are solutions of a classicalintegrable $H$ irota-type equations. R 1;2;3 can be represented in term sof the B azhanov B axterFerm at curve cyclic functions, or altematively in term $s$ of $G$ auss fiunctions. T he paper sum $m$ arizes several recent publications on the sub ject.

## Introduction

The sub ject of constructing and solving two-dim ensional integrable lattice models is a w ell-established branch of $m$ athem atical physics. It has boosted im portant developm ents like conform alquantum eld theory, quantum groups and the quantum inverse scattering m ethod. B ut the analogous three-dim ensional integrable lattioe m odels have received little attention: the few known cases are com plicated and direct physical applications seem to be rem ote. $M$ any tools which are pow erfiul for dealing w th tw o-dim ensional lattige $m$ odels seem to have little relevance for the higher-dim ensional cases. H ow ever, the Y ang-B axter equation can easily be generalized to tetrahedron- and D-sim plex equations [2, 3] which still guarantee the existence of com $m$ uting fam ilies of transfer $m$ atrioes, and concepts from the quantum inverse scattering $m$ ethod like L-operators can be generalized to dim ensions D $>2$ [17]. Since $m$ any statistical system $s$ require a truly three-dim ensional treatm ent, exploring the possibilities of constructing and solving 3D -integrable m odels should not be useless.

The rst solution to the tetrahedron equation (TE) was found by Zam olodchikov in 1981 [1], and the partition function of th is $N=2$-state $m$ odelw as calculated by B axter [4]

[^0]using only sym $m$ etry properties, som e factorization and com $m$ utativity. Later, B azhanov and Baxter [5] showed how to generalize the Zam olodchikov model to $\mathrm{N}>2$, using the interaction-round-a-cube language ( $\mathbb{R} C-Z B B-m$ odel). Then, Sergeev, M angazeev and Stroganov found the vertex-form ulation of the $Z B B \rightarrow m$ odel [11]. These $m$ odels share the feature the ZBB B oltzm ann weights are not positive de nite, but at least in the therm odynam ic lim it the partition function becom es real. B axter and Forrester 7] have investigated whether the integrable ZBB m odelm ay describe phase transitions. T hey m odify the ZBB $m$ odel introducing a sym $m$ etry breaking param eter (destroying the integrability). C alculating the corresponding order param eter by variational and num ericalm ethods, they nd good evidence that in the integrable case the $m$ odel is just at criticality (rem in iscent of what happens in the 2D Potts $m$ odel).

There have been several attem pts to construct physically more interesting 3D integrable models, avoiding the too restrictive Zam olodchikov TE, using "M odi ed TEs" [9, 10, 15, 16]. The notion of a M odi ed TE and the way to construct an integrable $m$ odel from its solution has been rst suggested by $M$ angazeev and Stroganov in 8].

A di erent starting point to nd a large class of integrabel 3D m odels has been used by Sergeev [17, 18]. F irst an autom orphism of a triple $W$ eyl algebra is constructed, which satis es a K irchho -like auxiliary linear problem and a B axter Z-invariance principle. This invertible canonical autom orphism im plies the TE, so this approach avoids the need of a tedious proof of the TE [21]. If the W eylparam eter is taken to be the $N$ th prim itive root of unity, a very interesting $m$ echanism notioed before in [23, 20, [22, [13, 17, 34] becom es operative: The mapping operator becom es a m atrix con jugation (which is the quantum operator of an euclidian tim e evolution, or the Boltzm ann weight) which depends on $c^{-}$ num ber param eters, which satisfy a set of $H$ irota-type classical integrable equations of m otion. So we have a quantum integrable system which is param eterized by solutions of a classical integrable system.

T he di erent solutions of the classical integrable equations de ne various 3D-integrable quantum $m$ odels. This fram ew ork contains the ZBB m odelwhich is obtained choosing the trivial classical solution. T he general solution to the $H$ irota-type equations for given global boundary conditions can form ally be w ritten dow $n$ in term $s$ of high-genus theta functions, using the Fay-identity [27, 28, 29, 30].

W hat is the use of these results? It is clear that the construction of a versatile integrable 3D-statistical model with nice physical properties and its analytic solution is not yet round the comer, but the $m$ athem atical structures which such a m odel should inconporate becom em ore clear. W hether this class ofm odels is su ciently w ide to describe 3D phase transitions, w illbe seen. A nother application which can be m ade right now is to use these 3D models in an asym $m$ etric geom etry and to reduce them to new 2D integrable models [24]. Since Ferm at curves are involved, these will be usefiul relatives of the chiral P otts m odeland of the relativistic T oda m odel [34]. T he large variety ofparam eterizations w hich the M TE allows (in contrast to the YangBaxter equation) should help to overcom e the serious param eterization problem swhich have prevented progress to nding more analytic results for the chiral $P$ otts $m$ odel.

W e shall not try to touch all interesting aspects of this program. W e concentrate on explaining the construction of the basic triple $W$ eyl autom onphism and how it gives rise to the m odi ed tetrahedron equation (MTE) and the classical H irota-type equations of m otion. W e focus on the localproperties and do not discuss boundary conditions and large system s. For the reader's convenience, we sketch som e details of the derivations even if
these are rather straightforw ard. T he interested reader $m$ ay consult references [17, 36, 35] which give m ore details on recent results on 3D integrable m odels satisfying M TEs.

## 1 The canonial invertible $m$ apping $R_{123}$

The models to be discussed in this paper are de ned on a 3-dim ensional oriented lattice, which can be im agined as a (possibly distorted) cubic oriented lattice. $W$ e use the vertex language: the dynam ic variables $w_{i}$ live on the oriented links $i$ of the lattice and the Boltzm ann weights are associated to the vertioes. W e assum e that the lattioe is nondegenerate so that at all vertioes exactly three lines m eet. The Boltzm ann weights can be considered as operators $m$ apping the three dynam ic variables on the incom ing links to the three variables on the outgoing links. F ig $\mathbf{1}_{\text {show s a perspective view oftw o ad jacent cubes }}$ of the lattice (to keep the picture simple, we do not show the other vertioes and lines). O nly the dynam ic variables on the links surrounding the vertex A are indicated. The links (or edges) of the lattice arise from the intersection oftw o planes each, the vertices from the intersection of three planes. W e introduce auxiliary planes (shaded in Fig(1) and locate the dynam ic variables at the vertices of the lines where the lattice planes intersect the auxiliary planes. Them apping of the variables $w_{i}$ onto the $w_{i}^{0}$ can be regarded as $m$ oving the auxiliary plane through the vertex A. This way we $m$ ay interpret the 3 -dim ensional statistical $m$ odel as the euclidian tim e evolution of the 2 -dim ensional lattice which arises when we m ove the auxiliary plane.

The next step is to specify the $m$ apping, or, equivalently, the Boltzm ann weights. $W$ e assum e that the dynam ic variables $w_{i}$ are elem ents of the ultralocal $W$ eyl algebra

In order to determ ine the $m$ apping uniquely, we postulate a linear current branching principle (a kind of $K$ irchho law ), together with a B axter $Z$-invariance. C onsider F ig 2. O $n$ the right hand side we show again the vicinity of the vertex A offig 1 : on top and on the bottom there are the two auxiliary planes. T he three links of the basic lattioe which connect the $\mathrm{w}_{\mathrm{i}}$ and the $\mathrm{w}_{\mathrm{i}}{ }^{0}$, intersect in $A . W$ e now postulate currents $j_{i} i \quad$ ow ing out of the vertiges into the surrounding four sectors of the auxiliary plane. $T$ he distribution of the current $j_{i} i$ ow ing out of $w_{i}$ into the sectors is steered by the value of the variable $w_{i}$ and one coupling constant $i$, as show $n$ in the left hand picture of $F$ ig 2: $T$ he vertex $i$ sends the current $j$ ii into the sector left to the arrow $S$, into the sector betw een the tw o outgoing arrow $s$ it sends $q^{1=2} u_{i} j{ }_{i} i$, to the right of the arrow $s w_{i} j{ }_{i} i$, and betw een the incom ing arrow $s{ }_{i} u_{i} W_{i j}{ }_{i} i$. The total current in an intemal sector is required to be zero and the total current reaching an extemal sector should be independent of the intemal structure. In F ig 3 we show the low er and upper auxiliary planes of the previous tw o F igures. A ccording to the rules just stated, the total currents ow ing into the intemal

and j 3 i. Since both structures di er just by a shift of one line through one vertex, there is a unique correspondence betw een the respective sectors. So these rules give:

These eight equations determ ine the $u_{i}^{0}$ and $w_{i}^{0}$ uniquely in term $s$ of the $u_{i}$ and $w_{i}$ and vige versa (we give details of the calculation in the A ppendix). The resulting rational transform ation can be w ritten as:

In (4) the order of the factors on the right hand side is irrelevant since e.g. 1 contains only operators which com $m$ ute $w$ ith both $u_{2}$ and $u_{3}$, in particular, it contains no $w_{2} ; w_{3}$. The six eqs. (4) are written $w$ th only three operators $i$ because the $m$ apping conserves three centers:

$R_{1 ; 2 ; 3}$ is an autom orphism of $W$ and conserves the three centers (6) .
$T$ he derivation of (4), (5) from (3) given in the A ppendix does not use that $u_{i} ; w_{j}$ are W eyloperators. H ow ever, the canonicalproperty of $R_{1 ; 2 ; 3}$ is obtained for ultralocalW eyl dynam ic variables only. T he inverse transform ation has a sim ilar form and we sum marize it giving $i^{1}$ in term $s$ of the prim ed variables:

There is a way dual to (3) to form ulate the current branching principle as "Linear problem ". This is m ore convenient if one is dealing $w$ th a large lattige $w$ ith de nite boundary conditions. The resulting $m$ apping is the sam e (4), (5), we give this altemative derivation in the A ppendix. W e refer to [36, 33] for a detailed exposition of the linear problem equations for large cubic lattioes.

## 2 W eyl param eter q a root of unity: decom position of R into a $m$ atrix con jugation and a functionalm apping.

Then $u^{N}$ and $W^{N}$ are centers of the $W$ eylalgebra and we can represent the canonical pair ( $u_{i} ; w_{i}$ ) by its action on a cyclic basis as unitary $N \quad N \mathrm{~m}$ atrices $m$ ultiplied by com plex param eters $u_{i} ; w_{i}$ :Thealgebra $W$ w illthen be represented in a $N$ dim ensionalproduct space, see (1). Because of the ultra-locality, the $W$ eyl operators ( $u_{i} ; w_{i}$ ) $2 w_{i} w$ ill be represented trivially in all spaces $j \in i$, acting non-trivially only in the space $w$ th labeli, where (now om itting the index i):

W e shall see that for $q$ a root of unity, the rather com plicated looking transform ation (4), (5) can be represented in a rather sim ple way.

### 2.1 The functionalm apping $\mathrm{R}_{1 ; 2 ; 3}^{(\mathrm{f})}$

For $q$ a root of unity, not only the $N$ th powers of the $W$ eyl variables are num bers, but also the N th powers of the operators $i$ w ill be num bers. T his is because in calculating the $N$-th pow ers the cross term s drop out, e.g. $(a u+b w)^{N}=(a u)^{N}+(b w)^{N}$ due to $\underset{j=0}{N} 1^{1}{ }^{j}=0$, etc. $W$ e get

Later we shall need not only the $m$ apping of the centers (14) but also the $m$ apping of the $u_{i} ; w_{i}$ itself onto the $u_{i}^{0} ; w_{i}^{0}$. For this $w e$ have to take $N$ th roots and get a freedom to choose phases. If we dem and the num ber products $w_{1} w_{2} ; u_{2} u_{3} ; u_{1} w_{3}{ }^{1}$ to be centers of this $m$ apping, then there are three free phases.

## 2.2 $M$ atrix structure of the $m$ apping $R_{1 ; 2 ; 3}$

$W$ e now look at the $m$ atrix form of $\mathrm{R}_{1 ; 2 ; 3}$ in the representation (11). W e separate the num erical factors from the constant diagonal resp. cyclic raising $m$ atrices $x_{i} ; z_{i}$. ## 3 Tetrahedron equation and modi ed tetrahedron equation

$W$ e postpone for a $m$ om ent the discussion of the explicit form of $R_{1 ; 2 ; 3}$ and of the possible form of $R{ }_{1 ; 2 ; 3}^{(f)}$. W e shall rst see that, once we have constructed the invertible canonical $m$ apping of the triple $W$ eylalgebra $R_{1 ; 2 ; 3}$, no calculation is needed to conclude that $R_{i ; j ; k}$
satis es the Tetrahedron equation. W e want to keep the point of view taken in $F$ ig 1 that the $m$ apping $\mathrm{R}_{1 ; 2 ; 3}$ com es about by $m$ oving the auxiliary plane through a vertex of the basic lattice. For considering the single $m$ apping $R_{1 ; 2 ; 3}$ we selected three planes of the basic lattioe and intersected these by the auxiliary plane. N ow we look at four (w ith no pair being parallel) lattioe planes intersecting the auxiliary plane. In the auxiliary plane this gives rise to a gure called quadrangle shown in $F$ ig 4. A quadrangle consists of four lines which form two triangles and one four-sided gure. There are six crossing points. Shifting the auxiliary plane $w$ th in the basic lattioe, we can revense (from to $r$ ) either of

the tw o triangles: Shifting such that the plane producing the line B gets to the other side of point 1 (this happens $m$ oving the auxiliary plane through the vertex form ed by planes $\mathrm{B} ; \mathrm{C} ; \mathrm{D}$ ) we perform the m apping $\mathrm{R}_{1 ; 2 ; 3 \text {. A ltematively, wem ay shift the plane } C \text { through }}$ the point 6 ( $m$ oving the auxiliary plane through the vertex of $A ; B ; C$ ), so perform ing the mapping $R_{3 ; 5 ; 6}$.
A s show $n$ in $F$ ig 5 , there are tw o di erent sequences ofm appings which, starting from $Q_{1}$, lead to the sam equadrangle $Q_{5}$ : either $Q_{1}!Q_{2}!Q_{3}!Q_{4}!Q_{5}$ or $Q_{1}!Q_{8}!Q_{7}!$ $Q_{6}!Q_{5}$. Since the $m$ apping $R_{i ; j}{ }^{2}$ is invertible and canonical, we conclude that the two corresponding products of the $R \mathrm{~m}$ ust be the sam e $m$ apping:

W e shall not enter into the discussion of these phase choiges here, in [35] it is shown that 16 phases can be chosen arbitrarily. (28) or (29) m odi ed tetrahedron equations because in (28) the R (j) depend on several "rapidity" variables $u_{1} ;::: ; \mathrm{w}_{6} \mathrm{w}$ hich are not the sam e on the left-and right hand sides of the equation, but rather are related by various functional $m$ appings. $W$ e shall later see that there is $m$ uch freedom in choosing $R_{1 ; 2 ; 3}^{(f)}$, accordingly leading to di erent $m$ odels.

## 4 <br> D etails on the $m$ atrix-and the functionaltransform ations

4.1 M atrix part of $R_{1 ; 2 ; 3}$ at root of unity in term $s$ of Ferm at curve cyclic functions $W_{p}(n)$

In $S e c 22$ we introduced the con jugation operator $R_{1 ; 2 ; 3}$ and its representation $R_{i_{1} ; i_{2} ; i_{3}}^{j_{1} ; j_{2} ; j_{3}}$, which allowed to w rite eqs. (17) in the form (18). W e just have seen that the m atrix elem ents of the $\mathrm{R}_{1 ; 2 ; 3}$ play the role of B oltzm ann weights and solve the M TE.

In (20) we had rem arked that $\mathrm{R}_{i_{1} ; i_{2} ; i_{3}}^{j_{1} ; j_{2} ; j_{3}}$ has to satisfy six recursion relations w ith respect to its modulo N de ned indices, but have not yet seen its explicit form .
We now show that the $R_{i_{1} ; i_{2} ; i_{3}}^{j_{1} ; j_{2} ; j_{3}}$ can be constructed from Ferm at curve cyclic functions $W_{p}(n)$ which were introduced by B azhanov and B axter [5] for buiding up the B oltzm ann weights of theirm odel. The form (33) which we shalluse has rst been given in [11] several years ago.

### 4.3 The functionalm apping in term $s$ of trilinear H irota equations

W hen we wrote the M TE in Sec 3 , we did not specify the details of the functional transform ations $R_{i ; j ; k}^{(f)}$ which act on the scalar param eters of the quantum operators $R_{i ; j ; k}$ (by (33) the scalar param eters then determ ine the Ferm at variables). W e are interested to write this m ore explicitly and we like to understand which restrictions the M TE im poses on the $\mathrm{R} \underset{i ; j ; k}{(£)}$.

Ifwe just use (42) repeatedly to calculate the $R{ }^{(j)}$ in (25), we get very lengthy expressions. $R^{(3)} w$ illbe $m$ uch $m$ ore com plicated than $R^{(2)}$ etc. It is not transparent, which variables are independent because the conservation of the centers is hidden in com plicated form ulas. $H$ ow ever, the nige sym $m$ etry of $F$ ig 5 suggests that a di erent param eterization should be possible which treats all operators in (28) on essentially equal footing. Indeed this is achieved applying a Legendre transform ation or, equivalently, by the introduction of taufunctions as it is com m on practioe in the theory of classical integrable system s [36]. Let us see in an elem entary way how this works.

In $F$ ig 6 we show a magni ed view of the two quadrangles $Q_{1}$ and $Q_{2}$ of $F$ ig. 5 . $C$ onsider $Q_{1}$ : The twelve scalar variables $u_{i} ; w_{i}(i=1 ;::: ; 6)$ are located at the six vertices labeled $i=1 ;::: ; 6$. The vertices cut each directed line $A ; B ; C ; D$ into four line-sections. We label these line-sections as shown in the gure. R atios of line sections willbe our new variables and we explain the rule for the variables $u_{1} ; w_{1}$ associated $w$ ith vertex "1" in the upper left comer:

This $w$ ay the twelve scalar variables $u_{1} ; \mathrm{w}_{1} ;::: ; \mathrm{u}_{6} ; \mathrm{w}_{6}$ of each quadrangle are expressed in term $s$ of eight \intemal line sections, $a_{1} ; a_{2} ;::: ; d_{1} ; d_{2}$ for $Q_{1}$, and eight lextemal line sections $a_{0} ; a_{3} ;::: ; d_{0} ; d_{3}$.

Passing from one quadrilateral to an adjacent one, corresponding to a mapping $R$, alw ays three of the \intemal\ lines are changed, and for distinction, we attach to these changed variables dashes (if left-tuming in Fig 5 and daggers (if right tuming). The

Since we know already that $\mathrm{R}_{\mathrm{i} ; j ; \mathrm{k}}^{(\mathrm{f})}$ is a solution to the functional E , one m ay easily show that eight of the 83 trilinear eqs. of type (44) are super uous. For the whole M TE we have introduced 16 line sections to replace the 12 scalar variables, but the eight \extemal\} variables $a_{0} ;::: ; d_{3}$ and the six couplings $i$ tum out to be irrelevant, i.e. these can be elim inated by a re-scaling [35].

So the conclusion is that the eight \intemall variables $\mathrm{a}_{1} ; \mathrm{a}_{2} ;::: ; \mathrm{d}_{1} ; \mathrm{d}_{2}$ together w th sixteen phase choiges param eterize the M TE eq. (28) or (29). This is much m ore com plicated than the rapidities which appear equally on both sides of a Y ang-B axter-equation. O f course, there is no di erence property of the param eters of the M TE.

### 4.4 Solving the M TE using tools of algebraic geom etry

It is well-known [27, 28, 29, 30, 31] that discrete integrable classical equations can be solved by $m$ ethods of algebraic geom etry. The bilinear $H$ irota equation is equivalent to Fay's identity for theta-functions on the Jacobian of an algebraic curve [30]. T he tri-linear equations (44) are also of the correct type to be solved using Fay's identity.

From these form ulas sim ple param eterizations can be obtained taking the rational $\lim$ it. $T$ hen the theta functions becom e trigonom etic functions and the cross ratios of the prim e form s becom e sím ple rational cross ratios [36].

## 5 Free boson ic realization of $\mathrm{R}_{1 ; 2 ; 3}$

Together with introducing the ZBB m odel in [26], B azhanov and Baxter also considered a related continuum bosonic $m$ odel. Since our fram ew ork includes the $Z B B m$ odel, we expect that such a bosonic representation should also exist for $\mathrm{R}_{1 ; 2 ; 3}$. Since this broadens the class of m odels, we shall present here the basic form ulas. We shall not consider this realization a lim iting case of the discrete realizations, but rather a new representation.

C ertainly, if this bosonic representation is used, the M TE involves integrations over $R$ instead of sum $m$ ations over $Z_{N}$. The bosonic M TE m ay be proven directly w ith help of G aussian integrations.
$T$ here are indications that this bosonic model will not be critical all over and so be physically interesting [37].

## 6 C onclusions

A large class of integrable 3-dim ensional lattioe spin models is constructed. The starting point and central ob ject of the construction is an invertible canonical autom orphism of a triple ultralocal W eyl algebra which satis es two physically m otivated principles: A current branching rule and a B axter Z-invariance. To argue that this autom onphism operator full ls the tetrahedron equation requires no calculation. If the $W$ eyl param eter $q$ taken to be a root of unity, one chooses the $\mathrm{N} \quad \mathrm{N}$ unitary representation of the W eyl operators and the $N$ th pow ers of the $W$ eyloperators are represented by num bers. A ccordingly, in this representation the autom onphism operator can be decom posed into a m atrix conjugation and a functionalm apping. Q uite trivially, the functionalm apping operator satis es a tetrahedron equation too. The conjugation $m$ atrix which can be expressed in com pact fashion in term $s$ of the $B$ azhanov-B axter Ferm at curve cyclic functions, satis es the m odi ed tetrahedron equation, (28). So we have a quantum problem with coe cients which are form a classical integrable system them selves. The large class of di erent solutions to the classical integrable system leads to a large class of quantum 3D-integrable m odels. The Zam olodchikov-B axter-B azhanov m odel is obtained if we choose the trivial classical solution. T here is also a G aussian continuum representation of the autom orphism operator.

O ur expectation is that the fram ew ork set is broad enough to contain physically interesting 3D -integrable lattioe $m$ odels. A $n i m m$ ediate application is to perform an asym m etric lim it to construct new 2D -integrable chiralm odels involving rapidity param eters living on
$m$ anagable algebraic curves. T he vast possibilities to choose convenient param eterization of the 3D Boltzm ann weights should open new possibilities to solve the 2D-descendent m odels.

T he right colum $n$ in (71) is just an evident consequence of (69).
T w o im portant notes are to bem ade. Recall, at the rst, expressions 69) , 70), (71) are obtained in the fram ew ork of the associative noncom m utative ring, i.e. we never changed the order of the invertible elem ents $u_{i}, w_{i}, v_{i}, u_{i}^{0}, w_{i}^{0}$ and $v_{i}^{0}$. Secondly, since the linear equivalence principle im plies eight independent relations, there are eight independent relations betw een nine relations (69), (71). In the fram ew ork of the noncom $m$ utative ring the proof of this $m$ iracle is a quite com plicated exercise.

N ow the question is how to get rid of one degree of freedom in the prim ed elem ents. The answ er lies in the com parison of the left and right colum ns of (71). O nem ay see that it is natural to identify left and right colum ns . T he identi cation produces tw O dem ands

and the analogous relations for the prim ed elem ents. Evidently, eqs. (72) $x$ the $W$ eyl algebra structure.

Let now the in itialelem ents $u_{i}, w_{i}$ and $v_{i}$ obey the localW eylalgebra relations (2) w ith $v_{i}={ }_{i} u_{i} w_{i}, ~ i 2 \mathrm{C}$. Then (69), (71) im m ediately give $v_{i}^{0}={ }_{i} u_{i}^{0} w_{i}{ }_{i}$, where ${ }_{i}^{0}$ are centers such that $1_{2}=\begin{array}{lll}0 & 0 \\ 1 & 2 & 2\end{array}{ }_{2}={ }_{2}^{0}{ }_{3}^{0}$, and the mapping (69) de nes the autom onphism of the local W eyl algebra. Extemal \physical" dem and is that since $i$ are centers, a well de ned autom orphism should not change them : ${ }_{i}^{0}={ }_{i}$. A fter the identi cation of $i$ and ${ }_{i}$, eqs. (69), (70) coincide w ith (4), (5) up to the rescaling $2_{2}=q_{1}{ }_{3} \mathrm{f}_{2}$.
