Complex behavior from a simple physical system :

A num erical investigation

Abstract

In this paper, the fam iliar problem s of free-fall motion and simple harm onic motion (SHM) are combined. The novel composite system passes from regular to chaotic behavior for increasing values of energy E. This system is a suitable example to introduce undergraduates to some of the concepts of dynamical chaos theory.

I. IN TRODUCTION

For many centuries now, students of introductory physics have studied Newton's Laws of M otion. The two systems done ad nausea are a particle in free-fall and the mass-spring system (inclines being a special case of the form er). A dditionally, it is well know in the chaos community, over the past few decades, that coupled oscillators can exhibit chaotic behavior i.e. motion that is very sensitive to initial conditions.¹ E xam ples of this kind include the driven dam ped oscillator, the double pendulum, and the magnetic pendulum. A few of these are illustrated in M arion and Thomton's text on classical dynam ics.²

The purpose of this paper is to answer the question, \W hat is the behavior of a massspring system which is subject to free-fall motion above a rigid oor without dam ping?". This system is a variant of a class of problem s know as in pact oscillators. One of the earliest was put forward by Ferm i to explain the origin of cosm ic rays.³ H is model was an elastic ball which bounced o of a vertically oscillating oor. The interested reader is referred to the bibliography for descriptions of sim ilar system s.^{4,5}

The free-fall spring subject to impact (FSI) constitutes a coupled oscillator problem and the resulting motion is chaotic.

II. THE PHYSICAL SYSTEM : COUPLED OSCILLATORS

Consider the motion of a point particle released from rest at an initial height y subject to the acceleration due to gravity g. If the particle su ers a perfectly elastic collision with the oor (as is done in billiard theory) it will return to height y after a time $T_{free fall}$ given by

$$T_{\text{free fall}} = \frac{r}{\frac{8y}{g}}$$

If the system is allowed to continually bounce, then it behaves like an oscillator with frequency given by

$$f_{\text{free fall}} = \frac{1}{T_{\text{free fall}}}$$

Next, consider two equal masses at either end of a perfect spring with an equilibrium position of y_0 and Hooke's constant k. The motion of the di erence coordinate i.e. Y =

 y_2 y_1 will be SHM with frequency

$$_{\text{SHM}} = \frac{1}{2} \int_{-\infty}^{\infty} \frac{\frac{2k}{2k}}{m}$$

The motion of the two systems can be coupled by releasing the spring system vertically and having the lower mass reject of of a perfectly elastic surface. The system is illustrated in gure 1 and represents a coupled oscillator. Examples in nature of such a system would be a diatom icm olecule of gas which su ers collisions with the oor of its container or a child on a pogo stick.

III. SIM ULATION : THE ROUTE FROM PHYSICS TO COMPUTER

In this section, the steps to get from physicalm odel to a computer simulation are outlined. D im ensionless coordinates are also introduced.

A. Equations of M otion M odel to Theory

New ton's second law is used to write down the equations of motion. Taking the rigid oor to be at y = 0, $m_1 = m_2 = m$, and the rest length of the spring to be y_0 the accelerations of the respective particles are

$$y_1 = g + !_0^2 (y_2 \quad y_1 \quad y_0)$$

The conventional dot notation has been used to represent the tem poral derivatives and $!_0^2 = k = m$. To simplify the above equations 4, dimensionless coordinates are used

The dimensionless quantity contains all of the physical parameters of the problem.

The two second order equations can be rewritten into a system of four rst order equations by noting that velocity is the time derivative of position. In this way, and using system 5, the dimensionless equations of motion for the FSI are

The above system of equations ignores the interaction of the lower mass y_1 with the rigid oor. The lower mass receives a delta function in pulse which switches its velocity v_1 ! v_1 upon impact. Care must be taken on handling this impact and will be discussed in the numerics section.

B. Energy Bounds

There are energy bounds that must be taken into consideration for the free-fall spring subject to im pact (FSI) F irst, the energy is written down in dimensionless form

$$E = \frac{1}{2} (v_1^2 + v_2^2) + \frac{1}{2} (y_2 - y_1 - 1)^2 + y_2 + y_1$$

The term s are in the order of kinetic, spring potential, and gravitational potential energy. The minimum of energy is chosen to be the system at rest with the lower mass on the oor at $y_1 = 0$ and the upper mass to be at $y_2 = 1$ which corresponds to

$$E_{m in} = 1 - \frac{1}{2}$$

Since negative energy is unphysical in this problem, this relation requires that < 2. Moreover, must be chosen so that $y_2 > 0$ i.e. < 1. By choosing the spring to start o at its equilibrium length, the minimum of energy is $E_{min} = 1$.

The upper bound on energy is found by requiring that the spring not be compressed to zero length i.e. $y_1 = y_2 = 0$. This is to ensure that particle two does not su er a collision

with the oor and that the two particles don't pass through each other. Substituting these initial conditions into 7 gives

$$E_{max} = \frac{1}{2}$$

The energy and parameter requirements for the FSI are

$$1 < E < \frac{1}{2} \tag{10a}$$

C. Theory to Num erics

The system was integrated in time with a fourth order Runge-Kutta method. The time step chosen wash = 0:001 which results in a local truncation error of approximately O (h^5) = 10¹⁵. The energy of the system was monitored and noted to be conserved to eight decimal places in double precision arithmetic. For all the simulations was chosen to be = 0:25 making the energy range 1 < E < 2.

The subtle part of the simulation is the actual in pact of the lower mass y_1 with the oor at y = 0. The time of impact can not be predeterm ined with a static discrete time step. As an example, let y_1 (t_i) equal the location of the lower mass right before impact at time t_i . At the next time step y_1 ($t_i + h$), the lower mass has moved through the oor and y_1 ($t_i + h$) < 0 which is unphysical and a consequence of using discrete time steps. The situation can be remedied by switching the independent variable from time to y_1 and integrating the system back to the surface. Applying the chain rule from calculus, the system is transformed to

and integrated with h replaced by h ! y_1 . The system , in this way, is moved back by the amount of the overshoot. At this point, the velocity of the lower particle is switched v_1 ! v_1 and the system is integrated forward again with the original time step. A similar example can be found in the references as well as a description of R unge-K utta routines.⁶

IV. THE INDICATORS OF CHAOS

In this section, the system is investigated for the existence of chaos and two popular chaos indicators are described.

A. Sensitivity to Initial Conditions: Lyapunov Exponents

Chaos has been described as a system which exhibits strong sensitivity to initial conditions. The fam ous \butter y e ect" of Edward Lorenz is an example.⁷ In gure 2.a two time series of y_2 are plotted on the same graph. Trajectory 1 is at an energy of E = 1:1 and trajectory two at E = 1:1 + E where E = 0:001. The sm all separation in the two trajectories is slightly noticeable and the two paths follow each other closely. A lso, the trajectory looks periodic. When the energy is increased to E = 1:75 and E = 1:75 + E som ething very di erent happens. The two paths in gure 2.b start out following each other but around t = 10 they start to diverge apart. A lso, the motion of neither looks periodic in plying that higher harm onics have been introduced. The proper way to quantify this phenom ena is with the Lyapunov characteristic exponent.

If a system is chaotic, then two trajectories separated slightly in phase space will, on average, diverge away from each other with an exponential behavior given by

$$d(t) \quad d_0 e^{t}$$

W here d_0 is the initial phase space separation at t = 0 and is known as the Lyapunov characteristic exponent or the largest Lyapunov exponent. Equation 12 should not be taken too literally but only represents an average behavior of dynam ical systems. The calculation of is actually an iterative process.

To start o , two trajectories initially separated in phase space by an amount d_0 are integrate forward for some time . The system is now separated in phase space by an

amount d_1 . At this point the two trajectories are renormalized so that the separation is again d_0 and then integrated forward again for . Continuing in this manner, a set of N d_i 's is used to calculate the Nth approximate of the Lyapunov exponent, given by

$$_{N} = \frac{1}{N} \sum_{i=1}^{X^{N}} \ln \frac{d_{i}}{d_{0}}$$

The largest Lyapunov exponent is then given by taking the lim it as N ! 1 of equation 13. The interested reader should follow the references for a more detailed description.^{2,8,9,10,11}

In the presence of chaos, tends toward some positive nite value. In the absence of chaos, ! 0. In gure 3, the results of for the above two values of energy separated in phase space by $d_0 = 10^6$ are shown. A fter 10^6 iterations the results were $_{E=1:1}$ 0:004 and $_{E=1:75}$ 0:187. The results in ply that for the smaller energy the motion of the FSI is regular and for the larger energy the motion is chaotic.

B. Poincare maps

The system under consideration is four dimensional in phase space given by the set $(y_1; y_2; v_1; v_2)$. Since energy is a conserved quantity the degrees of freedom can be reduced to three. A trajectory through three dimensional phase space of the system would be in possible to visualize and too complicated to follow. Information about the system is still possible by cutting phase space with a plane and looking at the crossing through this plane by trajectories at the same energy. The pattern left behind on the plane is known as a Poincare map or a Poincare surface of section.⁶

In gure four, four maps for various values of energy are shown. The surface of section plane was chosen by plotting points $(v_2; y_2)$ whenever y_1 made an impact with the oor. For the lowest value of energy, E = 1:1, the motion is regular and periodic. As the energy is increased to E = 1:75 the motion becomes more complex and the map becomes dense with points. This phase space lling behavior is indicative of chaos.

V. CONCLUSION

The free-fall spring subject to impact is a simple model which exhibits rich behavior. The reader is invited to carry out other investigations such as higher energies or setting $m_1 \in m_2$. The interested reader should see the references for non-technical^{12,13} and technical introductions to chaos.¹⁴








FIG.1: Twom asses at either end of spring released vertically in a constant gravitational eld over a perfectly relecting surface
















FIG.4a: Energy = 1.1




FIG.4.b: Energy = 1.25




FIG.4.c: Energy = 1.5




FIG.4d: Energy = 1.75
