# Inverse scattering approadh to coupled higher order nonlinear Schrodinger equation and N -soliton solutions

A bstract
A generalized inverse scattering $m$ ethod has been applied to the linear problem associated w th the coupled higher order nonlinear schrodinger equation to obtain it's N -soliton solution. An in nite num ber of conserved quantities have been obtained by solving a set of coupled R iccati equations. It has been show $n$ that the coupled system adm its tw o di erent class of solutions, characterised by the num ber of localm axim a of am plitude of the soliton.

## 1 Introduction

O ptical soliton since it's discovery occupies a distinguished position in the nonlinear optics research and it is regarded as the next generation carrier in sudipta@ iopb res.in
an all-optical com $m$ unication system. Because of their rem arkable stability solitons are capable of propagating long distance w ithout attenuation [1,2]. Theoretical study of optical soliton began as early as in seventies w ith the landm ark disoovery by H asegaw a and Tappert [3]. They had show $n$ that the nonlinear Schrodinger equation (NLSE) studied by Zakharov and Shabat [4] (but w ith space and tim e interchanged) is the appropriate equation for describing the propagation ofpico-second opticalpulses in optical bers. Later on M ollenauer etal. [5] successfiully dem onstrated the transm ission of pioosecond optical solitons through a m onom ode ber. Recently K odam a and H asegaw a [6] proposed a modi ed NLS m odel, known as the higher order nonlinear Schrodinger equation (HNLSE), which is suitable for the propagation of fem to-second optical pulse. Untill now only two integrable HNLS equations [7, 8] which has soliton solutions are known. The dynam ics of HN LSE not only takes care of dispersion loss but also takes care of the propagation loss as the optical soliton propagate along the ber. This is due to the fact that the stim ulated $R$ am an scattering e ect, which com pensates the propagation loss, already exists in the spectrum of the HNLS equation. As a consequence a short pulse can propagate as a soliton for a long distance w ithout distortion. Therefore the im portance of the study of HNLS system and to nd their soliton solution is unquestionable. The soliton solution $m$ ay be obtained by severalm ethods like H irota's bilinearm ethod [27, 28, 29], Lie group theory $[30,31,32]$ and inverse scattering $m$ ethod (IST ) [4, 33, 34]. The

IST is the $m$ ost elegant and one of the $m$ ost widely used technique, which eventually proves the com plete integrability of the system .

It hasbeen know $n$ that a good num ber of soliton equations in nonlinear optics have multi eld generalizations. The coupled nonlinear Schrodinger equation proposed by $M$ anakov [9], is one such exam ple. It describes a system $w$ ith tw o interacting optical elds w ith di erent states of polarizations. It has an im portant application in com m unication system susing opticalsolitons. Such system s have $m$ any other im portant applications in all optical com putations $[10,11,12,13]$, in photorefractive crystals $[14,15]$. R ecently the existence of m ultioom ponent solitons has been discovered experim entally also [16]. Interestingly the HNLS equation also has it's multi eld generalization and they have been studied in di erent physical contexts [17, 18, 19, 20]. The coupled HNLS (CHNLS) equations are particularly im portant for describing the dynam ics of ultrashort optical pulse in a system involving two or more interacting optical elds. Recently a CHNLS equation, which inconporates the e ect of third order dispersion, kerr nonlinearity and stim ulated $R$ am an scattering was proposed by N akkeeran et. al, [21, 22]. The equation considered in $[21,22]$ is given by

w ith n com ponents, w here n is a nite integer. T he su ces z and denote the norm alised space and tim e derivatives respectively. $\mathrm{E}_{\mathrm{k}}$ and $\mathrm{E}_{\mathrm{k}}^{?}$ respectively represent the am plitude of the kth com ponent of a slow ly varying eld and it's com plex conjugate. is an independent param eter. T hey have also show $n$ the integrability of (1) through the existence ofLax pair and obtained the one soliton solution (1SS) of (1) through B acklund transform ation. Existence of Lax pair although indicates the integrability of the system but a conclusive sense of integrability is achieved if the system possess an in nite num ber of conserved charges [26]. It is im portant to note that the equation (1) is the multi eld generalization of the Sasa-Satsum a equation [7]. Interestingly for Sasa-Satsum a (scalar) equation two di erent 1SS were reported in $[7,23,24,25]$. O ne is the convensional sech solution having a single peak and the other is a com plex com bination of sech function having two peaks. In view of the connection between the Sasa-Satsum a equation and it'sm ultield generalization it is expected that the latter equation should also adm it both type of soliton solutions. It should be mentioned that the 1SS w ith sech envelope function has been obtained in [21, 22]. H ow ever, it rem ained to show that (1) adm it a m ore general class of solutions. T he existence of the higher order solitons, which are im portant to study the soliton interactions also rem ained unexplored. A possible reason for this $m$ ay be the di culty involved in solving the linear problem associated w ith the system. It is im portant to note that for a com pletly integrable system it is necessary that
the system possess N -soliton solution.

O ur ob jective in this paper is to obtain the whole hierarchy of the conserved charges in a system etic way to establish integrability of (1) conclusively. W e com plete the investigation ofhigher order soliton solutions for (1) by deriving the exact $N$-soliton solutions for the system . W e invoke the inverse scattering $m$ ethod for an $(2 n+1 \quad 2 n+1)$ dim ensionaleigenvalue problem and obtain the $N$-soliton solution by solving the set of $(2 n+1) G$ elfand- $-\operatorname{levitan}-M$ archenko (G LM ) equations. Subsequently we discuss som e im portant characteristics of the 1SS.

T he paper is organized in the follow ing sequence. In section 2 we use a set of variable transform ations to cast the CHNLS equation into a form, suitable for the inverse scattering transform . Subsequently we study the linear problem associated w ith the $m$ odi ed system. In section 3 we show the existence of in nite num ber of conserved quantities by solving a set of coupled $R$ iccati equations. The IST schem e and the properties of the scattering data are studied and the generalized G LM equations are derived in the section 4. T he exact $N$-sollton solution is obtained in section 5. In Section 6 tw o class of solutions of the C H N LS equation are discussed. Section 7 is the concluding one.

## 2 E igenvalue problem

In order to investigate (1) we use the follow ing change of variables and a G alelian transform ation,

Thus we get a set of com plex modi ed $K-d V$ equations (CM KDV)

W e use $x$ and $t$ in (5) and in the subsequent expressions to denote the derivatives $w$ ith respect to $x$ and $t$ respectively. T he associated spectral problem of (5) m ay be represented by a pair of linear eigenvalue equations.

where is the $(2 n+1)$ dim ensional auxiliary eld and is the time independent spectral param eter. T he pair of $m$ atriges ( $L ; M$ ) is called the Lax pair. T he explicit form of the Lax pair has been given in [21, 22]. W ith slight modi cations (see eq. 11 in [22]) we express the Lax pair ( $\mathrm{L} ; \mathrm{M}$ ) by using a pair of $m$ atrioes ( ;A ), where is a c-no. diagonal $m$ atrix and the $m$ atrix

A $(x ; t)$ is a potential function of the eigenvalue problem and consists of the dynam ical elds, $q_{k}(x ; t)$ and $q_{k}(x ; t)$ only,

The Lax pairs given by (9) is also valid upto an additive constant, since a constant com $m$ utes $w$ ith all other $m$ atrices. $W$ e assum e the constant to be zero for simplicity. The consistency of the Lax equations $(6,7)$ gives the nonlinear evolution equation for the $m$ atrix $A$,

which is nothing but the $m$ atrix form of the equation (5). A though the existence of a Lax pair is itself a sign of the integrability of (5) vis. a. vis. (1), it rem ains to show that the system also possess in nite num ber of conserved quantities and adm it N -soliton solutions.

## 3 C onserved quantities

In order to obtain the conserved quantities rst we derive the associated $R$ iccatiequations. To this aim we write the Lax equation (6) in the com ponent form. For the rst $2 n$ com ponents of , the equation (6) can be written in the form

W e w ill see in the section 4 that $2 n+12 n+1$ is the diagonal elem ent of the scattering $m$ atrix and it is tim e independent.

$N$ otioe that the ham iltoniansw ith odd indioes only survive. The even indexed ham iltonians becom e trivial. It is easy to see using the equation of m otion that $\mathrm{H}_{1} ; \mathrm{H}_{3} ; \mathrm{H}_{5}$ are indeed the constants ofm otion. Ifwe choose the eld $\mathrm{q}, \mathrm{a}$ scalar eld then we are able to show that $\mathrm{H}_{1} ; \mathrm{H}_{3} ; \mathrm{H}_{5}$ reduce to the conserved quantities for the scalar Sasa-Satsum a equation [24].

## 4 Gelfand-Levitan -M archenko equations

W e now generalise the inverse scattering method for the $(2 n+1 \quad 2 n+1)$ dim ensional Lax operators (9). The generalization how ever, is a nontrivial one and crucially depends on the scattering data $m$ atrix. we have broadly follow ed the treatm ent of $M$ anakov, developed in the context of 3 Lax operators [9].

In order to form ulate the scattering problem we assum e that the fam ily of Jost functions $(k=1 ; 2 ;:: 2 n+1)$ and $(k=1 ; 2 ;:: 2 n+1)$ of (6) satisfy the follow ing boundary conditions for real values of ,

In order to obtain the com plete analytic behaviour of the jost functions vis a vis scattering data the dom ain of is extended to com plex plane. It is im portant to note that the bound states of the eigenvalue equation (6) correspond to zeros of $2 n+12 n+1$ () in the low er halfplane. ## 5 N -soliton Solution

To obtain a closed form solution of the G LM equation (51) we assume $(2 n+1 \mathrm{p}()=0)$. This is justi ed because our prim ary interest is to obtain the soliton solutions, which is obtained for the re ectionless potential. W e
also note that, substituting (44) in (6)we get a relation betw een the $K$ emels of the integral equations (51) and the 'potential' of the eigenvalue equation (6),

## 6 O ne soliton solution

The one soliton solution for (5) is obtained by choosing $\mathrm{N}=1$ in (56). It im plies from (54), that $2 n+12 n+1$ ( $j$ ) has a pair of zeros located sym m etrically about the im aginary line in the lower half-plane. W e assign them as ( 1 ; ${ }_{i}$ ), where ${ }_{1}=(+i)=2 \mathrm{w}$ th ; $>0$. By reinstating the transfor$m$ ations $(2,3,4)$ in $(56)$ we obtain the $k$ th com ponent of one soliton solution for (1), which is given as,

$N$ otioe that each com ponent of the soliton solution (62) is de ned com pletely x
by a set of four param eters viz, , , $p_{k 1}$, and $p_{j 1}$. It represents an envelope wave $m$ oving with a group velocity, ( $\left.\begin{array}{cc}2^{2} & 3^{2}+\frac{1}{12^{2}}\end{array}\right)$ undergoing intemal oscillation. Interestingly the group velocity depends on both real part ( ) and im aginary part ( ) of 1 . If we specialize to the scalar lim it of the CHNLS equation the solution (62) reduces to the one soliton solution of the Sasa-Satsum a equation (see Eqs 42. in [7]). In order to investigate the shape of the pulse we take the derivative of $\Psi_{k} \stackrel{\jmath}{\jmath}$ with respect to . This gives the follow ing conditions form axim a of $\mathrm{E}_{\mathrm{k}}{ }^{\text {J }}$,

It is clear from (67) that for $\dot{\mathcal{C} j}$ juch that 1 jcj 2 the solution has a single peak. Interestingly how ever, for $\dot{c} j \mathbf{j}>2$, there are two values (real) for $e^{2 A}$, that is (62) has two $m$ axim a. This corresponds to two peaks. A $s$ jंj increases further the two peaks gradually shifts apart from each other. Finally at jcj! 1 , that is, when the two zeros of $2 n+12 n+1$ merge on the im aginary line in the low er half-plane the solution (62) then reduces to,

It is im portant to note that the phase factor arises in (68) is purely from the variable transform ations $(2,3,4)$. The solution (68) represents an wave $m$ oving $w$ ith a group velocity, $\left({ }^{2}+\frac{1}{12}\right)$. Unlike the earlier case (62), the group velocity depends only on the real part of 1 . This is the solution reported in 21,22$]$. It is im portant to note that the shape of the solitons rem ains invariant with respect to space and time for all values of jcj. The two class of solutions obtained for 1SS m ay be extended straightforw ardly for N - soliton solutions.

## 7 C onclusion

In this paper we have studied the CHNLS equation by applying a generalized inverse scattering $m$ ethod developed to solve the ( $2 n+1 \quad 2 n+1$ ) dim ensional linear problem associated with (5) vis a vis (1). W e have show $n$
the integrability of the system by show ing the existence of in nite num ber of conserved quantities. T he N -soliton solutions for the system have been obtained by solving a set of generalized G LM equation. W e have shown two di erent class of solutions by considering the zero's of the diagonal elem ent of the scattering data on the im aginary line and a pair of zero's lying sym $m$ etrically about the im aginary line in the lower-half plane. By a suitably de ned param eter we have show $n$ how the double-peak solton reduces to the single peak soliton. T he results, we have obtaind predicts that C H N LS equation allow s dispersionless propagation of the ultrashort optical soliton in the shape of single hum p pulse or double hum $p$ pulse. T his m ay have interesting consequences in the propagation of optical solitons through nonlinear ber.
