Turbulence and T sallis Statistics

Fully-developed incompressible Navier-Stokes turbulence in three dimensions is a dissipative dynamical system that exhibits strong departure from absolute equilibrium. Nevertheless, several kinds of representation by T sallis equilibria have been proposed. The symmetry of the contributions to the kinetic energy from the degrees of freedom of the ow must be broken in order to construct turbulence applications. T sallis representations of turbulence involve the extrapolation of results for system s with a single degree of freedom, a procedure that requires critical examination. Theories of T sallis statistics for acceleration of uid particles are compared with computer simulations of the pressure gradient eld in the present paper. Applications of T sallis form ulations to statistics of longitudinal velocity di erences are analyzed. No avor of equilibrium statistics based on the kinetic energy can encom pass the dynamically fundam ental turbulent energy cascade, which requires correlation of triads of degrees of freedom at di erent scales.

1. IN TRODUCTION

The search for som ething that is maxim ized or minimized by turbulent ows extends back over more than a half-century. Non-extensive entropy has joined a varied set of candidates.

Fully developed in compressible Navier-Stokes (NS) turbulence is a dissipative dynam ical system with very m any degrees of freedom in a state of strong departure from absolute statistical equilibrium. The disequilibrium is expressed by several features. In isotropic NS turbulence in three dimensions (3D), the wavenum ber energy spectrum E (k) at high Reynolds num bers goes approxin ately like k $^{5=3}$ in the inertial range of k, which extends between the low k where any driving occurs and the high k where viscous dissipation is strong. In contrast, Boltzmann-Gibbs equilibrium based on kinetic-energy yields E (k) / k^2 . Moreover, there is strong energytransferring coupling within the inertial range between k that di er by a factor greater than 2. If one thinks of a tem perature local in k, this m eans strong coupling am ong degrees of freedom whose local tem peratures di er by a factor like 2.

In 1988 T sallis proposed a generalization of statisticalm echanics that can describe non-extensive statistical equilibrium, in contrast to other generalizations, like that of R enyi, that preserve the additivity of the entropies of independent subsystem s [1]. The B oltzm ann-G ibbs equilibrium is recovered as a limiting case. T sallis statistics have been formulated for a variety of system s including uid turbulence. The theoretical formulations for 3D N S turbulence assume isotropy. The results have been com – pared not only with approximately isotropic direct num erical simulation (DNS) but also with experiments that have more complex geometries. The key analysis typically is performed for systems very much simpler than turbulence: one-dimensional maps and dynamical systems consisting of a single degree of freedom that obeys a modi ed Langevin equation.

2. TSALLIS STATISTICS

A number of generalized de nitions of entropy have been proposed that reduce to Boltzm ann-G ibbs entropy in a limit. The entropy proposalby Renyi [1] was motivated by information-theoretic considerations. It yields additivity of the entropies of independent subsystems. T sallis statistics are based upon the entropy formula

where q is a parameter of the theory and the sum is over the probabilities p_i of states i that assign values to a complete set of real dynamic variables y_n .

If $q \in 1, S_q$ is not the sum of contributions from each i. Independent subsystem s give interlocked contributions to S_q , yielding non-extensive equilibrium p The lim it q ! 1yields the Boltzm ann form ula $S_q = p_i \ln p_i$.

Let E $_{\rm i}$ be the energy of state i. The extrem e value of S $_{\rm g}$ under the generalized energy constraint

is realized by the probabilities

Here k_B is an inverse temperature parameter whose value is determined by the value taken for U_q , k_B is Boltzmann's constant and

The Lagrange multiplier for the energy constraint is written in the form $(q \ 1)$ so that the limit $q \ 1$ yields the Boltzm ann-G ibbs values

Consider the case in which (a) each E_i is a sum of energy contributions e_n from the y_n ; (b) the dynamics conserve energy; (c) there is a Liouville property $_n @y_n = @y_n = 0$. In this case it is self-consistent to take uniform density of states in the phase space of the y_n . The Boltzm ann-G ibbs form ula (5) then yields an explicit result for the probability density function (PDF) of y_n :

If $q \in 1, E_i$ that are sum s of contributions from each y_n do not yield separation of the PDFs of distinct y_n . In most cases $P_n(y_n)$ can be obtained only by integration over all the $y_{m \ 6 \ n}$.

The particular case

is appropriate to a suitably constructed truncated representation of Euler or NS ow. In this case only, the constant energy surfaces are hyperspherical surfaces in the phase space of the y_n . The Boltzm ann form ula (6) im m ediately yields G aussian P_n (y_n).

If q 6 1, (3) and (7) yield complete symmetry in n. An explicit result for P_n can be extracted if, in addition, N ! 1 . Then the distribution of each y_n on the energy shell tends to the G aussian

The canonical distribution (5) is realized if the conservative system is put in contact with a heat bath and then removed. This implies unique stability properties for the canonical distribution that can be dem onstrated as follows. Consider two systems A and B that are initially independent with $PDFsP_A$ (E_A) and P_A (E_B) that are functions only of the system energies. The initial PDF for the combined system is then P_A (E_A) P_B (E_B). Now let the system s be coupled by arbitrary couplings that conserve the total energy $E_A + E_B$ and preserve the Liouville property. The condition that the total system PDF be invariant under these couplings is that the PDF keeps the form $P_A (E_A)P_B (E_B)$ and is time invariant. But since there are arbitrary couplings, the PDF must also have the form $P_{A+B} (E_A + E_B)$. Equality of these two form s has the canonical distribution as its unique solution, a fact easily veri ed by taking the derivative with respect to E_A and separately with respect to E_B , then rearranging term s.

T sallis q ϵ 1 statistics for a conservative system with Liouville property do not have the robust stability properties of the canonical distribution. A necessary condition for q ϵ 1 is that the system be isolated from its environm ent or the environm ent be specially constructed.

D issipation destroys the Liouville property. Equilibrium statistics can be extended to some dissipative systems, such as a single degree of freedom that obeys a Langevin equation with suitable relation between dam ping and random forcing. If particular assignments of effective energy are made, dissipation less equilibrium T sallis statistics yields exact PDFs for some dissipative systems. Exam ples of such systems, with a single degree of freedom, will be discussed in Sec. 4. NS turbulence at high R eynolds num bers is a dissipative system with m any strongly interacting degrees of freedom. In the forced steady state, the forced degrees of freedom are separated from those where the dissipation occurs by a multistage energy cascade. Any attempt to describe NS turbulence by equilibrium statistics must be considered courageous.

3. APPLICATION TO NAVIER-STOKES FLOW

An underlying fact is that the quadratic inviscid constants of motion give no hint of the rich dynam ics that emanate from the NS equation. For example there is nothing to imply the crucially important K elvin circulation theorem .

The exploration of the Boltzm ann-G ibbs and T sallis statistics of Sec. 2 for NS ow begins with the choice of a representation basis for the ow. There is an in nity of representation bases, constrained by the boundary conditions on the ow. The DNS to be described in what follows uses cyclic boundary conditions on a cube. This is appropriate for spatially hom ogeneous ow. The representation m ost im mediately suggested by hom ogeneity is expansion of the velocity eld into wavevector com ponents.

In order that the system be nite, the expansion can be truncated at a wavenum ber $k_{m\ ax}$ su ciently large com – pared to typical dissipation wavenum bers that excitation above $k_{m\ ax}$ can be neglected. The real variables y_n at each k are the am plitudes of the real and im aginary parts of the ow components perpendicular to k. The kinetic energy is given by (7) if the uid density is set to unity. O rthogonal transform ations yield other representations in which E_i is a sum of squares. O ne class of such bases is wavelets, which may be appropriate to describe the interm ittency of turbulent ow .

High Reynolds number turbulence maintained in statistically steady state by forcing at large spatial scales and viscous dissipation at much smaller spatial scales exhibits a cascade of energy through interm ediate scales, the inertial range. Energy cascade is the most fundam ental dynam ical feature of the turbulence. It is not a phenom enon of absolute equilibrium, whether Boltzmann-G ibbs or T sallis. Energy cascade requires nonzero triple correlations of the form $hy_n y_m y_r i$, where n;m;r label m odes with di erent wavenum bers or other scale labels. Such correlations are not produced by any avor of equilibrium statistics based on the kinetic energy: the kinetic energy is a sum of squares and is invariant under yn ! y_h. The characteristic times of the ow modes associated with energy cascade and other dynam ical features decrease with scale size but are nite at all scales.

In any representation where (7) holds, the results of Sec. 2 in ply that neither Boltzm ann-G ibbs nor $q \in 1$ T sallis statistics describes high R eynolds num ber turbulence. B oth statistics yield equipartition of kinetic energy am ong the degrees of freedom because of the symmetry of (7) in the y_n on each energy shell. An application of T sallis statistics to turbulence, viable in the sense of t-ting certain m odal PDFs, m ust break the symmetry over the degrees of freedom. In some work, individualized values of q and are invoked for subsets of the degrees of freedom and/or the kinetic energy is replaced by a m odied energy function that is di erent for di erent degrees of freedom.

D i erent q and values for two subsets of the ow degrees of freedom m ay possibly be justied as an approximation if the subsets have dynamical coupling suf-

ciently weak com pared to the strength of their internal dynam ics. If the subsets are ranges of wavevector am – plitudes in a hom ogeneous ow, both approxim ate theory and DNS suggest that this requires separation of the ranges by m ore than a decade in k. If som e weakness of coupling criterion is not satis ed, there is no justi cation for assigning di erent \mathbf{q} and \quad values to di erent degrees of freedom .

The turbulence PDFs that have been approximated in applications of generalized equilibrium statistics have shapes that are easy to t in a number of ways: the PDFs are smooth and nearly symmetrical with aring skirts. Justi cation of a t from turbulence dynamics is essential for the tting process is to be considered m eaningful.

The applications by A rim itsu and A rim itsu use the link between T sallis statistics and multifractals [2,3] to determ ine a single q < 1 value for the entire system, related to the interm ittency behavior associated with a multifractal turbulence model. The multifractal model describes interm ittency that increases with decrease of scale size. Multifractal models of turbulence have not been derived from the NS equation but they are supported by theoretical arguments and their parameters can be tuned to agree well with a variety of experimental measurements.

M any of the applications dealw ith velocity increments across spatial separations. Velocity increments do not constitute a representation basis for a ow. In contrast to the invertible transformation between, say, wavevector components and wavelet amplitudes, the transformation from the velocity eld in x space to sum s and di erences of velocities at two space points is overcom plete. If the velocity sum s are struck out, leaving only the increments, the transformation is not invertible. A nalysis that derives results by working with velocity increments rests on the implication of corroboration in a representation basis from which the velocity increments are constructed.

In Sections to follow, we shall exam ine several applications of T sallis statistics to turbulence. Before that, we shall sum m arize the behaviors of three system s with a single dynam ical variable for which T sallis statistics is exactly realized: anom alous di usion in an optical lattice [4], a Langevin equation with uctuating parameters [5] and sensitive nonlinear m aps [2,3].

4. TSALLIS STATISTICS FOR SINGLE VARIABLES

Lutz [4] nds that the di usion of momentum p in an optical lattice treated sem iclassically satis es the Langevin equation

where K (p), D (p), and dD (p)=dp are nonlinear nonstochastic functions of p and w (t) is G aussian noise with hw (t)w (t⁰)i = (t \bigcirc). The exact PDF in steady state that follows from (10) is

Here q > 1 and are found from D (p) and K (p); p^2 comes from the specic form sofK (p) and D (p); Z is the norm alization factor.

Lutz notes that the steady state described by (10) and (11) is not an equilibrium state and is not a well-de ned inverse tem perature.

Beck [5] has demonstrated that T sallis statistics with q > 1 are realized by a dynam ical system consisting of a degree of freedom that obeys a Langevin equation with uctuating parameters. Let y satisfy

where is a damping constant, is a strength parameter, and w (t) is unit white-in-time G aussian noise. The steady-state PDF of y is G aussian with variance 1 =, where $= = 2^{2}$.

Now suppose that and/or uctuate so that = 2 has a 2 distribution of degree n. This means that the PDF of is / ${}^{n=2}$ 1 exp (n =2 $_{0}$), where $_{0}$ is the mean value of . Assume that uctuates on time scales in nitely large compared to the O (1=) time required for y to reach equilibrium. Beck shows that the PDF of y has the form

In comparison with the form ulas of Sec. 2, y^2 plays the role of an energy.

A lthough (10) and (12) are dissipative equations, the PDFs (11) and (13) express T sallis non-dissipative equilibrium if the energy constraint is constructed with the required e ective energies.

C ertain classes of nonlinear one-dimensional maps have a kind of sensitivity to initial conditions, at the onset of chaos, that can be described by T sallis statistics. The grow th of sm all perturbations in initial conditions is not exponential but instead follows a power law that corresponds to a T sallis distribution with 1 > q > 0. Lyra and T sallis [2] nd that the critical attractor for several kinds of maps, including generalized logistic maps and the circle map, exhibits multifractal behavior in which the singularity strength has maximum and minimum values that are related to q in a T sallis distribution by

5. ACCELERATION OF FLUID ELEMENTS

The statistics of pressure forces, viscous forces, and the resulting acceleration of uid elements in incompressible

NS ow has drawn continuing attention form ore than 50 years [6[9]. The behavior of uid-element acceleration (acceleration along Lagrangian trajectories) can be obtained completely if the distribution of the velocity eld is taken to be G aussian with a speci ed spectrum. Suppose that the G aussian velocity eld is isotropic, with a wavenum ber spectrum that includes a long k $^{5=3}$ range followed by a rapidly falling dissipation range. Then the acceleration a is dom inated by pressure forces, which m ake a contribution

to the mean-square $ha^2 i$, where c_p is a number nom inally O (1), is the average dissipation per unit mass, and is the kinematic viscosity. The viscous forces make a contribution of the same form and nom inal magnitude, but the corresponding coe cient c_v is smaller than c_p by a large enough factor that a is strongly dom inated by the pressure-gradient contributions.

In realizations of approximately isotropic NS turbulence at large Taylorm icroscale Reynolds number R by DNS or experiment, interm ittency strongly a ects the distribution of pressure-gradient forces and causes a small deviation from the 5=3 energy spectrum exponent for the inertial range. The e ect on the pressure-gradient contribution to ha² i probably is to make c_p weakly dependent on the ratio $k_d = k_0$ of the dissipation and macro-scale wavenum bers. It is to be expected that the dom inance of pressure over viscous contributions to a is enhanced com – pared to the Gaussian case, especially for contributions to the tails of the PDF of a.

Beck [10] constructs T sallis statistics for the acceleration, with the conclusion that the normalized PDF of x = a=ha^2\,i^{1=2} is

The analysis uses a single variable u de ned as the difference in the velocity measured at two times along a uid-element trajectory. The time di erence is taken to be the order of the characteristic dissipation time $= (= \frac{1}{2})^{-2}$ of the 1941 K olm ogorov theory (K 41). The acceleration is measured as a = u = .

Beck models the dynamics of u by that of y in the Langevin equation with Gaussian and ² uctuating parameters whose analysis is summarized in Sec. 4. He states that an excellent t to experimental data on the PDF of a [11] and on ha²i [12] is obtained by taking q = 3=2 and using, instead of ⁰ in (13), an O (¹⁼²) parameter whose precise value is tuned. The choice q = 3=2 gives (17).




FIG.1. Lin-log plot of normalized PDFs of components of DNS pressure gradient at R = 381 together with Beck's ² and lognormal ts. The tails of the DNS PDF curves ta stretched exponential of form exp($jxj^{0.41}$).




FIG.2. Same as Fig. 1 but only the central regions of the PDFs are shown on a lin-lin plot.

In m ore recent work (private com m unication and [10]), a t to norm alized pressure gradient component data $x_i = p_i = hp_i^2$ i from approximately isotropic DNS at R = 381 [13] is made using log-norm alrather than ² statistics in (12). There is one tting parameter. The bold simplicity of (17) is lost, but the t is extended over the range to $P_x(x) = 10^{-12}$. The ² and log-normal ts are plotted with the DNS PDFs in Figs. 1 and 2. Fig. 2 shows that neither t is accurate in the central peak region, which contains most of the weight of $P_x(x)$.

A uctuating equilibrium environment, of which the log-norm al and 2 statistics are particular examples, is inconsistent with the turbulent energy cascade. See Sec. 8 for further discussion. The white-noise forcing in (12)

con icts with the fact that turbulence modes of given scale are principally driven by modes of larger scale that have nite and longer characteristic times.

The DNS pressure gradient curves agree well with experim ental acceleration data [11]m easured in the approxim ately isotropic central region of ow between counterrotating disks at reported R values of 200, 690, and 970. The experim ental data extend down to about 10 6 on the vertical axis.

A rim itsu and A rim itsu [3] derive an acceleration PDF from a multifractal cascade model. The starting point is (15), which they generalize to the form $1=(1 \quad q) = 1 = 1 = +$, where negative f() is admitted and (+) is the smaller (larger) zero of the multifractal spectrum f(). The spectrum f() is linked to that of a cascade model for isotropic turbulence. Speci cally,

A fterm statistically independent steps the probability P ^(m) () d to nd an eddy with singularity in the range to + d is determined as

The acceleration statistics are obtained from the scaling $p_m = p_0 = (r_m = r_0)^2$ ⁼³. Here p_m is the pressure

di erence across the distance $\mathbf{i}_m = 2 \ ^m \mathbf{i}_0$ and \mathbf{i}_0 is a turbulence m acroscale. The cascade is term inated at step n chosen so that $p_n = \mathbf{i}_n$ is expected to approximate the pressure gradient.

An additional element in the analysis is \thermal uctuations" that have a Gaussian or q > 1 T sallis distribution and are expected to dominate the acceleration PDF for small amplitudes. The total PDF is written as the sum of a contribution from the cascade up to step n and the \thermal uctuations" part. We do not nd a physical basis for the \thermal uctuations". If such uctuations existed, we would expect them to pervade space so that they add everywhere to the eld produced by the multifractal cascade. In that case, the PDF of the total eld would not be the sum of PDFs from the two contributions to the eld.




FIG.3. Lin-log plot of PDF of norm alized DNS pressure gradient component $p_x = hp_x^2 i^{1=2}$ at R = 381 compared with the PDF proposed for uid-element acceleration in [3]. Curves for cascade term ination step numbers of n = 20.9, 9.0, and 5.0 are shown. For these ts, = 0.210 and q = 0.3183.

W e have calculated acceleration PDFs from the com - bined multifractal and G aussian theory as presented in




FIG.4. Same as Fig. 3 but only the central regions of the PDFs are shown on a lin-lin plot.

[3]. The results are compared with DNS [13] of pressure gradient in Figs. 3 and 4 for n = 20.9, n = 9, and n = 5. The curves for these n values are obtained with = 0.210, q = 0.3183. R = 381 in the DNS.

The DNS is cyclic in each axis direction and the num -

ber of points in each direction is $2^{10} = 1024$. The largest possible value of '₀ pointing along an axis therefore is $2^9 = 512$ grid point spacings (this is a distance). Thus the upper limit for n is 9. In fact, this limit should

be reduced because the forcing extends from the lowest wavenum ber k = 1 to k = 6. The multifractal cascade consequently should be taken to start at no more than 512 = 6 209 grid point spacings.

There is substantial scale nonlocality in the turbulence coupling so that there must be a non-asymptotic region at the start of the assum ed multifractal scaling range. If we assume that this region starts at approximately 209 grid point spacings and extends for approximately 3 of the nom inal cascade halving steps, we get 5 as a plausible value of n. If R were increased to 1000, the inertial range would be extended by approximately two scale-size halvings.

A lthough the value n = 20.9 is not meaningful for the DNS, we show it because it gives optimum thing of the theoretical curve to the skirts of the DNS curve. We not that the optimum tobtained by tuning both and n is insensitive to variation of over the range 0.210 to 0.260 and a corresponding variation of n from 20.9 to 17.0. Over this range the resulting theoretical curve is alm ost invariant. There appears to be no way to bring the tails of the theoretical curve for n = 9.0 or n = 5.0 close to the DNS by tuning .

The best t stated in β] uses = 0.241, n = 182. This is almost identical with one of the ts we found (= 0.240, n = 18.0) in the parameter domain where the result is nearly invariant to tting changes. Note that n = 18 would correspond to 1/512 grid point spacing if γ_0 is given the maximum possible value of 512 grid point spacings.

The crucial parameter in the ts is the number of statistically independent cascade steps, which is the maximum value n of m in (19). In the preceding discussion, we have started with a maximum meaningful value of c_0 and assumed that the scale decrement in each cascade step is 1/2. Then n = 18 yields the meaningless minimum scale size 1/512 grid point spacing. A rim itsu & A rim itsu discuss two alternatives to force the minimum scale size to be the order of one grid point spacing with n = 18. One is to make c_0 much larger than the largest meaningful value of 512 grid point spacings. The other is to make the inverse of the scale decrement factor less than 2. It must be stressed that a factor of 2 is already is smaller than the scale ratio needed for approximate dynamical independence of ow modes.

6. SCALE DEPENDENT TSALLIS PARAM ETERS

K 41 im plies that velocity statistics associated with the succession of scales in the inertial range are similar. It has long been known from experiment and suggested by theoretical arguments that this is not the case. Instead, there is interm ittency that increases with decrease of spatial scale. One manifestation of the interm ittency is the behavior of the velocity structure functions, de ned as moments of order n of velocity di erences across a distance r. As r takes successively smaller values in the inertial range, the structure functions show an increasingly rapid grow th with n, in con ict with K 41 sim ilarity. The grow th of the structure functions expresses anom alous scaling exponents. A number of theoreticalm odels have been explored, but alm ost nothing has actually been deduced from the NS equation.

Beck has studied a series of models of the longitudinal velocity di erence u (di erence in the velocity component pointing along r). We shall consider them in more or less chronological order. In the rst of these models [14], the dynamics of u is related to a Langevin equation with non-stochastic damping and a stochastic forcing term :

Here f (t) is what Beck calls determ inistic chaotic noise with typical time scale 1=. The statistics of f is such that the PDF of u acquires a skewness. The actual qualitative physics of transfer into modes of given scale is that the transfer comes mostly from modes of larger scale with longer dynamical times. This con icts with

1= in the model equation (20). The result is that for c = R 1= \hat{a} the PDF of $\hat{a} = u = hu^2 i$ has the form

where q is a T sallis entropy parameter, q = q = 1, R is the Taylor m icroscale R eynolds number of the turbulence, and c is a positive O (1) constant. Higher-order terms in c prevent a change of sign of p(\hat{u}) at large negative \hat{u} and m ake p(\hat{u}) norm alizable. The value of is adjusted to give \hat{u} variance 1, which requires = 2=(5 3q) for large R .

How is (21) obtained from (20) and how is q determined? There are a number of steps. The small parameter is identied with 1=R by the following argument: since is a damping, it should be proportional to the underlying viscous damping coe cient ; correct dimensionality then requires a length scale, which is set equal to the Taylormicroscale , so that $p = \frac{2}{10} \cdot A$ lso it is assumed reasonable to take $= 1000 \cdot M^2 \cdot A$ how it is assumed reasonable to take $= 1000 \cdot M^2 \cdot A$ how it $P = \frac{1000}{R} \cdot M$ with c = 0 (1).

The parameter q 1 is set according to the number of cascade steps between r and the K 41 dissipation length $= ({}^{3}=)^{1=4}$. A cascade step is taken to be a factor of 2 in 1=r. This leads to

F inally O (1) is set to 1 because that is said to give agreement with experimental data.

Beck uses (21) to calculate m om ents of the norm alized velocity di erence \hat{u} (norm alized structure functions) and from them calculates scaling exponents for the norm alized structure functions.

Som e com m ents on (20) { (22): In K 41, the characteristic tim e at scale r in the inertial range is 0 $(r=v_r)$ where $v_r = (r=)^{1=3}v$ and $v = (\frac{1}{2})^{-4}$. The eddy damping rate, which m easures the rate of cascade to sm aller r, is 0 $(v_r=r)$. Scales in the inertial range see only the eddy damping and do not see . A physical cascade step m ust be m ore than a factor of 2 in 1=r; there is still substantial energy transfer at a factor of 4. The maximum number of e ective cascade steps was discussed in Sec. 5 and w ill be discussed further in Sec. 7.

The skewness $h\hat{1}^{3}i=h\hat{1}^{2}i^{3=2}$ is independent of r in the inertial range of K 41. It measures the rate of energy cascade. There is no dependence on R . Experiment and DNS indicate that the skewness is very nearly independent of r and R in actual interm ittent turbulence. The same conclusion comes from severalm odels of interm ittency, including the beta model and multifractalm odels [15].

W e noted in Sec. 3 that the energy cascade cannot be captured if the kinetic energy, which is a sum of squares in k or wavelet bases, is used in the T sallis form alism. In (21), skew ness is given to \hat{u} by adding linear and trilinear terms to the actual kinetic energy. This procedure requires exam ination.

Suppose that in (12) is non-stochastic but is stochastic and constant in time. Then the PDF of y is obtained by a weighted integration over the variance parameter of a G aussian PDF.Very wide classes of PDF can be generated in this way. See Sec. 8 for further discussion. A T sallis PDF with q > 1 is generated by ² statistics for $1 = {}^{2}$, as described in Sec. 4. No choice of weight function can give y a skewness. To obtain skewness, the weighted white noise w (t) must be replaced by a skew ed forcing with nite correlation time. This is taken as the f (t) of (20).

W e have di culty accepting the relation between turbulence and these manipulations with single-degree-offreedom models. Problem swith characteristic times have already been noted. The inclusion of skewness in the models seem s to be motivated by the empirical fact that the PDF of this skewed, rather than any dynamical link to turbulence structure.

In later work [16], (21) is modiled and the dependence on R is dropped; c^{p} R is replaced by c^{p} and it is stated that a match to experimentally measured skew – ness requires ^p to be about 0.1. It is stated that c may vary with the experiment and may depend on q. Also, it is implied that the variation of q with r needs to be determined a posteriori. An additional parameter is introduced yielding the elective energy

It is stated that < 1 corresponds to a fractal phase space, in analogy to the beta-m odel picture of active eddies con ned to a fraction of space.

The complicated theoretical apparatus thus constructed can give m atches to the norm alized PDFs of u measured in the central region of a Taylor-Couette ow at macroscale R eynolds num ber R = 540000. The ow is between a rotating inner cylinder and a stationary outer cylinder. The best ts are obtained by the empirical procedure of taking = 2 q, c^{2} = 0:124 (q 1), and then choosing q to give m in im um m ean-square deviation from the measured PDF.Once these expressions and c^{p} are xed, the only free parameter is q. for If the parameter is not invoked, the range of $1 = (q \ 1)$ needed for best ts to experim ental data increases and there is some loss of accuracy in the best ts. The range of q 1 used in thing the measured curves is from 0.055 at r = 14400 to 0.168 at r = 11:6, corresponding to a range of 1=(q 1) from 18.2 to 5.95. If the parameter is not employed, the range increases.

As already noted, the velocity di erence u does not belong to a valid representation basis for the ow. A nalysis with given q and must apply to appropriate m odes in a valid underlying basis. The implication is that the given q and must describe all statistics dom inated by those m odes, including but not limited to the statistics of transverse velocity di erences.

The modeling that yields (23) has been re ned [17] by appeal to extended self-similarity (ESS) to determ ine

and thereby reduce the number of fime parameters. C lose matches to experimental estimates of scaling exponents are obtained. An e ort in a dierent direction [18] nds that the T sallis entropies of subsystems can be made quasi-additive by adjustment of the q values for the subsystems. This leads to another formula for the variation of q with r.

We have two principaldi culties with models in which q varies with r. The rst is that the analysis appeals to uctuations of e ective equilibrium temperatures. Equilibrium temperatures, uctuating or not, are inconsistent with the dom inance, in the turbulence dynamics, of the strong and on-average unidirectional multistep energy cascade. The second di culty, noted in Sec. 3, is that modes whose scales di er by less than a decade have substantial dynamical coupling so that assigning them di erent q values seem s unjusti ed.

7. M U LT IFRACTAL ANALYSIS OF VELOCITY FLUCTUATIONS

A rim itsu and A rim itsu [3] use the relation of T sallis statistics to multifractal processes to develop a multifractal model of high R eynolds num ber isotropic turbulence that gives detailed predictions of scale-dependent statistics. In addition, scaling exponents of velocity differences and other properties are derived and com pared with the approxim ately isotropic DNS of [13]. O ther, em - pirically developed and tuned, multifractal models have previously been found to agree wellw ith a variety of measurem ents [19].

As noted in Sec. 5, the starting point of the analysis by Arim itsu and Arim itsu is the relation (15) between q and the extrem es of the multificatal spectrum f () of a one-dimensional nonlinear map that displays sensitivity to initial conditions. This relation is generalized and then applied to the multificatal spectrum of a turbulence model. An explicit value for q is found in terms of the interm ittency exponent of the model.

Some remarks on the physical nature of the inertialrange cascade: V iscosity is not felt directly at a scale r well within the inertial range. Instead the cascade of kinetic energy is characterised by a transfer rate (r).

(r) is not positive-de nite, and the DNS shows that it has a nite probability of negative values [13]. In contrast, all spatial averages of viscous dissipation are positive. This contrast is recognized in [19]. Finite timescales are associated with the cascade process at the scale r; there is not an instantaneous relation between cascade rate over a dom ain of size r and dissipation averaged over the dom ain. Moreover the energy cascade is su ciently di use that there is signi cant transfer at scale ratios 4 and larger.

A rim itsu and A rim itsu use the multifractal form alism described in Sec. 5 to t scaling exponents of velocity differences presented in [13]. Both longitudinal and transverse di erences are tted. They nd that an optimum t over a wide range of space intervals r is obtained by taking = 0:327 and n values that range from 21.5 to 4.00 for r= values that range from 2.38 to 1220.

Maximum admissible n values for various r= values follow from the discussion in Sec. 5. We noted there that the elective number of grid point spacings at the beginning of the unforced cascade range is 209; that there is substantial scale nonlocality in the turbulence coupling; and that there must be a non-asymptotic region at the beginning of the scaling range. Since in the DNS is approximately 1 grid point spacing, this leads to the conclusion that the maximum admissible n value for r is less than 9. Extension of this argument to other r values gives n = 8, 7, 6, 5, 4, 3, 2, 1, 0 as upper limits for r= = 1.95, 3.91, 7.81, 15.6, 31.3, 62.5, 125, 250, 500.

All of the n values used in the optimum thing in β] greatly exceed the maximum admissible n values given above. We are thereby stymied in considering further the ts to velocity-di erence statistics and scaling exponents of structure functions. We cannot assess the proposal that there are two multifractal scaling ranges separated by a crossover value of r.

8. CONCLUDING REMARKS

The inviscid conservation of kinetic energy in incom pressible 3D NS ow gives in portant inform ation about the energy cascade process at large R eynolds num ber and the associated skew ness of the velocity eld. Energy conservation fails to provide inform ation about higher statistics { in particular, the developm ent of interm ittency in the cascade. A number of mechanism s that a ect higher statistics are known. Vortex stretching implied by the Kelvin circulation theory and the existence of several kinds of instability play important roles. However, it is not known how to put all these things together into a deductive theory of turbulence statistics. Instead, there are a variety of m odels of higher statistics that have m eager or nonexistent deductive support from the NS equations but can be made to give good ts to experim entalm easurem ents.

A straightforward application of T sallis statistics to turbulence su ers the same basic limitation as Boltzmann-Gibbs statistics: the equilibria are based solely on the kinetic energy of the ow. It was noted in Sec. 3 that all the degrees of freedom enter sym m etrically into the kinetic energy and therefore are equally excited in equilibrium, whether Boltzm ann-G ibbs or T sallis. Two strategies that have been used to break the symmetry are the construction of e ective modal energies that dier from the actual kinetic energy and the use of di erent values of the nonextensivity parameter q for dierent parts of the system . Some of the work that uses these strategies is described in Secs. 5{7. As explained in Sec. 3, the result is no cascade of energy between groups of modes at dierent scales, whether or not skew ness appears in the PDFs.

A n absurd, but perhaps illum inating, manipulation of e ective energies that breaks the symmetry over modes can be performed within Boltzmann-Gibbs statistics. Any desired PDF $P_n(y_n)$ can be realized for a mode y_n by taking $q_i(y_n) = \ln P_n(y_n)$ in (6) to determ ine $e_n(y_n)$. $P_n(y_n)$ can be constructed to include skew ness, but again the result does not describe the energy cascade. Energy transfer requires nonzero correlations of form $hy_n y_m y_r i$, where n;m;r labelm odes with di ering wavenum bers or other scale labels.

Beck and his cow orkers treat velocity di erences across distances r as dynam ic ow variables, which they are not. A problem with their approach is that each velocity difference is modeled by a modi ed Langevin equation with white-noise forcing. This con icts with the fact that the driving of modes of given spatial scale is dom inated by modes of larger scale that have nite and longer characteristic tim es.

A rim itsu & A rim itsu generalize single-variable multifractal attractors for which T sallis statistics is exact and propose a link to multifractal turbulence models. A key quantity in the ts to DNS statistics is the number of nom inal\eddy size" halvings. Im pressive ts are made if this number is freely disposable, but they are destroyed if the number is limited to meaningful values.

The PDFs that have been tted in applications of T sallis statistics to NS turbulence have benign shapes: sm ooth and nearly sym metrical with aring skirts. Such shapes can be generated in many ways. For example, consider the ts to acceleration PDF exam ined in Sec. 5. With all questions of consistency and validity put aside, the fact is that both Beck and A rim itsu & A rim itsu present ts to the entire range of the DNS PDF. Yet the tting algorithm s and physicalm odels used by these authors are very di erent. Fits to PDFs of velocity increm ents, and scaling exponents, have been obtained from a variety of m odels constructed by Beck. M ore challenging would be shapes like the strongly asym metrical and sharply cusped PDF of velocity gradient in Burgers turbulence forced at low wavenum bers [20].

Beck and Cohen [21] consider general ensembles of Boltzm ann-M axwell distributions over which is itself stochastically distributed. The distributions explicitly exam ined include ² and log-norm al. If the energy is a sum of squares of modal am plitudes, the PDFs of mode amplitudes over such ensembles can be given protean shapes, with a smooth central peak and aring skirts, by adjusting the distribution. A wide variety of empiricalPDFs can be tted in this way. In order to make an application to cascading turbulence, the interaction of a mode like, say, a k or wavelet am plitude with the rest of the system would have to be modeled as an interaction with a heat bath whose uctuates. An ensemble of equilibria with heat baths is inconsistent with the energy cascade, in which there is a strong, on-average unidirectional, ow of energy from larger to smaller scales. Strong here m eans that the cum ulative m ean energy ow through, say, a double octave of wavenum bers in one bcal characteristic time is the order of the mean energy in the double octave.

M ultifractal cascade m odels raise the general issue of distinction between what is descriptive of physical behavior and what can be used for analysis of data. In [19] experimental data are analyzed to yield generalized dimensions D_p and the corresponding multifractal spectrum over the range 20 p 20. Then the multifractal model is tuned to give an optimum (and excellent) to the data. Multifractal models may or may not express well the cascade physics at large but nite R eynolds num - bers.
