The In uence of Quantum Field Fluctuations on Chaotic Dynamics of Yang {Mills System

A bstract

On example of the model eld system we demonstrate that quantum uctuations of non-abelian gauge elds leading to radiative corrections to Higgs potential and spontaneous sym metry breaking can generate order region in phase space of inherently chaotic classical eld system. We demonstrate on the example of another model eld system that quantum uctuations do not in uence on the chaotic dynamics of non-abelian Yang{Mills elds if the ratio of bare coupling constants of Yang{Mills and Higgs elds is larger then some critical value. This critical value is estimated.

A steady interest to chaos in gauge eld theories (GFT) 3 is connected with the facts that all four fundam ental particle interactions have chaotic solutions 9. There are a lot of footprints on chaos in HEP [12, 18], nuclear physics (energy spacing distributions) 6, 7, quantum mechanics (QM) [10].

O riginally phenomenon of chaos was associated with problems of classical mechanics and statistical physics. Substantiation of statistical mechanics initiated intensive study of chaos and uncovered its basic properties mainly in classical mechanics [13]. One of the main results in this direction was a creation of KAM theory and understanding of phase space structure of Hamiltonian systems. It was clarified that the root of chaos is local instability of dynamical system. Local instability leads to mixing of trajectories in phase space and thus to non-regular behavior of system and chaos (for review see [16, 22]).

Large progress is achieved in understanding of chaos in sem i-classical regim e of quantum m echanics [5, 19].

Investigation of stability of classical eld solutions faces di culties caused by in nite number of degrees of freedom. That is why authors often restrict their consideration by the investigation of some model eld con qurations 12, 1, 2.

There are papers devoted to chaos in quantum eld theory 4,15]. Nevertheless there is no generally recognized de nition of chaos for quantum systems in QM (beyond sem i-classical approximation) and QFT [7]. This fact restricts use of chaos theory in the eld of elementary particle physics.

It was analytically [21,20,14] and num erically [12,2] shown that classical gauge Yang { Mills theories (GYMT) are inherently chaotic theories. Particularly, it was shown for spatially hom ogeneous eld con gurations [] that spontaneous symmetry breakdown leads

to appearance of order-chaos transition with rise of density of energy of classical gauge elds 2, 20, 14], whereas dynamics of gauge elds in the absence of spontaneous symmetry breakdown is chaotic at any density of energy [21]. This conclusion was supported by studying the stability of topological solutions [12]. Study of chaos in classical GYMTs revealed several new problems. One of them is to understand the role of Higgs elds from the view point of their in uence on chaotic dynamics of classical gauge elds. It was demonstrated that classical Higgs elds regularize chaotic dynamics of classical gauge elds at low densities of energy and lead to appearance of order-chaos transition [12, 2]. The most of the results concerning chaos in GYMTs are obtained in classical theories. The question about chaotic properties of quantum GYMTs remains open. However, it was demonstrated that quantum uctuations of abelian gauge eld leading to spontaneous symmetry breaking via Coleman {Weinbergeect {} regularize chaotic dynamics of spatially hom ogeneous system of Yang{Mills and Higgs elds at small densities of energy [7].

In this Letter we demonstrate that the same elect takes place in the case of non-abelian gauge eld theory such as the theory of electroweak interactions. Namely, the \switching on "of quantum uctuations of vector gauge elds leads to ordering at low densities of energy, order-to-chaos transition with the rise of density of energy of gauge elds occurs (compare with [17]). This phenomenon escapes one's notion under classical consideration and thus we make the step to understanding the role of chaos in GYMTs. Also we note that if the ratio of the coupling constants of Yang (Mills and Higgs elds is larger than some critical value then quantum corrections do not a ect the chaotic dynamics of gauge and Higgs elds.

Consider SU (2) U (1) gauge eld theory with real massless scalar eld with the Lagrangian

Here denotes a self-coupling constant of scalar eld, g | self-coupling constant of non-abelian gauge elds, w is W einberg angle, A corresponds electro-m agnetic eld, W 1 , W 2 describe W -bosons and Z | neutral Z-boson.

W e used the following denotations

To study the dynam ics of classical gauge elds from the view point of chaos we use spatially hom ogeneous solutions [1]. Their dynam ics in the classical vacuum of scalar eld = 0 is chaotic at any densities of energy [21].

Situation qualitatively changes if we take into account quantum uctuations of vector elds. It is caused by the known fact that the state h i = 0 is not a vacuum state in this case. Here h i denotes vacuum quantum expectation value of scalar eld related with its classical vacuum value as follows h i = + quantum corrections. To nd a true vacuum of scalar eld in this case we use the method of the elective potentials.

One loop e ective potential generated by the Lagrangian 1) has the form (see also [11])

Where 2 is a renormalization constant. Here we took into account contributions of all Feynman diagrams with one loop of any (W_1 , W_2 , Z or A) gauge eld and external lines of Higgs eld. This potential leads to spontaneous symmetry breaking and non-zero vacuum expectation value of scalar – eld appears. Classical vacuum of scalar eld is = 0, but it is not so in quantum case, because of Coleman {Weinbergeect \$}].

In the case of the Lagrangian (1) it is known that vacuum state of the scalar eld becomes degenerated and hi \in 0 if we take into account quantum properties of gauge elds [1].

It is easy to calculate that the squared vacuum expectation value equals

Its existence qualitatively changes chaotic behavior of spatially hom ogeneous solutions in the quantum vacuum of scalar eld compared to pure classical consideration. Order-to-chaos transition occurs with the rise of density of energy of non-abelian gauge elds (see also [17]).

To demonstrate this in more evident form let us consider a simpli ed model system. Full consideration does not add any new physical content.

Wewill investigate elds of the following form

Here e_i^a are constant vectors. Other classical gauge—elds for simplicity are put to be equal to zero, but their quantum—uctuations are included and give contribution to the potential (2).

Lagrangian describing dynamics of the model eld system has the following form

Here p_1 , p_2 are momenta of gauge elds, $0 < \sin^2 < 1$ is a free parameter. In wence of quantum uctuations on the classical model eld con guration3) is taken into account in (4). Lagrangian of the classical (no quantum corrections) model system follows from (4) if one puts h $i_v = 0$.

To analyze dynamics of the system from the viewpoint of chaos we use well known technique [22, 23]. Particularly, we reduce equations of motion expressed in action-angle variables (for instance see [16]) to discrete mapping by angle variable—and calculate parameter of local instability $K = j \frac{1}{n+1} = n$ 1j de ned in [23] ($K > 1 \mid m$ otion is locally unstable and chaotic, $K = 1 \mid m$ otion is stable). Here $\frac{1}{n+1}$ and $\frac{1}{n}$ denote values of angle variable at $\frac{1}{n}$ th and $\frac{1}{n}$ the map

and detailed calculations can be found in [14] where model system (4) was considered in dierent physical context.

Let us put h $i_v=0$ (that corresponds to absence of gauge elds quantum uctuations). In this case, as it was claried in 21, dynamics of spatially homogeneous eld congurations in the classical vacuum of real scalar eld is always chaotic, at any, even small densities of energy. This conclusion agrees with the results of [2, 20, 14].

If vector gauge elds quantum uctuations are \switched on", and therefore h \downarrow 6 0, then parameter K can be calculated (see [14]) and equals

Here E is the density of energy of the spatially hom ogeneous model eld system (4). From (5) it follows that at small densities of energy motion is stable (K < 1). At large enough densities of energy motion becomes unstable and non-regular (K > 1). Thus if the density of energy of the model eld system increases, we obtain order-to-chaos transition. Critical density of energy E corresponding to this transition is given by the following expression

Thus at the densities of energy less than E $_{\rm c}$ dynam ics of the eld system is regular and at the densities of energy larger than E $_{\rm c}$ we obtain regions of unstable m otion and chaos in the phase space of the system .

We can conclude that quantum properties of gauge—elds are essential since they qualitatively change chaotic dynam ics of classical gauge—eld con gurations. Quantum gauge—eld—uctuations generated by the Lagrangian 1() lead classical non-abelian Y ang {Mills—elds to order at low densities of energy due to the same mechanism as it was demonstrated for abelian one [17]. Thus order-to-chaos transition missed under the classical consideration can be obtained if one includes quantum emechanism.

Sim ilar analysis can be made for boson sector of electro-weak theory including Higgs potential. In this case quantum corrections are considered against the background of the classical vacuum value of Higgs elds. Thus quantum uctuations of elds lead only to quantitative changes.

Starting from the Lagrangian (1) we build new model eld system including Yang {M ills and Higgs elds. We consider spatially homogeneous elds. For non-abelian gauge elds we use the same assumptions and denotations as in (4). In order to simplify the problem we put = 0 which means that the elds of W and W gauge bosons have the same linear polarization. Therefore the Hamiltonian of the model eld system has the form

Here p_1 and p_2 are momenta of gauge elds and p is a momentum of Higgs eld. Now we make the substitution $q_1 = r\cos'$ and $q_2 = r\sin'$. It is easy to see that ' is a cyclical variable and therefore its conjugate momentum $p_r = r^2'$ is a constant of motion. Ham iltonian (6) can be written is the form

Here p_r is a conjugate momentum of r. We neglected by the term $p_r^2=r^2$ compared to the term proportional to r^2 considering further classical Yang {Mills elds with high intensity. Using well known technique based on Toda criterion of local instability [20, 15] one can obtain that there is an order to chaos transition with the rise of the density of energy of the system. Critical density of energy (minus vacuum density of energy which is non-zero) is given by the following relation

Here the following denotations are used

If one does not take into account quantum corrections to H iggs potential it can be shown that the behavior of the system (7) is chaotic at any density of energy. From the expression (8) it is seen that E_c can be exponentially suppressed if the ratio of bare coupling constants of H iggs and gauge—elds is larger then some critical value. If this ratio is large enough E_c exponentially close to zero and one does not observe any order to chaos transition. O therwise, if the ratio of coupling constants is small enough, the critical density of energy given by the expression (8) have detectible value. Thus the magnitude of the critical density of energy strongly depends on the value of the ratio $=g^4$. Namely, if the following condition is true

then quantum radiative corrections to Higgs potential a ect the chaotic dynamics of the modelsystem. O therwise, at least one-loop e ective potential can not essentially regularize chaotic dynamics.

In conclusion, we demonstrated that quantum uctuations of non-abelian gauge elds leading to e ective potential of H iggs eld can regularize chaotic dynam ics of Y ang {M ills elds at low densities of energy. We showed also that if H iggs eld is considered as a dynam ical variable then under the conditions stated above quantum corrections do not a ect classical dynam ics of gauge and H iggs elds.

Quantum corrections are known to be important in the framework of QCD, where spontaneous symmetry breakdown is suggested to appear via Coleman (Weinberge ect.

Therefore we can expect that there is order-to-chaos transition in QCD at low densities of energy as it is described above.

It is known that classical chaos in unerces on quantum properties of the system, for instance, on the rate of quantum tunnelling (chaos assisted tunnelling), see [5] and references therein. Here we have demonstrated that inverse elect exists also. Quantum uctuations of the system can change its classical chaotic behavior.
