On dissipation less shock waves in a discrete nonlinear Schrodinger equation

It is shown that the generalized discrete nonlinear Schrodinger equation can be reduced in a small amplitude approximation to the KdV, mKdV, KdV (2) or the fith-order KdV equations, depending on values of the parameters. In dispersionless limit these equations lead to wave breaking phenomenon for general enough initial conditions, and, after taking into account small dispersion e ects, result in formation of dissipationless shock waves. The Whitham theory of modulations of nonlinear waves is used for analytical description of such waves.

### I. INTRODUCTION

D issipationless shock waves have been experimentally observed or their existence has been theoretically predicted in various nonlinear media { water [1], plasm a [2], optical bers [3], lattices [4]. In contrast to usual dissipative shocks where combined action of nonlinear and dissipation e ects leads to sharp jumps of the wave intensity, accompanied by abrupt changes of other wave characteristics, in dissipationless shocks the viscosity e ect is negligibly small compared with the dispersive one, and, instead of intensity jumps, the combined action of nonlinear and dispersion e ects leads to form ation oscillatory wave region (for review see e.g. [5]). Since intrinsic discreteness of a solid state system gives origin to strong dispersion, which can dominate dissipative e ects in wave phenomena, it is of considerable interest to investigate details of form ation of dissipation less shocks in lattices.

As a model, in the present paper we choose the general discrete nonlinear Schrodinger (GDNLS) equation

introduced by Salemo [6,7]. Eq. (1) turned out to be an important model not only because of its property to provide a one-param etric transition between an integrable Ablow itz-Ladik (AL) model and the so-called discrete nonlinear Schrodinger (DNLS) equation ( = 1 and = 0, respectively), but also because of a number of physical application for a review of which we refer to [8].

Obviously, (1) has a constant am plitude solution  $q_n = 0$ . It was shown in [9, 10], that in a small am plitude, jaj and long wave (so that the discrete site index n can be replaced by a continuous coordinate x) limit, evolution of small am plitude perturbations with respect to this constant background,

is governed by the Korteweg-de Vries (KdV) equation for the amplitude a (x;t):

which is written in the reference system moving with velocity  $2^{p}$   $1^{-2}$  of linear waves in dispersionless lim it. It is well known (see, e.g. [1]) that if the initial pulse is strong enough, so that the nonlinear term dominates over the dispersive one at the initial stage of the pulse evolution, then the dissipationless shock wave develops after the wave breaking point. The theory of such waves, described by the KdV equation, is well developed (see, e.g. [5]). Existence of the respective shock waves for model (1) has been predicted analytically and observed in numerical simulations in [9, 10]. Moreover, as it is shown in [11] a nonlinear Schrodinger equation of a rather general type can bear \KdV-type" shock waves. In this context the results presented below in the present paper although being mostly related to model (1) display some general characteristic features of a lattice of a nonlinear Schrodinger type.

The coe cients of (3) depend on two parameters and and can vanish at special choice of these parameters, so the KdV equation looses its applicability for these values of and . Physically acceptable values of and are limited by the inequalities




FIG. 1: Diagram showing dierent continuous limits of the GDNLS equation. The abbreviations are explained in the text.

the coe cient before the nonlinear term in (3) vanishes. This means that implied in derivation of the KdV equation approximation limited to only quadratic nonlinearities fails and higher nonlinearities have to be taken into account for accurate description of the wave dynamics. Hence, one may expect that the modied KdV (mKdV) equation with cubic nonlinearity arises for values of and related by 5).

the coe cient before the dispersion term in (3) vanishes what means that higher order dispersion elects have to be taken into account. In this case one may expect that evolution equation for a (x;t) contains quadratic nonlinear term and linear dispersion term with fith-order space derivative of a (x;t).

The most interesting point corresponds to the values

when both nonlinear and dispersion coe cients vanish. Since Eq. (1) with = 1 coincides with the completely integrable Ablow itz-Ladik equation, one may expect that in a small amplitude approximation this equation with the parameters equal to (7) reduces again to a completely integrable equation. The KdV equation (3) with = 1 is valid for all interval 0 < 1 except for some vicinity of the point  $= \frac{1}{3}$ , and therefore one can suppose that at the point (3) one has to obtain the second equation of the KdV hierarchy KdV (2) in which the higher order nonlinear and dispersion elects play the dominant role.

The aim of this paper is two-fold. At rst, in Sec. II we derive the evolution equations for the whole region (4) and show that along the line (5) the small-amplitude approximation reduces to the mKdV equation (Sec IIB), along the line (6) to a nonlinear equation with the dispersion of the fih-order (Sec IIC), and at the point (7) to the KdV (2) equation (Sec IID). The last result sheds some new light on the nature of higher equations of the KdV hierarchy they arise as small amplitude approximations to completely integrable equations, if lower orders of nonlinear and dispersion contributions vanish at some values of the parameters of the equation under consideration.

The second aim of the paper is to develop a theory of shock waves (Sec III) for the m K dV (Sec IIIA) and K dV (2) (Sec IIIB) equations analogous to that developed earlier for the K dV equation. This theory perm its one to described in details the behavior of shocks after the wave breaking point for dierent values of the parameters entering into Eq. (1). The results are sum marized in Conclusion.

### II. SM ALL AM PLITUDE APPROXIM AT ION

U sing ansatz (2) and replacing a discrete index n by a continuous variable x, we rew rite Eq. (1) as

In the linear approximation, this equation yields for the harmonic wave solution

where expansion in powers of K corresponds to taking into account di erent orders of the dispersion e ects. In the lowest order, when the dispersion e ects are neglected, linear waves propagate with constant velocity

To evaluate contribution of small (for jaj ) nonlinear elects, it is convenient to introduce a small parameter " a and pass to such scaled variables in which nonlinear and dispersion elects make contributions of the same order of magnitude into evolution of the wave. Since the choice of these scaled variables depends on values of the parameters, we shall consider the relevant cases separately.

A. KdV equation

For the sake of completeness we start by reproducing brie y some results of [9]. We expand a (x 1;t) and (x 1;t) into the Taylor series around x, introduce scaling indexes

where we have chosen the upper sign of v in (12), and in the next order the K dV equation (3) written in terms of the scaled variables. The nonlinear term changes its sign at (5) and the dispersion term changes its sign at (6). Hence, there can be as bright solitons against a background (a (x;t) > 0) or dark solitons (a (x;t) < 0) of the GDNLS equation approximated by the K dV equation (3). In both cases it is possible to pass to new dependent variable

B. m K dV equation

At = 3-4 the quadratic nonlinearity in Eq. (3) becomes zero and in order to describe the wave in the vicinity of the breaking point the scaling should be chosen to take into account cubic nonlinearity which is now must have the same order of magnitude as  $a_{xxx}$ ,

Here the nonlinear term can be obtained from the corresponding term in the KdV equation (3) by substitution of (6) and dispersion term reproduces the expansion of the dispersion relation (9) at the same value of .

At the point (7) both the quadratic nonlinear and  $\,$  rst order dispersion terms disappear, so that now the cubic nonlinearity must be of the same order of magnitude as a  $^{(V)}$ ,

As one should expect, the main nonlinear term here coincides with that of the m K dV equation (20) at the point (7), and linear dispersion term with the corresponding term of the fith-order K dV equation (28) at the same point.

Thus, the completely integrable AL equation reduces in the small amplitude approximation either to the KdV equation beyond some vicinity of the point (7), or to the second equation of the KdV hierarchy at the point (7), so that approximate equations remain completely integrable in both cases. This observation suggests that the property of complete integrability preserves in framework of singular perturbation scheme, which is a known phenomenon (see e.g. [13]). Then higher equations of some hierarchy may arise as approximate equations. This happens if at some values of the parameters of the underline completely integrable problem nonlinearity and, hence, dispersion of lower equations of the hierarchy vanish. This phenomenon can be viewed as physical meaning of the higher equations of hierarchies of integrable equations.

#### III. DISSIPATIONLESS SHOCK WAVES

In dispersionless lim it when dispersion e ects can be neglected compared with nonlinear ones, all derived above equations reduce in the leading approximation to the Hopf-like equation

where n=1 for the K dV and fth-order K dV equations and n=2 for m K dV and K dV (2) equations. It is well-known (see, e.g. [5]) that Eq. (33) with general enough initial condition leads to form ation of the wave breaking point after which the solution becomes multi-valued function of x. This means that near the wave breaking point one cannot neglect the dispersion elects. If we take them into account, then the multi-valued region is replaced by the oscillatory region of the solution of the full equation. This oscillatory region is called dissipationless shock wave and its analytical description is the aim of this section.

Existing theory of dissipation less shock waves can be applied in principle to completely integrable equations only. Among equations derived in the preceding section, however, fith-order KdV equation (28) does not belong to this class. Fortunately, just this case of zero rst-order dispersion was studied numerically in [9, 10]. We also bear in mind that the dissipation less shock waves of the KdV equation are already described in literature (see e.g. [5]). Therefore we shall not consider this equation here and concentrate our attention on the completely integrable models.

The analytical approach is based on the idea that the oscillatory region of the dissipationless shock wave can be represented as a modulated periodic solution of the equation under consideration. If the parameters dening the solution change little on a distance of one wavelength and during the time of order of one period, one can distinguish two scales of time in this problem { fast oscillations of the wave and slow change of the parameters of the wave. Then equations which govern a slow evolution of the parameters can be averaged over fast oscillations what leads to the so-called W hitham equations [1] and their solution subject to appropriate initial and boundary conditions describes evolution of the dissipationless shock wave. This approach was suggested in [12] and now it is well developed for the K dV equation case (see, e.g., [5]). The results of this theory can be applied to shocks in G D N LS equation when it is reduced to the K dV equation (3) or (16). Since this theory is presented in detail in [5], we shall develop rst analogous theory for the m K dV and K dV (2) equations and after that compare the results obtained for different equations.

# A. Dissipationless shock wave in the m K dV equation (21)

At rst we have to express a periodic solution of the m K dV equation (21) in a form suitable for the W hitham modulation theory. Such a form is provided automatically by the nite-gap integration method which is used here to nd the one-phase periodic solution of the m K dV equation.

The nite-gap integration method (see, e.g. [5]) is based on the complete integrability of the mKdV equation, following from a possibility to represent this equation as a compatibility condition xt = tx of two linear systems

Now our task is to consider the solution of the mKdV equation after the wave-breaking point. As it follows from (20), before this point in dispersionless approximation the evolution of the pulse obeys the Hopf equation




FIG. 2: Form ation of multi-valued solution of the m K dV equation in dispersionless limit (58). The initial data correspond to the cubic curve  $x = (u^2 - u_b^2)^3$  (see Eq. (60)).

Hence, in its vicinity we can represent (59) as

$$x + 6u^2t = (t^2 + t_2^2)^3;$$

where  $u_b = u(x_b; t_b)$ . Note that the mKdV equation is not Galileo invariant and therefore we cannot eliminate the constant parameter  $u_b^2$ , in contrast to the case of aKdV equation (see, e.g. [5]).

For t>0 solution (60) becomes multi-valued function of x. Form ation of this multi-valued region is shown in Fig. 2. For t = 0 we cannot neglect dispersion and have to consider full m K dV equation. Due to elect of dispersion the multi-valued region is replaced by the region of fast oscillations which can be represented as a modulated periodic solution of the m K dV equation (21). We rewrite this solution [see Eqs. (52), (53)] in terms of the slow by varying functions  $r_i(x;t)$ , i=1;2;3,

w here

and functions  $r_i$  (x;t) are governed by the W hitham equations (56). We have to nd such solution of these equations that the region of oscillations m atches at its end points corresponding to m=0 and m=1 to the dispersionless solution (60) which we rewrite in the form

$$x + 6rt = (r r)^3; r = u^2; r_b = u_b^2;$$

This means that the solution of Eqs. (56) written in implicit form

m ust satisfy the boundary conditions

Then, as we shall see from the results, m can values of u will m atch at these boundaries to the solution of dispersionless m K dV equation.

To nd the solution (64) subject to the boundary conditions (65), (66), we shall follow the method developed earlier for K dV equation (see, e.g. [5]). We look for  $w_i$  in the form similar to (56),

and nd that W satis es the Euler-Poisson equation

For our aim it is enough to know a particular solution of this linear equation  $W = \text{const} = \frac{p}{P(r)}$ , where P(r) is a polynom ial with zeroes  $r_i$  and it can be identified with polynom ial (39) with taking into account Eqs. (55). The series expansion of this solution in inverse powers of r,

can be considered as generating function of sequence of solutions,

where  $s_1; s_2; s_3$  are the coe cients of the polynom ial (39) expressed in term s of  $r_1; r_2; r_3$ :

It is easy to nd that the resulting velocities

Thus, we see that if we take




FIG. 3: Dependence of the Riem ann invariants  $r_1$ ;  $r_2$ ;  $r_3$  on x at some xed value of time. The plots are calculated according to formulae (64) with  $r_b$  = 5 and t = 0.5. A dashed line represents the dispersionless solution which matches the Riem ann invariants at the boundaries x of the region of oscillations.

then formulae (64) satisfy all necessary conditions and de ne dependence of  $r_1$ ;  $r_2$ ;  $r_3$  on x and t in implicit form. In Fig. 3 we have shown the dependence of  $r_1$ ;  $r_2$ ;  $r_3$  on x at t=0.5 and  $r_b=5$ . It is clearly seen that  $r_2$  and  $r_1$  coalesce at the right boundary  $x_+$ , where m=1, and  $r_2$  and  $r_3$  coalesce at the left boundary  $x_+$ , where m=0. D ispersionless solution is depicted by dashed line and  $r_1$  m atches this solution at  $x_-$  and  $r_3$  m atches it at  $x_+$ .

Let us not the laws of motion x (t) of the boundaries of the region of oscillations. At the right boundary we have the condition

$$\frac{\mathrm{dx}}{\mathrm{dr}_1} = \frac{\mathrm{dx}}{\mathrm{dr}_2} = 0; \tag{77}$$

which yields the expression

and substitution of this expression into Eqs. (64) with  $r_1 = r_2$  gives the coordinate  $x_+$  expressed in terms of the R iem ann invariants  $r_1$  and  $r_3$ :

On the other hand, this value of  $x_+$  must coincide with coordinate obtained from the dispersionless solution (63) with tequal to Eq. (78),

C om parison of these two expressions for  $x_+$  yields the relation between  $r_1$ ;  $r_2$  and  $r_3$  at m=1:

Substitution of  $r_1$  obtained from this equation into Eq. (78) gives

$$t = \frac{3}{20} (r_3 r_5)^2$$

and again with the use of Eq. (81) we obtain

These formulae give values of the Riem ann invariants at the right boundary as functions of time t. Their substitution into (79) or (80) yields the motion law of the right boundary

In a sim ilar way at the left boundary x the conditions

yield

which substitution into Eqs. (64) and (63) gives, respectively,

Substitution of these formulae into (88) or (89) yields the motion law of the left boundary




FIG. 4: Dependence of coordinates x of boundaries of the region of oscillations on time for the mKdV equation case.




FIG. 5: The dissipationless shock wave for the m K dV equation. The parameters are equal to  $r_b = 5$  and t = 0.5. The dashed line represents the squared roots of the R iem ann invariants which m atch the smooth solution  $u\left(x;t\right)$  of the dispersionless equation at the boundaries of the region of oscillations.

The plots of  $x_+$  (t) and  $x_-$  (t) are depicted in Fig. 4. To the right from  $x_+$  (t) and to the left from  $x_-$  (t) the wave is described by the dispersionless solution (63). Between  $x_+$  (t) and  $x_-$  (t) we have the region of fast oscillations represented by Eq. (62) with  $r_i(x;t)$ , i=1;2;3; given in plicitly by Eqs. (76). The dependence of u on u at some u and u of u on ent of time is shown in Fig. 5. It describes dissipationless shock u ave connecting two u on ooth regions u here u can neglect dispersion u ects. At the right boundary the periodic u ave tends to a sequence of separate dark soliton solutions of the u K dV equation and at the left boundary the amplitude of oscillations tends to zero.

## B. Dissipationless shock wave in the KdV (2) equation (32)

The theory of dissipation less shock wave for the K dV (2) equation is similar to that for the K dV and m K dV cases. Therefore we shall present here only its main points.

The periodic solution of K dV (2) equation has the same form as in K dV equation case (see, e.g. [5]),

$$u(x;t) = r_2 + r_3$$
  $r_1 = 2(r_2 - r_1)sn^2$   $r_3 = r_1 + r_3 = r_2 + r_3 = r_3 + r_4;$  (95)

with phase velocity

$$x V t$$
;  $V = 2s \frac{3}{2}s_1^2$ ; (96)

corresponding to the second equation of the KdV hierarchy.

Now the periodic solution (95) is param eterized by the R iem ann invariants  $r_i$ , i = 1;2;3; rather than by their squared roots, as it was in m K dV equation case. Hence, the solution of the dispersionless equation

$$u_{t} = \frac{15}{2}u^{2}u_{x} \tag{97}$$

near the wave breaking point should be taken in the form

$$x + \frac{15}{2}u^2 = (u \quad y)^3$$
: (98)




FIG.6: Form ation of multi-valued solution of the K dV (2) equation in dispersionless limit (97). The initial data correspond to the cubic curve  $x = (u \ u_b)^3$  (see Eq. (98)).

In fact, this form is equivalent near the wave breaking point to the solution (60), since  $(u^2 u_b^2)' 2u_b(u u_b)$  and the constant factor can be scaled out. Form ation of multi-valued region is illustrated in Fig. 6. A first taking into account the dispersion exception of the dissipation less shock wave.

W ithin the shock wave we have modulated periodic solution (95) where  $r_i$  are slow functions of x and t and their evolution is governed by the W hitham equations (56) with V de ned by Eq. (96). Their solution subject to the necessary boundary conditions can be found by the same method as was used in the preceding subsection. As a result we obtain




FIG. 7: Dependence of the Riem ann invariants  $r_1$ ;  $r_2$ ;  $r_3$  on x at some xed value of time for the KdV (2) equation case. The plots are calculated according to formulae (99) with  $u_b = 0.5$  and t = 0.25. A dashed line represents the dispersionless solution which matches the Riem ann invariants at the boundaries x of the region of oscillations.

$$x w_i^{(2)} t = u_b^3 + \frac{1}{2} u_b^2 w_i^{(1)} \frac{2}{5} u_b w_i^{(2)} + \frac{4}{35} w_i^{(3)}; (99)$$

where  $w_i^{(n)}$  are defined by formulae (70){(72). Equations (99) define implicitly the dependence of the Riemann invariants  $r_i$ ; i = 1;2;3; on x and t. The resulting plots are shown in Fig. 7. At the right boundary  $x_+$  we have soliton  $\lim_{x \to \infty} it$  (m = 1) and at the left boundary x we have a wave with vanishing m odulation.




FIG. 8: Dependence of coordinates x of boundaries of the region of oscillations on time for the KdV (2) equation case.

# IV. CONCLUSION

We have shown that GDNLS equation with nite density boundary conditions can be reduced, depending on values of the parameters—and—, to several important continuous models KdV, mKdV, KdV (2) and—fth-order KdV—equations which describe dierent regimes of wave propagation in nonlinear lattice (Salemo model). The KdV (2) equation appears at such values of the parameters for which nonlinear and dispersive terms in in the KdV equation vanish, so that the main contribution in smallam plitude long wave approximation is given by the third order nonlinear and—fth-order dispersion—e ects. This point correspond to the AL equation case, and since the AL equation is completely integrable and multi-scale method preserves complete integrability, we arrive at the second equation of the KdV hierarchy. This observation explains physical meaning of higher equations of integrable hierarchies they give main contribution into wave dynamics if lower order e ects vanish in small amplitude approximation of initial integrable equation.

The evolution equations obtained as approximations to the GDNLS equation lead in dispersionless limit for general enough initial pulses to wave breaking so that taking into account small dispersion e ects leads to formation of




FIG. 9: The dissipationless shock wave for the K dV (2) equation. The parameters are equal to  $u_b = 0.5$  and t = 0.25. The dashed line represents the R iem ann invariants which m atch the smooth solution u(x;t) of the dispersionless equation at the boundaries of the region of oscillations.

dissipationless shock waves. We have developed the theory of these waves in fram ework of W hitham averaging method. Analytical expressions are obtained which describe their main characteristics trailing and leading end points, am plitudes and wavelengths.

The phenom ena described in the present paper are not restricted by the GDNL, but are characteristic features of a large class of nonlinear Schrodinger lattices, which depend on one or more free parameters.
