Geometric Analysis of Bifurcation and Symmetry Breaking in a Gross-Pitaevskii equation

A bstract

G ross-P itaevskii and nonlinear H artree equations are equations of nonlinear Schrödinger type, which play an important role in the theory of B ose-E instein condensation, R ecent results of A schenbacher et al [3]dem onstrate, for a class of 3 dimensionalm odels, that for large boson number (squared L^2 norm), N, the ground state does not have the symmetry properties as the ground state at sm all N. We present a detailed global study of the symmetry breaking bifurcation for a 1 dimensionalm odel G ross-P itaevskii equation, in which the external potential (boson trap) is an attractive double-well, consisting of two attractive D irac delta functions concentrated at distinct points. U sing dynam ical system smethods, we present a geometric analysis of the symmetry breaking bifurcation of an asymmetric ground state and the exchange of dynam ical stability from the symmetric branch to the asymmetric branch at the bifurcation point.

1 Introduction

The experimental realization of Bose-E instein condensation has given great in – petus to the study of the Gross-P itaevskii and nonlinear Hartree equations. These are equations of nonlinear Schrödinger (NLS) type, with a potential having both linear and nonlinear parts. Such equations arise in the study of large dilute system s of bosons; N-body quantum mechanics of coupled bosons, where N tends to in nity and the coupling strength tends to zero, [4, 11, 5, 1]. Of fundamental interest are the properties of the ground state of such systems.

B ecause of the nonlinearity, the ground state can exhibit non-trivial transitions in structure.

Indeed, that such a transition takes place was established in the recent paper $[\beta]$. They consider the nonlinear H artree energy functional

Here, v(x) is an external potential (the boson trap), and V (x) is the two-body C oulom b interaction potential V (x) = jkj^{1} between bosons. The ground state of a system of N bosons is characterized by solution to them inim ization problem

For spatial dimensions d 2 and the case in which g < 0 is xed, corresponding to attractive interatom ic forces (negative scattering length), it is shown that for a class of potentials v(x), e.g., the double well potential, that if N is su ciently large, then symmetry breaking in the ground state occurs, in the sense that the ground state of (1.2) does not have the same symmetries as v(x). The proof in [3] is based upon the intuition in the double well case, for example, that for small amplitude states (N small) the nonlinear potential is negligible, and therefore the ground state should be a small distortion of the linear ground state (g = 0), and have the same symmetries as the linear ground state. However, by careful construction of trial functions, one can see that for N su ciently large, N > N thresh, it is energetically preferable for the ground state to be concentrated in one well or the other, but not equally in both.

The size of N $_{\rm thresh}$ and the dynam ical stability properties of the various coexisting states (sym m etric and asym m etric) is unaddressed. In this work we address these questions in the context of the sim plerm odel, the one-dim ensional G ross-P itaevskii equation (G P/NLS)

Sym m etry breaking bifurcations have been observed in this model [6] and in the analogous double square wellm odel [12], by piecew ise analytical solution in

terms of hyperbolic secant and Jacobi elliptic function solutions of the translation invariant NLS equation (v = 0), followed by numerical solution of the nonlinear algebraic equations resulting from the required continuity and jump conditions at singular points of the equation's coe cients.

W e present a sim ple geom etric analysis dem onstrating

(A) the symmetry breaking of the ground state, as a bifurcation of an asymmetric branch of solutions from the branch of symmetric solutions

and

(B) the exchange of dynam ical stability from the symmetric branch to the asymmetric branch. In particular, beyond the bifurcation point the symmetric state is linearly exponentially and nonlinearly unstable, whereas the asymmetric state is nonlinearly orbitally stable.

W e note that our analysis does not require the speci c cubic nonlinearity and is applicable for general local nonlinearities, where j \hat{j} is replaced by f (j \hat{j}), with f () of a general class.

A bifurcation diagram showing the symmetric, antisymmetric and asymmetric states is presented in gure 1. The solid curve corresponds to the nonlinearly stable ground state. As is increased (2 is the frequency) the symmetric solution becomes unstable at the bifurcation point, while the new asymmetric state is nonlinearly stable. We expect that anti-symmetric states (nonlinear excited states), corresponding to points on the disconnected branch to the left of the symmetric branch, are unstable to generic perturbations due to a nonlinear resonance phenomena, and that for large t, the system's energy resides in the ground state and radiation modes; see, for example, [14, 15].

2 Overview of Gross-Pitaevskii / NLS

In appendix A we review the well-posedness theory of (1.3, 1.4). The initial value problem is well-posed in C⁰ (R¹; H¹ (R¹)).

In this section we focus on nonlinear bound states of (1.3). These are solutions of the form :

For the linear Schrödinger equation, the functions are eigenstates of a Schrödinger operator: $\theta_x^2 + v(x)$ and satisfy the equation

In the case where v(x) is given by (1.4), with L su ciently large, the set of bound states is two-dimensional, spanned by symmetric and antisymmetric functions.




Figure 1: A bifurcation diagram is given for the case = 1, L = 2. The curve on the left bifurcating from N = 0 represents the antisym metric pulse, whereas the curve on the right represents the sym metric pulse. At the threshold value N thresh, an asym metric pulse bifurcates from the sym metric pulse. At N levels where the asym metric pulse is present, the sym metric pulse is unstable.

For (1.3), nonlinear bound states satisfy the equation

For the translation-invariant case, v = 0, there is a well-known fam ily of solitary (\soliton") traveling wave solutions. These are G alilean boosts (see (A 2)) of the basic solitary (\soliton") standing wave with hyperbolic secant spatial prole. For a non-trivial potential v(x) as in (1.4), the equation is no longer translation-invariant and we have \defect" or \pinned" states. These pinned nonlinear bound states are plotted in the bifurcation diagram of gure 1. In the translation invariant case, v = 0, the nonlinear bound states reduce to the branch of NLS solitons, bifurcating from the zero state at zero frequency, the endpoint of the continuous spectrum of the linearized operator θ_x^2 about the zero state. For v(x) nontrivial, there is a fam ily of defect states, bifurcating from the zero state at each linear eigenfrequency of the linearized operator,

 ℓ_x^2 + v(x) and in the direction of the corresponding eigenfunction; see [13] for a general discussion.

Stability of nonlinear bound states: An important characterization of the nonlinear bound states is variational. The advantage of the variational characterization is that it can be used to establish nonlinear stability of the ground state; see [18, 13].

Theorem 1. (I) Nonlinear bound states can be constructed variationally by minimizing the Hamiltonian, H, subject to xed L^2 -norm, N:

Such m in imizers are called nonlinear ground states, $_{\text{Def}}()$. The associated frequency, $^{2}()$, arises as a Lagrange multiplier for the constrained variational problem (2.4). As $! 0, ^{2}()$ tends to the ground state eigenvalue of $\ell_{x}^{2} + v(x)$.

(II) G round states are H 1 nonlinearly orbitally Lyapunov stable, i.e., if the initial data are H 1 close to a soliton (m odulo the phase and translation symmetries of GP / NLS), then the solution remains close to a soliton in this sense for all t2 (1;1).

A lthough, the above theorem establishes the ground state as a dynam ically stable state, it leaves unaddressed the question of detailed spatial characteristics of the ground state. As we shall now see, dynam ical systems m ethods can, in som e cases, be used to study this question globally and in detail.

3 Nonlinear bound states - dynam ical system s approach

D ynam ical system s m ethods are particularly well-suited to studying the existence and nature of nonlinear bound states for the one-dimensional problem (1.3, 1.4), since the equation is piecew is autonom ous. In particular, we study

A search for bound states (standing waves) in this system can then be undertaken as follows:

- Since any standing wave must decay as z ! 1, a potential standing wave solution must originate (in the phase plane) along the global unstable manifold of (0;0). W ithout loss of generality, we consider only the portion of this manifold that lies in the rst quadrant.
- 2. When this solution approaches the rst well at z = L, we may shift z so that the point $\lim_{z_1} L(u(z); v(z))$ can be chosen anywhere along the unstable manifold. (The value of u(L) can be thought of as a shooting parameter.) At this chosen point, the solution jumps vertically according to the matching conditions for v.
- 3. A fler completing the vertical jump at z = L, we again ow the solution forward for \time" 2 L according to the ordinary dimension, until we approach the second well at z = + L.
- 4. When z = + L, the solution again jumps vertically in the phase plane according to the matching condition. The phase plane solution that we have been following represents a standing wave if and only if this second jump lands our solution exactly upon the stable manifold, in accordance with the condition that u(z) ! 0 as z ! +1.

For xed values of the parameters , and L, it may happen that there are multiple standing waves present, corresponding to di erent values of the function at the rst defect. In accordance with the search method described above, such solutions are shown in the phase plane in gure 2.

3.1 The linear limit; in nitesim al solutions

To illum inate this search for standing waves, it is instructive to st consider the case of sm allam plitude solutions. For in nitesim alsolutions, we neglect the nonlinear term and we are left with the following linear system




Figure 2: Standing waves of di erent form s are found for = 1, L = 2 and = 0.65. Here we see a sym m etric wave, an asym m etric wave and an antisym m etric wave.

For the linear system, a bounded solution again grows from (0;0) along the unstable subspace, jumps to some transient at the rst well, evolves further according to the linear system and then must jump exactly to the stable subspace at the second well in order to decay to (0;0) as z ! 1. For a xed value of L and in this system, we can determ ine the values of for which standing waves exist. This is pursued below.

First, the unstable subspace at (0;0) is given as the eigenvector of the matrix

associated with the eigenvalue of positive realpart. This is the vector (1;1) and so any point in the unstable subspace can be written as (;). Similarly, the stable subspace is spanned by the vector (1; 1). The jump at the rst well is then J:(;)!;(1 -) . Note that this jump will take us to one of the interior transient curves (inside the hom oclinic loop in phase space) when > =2 and to one of the exterior transient curves (outside the hom oclinic loop) when < =2.




Figure 3: vs. L for = 1. Symmetric states exist for any > =2, while for < =2, antisymmetric states exist only for well-separation L > 1 .

In this in nitesimal amplitude limit, we can not the standing waves of this system explicitly. Writing the landing point of the rst jump in terms of the eigenbasis yields

Because the system is linear in this limit, we ignore the -term s from here on. Evolving this point forward for time 2 L brings us to the point

The antisymm etric solutions exist only for $L > {}^{1}$ because the function $L_{anti}()$ is monotone increasing on [0; =2), with minimum value 1 attained at = 0. The two branches of solutions (symmetric and antisymmetric) are shown in gure 3. The results are summarized in the following proposition:

P roposition 2. In the small amplitude limit, with the wells separated by any positive distance L > 1= , there exists a symmetric standing wave with =2 <

(L) < and an antisymmetric wave with 0 < (L) < =2. These states are unique (up to linear scaling) and no other standing waves exist. Finally, for L su ciently large,

3.2 Nonlinear regime; solutions with larger am plitude.

For solutions with nontrivial amplitude, things get much more interesting (as we have seen in our initial num erical search). Because of the periodicity of the transient states, there are m any possible solutions for this system (especially for larger values of L). We show particularly that in addition to the sym metric pulse (and the antisym metric pulse, for L values at which it exists) described above, there is also an asym metric pulse that bifurcates away from the sym metric pulse at a particular value of the boson num ber N. (I here results follow for a focusing nonlinearity, g < 0. In the defocusing case, g < 0, an asym metric pulse can be seen to bifurcate from the antisym metric solution.)

For xed values of the parameters L and , we will consider what sorts of positive-valued standing waves exist for varying values of . These solutions can be determined by adapting the previous search technique in the following way:

1. For this system, the branch of the unstable manifold in the rst quadrant is given by the explicit expression

W e now search for standing waves by evolving this entire curve via the matching conditions and the evolution equation.

2. For a particular value of , application of the m atching conditions at the rst defect yields the curve

4. Finally, we compare the evolved curve $T_{2 L}$ (J (W ^u)) with the set of points that jump to the stable manifold at the second defect

This agrees with (3.4) in the linear limit. Notice that the set J 1 (W $^{\rm s}$) is simply the rejection of the set J (W $^{\rm u}$) through the v-axis. Each non-trivial point of intersection of the two sets T_{2 L} (J (W $^{\rm u}$)) and J 1 (W $^{\rm s}$) represents a standing wave of this system .

R em ark 3. Because the curve $J(W^u)$ intersects m any of the periodic transients m ore than once, it seems plausible that there m ay be non-symmetric solutions for some values of $L \cdot W = w$ ill m ake that clear by pursuing the strategy above.

Proposition 4. Let and L remain xed. For all $> _{sym}$ (where $_{sym}$ is the value of for which a sym metric solution exists in the linear limit, as in (3.6)), there is at least one sym metric solution standing wave.

P roof. This is a simple argument regarding the continuity of the curves $J^{-1} (M^{-s})$ and $T_{2 L} (J (M^{-u}))$. We consider only the portions of these curves interior to the hom oclinic orbit of the autonom ous system. The portion of $J (M^{-u})$ inside this loop has one endpoint at (0;0) and the other endpoint on the curve W^{-s} in the lower half-plane; see gure 4.

For > $_{sym}$, the initial portion of the curve $T_{2 L}$ (J (M u)) leaving (0;0) is between J 1 (W s) and W u { in particular, above the curve J 1 (W s). How ever, the other end m ust remain on the invariant manifold W s , and this manifold lies below the curve J 1 (W s). Therefore, since $T_{2 L}$ (J (W u)) is a continuous curve, it must intersect the curve J 1 (W s) in at least one point. Therefore there is at least one standing wave in this system for all > $_{sym}$.

F inally, notice that if there is only one point of intersection, then the standing wave corresponding to this intersection point will be a symmetric function of position. This follows from the reversibility of the autonom ous portion of the evolution equation. $\hfill \Box$

K now ing that one orm ore standing waves exist, we now look into the form s that such waves take. In the follow ing, we will look for sym metric standing waves that are concentrated at the defects; in particular, we hope to nd pro les that achieve their maximum values at the two defects. We take a slight change of view in the following, considering and as xed and asking for which values of the spacing parameter L do such standing waves exist?

Proposition 5. Let and be xed parameters. There is a symmetric solution concentrated at the defects in each of the following regimes:

1. For $\frac{1}{2} < <$, there is such a solution for all L > L_{sym} () = $\frac{1}{2} \ln \frac{1}{2}$. 2. For $< < \frac{p}{2}$, there is such a solution for all values of L. 3. For $= \frac{p}{2}$, there is such a solution for all L > $\frac{1}{2}$ tan $^{1}2$.




Figure 4: For all values of $> _{sym}$ there is an intersection of $T_{2 L}$ (J (W^u)) and J¹ (W^s) { and such an intersection represents a standing wave. As increases, more intersections may arise.

Proof. We will prove this proposition by considering the amount of \time" it takes each point on the curve J (M^u) (from the point where the curve enters the lower half plane until it meets the manifold W^s) to reach its rejection on the curve J¹ (M^s). For xed value 2L, we show there is a point on J (M^u) which is mapped to its rejection on J¹ (M^s) in time 2L. We can denote the function L (u) as the \time" it takes the solution beginning at a point $u; u(1)^{2} = 0$ (meeting the previous parenthetical requirement) to reach the symmetric point $u; u(1)^{2} = 0$.

- 1. The result follows quickly in the regime $\frac{1}{2} < < \cdot$, by noting that as $u \mid 0^+, L(u) \mid L_s$ as given in the earlier proposition. Also, as $u \mid \frac{p}{1 + (1 2)^2}$, $L(u) \mid 1$. A continuity argument completes this case.
- 2. For > the curve $J(M^{u})$ beaves the origin into the upper half plane. It reaches the u-axis when $u = \begin{bmatrix} 1 & (=)^{2} \end{bmatrix}$ and reaches the stable manifold M^{s} when $u = \begin{bmatrix} 1 & (=2)^{2} \end{bmatrix}$. In this regime, it is clear that L(u) ! 0 as $u ! \begin{bmatrix} p \\ 1 & (=)^{2} \end{bmatrix}^{+}$ and L(u) ! 1 as $u ! \begin{bmatrix} p \\ 1 & (=2)^{2} \end{bmatrix}$
- 3. When $= \frac{p}{p} \frac{1}{2}$, the curve J (W^u) crosses the u-axis at the elliptic xed point (1= 2;0). A careful study of the linearization near this xed point reveals the lower limit given above.

Now we note an important consideration concerning the form of these symmetric pulses. In particular, for xed values of the parameters and , there is a distinguished value of the parameter L so that the curve J (W $^{\rm u}$) is tangent

to the symmetric standing wave as we approach the rst defect from the right. The value of the standing wave at each defect can be quickly computed for this threshold value,

and the threshold value of L, L_{thresh} , can then be computed simply by noting the $\pm v_{thresh}$, to its relation (u_{thresh} ; v_{thresh}).

In gure 5, we show the energy of the sym m etric standing wave at the threshold values of L. W e will now show that beyond this threshold, there is a pair of asym m etric standing waves (in addition to the sym m etric and antisym m etric waves discussed previously).




Figure 5: Threshold values of the particle number N _{thresh} for varying values of L are shown. At these threshold values, there is a bifurcation of asymmetric pulses (see Proposition 6) and beyond these values, the symmetric standing wave will be unstable (see Theorem 8). The point along the curve marked with a solid circle corresponds to the special value $= \frac{1}{2}$, where the point $u_{\rm thresh}$ is the xed point in the phase plane. A long the curve to the right of this point, the symmetric standing waves at threshold have the desired two peak prole; to the left, the symmetric standing waves at threshold have a single peak centered between the two wells.

P roposition 6. Let and remain xed. For $L>L_{\rm th\,resh}$ (), there exists a pair of non-sym m etric standing waves. These waves have the sym m etric wave in a pitchfork bifurcation at L = $L_{\rm th\,resh}$.




Figure 6: The solutions corresponding to the various intersection points from the phase plane diagram in gure 4 are shown here.

Proof. Consider and xed and positive, with L so that L > L_{thresh} (). For this value of L, the sym metric standing wave has a value $(u_0;v_0)$, with $u_0 > u_{thresh}$, approaching the rst defect from the right. This wave then must pass through J 1 (W $^{\rm s}$) in the phase plane an additional time before the reaching the term inal point at the second defect.

In the phase space, the part of the standing wave between the two defects can be written as the curve

Note that the curve $_0 \sin p \ln t$ traces out the portion of the periodic orbit connecting the symmetric points $(u_0; v_0)$ and $(u_0; v_0)$.

We consider an arbitrary parameterization (u ;v), 2 [0;1] of the portion of the curve J (W ^u) between (u₀;v₀) and its nontrivial intersection with the stable manifold W ^s, so that (u₀;v₀) is as above and (u₁;v₁) 2 W ^s. Then we can de ne

for all 2 [0;1]. Notice that the curve $J^{-1}(M^{-s})$ is transverse to all of the periodic orbits in the phase plane away from the xed point $(1 = \frac{1}{2}; 0)$. Therefore if a curve crosses $J^{-1}(M^{-s})$, it must do so transversely.

Recall that the curve $_0$ crosses J 1 (M $^{\rm s}$) prior to its term inal point at the second defect. (This earlier crossing does not represent a standing wave, of course, since it occurs for a value of z not corresponding to a defect.) On the other hand, for su ciently close to 1, the curve no longer crosses J 1 (M $^{\rm s}$). Continuity considerations therefore dictate that there must be a value of between 0 and 1 so that T_{2 L} ((u;v)) lies on the curve J 1 (M $^{\rm s}$). This value clearly does not represent a symmetric state since u₀ > u_{thresh}, while the rst point of intersection is smaller than u_{thresh}.

There is a second non-symmetric standing wave that, in the phase plane, has the form of the wave just found rejected across the u-axis.

This pair of non-symmetric solutions is originally produced in a pitchfork bifurcation when $L = L_{thresh}$ { at this parameter value the transversality of J^{-1} (M^{-s}) and the periodic orbit carrying the symmetric standing wave is lost.

4 The eigenvalue problem and stability.

In the previous section, we found various standing wave solutions of the equation

where v(x) is the double well potential $(x \ L) (x + L)$. In this section, we will analyze the stability of the various branches of solutions constructed, by studying the eigenvalue equation, associated with linearization about a xed nonlinear bound state.

First we change coordinates into the fram e of the standing wave

O finterest is the spectrum of this operator N . For the ground state (see section 2), the spectrum of N lies entirely on the imaginary axis and modulo zero modes,

associated with symmetries, exp (tN) is bounded on H 1 and indeed, the solution is nonlinearly stable $\left[17,13\right]$.

A state is unstable if one can exhibit an eigenvalue of the operator N with positive real part. Nonlinear instability is a consequence; see the appendix of [8]. Unfortunately, even though the spectrum of L_+ and L_- can, in principle, be determ ined using Sturm {Liouville theory, it is not obvious how to construct the spectrum of N using this information. However, this is exactly the operator studied by Jones in [9], in an application to optical pulses in nonlinear waveguides. In that work, Jones interprets the search for a real positive eigenvalue as a shooting problem in the space of Lagrangian planes. U sing a winding argument in this space, he derives a relationship between the number of positive eigenvalues of the simpler operators L_+ and L and the number of positive eigenvalues of N. Let

 $P = num ber of positive eigenvalues of L_+ and$

Q = num ber of positive eigenvalues of L :

Then we have [9, 8]:

Theorem 7. If P $Q \in 0;1$, there is a real positive eigenvalue of the operator N.

An alternative, PDE approach to this result was developed by G rillakis [8].

From Sturm {Liouville theory, P and Q can be determ ined by considering the behavior of solutions of $L_+ p = 0$ and $L_- q = 0$, respectively. In particular, P and Q equal the number of nodes of the associated solutions p and q. Since $L_- q = 0$ is satisfied by the standing wave u(x) itself, it quickly follows that

Q = num ber of zeros of the standing wave u(x):

For all positive-valued pulses, then, Q = 0.

So we have that if P > 1, then N has a positive eigenvalue and the standing wave u(x) is unstable. The operator L_+ acts as the equation of variations for (4.1), and a natural interpretation of the equation of variations is that it carries tangent vectors under the ow. So if we initialize q(x) as a vector tangent to the unstable manifold at the point u(x), then we can calculate P by counting the nodes of the resulting solution q(x).

In the context of vectors, a node of q(x) is a vector in the phase plane pointing straight up or down. And so, P can be computed by counting the number of times that the vector initialized tangent to the unstable manifold passes through verticality. In particular, considering only the angle of this vector and not its magnitude, P corresponds to the largest number of integer multiples of through which this vector rotates as it is evolved under the linearized ow.

The only diculty in the computation is this: because of the jumps at the defects, i.e., the inhomogeneity of the evolution equation, a vector q(x)

initialized tangent to the nonlinear bound state solution will not rem ain tangent to this solution once we reach the rst defect.

How ever, using the simple m atching conditions for these vectors at the wells, we have the following theorem :

Theorem 8. For L $L_{\rm thresh}$, the symmetric solution has P 1. For L > $L_{\rm thresh}$, the symmetric solution has P 2. Therefore, after the bifurcation of the asymmetric waves, the symmetric wave is unstable.

Proof. The result follows simply by evolving a vector (initialized as a tangent vector to the upper branch of the hom oclinic) around each standing wave under the in uence of the equation of variations. This can be visualized by noting that, at the rst defect, the tangent vector to the unstable manifold W^u is taken to a vector that is tangent to the curve J(M^u). The observation of instability is then reduced to simply noting the manner in which this landing curve J(M^u) intersects the periodic curve in the phase plane representing the standing wave between the defects.

- 1. At the threshold value $L = L_{thresh}$ itself, the curve J (W^u) is tangent to the transient to which the solution jumps at the rst well. The variational solution, then, will still be tangent to the transient curve (although pointing backwards). Hence, we can continue to trace the solution exactly by following the tangent vector around this transient to the second jump. Then, as symmetry dictates, this vector is taken to a tangent vector to W^s at the second jump. This vector is seen to pass through verticality only once (at t = 0) and hence has P = 1.
- 2. For L < L_{thresh}, the vector jumps through a smaller angle at each well than it does at the bifurcation point itself. At the rst defect, it then points along the curve J (M^u), which in this case points up and into the internal ellipse. Because solutions are unique, the tangent vector to this ellipse provides a bound for our solution as it evolves, and the vector in question must retain its orientation with respect to the tangent to the ellipse; in particular, it rotates clockwise and must be pointing \below" the ellipse at the second defect. However, the vector that is taken to the curve W^s is the vector tangent to J¹ (W^s), and comparing these two vectors we quickly see that P¹ in this case.
- 3. For L < L_{thresh}, the vector jumps through a larger angle at the st defect and now points along J (W^u) down and out of the internal ellipse, and so the tangents to the ellipse now provide a bound on the other side. At the second well, the solution must still point out of the ellipse and com parison with the vector tangent to J¹ (W^s) forces P² in this case.

These three cases are sketched in gure 7.




Figure 7: The evolution of the tangent vector is shown for solutions with varying values of L. In the sst gure L = L thresh and the evolved vector is parallel to the solution throughout its evolution. In the second gure L < L thresh and the vector m oves through a sm aller angle at each defect and we see P 1. W hen L > L thresh as in the third gure, the vector m oves through a larger angle at each defect and forces P 2.

A Wellposedness of Gross-Pitaevskii / NLS

Structural properties of NLS: The G ross-P itaevskii / NLS equation is a H am iltonian system, which can be written in the form :

where H_{GP} [u;u] denotes the H am iltonian (1.5). Invariance with respect to timetranslations in plies that H_{GP} [u;u] is conserved by the ow generated by (A.1). Additionally, invariance under the transformation u 7 eⁱ u; 2 R¹ in plies that N [u;u], the L² norm de ned in (1.6), is conserved.

For the spatially translation invariant case, NLS has the Galilean invariance:

W ell-possibles theory: W e present a sketch of the existence and uniqueness of solutions to (1.3); see also [7]. The functionals H_{GP} [] and N [] are well de ned on $H^{-1}(\mathbb{R}^{1})$, the space of functions f, for which f and θ_{x} f are square integrable. It is therefore natural to construct the ow for initial data of class H^{-1} . In fact, it can be shown that, for initial conditions $u_{0} = u(x;t=0) 2 H^{-1}(\mathbb{R}^{1})$, there exists a unique global solution of NLS, $u \ge C^{0}(\mathbb{R}^{1};H^{-1}(\mathbb{R}))$, in the sense of the equivalent integral equation:

The spectral decomposition of H is known explicitly [2] and can be used to construct U (t) explicitly.

To show the existence of a solution to (A 3a) in H¹, we must show the existence of a C⁰ (R¹; H¹(R)) xed point of the mapping u(x;t) 7 J[u](x;t), given by the right hand side of (A 3a).

We now outline the key ingredients of the proof. To bound J [u] and its rst derivative in L², we introduce the operator A = I + P_cH , where P_c denotes the projection onto the continuous spectral part of H . Note that A is a nonnegative operator, since the continuous spectrum of H is the nonnegative real half-line. M oreover, we expect kA $\frac{1}{2}$ fk kfk_H¹ k(I $(\ell_x^2)^{\frac{1}{2}}$ fk_{L²}. In fact, we shall use that the follow ing operators are bounded from L² to L²:

Our formulation (A.3a) and introduction of A are related to the nice property that A, and hence also functions of A, commute with the propagator exp(if t).

Now assume that u is such that $\sup_{s^2 [0;T]} ku (s) k_{H^{-1}} 2C_1$. Then, by (A.8), choosing $T < T_1$ su ciently small, $\sup_{s^2 [0;T]} kJ [u](s) k_{H^{-1}} 2C_1 ku_0 k_{H^{-1}}$ and so

Therefore, J[] has a unique xed point in $C^0([0;T];H^{-1}(R))$ for T su ciently sm alland localexistence in time of the ow follows. G lobalexistence in time follows from the a priori bound on the H 1 norm of the solution im plied by the time-invariance of L^2 norm, N, and the Ham iltonian, H $_{\rm G\,P}$.
