A Remark on Nonlocal Symmetries for the Calogero {Degasperis {Ibragimov {Shabat Equation

A bstract

We consider the Calogero{Degasperis{Ibragim ov{Shabat (CDIS) equation and not the complete set of its nonlocal symmetries depending on the local variables and on the integral of the only local conserved density of the equation in question. The Lie algebra of these symmetries turns out to be a central extension of that of local generalized symmetries.

1 Introduction

The existence of in nite-dimensional Lie algebra of commuting higher order symmetries for a system of PDEs is well known to be one of the most important signs of its integrability, see e.g. [3, 14, 19, 20]. This algebra can be extended, see e.g. [3], to a noncommutative algebra (which is often referred as a hereditary algebra, see [3]) and references therein) of polynomial-in-time (and possibly nonlocal) symmetries. In (2+1) dimensions these symmetries are polynomials in time to farbitrarily high degree, while in (1+1) dimensions one usually can construct only the symmetries which are at most linear in time [3].

For a long time the only known (1+1)-dimensional nonlinear evolution equation possessing symmetries being polynomials in time of arbitrarily high degree was the Burgers equation, see [23] for the complete description of its symmetry algebra. It is natural to ask whether there exist other (1+1)-dimensional evolution equations having the same property. In [18] we have answered this question in a rm ative and shown that the Calogero (Degasperis (Ibragimov (Shabat (CDIS) [4,5,9,16,19,21] equation also possesses a hereditary algebra of polynomial-in-time symmetries which, exactly as in the case of Burgers equation, is its complete symmetry algebra in the class of local higher order symmetries.

The CD IS equation (2.1) has only one nontrivial local conserved density = u^2 , so the natural next step in analyzing this equation is to consider its symmetries involving a nonlocal variable! being the integral of this density. Theorem 1 below provides the

complete characterization of symmetries which depend on this variable and on a nite number of local variables. It turns out that, unlike the local case, the Lie algebra of these symmetries possesses a nontrivial one-dimensional center, spanned by (the only) genuinely nonlocal symmetry.

2 Sym m etries of the CD IS equation

The Calogero (Degasperis (Ibragim ov (Shabat (CD IS)) equation has the form [4,9]

Here $u_1 = 0^j u = 0 x^j$ and $u_0 = u_i x^j$ see [18] for the further details on notation used.

Let us mention that (2.1) is the only equation among third order (1+1)-dimensional scalar polynomial -homogeneous evolution equations with = 1=2 that possesses innitely many x;t-independent local generalized symmetries [15].

Consider a nonlocal variable! de ned (cf. e.g. [21, 22, 23]) by the relations

N ote that the CD IS equation is linearized into $v_t = v_3$ upon setting $v = \exp(!)$ u [19].

The quantity = u^2 is [19, 21] the only nontrivial local conserved density for (2.1), but (2.1) has [21] a Noether operator, i.e., an operator that sends conserved covariants to sym metries, see e.g. [8] for more details on such operators, of the form exp(2!) and in nitely many nontrivial conserved densities explicitly dependent on! [21].

We shall call a function G $(x;t;!;u;u_1;...;u_k)$ a sym metry of CD IS equation, if

Note that our de nition of nonlocal sym m etries is a particular case of the usual one, cf. e.g. [3], but in term inology of [22] the solutions of (2.3) are referred as shadows of sym m etries.

For any function H = H (x;t;!;u;u1;:::;uq) we de ne its order ord H as a greatest integer m such that $H = u_m \in O$, and set

Here denotes a composition law induced by generalized Leibnitz rule' (see e.g. [12, 19])

A function $H = H(x;t;!;u;u_1;:::;u_q)$ is called local if $\theta H = \theta ! = 0$.

Let $S_{\text{CD IS}}^{(k)}$ be the set of sym m etries of the form G (x;t;!;u;u_1;:::;u_k) for the CD IS equation, and let $S_{\text{CD IS}} = S_{\text{CD IS}}^{(j)}$, $S_{\text{CD IS}}$, $S_{\text{CD IS}}$, $S_{\text{CD IS}}$, $S_{\text{CD IS}}$ for j 1, and $S_{\text{CD IS}}$, $S_{\text{CD IS}}$ = $S_{\text{CD IS}}^{(0)}$, where $S_{\text{CD IS}}$ = $S_{\text{CD IS}}$

Suppose that k ord G 1. Then dierentiating the left-hand side of (2.3) with respect to u_{k+2} and equating the result to zero yields D (@G=@u_k) = 0. Hence, in analogy with Section 5.1 of [14], for any sym metry G 2 S_{CD} so forder k 1 we have

where c_k (t) is a function of t.

In particular, any symmetry G 2 $S_{CD\,IS}^{(2)}$ is of the form $G = c(t)u_2 + g(x;t;!;u;u_1)$. Substituting this expression into (2.3), collecting the coe cients at u_4 , u_3 , u_2 , equating to zero these coe cients and the sum of remaining terms on the left-hand side of (2.3), and solving the resulting system of equations for c(t) and g readily shows that g and g is a linear combination (with constant coe cients) of g and g = exp(2!)g.

Below we assume without loss of generality that any symmetry G 2 $S_{CDIS;k}$, k 1, vanishes if the relevant function q_k (t) is identically equal to zero.

Further di erentiating (2.3) with respect to u_{k+1} and u_k and then with respect to x shows that, exactly as in [17], for k 2 we have $\ell^2G = \ell u_{k+1} \ell x = 0$, and for k 3

Taking into account that G 2 $S_{CD IS}$ in plies $G = Q^rG = Qx^r 2 S_{CD IS}$, and successively using (2.5), we not that for k 2 and r [k=2] 1 we have ord G k 2r and

For r=k=2] 1 we have $\operatorname{ord} G$ 3. The straightforward computation shows that all symmetries from $S_{\text{CD}\,\text{IS}}^{(3)}$ are at most linear in t, and thus the function c_k (t) satisfies the equation $d^m c_k$ (t)= $dt^m=0$ form = k=2]+1. Hence, $\dim S_{\text{CD}\,\text{IS};k}$ k=2]+1 fork 1, i.e., the dimension of the quotient space of symmetries of the form G=G (x;t;!;u;u1;:::;uk1) modulo the space of symmetries of the form G=G (x;t;!;u;u1;:::;uk1) does not exceed k=2]+1 fork 1. From this it is immediate that all odd-order symmetries from $S_{\text{CD}\,\text{IS}}$ are exhausted by local ones, as we can exhibit exactly k=2]+1 such symmetries of order k for each odd k [18].

Furtherm ore, as all sym metries of the form $G(x;t;!;u;u_1;u_2)$ are exhausted by u_1 and W, in analogy with Theorem 2 of [17] we can show that all sym metries of the form $G(x;t;!;u;u_1;:::;u_k)$ of the CD IS equation are polynomial in time t for all $k \in \mathbb{N}$. Indeed, assume this result to be proved for the sym metries of order $k \in \mathbb{N}$ and let us prove it for sym metries of order k. It readily follows from the above that the function $u_k \in \mathbb{N}$ is a polynomial in tof degree not higher than $u_k \in \mathbb{N}$. Therefore, $u_k \in \mathbb{N}$ where $u_k \in \mathbb{N}$ is a sym metry of CD IS of order not higher then $u_k \in \mathbb{N}$ and thus is polynomial in t by assumption, whence we readily see that $u_k \in \mathbb{N}$ is polynomial in t as well. The induction on $u_k \in \mathbb{N}$, starting from $u_k \in \mathbb{N}$, completes the proof.

Now let us turn to the study of time-independent symmetries of the CD IS equation. This equation is well known to have in nitely many x; t-independent local generalized

sym m etries, hence it has [10] a form alsym m etry of in nite rank of the form $L=D+\sum_{j=0}^{1}a_{j}D^{-j}$, where a_{j} are some x; t-independent local functions.

Taking the directional derivative of (2.3), we not that for any sym m etry G 2 S_{CD IS} of order k the quantity G is a form alsym m etry of rank not lower than k+1 for the CD IS equation, and therefore (cf. e.g. [12, 19]), provided k-1 and 0 = 0 = 0 we have

where c_j are some constants and $B= \displaystyle \int_{j=1}^{p_0} b_j D^j$, b_j are some t-independent local functions.

From this equation we infer that (cf. [18]) any sym m etry G (x;!;u;u₁;:::;u_k) 2 S_{CD} $_{IS}$, ord G 1, can be written as

$$G = G_0(u;u_1;...;u_k) + Y(x;u;!)$$

It can be easily seen that @Y = @x = @G = @x and @Y = @! = @G = @! are time-independent sym metries of the CD IS equation of order not higher than zero. We readily conclude from the above that $@Y = @x = c_1W$ and $@Y = @! = c_2W$ for some constants c_1 , c_2 . As $@^2Y = @x@! = @^2Y = @! @x$, we not that $c_1 = 0$, and thus @Y = @x = 0, so any time-independent sym metry G of order k 1 for the CD IS equation is x-independent as well, and $G = G_0(u;u_1;:::;u_k) + cW$ for some constant c. As we have already shown above, the only sym metry of order zero or less from $S_{CD \ IS}$ is W. Thus, we conclude that any time-independent sym metry of the form $G(x;!;u;u_1;:::;u_k)$ is x-independent as well.

U sing the sym bolic m ethod, it can be shown [15] that the CD IS equation has no even order t; x-independent local generalized sym m etries, so its only even order time-independent sym m etry (in the class of sym m etries of the form $G(x;!;u;u_1;:::;u_k)$) is W.

Now let us show that the same result holds true for time-dependent sym metries as well. The CD IS equation is invariant under the scaling sym metry $K = 3tF + xu_1 + u = 2$. Therefore, if a sym metry Q contains the term sofweight (with respect to the weighting induced by K, cf. [2], when the weight of u is 1=2, the weight of! is 0, the weight of t is 3, the weight of x is 1, and the weight of $u_j = j + 1 = 2$), there exists a hom ogeneous sym metry Q of the same weight . We shall write this as wt(Q') = . Note that [K;Q'] = (1=2)Q'.

If G 2 $S_{CDIS;k}$, k 1, is a polynomial in tof degree m, then its leading coe cient

Thus, we conclude that the existence of a time-independent symmetry of order k-1 from $S_{\text{CD IS}}$ is a necessary condition for the existence of a polynomial-in-time symmetry $G_{\text{CD IS}}$ of the same order k. Moreover, by the above all symmetries from $S_{\text{CD IS}}$ are polynomial in t. Hence, the fact that the CD IS equation has no time-independent symmetries $G_{\text{CN IS}}$; $u;u_1;:::;u_k)$ of even order k-2 immediately implies the absence of any time-dependent symmetries of even order k-2 belonging to $S_{\text{CD IS}}$.

Sum m ing up the above results, we infer that the space $S_{CD\ IS}$ is spanned by the sym m etry $W = \exp(2!)u$, and by local generalized sym m etries of the CD IS equation. The latter were found in [18], and can be described in the following way.

De nethe com mutator of two functions f and g of x; t; !; u; u; u; ::: as (cf. e.g. [3, 12, 19])

Set $m_{i,0} = x^m u_1 + m_1 x^m u_2$, $m_i = 0;1;2:::$, and $u_{i,1} = x_i(u_3 + 3u^2u_2 + 9uu_1^2 + 3u^4u_1) + 3u_2 = 2 + 5u_1u^2 + u^5 = 2$. The latter is the rst nontrivial master symmetry for the CD IS equation, see e.g. [15, 16]. The quantities $u_{i,0}$, $u_{i,0}$, $u_{i,0}$, and $u_{i,1}$ meet the requirements of Theorem 3.18 from [3], whence

where $_{m;j}$ with j > 0 are dened inductively by means of (2.8), i.e., $_{0;j+1} = \frac{1}{2j+1} [_{1;1};_{0;j}]$, $_{m+1;j} = \frac{1}{2+4j} [_{1;0};_{m;j}]$, see [3].

Note that the idea of constructing new symmetries by the repeated commutation of a master symmetry with a seed symmetry, as well as the notion of master symmetry, were suggested by Fuchssteiner and Fokas [6], see also Fuchssteiner [7].

Thus, the CD IS equation, as well as the Burgers equation, represents a nontrivial example of a (1+1)-dim ensional evolution equation possessing a \doubly in nite" hereditary algebra of m aster sym m etries $_{\rm m,m}$.

Using (2.8), it can be shown (cf. [3]) that $ad_{0;j}^{m+1}(m;j^0) = 0$, i.e., m;j are master symmetries of degree m for all equations $u_{t_k} = 0;k$, k = 0;1;2;... Here $ad_B(G)$ [3] for any (smooth) functions B and G depending on! and on a nite number of local variables.

Let exp (ad_B) $ad_{B}^{j} = j!. A s ad_{0;j}^{m+1} (m;j^{0}) = 0, \text{ it is easy to see (cf. [3]) that }$

are local time-dependent generalized sym metries for the equation $u_{t_k} = 0; k$, and ord $G_{m;j}^{(k)} = 2(j+mk) + 1$. Note that $G_{m;j}^{(k)}$ obey the same commutation relations as m;j, that is,

$$[G_{m;j}^{(k)};G_{m^{0};j^{0}}] = ((2j^{0}+1)m (2j+1)m^{0})G_{m+m^{0}1;j+j^{0}}^{(k)}$$

It is straightforward to verify that $_{0;1} = F = u_3 + 3u^2u_2 + 9uu_1^2 + 3u^4u_1$ and thus $G_{m;j} = G_{m;j}^{(1)}$ (t) = exp (tad_F) _{m;j} are time-dependent symmetries for the CD IS equation.

It is easy to see that the number of symmetries $G_{m,j}$ of given odd order k=2l+1 equals [k=2]+1=l+1. As dim $S_{\text{CD}\,\text{IS};k}$ [k=2]+1, these symmetries exhaust the space $S_{\text{CD}\,\text{IS};k}$ for odd k. Moreover [18], any local generalized symmetry of the CD IS equation is a linear combination of the symmetries $G_{m,j}$ for $m=0;1;2;\ldots$ and $j=0;1;2:\ldots$

Evaluating the com mutator of W with $m;0=x^mu_1+mx^{m-1}u=2$, we readily see that it vanishes, if we assume that the result of application of D 1 to a homogeneous polynomial in $x;t;u;:::;u_k$ without u_j —independent terms is a polynomial of the same kind. Next, under the same assumption [W; 0;1] = [W; F] = 0, just because W $2 S_{CDIS}$. Finally, using the commutation relations (2.8) and the Jacobi identity, we conclude that the commutator of W with all symmetries $G_{m;i}$ vanishes as well. As a result, we have

Theorem 1. Any sym metry of the CD IS equation of the form $G(x;t;!;u;:::;u_s)$ is a linear combination of the sym metries $G_{m;j}$ for m;j=0;1;2;:::, and of the sym metry $W=\exp(2!)u$, which commutes with all other symmetries.

This result can be generalized to the sym m etries of higher CD IS equations' $u_{t_k} = 0_{jk}$. Recall [10] that because of existence of in nitely many x;t-independent local generalized sym m etries the CD IS equation has a form all sym metry of in nite rank of the form $L = D + u^2 + a_j D^{-j}$, where a_j are some x;t-independent local functions. U sing Lem m a 11 from [20], we can show that L is a form all sym metry of rank at least ord $0_{jk} + 3$ for the equation $u_{t_k} = 0_{jk}$, and hence $u^2 = \text{res ln L}$ is a conserved density for all these equations: $D_{t_k}(u^2) = D_{-k}(u^2) = D_{-k}(u^2)$

In order to describe the sym m etries of the system s $u_{t_k} = u_{jk}$, let us extend (2.2) by adding the equations

Theorem 2. Any symmetry of the form $G(x;t_k;!;u_j::::;u_s)$ for the equation $u_{t_k}=0;k$, k=1, is a linear combination of the symmetries $G_{m;j}^{(k)}(t_k)$ for m=0;1;2;::: and j=0;1;2:::, and of $W=\exp(2!)u$, which commutes with all other symmetries.

As a nalremark, let us mention that, as an alternative approach, one could try using the formula $v = \exp(!)u$ in order to \transfer" the known results on symmetries and recursion operators of the linear equation $v_t = v_3$ to the CD IS equation. However, the symmetries resulting in this way are in general highly nonlocal. Even the description of nonlocalities that occur in thus constructed symmetries, as well as sorting out local and \weakly nonlocal" (depending only on !) symmetries, is quite a dicult task, and we intend to analyze this and related problems elsewhere.
