#### Abstract

M ultifractal properties of a tracer density passively advected by a com pressible random velocity eld are characterized. A relationsh $i p$ is established betw een the statistical properties of $m$ ass on the dynam ical fractal attractor tow ards which the tra jectories converge and large deviations of the stretching rates of the ow. In the fram ew ork of the com pressible K raichnan model , this result is ilhustrated by analytical calculations and con m ed by num erical sim ulations.


W e are interested in the passive transport of a scalar density by sm ooth-in-space com pressible random ows in a d-dim ensional bounded dom ain . D uring transport, the density develops strong inhom ogeneities. O ur goal is to describe quantitatively their ne structure arising at asym ptotically large tim es. C om pressible ow sare physically relevant not only at large $M$ ach num bers. For instance, the dynam ics of a suspension of nite-size (inertial) particles in an incom pressible ow $m$ ay be approxi$m$ ated in the lim it of short Stokes tim es by that of sim ple tracers in an e ective com pressible ow [1, 2]. A nother application is to the advection ofparticles oating on the surface of an incom pressible uid [3].

A sm ooth passive density eld ( $t$; $x$ ) evolves in the velocity eld $v(t ; x)$ according to the continuity equation

which preserves the total $m$ ass that we shall assum e for convenience norm alized to one. If the initial density at time to is uniform and if the ow is compressible and su ciently $m$ ixing, then the solution ( $t$ ) of (11) will approach, when to tendsto 1 , a singularlim it (t) which is a m easure $w$ th support on the dynam icalattractor towards which the Lagrangian trajectories converge. For random velocities, the $m$ easure ( $t$ ) and the dynam ical attractor depend on the velocity realization. W e shall consider stationary velocity ensem bles where the statistics of $(t)$ does not depend on $t$. For convenience, we shall restrict our study to (0). O ne expects the $m$ easure to have roughly a local product structure $w$ th a sm ooth density along the unstable $m$ anifolds of the ow and a fractal-like structure in the transverse directions (such m easures are called SRB [4]).
$T$ he Lagrangian average de ned by

where the overline denotes the expectation $w$ ith respect to the velocity ensemble, sam ples points in according to the density of the asym ptotic tracer distribution on the random attractor. It determ ines an invariant $m$ easure of the random dynam ical system de ned on the product of the physical space and the space of the velocity realizations.

W e are interested in the sm all-scale statistics of the $m$ ass distribution associated to the $m$ easure. D enote by $B_{r}(x)$ the ball of radius $r$ around the point $x$ and introduce the quantities

The localdim ension at $x$, de ned if the lim it exists as $h(x) \quad \lim _{r}$ ! $0 h_{r}(x)$, characterizes the sm all-scale distribution of $m$ ass associated to the lim iting density . A m ore global assessm ent is provided by the $H$ entschel$P$ rocaccia spectrum for dim ensions [5, 6] of :

for realn. In particular, $H P(0 j)$ is the fractal dim ension of the support of , HP ( 1 j$)$ is known as the inform ation (or capacity) dim ension and HP (2j ) as the correlation dim ension. For random ow $s$, one $m$ ay dene the quenched version of the $H$ entschelP rocaccia spectrum $H P_{\text {qu }}(n) \quad \overline{H P(n j)}$ and the annealed version $H P_{\text {an }}(n)$ where the velocity average is taken under the logarithm in the num erator on the right-hand side of (2). O ne has ( $n$ 1) H $P_{\text {qu }}(n)$ ( $n$ 1) H $P_{\text {an }}(n)$ and $\mathrm{HP}_{\mathrm{qu}}(1)=\mathrm{HP}_{\mathrm{an}}(1)$ (if exists). If the m om ents of $m_{r}(x$ jv) $w$ ith respect to the invariant $m$ easure exhibit the sm all r scaling

then $H P_{\text {an }}(n+1)=n_{n}=n$. There are various aspects of behavior (3). First, a non-linear dependence of the scaling exponents $n$ im plies interm ittency in the $m$ ass distribution and, in particular, the presence ofnon-G aussian tails in the probability density function (PDF) of $m_{r}$. Second, th is behavior suggests that the PD F s of $h_{r}$ take, for $s m$ all radii, the large deviations form $e^{(\ln r) S(h)} w$ th the rate function $S(h)$ and the scaling exponents $n r e-$ lated by the Legendre transform : $S(h)=\max _{n}\left[\begin{array}{ll}n & n h\end{array}\right]$. $T$ hird, the (annealed) fractaldim ensions $f(h)$ of the random sets on which the localdim ension $h(x)$ is equal to $h$ (the m ultifractal spectrum ), is expected to be equal to $h \quad S(h)$.

The aim of this letter is to relate quantitatively the dim ensional spectrum $H_{P a n}(n)$ to the large deviations of the stretch ing rates of the ow (som etim es also called nite-tim e Lyapunov exponents). W e note here that in [2] a sim ilar relation was discussed for $\mathrm{n}=1$ and, in a qualltative way, for large $n$.

Let $\mathrm{X}(\mathrm{t} ; \mathrm{x})$ denote the Lagrangian trajectory passing at tim e zero through point $x$. The $m$ atrix $W$ ( $t ; x$ ) $@_{j} X^{i}(t ; x)$ describes the ow linearized around the trajectory X . The eigenvalues of the positive m atrix $\mathrm{W}{ }^{\mathrm{T}} \mathrm{W}$ $m$ ay be written, arranged in non-increasing order, as $e^{2 t}{ }_{1} ;::: ; e^{2 t} d \quad w$ th $i(; x j)$ called the stretching rates of the ow. The lim its

exist alm ost surely $w$ ith respect to the invariant $m$ easure
and are constant if the latter is ergodic. T hey de ne the Lyapunov exponents of the ow. This is the content of the M ultiplicative E rgodic T heorem [7]. A s argued in [8], if the exponents $i$ are all di erent then the PD F of the stretching rates takes the large deviation form

for large $t w$ th convex rate function $H$ attaining its $m$ inim um, equal to zero, at $i=i$.

If the top Lyapunov exponent 1 is negative, then the attractorm easure is expected to be atom ic w ith trivialm ass statistics. For ${ }_{1}>0$, Ledrappier and Young [G] showed under rather general assum ptions that the $10-$ cal dim ension $h$ is alm ost surely equal to the Lyapunov dimension $d_{L}=j+\quad$ where $0<1$ is such that

The Lyapunov dim ension $d_{L}$ was introduced by $K$ aplan and Y orke [10] and $m$ ay be heuristically interpreted as the dim ension of ob jects keeping a constant volum e during the tim e evolution. Eq. (5) gives only partial inform ation about the $m$ ass scaling as com pared to the full set of exponents $n$ -

To relate the $m$ ass distribution in sm all balls to the uctuations of the stretching rates, we focus on the tw odim ensional case. $T$ he expected $s m$ oothness of in the

unstable direction leads us to consider sm all parallelogram $s w$ th one side of size $r_{1}$ parallel to the unstable m anifold and w ith extension $r_{2}$ in the direction perpendicular to it. $W$ e expect that the $m$ om ents of the $m$ ass $m_{r_{1} ; r_{2}}$ in such parallelogram sobey

$T$ his $m$ ay be view ed as analogous to the stretching in one direction of a fractal set of dim ension $D$, while contracting it in the other one. In the expanding direction, the set $w$ illlbehave (dow $n$ to a scale depending on the stretching) as if projected on a line, so it will have dim ension m in $(1 ; \mathrm{D})$. In the other direction it w ill have the com ple$m$ entary dim ension $D \quad m$ in $(1 ; D)=m$ ax (D $1 ; 0)$.

Let us consider such a parallelogram at $t>0$ and let us look at its pre-im age at tim e zero. W hile the direction parallel to the unstable $m$ anifold is exponentially contracted backw ard-in-tim ew ith a rate given by the largest stretching rate 1 , the other direction typically expands w ith an exponential rate 2 . Hence the tim e-zero preim age of the original parallelogram is (approxim ately) another parallelogram as sketched in Fig. [1. C onservation ofm ass and stationarity of the statistics lead to the relation

If there is a su ciently rapid loss of mem ory in the Lagrangian dynam ics (i.e. if the invariant $m$ easure is sufciently $m$ ixing) then the expectation on the right-hand side should factorize for larget (such a factorization holds for allt in the $K$ raichnan $m$ odeldiscussed below). In such situation, using the large deviation form (4) of the PDF of the stretching rates, we infer that

It is easily checked from (8) that $\left(d_{n}=d n\right) \dot{j}_{n}=0=1$ ${ }_{1}=2$ which coincides, in our settings, with form ula (5). A lso from (8) one $m$ ay deduce that

for $R(t)=W(t ; x) R_{0}, m$ eaning that the generalized Lyapunov exponent of order 1 vanishes. This is a known result for stochastic ow s of di eom onphism $s$, see [11]. Relation (8) can be extended to dim ensions higher than two using sim ilar argum ents.

To illustrate the sm all-scale properties of the $m$ ass distribution, we focus in the sequel on transport by a random com pressible velocity eld chosen in the fram ew ork of the K raichnan m odel [12]. For the dom ain we take a periodic box. The velocity $v$ is taken centered $G$ aussian, w ith covariance

assuring local isotropy. The param eter \}, called the com pressibility degree, is chosen in the interval [0;1]. Its extrem e values correspond, respectively, to incom pressible and to potential velocity elds. For such velocity ensem bles, the distribution of the stretching rates is explicitly know $n$ [8, 13]. The corresponding rate function takes the simplef form

$T$ he two di erent behaviors are illustrated in $F$ ig. 2. In both cases, the events contributing to the saturation of the exponents are those for which a m ass of order unity is concentrated inside the sm all ball.

$N$ um erical sim ulations con $m$ the values of the scaling exponents obtained explicitly for the com pressible K raichnan model. To distinguish the two cases, two di erent values of the com pressibility degree are investigated $( \}=1=10<1=6$ and $\}=3=10>1=6)$. The velocity eld $v$ is generated by the superposition of nine independent $G$ aussian $m$ odes and the density is approxi$m$ ated by considering a large num ber of Lagrangian tracers. The exponents obtained num erically after averaging over $10^{5}$ tumover tim es and for $\mathrm{N}=10^{5}$ tracers are show $n$ in $F$ ig. 3. A though statistical convergence of the average is quite slow, these expensive sim ulations are in a rather good agreem ent w th the theory, in particularw ith the saturation of the exponents after the critical order.

The determ ination of the exponents $m$ ay be im proved forpositive integer orders $n$ by considering only $n+1$ particles. T his m ethod allow s to perform very long tim e averages (here of the order of $10^{8}$ tumover tim es) required for good convergence of the statistics at sm all scales. A s show $n$ in $F$ ig. 4, for $\}=3=10$, the $m$ om ents clearly scale
over several decades. For the low er value of com pressibility \} = $1=10$, convergence is slow er because of the sm aller probability for the tracked particles to com e close together.

Finally, let us mention that, for integer orders, the exponent $n$ for the $K$ raichnan $m$ odelcan be linked to the hom ogeneity degree of the stationary single-tim e density correlation function

W e need not w rite these zero $m$ odes explicitly. T he ho$m$ ogeneity degree of the isotropic solution of low est de-
gree can be found sim ply by requiring its positivity and im posing on it certain continuity and integrability conditions. The branch $n<n_{c r}$ in (10) is obtained by requiring the solution to be continuous at $\mathrm{x}_{1}=:::=\mathrm{x}_{\mathrm{n}}$. O $n$ this subspace, $M \underset{n+1}{\mathrm{Y}}$ is degenerate, ow ing to the fact that collinear points rem ain collinear when transported by the (linearized) ow. If in addition we restrict $M \underset{n}{y}+1$ to the rotationally invariant sector, it becom es an ordinary second-order hom ogenous di erentialoperator. It has tw o scaling solutions. The one $w$ th exponent $n$ nd gives, through (11), the non-saturated ( $n<n_{c r}$ ) branch of 10). Such a solution breaks down when the corresponding zero $m$ ode ceases to be integrable at sm all $x_{i}$ $w h i c h ~ m$ ay occur if the restriction of the zero $m$ ode to the collinear sector is not integrable near 0, i.e. $n$ nd 1 . $T$ his gives $n_{c r}$ and 1 in the case \} < $1=6$. A nother scenario is if the zero $m$ ode has a non-integrable singularity around the collinear geom etry. This gives $n_{c r}$ and $1_{1}$ in the case \} > $1=6$.

An im portant open question not touched upon by this paper concems the case of rough-in-space velocity elds appearing in the lim it of very high $R$ eynolds num bers. That problem cannot be form ulated in term $s$ of stretching rates but the relationship w ith density correlations and zero m odes still holds.
