# Vortex solitons in photonic crystal bers

We demonstrate the existence of vortex soliton solutions in photonic crystal bers. We analyze the role played by the photonic crystal ber defect in the generation of optical vortices. An analytical prediction for the angular dependence of the amplitude and phase of the vortex solution based on group theory is also provided. Furthermore, all the analysis is performed in the non-paraxial regime.

Spatial soliton solutions in 1D periodic structures have been theoretically predicted [1] and experim entally dem onstrated in nonlinear waveguide arrays [2]. More recently, similar structures have been observed in optically induced gratings [3, 4] and, for the rst time, in 2D photonic lattices [5]. Modeling has been traditionally performed using the discrete nonlinear Schrodinger equation (NLSE)[1, 6], valid only in the so-called tight-binding approximation. However, the accurate study of nonlinear solutions in optically-induced lattices requires the resolution of the NLSE with a continuous periodic potential model [3, 4, 5]. Discrete optical vortices have been also predicted in the discrete NLSE [7] and in continuous models [8] and, recently, experimentally observed in optically-induced 2D lattices [9].




FIG. 1: (a) Schem atical representation of a PCF. (b)-(d) Amplitudes of several vortices for increasing values of in a PCF with = 31 m and a = 6 m ( =  $1064 \,\mathrm{nm}$ ): (b) = 0;45 10  $^3$ ; (c) = 0;95 10  $^3$ ; (d) = 1;75 10  $^3$ .

A di erent scenario appears in a 2D photonic crystal in the presence of a defect. An exam ple of such a system is a photonic crystal ber (PCF). A PCF is a silica ber that possesses a regular array of air-holes extending along the entire ber length (see Fig.1(a)). It is an axially invariant 2D photonic crystal with a central defect (the PCF core, where guidance occurs). It has been recently proven that a PCF acting as a 2D nonlinear photonic crystal can support and stabilize fundamental solitons [10]. Unlike fundamental solitons embedded in perfectly periodic potentials [5, 8], a distinguishing feature of these systems is that no power gap is needed to generate the nonlinear localized solution. In this letter we go a step further and give numerical evidence of the existence of vortex solitons in PCF's.

When one considers that silica can have a nonlinear response, electrom agnetic propagation in a PCF is given by the following nonparaxial equation (r E 0):

r the 2D transverse Laplacian operator and

 $k_0=\mathop{!}{_0}=c$  the vacuum wavenumber. The linear refractive index pro le function  $n_0\left(x;y\right)$  is 1 in the air-holes and equals  $n_{\rm silica}$  in silica, whereas the nonlinear index pro le function  $n_2\left(x;y\right)$  is di erent from zero only in silica  $(n_{2\,(\rm silica)}^2 \quad 3 \quad {\rm (3)}_{\rm (silica)}^2 = (2\, {\rm "}_0\, cn_0\, (\rm silica)))$ . We search for monochrom atic (or quasi-monochrom atic) stationary electric eld solutions with well-de ned constant polarization: E  $(x;y;z;t)\quad u\quad (x;y)e^{i\left(z\right)}$ . That is, we analyze the following equation:

where  $L_0 = r_t^2 + k_0^2 n_0^2$  (x;y) and  $L_{\rm N\,L}$  (j j) =  $k_0^2 n_2^2$  (x;y)j j stand for the linear and nonlinear parts of the di erential operator L (j j), respectively. Due to the geometry of the air-holes distribution, both  $n_0$  (x;y) and  $n_2$  (x;y) are invariant under the action of the  $C_{6v}$  point-sym m etry group. This group is constituted by discrete =3-rotations (R =3) plus specular re ections with respect to the x and y axes:  $y^{R_1 \times r}$  y and  $x^{R_2 \times r}$  x, or, equivalently,  $r_1^{R_2 \times r}$  and  $r_2^{R_2 \times r}$  , in polar coordinates.

Our aim is to look for nonlinear solutions of Eq.(2) beyond the fundam ental solitons reported in Ref.[10]. Our search strategy will be based on group theory arguments, which will be enlightening in the classication and understanding of new solutions according to the sixth-fold symmetry of the system. In the linear case, this approach has been adopted to study the degeneracy of solutions in a PCF [11]. Here, we will use it to obtain analytical expressions for the angular dependency of solutions. A ccording to group theory, since  $L_0$  is invariant under the  $C_{6v}$  group, all its eigenfunctions have to lie on discrete representations of this group [12]. Solutions of the vortex type belong to one of the two two-dimensional representation of  $C_{6v}$ . A pair of functions (1; 1) (1 = 1; 2) be-

longing to these representations have the following transform ation properties:  $(1; 1)^R!^{-3}(1; 1; 1) = e^{i -3}$ ,  $(1; 1)^R!^{\times}(1; 1)$  and  $(1; 1)^R!^{\times}(1)^1(1; 1)$ . These sym metry constraints in pose the form of these functions:

where  $^{\rm s}$  (r; ) is a scalar function, characterized by  $^{\rm s}$  (r; + =3) =  $^{\rm s}$  (r; ) and  $^{\rm s}$  (r; ) =  $^{\rm s}$  (r; ), and  $^{\rm p}$  (r; ) is a pseudoescalar function characterized by  $^{\rm p}$  (r; + =3) =  $^{\rm p}$  (r; ) and  $^{\rm p}$  (r; ) =  $^{\rm p}$  (r; ) =  $^{\rm p}$  (r; ). Both  $^{\rm s}$  and  $^{\rm p}$  are periodic functions of , so they can be expanded in Fourier series in cos(6n ) and sin(6n ) (n 2 N ). Re ection sym m etry forces  $^{\rm s}$  ( $^{\rm p}$ ) to depend on the cosine (sine) term s only:  $^{\rm s}$  (r; ) =  $^{\rm s}$  n  $^{\rm s}$  n  $^{\rm p}$  (r; ) =  $^{\rm s}$  n  $^{\rm s}$  ln (r) sin(6n ).

In the nonlinear case, functions  $_1$  of the form given by Eq.(3) can satisfy self-consistency, according to group theory. The full operator L  $(j_1) = L_0(n_0) + L_{NL}(r^1_1^s;n_2)$  is invariant under the  $C_{6v}$  group because  $L_0$ ,  $r^1$ ,  $_1^s$  and  $n_2$  are all  $C_{6v}$  invariants. Thus L  $(j_1)$ , like in the linear case, provides the representation where  $_1$  lies on. However, group self-consistency is not su cient to ensure that the resolution of the nonlinear equation (2) with the ansatz (3) provides a nontrivial solution in all cases, since Eq.(2) always admits the = 0 solution. We solve Eq.(2) by means of the Fourier iterative method previously used in Ref.[10] to nd soliton solutions in PCF's. These solutions also full lithe group self-

consistency condition and they belong to the fundam ental representation of  $C_{6v}$ . The important dierence now is that we restrict ourselves to a dierent representation space; we search for nonlinear solutions in the l=1;2 representations of  $C_{6v}$ . The  $_1$  solution and its conjugate  $_1$  represent a vortex and an anti-vortex soliton of order l, respectively.




FIG. 2: E ective index of a fam ily of vortex solutions as a function of (solid line). Same for a fam ily of fundam ental solitons (dashed line), as in Ref.[10]. The shadow region corresponds to the conduction band, constituted by B loch modes, of the 2D photonic cladding with = 31 m and a = 10 m ( = 1064 nm).

We have simulated large-scale PCF's (in order to prevent silica breakdown [10]) with a lattice period, or pitch, = 31 m, and several air-hole radius at a xed wavelength = 1064 nm (a convenient quasi-continuum source). We de ne a dimensionless nonlinear param -=  $n_{2 \text{ (silica)}}^2 P = A_0$  (A<sub>0</sub> is an area parameter: eter as  $A_0 = (=2)^2$ ; P is the total power carried by the solution) and perform calculations for increasing values of . We discover that a family of optical vortex solutions of the type given by the ansatz (3) is found. The am plitudes of several solutions (with l = 1) for increasing values of are represented in Fig1(b)-(d). According to group theory (Eq.(3)), these amplitudes have to be scalar functions, thus showing full invariance under  $C_{6v}$ , and they have to vanish at the origin, as seen in Fig.1 (b)-(d). Besides, they becom e gradually narrow eras the nonlinearity increases. It is interesting to plot the e ective index of these solutions  $(n_e = -k_0)$  versus , as shown in Fig 2. The value of ne increases as increases, accordingly to the narrowing of solutions depicted in Fig.1 (b)-(d). For comparison, we have also included the n<sub>e</sub> () curve of the fundam ental soliton family for the same PCF structure, as in Ref.[10]. Both lie on the upper forbidden band of the perfectly periodic cladding structure. Here it can be clearly envisaged the role of the central defect. Notice that there is no threshold (power) to generate a nonlinear vortex soliton, i.e., there is a continuum of solutions in

starting from the linear (TE or TM) mode. Unlike in perfectly periodic structures, the defect can elim inate the presence of a threshold power [8]. If we consider structures where the linear mode is not present [13], a threshold is necessary to generate the nonlinear solution in the forbidden band. By playing with the geometric param eters of the PCF, it is possible to tune this threshold value. In all cases, this value is much lesser than in perfectly periodic structures, which can be important for experimental purposes.




FIG. 3: Phase of a vortex with l=1 at r=21 m. We represent both the total phase arg(1) (solid line) and the group phase arg(1) (dashed line).

Even more interesting is the phase behavior of these solutions. We show in Fig.3 a typical phase pro le of a PCF vortex calculated at a xed radius. It shows strict accordance with the group theory prediction for the phase:  $\arg(\ _1) = 1 \ + \ _1^p(r;\ ) = 1 \ + \ _{n=1}^1 b_{ln}(r) \sin(6n\ ).$  The phase of these vortex solutions diers from that of an ordinary vortex by the presence of the pseudo-scalar function extra term: the group phase. Besides the existence of the standard linear behavior in , the group phase provides an additional sinusoidal dependence on the angle (with period determined by the group order: =3 for order 6) not present in ordinary vortices.




FIG. 4: A xial evolution of  $h_{\rm e}$  (z) i for a diagonal perturbation. Inset: two snapshots of the asymptotic behavior of a non-diagonal oscillation instability (notice the dierent positions of the peak intensity).

In order to check the stability of a vortex soliton solution 1, we have to consider z-dependent perturbations. This implies solving the non-paraxial equation (1) for the perturbed eld  $^0 = _1 +$ . In terms of group theory, (1; 1) constitute a basis of the 1 representation of  $C_{6v}$ , so we can consider two types of perturbations around a vortex solution 1: diagonal perturbations, in which or remains in the one-dimensional subspace spawned by 1, and non-diagonal, where the perturbation takes 0 out of this subspace. An initial condition of the form  $^{0} = re^{i} \exp[(r=r_{0})^{2}]$  is an exam ple of diagonal perturbation for a vortex (l = 1). Nonparaxial evolution shows that a vortex is stable under diagonal perturbations. In Fig.4, we show the stabiliza-L()  $^{1=2}$  = $k_0$  to the  $n_e$  of an tion of hn<sub>e</sub> (z)i

asym ptotic vortex state. D iagonal perturbations generalize the concept of radial perturbations to the discrete sym metry case. We have also simulated non-diagonal perturbations. In this case, an oscillatory instability occurs, as seen in Fig.4 (inset). Non-diagonal perturbations correspond to azimuthal ones in the radially sym metric case. Despite the presence of azimuthal instabilities, no collapse is detected due to the non-paraxial nature of evolution [14].

Sum marizing, we propose a novel way of generating vortex solitons, based on PCF's, in which the presence of the defect plays a crucial role. Our analytical approach, based on group theory, is completely general and applies to any system owning a discrete invariance, no matter is periodic or non-periodic, linear or nonlinear. Finally, the use of a non-paraxial equation perm its to analyze new phenomena beyond the paraxial approximation.
