N on linear 2 + 1{D im ensional Field Equations from Incomplete Lie Algebra Structures

A bstract

We show that the nonlinear 2+1 {dimensional Three{W} ave Resonant Interaction equations, describing several important physical phenomena, can be generated starting from incomplete Lie algebras in the framework of multidimensional prolongation structures. We make use of an ansatz involving the structure equations of a principal prolongation connection induced by an admissible Backlund map.

1 Introduction

As it is well known, completely integrable nonlinear eld equations adm it Lax pairs, (multi() soliton solutions and an in nite set of conservation laws. It was pointed out that all these properties can be related with the existence of specick inds of Backlund transform ations (see e.g. [1, 2]).

In this context the prolongation structures m ethod, which can be interpreted as the construction of an Ehresm ann connection [3,4], plays a relevant role (see e.g. [5,6,7,8,9,10]). One of the most interesting features of the arising algebraic structures is that they are hom omorphic to in nite(dimensional loop algebras (see e.g. [11, 12, 13, 14] and references quoted therein). The inverse prolongation structures procedure can be thought as the search of the Backlund map which generates a given (incomplete) Lie algebra structure [5,6,7,8,4,10]. This inverse procedure, based on the Cartan method of moving frames, was rst outlined by Estabrook [5,6,7] who showed how exterior dierential systems can be obtained from incomplete Lie algebra structures. Further results concerning the (1+1){dimensional case were exploited e.g.: in [11,12,5,6,7,15,16,13,14]. Starting from a given incomplete Lie algebra structure, it is then possible to generate the eld equations whose prolongation structure is the given

algebra¹. In fact, the extension of both the direct and inverse prolongation structure procedure to the multi(dimensional case is not trivial and presents several technical diculties (see e.g. [14, 17]).

This note is aimed to give a contribution in the geometrical characterization of integrability properties of nonlinear eld equations in the fram ework of the inverse procedure in 2+1 dimensions. It is in fact well known that the study of higher dimensional systems is a central theme in the theory of integrable systems, nevertheless the investigation was always made in the direction of extension of (1+1) (dimensional systems to (2+1)) (dimensional ones just via the extension either of the Lax pair (see e.g.: [18]) or of the so (called prolongation forms (see e.g.: [19, 20]), as well as of the moving frames setting [21]. In this paper theme ore general approach of generating new (2+1) (dimensional integrable systems from a given abstract algebraic structure via the extension of a Backlund map is tackled.

We are, in general, interested in the case when incomplete Lie algebras arise as necessary conditions for integrability of a (form al) connection induced by a Backlund map [4], and the choice of a realization of such algebras (particularly in loop{algebras form) gives us the solution of the so{called Backlund problem. Conversely, if the algebraic structure is known and the 'new' variable (also called pseudopotentials [10]) dependence of the Backlund map is xed, the integrability condition for the form all connection induced by a Backlund map provides the whole family of exterior dierential systems which admits the given Backlund map.

We shall make use of an ansatz which is based on the fact that, from a geom etric point of view, the connection forms (induced by an admissible Backlund map) play the relevant role. This approach is then slightly dierent from the one formulated in the 2+1 (dimensional direct prolongation procedure by Morris and Tondo [19, 20] and it should be seen within the geometric approach in the framework of jet bundles and connections provided by Pirani et al. (see e.g. [4]). The ansatz is in fact a slightly modi ed version of the structure equations of the connection, which will be the starting point for the application of the inverse method. According to this, in Section 2 we recall how a connection can be induced by a Backlund map in the jet bundles framework and provide a characterization of completely integrable systems in terms of Backlund structures.

In Section 3, we give an example of physical application of such a generalized ansatz providing some nonlinear 2 + 1{dimensional eldequations describing various physical phenomena [19, 20, 23, 24, 25, 26]. We show that the 2+ 1{dimensional Three Wave Resonant Interaction (3W R I) equations, together with a condition on the group velocities which is related with the resonance condition, can be generated from an incomplete Lie algebra, as the integrability condition for a special class (which we shall call admissible) of Backlund connections. Our ansazt enables us on the other hand to generate a whole family of nonlinear eldequations related with the 3W R I equations by transformations of coordinates and elds of the Miura type. A lithefamily is in fact contained in the exterior dierential system admitted by a postulated (admissible) Backlund map as the integrability condition of the corresponding induced Backlund connection.

2 Backlund transform ations and induced Connections

In the following we shall shortly recall few basics concepts and set the notation. We shall assume the reader is familiar with the basic notions from the theory of bundles, jet prolongations, principal bundles and connections (for references and details see e.g. [27, 28, 29]).

Let :U : X, :Z : X, be two (vector) bundles with local bered coordinates $(x ; u^A)$ and $(x ; z^i)$, respectively, where $= 1; ::: ; m = \dim X$, $A = 1; ::: ; n = \dim U$ dim X, $i = 1; ::: ; N = \dim Z$ dim X. We shall assume that sections of the bundles U = (U ; X ;) and Z = (Z ; X ;) represent physical elds sastisfying a given system of (nonlinear) eld equations.

A system of nonlinear eld equations of order k on U is geom etrically described as an exterior di erential system on J^kU [5, 6, 7, 8, 9, 29, 30, 10]. The solutions of the eld equations are (local) sections of U ! X { i.e. (local) mappings : X ! U such that = igl { such that $(j^k)=0$. They de neas ubmanifold in J^kU . We shall also denote by J^1 (resp. j^l) the in nite order jet prolongation of (resp.).

2.1 A dm issible B acklund transform ations

We recall that the group of contact transform ations of a bundle is the group of its in nitesimal bered automorphisms. A contact transformation preserves then, by de nition, the bering (see e.g. [29, 30]). Let then B be the in nite(order contact transformations group on J^1 U [2].

In the following we recall some basic de nitions (see e.g. [2]) and stress some important properties which will be used later.

De nition 1 The group of Backlund transform ations for the system $\;\;$ is the closed subgroup K of B which leaves invariant J^1 . $\;\;\Box$

Denition 2 The group of adm is sible Backlund transform ations for the system is the closed subgroup K of B which leaves invariant solution submanifolds of J^1 .

R em ark 1 The contact transform ations group B acts freely on the in nite dim ensional submanifold of J^1 U de ned by J^1 . The group K of admissible Backlund transform ations is then the compact subgroup of B which preserves contact elements along the solutions of the given (system of) nonlinear eld equations. Thus K can be seen as the isotropy subgroup of B.

Let :U ! X , :Z ! X , be vector bundles as the above and 1 :J 1 U ! X , 1 :J 1 Z ! X , the rst order jet prolongations bundles 2 , w ith local bered coordinates (x ;u A ;u A), (x ;z i ;z i), respectively. Furtherm ore, let (0, 0_A , 0_A), (0; 0_i , 0_i) and

(dx , du^A , du^A), (dx ;dzⁱ , dzⁱ) be local bases of tangent vector elds and 1{form s on J^1U and J^1Z , respectively. In the sequelwewill be concerned with the pull{backs (Z)'ZU, (U)'UZ, (J^1U)'J^1UZ, where \rightleftharpoons ().

De nition 3 Following [4], we de ne a Backlund map to be the bered morphism over \mathbf{Z} :

R em ark 2 By pull(back of the contact structure on J^1Z , the Backlund morphism induces in a naturalway an horizontal (with respect to $_0^1$) distribution on the bundle ($J^1U_XZ;J^1U;_0^1$). The local expression of generators of such a horizontal distribution is given by the following connection form s

De nition 5 The horizontal distribution locally de ned by Eq. (3) is called the induced Backlund connection. \Box

Denition 6 The system is said to be completely integrable if there exists a normal subgroup K $_0$ (K \ K) B leaving invariant (the in nite order prolongation of) and its solutions.

Let $_k=\ _i^k\theta_i$ be generators of the Lie algebra k_0 of the Lie subgroup K $_0$, which satisfy the com mutation relations

where C^{n}_{lm} are the structure constants of the Lie algebra k_{0} .

Theorem 1 The following statements are equivalent.

- 1. is an adm issible B acklund transform ation for the di erential system $\,$.
- 2. The horizontal distribution (3) is K $_0$ {invariant.

Proof. If the horizontal distribution (3) is K (invariant, we have (see e.g. [29]):

Then the integrability conditions (2) for the Backlund map are equivalent to the integrable exterior di erential system:

In fact, taking Eq.s (3) into account, from the equivariance condition, the structure equations for the connection induced by the admissible Backlund map are (up to pull(backs):

where $!^k = !^k dx$ are 1{forms on J^1U , horizontal with respect to 1 . The integrability condition d $^i = 0$ is then equivalent to k $^i_k = 0$, i.e. to Eq. (6).

C onversely, if the Backlund m ap is adm issible for the system , then the group K $_0$ leaves invariant the solution (integral m axim al) subm an ifolds of , then the horizontal distribution induced by the Backlund m ap is K $_0$ { invariant.

C orollary 1 A nonlinear exterior system — is completely integrable if and only if there exists an admissible Backlund transform ation — for the dierential system —.

Proof. It follows from De nition 6 and the above Theorem.

3 The (2+1)-3W RI from incomplete Lie algebras

From a geometric point of view, the connection forms induced by an admissible Backlund map play a relevant role. Once that the dependence of the connection forms on the z^i variables is known³, the integrability condition (the i.e. zero curvature condition) for such a connection provides, via the inverse procedure and thanks to C orollary 1, whole families of integrable differential systems [11, 12, 5, 6, 7, 15, 16, 13, 14].

This suggests the introduction of an ansatz which is aimed to generalize the geom etric approach in the fram ework of jet bundles provided by Pirani et al. [4] and Hoenselaers [15]. The ansatz is in fact a slightly modi ed version of the structure equations, which will be the starting point for the application of the inverse method.

Let us then consider the following ansatz:

Thus, by requiring the structure equations (8) hold true, from the ansatz (9), we obtain the following integrable exterior di erential system:

The choice of brations of U over a basis manifold provides a whole family of nonlinear elds equations related by M iura's transform ations (see e.g. [11, 12, 16, 13, 14]). In the sequel we will not out the 3W RI equations making a speci c choice.

R em ark 4 Eqs. (30) { (32), together with their complex conjugate, are just the equations describing the resonant interaction of the three waves envelope in (2+1) dim ensions [23, 19, 20]. Equation (33) is related to the resonance condition for the wave envelope (see e.g: [23]).

3.1 Conclusions

We provided a characterization of completely integrable nonlinear eld equations in terms of algebraic properties of associated Backlund structures by investigating the relation between Backlund transformations and connections theory. As an example of application, by resorting to the structure equations induced by an integrable admissible Backlund map, we have shown how nonlinear (2 + 1) (dimensional eld equations can be generated starting from incomplete Lie algebras.
