Sem iclassical approximation for a nonlinear oscillator with dissipation

An $S \{m \text{ atrix approach is developed for the chaotic dynam ics of a nonlinear oscillator with dissipation. The quantum {classical crossover is studied in the fram ework of the sem iclassical expansion for the <math>S \{m \text{ atrix}. A \text{ nalytical expressions for the braking time and the } S \{m \text{ atrix} are obtained.}$

We consider here a sem iclassical dynamics of a nonlinear oscillator with dissipation. The main objective is to nd the breaking time of the quantum {classical crossover for the dissipative system. In the absence of dissipation, the breaking time, namely, the Ehrenfest time has been found [1] to scale logarithm ically with respect to the Planck constant h: $h = (1 =) \ln (I_0 = h)$, where I_0 is a characteristic action, and is a Lyapunov exponent. It characterizes the exact classical(to{quantum correspondence between the Ham iltonian equation ofmotion and the Ehrenfest ones [1, 2, 3, 4]. The renewed interest to this time is related to the extensive studies of the chaotic scattering in cavities [6], the Loschm idtecho [7] and observation of essential deviation from the logarithm ic scaling for systems with phase space structures [8, 9]. The nonlinear oscillator since the rst observation of the Ehrenfest time [1] is explored to study the quantum (classical correspondence [2, 3, 4, 5, 10]. This time species a fast (exponential) growth of quantum corrections to the classical dynam ics due to chaos. In the presence of dissipation the breaking time diers from the $_{\rm h}$ since the classical dissipation changes the local instability of trajectories. The breaking time $_{\rm h}^{\rm (d)}$ for a dissipative web map has been obtained [9] by the c-number projection of the Heisenberg equations on the coherent states basis. At the time $_{\rm h}^{\rm (d)}$, the quantum corrections is of the order of 1 and destroy the (sem i) classical behavior of the system . The subject of quantum dissipative chaos grew out of the the pioneering work on dissipative quantum maps [11], and various aspects of the extensive studies on quantum dissipative chaos are rejected in the recent reviews [12] as well. We show here in the framework of a S (matrix approach for chaotic dynamics of the nonlinear oscillator with a dissipation rate , that the breaking time $_{\rm h}^{\rm (d)}$ depends essentially on the ration between the dissipation rate $_{\rm h}^{\rm (d)}$ and the local instability characteristics the Lyapunov exponent . The Ham iltonian of the system can be written in the following non-Hermitian form

C reation and annihilation operators has the commutation rule $[a;a^y]=1$. The complex frequency !=i=2 determines the elective frequency !=i=2 in the presence of a nite width of the levels =2, and is the nonlinearity. The perturbation is a train of functions: $_T(t)=\frac{1}{n=1}$ (to $_T(t)$), characterized by the amplitude and the period T. Evolution of the wave function is governed by the quantum map

where the evolution operator U (T) over the period T corresponds to a free dissipative motion and then a kick. In our case it is a product of the unitary evolution operator U (T) and the decay operator B

Here the dimensionless semiclassical parameter $\tilde{n}=h$ T is introduced. In what follows this parameter is small: 1. To describe chaotic dynamics of the open system it is necessary to construct an S {matrix. To this end we close the system by means of the complementary conditions with an incident wave (t) and an outgoing wave $_{+}$ (t). Therefore, the quantum map (2) takes the following new form [13, 14]

Taking the closure of the system in the form $W_1(t) = W_1 \Big|_{n=1}^{P}$ (t nT), we obtain after the Fourier transform respect to time that the quantum map (4) takes the following form

Relation between the incident and outgoing waves is determined by the following expression $_{+}$ (E) = S(E), where S(E) is called the S(m atrix [13]. From this de nition and Eq. (6) the S(m atrix reads

It is known [15] (see also [13]) that the matrix V can be parameterized as follows

where $T = i \frac{p}{1 - B^2}$, and $W_1 = ihB^1T$; $W_2 = \frac{i}{h}W_1^yB = T^y$; $S_0 = B$. A first the parametrization (8), the S_1 fm atrix reads

Now, we consider the following autocorrelation function

The over-line means an average over the quasienergy ET from 0 to 2. It corresponds to the averaged cross(section [16]. The treatment of this form is analytically tractable, and in what follows we perform the semiclassical analysis for the correlation function. After simple calculations, we obtain

The evolution operator U (T) in the power T could be formally considered as the evolution operator for an arbitrary time T corresponding to the power, namely $U^{t}(T) = U(t)$.

where we use that $\tilde{h} = h$ T and t=T! t is a number of kicks represented in the continuous form. We take into account that the harm onic oscillator, acting on the coherent state, changes its phase only, and the perturbation acts as a shift operator. that essentially simplies the follows semiclassical consideration. In the limit many 1, the expression for the trace Matter (t) is strongly simplied and evaluated analytically. Following [5], we perform the linear transform $_1 = 2 + \% = 2$; $_2 =$ ñ = 2, with the Jacobian equals to 2ñ. After the variables change, we obtain from (15) and (16) the following sem iclassical expressions for the second exponential in (17)

Here $e^{T}=2a$ () is de ned in Eq. (15) and (16) for 0. Now we carry out integration over () and () in the classical lim it, neglecting the term of the order of \tilde{h}^2 of Eq. (19) in the exponential. Integral over in this case gives Q $\tilde{h} \stackrel{\text{T}}{:} \stackrel{=2}{:} a()^2$, and it leads to the exact integration over as well. Finely, we obtain for Eq. (17)

This expression could be evaluated by dierent approximations. For example, we can take approximately in the following form M (t) exp [TthIi], where hIi is som e classical action averaged over time with zero initial conditions. It corresponds to a chaotic attractor with a nite phase space volume for a specic choice of the parameters ;; and T. Inserting this into Eq. (11), we obtain a nite expression for the correlation function in the form

It is interesting to adm it that the autocorrelation function R (E) related to an averaged cross section corresponds to the Ericson uctuations (see i.g. [16]). Considering that E; ThIi are small and taking into account only the rst two terms in the expansion of the exponential in the denominator in (21), we obtain approximately, the following expression

where G = ThIi. This Lorentzian corresponds to the Erickson distribution of uctuations, see e.g. [16]. The important point of the consideration is the neglecting of the term $R^2 = d$ () a () . Therefore, to specify the validity condition of the performed semiclassical approximation and the obtained result one needs to evaluate M (t) taking into account the omitting term $O(\tilde{n}^2)$. To this end, at performing the integration over (), we use the following auxiliary expression

Substituting (18), (19) and (23) into (17), one obtains the following expression for the trace

The functional integration over () is exact and gives the {function in . Hence the integration over () is also exact. After these integrations we obtain from (24)

The validity of Eq. (20), which is the zero approximation, is the neglecting of the all terms higher than zero order in Taylor's series of Eq. (26). In the classical case, when $\tilde{n}=0$, the action $I_{cl}(\;;\;;\;)=I_{cl}(\;;\;;\;)$ for $=\;=0$ corresponds to a chaotic attractor under condition of strong chaos. A rough estimation of the classical chaotic attractor can be obtained from the stability condition e.g. of a limiting cycle with the minimum phase space volume of the order of 2 . In this case, the criterion of the chaotic attractor is

In the case, when a chaotic attractor exists, the strongest contribution to the sum s in Eq. (26) is due to the derivatives over the initial conditions determ ined by the following term

Therefore, the validity condition of the performed approximation is D (I_{c1} ; I_{c1}) exp[(T)t] < I_{c1} =ñ. Finely, we obtain the validity condition on time, which is a breaking time of the crossover between classical and quantum dynamics for the nonlinear kicked oscillator in the presence of dissipation:

It worth to underline that this result coincides with the breaking time obtained for a quantum chaotic attractor of a web map [9], where an existence of the classical chaotic attractor, namely, the dying attractor" (T! 0+) leads to the essential increasing of the applicability of the semiclassical approximation. Since the S-matrix corresponds to the quantum map of Eq. (4) considered on the period T, therefore, the conditions of the S {matrix approach application for studying the quantum chaotic attractor depends on the correlations between the Ehrenfest time $_{\rm h}^{\rm (d)}$, the period T and the relaxation time $_{\rm h}^{\rm (d)}$. There exist two important inequalities, that are important for the present analysis. The rst one is T > 1=, and it means that the relaxation process is fast and should not be taken into the consideration. The second inequality $_{\rm h}^{\rm (d)}$ > T means that the semiclassical approximation is valid for the S {matrix construction. In particular, the Ericson distribution of uctuations of the S-matrix (21) and (22) is valid. In the same time, a possible phase space structure of the chaotic attractor as a cantor set might be studied in the framework of the semiclassical S-matrix consideration on the nite time scale restricted by the breaking time (29).

the sem iclassical S-m atrix consideration on the nite time scale restricted by the breaking time (29). To complete the consideration, the criterion of chaos (27) should be explained. By denoting () = $\frac{p}{I()}$ (see also Eqs. (15) and (16)), an approximated map for the action (angle (I;) variables has the form

In spite of the map is an approximation of the exact analysis of [1], it is detailed enough in order to obtain a crude criterion of chaos. Therefore we obtain for the local instability condition $\mathfrak{F}_{+1}=0$ 1j 4 $\mathfrak{T}_{\overline{K}}$ e $\mathfrak{t}=K$ e \mathfrak{t} . The minimum action and correspondingly phase space volume in any moment is min(I) = inf $_0$ d 0 I(0) 2 . Therefore the condition for chaotic attractor is K 4 2 Te T > 1. It also follows that the condition for quantum chaos [4] $\tilde{h}=h$ T 1; = 4 2 =h 1 reads now $\tilde{h}=K$ > e T .
