# Speculative bubbles and fat tail phenom ena in a heterogeneous agent m odel

#### Abstract

The aim of this paper is to propose a heterogeneous agent model of stock markets that develop complicated endogenous price uctuations. We nd occurrences of non-stationary chaos, or speculative bubble, are caused by the heterogeneity of traders' strategies. Furtherm ore, we show that the distributions of returns generated from the heterogeneous agent model have fat tails, a remarkable stylized fact observed in alm ost all nancialmarkets.

K ey words: heterogeneous interacting agents, non-stationary chaos, speculative bubbles, leptokurtosis, fat tails

### 1 Introduction

D uring the past decade, the dynam ics of nancial asset prices resulting from interaction of heterogeneous agents have become of increasing interest. For exam ple, these price dynam ics have been studied A rthur et al. (1997), B rock and Hommes (1997, 1998), Chen and Yeh (2001), Chiarella (1992), Chiarella and He (1999), Chiarella et al. (2001), D ay and H uang (1990), D e G rauwe

et al. (1993), Farm er (2000), Frankel and Froot (1988), K im an (1991, 1993) and Lux (1995, 1998), Brock, Hommes and Wagener (2001), Gaunersdorfer and Hommes (2000), Kimman and Teyssiere (1998), LeBaron et al. (1999), Lux and M archesi (1999, 2000) and Youssefin ir and Hubern an (1997)). However, surprisingly few studies so far have tried to explain prolonged rises in asset prices, known as speculative bubbles, due to interaction of heterogeneous agents with di erent trading strategies and expectations. In contrast, a large number of both theoretical and empirical studies has been made on rational bubbles since Blanchard rst proposed this idea in 1979. The aim of this paper is to propose a heterogeneous-agent model that can generate speculative bubbles as a result of the interaction of heterogeneous agents. The theoretical set-up of the model presented here resembles that of previous works in many respects. We think of stock markets as consisting of a m arket m aker who m ediates the trading and generates the m arket-clearing price, and three typical types of traders that can be observed in nancial practice<sup>1</sup>: fundam entalists who believe that the asset price will return to the fundam ental price, chartists who base their trading decisions on an analysis of past price-trends, and noise traders who base their trading decisions on noisy information. Traders choose their trading strategy depending on the degree of accuracy of the price prediction. Our model di ers from previous works in that the traders' excess dem and functions for stock, which are derived from utility maxim ization, have lower but no upper lim its. We dem onstrate that this feature is an important factor in speculative bubbles. In particular, we derive the following results:

- 1. When the non-linearity of the excess dem and functions is su ciently strong, a speculative bubble or non-stationary chaos will be observed; that is, irregular uctuations of the asset price around an upward price trend appear.
- 2. W hen speculative bubbles occur in the stock m arket, irrational traders, namely, the chartists and noise traders, will drive out of the m arket rational traders, namely the fundam entalists.
- 3. A fat-tailed distribution of the relative stock price change appears.

The structure of the paper is as follows: Chapter 2 presents the heterogeneous interacting agent model. Chapter 3 investigates the local and global properties of the determ inistic dynamics in the model, and explains why speculative bubbles occur. Chapter 4 shows bubbles of stochastic dynamics

and the fat tailed distribution of returns generated from the model. Chapter 5 gives brief concluding remarks.

## 2 The M odel

Let us consider a simple stock market with the following characteristics. A large amount of stock is traded. In the market, there are three typical groups of traders with di erent strategies: fundamentalists, chartists, and noise traders. Traders can invest either in money or in stock. Since the model is designed to describe stock price movements over short periods, such as one day, the dividend from stock and the interest rate for the risk-free asset will be omitted for simplicity. Traders are myopic and bent on maximizing utility. Their utility depends on the price change they expect, and on their excess demand for stock rather than simply their demand. Their excess demand is derived from utility maximization. W hat follows is a more precise account of the decision making of each trader type.

### 2.1 Fundam entalists

Let  $Y_t^f$  be the am ount of m oney that a fundam entalist holds at time t and let  $X_t^f$  be the number of shares purchased by a fundam entalist at time t. Let  $p_t$  be the price per share of stock at time t. The fundam entalist's budget constraint is given by

where  $y_t^f = (Y_t^f \quad Y_{t-1}^f)$  denotes the fundam entalist's excess dem and for m oney, and  $x_t^f = (X_t^f \quad X_{t-1}^f)$  his excess dem and for stock. Suppose that the fundam entalist's preferences are represented by the utility function,

where  $p_{t+1}^{f}$  denotes the fundam entalist's expectation in period t about the price in the following period t+1. The parameters and are assumed to be positive. Inserting (1) into (2) the fundam entalist's utility maximization problem becomes:

The utility function u satis es the standard properties:  $u^{0}(jx^{f} j) > 0$ ,  $u^{0}(jx^{f} j) < 0$  for all  $jx^{f} j$   $jx^{f}$  jwhere  $jx^{f}$  jdenotes the absolute value of  $x^{f}$ producing a maximum utility. Thus, the utility function is strictly concave. It depends on the price change expected by fundamentalists  $(p_{t+1}^{f} p_{t})$  as well as the fundamentalist's excess demand for stock  $x_{t}^{f}$ . The rst part  $(p_{t+1}^{f} p_{t})x_{t}^{f}$  implies that a rise in the expected price change increases his utility. The remaining part expresses his attitude toward risk. Even if the expected price change is positive, he does not want to invest his total wealth in the stock, and vice versa. In this sense, fundamentalists are risk averse. is the parameter that sets the lower limitation on excess demand. All excess demand for stock derived from the utility maximization is limited to 1 = .W hen the expected price change  $(p_{t+1}^{f} p_{t})$  is positive, the maximum up he of the utility function is a positive. This means that fundamentalists

value of the utility function is also positive. This means that fundam entalists try to buy stock. By analogy, when the expected price change  $(p_{t+1}^f p_t)$  is negative, the maximum value of the utility function is negative, which means that they try to sell. The utility maximization problem (3) is solved for the fundam entalist's excess dem and,

Excess dem and increases as the expected price change  $(p_{t,t+1}^{f} \quad p_{t})$  increases. It should be noticed that the optimal value of excess supply is limited to 1 =, while the optimal value of excess dem and is not restricted. Since there is little loss of generality in xing the parameter at unity, below, we will assume to be constant and equal to 1.

Then let us think of the fundam entalist's expectation formation. We assume that he form his price expectation according to a simple adaptive scheme:

We see from Equation (5) that fundam entalists believe that the price m oves towards the fundam entalprice p by factor . To sum up fundam entalists' behavior: if the price  $p_t$  is below their expected price, they will try to buy stock, because they consider the stock to be undervalued. On the contrary, if the price is above the expected value, they will try to sell, because they consider the stock to be overvalued.

#### 2.2 Chartists

C hartists are assumed to have the same utility function as the fundamentalists (2). Their behavior is formalized as maximizing the utility function

where  $x_t^c$  and  $y_t^c$  represent the chartist's excess dem and for stock and for m oney at period t, and  $p_{t+1}^c$  denotes the price expected by him . The chartist's excess dem and function for the stock is given by

H is expectation formation is as follows: He is assumed to forecast the future price  $p_{t+1}^c$  using adaptive expectations,

where the parameter (0 < < 1) is a so-called error correction  $\cos - \operatorname{cient}^2$ . It follows that chartists try to buy stock when they anticipate a rising price for the next period, and, in contrast, try to sell stock when they expect a falling price.

#### 2.3 Noise traders

F inally, let us consider the noise traders' decision m aking. They are assumed to base decisions on noise in the sense of a large number of sm all events<sup>3</sup>. The behavior of a noise trader can be form alized as m axim izing the quadratic utility function

where  $x_t^n$  and  $y_t^n$  represent the noise trader's excess dem and for stock and form oney at time t, respectively. The noise t is assumed to be an IID random variable. The excess dem and function for stock is given as

where denotes the strength of the reaction to noisy information. In short, noise traders try to buy stock if they believe the noise to be good news ( $_t > 0$ ). Inversely, if they believe the noise to be bad news ( $_t < 0$ ), they try to sell it.

#### 2.4 The adjustment process of the price

Let us leave traders' decision-m aking processes and turn to the adjustment of the stock-m arket price. We assume the existence of a market maker, such as a specialist in the New York stock exchange. The role of the market maker is to give an execution price to incoming orders and to execute transactions<sup>4</sup>.

The market maker announces a price at the beginning of each trading period. Traders then determ ine their excess dem and, based on the announced price and on their expected prices. When the market maker observes either excess dem and or excess supply, he applies the so-called short-side rule to the dem ands and supplies, taking aggregate transactions for the stock to be equal to the minimum of total supply and dem and<sup>5</sup>. Thus traders on the short side of the market will realize their desired transactions. At the beginning of the next trading period, he announces a new price. If the excess dem and in period t is positive (negative), the market maker raises (reduces) the price for the follow ing period t+ 1. The process then is repeated. Let and be the fractions of chartists and of noise traders in the total number of traders, respectively. Then the process of price adjustment can be written as

where denotes the speed of the adjustment of the price, and n the total number of traders.

### 2.5 Strategy switching

Interesting questions are whether the rational traders (fundam entalists) will drive irrational traders (chartists and noise traders) out of the m arket, or whether the irrational traders (chartists and noise traders) will derive the rational traders (fundam entalists) out of the m arket. As in m any studies on heterogeneous interacting agent m odels (cf. B rock and H om m es (1997, 1998) and Lux (1998)), it m ay seem natural that switching between di erent trading strategies plays an important role. In this subsection, we ask the question how a trader m akes his choice between the fundam entalist and chartist strategies. The basic idea is that he chooses according to the accuracy of prediction. M ore precisely, we propose that the proportion of chartists to the di erence between the squared prediction errors of each strategy. Form ally, we write the dynam ics of the proportion of chartists as

where m easures how sensitively the mass of traders selects the optimal prediction strategy at period t. B rock and H om mes (1997, 1998) introduced this parameter as the intensity of choice to switch trading strategies. Equation (13) shows that if the chartists' squared prediction error  $E_t^c$  is smaller than that of fundam entalists  $E_t^f$ , some fraction of fundam entalists will become chartists, and visa versa.

### 3 Deterministic Dynamics

The aim of this section is to describe the dynam ic behavior of the model. In particular, we will indicate local and global properties of the determ inistic dynam ics when the parameter is allowed to vary. measures the strength of the non-linearity of the excess dem and functions. Substituting (4), (5), (8), (9) and (11) to (12), the model can be rewritten as

The rst of the equations above represents the adjustment of the price performed by the market maker. The second and third equations show the formation of the expectations of fundamentalists and chartists, respectively. The fourth equation represents the movement of the chartist fraction. Throughout this section, we assume that there exists no noise traders (= 0). Thus, the dynamics of the system (14) is deterministic. As can be checked easily, the dynamic system (14) has as an unique xed point: P (p;p<sup>f</sup>;p<sup>c</sup>) = (p;p;p).

#### 3.1 The local stability conditions

To investigate the dynam ics of the model, we shall not determ ine the local stability region of the unique equilibrium point P. The local stability analysis of the equilibrium point P is performed via evaluation of the three eigenvalues of the Jacobian matrix (14) at P. Let us denote by

the associated characteristic polynom ial of the Jacobian matrix at P, where  $D = (2 \quad 0.5 \text{ n} (1 + ))$  and  $T = (1 \quad 0.5 \text{ n} (1 + )(1 ))$ . A n eigenvalue of the Jacobian is 0, and the other roots  $_1$  and  $_2$ , satisfy the relation

Thus, the stability of the equilibrium point is determined by the absolute values of  $_1$  and  $_2$ . The eigenvalues  $_1$ ,  $_2$  are  $_{1;2} = T = 2 + = 2$  where

As is well known, a su cient condition for local stability consists of the following inequalities: (i)1 T + D > 0, (ii) 1+T+D > 0, and (iii) D < 1, giving necessary and su cient conditions for the two eigenvalues to be inside the unit circle of the complex plane. Elementary computations lead to the condition:

The above local conditions dem onstrate that while increasing starting from a su ciently low value inside the stability region, a loss of local stability of the equilibrium point P m ay occur via a ip bifurcation, when crossing the curve

#### 3.2 G lobal bifurcations

W hat happens as is further increased? We will see that rst, a stable 2-cycle appears; secondly, the time path of the price diverges; and thirdly, the time evolution of  $p_t$  displays a remarkable transition from regular to chaotic behavior around an upward time trend. It is important that the non-stationary chaos can be transformed to a stationary series by di erentiation once  $p_t = p_t p_{t\,1}$ . The price series uctuates inregularly around an upward price trend, and the series of the price change uctuates chaotically within a nite interval. Below, this non-stationary chaotic pricing will be referred to as a speculative bubble.

Let us look at these phenom ena using the num erical simulation. In all num erical simulations below, we will use a set of parameters given by

Figure 1 shows a bifurcation diagram with the parameter as the bifurcation parameter. The gure summarizes the long-run time evolution of the price change  $p_t$ , for values of the parameter 3 < < 7. By looking at Figure 1, it is evident that the dynamic behavior starts from a stable point, then goes through a sequence of period doubling bifurcations into a stable cycle of periods 2;4;8;16; ..., and so on. Then, the strange attractor set occurs for values beyond the cycle of period three, which appears at about = 6. This bifurcation scenario to chaos is the familiar route to chaos, that is to say, the Feigenbaum scenario.

### 3.3 Speculative bubbles

W hy does a speculative bubble or non-stationary chaos appear when increases? Unfortunately, it is di cult to prove m athem atically the existence of the strange attractor. However, as we shall see, it is possible to give an intuitive interpretation of speculative bubbles. To begin with, let us consider why chaotic behavior of the price change is observed for large values of . Figure 2 indicates a phase plot ( $p_t$ ;  $p_{t+1}$ ) of the sequence of price change  $p_t$  for = 5.5. The phase plot is constructed by iteration of 20000 times, but here we use just the last 10000 iterations. A glance at Figure 2 shows a xed point on the phase curve, depicted as an intersection between the phase curve and the 45-degree line<sup>6</sup>. As can be traced in this phase plot, a set of states of  $p_t$  initially located close to the xed point will rst be stretched, and then at some point will folded back on itself. This stretching and folding is the root of the chaotic price behavior (Form athem atical proof see Li and York (1975), and M arotto (1978).).

The next question is why speculative bubbles occur when is large. The price adjustment equation suggests that a price trend can occur only when excess dem and aggregated over two types of traders is positive on average. W hy would average excess dem and be positive as become large? For an answer, let us recall the traders' excess dem and functions (4) and (8).  $x_t$  denotes the traders' excess dem and, and  $p_{t+1}^e$  denotes the expected price. The partial derivative of the excess-dem and function with respect to the parameter is obtained as

where we assume = 1. This equation suggests a rise in increasing excess dem and exponentially, given the expected price change  $(p_{t+1}^e \quad p_t)$  is positive. As shown in the preceding subsection, the maximum value of the excess dem and increases freely when increases, while the maximum value of the excess supply never can be lower than 1 =, regardless of the value of . A ssum e that, in the initial state, the price  $p_t$  exceeds the fundam ental price p in period t, and that the chartists forecast a rise over the next period. The fundam entalists predict a falling price. Then, chartists try to buy and fundam entalists try to sell stock. When is su ciently large, one can safely state that chartist excess dem and will exceed fundam entalist excess supply. The

m arket m aker observes excess dem and, and raises the price for the following period. If the rise is strong, chartists m ay predict a new rise, which provokes yet another reaction of the m arket m aker. Once the price deviates strongly from the fundam ental price, the fundam entalists become perpetual sellers of stock, and when is su ciently large, the chartists' excess dem and m ay begin to exceed the fundam entalists' excess supply on average. Furtherm ore, fundam entalists m ay be driven out of the m arket by evolutionary com petition expressed by  $(13)^7$ . It follows that when the value of is su ciently large, average excess dem and is positive and speculative bubbles occur.

# 4 Stochastic dynam ics

To adjust the model to approximate real stock markets, we now assume the existence of noise traders. Below, we set = 0.3; i.e., 30 percent of the total number of traders are noise traders. Figure 3a and Figure 3b indicate the time series of the price and of the price change for = 5.5, disturbed by dynamic noise with t N (0;1). The gures show that the time series of the price has an upward trend and that it uctuates irregularly<sup>8</sup>. (Figure 3a

#### 4.1 Evolutionary com petition

A nother very interesting question is whether the irrational traders (chartists and noise traders) can survive competition against the rational traders (fundam entalists), or whether the rational traders (fundam entalists) can survive competition against the irrational traders (chartists and noise traders). Figure 4a illustrates the time series of the fraction of chartists for the parameters = 4 and = 0.3. The speculative bubble does not occur under this set of parameters. Figure 9a shows that t continues to uctuate around 0.35. This means that, on average, the same number of fundam entalists and chartists exists, and that the irrational traders will stay in the market forever. On the other hand, Figure 4b shows the time series of the fraction of chartists t for the parameters = 5 and = 0.3. There occurs a speculative bubble under this set of parameters. We see from Figure 9b that t nally converges to 0.7. This means that fundam entalists die out, and irrational

traders survive competition. The reason is the speculative bubble caused by the strong non-linearity of the excess-dem and functions. When speculative bubbles occur, the price continues to deviate from the fundam ental price, so that the prediction errors of the fundam entalists' trading strategy increase compared to those of the chartists' trading strategy. Therefore, the number of fundam entalists decreases and the number of chartists increases.

### 4.2 Fat tail phenom enon

A number of empirical studies have found that the empirical distributions of returns in alm ost all nancialdata show an unimodal bell shape, and possess excessive fourth moments, so-called leptokurtosis, (cf. Pagan (1996)). Figure 5 is a histogram of the stock-return series <sup>9</sup> for = 4. It is constructed by 20000 iterations of the system (14) with = 5.5. The shape of the histogram appears well behaved: an unimodal bell-shape. Table 1 presents sample statistics of the stock returns, which are based upon several series of 20000 data points. The sixth and seventh columns denote the dynam ic properties of the price and the price change, respectively. The mean value is very close to zero, and the standard deviation is small. The skewness is positive, and the kurtosis is signi cantly positive. The important result is that the histogram exhibits apparently more probability mass in the tails and the centre than the standard Norm al. Therefore, the time series of the returns are leptokurtotic, i.e., possessing excessive fourth moments.

However, the kurtosis is a relatively limited measure of deviation for Gaussian statistics. Recent literature inds that the distribution of returns is not only leptokurtotic, but also belongs to the class of fat-tailed distributions. This inding is generally accepted as a universal characteristic of practically all nancial returns. More form ally, it has been shown that the tails of the distribution of returns follow approximately a power law:

where the function F denotes the cumulative probability distribution of the normalized stock returns and is called tail index. We normalized the stock returns,

$$z_{t} = \frac{(r_{t} \quad hr_{t}i)}{(22)}$$

where  $hr_t i$  denotes the time average and denotes the standard deviation. The last column of Table 1 shows the values of the tail index for tail sizes up to 5 percent of the size of the return series generated from our model under various values of  $^{10}$ . Most empirical studies show estimates of falling in the range of 2 to 4 (cf. Pagan (1996), G opikrishnan et al. (1998)). In Table 1 the values of range between 2 and 4, as long as periodic solutions of the price are observed. Thus, we nd a power-law behavior for the cumulative distribution of the stock returns with well outside the Levy regime (0 < < 2). Consequently, the time series of the returns generated from the above articial stock market share this remarkable feature of actual data from stock markets.

# 5 Concluding Remarks

In this paper, we proposed a heterogeneous interacting agent m odel for stock m arkets. It generates three in portant ndings: (1) the non-linearity of the excess dem and functions derived from the traders' optim ization behavior m ight generate speculative bubbles; (2) fundam entalists m ay be driven out of the m arket by irrational traders, such as chartists and noise traders, provided a speculative bubble occurs; and (3) the return distributions derived from the m odel have fat tails, an in portant characteristic of em pirical nancial data which is observed in alm ost all nancialm arkets. There are, how ever, rem arkable di erences between the tim e series generated by our m odel and actual nancial data. For exam ple, the noisy tim e series of the price change

(Figure 3b) has strongly signi cant autocorrelations at the rst two lags (0.5 and 0.1), whereas in reality the series of price changes or returns have alm ost no signi cant autocorrelations at any lags. Furtherm ore, the returns series generated by the model exhibit no volatility clustering, which is a universal property of real returns series. A pparently, ourm odel is too sim ple to explain all stylized facts of real nancial data at the same time and, thus, needs to be further developed. This we have to future work.




Figure 1: The bifurcation diagram of the stock return when the parameter varies smoothly from 3 to 7. The other parameter values: = 0.001, n = 1000, = = 0.5, = 1, p = 100, = 0.001, and = 0.





Figure 2: A phase plot ( $p_t$ ;  $p_{t,1}$ ) of the sequence of price change  $p_t$  generated for = 5.5. The other parameter values are: = 0.001, n = 1000, = 0.05, = 1, p = 100, = 0.001, and = 0.






Figure 3: (a) The time series of the price for = 5.5, bu etcd with dynam ic noise with N (0;1). The other parameter values are: = 0.001, n = 1000, = = 0.5, = 1, p = 100, = 0.001, and = 0.3. (b) The time series of the price change for = 5.5, bu etcd with dynam ic noise with N (0;1). The other parameter values are: = 0.001, n = 1000, = = 0.5, = 1, p = 100, = 0.001, and = 0.3.




Figure 4: (a) The time series plots of the fraction of the chartists for the parameters = 4 and = 0.2. The other parameter values are: = 0.001, n = 1000, = = 0.5, = 1, p = 100, = 0.001, and = 0.3. (b) The time series plots of the fraction of the chartists for the parameters = 5 and = 0.3. The other parameter values: = 0.001, n = 1000, = 0.5, = 1, p = 100, = 0.001, and = 0.3.

The relative frequency




Figure 5: A histogram of returns generated from the time series of the price for = 5:5. The other parameter values are: = 0:001, n = 1000, = = 0:5, = 1, p = 100, = 0:001, and = 0:3.
