Comment on \Shadow ability of Statistical Averages in Chaotic System s"

Lai et al. [1] investigate systems with a stable periodic orbit and a coexisting chaotic saddle. They claim that, by adding white Gaussian noise (GN), averages change with an algebraic scaling law above a certain noise threshold and argue that this leads to a breakdown of shadow ability of averages. Here, we show that (i) shadow ability is not well de ned and even if it were, no breakdown occurs. We clarify m isconceptions on (ii) thresholds for GN. We further point out (iii) m isconceptions on the e ect of noise on averages. Finally, we show that (iv) the lack of a proper threshold can lead to any (m eaningless) scaling exponent.




FIG. 1: (a)  $hx^2i$  for the linear map vs. D with a = 0:7 and b = 0:75 (circles) and analytical  $thx^2i = x_2^2 + \frac{1}{1 a^2}D$ (full line). (b) hsin xi for the logistic map with a = 3:8008 and a polynomial t for D 1:4 10<sup>5</sup> (full line) (c) Scaling G (D D c) with D c 7 10<sup>6</sup> (circles) and least squares t (full line). All averages are for 10<sup>8</sup> iterations.

(i) Shadowing deals with m acroscopic error propagation of noise bounded by a small value (e.g. computer accuracy of 10<sup>16</sup>), comparing a noisy and a 'true' trajectory [2]. Since the authors use GN, one cannot properly speak of shadowing. However, even for bounded noise, their claims are still doubtful. In a recent work, the error of an average was found to be amplied by a factor of up to  $10^{12}$ , although the trajectory never exits the attractor [3]. This renders a reliable computation truly unfeasible. In [1], though, the e ect on the averages is only of the same order as the variation of the noise level D. Furtherm ore, the averages in Figs. 1a and 2a in [1] do change even less below D =  $10^{-2:5}$ . Therefore, shadow ability is not com prom ised at all.

(ii) The authors of [1] mention a threshold for GN above which the periodic orbit and the chaotic saddle would become connected. Yet, such a threshold does not exist, since the mean rst exit time h i is given by K ramers' law h i  $\exp(\frac{U}{D})$ , where D is the noise variance and U is either the potential [4] or, for nonequilibrium and chaotic systems, the quasipotential di erence [5]. Thus, h i varies with D, yielding a di erent average for every noise level.

(iii) Generally, averages depend on the noise for all noise levels, implying that no threshold can exist, even with only one metastable state. For the linear map  $x_{n+1} = ax_n + b + {}_n$  with a xed point  $x_? = \frac{b}{1 a}$  and white GN one gets  $hx^2i = x_?^2 + \frac{1}{1 a^2}D$ . This is pictured in Fig. 1a, tting perfectly the data. A lthough the average appears to be constant for low noise, it depends, in fact, on the noise for all D. The same applies also to nonlinear system s (cf. t in Fig. 1b) and bounded noise.

(iv) Because the value of the threshold is arbitrary, any scaling can be achieved, just by tuning D<sub>c</sub>, as things of the form of Eq. (1) of [1] are very sensitive to the value of D<sub>c</sub>. To verify this, we show in Fig. 1b the logistic map  $x_{n+1} = ax_n (1 \quad x_n) + D_n$  with  $h_n$ ; mi = nm as in [1].

The putative threshold of  $D_c = 10^{-5}$  is marked by an arrow. The graph is evidently not constant there. W ith  $D_c$  7 10<sup>6</sup> (rst arrow), a scaling G (D D c) results, with G of [1]. This yields 2:1 (Fig. 1c), in clear contrast to 1 reported in [1]. Therefore, no reliable (i. e. any) exponent can be obtained, since  $D_c$  is not well de ned from the outset.

As to the reply, the authors claim to have \a theoretical just <u>j</u> <u>cation</u> for the existence of a threshold" through  $D_c =$ = ln <sup>1</sup>, with the quasipotential (see (ii)) and the probability resolution. Contrary to Ref. [5] of the reply, where drops out since only proportionalities under param eter variation are considered, D <sub>c</sub> in [1] depends for xed parameters on and hence is not uniquely de ned. Applied to (iv) with  $D_c = 10^{-5}$  of 7:8 10  $^{10}$  (not shown) yields = 0:0004. [1] and But a ner resolution  $= 10^{7}$  gives D<sub>c</sub>  $= 7 10^{6}$ , 2:1 (cf. (iv)), whereas =  $10^{2}$  results in with  $D_{c} = 1:3 \quad 10^{5}$  and 0:21 (not shown). Again, this invalidates any proper scaling.
