# On the r-th dispersionless Toda hierarchy I: Factorization problem, symmetries and some solutions

#### A bstract

For a fam ily of Poisson algebras, param etrized by r 2 Z, and an associated Lie algebraic splitting, we consider the factorization of given canonical transform ations. In this context we rederive the recently found r-th dispersionless modi ed KP hierachies and r-th dispersionless Dym hierarchies, giving a new M iura map among them. We also found a new integrable hierarchy which we call the r-th dispersionless Toda hierarchy. Moreover, additional symmetries for these hierarchies are studied in detail and new symmetries depending on arbitrary functions are explicitly constructed for the r-th dispersionless KP, r-th dispersionless Dym and r-th dispersionless Toda equations. Some solutions are derived by examining the imposition of a time invariance to the potential r-th dispersionless Dym equation, for which a complete integral is presented and therefore an appropriate envelope leads to a general solution. Symmetries and Miura maps are applied to get new solutions and solutions of the r-th dispesionless modi ed KP equation.

#### 1 Introduction

The study of dispersion less integrable hierarchies is a subject of increasing activity in the theory of integrable systems. This was originated in several sources, let us metion mention here the pioneering work of K odam a and G ibbons [14] on the dispersion less KP, of K upershim dt on the dispersion less modi ed KP [18] and the role of R iem ann invariants and hodograph transform ations found by T sarev [9]. The important work of Takasaki and Takabe, [22], [21] and [23] which gave the Lax formalism, additional symmetries, twistor formulation of the dispersion less KP and dispersion less Toda hierarchies. For the dispersion less Dym (or Harry Dym) equation see [24]. The appearance of dispersion less systems in topological eld theories is also an important issue, see [17] and [4]. More recent progress appears in relation with the theory of conformal maps [10] and [25], quasiconformal maps and (12), reductions of several type [19] and [12], additional symmetries [20] and twistor equations [13], on hodograph equations for the Boyer(Finley equation [7] and its applications in General Relativity, see also [5] and [6]. It is

also remarkable the approach given in [8] to the theory. Finally, we comment the contribution on electrodynamics and the dispersionless Veselov (Novikov equation [16].

Recently, a new Poisson bracket and associated Lie algebra splitting, therefore using a Lax form alism and an r-m atrix approach, was presented in [1] to construct new dispersionless integrable hierarchies and latter on, see [2], the theory was further extended. We must remark that since the work [11] and [24] it was known the possibility for a r-matrix formulation of dispersionless integrable systems.

In this paper we shall use this new splitting together with a standard technique in the theory of integrable hierarchies, the factorization problem, to get a new dispersionless integrable hierarchy, which we call the r-th dispersionless Toda hierarchy. For that aim we consider the Lie group of canonical transform ations associated with a particular Poisson bracket together with a factorization problem induced by a r-m atrix associated with a canonical splitting of the corresponding algebra of sym plectic vector elds [1]. These new hierarchies contains dispersionless integrable equations derived previously in [1] | which we call r-th dispersionless modiled KP and r-th dispersionless Dym equations (for r = 0 we get the well-known dispersionless modiled KP and dispersionless Dym equations) | . However, we found new integrable hierarchies, which we decided to name as r-th dispersionless Toda hierarchy (as for r = 1 we get the well-known dispersionless Toda hierarchy).

In [3] the M iura m ap among the dispersionless modi ed KP and dispersionless D ym equations was presented, here we extend those results to the present context. We also study in detail the additional sym metries of these hierarchies and in particular for the three integrable equations: r-th dispersionless modi ed KP, r-th dispersionless D ym and r-th dispersionless Toda equations we get new explicit sym metries depending on arbitrary functions, in the spirit of the sym metries given in [5] for the dispersionless KP equation.

Latter we nd a complete integral for the  $t_2$ -reduction of the potential r-th dispersionless D ym equation. Thus, using the method of the complete solution, an appropriate envelope leads to its general solution. Then, when the sym metries are applied we get more general solutions, non- $t_2$  invariant of the potential r-th dispersionless D ym equation. Using the M iura map new solutions of the r-th dispersionless modiled KP equation are gotten and the corresponding functional sym metries are applied to get more general families of solutions. Finally, we also derive from the factorization problem twistor equations for these integrable hierarchies.

The layout of this paper is as follows. In x2 we consider the Lie algebra setting, the factorization problem and its dierential description, Lax functions and Zakharov {Shabat formulation are given, as well. Then, in x3 the corresponding integrable hierarchies are derived together with the M in x3 map. Next, in x4, we introduce 0 rlov functions and show how the factorization problem constitutes a simple fram ework to derive the corresponding additional symmetries of the integrable hierarchies. In particular, additional symmetries (which depend on arbritrary functions of x3 of the integrable dispersionless equations discussed in x3 are found. Finally, x3 is devoted to some solutions of these integrable hierarchies and x3 to a twistor formulation of these dispersionless integrable hierarchies derived from the factorization problem. In a forthcoming paper we will give a twistor formulation of these hierarchies which is derived independently of the factorization problem.

# 2 Factorization problem and its di erential versions

We shall work with the Lie algebra g of Laurent series H (p;x) :=  $\binom{p}{n2Z} u_n(x) p^n$  in the variable p 2 R with coe cients depending on the variable x 2 R, with Lie commutator given by the following Poisson bracket [1]

We remark that allowing the variable p to take values in C we have the following interpretation for the above splitting (2). Suppose that g is the set of analytic functions in some annulus of p=0. Then, H 2 g $_{<}$  i H (p)p  $^{1+r}$  is an analytic function outside the annulus which vanish at p=1. On the opposite a function H 2 g $_{>}$  if H (p)p  $^{1+r}$  has an analytic extension inside the annulus.

## 2.2 The factorization problem

Given an element H 2 g the corresponding vector eld  $ad_H$  generates a sym plectic diesorm orphism (canonical transform ation)  $_H$ , given by

This transform ation corresponds to the element  $h=\exp(H)$  belonging to the local Lie group G generated by g. In fact,  $H=A\,d_h$ , the adjoint action of the Lie group G on g.

In what follows we shall denote by  $G_<$ ;  $G_1$  r;  $G_>$  and  $G_>$  the local Lie groups corresponding to the Lie algebras  $g_<$ ;  $g_1$  r;  $g_>$  and  $g_>$ , respectively.

# 3 The associated dispersion less integrable hierarchies

We now deduce the integrable hierarchies associated with the factorization problem (4), namely the r-th dispersionless modiled KP, r-th dispersionless Dym and r-th dispersionless Toda hierarchies.

## 3.1 The r-th dispersionless modi ed KP hierarchy

# 4 Additional sym metries

In this section we deal with the additional symmetries of the integrable hierarchies just described. We rst introduced the O rlov functions M; M; m in this context and the consider the construction of additional symmetries. We compute explicitly some of these additional symmetries for the potential r-dm KP (32), the r-dD ym (44) and the r-dT oda (56a) equations, nding explicit symmetries of these nonlinear equations depending on arbitrary functions of the variable  $t_2$ .

Thus, given a solution X of the potential r-dD ym equation (44) and arbitrary function T ( $t_2$ ) a new solution  $\hat{X} = X$  (s) is given by (95). The corresponding sym m etry of the r-dD ym equation (47) is

$$v = T^{\frac{1}{3}r} v(x; T(t_2)^{\frac{2}{3}r} t_1; T(t_2))$$

When r = 1 we nd for the following PDE

whose solution is

## 4.5 Sym m etries of the r-dToda equation

The r-dToda equation (56a) m ixes the independent variables x,  $t_1$  and  $t_1$ . Let us analyze the sym m etries associated with the  $t_1$ -ow; i. e., study the action of additional sym m etries generated by F (L;M). Suppose that N=1, then we have the cases n=1 r and 2 r, so that we have two di erent generators, namely

 L<sup>1 r</sup> and  $\frac{M}{(2 r)L}$  L<sup>2 r</sup>:

We rst observe that

If we denote

we have the following Taylor expansion

$$(t_1 + ") = (t_1) + _(t_1)" + \frac{1}{2} (t_1)"^2 + \frac{1}{6} " (t_1)"^3 +$$

$$= (t_1) + \frac{1}{2 r} _(t_1) \times L^{-1} + \frac{r}{2 r} _{1 - (t_1)} + \frac{1}{2(2 r)^2} (t_1) \times^2 L^{-2} +$$

leading to the sym m etry

$$^{\sim} = x \log T_{-} + (x;T(t_1);t_1):$$

There are additional sym m etries associated with the  $t_1$  ow . Now N = 1 and n =  $\,$ r and n = 1  $\,$ r and there are two di erent generators:

$$\frac{M}{rL^{-1}}L^{1-r}$$
 and  $\frac{M}{rL^{-1}}L^{-r}$ :

Notice that

with

we also have the following Taylor expansion

The two generators are

$$F = (t_1)L^{r} \frac{1}{r} - (t_1)X L^{1}^{r};$$

To deal with the sym metries we recall that

$$\frac{d_{1}r}{ds} = P_{1}rAd_{1}rF(L;M) = P_{1}rF(';m);$$

$$\frac{d_{1}r}{dt} = P_{1}rAd_{1}rL^{1}r^{n} = P_{1}r^{1}r^{+n};$$

With the rst generator given in (96) we have

$$\frac{1}{1} \frac{X_{s}}{X_{x}} = (t_{1});$$

so that X is subject to the following PDE

$$X_{s} = (1 \ r) \ (t_{1})X_{x}$$

whose solution is

$$X (s) = f(x + s(1 r) (t_1);t_1;t_1);$$

with f an arbitrary function. Then, the corresponding symmetry transformation is given by

$$\tilde{X} = X (x + (1 r) (t_1); t_1; t_1):$$

For the second generator in (97) we not the following PDE

$$X_{s} = (t_{1})X_{t_{1}} \frac{1 r}{r} (t_{1})X_{x}$$

whose general solution is

$$X (s) = f x (t_1)^{\frac{1-r}{r}}; s + \frac{Z}{t_1} \frac{dt}{(t)}$$

with f an arbitrary function. Proceeding as before we nd a new symmetry:

$$\hat{X} = X \left( T - (t_1) \right)^{\frac{1-r}{r}} x; t_1; T (t_1)$$

with T an arbitrary function on  $t_1$ .

For the r=1 case we may proceed as above, however notice that in the r=1 case we have the dToda equation,  $(\exp(x))_x + t_1 t_1 = 0$ , the interchange of  $t_1$  and  $t_1$  leaves the equation invariant. Thus, the symmetries are as the one derived already for the F (L;M) generators but replacing  $t_1$  by  $t_1$ . Namely:

$$^{\sim} = (x;t_1;t_1) + (t_1);$$
  
 $^{\sim} = x \log T - (t_1) + (x;t_1;T(t_1))$ 

We collect these results regarding the r-dToda equation in the following

Proposition 9. Given a solution X of the r-dToda equation

  $\frac{1}{(1-r)r} \frac{X_{t_1}}{X_x} = 0;$ 

and arbitrary functions  $(t_1)$ ,  $T(t_1)$ ,  $(t_1)$  and  $T(t_1)$  the following functions are new solutions of the r-dToda equation:

$$\hat{X} = X (x;t_1;t_1) (1 r) (t_1);$$
 $\hat{X} = T_-(t_1)^{\frac{1-r}{2-r}} X (x;T (t_1);t_1);$ 
 $\hat{X} = X (x + (1 r) (t_1);t_1;t_1);$ 
 $\hat{X} = X (T_-(t_1)^{\frac{1-r}{r}} x;t_1;T (t_1)):$ 

Finally, observe that the sym m etries derived for the r=1 case, i. e., the Boyer(Finley equation (exp(x))x +  $t_1t_1 = 0$ , are:

$$\begin{array}{lll} & \sim = & (x; t_1; t_1) + & (t_1); \\ & \sim = & \log T_-(t_1) + & (x; T(t_1); t_1); \\ & \sim = & (x; t_1; t_1) + & (t_1); \\ & \sim & = & \log T_-(t_1) + & (x; t_1; T(t_1)); \end{array}$$

These sym metries are the well known, since 1986 by P.O lver, conformal sym metries of the dToda equation.

# 5 On $t_2$ invariance and solutions for the potential r-dD ym and r-dm KP equations

Here we study the  $t_2$  invariance on the equations potential r-dD ym equation (44) and using the M iura type m ap corresponding solutions for the  $t_2$  invariant solutions of the r-dm KP equation (34), which we may call r dipersionless modi ed Boussinesq equation.

# 5.1 $t_2$ -invariance for the r-dD ym equation

We analyze here solutions of the (44) which do not depend on one of the variables  $t_2$ . Thus, (44)  $sim\ pli\ es\ to$ 

$$(1 r) X_{t_1 t_1} X_x = (2 r) X_{x t_1} X_{t_1}$$

which can be written as

$$(\log (X_{t_1}^{1}))_{t_1} = (\log (X_x^{2}))_{t_1}$$

so that

$$\log \frac{X_{t_1}^{1} r}{X_{x}^{2} r} = 0:$$

This last equation is equivalent to

$$\frac{1}{k^0(x)}X_x = X_{t_1}^{\frac{1-r}{2-r}}$$

where  $k^0$  is the derivative of k(x), an arbitrary function of x. Thus, if we introduce the variable x = k(x) we have

$$X_{*} = X_{t_1}^{\frac{1-r}{2-r}}:$$

This is a rst order nonlinear (for  $1 ext{ r } \in 0$ ) PDE, and we will solve it by the the method of the complete solution. First observe that a complete integral is

$$X (x;t_1;a;b) = a^{\frac{1}{2}r}x + at_1 + b$$
:

Set b = f (a) so that we get a uni-param etric family of solutions depending on arbitrary function

$$X (x;t_1;a) = a^{\frac{1}{2} r} x + at_1 + f(a)$$
:

To nd the envelope of this solution we request

$$X_a = \frac{1}{2} \frac{r}{r} a^{\frac{1}{2}r} x + t_1 + f^0(a) = 0;$$

which determ ines locally a solution of the form

$$a := a(x;y)$$
:

Then, the corresponding envelope is given by

$$X (x;t_1) = a(k(x);t_1)^{\frac{1-r}{2-r}}k(x) + a(k(x);t_1)t_1 + f(a(k(x);t_1))$$

which depends on two arbitrary functions k and f on one variable, being therefore a general solution.

For example, if f = 0 we get

$$a(x;t_1) = \frac{1 r x^{2}}{2 r t_1}$$

and the solution is

$$X = \frac{(x)^{2} r}{t_{1}^{1} r}; \qquad (x) = (1)^{1} r \frac{(1 r)^{1} r}{(2 r)^{2} r} k(x); \qquad (98)$$

Observe that may be considered is an arbitrary function.

We may get more general solutions of the potential r-dDym equation (44) which are not  $t_2$  invariant by applying the symmetries given in Proposition 7. We have the following new solutions

$$\hat{X} = \frac{(x)^{2-r}}{t_{1}^{1-r}} \quad (1 \quad r) \quad (t_{2});$$

$$\hat{X} = \frac{(1-r)(2-r)}{2(3-r)} - (t_{2})(-(t_{2}) + 2t_{1}) + \frac{(x)^{2-r}}{(t_{1} + -(t_{2}))^{1-r}};$$

$$\hat{X} = \frac{(1-r)(2-r)^{-2}}{2(3-r)^{-2}} t_{1}^{2} \frac{T(t_{2})}{T-(t_{2})} + \frac{(x)^{2-r}}{(T-(t_{2})t_{1})^{1-r}};$$

The second and third family are non trivial solutions depending on on two arbitrary functions of one variable each.

The case f (a) =  $\frac{2 r}{r}$  a  $\frac{r}{2 r}$  leads to the equation

$$^{2} + \frac{1}{2} \frac{r}{r} \times + t_{1} = 0; A = a^{\frac{1}{2}r}$$

whose solution is

$$= \frac{1}{2} \frac{r}{r^{\frac{*}{2}}} = \frac{s}{(1 + r)^{\frac{2}{2}} \frac{x^{2}}{4}} t_{1}$$

and the solution is

$$X = \frac{x}{r} + \frac{t_1}{2} + \frac{2r}{r}$$

Finally, if we consider f (a) =  $\frac{2 r}{1+r} a^{\frac{2}{1+r}}$  and introduce the functions

$$F = {\overset{\text{V}}{=}} \frac{\frac{\text{S}}{\text{S}}}{108t_1 + 12 \overset{\text{P}}{\text{3}}} \frac{\text{S}}{4 \frac{(1 \text{ r})^3}{(2 \text{ r})^3} \times^3 + t_1^2}; = \frac{1}{6}F + 2 \frac{1 \text{ r}}{2 \text{ r}} \frac{\text{x}}{F}$$

a solution is

$$X = \frac{x}{r} + \frac{t_1}{2} \frac{2 r}{1 + r}$$

## 5.2 Solutions of the r-dm KP through M jura m ap

As an example we shall use the Miura map

$$\frac{1}{(1 + r)(2 + r)} X_{t_1} (X (x;t_1;t_2);t_1;t_2) = u(x;t_1;t_2)$$

to get a solution of the r-dm KP equation from the solution of the r-dD ym equation as given in (98), which is  $t_2$  independent. The inverse function X is given, in this case in explicit form, by

$$X (x;t_1;t_2) = k^{-1} \frac{xt_1^{1-r}}{C}$$
;  $C = (1)^{1-r} \frac{(1-r)^{1-r}}{(2-r)^{2-r}};$ 

and as

$$X_{t_1} = C (1 r) \frac{k(x)^{2} r}{t_1^{2} r}$$

we get the corresponding solution of the r-dm KP equation (34)

$$u = \frac{1}{2 r t_1} x$$
 (99)

The corresponding solution of the potential r-dm KP (32) is

$$_{1} = \frac{1}{2(2 \text{ r})} \frac{x^{2}}{t_{1}};$$

and applying Proposition 5 we get the following solutions

Observing that

$$X_{t_1} = X_a a_{t_1} + a$$

and recalling that  $X_a = 0$  we get the corresponding solution

$$u = \frac{1}{(1 \text{ r})(2 \text{ r})} a(X;t_1;t_2)$$

of the potential r-dm KP equation.

# 6 Twistor equations

P reviously we have introduced the Lax and O rlov functions as the following canonical transformations of the pair p;x:

$$L = Ad < exp p;$$
 '=  $Ad > expt p;$   $L = Ad > expt p;$   
 $M = Ad < exp p;$   $m = Ad > expt x;$   $M = Ad > expt x:$ 

Thus, they satisfy

These functions result from the canonical transform ation of the p;x variables generated by the initial conditions h;h of the factorization problem (4).

W e are ready for

P roposition 10. For any solution < and > of the factorization problem (4) the following twistor equations hold
