#### Abstract

A ccording to a theorem in [1], the conserved functionals of the K dV equation van ish on each form al Laurent series $1=x^{2}+u_{0}+\underset{k=2}{+1} u_{k} x^{k}$. W e propose a new, very sim ple geom etrical proof for th is statem ent. $K$ eyw ords: K dV equation, sim $m$ etries and conservation law $s$, form al Laurent series.

## 1 Introduction.

Three years ago, $T$ reves obtained a new characterization for the conserved quantities of $K$ dV theory. R oughly speaking, his result concems functionals which are integrals of di erential polynom ials, and their evaluation on form al Laurent series with com plex coe cients in one variable $x$ (de ning the integral as the residue in $x$ ). For each functional $h$ of this kind on the Laurent series, $T$ reves [1] proved the equivalence betw een a) and b) :
a) $h$ is a conserved functional for the $K d V$ equation;
b) $h(u)=0$ for each Laurent series of the form $u=1=x^{2}+u_{0}+{ }_{P=2}^{+1} u_{k} x^{k} \quad\left(u_{0} ; u_{2} ; u_{3} ;::: 2 C\right)$. Subsequently, T reves obtained a sim ilar result for the m odi ed $K d V$ equation and derived the analogue of a) =) b) for the conserved functionals of the nonlinear Schrodinger equation [2].
In all cases analysed by $T$ reves, the proof of either a) =) b) or b) =) a) is very long. A sim pli ed derivation for the $K d V$ case, still based on the logic of the $T$ reves proof, was given by D ickey; this author also found a new proofofa) =) b) for the $K$ dV , and established its analogoue for the B oussinesq theory, using the dressing $m$ ethod for the Lax operator [3].
W e becam e aw are of the above results very recently, due to a talk given in M ilano by P rof. T reves [4], and we soon developed an interest in a further sim pli cation of the proofs. W e investigated in particular the im plication $a)=$ ) b), concentrating forbrevity on the $K d V$ case and trying to isolate a single geom etrical property of the conserved functionals, su cient to derive the thesis. The conclusion of our analysis is described in this Letter: here we propose a proof of a) =) b) for the $\mathrm{K} d V$, di erent from the ones of T reves and D ickey and possessing in our opinion the previously asked feature; the sam e approach could be probably used for other integrable system s.
O ur argum ent can be described in very few lines, in the follow ing way:
I) the conserved $K$ dV functionals are know $n$ to be invariant under the $B$ acklund transform ation (often called auto Backlund) M R $M^{1}$, where M and $R$ are the $M$ iura and re ection transform ations, respectively. This is the geom etricalproperty from which everything follow s.
II) Apy Laurent series $u=1=x^{2}+u_{0}+{ }_{k=2}^{+1} u_{k} x^{k}$ is the Backlund transform of a series $w=$ $\mathrm{w}_{0}+\quad{ }_{\mathrm{k}=2}^{1} \mathrm{w}_{\mathrm{k}} \mathrm{x}^{\mathrm{k}}$ 。
III) If $h$ is a conserved $K d V$ functional and $u$, $w$ are as before, we have $h(u)=h(w)$; on the other hand, $h(w)=0$ for a trivial reason: in fact, this is the integral of a series $w$ ith no negative pow ers of $x$ and thus $w$ th zero residue. $T$ he conclusion is $h(u)=0$.
$T$ he rest of this Letter is sim ply a rigorous form ulation of item SI)-III). In Section 2 , to $x$ the language we give som e background on di erentialpolynom ials, fiunctionals, $K$ dV theory and state precisely the Treves theorem; in Section 3, we review the Backlund transform ation and form alize statem ent I) in the fram ew ork of Laurent series. Expert readers can skip most of the prelim inaries in these two Sections, and conœentrate on: Eq.s (2.14-2.15) describing the space of Laurent series; Eq.s (3.3-3.6) on the Backlund transform ation and the invariance of $K$ dV functionals. In Section 4, we prove II) and show a) ) b) along the lines of III).
Let us point out how the idea I)-III) could be em ployed in relation to other integrable equations. First of all, one needs a B acklund transform ation leaving invariant the conserved functionals. Trivially, all functionals of the theory vanish on the subspace of form al series $w$ ith no negative pow ers of $x$. O ne should start from this subspace or a subset of it, and characterize its im age under the Backlund transform ation; the latter is $m$ ade of nontrivial Laurent series, on which the conserved functionals are again zero. In the $K d V$ case, the starting set and its $B$ acklund im age consist, respectively, of the series $w, u m$ entioned in II).
Som e term in ology. A llvector spaces considered in this Letter are over C. By a di erentialalgebra, we $m$ ean an associative and com $m$ utative algebra equipped $w$ ith a derivation, i.e., $w$ ith a linear $m$ ap of the algebra into itself having the Leibnitz property w r.t. the product. A m orphism of di erential algebras is an algebraic $m$ onphism respecting the derivations.

## 2 Form al variational calculus, $\mathrm{K} d V$ and the $T$ reves theorem.

In all concrete $m$ anipulations, the $K d V$ equation ( $d=d t$ ) $q=q_{x x x} \quad 12 q q_{x}$ is understood as a vector eld on som e "space" $Q$, whose elem ents $q$ are "functions of one variable $x$ ". The analysis of this vector eld is greatly sim pli ed if one assum es $Q$ to be closed under pointw ise sum $s$ and products, and under the operation $q 7$ $q_{x}$ of derivation $w$ r.t. $x$; in this case, $Q$ is a di erential algebra.
Investigations in this area soon $m$ ade clear that the striking features of $K d V$ are largely independent of the choige of the di erential algebra Q ; the sam e can be said for other integrable PD E s, discovered shortly after it. To take this fact into account, Gelfand and D ickey (see [5] and references therein) invented a form al variational calculus, allow ing to describe the K dV and sim ilar system $\mathrm{s} w$ ithin a very pure algebraic setting. H ereafter we illustrate som e facts about this calculus, in a fashion convenient for our purposes (and partly inspired by the setting of [1]).
Form al variational calculus for K dV theory can be based on the com $m$ utative algebra

The com position product $F$ G 2 F is the polynom ial obtained from the expression of F replacing ; $\mathrm{f}_{\mathrm{x}}$;:: w ith G , $@ G ;:::\left(^{2}\right)$. For each xed $G$, the mapping $F T F \quad G$ is the unique autom onphism of the di erential algebra $F$ sending into $G$. The operation is associative, so ( $F$; ) is a monoid with unit .
 this notation for the derivation is purely conventional). Then, we can represent the elem ents of $F$ as transform ations of $Q$ into itself. M ore precisely, if $F 2 \mathrm{~F}$ and $q 2 Q$, let us denote with $F$ (q) $2 Q$ the

W e point out the rem otion ofbold typeface to distinguish this $m$ ap from $F$; in particular, the transform ation $: Q$ ! $Q$ induced by is just the identity $m$ ap $q 7$ q. As $F$ ranges over the whole $F$, we get a correspondence

N ow, the set $P$ ol ( $Q ; Q$ ) of polynom ial $m$ aps $Q$ ! $Q$ is itself a com m utative algebra, w ith all the operations de ned pointw isely: for $K ; L: Q!Q$ and $2 C, K+L, K, K L: Q!Q$ are the $m$ aps $\mathrm{q} 7 \mathrm{~K}(\mathrm{q})+\mathrm{L}(\mathrm{q}), \mathrm{q} 7 \mathrm{~K}(\mathrm{q}), \mathrm{q} 7 \mathrm{~K}(\mathrm{q}) \mathrm{L}(\mathrm{q})$. $\mathrm{Pol}(\mathrm{Q} ; \mathrm{Q})$ is also a m onoid w th the usual com position ofm aps $F \quad G: q 7 \mathrm{~F}(\mathrm{G}(\mathrm{q})$ ) and the identity $m$ ap as unit; it tums out that (2.4) is a monoid monphism between ( $F$; ) and ( $\mathrm{P} \circ \mathrm{l}(\mathrm{Q} ; \mathrm{Q}$ ); ).
$D$ ue to the previous facts, it is helpfill for intuition to think the elem ents of $F$ as transform ations, even when no di erential algebra ( $Q$; x) is speci ed.
The next step in form al variational calculus is the introduction of functionals, which are "integrals" of transform ations. The only property needed for the integral is to vanish on a derivative; for this reason $G$ elfand and $D$ ickey de ned this operation as the quotient $m$ ap

is well de ned (i.e., independent on the choice of $F$ within the equivalence class $f$ ); we call this the com position betw een $f$ and $G$. O ne easily checks the associative property ( $f \quad G$ ) $G=E \quad(G \quad G)$ for any $\mathrm{G}^{0} 2 \mathrm{~F}$.
To get concrete countenparts of functionals, consider any di erential algebra ( $Q$; x), and de ne an integration for it to be any linear $m$ ap

[^1]O ne can then go on at the level ofF, de ning notions such as vector elds (identi able w ith elem ents of $F$ ), and the ( $\mathrm{L} i \mathrm{e}$ ) derivative of a functionalh along a vector eld X ; if the latter vanishes, we say that $h$ is conserved by $X$ (see 5] and references therein).

An outstanding feature of $K d V$ theory is that $Z_{K d v}$ is in nite dim ensional (as a vector space over C). A basis for it is well know $n$ and consists of countably $m$ any functionals $\left(h_{k}\right)_{k=1 ; 2 ;::, ~ f o r ~ w h i c h ~ s e v e r a l ~}^{\text {for }}$ equivalent constructions are available: for exam ple, one can use the M agri-Lenard recursion schem e [6]. T he rst elem ents are

W e nally come to the $T$ reves theorem, conceming the $K$ dy conserved functionals an their representation on a particular integral-di erential algebra ( $Q$; $;$; ) . By de nition, this is $m$ ade of form al Laurent series in one indeterm inate x and com plex coe cients, i.e.

A s anticipated, the rest of this Letter is a new geom etrical proof of the im plication a)=) b).

## 3 A review of the $M$ iura and $B$ acklund transform ations.

The basic facts on these transform ations can be stated in the language of form al variational calculus; so, we consider the algebra F of the previous Section, and state the follow ing
3.1 De n ition. The M iura and re ection transform ations are

Both $M$; $R$ are elem ents of $F$, so they can be com posed as explained previously; of course $M \quad R=$ $x^{+}+2^{2}$. We can as well com pose functionals $2 \mathrm{~F}=\mathrm{Im} @ \mathrm{w}$ th these transform ations; for exam ple, com posing the rst $K d V$ conserved functionals (2.13) with the $M$ iura transform ation we obtain

$T$ he follow ing facts are know $n$ from the very beginning of $K d V$ history:

i) $\mathrm{h} M$ is a conserved functional for the modi ed KdV vector eld $\mathrm{X}_{\mathrm{mKdv}}:=\mathrm{xxx}^{24}{ }^{2}{ }_{\mathrm{x}}$. ii) $h \quad M$ is invariant under re ection: ( $h \quad M$ ) $R=h \quad M$.

R eferences for the proof. For i), see the originalpapers by M iura et al [7]. ii) is proved recursively for allelem ents $\left(h_{k}\right)_{k=1 ; 2 ;::: ~ i n ~ t h e ~ b a s i s ~ o f ~}^{k}{ }_{k}$ dv , using the $M$ agri-Lenard recursion relations connecting $h_{k} M$ to $h_{k+1} M$ [6]: these relations are re ection invariant.

For our purposes, ii) is the ${ }_{R}$ essential feature ofM and $R$; now we represent this result on any integraldi erential algebra ( $Q$; x ; ). Let us consider the $m$ aps of $Q$ into itself induced by $M$;R according to the fram ew ork of the previous Section; these are

Let us also recall that any functionalf $2 \mathrm{~F}=\mathrm{Im}$ @ induces a $m$ ap $f: Q!C$; in particular, considering the $K d V$ conserved functionals we infer from $P$ rop. 32 ii) that

W e go on and introduce the Backlund transform ation on $Q$; essentially, this is the com position of $m$ aps $M \quad R \quad M^{1}$, leaving invariant any conserved $K d V$ functionaldue to $E q$. (3.4). H ow ever, $M$ is typically non invertible on the full space $Q$ : to overcom e this di culty, we use the follow ing

## 4 The implication a) =) b) in Prop. 2.1: a new proof.

The sim ple geom etrical proof we propose is based on the schem e I)-III) of the Introduction ${ }_{R}$ Item I) has been treated in the previous Section; here we form alise II) III). From now on, ( Q ; x ; ) is the integral-di erential algebra (2.14-2.15) of form allaurent series.
