# Quantum integrable multiatom matter-radiation models with and without rotating wave approximation

#### A bstract

New integrable multi-atom matter-radiation models with and without rotating wave approximation (RWA) are constructed and exactly solved through algebraic Bethe ansatz. The models with RWA are generated through ancestor model approach in an uni ed way. The rational case yields the standard type of matter-radiaton models, while the trigonom etric case corresponds to their q-deformations. The models without RWA are obtained from the elliptic case at the G audin and high spin limit.

### 1 Introduction

It is an azing to note that real system s, like those in quantum optics induced by resonance interaction between atom and a quantized laser eld, in cavity QED both in microwave and optical domain [1, 2], in trapped ion interacting with its center of mass motion irradiated by a laser beam [3, 4] etc., all involving complex matter radiation (MR) interactions can be described so successfully by simple models, like Jaynes-Cummings (JC) [5] and Buck Sukum ar (BS) [6] models. M any theoretical predictions based on these models, like vacuum Rabi splitting, Rabi oscillation and its quantum collapse and revival etc. have been veried in maser and laser experiments.

In such simplest interacting MR models the quantized radiation eld is taken in single bosonic mode:  $h = be^{i!_{f}t} + b^{y}e^{i!_{f}t}$ , while the atom is considered to be a two-level spin system with polarization vector  $S = e^{i!_{a}t} + e^{+i!_{a}t}$ . The interaction (h S) therefore contains in general both fast (with frequency  $w_{f} + w_{a}$ ) and slow oscillating (with frequency  $w_{f} - w_{a}$ ) components. However it is custom any to neglect the fast oscillating part by considering approximation  $jw_{f} - w_{a}j < w_{f}$ , which corresponds to the rotating wave approximation (RWA) and make the model solvable. This yields with the addition of free eld and atom ic excitation terms the well known JC model

However this approximation, which is justimed only near the resonance point  $!_f !_a$ , should be avoided in the general case [11], when additional counter rotating wave (CRW) term smust appear:

M oreover, for describing physical situations m ore accurately, one has to bok for generalizations of the basic m odels, i.e. has to consider their q-deform ations [7, 8], introduce higher nonlinearities [4, 9], involve multiple atom s [2, 9, 10] etc. However, while the exact solutions for the JC and the BS m odels together with their simple multi-atom extensions are known [12, 13, 14], the same appears to be no longer true for m ost of the above generalizations. M ore precisely, integrable m odels w ithout RW A as well as those with explicit inter-atom ic couplings are not known form ost of the MR m odels, except for a few recent attempts [15, 16]. M oreover, though q-deform ation, signifying introduction of anisotropy together with speci c nonlinearity into the system, was considered earlier for a few m odels [7, 8], their multi-atom and integrable variants are not known. Therefore, it is indeed a challenge to

nd a scheme for generating integrable MR models having the desired properties mentioned above.

# 2 Majoraims and strategy of our construction

To meet this challenge we construct new classes of integrable M R m odels with and without RW A. The result concerning our models with RW A has been reported recently [17], where we propose a general integrable system based on our ancestor Lax operator approach [18]. Through various reductions we generate from it a series of integrable M R models with explicit inter-atom ic interactions. This includes such new multi-atom generalizations of JC, BS and trapped ion (T I) models as well as their integrable q-deform ations involving quantum group. Moreover, since the construction of our models is based on a general Yang-Baxter (YB) algebra, we can also solve them in a uni ed way through the Bethe ansatz (BA). Our aim here is to review brie y this result and then present our new result obtained without RW A.

O ur strategy for constructing models with RW A is to start with a combination of Lax operators:  $T() = L^{s}() \int_{j}^{N_{a}} L_{j}^{s}()$ , where  $L^{s}()$  involving bosons represents the radiation or the oscillatory mode and  $L_{j}^{s}()$  involving spin operators represents N<sub>a</sub>-number of atom s. By construction it must satisfy the quantum YB equation (QYBE) R() T() T() = (I T())(T() I)R(), yielding the integrability condition [(); ()] = 0, with mutually commuting set of conserved operators, obtained through expansion () = trT() =  $_{a}^{P}C_{a}^{a}$  [19]. For constructing the bosonic Lax operator we implement our ancestor model approach [18] and from a generalized Lax operator linked with a generalized quadratic algebra or its quantum deformation generate di erent  $L^{s}()$ through various bosonic realizations. Our standard MR models are linked to the Lie algebra and the rational R-matrix of the xxx spin chain [19], while their q-deformations are related to the quantum algebra and the trigonom etric R-matrix of the xxz chain [20].

For constructing integrable M R m odels w ithout RW A, however, as we explain below, the above approach fails due to the di culty in bosonizing the Sklyanin algebra. Therefore for such m odels, which are linked to the elliptic R -m atrix of the xyz spin chain, we have to change our strategy and sw itch over to the G audin lim it together with a high spin lim it.

## 3 Integrable M R models with RW A

We concentrate st on standard MR models and recall that in the rational case the 2 2 ancestor Lax operator may be given as [18]

with operators s satisfying a quadratic algebra

The central elements m are expressed through arbitrary parameters appearing in (3) as m<sup>+</sup> =  $c_1^0 c_2^0$ ; m =  $c_1^1 c_2^0 + c_1^0 c_2^1$  and as it is easy to see, their di erent choices reduce (4) to di erent simple algebras:

i) su (u); at

and the corresponding limits yield from (3) the respective Lax operators. In case i), choosing  $c_a^0 = 1$ and  $c_1^1 = c_2^1 = c_j$ , (3) we get the spin Lax operator  $L_j^S$  (); j 2 [1;N<sub>a</sub>] describing N<sub>a</sub> atom s with inhom ogeneity parameters  $c_j$ , while the other cases can reduce to dimension types of bosonic Lax operators linked to the radiation mode.

Remarkably, such reductions yield in a united way new integrable multi-atom BS, JC and TI models, at the limits ii), iii) and iv) of (5). Thus case ii) with choice  $c_1^0 = c_2^0 = 1$ ;  $c_1^1 = c_2^1$  c, yields

which with a bosonic realization of su(1;1):  $s^+ = {p - b \over N} {b^y}; s = {b \over N} {p - s^3} = N + {1 \over 2}$  and taking the spin-s operator as  $S = {1 \over 2} {p \over k} {2s \over k} \sim_k$ , represents a new integrable multi-atom BS model with interatom ic interactions and nondegenerate atom ic frequencies. At N<sub>a</sub> = 1 the matter-matter interactions obviously vanish, recovering the known model [14]. The radiation frequency  $!_f$  and the atom ic frequencies  $!_{aj}$  in our models are de ned in general through the inhom ogeneity parameters as

Similarly, under reduction iii), choosing  $c_1^0 = ;c_2^0 = 0;c_1^1 \quad c;c_2^1 = {}^1$  and taking direct bosonic realization  $s = b;s^+ = b^y;s^3 = b^yb;$  we obtain from the same (3) an integrable multi-atom JC model with matter-matter coupling.

From reduction iv), by xing the parameter values as  $c_1^0 = 1$ ;  $c_1^1 = c_1c_2^1 = 0$  and considering a consistent realization through canonical variables:  $s = e^{-ix}$ ;  $s^3 = p + x$ , we generate an integrable multi-atom TIm odel with full exponential nonlinearity: ( $e^{-ix}S^+ + e^{ix}S$ ). Such models however are di cult to solve by standard BA, due to the absence of pseudovaccum like in the Toda chain.

For constructing integrable q-deform ed M R m odels the strategy is the sam e; only one has to start now from the trigonom etric type ancestor Lax operator involving generalized q-deform ed operators [18]. This yields an integrable system with H am iltonian in the form

which represent a new class of MR m odels with  $S_q$  belonging to the quantum group  $U_q$  (su (2)) and  $s_q$  to a more general quantum algebra [18].

 $q \xrightarrow{\text{Integrable } q-\text{deform ed BS m odel is obtained from (8) by realizing s_q through q-oscillator: s_q^+ =$  $N lqb_q^y; s_{q_p} = b_q N l_q; s_q^3 = N + \frac{1}{2}, \text{ and using quantum spin operator } S_q \text{ as its co-product [20]:}$  $S_q = P_j^s q^{k<j k_j} q^{j > j - j - 1}; S^z = P_j^s z_j^z. At s = 1, one gets an integrable version of an earlier m odel [8].$ 

Similarly realizing  $s_q^+ = b_q^y$ ;  $s_q = b_q$ ;  $s^3 = N$  yield a new integrable q-deformation of the JC model, and realization through canonical operators results an integrable q-deformed TIm odel.

W e em phasize again that all integrable M R m odels we proposed, sim ilar to their uni ed construction, allow exact BA solutions also in a uni ed way. M ore details on the above m odels and their exact solutions can be found in [17].

# 4 Integrable M R models without RW A

The basic idea for constructing integrable matter-radiation models with RWA, as we have explained above, is to consider set the xxx or the xxz spin chain with arbitrary spins and then replace one of the spins by its bosonic realization. The set case belongs to the rational class, where the spins satisfy the Lie type algebra, while the second case falls in the trigonom etric class, where the higher spin operators satisfy the quantum algebra. Fortunately both these algebras allow bosonic realization, which yields the required radiation mode.

For constructing m one general integrable m odels with additional CRW terms (like (2) and its multiatom generalizations), one m ay expect to apply the same idea, but for the xyz spin chain. However in this anisotropic case, linked to the elliptic R -m atrix, the higher spin operators satisfy the Sklyanin algebra [21], for which unfortunately no bosonic realization is known. In search for a way out, one observes that the Sklyanin algebra fortunately reduces again to the usualsu (2) algebra at the elliptic G audin lim it [22], allow ing the required bosonization. However, a direct bosonic realization of a single spin operator in G audin m odels fails again , since it results either nonintegrable or unphysical m odels. The situation is saved nally by a further lim it ofs ! 1 , for the bosonic mode, which yields the desired integrable multi-atom JC type m odel with nontrivial CRW terms. We should mention that sim ilar high spin lim it has been used recently for constructing integrable multi-atom JC m odel, but with RW A [16].

#### 4.1 Elliptic Gaudin model

Since the state in our construction is the elliptic G audin model (EGM), we review brie y the related results from [22]. EGM is obtained at the ! 0 limit from the inhomogeneous xyz spin model and therefore all relevant objects like the Lax operator, R-matrix, conserved quantities, as

well as important formulas in the Bethe ansatz method, like the eigenfunctions and the eigenvalues together with the Bethe equations etc. concerning this model can be derived directly from those of the xyz model [23] at the said limit. The Lax operator with inhom ogeneity parameters  $z_n$  and the r-matrix of the EGM can be expressed through elliptic functions in the form [22]

Operators (9) satisfy a sem iclassical YBE:  $[L_n() L_n()] = [r(); (L_n() I + I L_n()],$ obtained at ! 0 lim it from the QYBE. M utually commuting conserved quantities H<sub>n</sub> of the EGM are obtained from the expansion coe cient of the xyz transferm atrix

It is most crucial for our purpose to note that, higher spin operators  $S_n^a$  appearing in the G audin model (9), are reduced from the generators of the Sklyanin algebra to simply those of

with = corresponding to su (2) (or su (1;1)). Recall that in constructing standard MR models with RW A we have taken the spin operators for N<sub>a</sub> number of atom s as generators of su (2), while for the radiation eld we have considered bosonic realizations of di erent algebraic structures in (5). For EMG (9) how ever apart from su (2), only other possible algebra is su (1;1), as given in (12). And even this can not be used, since di erent algebras can not be mixed in integrable G audin model. On the other hand, if we choose su (2) algebra for all operators and use the H olstein-P rim ako transform ation (HPT)  $S_0^+ = b^{V} \frac{S_0}{2}$  N;  $S_0 = \frac{S_0}{2}$  N b;  $S_0^3 = N \frac{S_0}{4}$ ; N = b<sup>V</sup> b for bosonizing the radiative mode, though we can retain the integrability, but get unphysical H am iltonian for  $\langle N \rangle > \frac{S_0}{2}$ , with S<sub>0</sub> become ing nonherm itian!

#### 4.2 High spin lim it

Fortunately, the above di culties can be bypassed again by considering further a high spin limit  $s_0 \mid 1$  for the radiation eld, which reduces the HPT to

by retaining terms up to order 0  $(\frac{1}{2})$ .

For deriving now the integrable m atter-radiation m odels without RW A , we replace spin operators at n = 0 by bosons for the radiative m ode in (11) by using (13) and choose the arbitrary parameters at n = 0; j as

where K is the elliptic integral [23] related to a period of the elliptic functions. At the lim it ! 0 therefore the coupling parameters  $w_a (z_n - z_m)$  can be expanded as

Denoting  $w = \frac{1}{2} (w_1 \quad w_2)$ , which reduce the elliptic G audin H am iltonian to  $H_n = \frac{1}{2} H_n^{(2)} + \frac{1}{2} H_n^{(1)} + O({}^0)$  with  $H_0^{(a)} = {}^P_{j} H_j^{(a)}$ ; a = 1;2. Therefore,  $H_j^{(a)}$  give mutually commuting independent conserved quantities:  $[H_j^{(a)}; H_k^{(b)}] = 0$ , with

with elliptic modulus  $k = \frac{p_{1}}{1 - k^{02}}$ ; describes matter-radiation interaction having explicit CRW term s, where by an allowed phase transform ation  $e^{\frac{i}{2}}$  in both b;  $S_{j}^{+}$ , we have changed the sign of the RW term. In (16) the part

accouts for interatom ic interactions with inhom ogenious coupling constants expressed through  $x_j$ . These arbitrary parameters may be adjusted to make the interaction strengths diminishing with increasing distance between the atom s. Various combinations of Ham iltonians (16) with arbitrary coupling constants:  $H_j = !_j S_j^3; + J_j (H_j^{(SS)} + H_j^{(SS)})$  can yield digerent integrable multi-atom matter-radiation models without RW A. For example, by taking simply  $_j H_j$  with  $!_j = !_j J_j = 1$ , we get an integrable multi-atom JC -type model with nontrivial CRW term s:

which in contrast to the popular belief [11] is exactly solvable through Bethe ansatz, as we see below. To make the model more physical we should add a eld term  $!_f b^y b$  to the Ham iltonian (19). Considering the eld frequency  $!_f$  to be small we can treat this additional term perturbatively over the Bethe solvable original integrable model. It is curious to note that, essentially at this small

eld frequency limit the RW A becom es a bad approximation and the CRW terms, which we have considered, becom e signi cant.

# 5 Exact Bethe ansatz solutions

In the basic algebraic Bethe ansatz (ABA) m ethod the trace of the m onodrom y m atrix () = trT () produces conserved operators, while the o -diagonal elements  $T_{21}$  () B () and T  $_{12}$  () C () act

like creation and annihilation operators of pseudoparticles, with the M-particle state given as  $M >_B = B(1)$   $B_{M}(0,0) >$ , with the pseudovacuum 0 > de ned through C(0,0) > = 0. The majoraim of ABA [19] is to not the eigenvalue solution:  $(0,0) >_B = (0,0) = 0$ .

All ourm odels with RW A, constructed in a uni ed way through the ancestor m odel scheme, can be solved in a uni ed manner following the ABA method in its standard formulation [19]. Om itting here the details [17], we focus on the ABA solution of our integrable models without RW A (16-19). For deriving the ABA relations of these models we have to repeat the steps we have followed in obtaining their Ham iltonians. That is we have to start from the ABA relations for the xyz spin chain with arbitrary spins, where a gauge transform ed version of operators and states has to be used to de ne a modi ed pseudovacuum [23, 24]. Considering carefully the lim it ! O the corresponding ABA relations for the elliptic G audin model is obtained [22]. Taking the high spin lim it for the radiative mode in these relations we derive nally the eigenvalues and the Bethe equations for our integrable models w ithout RW A.

W e start therefore from the ellipic G audin m odel, and using the key ABA relations from [22], we derive the energy spectrum as

with arbitrary spin values  $s_n$  of operators at the n-th site and involving elliptic function  $_{11}$ . The corresponding Bethe equations can be found in [22] as

Choosing the inhom ogeneity parameters at n = 0; j as in (14), introducing a scaling also for the Bethe parameters:  $a = l_a$  and using some properties of the  $_{11}$  function, we can derive now from (20) for n = j the exact eigenvalue for our matter-radiation model (16) without RW A, at the high spin limit (or equivalently, at ! 0) for the radiation eld as

where we have used short-hand notations  $\begin{pmatrix} ll \\ 11 \end{pmatrix} (0) = \begin{pmatrix} ll \\ 11 \end{pmatrix}$ , for l = 0;1;2: Sim ilarly expanding (21) we extract the corresponding Bethe equation

the solutions of which should determ ine the Bethe m om entum s  $l_b; b = 1; ...; M$  for a given arbitrary nondegenerate set of inhom ogeneity parameters  $x_j; j = 1; ...; N_a$ . Note that  $x_0$  can be absorbed by shifting the parameters  $x_j$  and  $l_a$ .

Either expanding (20) for n = 0 and combining terms of di erent orders, or by taking the sum of (22) with an additional term with ! and using the Bethe equation (23), we can obtain the exact eigenvalues for our multi-atom model (19), with explicit CRW terms as

# 6 Concluding rem arks

In real matter-radiation models involving many atoms interatom ic interactions must appear. Likewise the custom ary rotating wave approximation in general must be avoided, at least when away from the resonance point. However these important cases could not be included without spoiling the integrability in most of the solvable models proposed earlier. We have proposed new integrable models, where both these cases can be incorporated retaining the integrability of the system and extract exact solutions through the Bethe ansatz. For models with rotating wave approximation we nd a series of integrable multi-atom models with inter-atom ic interactions, which gives generalizations of Jaynes-Cummings, Buck-Sukum ar and trapped ion models together with their q-deformations. These models belong to the rational or the trigonom etric class and can be solved exactly in a uni ed way.

We also construct for the st time exactly solvable multi-atom matter-radiation models without rotating wave approximation (RWA), which are close to the physical systems with the required counter rotating wave (CRW) terms. We achieve this by taking the high spin limit for the radiation

eld in the elliptic G audin model. However in contrast to our models with RW A, where we could construct di erent types of matter-radiation models, our success with models without RW A is restricted, where we could obtain only JC type models with CRW terms. Moreover, the free radiation term does not naturally appear in such integrable models and has to be included perturbatively over the exact BA result.

Identifying the models in real systems and experimental veri cation of the related results presented here, especially in many-atom microlasers [25] or in trapped ions away from resonance point [11] would be an important application.
