# Q uantum integrable $m$ ultiatom $m$ atter radiation $m$ odels $w$ ith and w thout rotating wave approxim ation

#### Abstract

$N$ ew integrable $m$ ulti-atom $m$ atter-radiation $m$ odels $w$ ith and $w$ thout rotating $w$ ave approxim ation (RW A) are constructed and exactly solved through algebraic B ethe ansatz. T he m odels with RW A are generated through ancestor m odel approach in an uni ed way. The rational case yields the standard type of $m$ atter-radiaton $m$ odels, while the trigonom etric case corresponds to their q-deform ations. Them odels w ithout RW A are obtained from the elliptic case at the G audin and high spin lim it. $42.50 \mathrm{Pq}, 03.65 \mathrm{Fd}, 32.80$ t


## 1 Introduction

It is am azing to note that realsystem $s$, like those in quantum optics induced by resonance interaction between atom and a quantized laser eld, in cavity QED both in $m$ icrow ave and optical dom ain [1, 2], in trapped ion interacting $w$ ith its center of $m$ ass $m$ otion irradiated by a laser beam $[3,4]$ etc., all involving com plex $m$ atter radiation ( $M$ R) interactions can be described so successfully by sim ple m odels, like Jaynes-C um m ings (JC ) [5] and Buck Sukum ar (B S) [6] m odels. M any theoretical predictions based on these models, like vacuum Rabisplitting, Rabioscillation and its quantum collapse and revivaletc. have been veri ed in m aser and laser experim ents.

In such sim plest interacting M R m odels the quantized radiation eld is taken in single bosonic $m$ ode: $h=b e^{i!}{ }_{f} t+b^{y} e^{i!} f_{f} t$, while the atom is considered to be a two-level spin system $w$ ith polarization vector $S=e^{i!a t}+{ }^{+} e^{+i!a t}$. The interaction ( $h \quad S$ ) therefore contains in generalboth fast ( $w$ th frequency $w_{f}+w_{a}$ ) and slow oscillating ( $w$ th frequency $w_{f} \quad w_{a}$ ) com ponents. H ow ever it is custom ary to neglect the fast oscillating part by considering approxim ation $j_{f} \quad w_{a} j \ll w_{f}$, which corresponds to the rotating wave approxim ation (RW A) and $m$ ake the $m$ odel solvable. This yields w ith the addition of free eld and atom ic excitation term s the well know n JC m odel

H ow ever this approxim ation, whidh is justi ed only near the resonance point $!_{\mathrm{f}} \quad$ !ar should be avoided in the general case [11], when additional counter rotating wave (CRW ) term smust appear:

M oreover, for describing physical situations m ore accurately, one has to look for generalizations of the basic models, i.e. has to consider their q-deform ations [7, 8], introduce higher nonlinearities [4, 9], involve m ultiple atom s $2,9,10]$ etc. H ow ever, while the exact solutions for the JC and the BS $m$ odels together $w$ ith their sim ple m ulti-atom extensions are known $[12,13,14]$, the sam e appears to be no longer true for $m$ ost of the above generalizations. M ore precisely, integrable $m$ odels $w$ thout RW A as wellas those w ith explicit inter-atom ic couplings are not known form ost of the M R m odels, except for a few recent attem pts $[15,16]$. M oreover, though $q$-deform ation, signifying introduction of anisotropy together $w$ th speci c nonlinearity into the system, was considered earlier for a few m odels $[7,8]$, their m ulti-atom and integrable variants are not known. Therefore, it is indeed a challenge to nd a schem e for generating integrable M R m odels having the desired properties m entioned above.

## 2 M ajor aim s and strategy of our construction

Tom eet this challenge we construct new classes of integrable M R m odels w ith and w ithout RW A.T he result conceming ourm odels w th RW A has been reported recently [17], where we propose a general integrable system based on our ancestor Lax operator approach [18]. Through various reductions we generate from it a series of integrable M R m odels w ith explicit inter-atom ic interactions. This includes such new multi-atom generalizations of JC , BS and trapped ion (T I) m odels as well as their integrable q-deform ations involving quantum group. M oreover, since the construction of our m odels is based on a general Yang-Baxter (YB) algebra, we can also solve them in a uni ed way through the B ethe ansatz ( $B A$ ). O ur aim here is to review brie $y$ this result and then present our new result obtained w ithout RW A.

O ur strategy for constructing $m$ odels $w$ ith RW A is to start $w$ ith a com bination of Lax operators: $T()=L^{s}()^{2} \underset{j}{N a} L_{j}^{S}()$, where $L^{s}()$ involving bosons represents the radiation or the oscillatory mode and $L_{j}^{S}()$ involving spin operators represents $N a$-num ber of atom $s$. By construction it $m$ ust
 yielding the integrability condition $[() ;()]=0, w$ th $m u t u a l l y ~ c o m m u t i n g ~ s e t ~ o f ~ c o n s e r v e d ~$ operators, obtained through expansion ()$=\operatorname{trT}()={ }^{P}{ }_{a} C_{a}{ }^{a}$ [19]. For constructing the bosonic Lax operator we im plem ent our ancestor model approach [18] and from a generalized Lax operator linked with a generalized quadratic algebra or its quantum deform ation generate di erent $L^{s}()$ through various bosonic realizations. O ur standard M R m odels are linked to the Lie algebra and the rational $R \mathrm{~m}$ atrix of the xxx spin chain [19], while their $q$-deform ations are related to the quantum algebra and the trigonom etric $R \mathrm{~m}$ atrix of the xxz chain [20].

For constructing integrable M R m odels w ithout RW A, how ever, as we explain below, the above approach fails due to the di culty in bosonizing the Sklyanin algebra. Therefore for such models, which are linked to the elliptic $R$ m atrix of the xyz spin chain, we have to change our strategy and sw itch over to the G audin lim it together w ith a high spin lim it.

## 3 Integrable M R m odels with RW A

W e concentrate rst on standard M R m odels and recall that in the rational case the 2 ancestor Lax operator $m$ ay be given as [18]

The central elem ents $m$ are expressed through arbitrary param eters appearing in (3) as $\mathrm{m}^{+}=$ $c_{1}^{0} c_{2}^{0} ; m=c_{1}^{1} c_{2}^{0}+c_{1}^{0} c_{2}^{1}$ and as it is easy to see, their di erent choiges reduce (4) to di erent sim ple algebras:

and the corresponding lim its yield from (3) the respective Lax operators. In case i), choosing $c_{a}^{0}=1$ and $c_{1}^{1}=c_{2}^{1}=C_{j}$, (3) we get the spin Lax operator $L_{j}^{S}() ; j 2\left[1 ; N_{a}\right]$ describing $N_{a}$ atom $s$ w ith inhom ogeneity param eters $C_{j}$, while the other cases can reduce to di erent types of bosonic Lax operators linked to the radiation $m$ ode.

Rem arkably, such reductions yield in a uni ed way new integrable multi-atom BS, JC and TI m odels, at the lim its ii), iii) and iv) of (5). Thus case ii) w ith choige $c_{1}^{0}=c_{2}^{0}=1 ; c_{1}^{1}=c_{2}^{1} \quad c$, yields

At $N_{a}=1$ the $m$ atter $-m$ atter interactions obviously vanish, recovering the known model [14]. The radiation frequency $!_{f}$ and the atom ic frequencies ! aj in our models are de ned in general through the inhom ogeneity param eters as

Sim ilarly, under reduction iii), choosing $c_{1}^{0}=; c_{2}^{0}=0 ; c_{1}^{1} \quad c ; C_{2}^{1}=\quad 1$ and taking direct bosonic realization $s=b ; s^{+}=b^{y} ; s^{3}=b y b ;$ we obtain from the same (3) an integrable multi-atom JC m odelw ith $m$ atter $m$ atter coupling.

From reduction iv), by xing the param eter values as $q=1 ; c_{1}^{1} \quad c ; c_{2}^{0}=c_{2}^{1}=0$ and considering a consistent realization through canonicalvariables: $s=e^{\text {ix }} ; s^{3}=p+x$, we generate an integrable m ulti-atom T I m odelw ith full exponential nonlinearity: ( $e^{i x} S^{+}+e^{i x} S$ ). Such m odels how ever are di cult to solve by standard BA, due to the absence of pseudovaccum like in the Toda chain.

For constructing integrable q-deform ed M R m odels the strategy is the sam e; only one has to start now from the trigonom etric type ancestor Lax operator involving generalized q-deform ed operators [18]. $T$ his yields an integrable system $w$ ith $H$ am ittonian in the form

which represent a new class of $\mathrm{M} R \mathrm{~m}$ odels w th $\mathrm{S}_{\mathrm{q}}$ belonging to the quantum group $\mathrm{U}_{\mathrm{q}}(\mathrm{su}(2)$ ) and $S_{q}$ to a $m$ ore generalquantum algebra [18].
Integrable $q$-deform ed BS m odel is obtained from (8) by realizing $s_{q}$ through $q$-oscillator: $s_{q}^{+}=$

At $s=1$, one gets an integrable version of an earlier m odel [8].

Sim ilarly realizing $\mathrm{s}_{\mathrm{q}}^{+}=\mathrm{b}_{\mathrm{q}}^{\mathrm{q}} ; \mathrm{s}_{\mathrm{q}}=\mathrm{b}_{\mathrm{c}} ; \mathrm{s}^{3}=\mathrm{N}$ yield a new integrable q-deform ation of the JC m odel, and realization through canonical operators results an integrable q-deform ed T I m odel.

W e em phasize again that all integrable M R m odels we proposed, sim ilar to their uni ed construction, allow exact BA solutions also in a uni ed way. M ore details on the above models and their exact solutions can be found in [17].

## 4 Integrable M R m odels w ithout RW A

T he basic idea for constructing integrable $m$ atter-radiation $m$ odels $w$ ith RW A, as we have explained above, is to consider rst the xxx or the xxz spin chain w ith arbitrary spins and then replace one of the spins by itsboson ic realization. T he rst case belongs to the rationalclass, w here the spins satisfy the Lie type algebra, while the second case falls in the trigonom etric class, where the higher spin operators satisfy the quantum algebra. Fortunately both these algebras allow bosonic realization, $w h i c h ~ y i e l d s ~ t h e ~ r e q u i r e d ~ r a d i a t i o n ~ m o d e . ~$

For constructing more general integrable models $w$ ith additional CRW term $s$ (like (2) and its $m$ ultiatom generalizations), one $m$ ay expect to apply the same idea, but for the xyz spin chain. H ow ever in this anisotropic case, linked to the elliptic $R$ m atrix, the higher spin operators satisfy the Sklyanin algebra [21], for which unfortunately no bosonic realization is known. In search for a way out, one observes that the Sklyanin algebra fortunately reduces again to the usualsu (2) algebra at the ellịtic G audin lim it [22], allow ing the required bosonization. H ow ever, a direct bosonic realization of a single spin operator in $G$ audin $m$ odels fails again , since it results either non integrable or unphysical m odels. The situation is saved nally by a further lim it ofs! 1 , for the bosonic mode, which yields the desired integrable multi-atom JC type modelw ith nontrivial CRW term s . W e should mention that sim ilar high spin lim it has been used recently for constructing integrable multi-atom JC model, but w th RW A [16].

### 4.1 Elliptic G audin m odel

Since the rst step in our construction is the elliptic Gaudin model (EGM), we review brie $y$ the related results from [22]. EGM is obtained at the ! 0 lim it from the inhom ogeneous xyz spin $m$ odel and therefore all relevant ob jects like the Lax operator, $R \rightarrow m$ atrix, conserved quantities, as
well as im portant form ulas in the B ethe ansatz method, like the eigenfunctions and the eigenvalues together $w$ th the $B$ ethe equations etc. conceming this $m$ odel can be derived directly from those of the xyz m odel [23] at the said lim it. The Lax operator $w$ ith inhom ogeneity param etrs $z_{n}$ and the r-m atrix of the EGM can be expressed through elliptic functions in the form [22]

It is $m$ ost crucial for our purpose to note that, higher spin operators $S_{n}^{a}$ appearing in the $G$ audin $m$ odel (9), are reduced from the generators of the Sklyanin algebra to sim ply those of

w ith $=$ corresponding to $\mathrm{su}(2)$ (or $\mathrm{su}(1 ; 1)$ ). R ecall that in constructing standard M R m odels w ith RW A we have taken the spin operators for $\mathrm{N}_{\mathrm{a}}$ num ber of atom $s$ as generators of su (2), while for the radiation eld we have considered bosonic realizations of di erent algebraic structures in (5). For EM G (9) how ever apart from su (2), only other possible algebra is su ( $1 ; 1$ ), as given in (12). A nd even this can not be used, since di emt algebras can not be $m$ ixed in integrable $G$ audin $m$ odel. On the other hand, if f \& choose su (2) algebra for alloperators and use the $H$ olstein $P$ rim ako transform ation (HPT) $\mathrm{S}_{0}^{+}=\mathrm{b}^{\mathrm{y}} \frac{\mathrm{S}_{0}}{2} \mathrm{~N} ; \mathrm{S}_{0}=\frac{\mathrm{S}_{0}}{2} \mathrm{~N} b ; \mathrm{S}_{0}^{3}=\mathrm{N} \quad \frac{\mathrm{S}_{0}}{4} ; \mathrm{N}=\mathrm{b}^{\mathrm{Y}} \mathrm{b}$ forbosonizing the radiative m ode, though we can retain the integrability, but get unphysical $H$ am iltonian for $\left\langle\mathrm{N} j \gg \frac{S_{0}}{2}\right.$, w ith $S_{0}$ becom ing nonherm itian!

### 4.2 High spin lim it

Fortunately, the above di culties can be bypassed again by considering further a high spin lim it so ! 1 for the radiation eld, which reduces the HPT to

accouts for interatom ic interactions with inhom ogenious coupling constants expressed through $x_{j}$. These arbitrary param eters $m$ ay be adjusted to $m$ ake the interaction strengths dim inishing with increasing distance betw een the atom s. Various com binations of $H$ am iltonians (16) with arbitrary coupling constants: $H_{j}=!_{j} S_{j}^{3} ;+J_{j}\left(H_{j}^{(b S)}+H_{j}^{(S S)}\right)$ can yield di ${ }_{P}$ erent integrable $m$ ulti-atom $m$ atterradiation models without RW A. For exam ple, by taking simply ${ }^{P}{ }_{j} H_{j} w$ th $!_{j}=!; J_{j}=1$, we get an integrable $m$ ulti-atom JC -type $m$ odelw ith nontrivialCRW term $s$ :

which in contrast to the popular belief [11] is exactly solvable through Bethe ansatz, as we see below. To m ake the $m$ odelm ore physical we should add a eld term ! $!_{f} b^{ } b$ to the $H$ am iltonian (19). C onsidering the eld frequency $!_{f}$ to be sm allwe can treat this additional term perturbatively over the Bethe solvable original integrable m odel. It is curious to note that, essentially at this sm all
eld frequency lim it the RW A becom es a bad approxim ation and the CRW term s, which we have considered, becom e signi cant.

## 5 Exact B ethe ansatz solutions

In the basic algebraic $B$ ethe ansatz (ABA) $m$ ethod the trace of the $m$ onodrom $y m$ atrix ( ) = trT () produces conserved operators, while the 0 -diagonal elem ents $\mathrm{I}_{21}() \quad \mathrm{B}()$ and $\mathrm{T}_{12}() \quad \mathrm{C}()$ act
like creation and annihilation operators of pseudoparticles, $w$ th the $M$ particle state given as $\mathbb{M}>_{B}=B\left(1_{1} \quad B_{1} 0 j 0>\right.$, with the pseudovacuum $j 0>$ de ned through $C() j 0>=0$. The $m$ ajor aim of $A B A$ [19] is to nd the eigenvalue solution: ( ) $\mathbb{M}>_{B}=(; f a g) \mathbb{M}>_{B}$.

A llourm odels w ith RW A, constructed in a uni ed way through the ancestor m odel schem e, can be solved in a uni ed manner follow ing the ABA m ethod in its standard form ulation [19]. Om ltting here the details [17], we focus on the ABA solution of our integrable m odels w ithout RW A (16-19). For deriving the ABA relations of these models we have to repeat the steps we have follow ed in obtaining their $H$ am iltonians. That is we have to start from the ABA relations for the xyz spin chain w ith arbitrary spins, where a gauge transform ed version of operators and states has to be used to de ne amodi ed pseudovacuum [23,24]. C onsidering carefilly the lim it ! 0 the corresponding ABA relations for the elliptic $G$ audin $m$ odel is obtained [22]. Taking the high spin lim it for the radiative $m$ ode in these relations we derive nally the eigenvalues and the B ethe equations for our integrable m odels w ithout RW A.
$W$ e start therefore from the ellipic $G$ audin $m$ odel, and using the key ABA relations from [22], we derive the energy spectrum as
$w$ ith arbitrary spin values $s_{n}$ of operators at the $n$-th site and involving elliptic function 11 . The corresponding Bethe equations can be found in [22] as

Choosing the inhom ogeneity param eters at $n=0 ; j$ as in (14), introducing a scaling also for the B ethe param eters: $a=l_{a}$ and using som e properties of the 11 function, we can derive now from (20) for $n=j$ the exact eigenvalue for our $m$ atter-radiation $m$ odel (16) $w$ thout RW $A$, at the high spin lim it (or equivalently, at ! 0) for the radiation eld as
where we have used short-hand notations ${ }_{11}^{(1)}(0)={ }_{11}^{(1)}$, for $l=0 ; 1 ; 2$ : $\operatorname{sim}$ ilarly expanding (21) we extract the corresponding B ethe equation

the solutions of which should determ ine the $B$ ethe $m$ om entum $s h_{b} ; b=1 ;::: ; \mathrm{M}$ for a given anbitrary nondegenerate set of inhom ogeneity param eters $x_{j} ; j=1 ;::: ; N_{a} . N$ ote that $x_{0}$ can be absorbed by shifting the param eters $x_{j}$ and $l_{a}$.

E ther expanding (20) for $n=0$ and combining term $s$ of di erent orders, or by taking the sum of (22) w ith an additional term $w$ ith ! and using the Bethe equation (23), we can obtain the exact eigenvalues for our m ulti-atom $m$ odel (19), w ith explicit CRW term $s$ as

## 6 C oncluding rem arks

In realm atter-radiation $m$ odels involving $m$ any atom $s$ interatom ic interactions $m$ ust appear. Likew ise the custom ary rotating wave approxim ation in general m ust be avoided, at least when aw ay from the resonance point. H ow ever these im portant cases could not be included w thout spoiling the integrability in $m$ ost of the solvable $m$ odels proposed earlier. $W$ e have proposed new integrable $m$ odels, where both these cases can be incorporated retaining the integrability of the system and extract exact solutions through the Bethe ansatz. For $m$ odels $w$ ith rotating wave approxim ation we nd a series of integrable $m$ ulti-atom $m$ odels $w$ ith inter-atom ic interactions, which gives generalizations of Jaynes $C$ um m ings, Buck-Sukum ar and trapped ion $m$ odels together $w$ ith their $q$-deform ations. $T$ hese $m$ odels belong to the rational or the trigonom etric class and can be solved exactly in a uni ed way.

We also construct for the rst tim e exactly solvable $m$ ulti-atom $m$ atter-radiation $m$ odels $w$ th out rotating wave approxim ation (RW A), which are close to the physical system swith the required counter rotating wave ( $C$ RW ) term $\mathrm{S} . \mathrm{W}$ e achieve this by taking the high spin lim it for the radiation
eld in the elliptic G audin model. H ow ever in contrast to our m odels w ith RW A, where we could construct di erent types of $m$ atter-radiation $m$ odels, our success $w$ th $m$ odels w thout RW A is restricted, where we could obtain only JC type m odels w ith CRW term s. M oreover, the free radiation term does not naturally appear in such integrable $m$ odels and has to be included perturbatively over the exact $B A$ result.

Identifying the $m$ odels in real system $s$ and experim ental veri cation of the related results presented here, especially in $m$ any-atom $m$ icrolasers [25] or in trapped ions aw ay from resonance point [11] would be an im portant application.
