Comment on \Soliton ratchets induced by excitation of internal modes"

Very recently Willis et al. Phys. Rev. E 69, 056612 (2004)] have used a collective variable theory to explain the appearance of a nonzero energy current in an ac driven, dam ped sine-G ordon equation. In this comment, we prove rigorously that the time-averaged energy current in an ac driven nonlinear K lein-G ordon system is strictly zero.

Recently several papers have been published trying to understand soliton ratchets (see, for example, Refs. [1, 2, 3, 4, 5, 6] and for a recent review chapter 9 in Ref. [7], pp. 343(364). This phenom enon is a generalization of the ratchet e ect [8] to spatially extended system s, and m anifests as a unidirectional motion of a soliton induced by zero-average forces. A paradigm atic example is the driven, dam ped nonlinear K lein-G ordon equation:

where $g_{,z}=$ @g=@z, f(t) is a periodic eld with period T and zero time-average [i.e., 1=T $_0^{R_T}$ dtf(t) = 0], > 0 is the dissipation parameter determining the inverse relaxation tim e in the system, and $U^{0}(z)$ is the derivative with respect to z of the potential U (z). In this com ment, we will assume that the potential U (z) is periodic with period , and presents m in im a at $z_1 = z_0 + j$, with j 2 Z. The ac driven, damped sine-Gordon equation considered in Ref. [6] is a particular case of this more general problem, with $U(z) = 1 \cos(z)$ and

To fully specify the mathematical problem, the partial di erential equation (1) must be am ended by both initial conditions for (x;0) and (x;0), and boundary conditions for $\lim_{x \to 1} (x;t)$. Several boundary conditions can be in posed to have a well-posed boundary value problem. For instance, in the absence of the periodic eld f (t), it is possible to choose the xed boundary conditions: $\lim_{x \to +1} (x;t) = z_1$ and $\lim_{x \to +1} (x;t) = z_m$. In the presence of f (t), the xed boundary conditions become incompatible with Eq. (1), and they are usually

replaced by the aperiodic boundary conditions:

where Q 2 Z is the so-called topological charge. The discrete version of these periodic boundary conditions are also the most used in the numerical solution of Eq. (1) (see, for example, Refs. [1] and [5]).

It can be derived from the continuity equation that the energy current density generated by the eld (x;t) in the absence of dam ping and external forcing is given by ;t (x;t);x (x;t) and, consequently, the energy j(x;t) =current reads

The time-averaged energy current hJi is de ned as the lim it.

In Ref. [1], it has been proved by symmetry considerations that a necessary condition for the appearance of a non-vanishing time-averaged energy current is that either the potential presents broken spatial sym m etry, or the eld f (t) violates the sym m etry property

or both simultaneously. Following this idea, a collective variable approach has been developed in Ref. [6] for the ac driven, dam ped sine-Gordon equation with a eld of the form (2) which leads to a non-vanishing timeaveraged energy current. The purpose of this comm ent is to prove that the tim e-averaged energy current, hJi, of a

driven, dam ped nonlinear K lein-G ordon equation of the form (1) is necessarily zero and, consequently, the above mentioned results in Ref. [6] must be erroneous.

To prove that hJi = 0, rstly we will obtain an ordinary dierential equation for the energy current J (t). In order to do that, we dierentiate with respect to time Eq. (5), resulting

By making use of Eq. (1) in the second term on the righthand side of the above expression, it is straightforward to write it in the form

D i erentiating Eq. (3) with respect to t, it is easy to see that the rst term between brace brackets on the right-hand side of Eq. (9) is equal to zero. From Eq. (4), it follows that the second term between brace brackets on the right-hand side of Eq. (9) is also equal to zero. The two terms of Eq. (9) containing U [(x;t)] also cancel each other due to the boundary condition (3) and the periodicity of U (z). Thus, from Eq. (3) we nally obtain

$$J_{-}(t) = J(t) Q f(t); \qquad (10)$$

It is im portant to emphasize that Eq. (10) is a direct consequence of Eq. (1) and the boundary conditions (3) and (4). Therefore, it is an exact result valid for any periodic potential U(z) of the type described in the paragraph below Eq. (1), and any external eld f(t). Equation (10) appears in Ref. [6] as an approximate result obtained after neglecting the dressing due to phonons.

The general solution of Eq. (10) is

and making use of the de nition of the time-averaged energy current in Eq. (6), it results

The rst lim it in the above expression is obviously equal to zero. The second one is also equal to zero as the




FIG. 1: Evolution of the energy current J (t) corresponding to the sine-G ordon equation with the biharm onic eld in Eq. (2) and the initial conditions corresponding to a static kink-like solution of the unperturbed sine-G ordon equation [i.e., f (t) = 0]. The parameter values are the same as in Fig. 3 of Ref. [6]: = 0.15, $_1$ = 0.16, $_2$ = $_1$ = $\overline{2}$, ! = 0.25, and = 1.61 . The points represents the results obtained by solving numerically the sine-G ordon equation and the solid line the analytical expression in Eq. (14). The agreement is obviously excellent since Eq. (14) is exact. The time-averaged energy current hJi is zero.

external eld is periodic with zero time-average. The integral appearing in Eq. (12) can be bounded using the fact that

where f_m is an upper bound of f (t) jand, thus, the third $\lim_{t\to\infty} f$ in Eq. (12) is also equal to zero. We conclude that hJi=0 for any periodic potential U(z) of the type described in the paragraph below Eq. (1), and any bounded, zero $\lim_{t\to\infty} f$ are f described periodic f (t).

To corroborate this result, we have solved numerically the sine-Gordon equation for the case of the biharm oniced in Eq. (2). We have considered the initial conditions for (x;0) and $_{;t}(x;0)$ corresponding to a static kink-like solution of the unperturbed sine-Gordon equation [i.e., f(t) = 0], so that, f(t) = 0, and f(t) = 0. For this particular choice, the energy current in Eq. (11) reads

Figure 1 shows the perfect agreem ent between the above expression and the numerical simulation of the sine-

G ordon equation. This agreem ent is not surprising at all since Eq. (14) is exact. The time-averaged energy current hJi is zero.

It is important to emphasize that the result in this comment is not applicable when the external eld not only depends on t but also on x. In that case Eq. (10) cannot be obtained and, in principle, it is possible to observe a non-vanishing time-averaged energy current. A eld of this kind has been considered in Ref. [1], where f(x;t) = E(t) + (x;t), with E(t) being an ac eld with zero mean and E(t) a Gaussian white noise.
